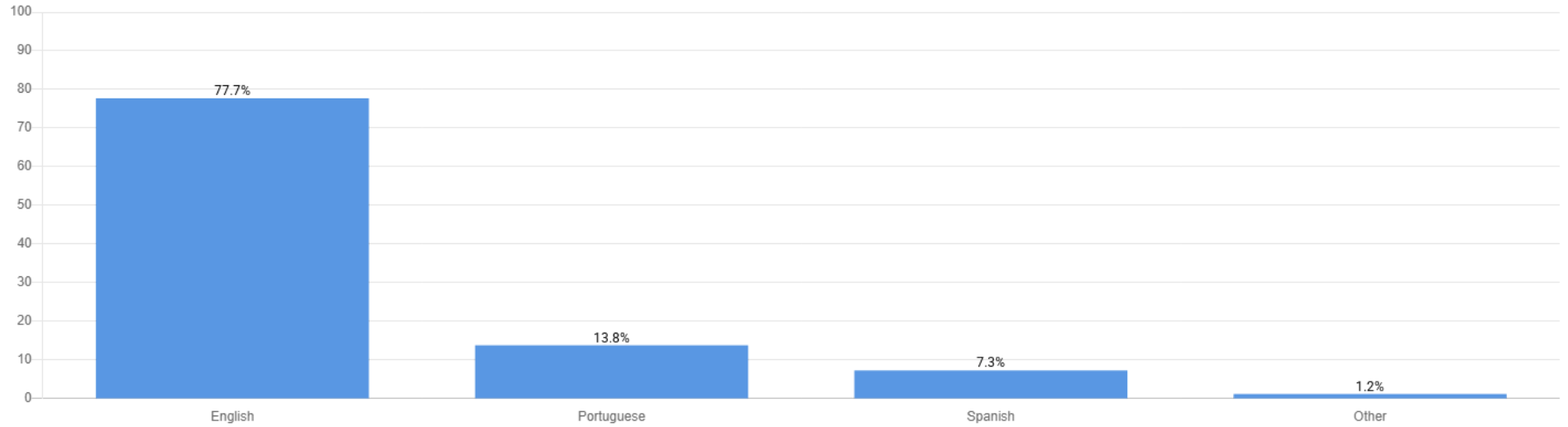

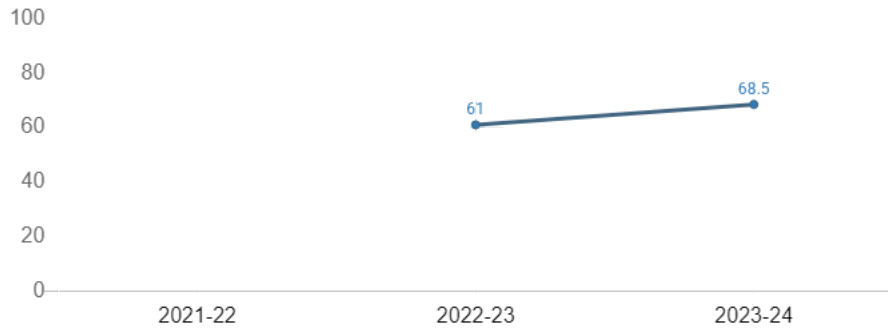

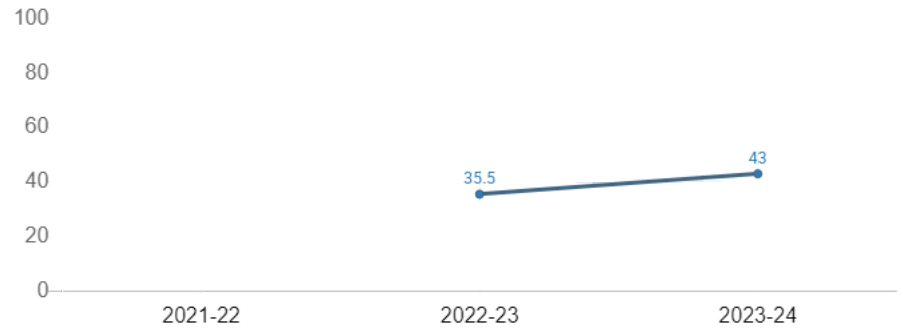

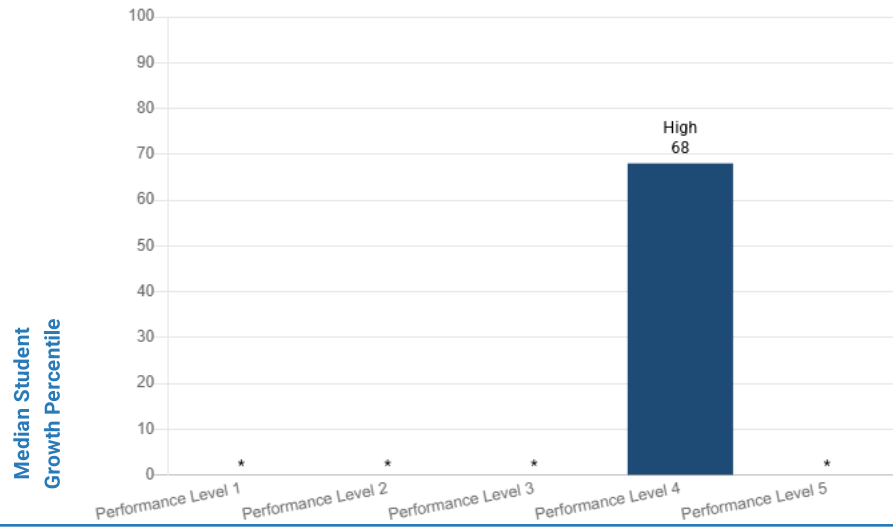

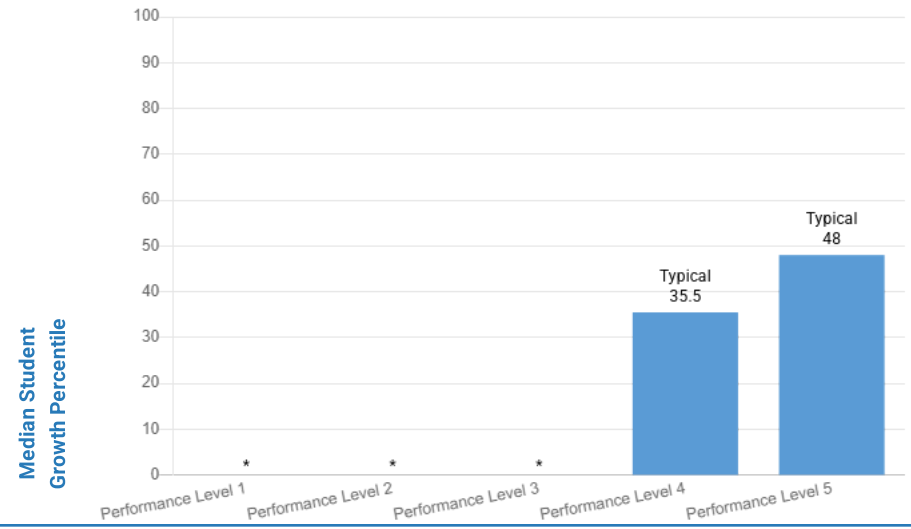

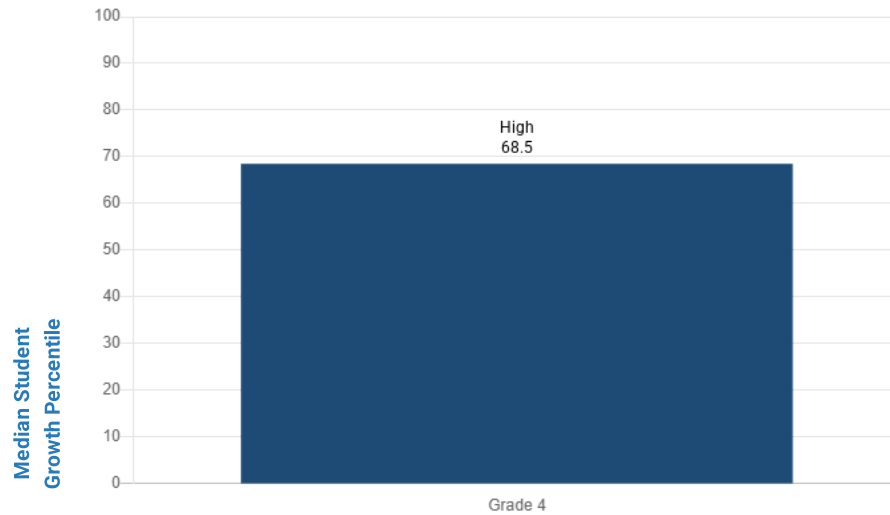

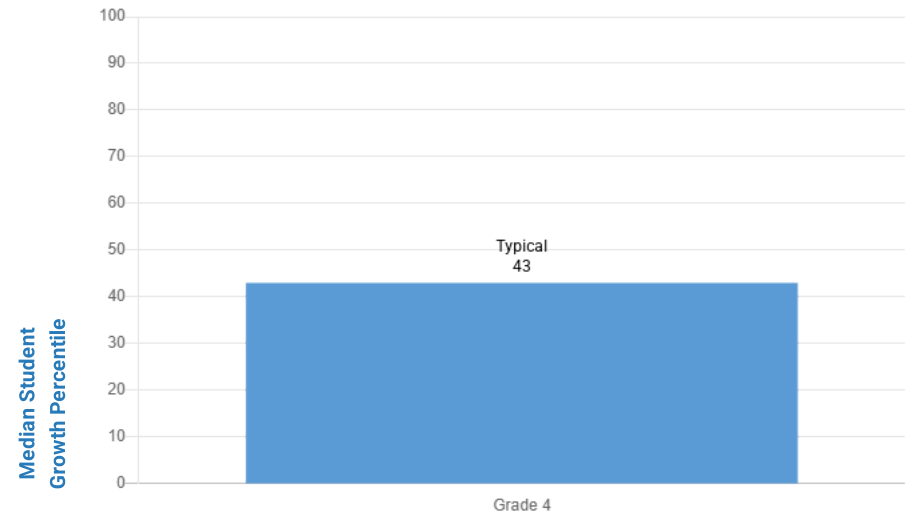

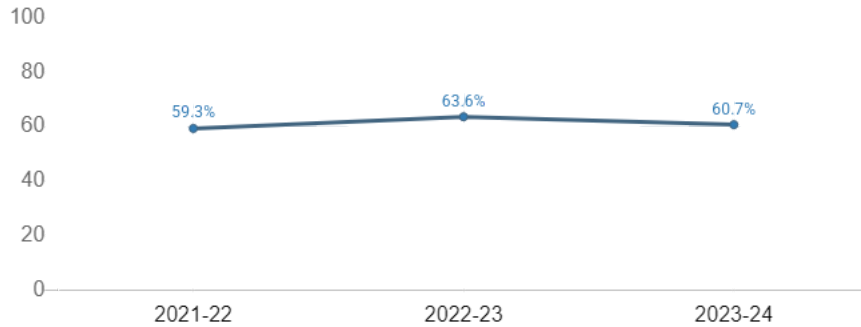

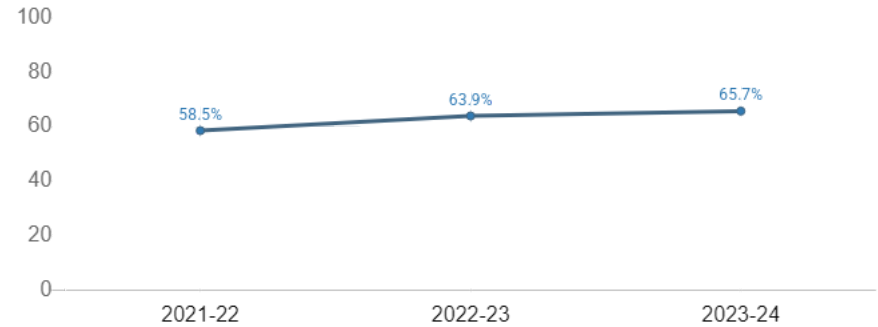
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 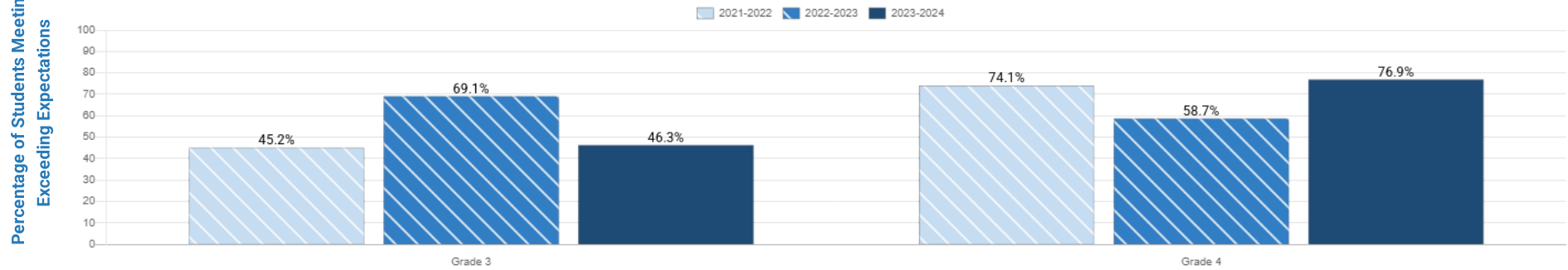

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

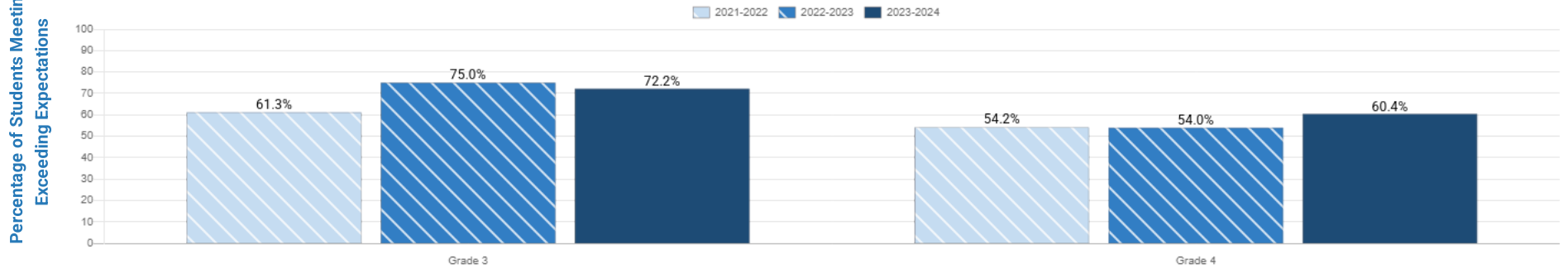

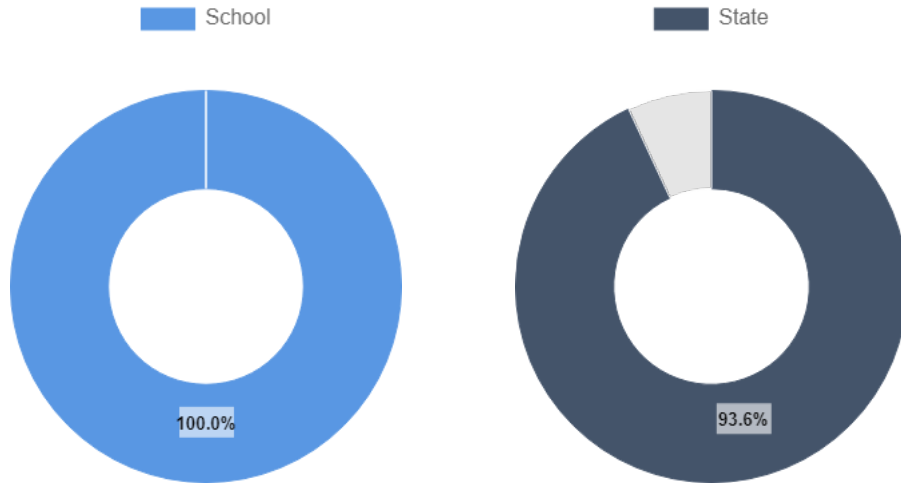

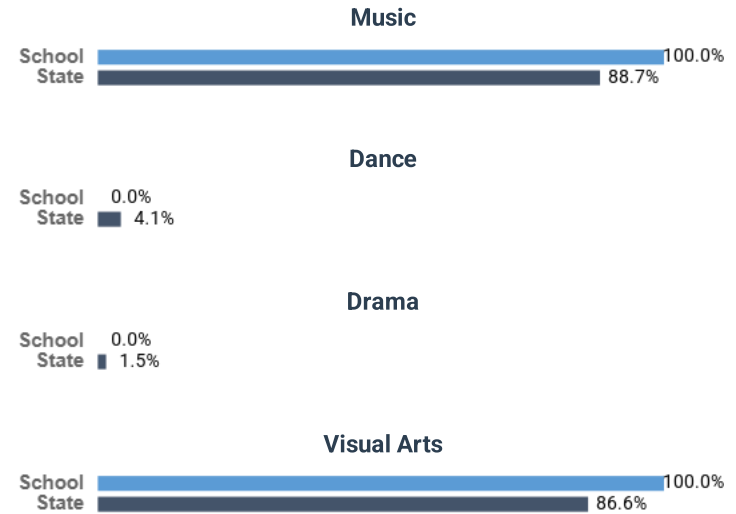

Students enrolled in one or more classes by discipline:



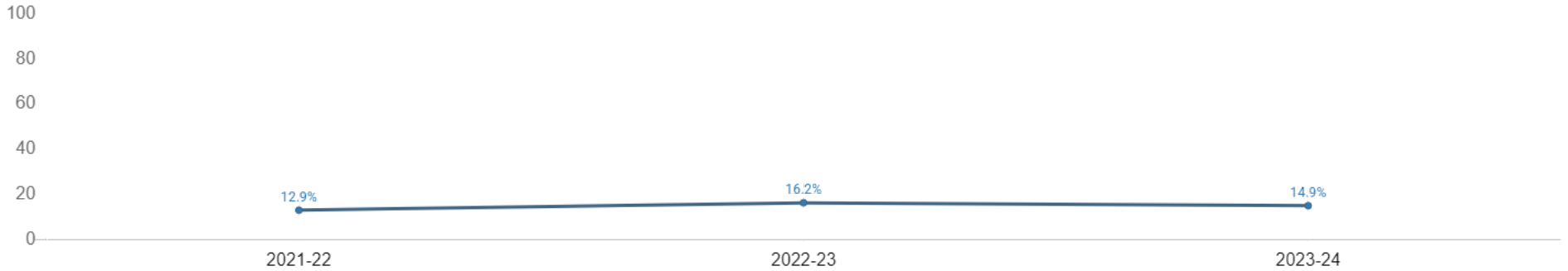

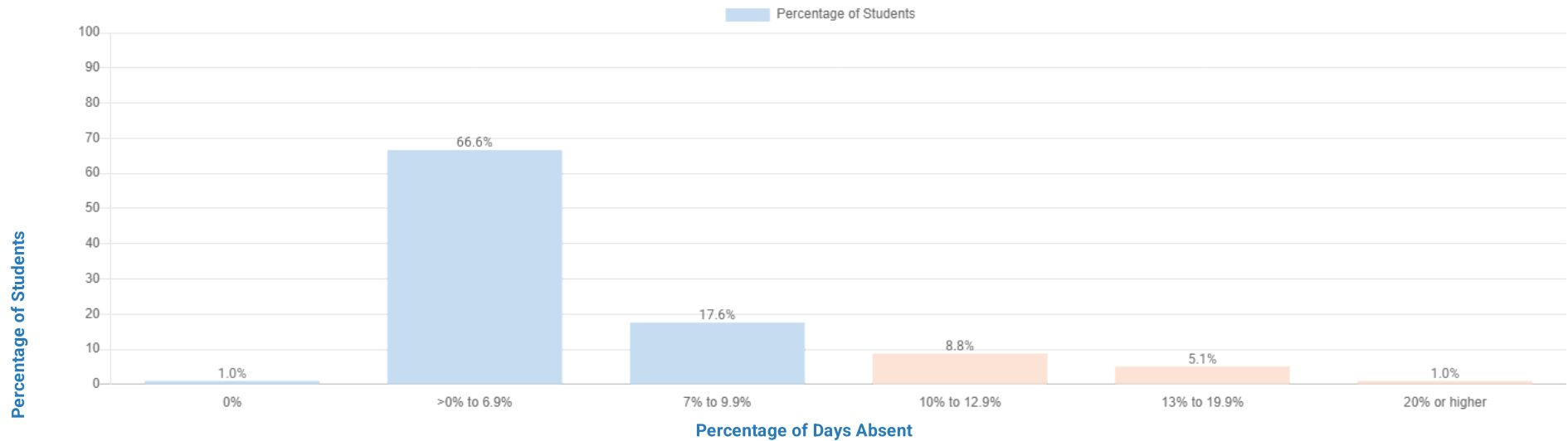

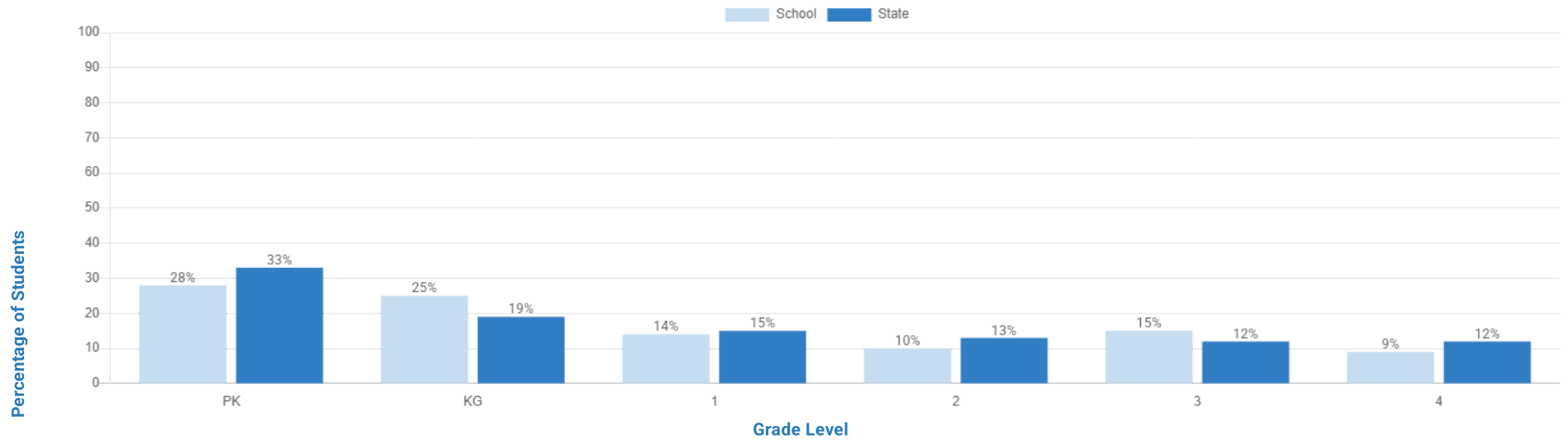

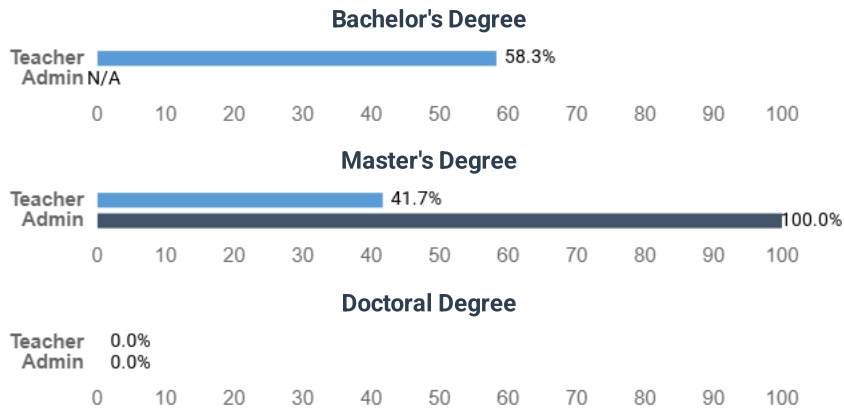

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The standards-based curriculum is enhanced by the use of technology and the infusion of 21st century competency skills. CKLA Amplify, Inspire Science, enVision Math, and HMH Into Social Studies, are the core resources that frame our instruction in ELA, science, mathematics, and social studies. Formative and summative assessment data points serve as the foundation for our programming, placement and planning for students. Additionally, for the 2023-2024 school year math and ELA intervention periods were provided to all students daily in grades K-4. Fourth grade students have the opportunity to participate in computer club, where they explore foundational technology skills in a supportive and engaging environment. Additionally, our Books and Beyond program, generously sponsored by the West Long Branch Foundation for Education, provides an exciting recreational reading experience that builds literacy skills and encourages family involvement. A highlight of the year is the BME Spring Show, an annual event held at Monmouth University's Pollak Theatre, where students in grades PreK-4 showcase their musical and dance talents. Guided by a selected theme, this memorable production invites fourth-grade students to participate in acting and artistic roles, performing before an audience of family members and guests. Fourth-grade students are also invited to participate in instrumental music lessons, with their progress and musical skills showcased during the winter and spring band concerts.



The YMCA of Monmouth County provides a structured before- and after-school care program for students in grades K-4 at Betty McElmon Elementary School, ensuring a safe and supportive environment beyond the traditional school day. To further assist students requiring additional academic support, the Betty McElmon Elementary School has introduced an expanded after-school program for the 2023-2024 school year, offering targeted instruction in English Language Arts, mathematics, and English as a Second Language. Eligible students were invited to participate in this program based on a comprehensive review of multiple data points to ensure tailored support for those in need.



The staff and administration of the Betty McElmon Elementary School are dedicated lifelong learners, continually pursuing professional growth to enhance instructional quality and meet the diverse needs of all students. Teachers engage weekly in professional learning communities, where they collaboratively analyze student data and refine instructional practices to support student success. The school also participates in multiple regional professional development consortiums, providing access to a range of specialized training and workshops. Additionally, several on-site professional development days are embedded within the school calendar, ensuring ample time to advance district and building goals effectively.

Student Supports and Services:

Our school supports students' academic, social, and emotional well-being through a comprehensive network of services. The Intervention and Referral Services (I&RS) team meets monthly to design tailored support plans for students facing learning, behavioral, or health challenges. Follow-up checks are conducted regularly to monitor each student's progress and assess whether additional interventions are necessary. Students identified as Multilingual Learners receive targeted instruction from a certified ESL instructor, while students who qualify for Special Education services receive support based on their Individualized Education Program (IEP). Our Special Education services include a full range of programs, along with specialized resources such as speech, occupational therapy (OT), physical therapy (PT), and advanced reading programs. The school also has two School Counselors who provide essential support to students and families and serve as Anti-Bullying Specialists.



Student Health and Wellness:

Our school supports all students through a variety of health and wellness initiatives. Supplemental lessons provided by our school counselors focus on topics such as kindness, social responsibility, and problem-solving. Regular wellness activities such as fitness challenges and mindfulness practices are integrated into the school year to encourage physical and emotional well-being. Additionally, the school provides access to routine screenings, including vision, hearing, and scoliosis checks, and a school nurse is on hand to support students' medical needs, administer medication, and provide guidance on managing chronic conditions. The school also offers after-school programs that encourage physical activity, teamwork, and skill-building. Breakfast and lunch are provided daily.



Parent and Community Involvement:

Betty McElmon Elementary School sees the school as an extension of the community. In partnership with the school community, we developed a comprehensive five-year strategic plan (2022-2027) which has already yielded significant advancements in student learning outcomes, facilities improvements, and enhanced district communication. We are fortunate to have an active PTA that sponsors a variety of activities, including a Book Fair, family fun nights, and school-wide assemblies. In addition, our Foundation for Public Education plays a critical role by raising funds for teacher grant programs and other curricularly-aligned projects. Our Special Education Parent Advisory Group (SEPAG) serves as an invaluable resource for parents of exceptional learners and ensures collaboration between home and school, and we are also supported by several advisory and improvement groups, including the Student Advisory, Parent Advisory, and School Improvement Panel (SciP).

Facilities:

Betty McElmon Elementary School is equipped with modern amenities, including full air conditioning. Recent upgrades have enhanced the school's facilities, such as the installation of a new playground, and a lighting upgrade throughout all spaces in the school. Planned improvements include new sidewalks, parking lot improvements, and field upgrades, all aimed at further improving the overall school experience for students, staff, and the community.



School Safety:

The West Long Branch School District is deeply committed to ensuring the safety and security of all students and staff. To support this, the district maintains a School Safety Team that meets twice per school year to review and strengthen safety protocols. The district collaborates closely with the West Long Branch Police Department to further enhance safety measures. A dedicated School Safety Specialist works in tandem with each school's security guard to ensure that all security practices meet the highest standards. Additionally, the district is excited to announce a new partnership with the Borough of West Long Branch, which placed a Class III Officer in the schools starting in September 2024. This partnership represents a proactive step in maintaining a secure environment for learning, providing an additional layer of support and safety for the entire school community.



Technology and STEM:

During the 2023-2024 school year, students in grades kindergarten through four were one-to-one with Chromebooks, which they utilized for a variety of learning opportunities and support. In addition to the digital platforms connected to our curricular programming, students and staff have access to supplemental technology tools for inclusion, enrichment, and instructional purposes. All classrooms are equipped with interactive display technology, and the district is transitioning to touchscreen smart displays which allow staff and students more efficient access to dynamic content hosted on cloud-based digital platforms. In Summer 2024, the district completed a wireless infrastructure upgrade that expanded our wireless footprint and capacity, making our school truly future-ready.

Early Childhood Education:

The Betty McElmon Elementary School proudly offers a free, full-day, high-quality integrated preschool program for 3- and 4-year-old children residing in West Long Branch and Allenhurst, thanks to funding provided through the Preschool Expansion Aid (PEA) grant. During the 2023-2024 school year, the program expanded to four classrooms located at Betty McElmon Elementary School. Additionally, the district has established a partnership with Kiddie Academy of Eatontown to open a fifth district-overseen preschool classroom at their location in September 2024. In preparation for continued program enhancement, the preschool instructional and administrative staff underwent comprehensive training to support a transition to the Tools of the Mind Preschool Curriculum in Fall 2024. This curriculum, designed to foster self-regulation and cognitive, social, and emotional development, will strengthen our ability to provide young learners with a solid foundation for future learning.
