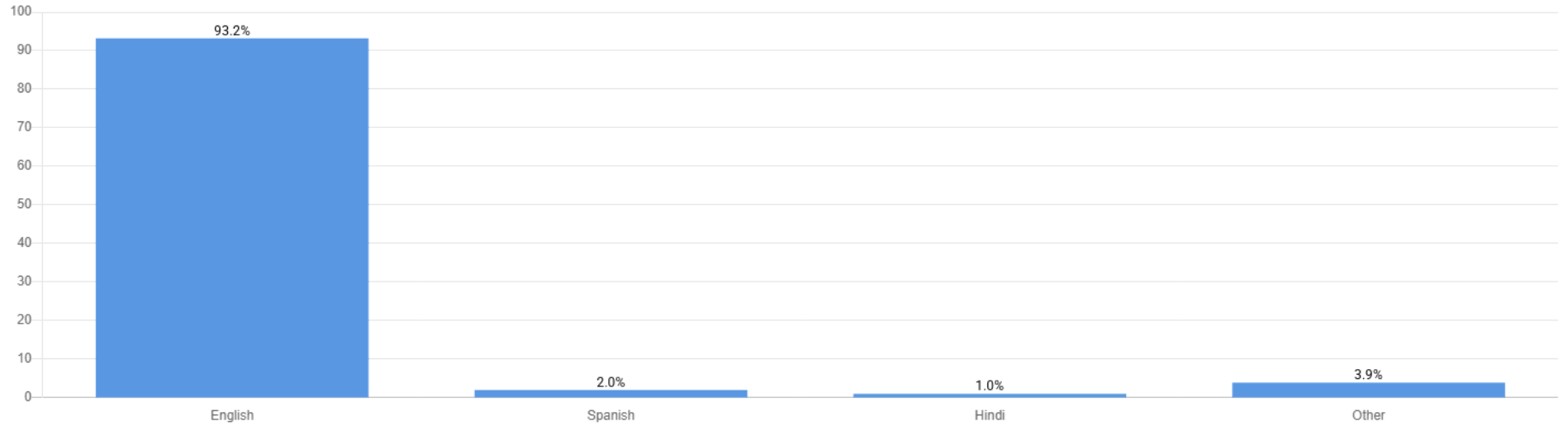

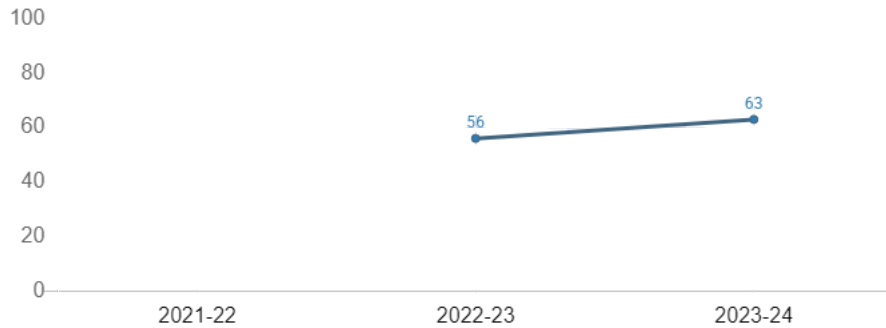

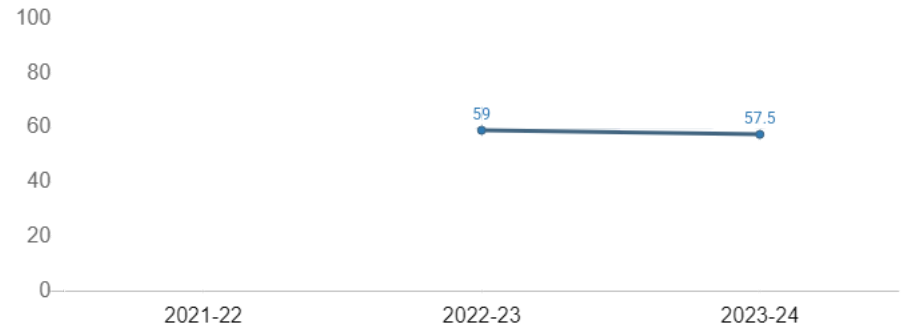

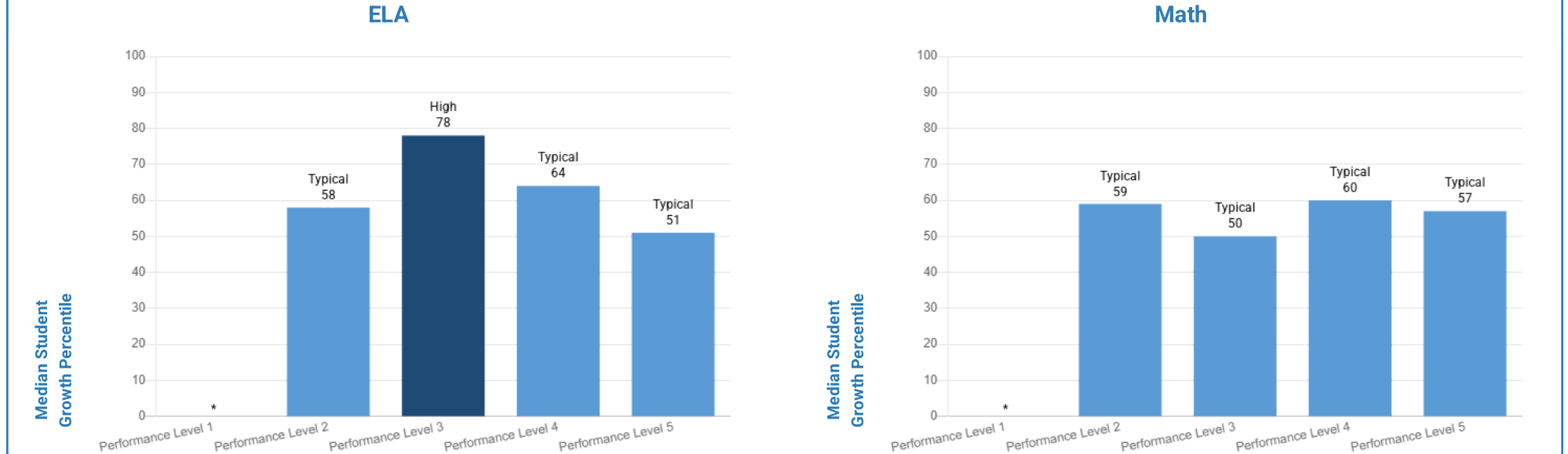

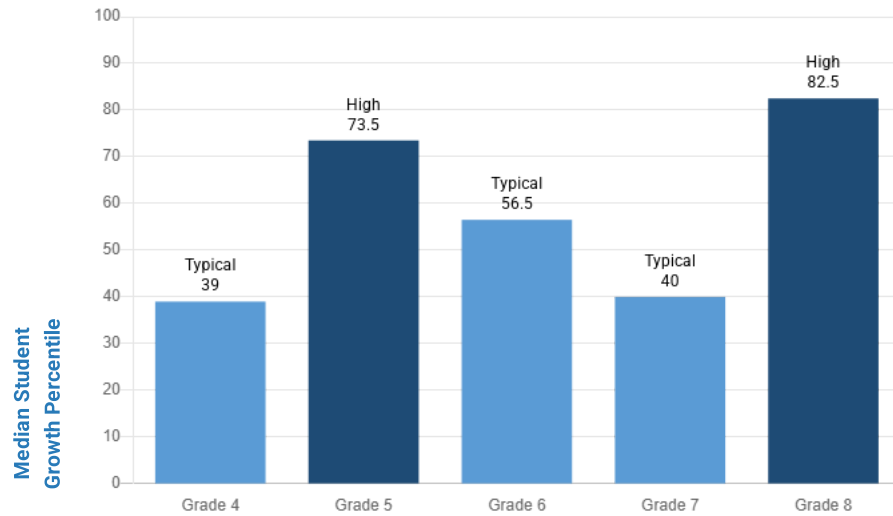

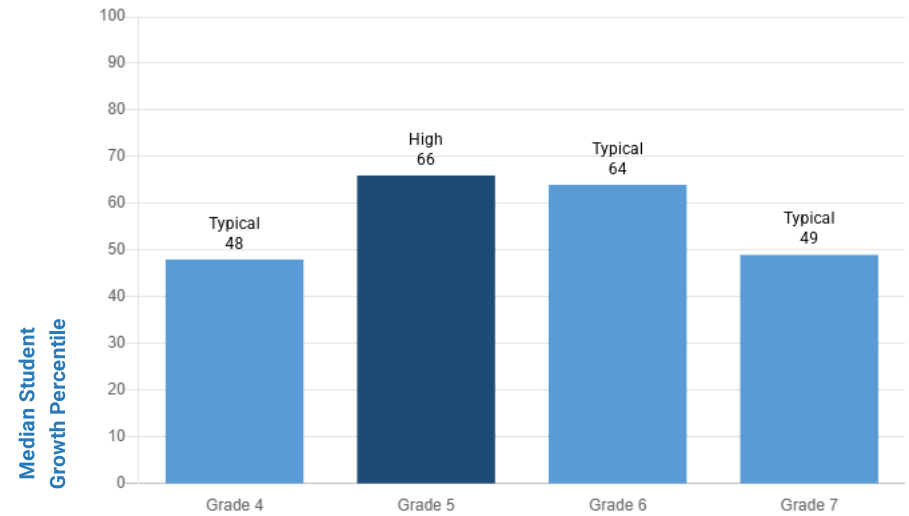

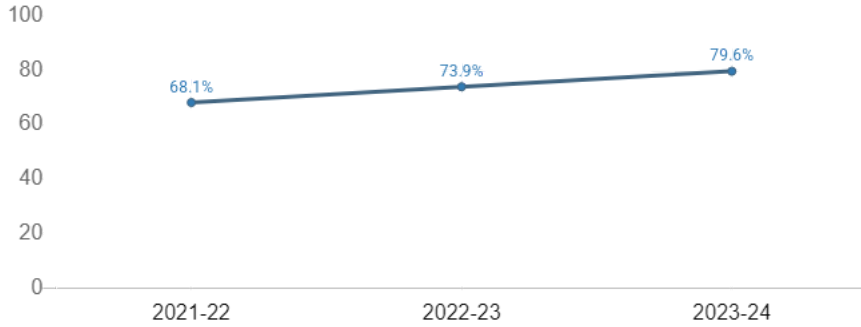

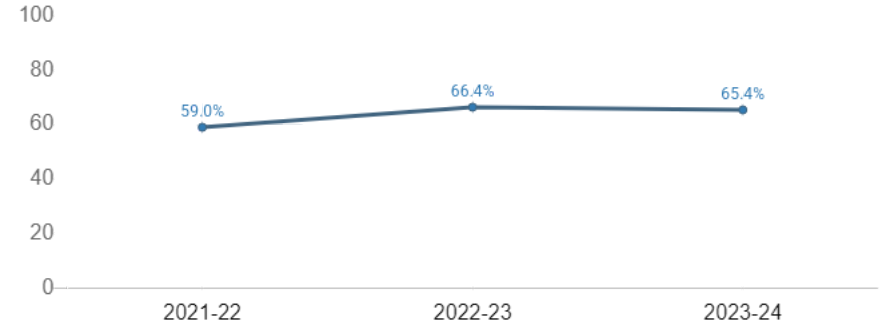
English Language Arts and Mathematics Performance Trends

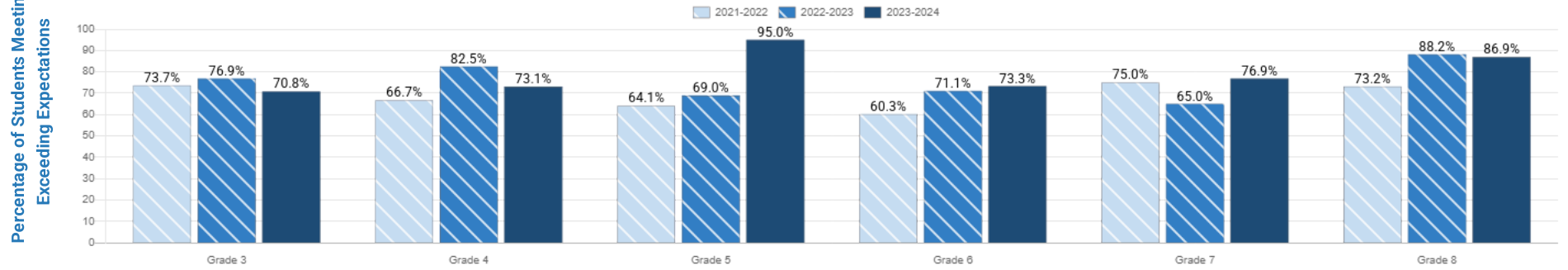

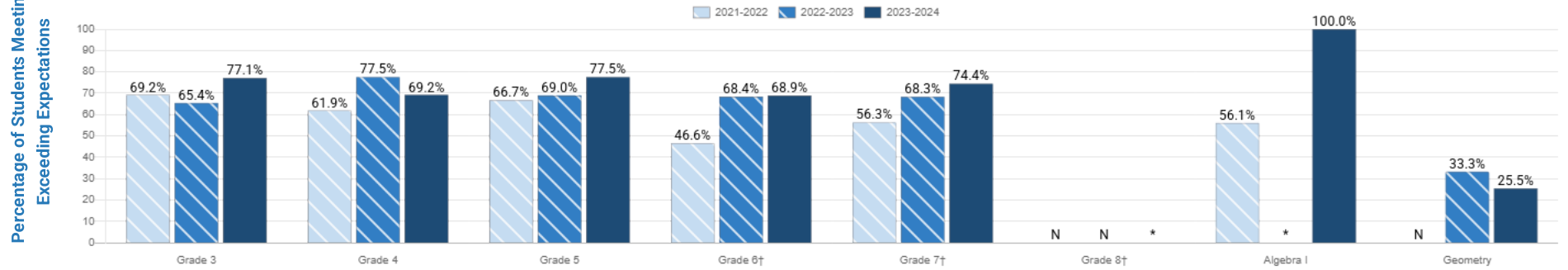

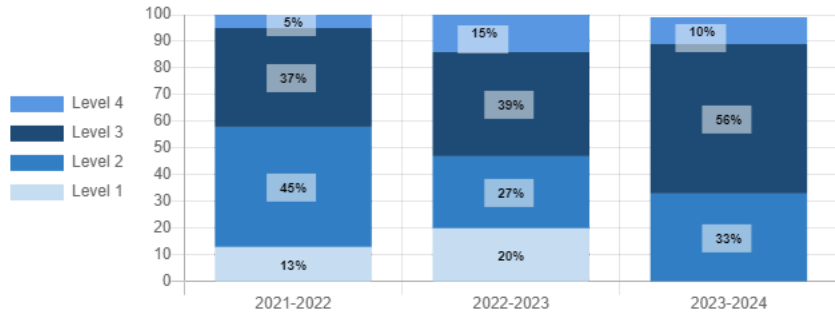

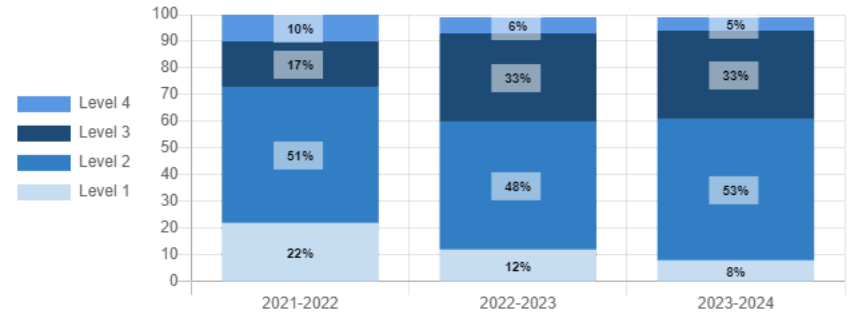

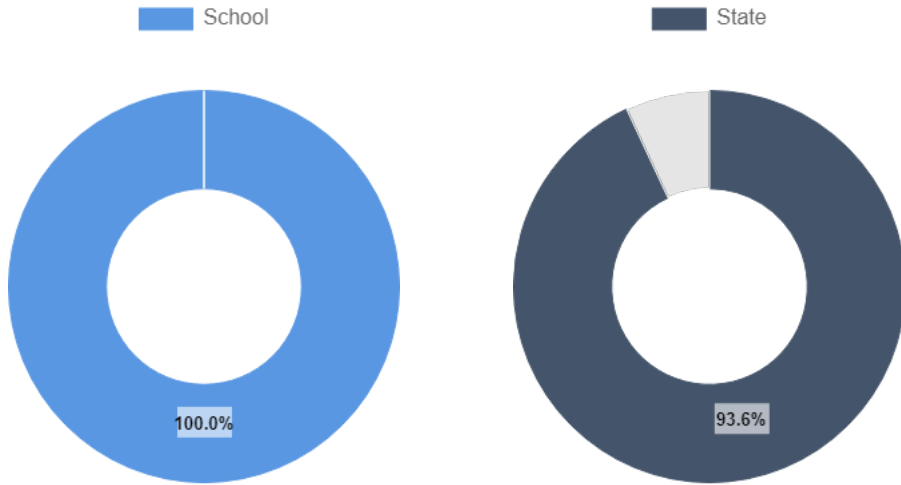

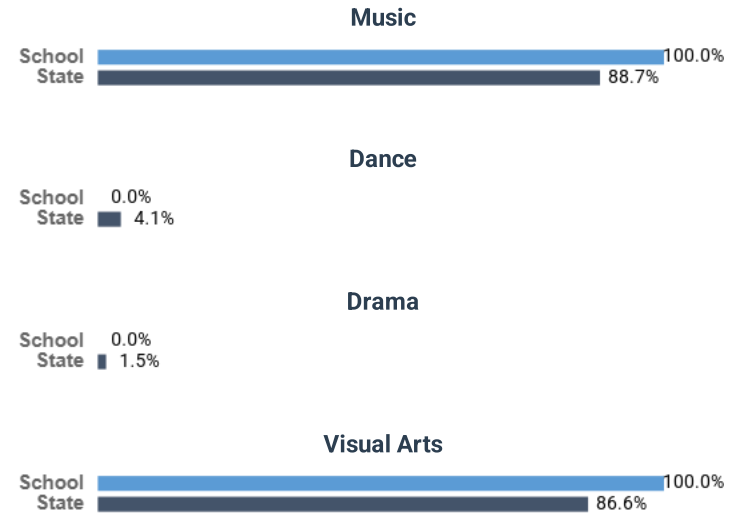

Students enrolled in one or more classes by discipline:



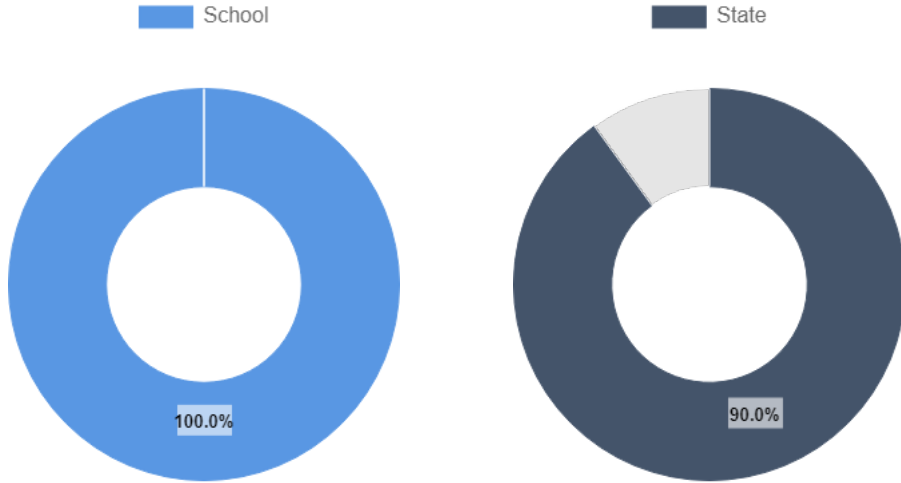

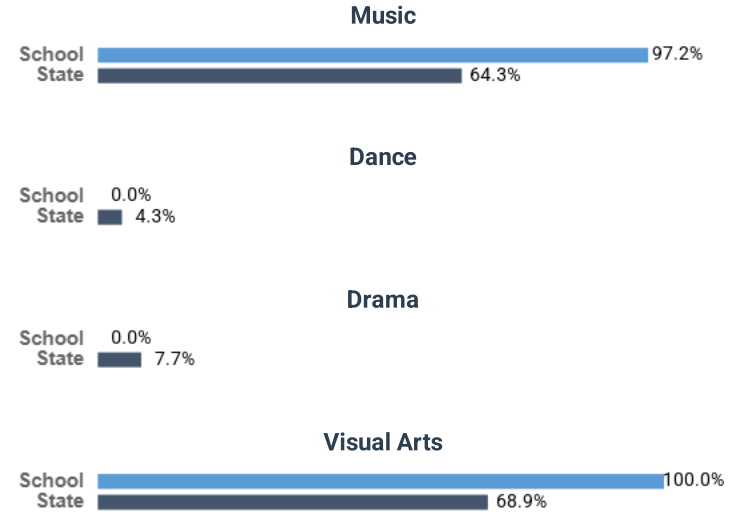

Students enrolled in one or more classes by discipline:



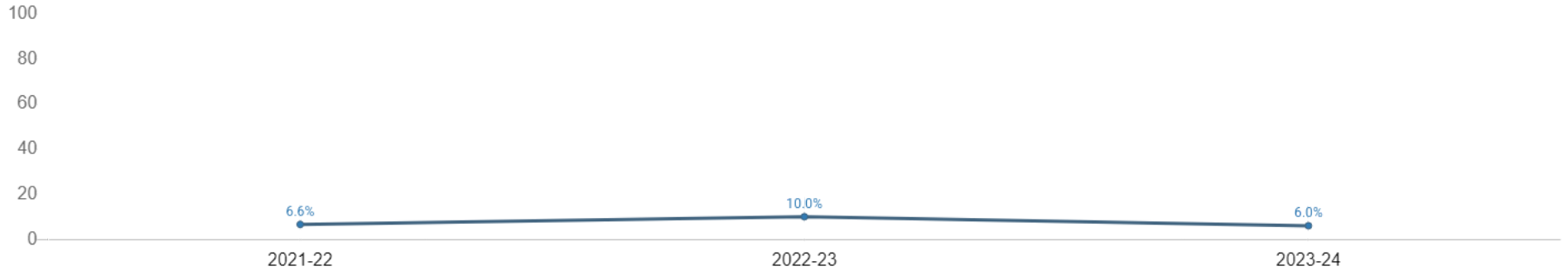
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 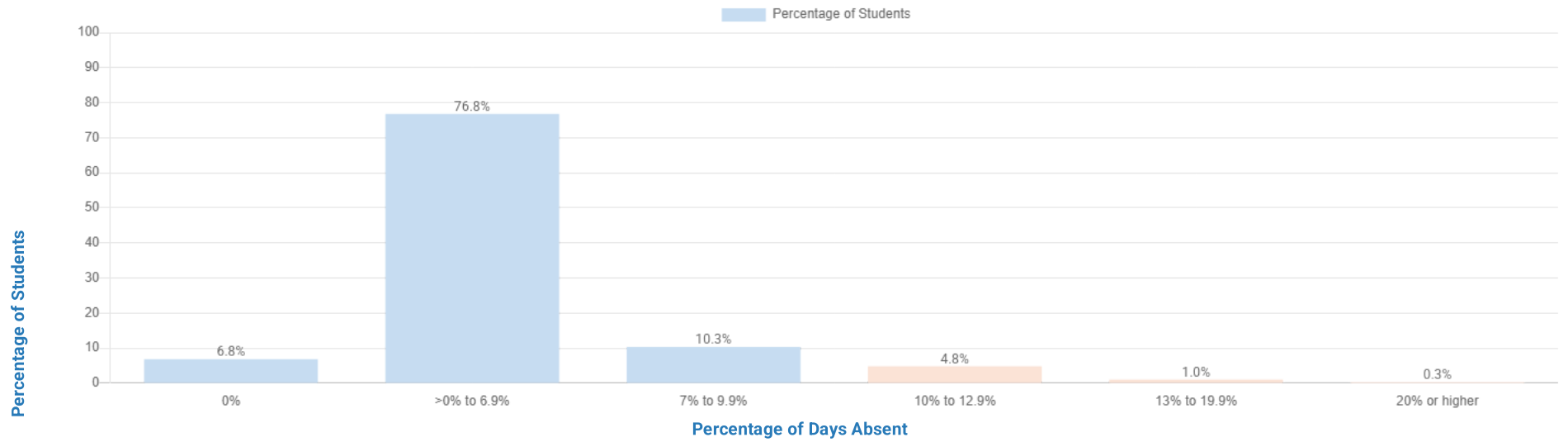

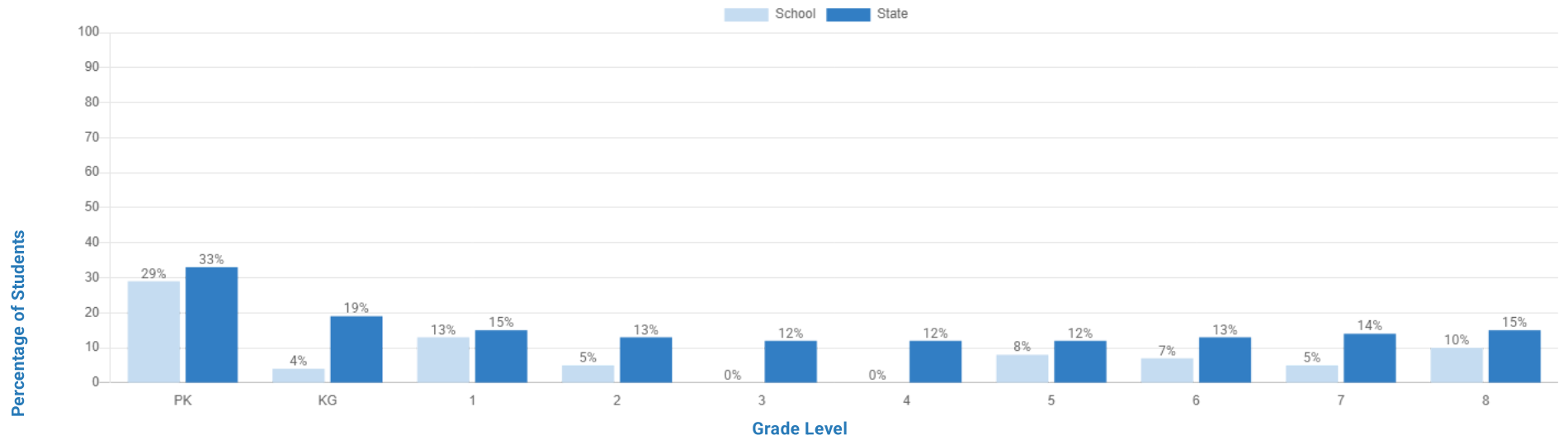

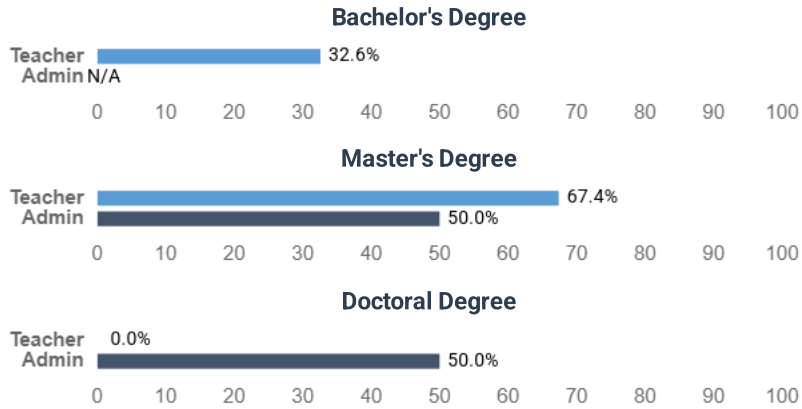

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Highlights:

- Boonton Township School District provides students in PreK through 8th Grade with a thorough and rigorous academic program while also developing social-emotional learning and 21 century skills.
- The district program allows students to pursue their passions in the classroom as well as in athletics and visual and performing arts and leadership and philanthropic endeavors.
- A 5-year Strategic Plan was created with input from a wide cross section of stakeholders in the spring. Implementation of goals began in Fall 2023. The plan can be viewed on the district website.



Mission, Vision, Theme:

The mission of the Boonton Township School District is to provide a solid educational foundation for all students, while challenging them to fulfill their individual potential. This potential is best achieved through a diversified curriculum that is aligned with the NJ Student Learning Standards and designed to meet the needs and aspirations of all students, while fostering self-esteem, independent thinking and respect for individual differences.



Courses, Curriculum, Instruction:

The Boonton Township School District aligns itself with the NJ Student Learning Standards. A comprehensive collection of curriculum maps can be accessed on the district website with learning objectives by grade and subject. Personal finance and civics are taught in select grades. The many state mandates within various core subjects (i.e., Holocaust education, etc.) are embedded within appropriate disciplines and even within cross-curricular opportunities. The S.O.A.R. program (gifted and talented) and enrichment, embedded within STEM/tech classes, provide the chance to focus on coding and programming, 3D printing and robotics.

Sports and Athletics:

Rockaway Valley School participates in the Greater Morris County Junior Schools Conference. All sports remain competitive each season as student enrollment and athletic teams are strong. Athletic teams have secured multiple County championships. In each sport, student-athletes are exposed to various foundational skills that teach them an appreciation for the game and that help to foster an aptitude for the sport that will benefit them into their high school years.



Clubs and Activities:

Rockaway Valley School offers clubs that extend learning and allow students to try out a variety of activities. The options include forensics/debate, academic bowl, broadcasting, student council, service squad, and environmental club. Club sports include ski club and volleyball. An extensive after-school enrichment program is offered in three semesters each year through the Boonton Township Education Association and covers topics ranging from crafting to cooking, dance and drumming. The BTEF also sponsors the annual musical production.



Before and After School Programs:

Staff and Professional Learning:

Teachers at Rockaway Valley School are involved in many types of professional development from on-line webinars to in-person trainings and workshops. In any given year about 10% of faculty are enrolled in graduate programs. In addition, on-site training on topics that range from social-emotional learning to increasing proficiencies in up-to-date technology are offered to faculty by the District.



Student Supports and Services:

Rockaway Valley School offers numerous supports for students who struggle. The Child Study Team works with teachers and parents to identify students and craft Individual Educational Programs that meet the requisites of each child's identified needs. All teachers offer two extra-help periods per week, before and/or after school, to any child with questions, wanting to bolster their understanding of a topic or who may have missed a concept when it was initially taught. Students who fall behind in homework are referred to Homework Club to catch up and boost their organizational and time management skills. In addition, the school also offers Extended Instructional Support (EIS) to students recommended by their teachers for remediation in ELA and math. A recess Wellness Lab is in place three days per week for students who need a quiet refreshing break before afternoon classes.



Student Health and Wellness:

Rockaway Valley School offers a comprehensive Health and Physical Education Program with all students participating in PE classes for 80 to 120 minutes per week. All students also engage in 20 minutes of recess daily. The school has a playground with up-to-date equipment and a fitness park as well. The school takes part in DARE, Jump Rope for Heart, Fatal Vision goggles and more. Student leadership groups meet often with school administration to discuss various topics that impact their academic and social lives. The school also brings qualified presenters to deliver age-appropriate programs to students on topics like internet safety and cyberbullying.

Parent and Community Involvement:

These two organizations provide enrichment programming and funding for programs and equipment outside of the district's normal budget. Parents may also participate on ad hoc committees of the administration. Parents help out at lunch, in the library, with after-school, fund-raising events and in so many more ways. Teachers may invite parents into the classroom to supplement learning on cultural, vocational or seasonal topics among other contributions.



Facilities:

The Boonton Township School District maintains one school building, housing grades PreK through 8. The District has a send-receive relationship with the Mountain Lakes School District for grades 9 - 12.



School Safety:

Rockaway Valley School strives to maintain the safest possible environment for students and staff. Many improvements to safe building access have been made over the past several years and policies/procedures have been updated to reflect up-to-date practices in security. Video monitoring of both inside and outside the building allows real-time surveillance. A close relationship with the local police department is maintained with frequent site visits and programming. Outdoor lighting improvements have been completed to insure safety in the parking lot and around campus during evening events/programs. The District hired Class III officers at the beginning of the 22-23 School Year.

Technology and STEM:

Students in grades 5-8 enjoy 1-to-1 school-assigned Chromebooks to assist in daily schoolwork and technology needs. Teachers are well-versed in Google Classroom and Promethian Board technologies. In addition to Tech Education instruction, all teachers embed opportunities to learn STEM skills across all subjects. Interdisciplinary projects frequently highlight students' ability to apply STEM skills throughout all fields of study.



Early Childhood Education:

Rockaway Valley School offers an Integrated Preschool Program with both learning disabled and typically developing students studying and discovering together under the guidance of two teachers and the requisite number of classroom aides for a given year's cohort of learners. Families of typical students apply for available spots and are responsible for tuition with options for 3-, 4-, or 5-day enrollment. Busing is available.



Attendance:

Over the past several years, ESSER funding (Elementary & Secondary School Emergency Relief) has been used to maintain health and sanitation through the purchase of HEPA air purifiers, HVAC filters and more. A new school counselor was hired to target students who were showing signs of learning loss and social/emotional struggles and also to support teachers and parents with social/emotional learning lessons and meaningful suggestions. Our counselors run a Wellness Lab 3 times per week during recess for students who prefer a quiet brain break with low-key activities. Our homework support program assists those who need help with executive functioning. A variety of "beyond the school day" activities such as the annual musical, talent show, band rehearsals, enrichment classes and before/after school teacher help periods further engage students in the diversity of their needs and interests.
