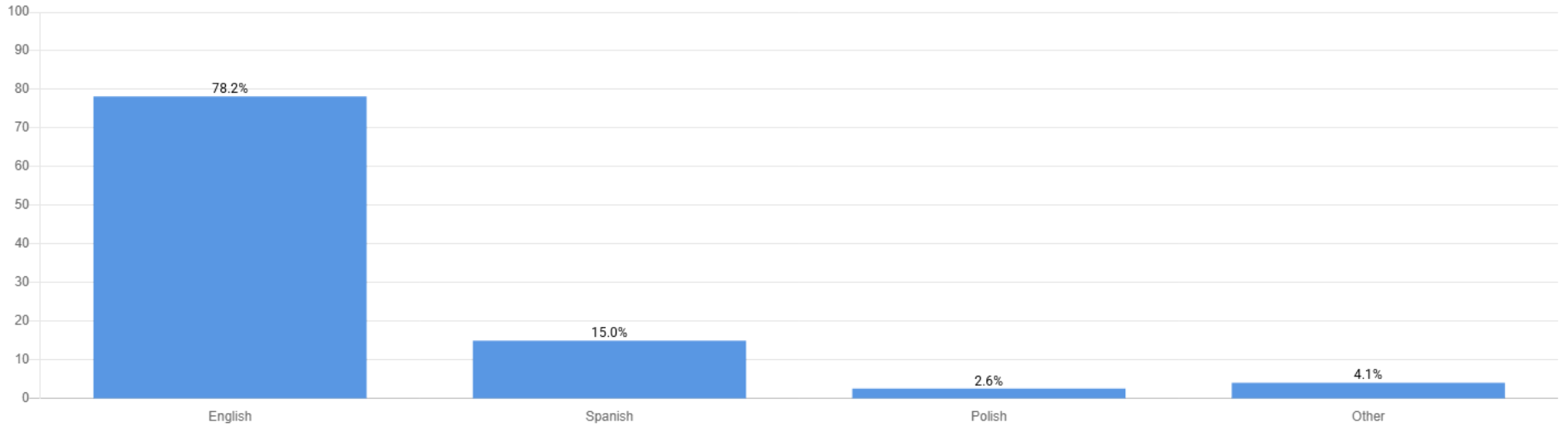

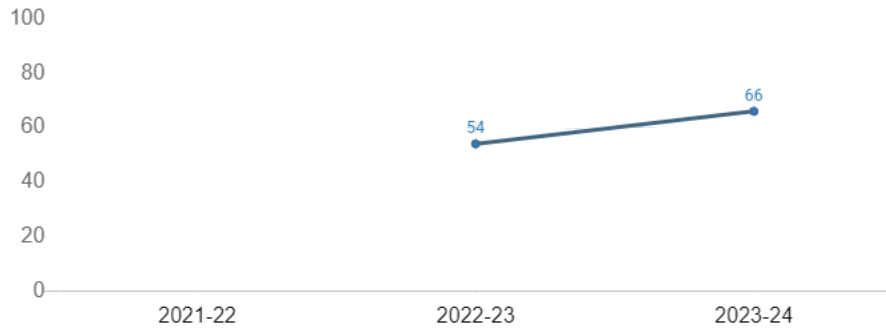

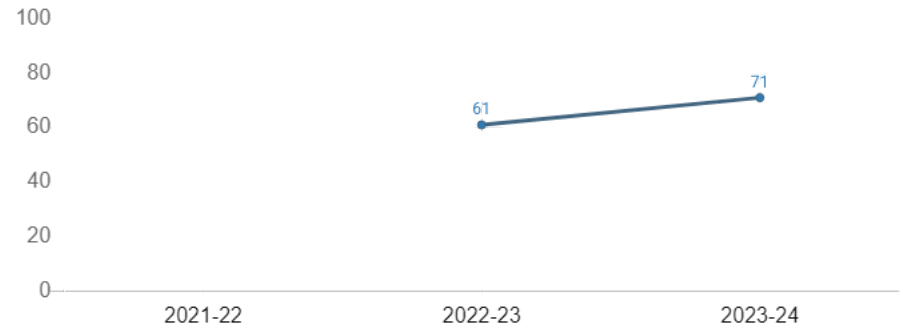

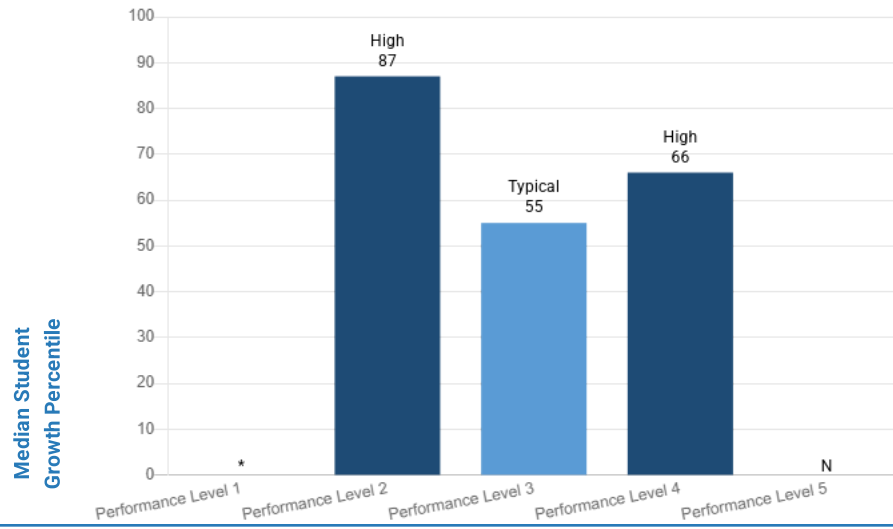

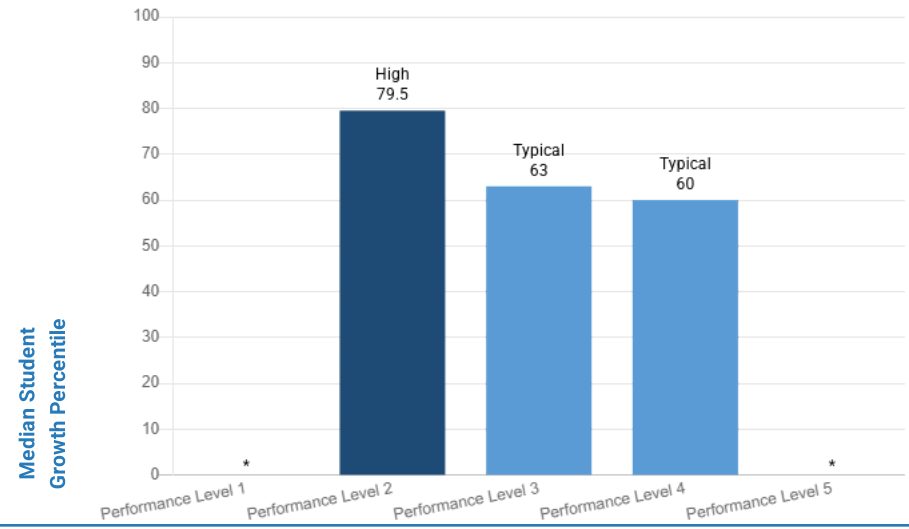

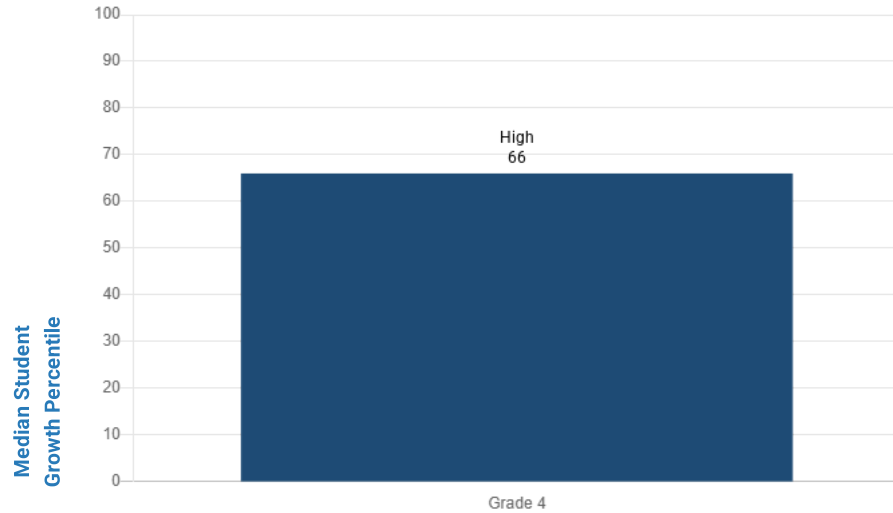

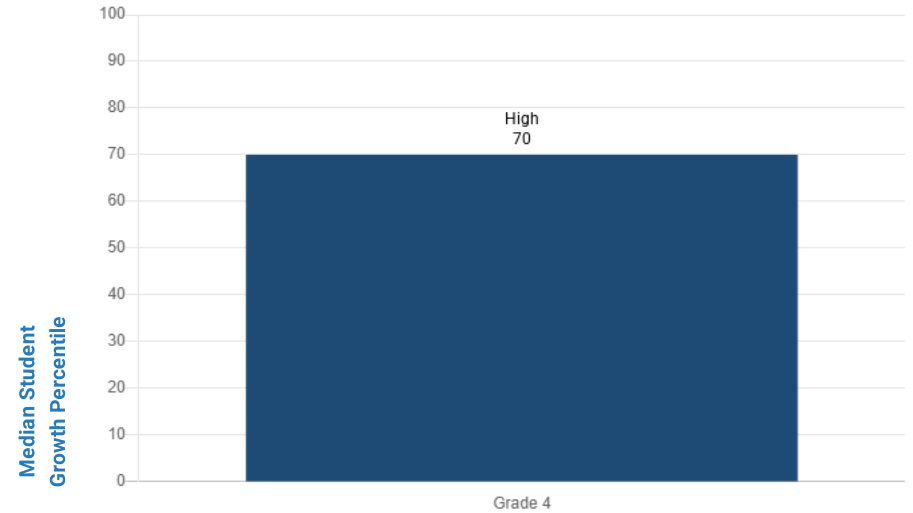

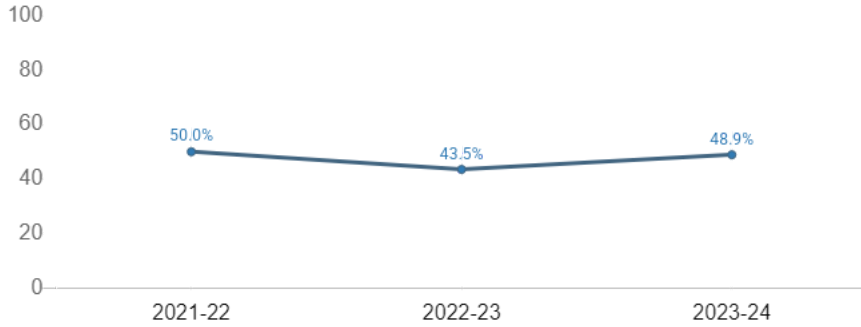

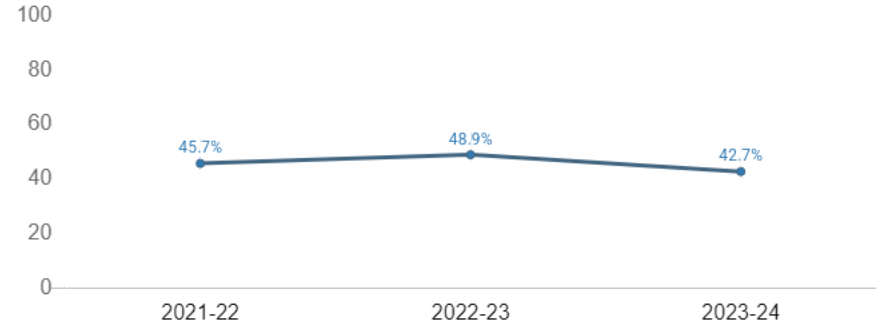
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 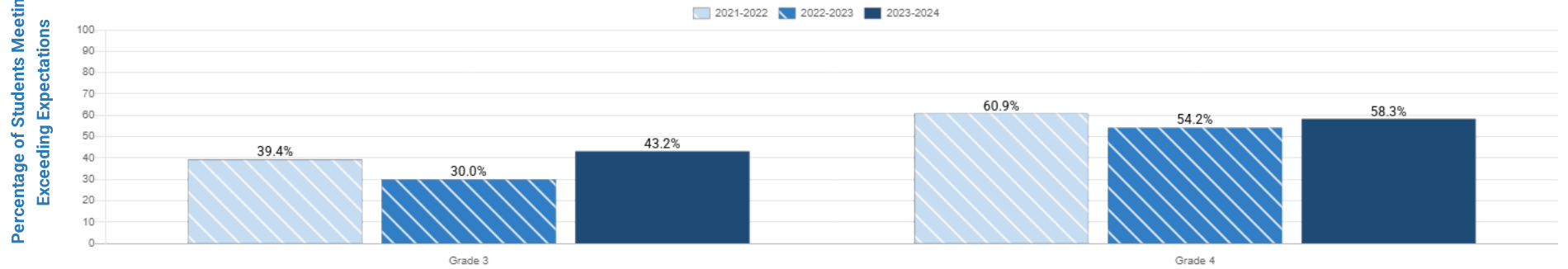

High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 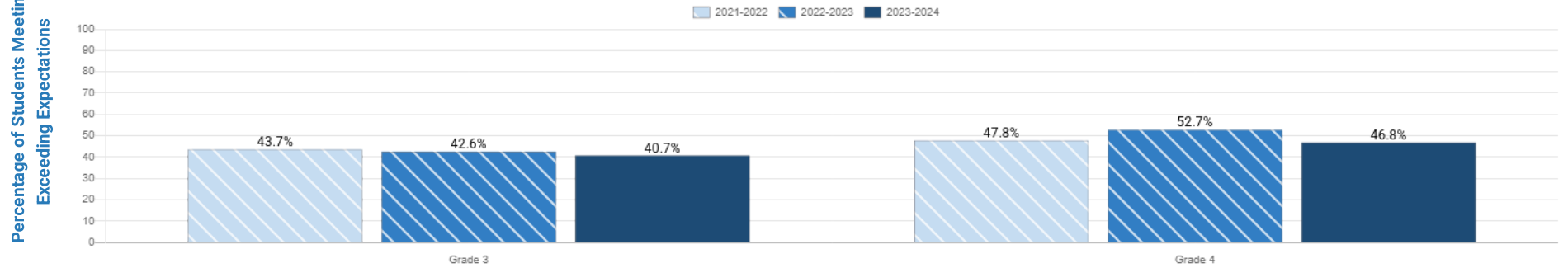

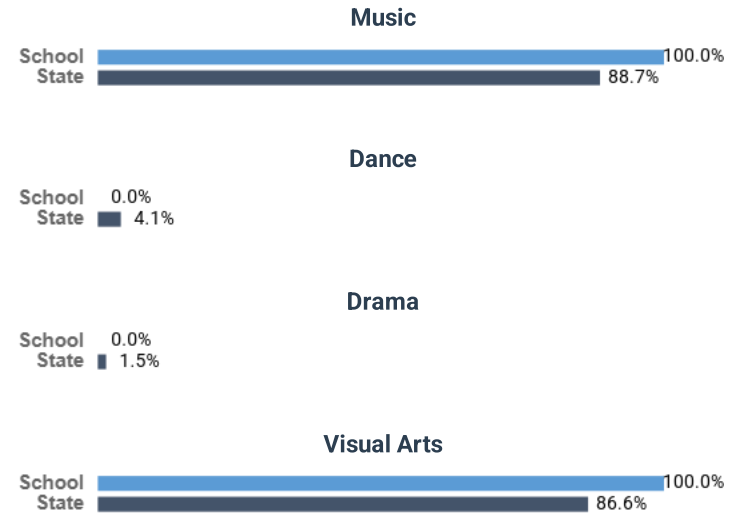

Students enrolled in one or more classes by discipline:



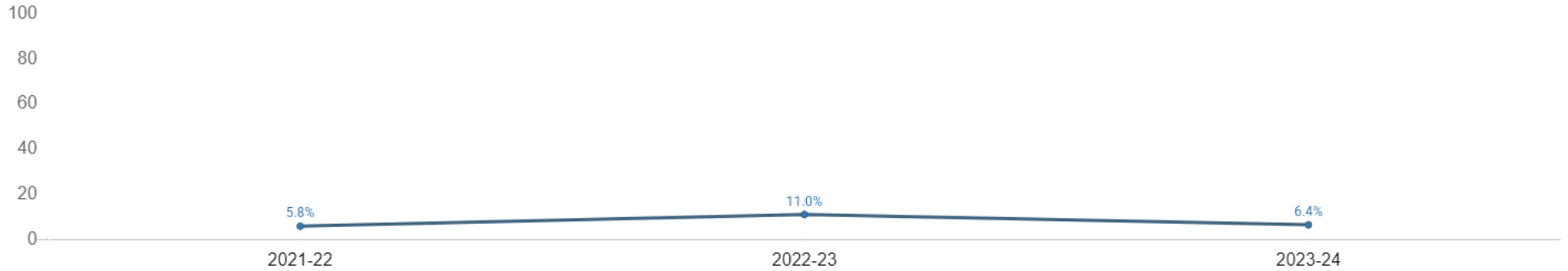

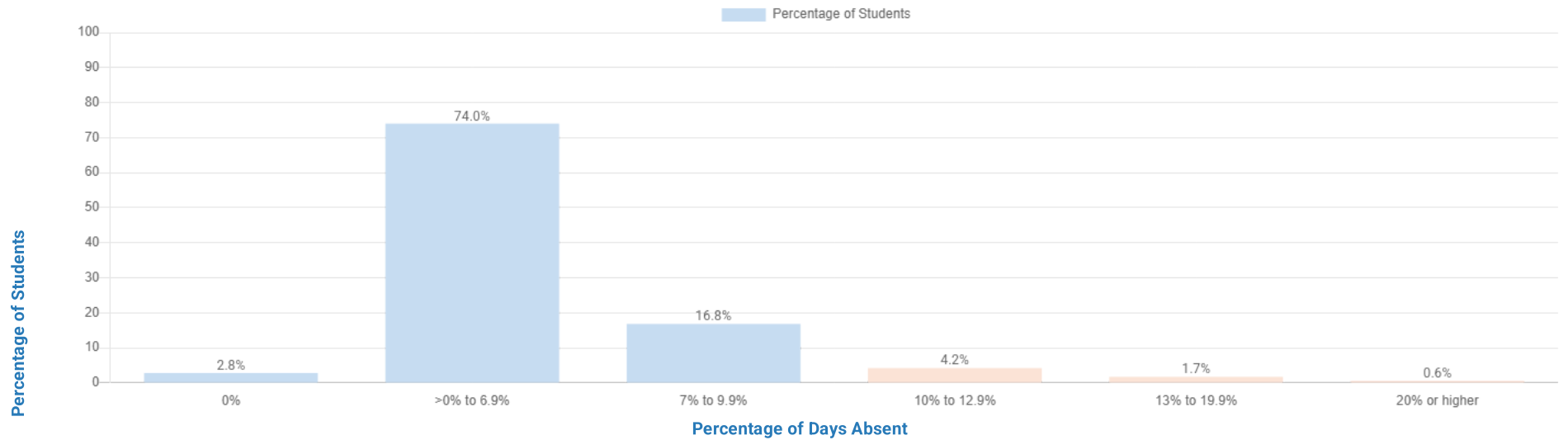

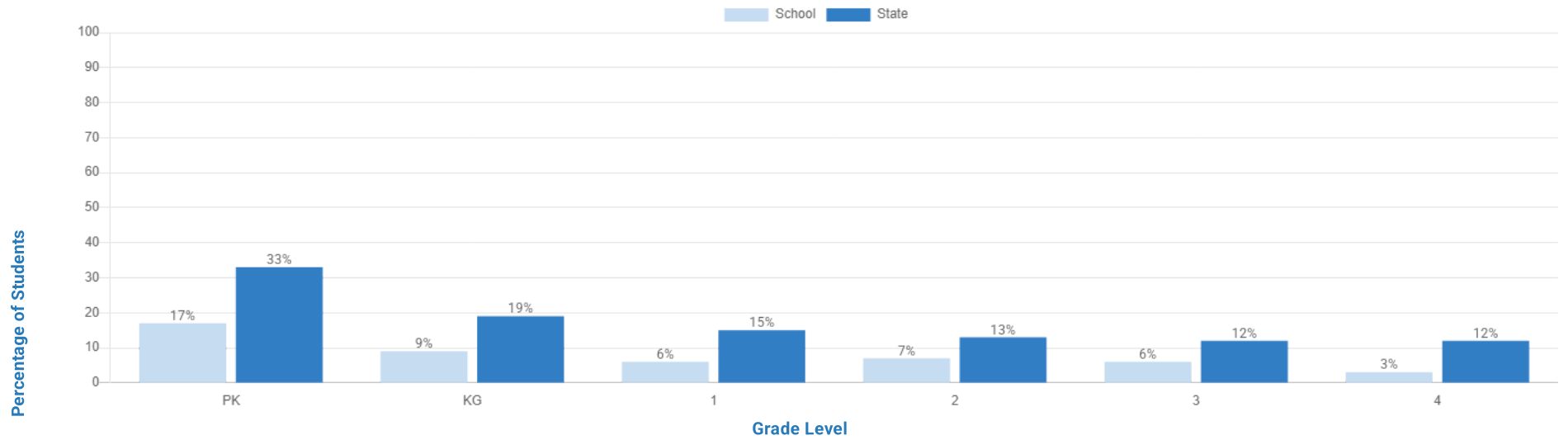

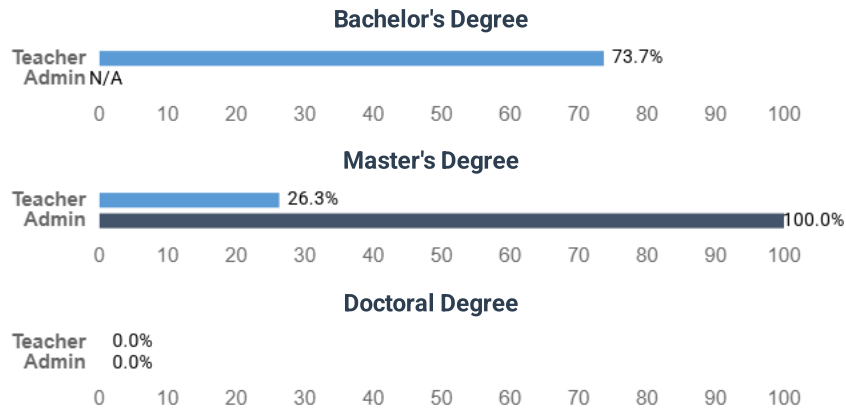

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ADS delivers the New Jersey Student Learning Standards in a supportive and inclusive environment at each grade level. Grade level teams plan lessons and review data frequently to keep the continuum of learning and growth moving forward in all areas of the curriculum. In addition to core academic subjects, Aaron Decker School offers strong programs in the Arts, Physical Education, and Technology. Using the School-wide Enrichment Model (Renzulli), a state of the art MakerSpace (STeAM) lab (Science, Technology, Engineering, Arts, Math) has been constructed at Aaron Decker School to allow our students to apply their knowledge in a hands-on learning environment.



Clubs and Activities:

T.R.A.C.K program, activities through our Culture and Climate committee (various drives and programs) along with many BASE programs run through our PTA. There are music concerts and art shows throughout the year.

Staff and Professional Learning:

All teachers participate in professional learning during workshops offered on full and half day in-service days. Teachers collaborate during grade-level meetings and curriculum committees.



Student Supports and Services:

Aaron Decker School offers a comprehensive special education program for students in grades PK-4. Students are programmed in the least restrictive environment in either our in class resource programs, pull out resource sections, LLD program or MD program. Related services such as a BCBA, Occupational Therapy, Physical Therapy, and Speech Therapy are available and provided to students on a regular basis. ADS offers ML programming to students learning the language and supports the students in multiple modalities. ADS utilizes a multi-tiered RTI system of support for struggling learners. A reading specialist and math specialist are on staff to assist as part of the RTI process. ADS also provides a HALO period (academic assistance period every day) along with a Gifted and Talented program for students.



Student Health and Wellness:

"All students receive Physical Education (P.E.), which includes a comprehensive curriculum covering nutrition, personal wellness, and fitness standards. Students participate in P.E., health lessons, and activities, and enjoy daily recess. Additionally, a breakfast program is available to all students. We have integrated a mindfulness block into the daily schedule, supported by a full-time counselor who focuses on the social and emotional well-being of our students. We have implemented a district-wide mindfulness movement to develop the personal and social skills of our students. Both students and teachers use self-regulation techniques, mindful breathing, and growth mindset strategies aimed at fostering personal growth and self-awareness. ADS also has a full-time school nurse who provides care to all students and staff and offers programs to parents, staff, and students.

The Parent-Teacher Association provides students with a variety of services, materials, and enrichment activities that reinforce, expand, and complement the instructional program. We have a parent portal that all parents are given access to. We partner with the Butler Police, local churches and other community groups.



Facilities:

ADS is a two story building. We have made many renovations to our building recently including an updated security and camera system, UV lighting, ceilings, and flooring. We added a new digital marquee to announce events and other important information. Many of our individual rooms have air conditioning and we continue to add more each year. ADS has a Makerspace Lab, Gym/cafeteria, media center, art room, and music room. ADS has a brand new playground which was recently installed.



School Safety:

Meetings and a strong partnership with Butler Police Departments. Updates to doors and security camera systems. New vestibule installed for main entrance. Raptor system installed for visitor screening. ADS has a School Safety Team/Culture and Climate Team/BTAM team. Extensive EOP and safety plan which is shared with staff and Butler Police. ADS has a part time RPO on duty. Security drills are completed on a monthly basis as per NJDOE guidelines.
