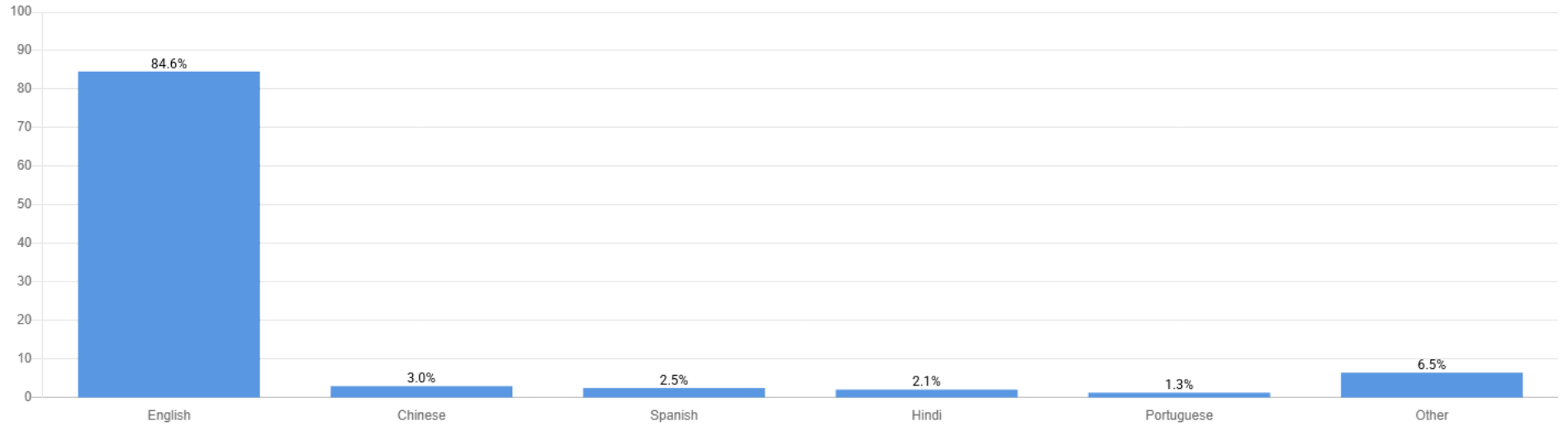

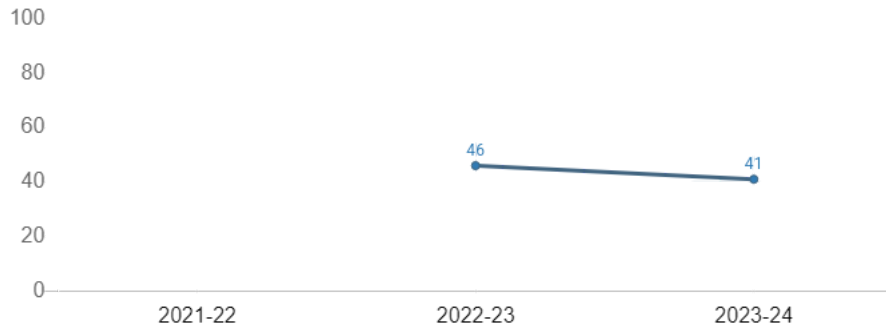

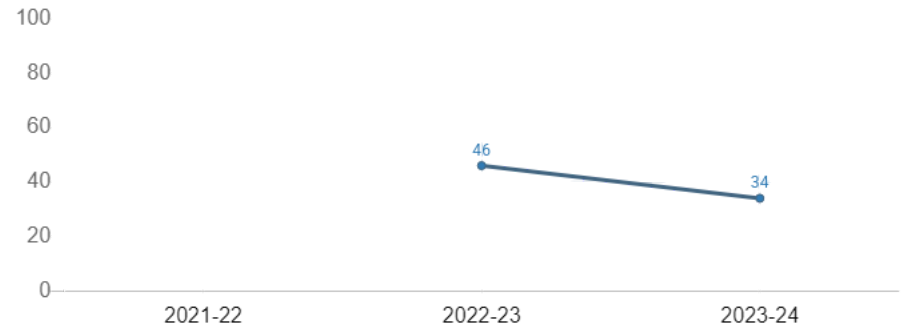

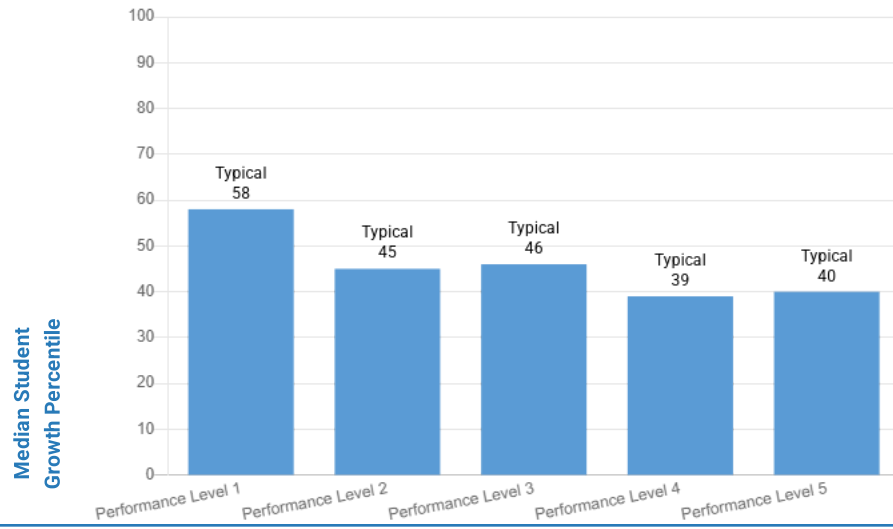

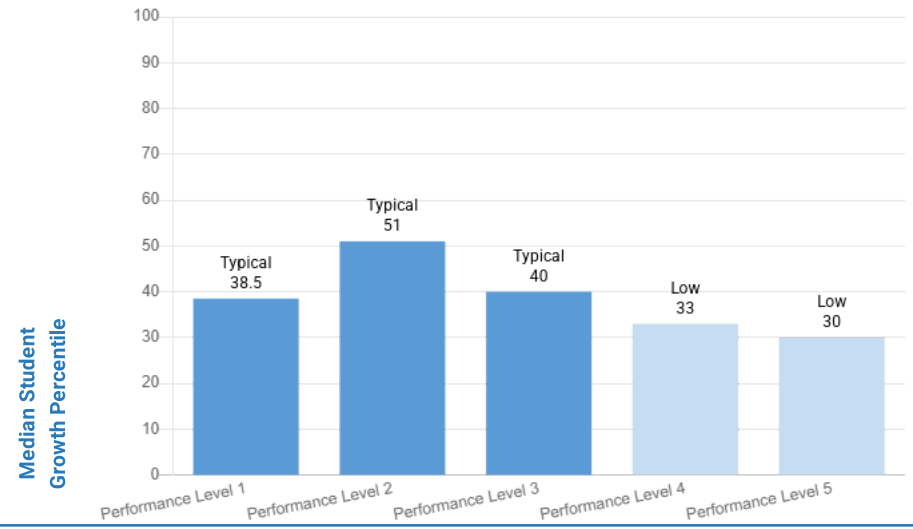

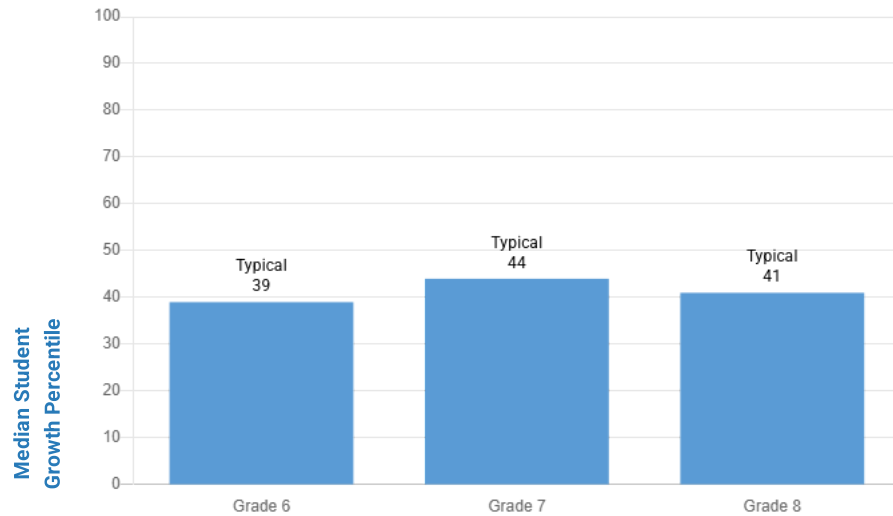

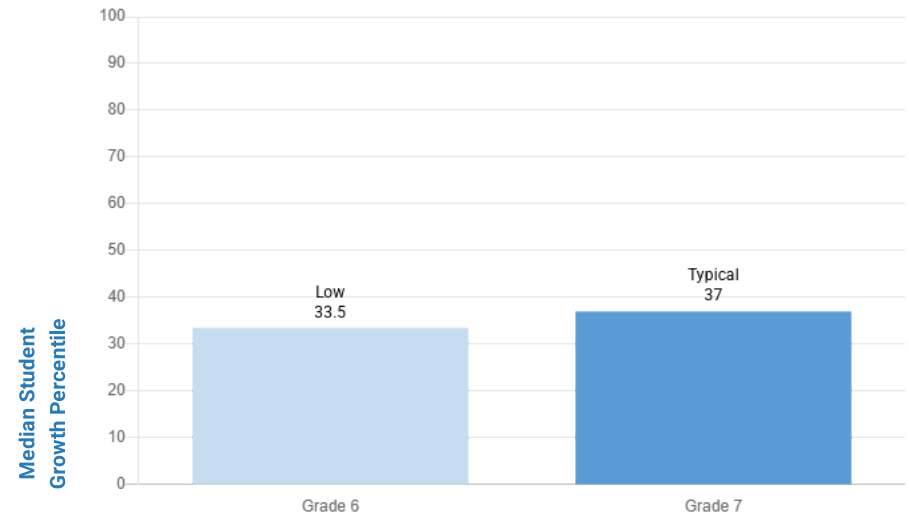

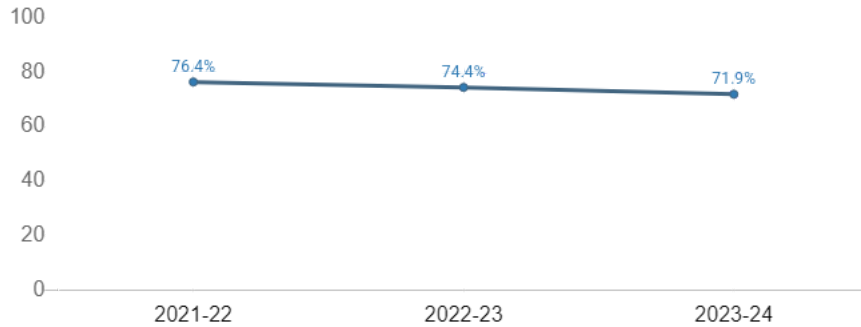

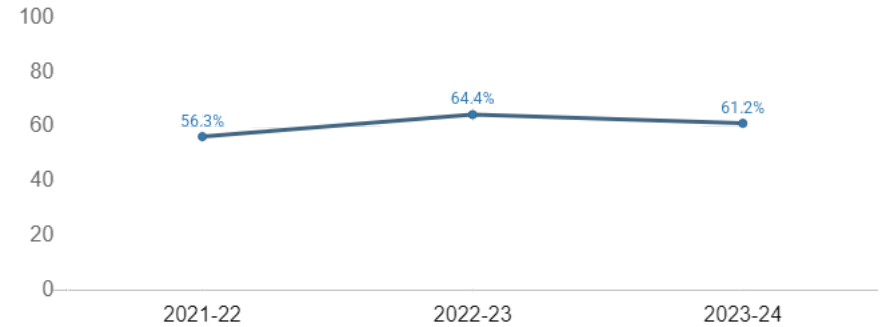
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 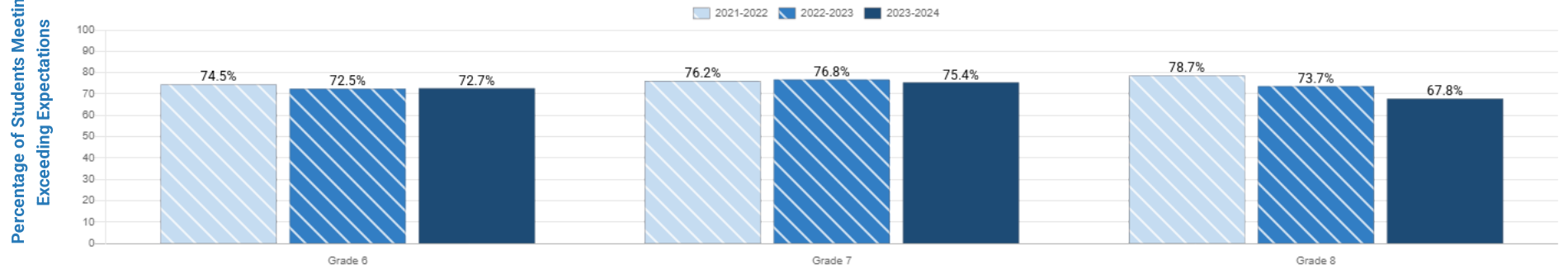

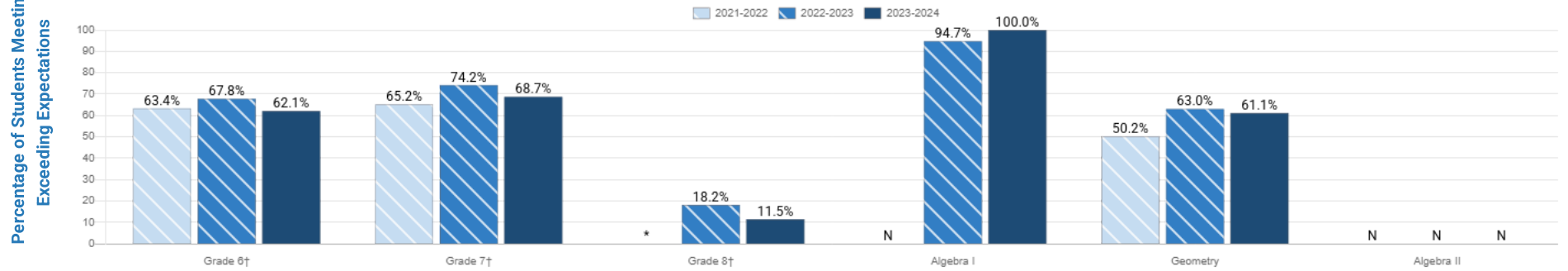

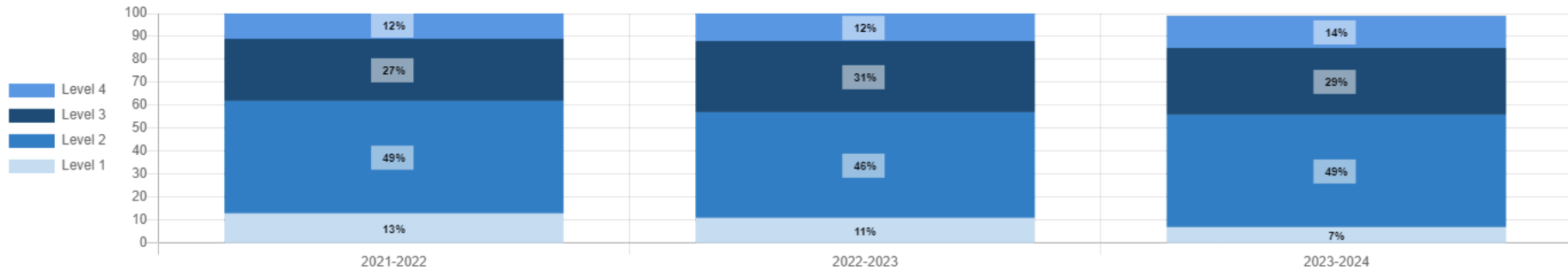

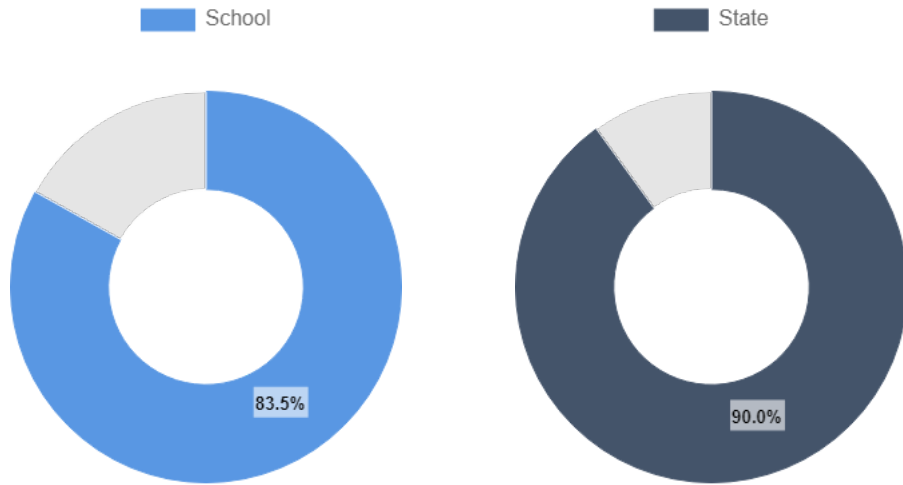

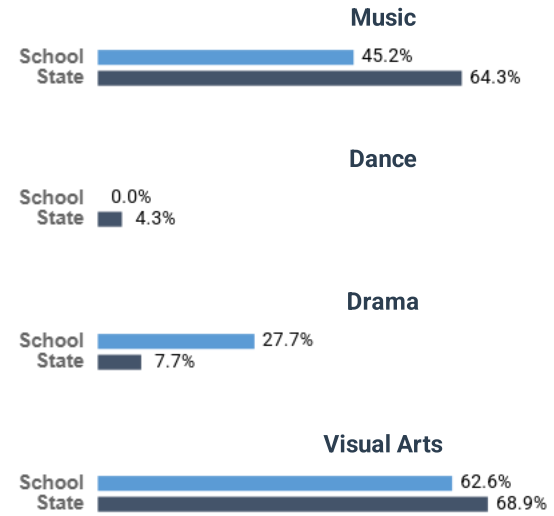

Students enrolled in one or more classes by discipline:



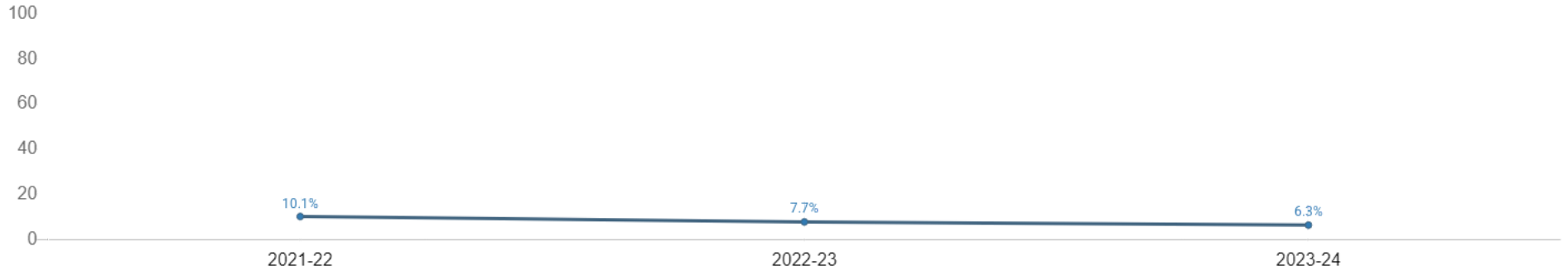

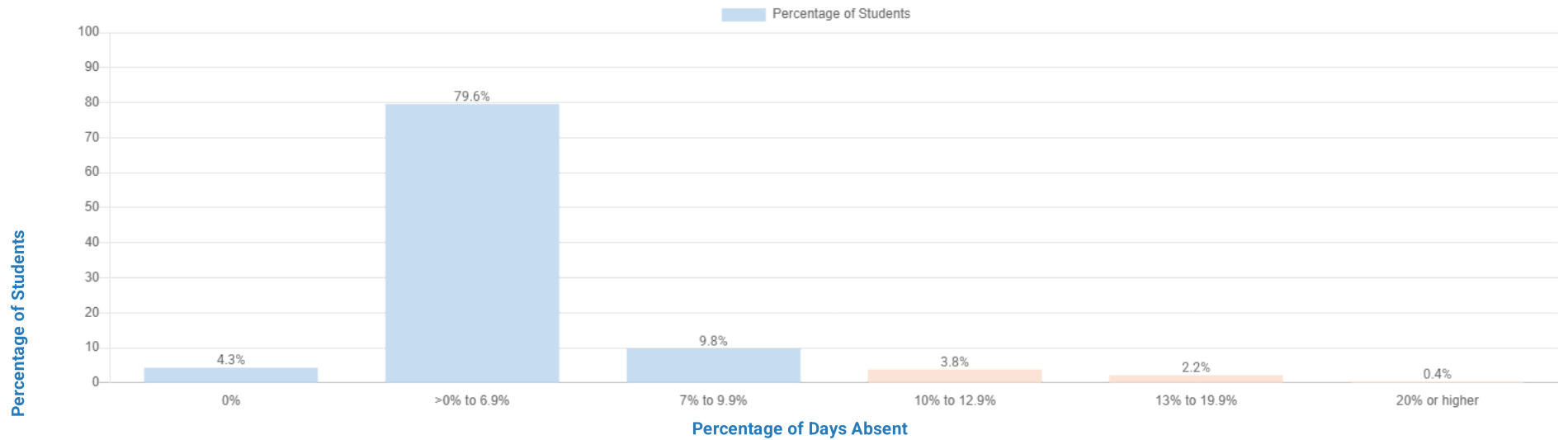

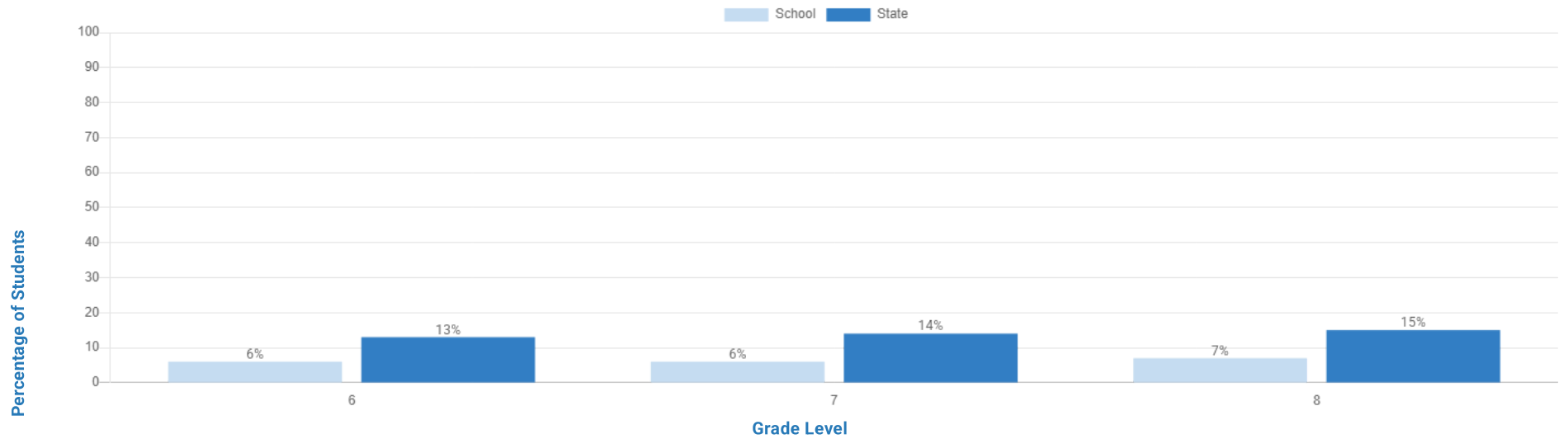

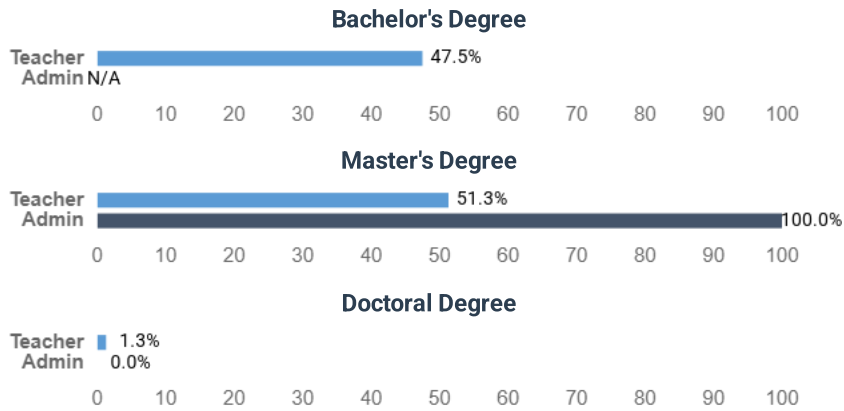

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. - CMS utilizes technology to enhance the education experiences of our students. Teachers use technology for instruction, assessment, and research. All students are issued 1-1 Chromebook devices.
- We embrace a balanced approach to learning through an emphasis on student wellness and social/emotional growth.

Our vision is to provide a secure, stimulating environment in which students find challenge and support. We foster respect for oneself, our environment and the world's diversity. CMS offers opportunities for exploration so that student interests and strengths can be developed. We encourage risk-taking, perseverance, and collaboration. Our school promotes learning that is relevant so that our students may become successful, responsible and contributing citizens.

The PTO and the Chatham Education Foundation have awarded us many grants to support our efforts in the classroom. Our orchestra, band and chorus annually receive recognition at regional music festivals. Our select choir has been selected to sing for the NJ Devils. Our Mock Trial club annually competes and places in local competitions. Our Robotics team competes annually at the national level and has been recognized with various awards. We participate in the Continental Math League competitions and always have students who receive recognition based on their performance.

Courses, Curriculum, Instruction:

Our Math classes develop the skills of abstraction, application and collaboration. Our Science curriculum incorporates the NGSS into integrated units. In ELA we use novels for literary exploration and promote writing across the curricula. Social Studies courses focus on critical social issues and an appreciation of the world's diversity. We offer courses in Chinese, French, German, American Sign Language and Spanish. Our core academics are complemented by classes in the arts, STEM, and Family and Consumer Science.



Sports and Athletics:

While we do not have organized sports teams at CMS, our PTO has offered enrichment classes in fencing, hockey and spin. Additionally, we hold open gym for students to spend time working out and playing organized sports after school. Our Physical Education classes meet for 43 minutes a day and focus on healthy living, fitness and team sports.



Clubs and Activities:

We have over 25 co-curricular offerings at CMS that provide our students with an opportunity to grow and to learn outside of the classroom. The Builders Club is our largest organization; it focuses on community service. The Student Council is an active student-led group that sponsors schoolwide projects and events. Our Acceptance Alliance celebrates differences among our students. Our annual All-School Production employs the diverse skills and talents of our students.

Before and After School Programs:

Our PTO offers enrichment programs after school that are designed to meet the different interests of our students. There are a variety of offerings such as fencing, cake design, digital photography, "Pinterest," spin and knitting. In the Spring, "Girls on the Run" provides an opportunity for our students to exercise while also developing strong bonds with their classmates. We have Open Gym during the Winter; this gives students a chance to play games and exercise. Our select choir, jazz band, and pops orchestra are smaller ensembles that rehearse before and after school.



Staff and Professional Learning:

Our staff participates in PD that is designed to help them to reach their professional growth goals and the building goals identified by our SciP team. Much of our PD is facilitated by staff who serve as mentors and instructors; some is led by supervisors. Teachers also have the opportunity to attend workshops outside of our school with the expectation that they will return and turn-key the training to their colleagues.



Student Supports and Services:

Our I&RS team meets monthly to address the needs of students who are struggling academically or behaviorally. The CST oversees the IEPs of all Special Education students; we also offer Learning Skills to these students. Our 504 team writes and manages plans for those students who qualify. Our ESL instructor teaches classes for MLLs in all grade levels. We offer Basic Skills Instruction in Math and ELA. We have a general education class called "Maximizing your Academic Potential" that addresses the needs of those students who have been identified as struggling with executive functioning and study skills. Extra help is offered to all students before and after school.

Student Health and Wellness:

Students take Physical Education and Health classes that focus on mindfulness and healthy living as a life goal. Our counseling department, which includes a SAC, provides both group and individual sessions for students. Teachers incorporate relaxation techniques into their courses. Our counselors create mini-workshops for teachers and students that provide self-help activities.



Parent and Community Involvement:

The PTO is active in supporting our school through assemblies, events, and gifts. Their Facebook page keeps all parents informed about upcoming events. PTO meetings take place bi-monthly and include a guest speaker. Our annual Back To School Night is extremely well-attended. Parent programs are designed to educate parents on current trends with adolescent children and to help with transitions between schools. Our website is full of information for parents.

Facilities:

We have undergone a major renovation of our art and music rooms that included the addition of a television studio. We recently finished a three-classroom STEM addition that includes state-of-the-art technology and resources. Our auditorium has undergone a complete overhaul; the modern space with new sound and lighting provides an excellent venue for assemblies and our all-school production. CMS has nine Science labs, two gymnasiums, and a cafeteria. We have an outdoor classroom, a turf field, and a furnished "reading garden." Our entire building is air-conditioned, with the exception of our cafeteria and upper gym.



School Safety:

We continually evaluate and update our security procedures as needed. Each year, we review all of our drills with our staff and students and provide a comprehensive security handbook to each staff member. All substitute teachers receive an abbreviated version of our security handbook as well so that they are familiar with our protocols. We run two drills each month, one fire drill and one other security drill. The Chatham Borough Police Department attends many of our drills. We also run two bus drills each year. All of the doors to our building are locked throughout the day and visitors can enter only after being buzzed in through our front door. All staff members wear photo IDs and visitors are issued temporary passes as well. We have a full-time security guard and a Class-3 Officer who are here whenever there are students in the building. Chatham PD makes regular visits to our school to do walk-throughs.



Technology and STEM:

All sixth grade students are required to take a course in "Creative Problem Solving" in which they learn about the design process while tackling innovative projects and challenges. All of our seventh graders take a "Digital Footprints" class in which they learn about responsible, appropriate and safe use of technology, social media, and the internet. We offer courses in Digital Game Design, Computer Animated Drawing, Robotics, and Innovation and Design. We also have a robotics team, a robotics club, a Science club, and an Environmental club.

We recognize that the emotional health and well being of students is foundational to their success. Our district has hired an additional mental health clinician to run an Aspire program here; through this program we have been able to identify those students with the greatest needs and to provide additional support, resources, and interventions for them and their families. We have also worked hard with our staff in identifying those students who may be struggling socially and emotionally so that we can better support them. We run a summer program for incoming sixth graders in which we have provided a more structured and intensive program to ease the transition between elementary and middle school.

Other Information:

Everyone at CMS works to provide a nurturing, yet academically challenging setting in which students can grow intellectually, emotionally, and socially. Our school schedule is unique in that it rotates to provide both variety and an opportunity for teachers to work with students at different times of the day. Daily common planning periods give teachers the necessary time to organize interdisciplinary instruction, discuss student progress and meet with other professionals and parents.
