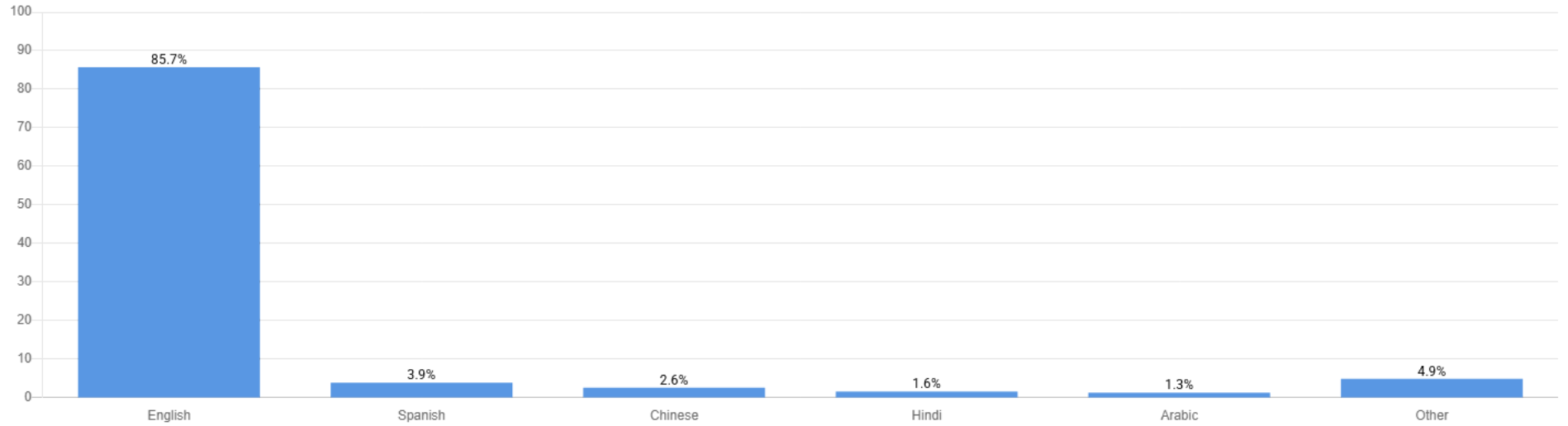

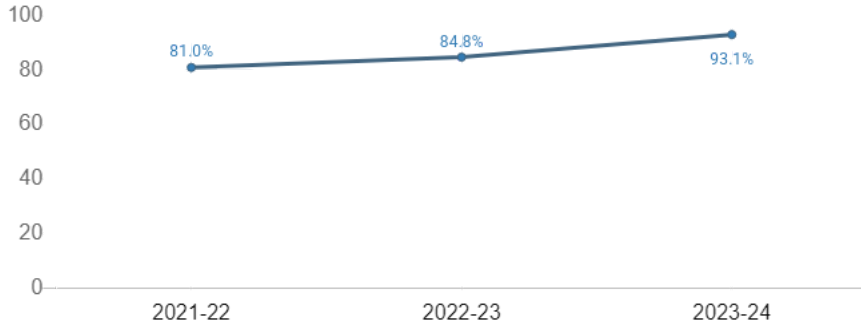

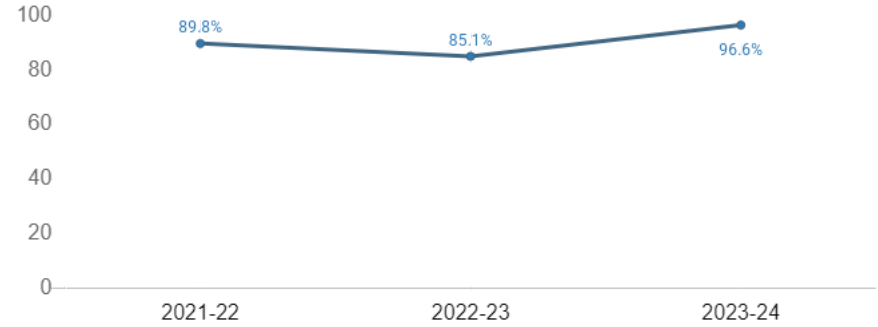
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 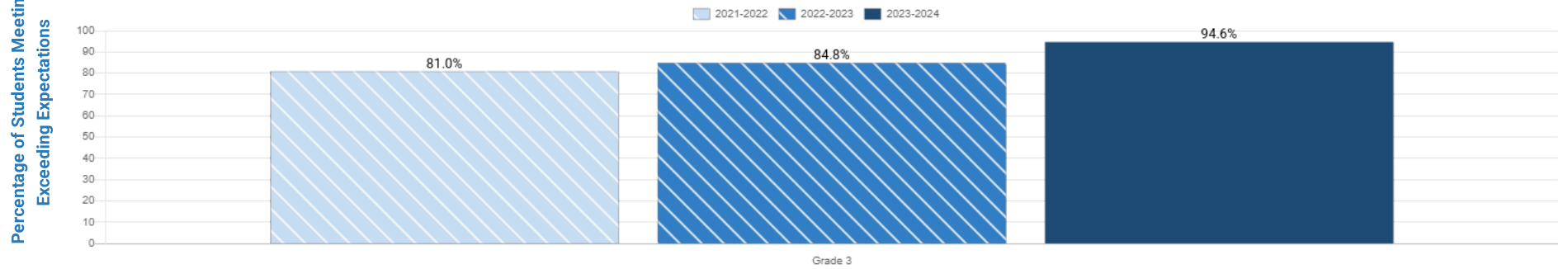

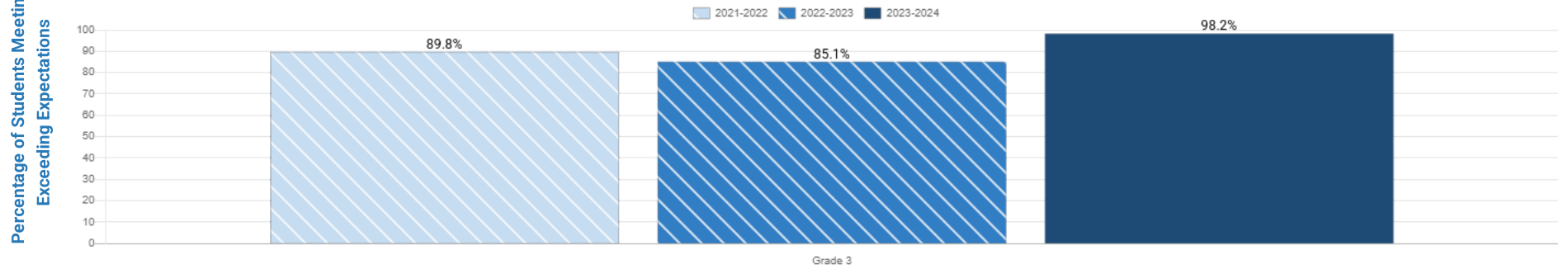

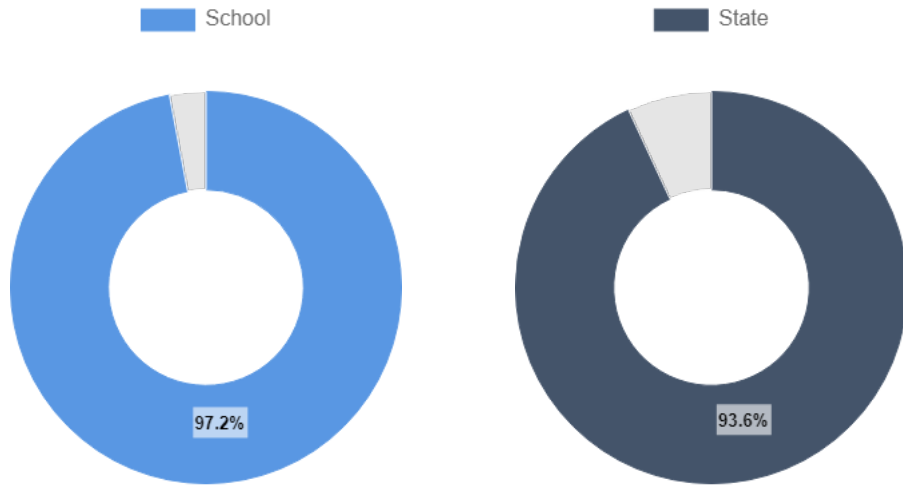

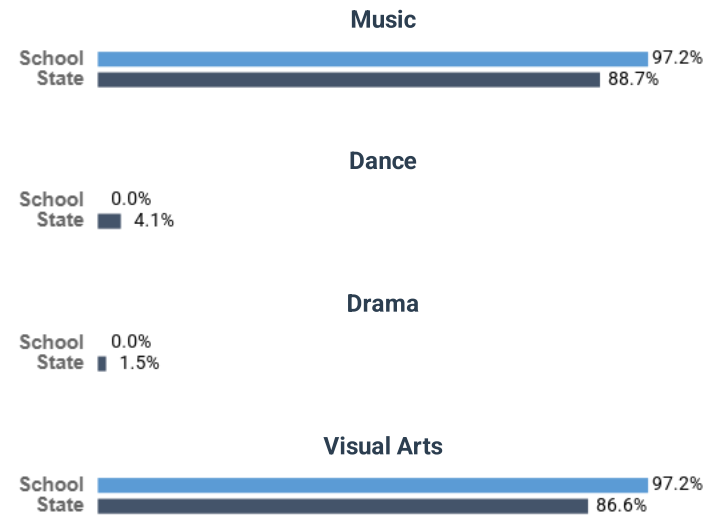

Students enrolled in one or more classes by discipline:



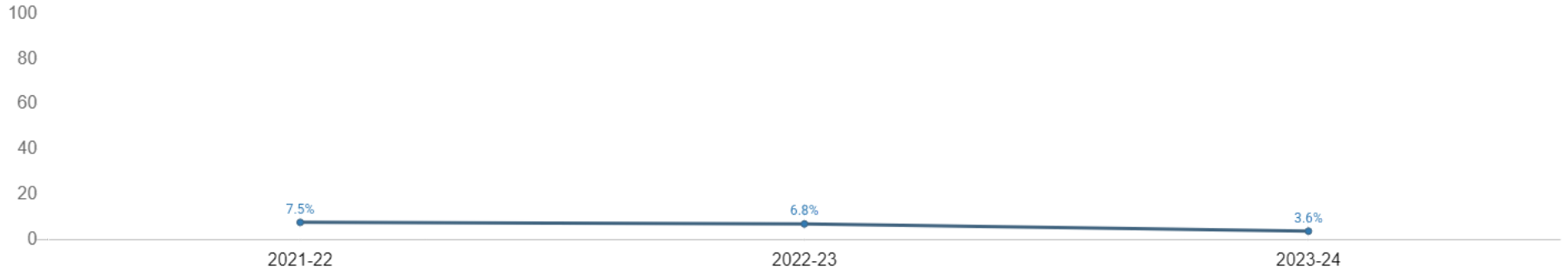
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

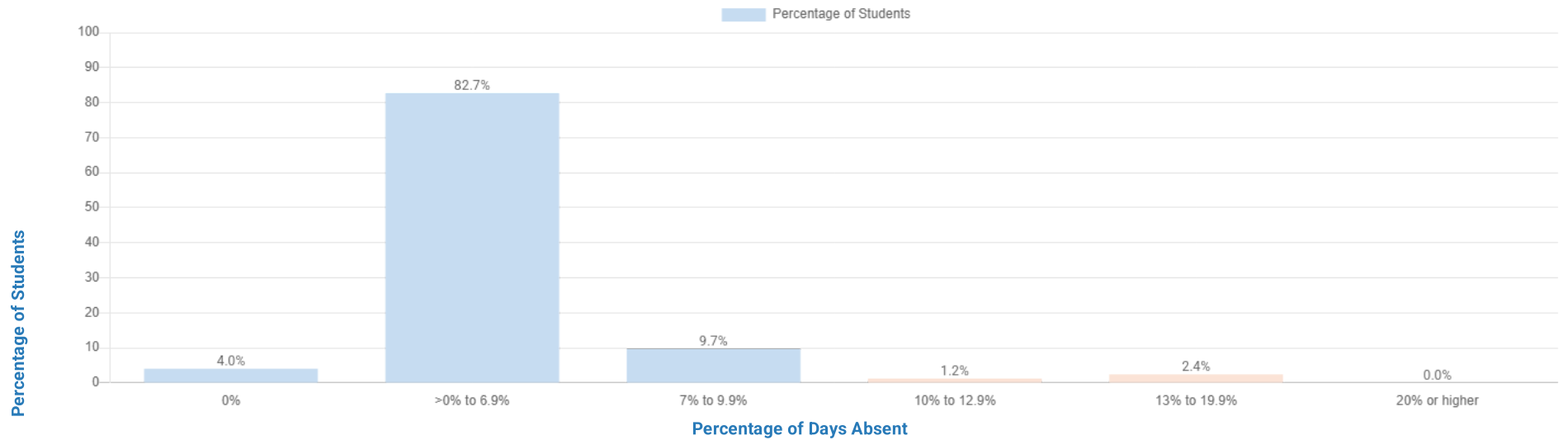

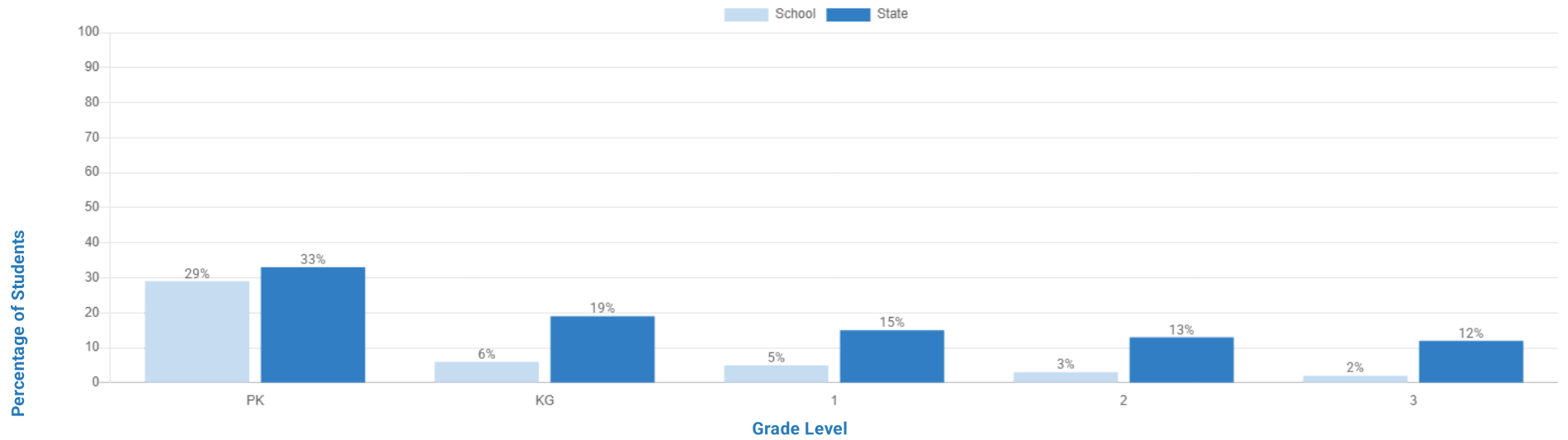

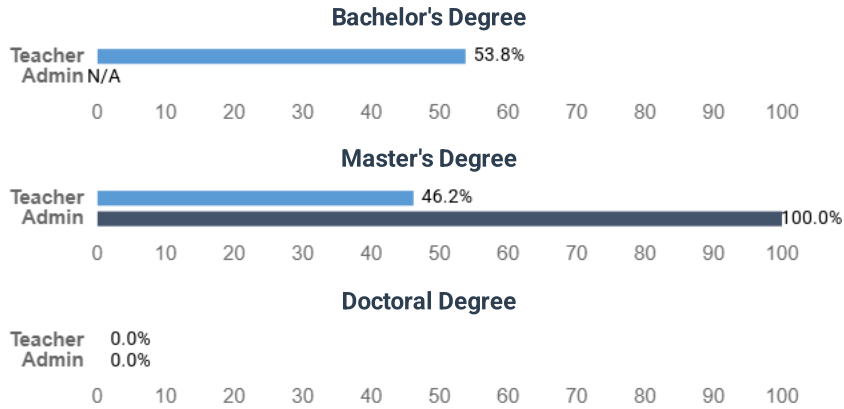

Courses, Curriculum, Instruction:

Instruction is aligned with the NJ Student Learning Standards to make certain that all Milton students have the chance to achieve high levels of excellence. English Language Arts is taught using Readers and Writers Workshop, as well as Heggerty, Foundations and Words Their Way. Big Ideas, and other supplemental math resources, foster critical thinking and application of skills in math. The science curriculum is aligned with NGSS. Strong related arts instruction is provided in art, music, physical education, Design & Technology, health, and library. Milton houses a half-day and full-day preschool programs aligned with Creative Curriculum.



Before and After School Programs:

Work Family Connection provides care for students both before school and after school for parents. They also assist us as part of a kindergarten wrap-around program since we still operate with a half-day kindergarten program.



Staff and Professional Learning:

Teachers are consistently engaging in professional learning in numerous areas. Teachers develop their Professional Development Plans around areas in which they would like to experience additional growth in alignment with building goals. Teachers engage in GO Time, which enables them the opportunity to choose an area to investigate that will assist them as educators. They then use Professional Development time to engage in their own professional growth and learning in that area of focus. In-district PD is provided on an on-going basis throughout the year and all faculty are encouraged to pursue outside PD opportunities.

Student Supports and Services:

Students may receive Basic Skills Instruction which provides additional support for students in the areas of Math and English Language Arts. Pull-out Resource Room is offered for students with an IEP. Milton Avenue School has a shared Child Study Team, Physical and Occupational Therapists, and Speech Therapists on staff as well. Small group instruction for English Language Learners occurs daily by an ESL instructor for all qualifying students. Our I&RS team meets monthly to address the needs of students who are struggling academically or behaviorally.



Student Health and Wellness:

Students engage in physical activities as part of our physical education program and recess. Our physical education teacher also organizes annual events such as the Milton Duathlon and the Milton Mile. In addition, we host Walk-to-School events each month, and we encourage students to walk or bike to school on a regular basis. Teachers have incorporated growth mindset concepts in their lesson planning and classrooms. Our school nurse is proactive in assisting students with medical needs and in performing health screening activities. Our school counselor works with students in the classroom, in small groups, and one-to-one.



Parent and Community Involvement:

The PTO is active in supporting our school through assemblies, events, and gifts. They recently supported our school by creating an outdoor classroom on our property. They also promote After School Enrichment programs to further engage our students in areas of high interest. Their Facebook page keeps all parents informed about upcoming events. PTO meetings take place bi-monthly and include a guest speaker.

Facilities:

Milton Avenue School has general and special education classrooms (self-contained and pull-out support) for all pre-K-3 students. We also have half-day and full-day preschool programs. Additional special area subject classrooms include a music room, art room, design and technology room, gymnasium, and media center. The school also has a faculty room and offices for other staff including Child Study Team, nurse, and principal. Outdoor spaces include playgrounds, blacktop areas for recess, and fields.



School Safety:

School safety is very important at Milton Avenue School. We have a Class II Officer who plays an essential role in enhancing the security of the building for our students and staff. Doors are locked at all times, and all visitors must buzz in at the front door to gain access into the building. School security drills and fire drills are practiced on a monthly basis, and Milton Avenue School has developed an Emergency Response Plan which outlines the procedures to be followed in various emergency situations. These plans are reviewed annually with our staff.



Technology and STEM:

Each preK-3 classroom is equipped with a teacher desktop, interactive display board, document camera, and Redcat speaker system. Each student in the building has been assigned a Chromebook and charger. All students in grades K-3 receive weekly specials classes in Design and Technology as well.
