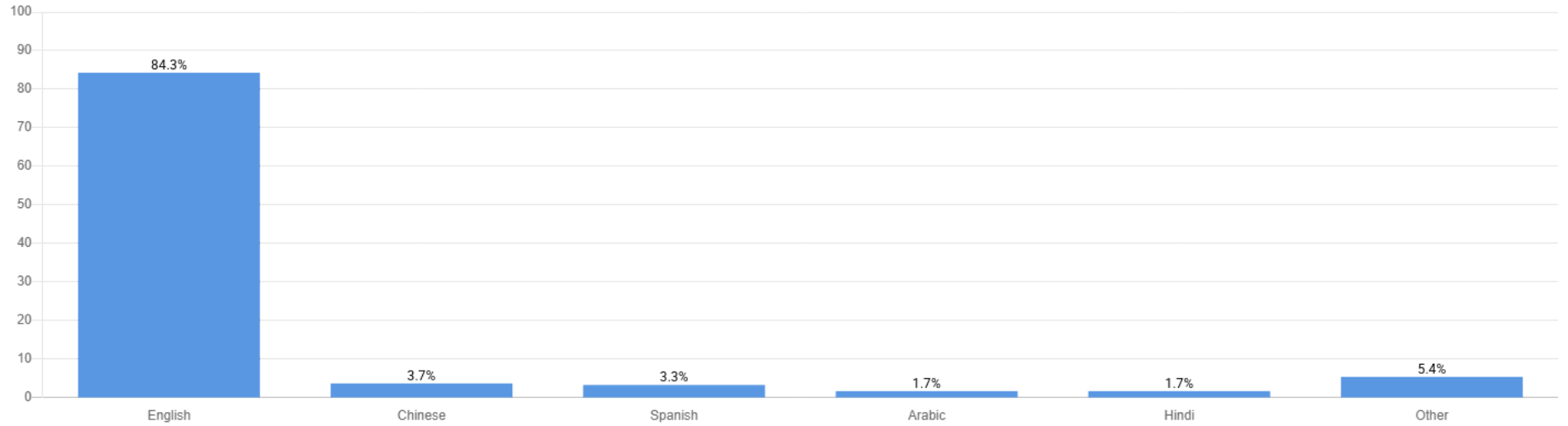

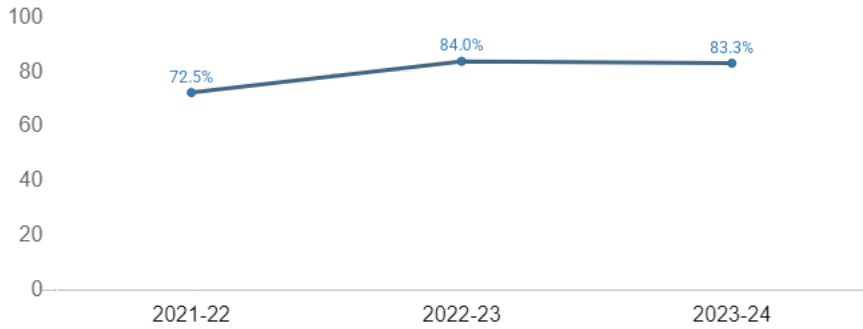

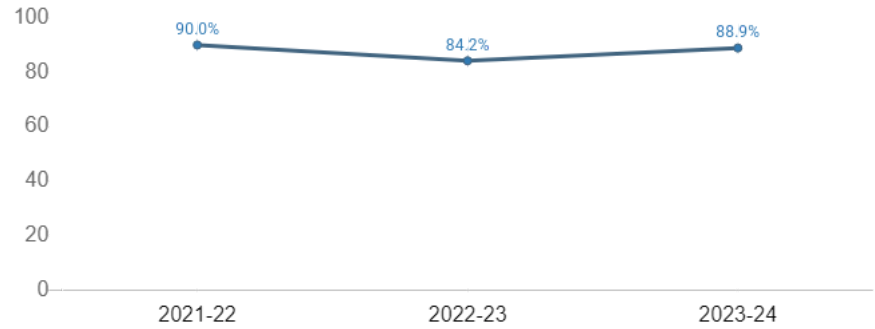
English Language Arts and Mathematics Performance Trends

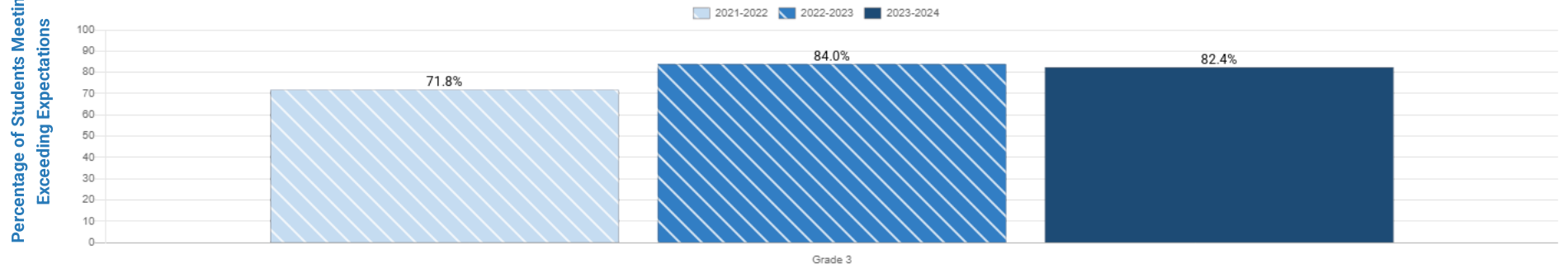

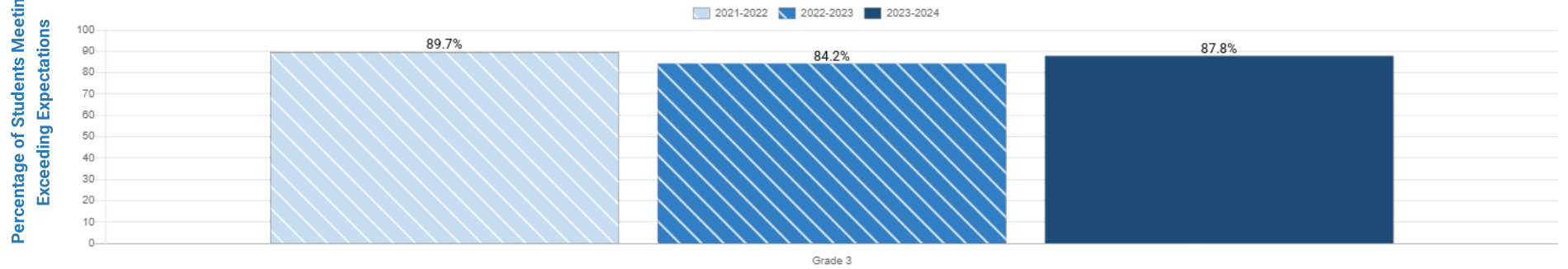

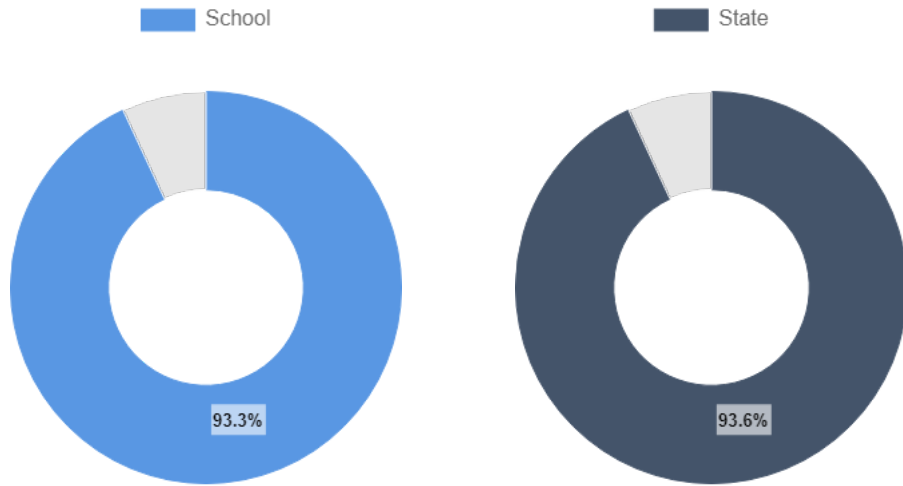

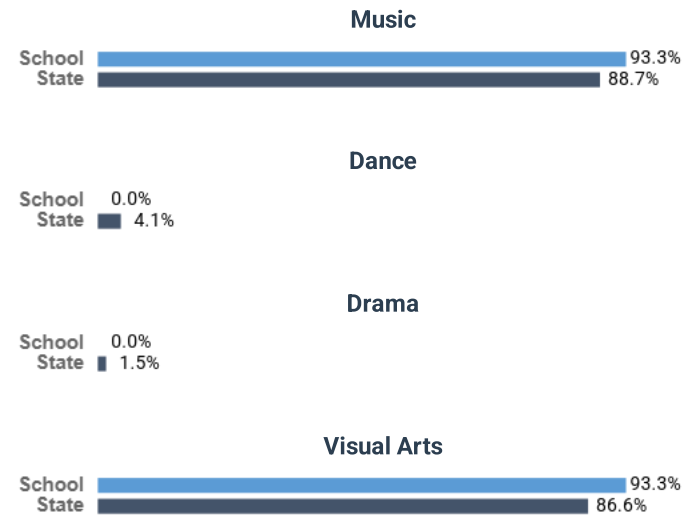

Students enrolled in one or more classes by discipline:



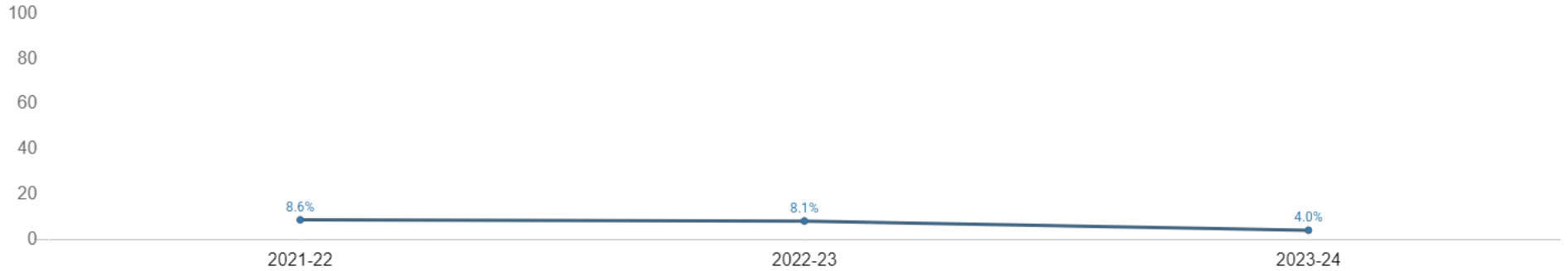
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

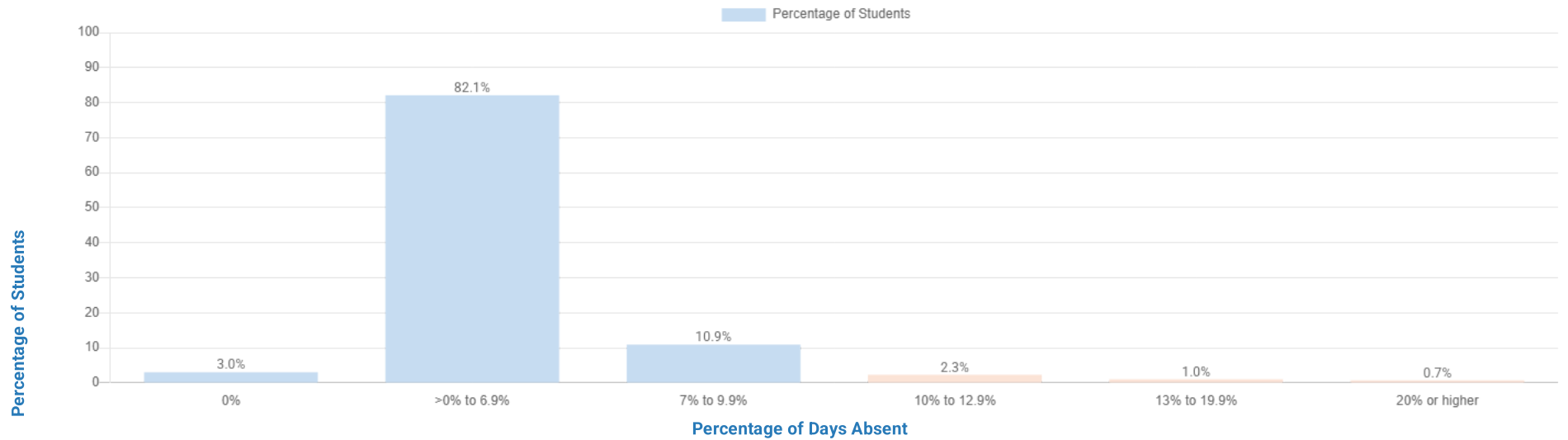

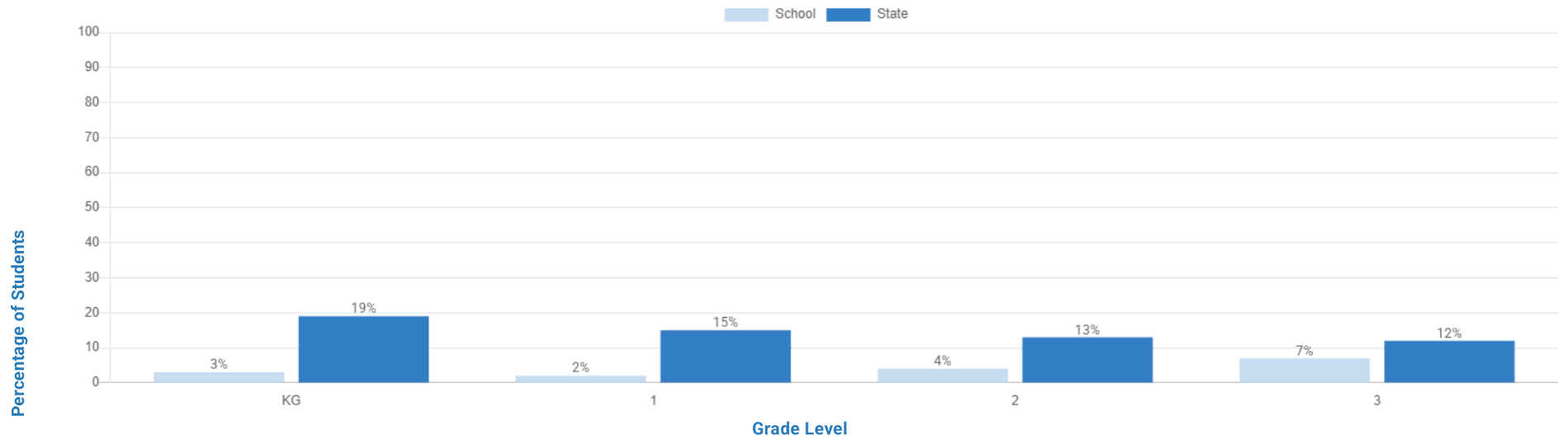

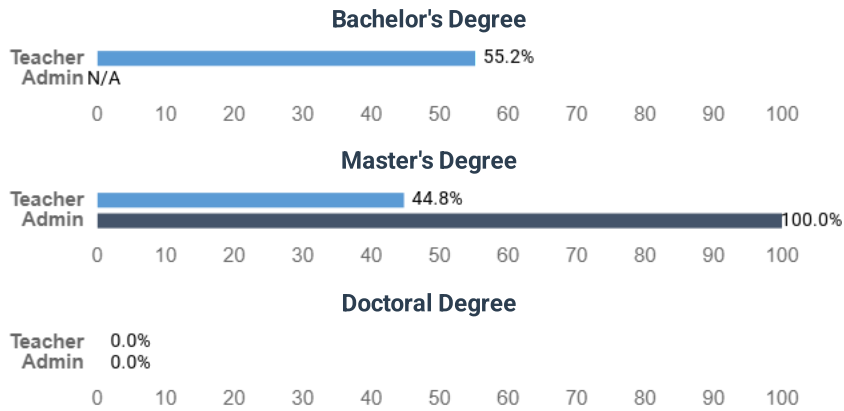

English Language Arts is taught using Readers and Writers Workshop, as well as Heggerty, Foundations and Words Their Way. Big Ideas, and other supplemental math resources, foster critical thinking and application of skills in math. The science curriculum is aligned with NGSS. Strong related arts instruction is provided in art, music, physical education, Design & Technology, health, and library. Teachers utilize Second Step to address the social-emotional development of students in their classrooms.



Clubs and Activities:

Washington Avenue School PTO offers an extensive After School Enrichment Program which provides classes in model rocketry, coding, and Lego robotics. Other activities hosted by Washington Avenue School throughout the school year include New Family Picnic, Holiday and Spring Concerts, Field Day, participation in a community Halloween parade along with 2 other K-8 schools, and a local Senior Center, the Cougar Bowl, Give Back, Give Thanks projects, and many more.



Before and After School Programs:

Work Family Connection provides care for students both before school, during lunch time, and after school for parents.

Staff and Professional Learning:

Teachers are consistently engaging in professional learning in numerous areas. Teachers develop their Professional Development Plans around areas in which they would like to experience additional growth in alignment with building goals. Teachers engage in GO Time, which enables them the opportunity to choose an area to investigate that will assist them as educators. They then use Professional Development time to engage in their own professional growth and learning in that area of focus. In-district PD is provided on an on-going basis throughout the year and all faculty are encouraged to pursue outside PD opportunities.



Student Supports and Services:

Students may receive Basic Skills Instruction which provides additional support for students in the areas of Math and English Language Arts. Pull-out Resource Room is offered for students with an IEP. Washington Avenue School has a Child Study Team, Physical and Occupational Therapists, and Speech Therapists on staff as well. Small group instruction for English Language Learners occurs daily by an ESL instructor for all qualifying students. Our I&RS team meets monthly to address the needs of students who are struggling academically or behaviorally.



Student Health and Wellness:

Students engage in physical activities as part of our physical education program and recess. Teachers have incorporated growth mindset concepts in their lesson planning and classrooms. Our school nurse is proactive in assisting students with medical needs and in performing health screening activities.

Parent and Community Involvement:

Washington Avenue School PTO offers an extensive After School Enrichment Program which provides classes in model rocketry, coding, and Lego robotics. Parent volunteers and are welcome to attend several activities both during and after the school day including walking field trips, class parties and activities, Movie Night, and New Family Picnic to name a few. The WAS PTO has 4 meetings a year that are held in person whenever possible. The PTO Board meets bi-monthly with the building principal to discuss activities and ways to support and fund student enrichment.



Climate Surveys:

Is a Climate Survey Used: No; Who is surveyed: Parents, Teachers. Washington Avenue School will be issuing school climate surveys designed to identify areas in which climate can be improved to staff and parents. Information from stakeholders is gathered and reviewed by the School Safety Team, and is used by the principal to consider adding or adjusting policies and/or programs. Several PTO meetings, events, and School Safety Team meetings are held throughout the year to elicit feedback from parents in the school community as well.



Facilities:

Washington Avenue School has general education classrooms and special education classrooms (self-contained, in-class support, and pull-out support) for all K-3 students. Additional special area subject classrooms include a music room, art room, design and technology room, gymnasium, and media center. The school also has a multi-purpose room, faculty room, and offices for other staff including Child Study Team, nurse, and principal. Outdoor spaces include a K-3 playground, fitness center, blacktop area for recess, Kindergarten playground, baseball field, and soccer field.

School Safety:

The school anti-bullying specialist is required to chair a school safety team composed of the principal (or his or her designee) and the following other appointees of the principal: a teacher in the school, a parent of a student in the school, and other members determined by the principal. The law specifies that the parent on the team may not participate in any activities the team undertakes that may compromise student confidentiality. The purpose of the school safety team is to develop, foster, and maintain a positive school climate. Such teams will identify and address patterns of harassment, intimidation, or bullying. The legislation outlines policy revision and training responsibilities that fall on the team. The bill also requires that the teams be provided with professional development opportunities that address effective practices of successful school climate programs and approaches. The building has a Emergency Response Plan which is reviewed annually by all staff.



Technology and STEM:

Each K-3 classroom is equipped with a teacher desktop, SMARTBoard, document camera, and Redcat speaker system. Students in grades K-2 utilize laptop and Chromebook carts throughout their day. Grades K - 3 students have 1-1 Chromebooks that are housed in their classrooms and are taken home when applicable. All students in grades K-3 receive weekly specials classes in Design and Technology as well.
