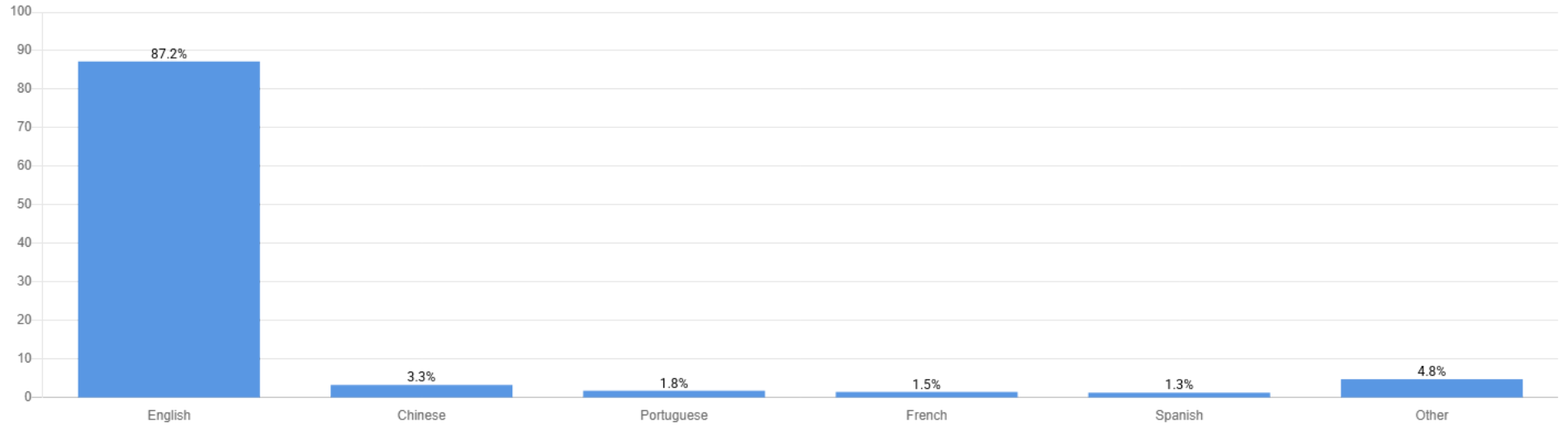

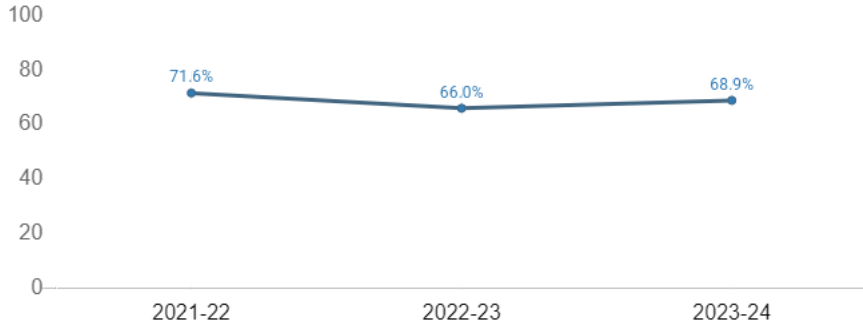

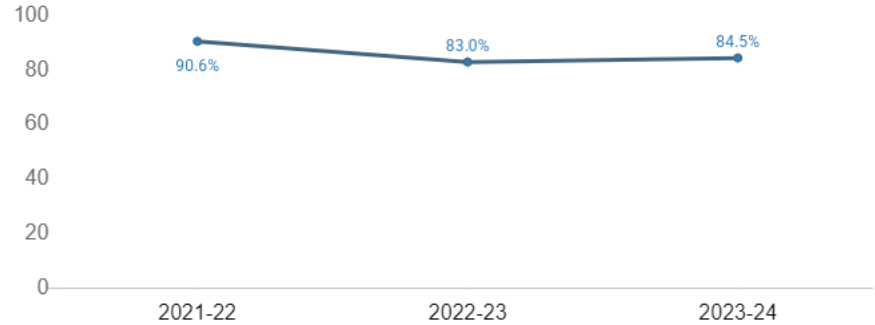
### English Language Arts and Mathematics Performance Trends

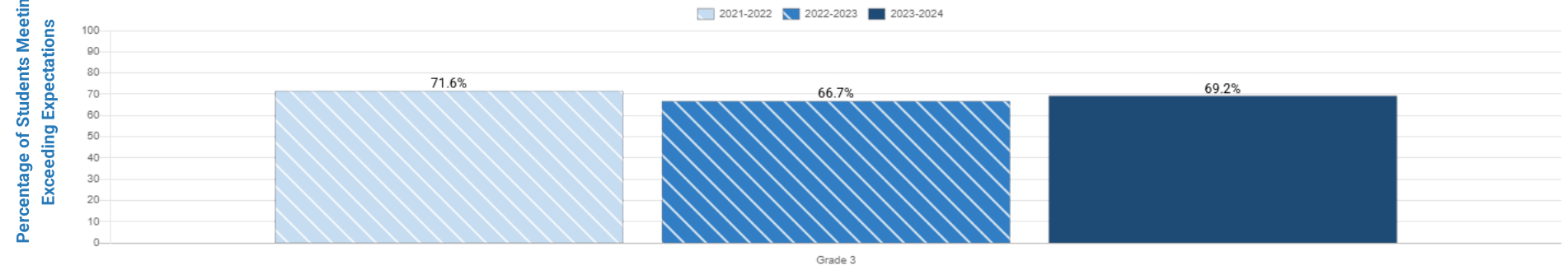

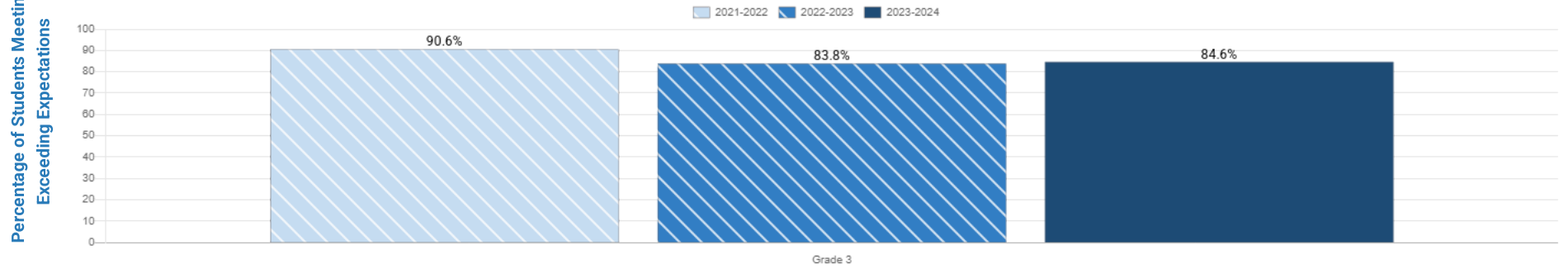

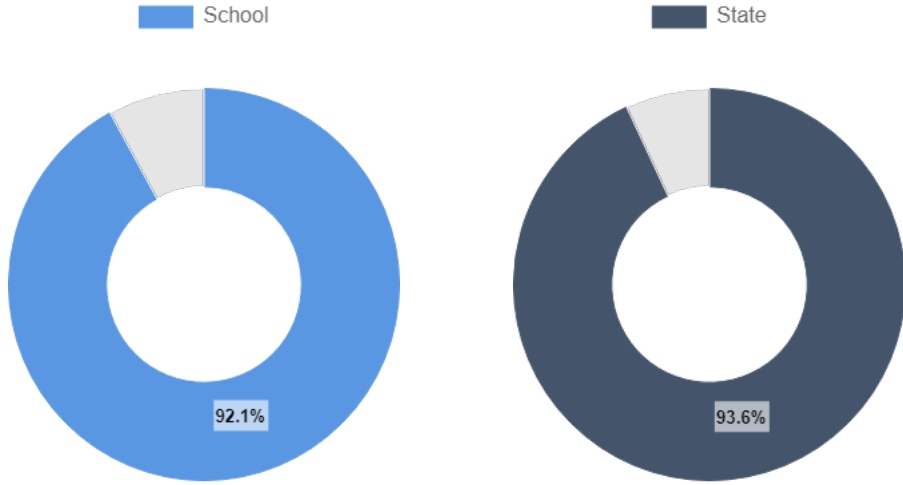

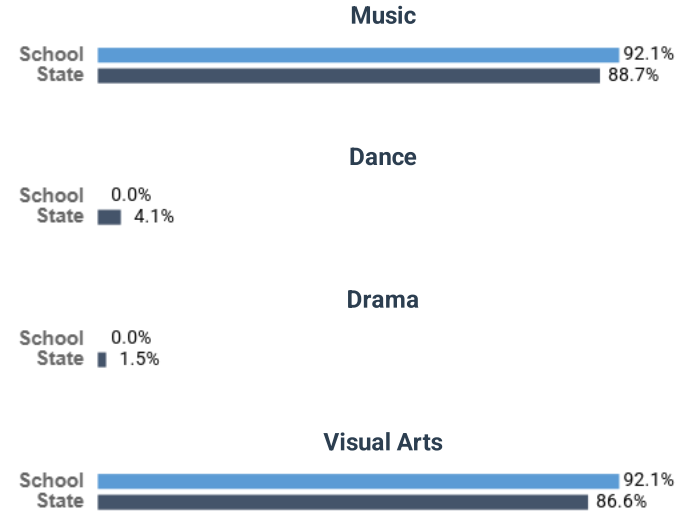

**Students enrolled in one or more classes by discipline:**



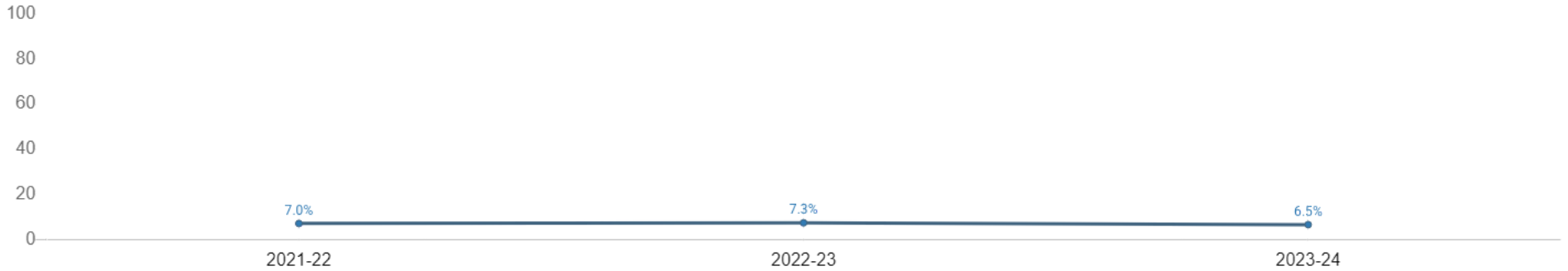
## Climate and Environment

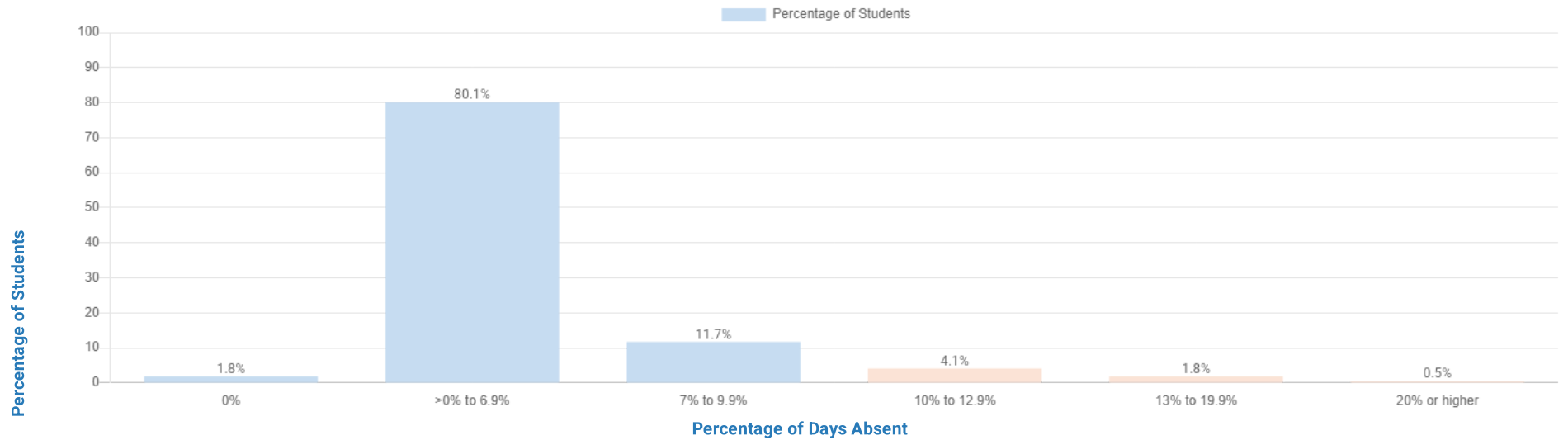

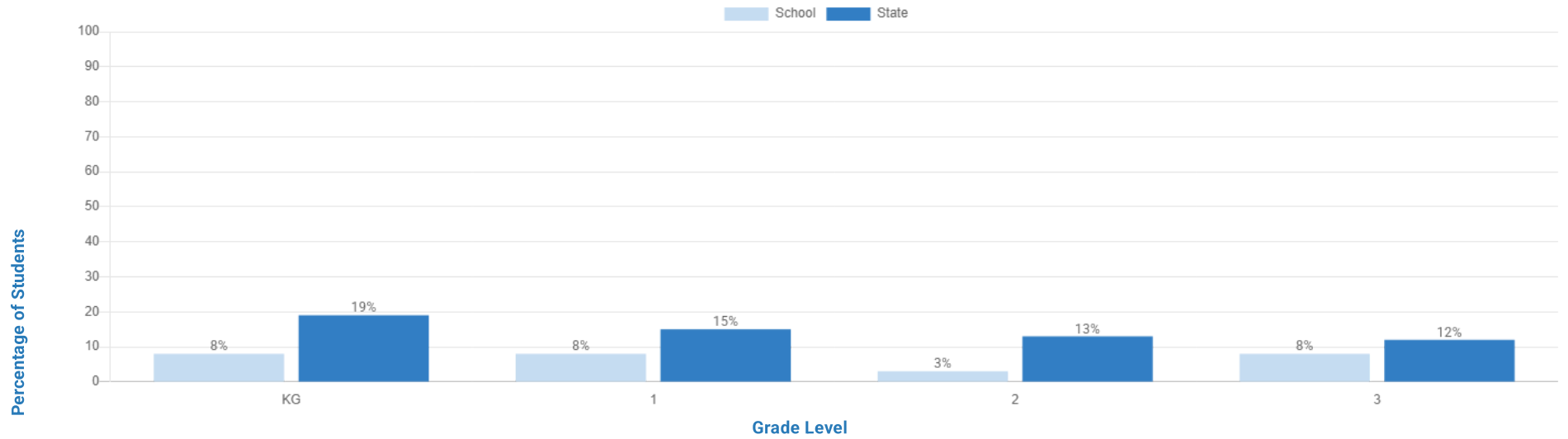

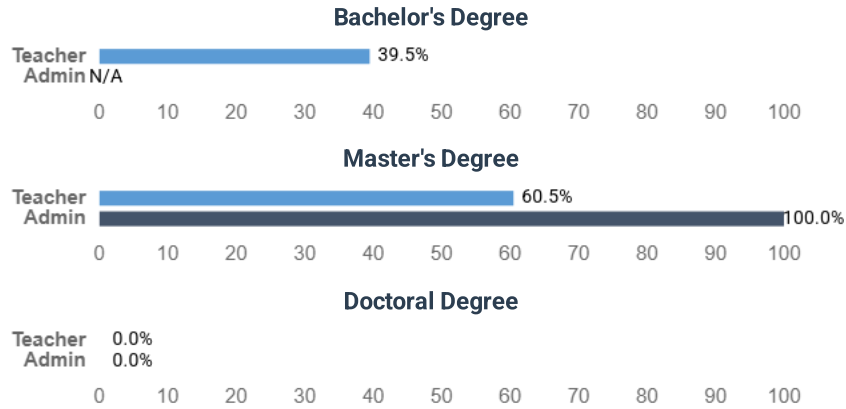

- Our curriculum includes Readers & Writers Workshop, Foundations, Heggerty, Words Their Way, Big Ideas Math and supplemental programs/resources to meet the expectations of the NJSL & NGSS.
- There is school-wide focus on Social and Emotional Learning and growth mindset is incorporated across the curriculum.

### Courses, Curriculum, Instruction:

Instruction is aligned with the NJ Student Learning Standards to make certain that all SBS students have the opportunity to achieve high levels of academic excellence. ELA, Mathematics and Social Studies instruction is aligned with the New Jersey Student Learning Standards. English Language Arts is taught using the Readers and Writers Workshop model, as well as Heggerty, Foundations and Words Their Way. The Big Ideas Math program is taught fostering critical thinking and application of skills in math. Social Studies is taught using the TCI curriculum. Our science curriculum is aligned with NGSS. Strong related arts instruction is provided in art, music, physical education, STEM, health, and library.



### Before and After School Programs:

Work Family Connection (WFC) provides both before and after school care for parents and students.



### Staff and Professional Learning:

Teachers are consistently engaging in professional learning in numerous areas. Teachers develop their Professional Development Plans around areas in which they would like to experience additional growth in alignment with building goals. Teachers engage in GO Time, which enables them the opportunity to choose an area to investigate that will assist them as educators. They then use Professional Development time to engage in their own professional growth and learning in that area of focus. In-district PD is provided on an on-going basis throughout the year and all faculty are encouraged to pursue outside PD opportunities.

### Student Supports and Services:

SBS students may receive Basic Skills Instruction. Our BSI program provides additional support in the areas of Math and English Language Arts. Pull-out and in-class Resource Room is offered for students with IEPs. Southern Boulevard School has a shared Child Study Team, Physical and Occupational Therapists and Speech Therapists. Small group instruction for English Language Learners occurs daily by an ESL instructor for all qualifying students. Our I&RS team meets monthly to address the needs of students who are struggling academically or behaviorally.



### Student Health and Wellness:

Students engage in physical activities as part of our physical education program. SBS implements several Walk-to-School days each year, when we encourage students to walk or bike to school. Teachers have incorporated growth mindset concepts in their lesson planning and throughout daily instruction. Our school nurse is proactive in assisting students with medical needs and in performing health screening activities. Our school counselor works with students in the classroom, in small groups and one-to-one.



### Parent and Community Involvement:

The SBS PTO is active in supporting our school through assemblies, events, and gifts. They also promote After School Enrichment programs to further engage our students in areas of high interest. Their Facebook page keeps all parents informed about upcoming events. PTO meetings take place bi-monthly alternating day and evening meetings.

### Facilities:

Southern Boulevard School has general education classrooms and special education classrooms (self-contained and pull-out support) for all K-3 students. Additional special area subject classrooms include a music room, art room, design and technology room, gymnasium and media center. The school has a faculty room and offices for other staff including Child Study Team, nurse, and principal. Outdoor spaces include playgrounds, blacktop area for recess and an upperfield with a running track.



### School Safety:

School safety is paramount at Southern Boulevard School. Southern Boulevard is staffed with a full time Class III police officer. This officer plays an essential role in enhancing the security of the building for students and staff. Doors are locked at all times and visitors must buzz in to gain access into the building. School security drills and fire drills are practiced on a monthly basis. Southern Boulevard School has an Emergency Response Plan which outlines procedures to be followed in various emergency situations. These plans are reviewed annually with our staff.



### Technology and STEM:

Each K-3 classroom is equipped with a teacher desktop computer, an interactive display board, document camera and Redcat speaker system. Each student in the building is assigned a Chromebook and charger that goes to and from school. All students in grades K-3 receive weekly classes in Design and Technology. Design and Technology class empowers students to think critically and creatively to develop innovative solutions to problems present in our modern world.
