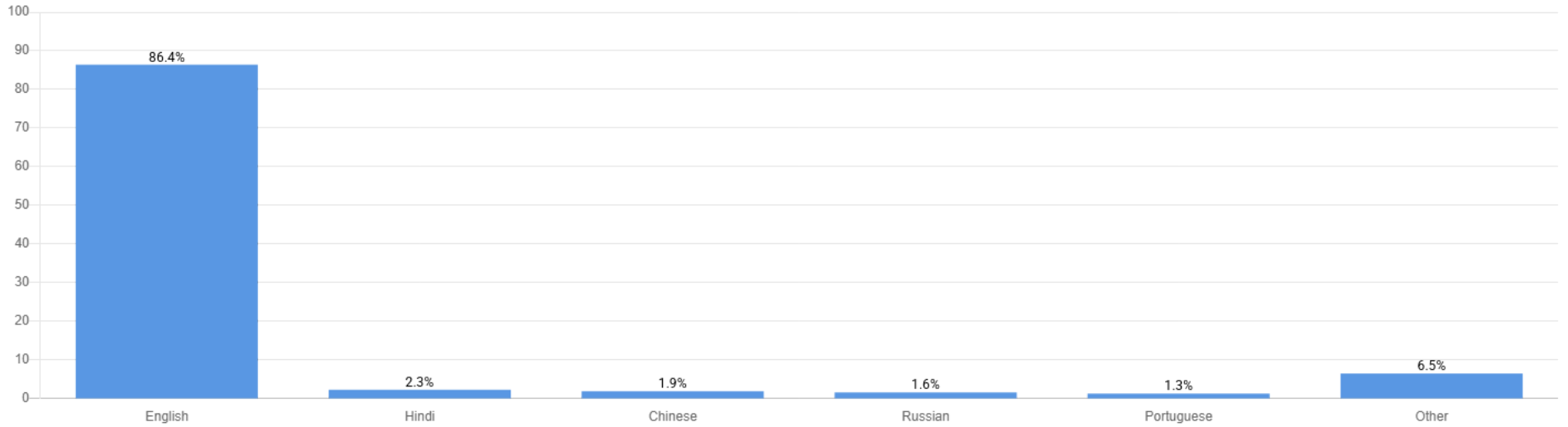

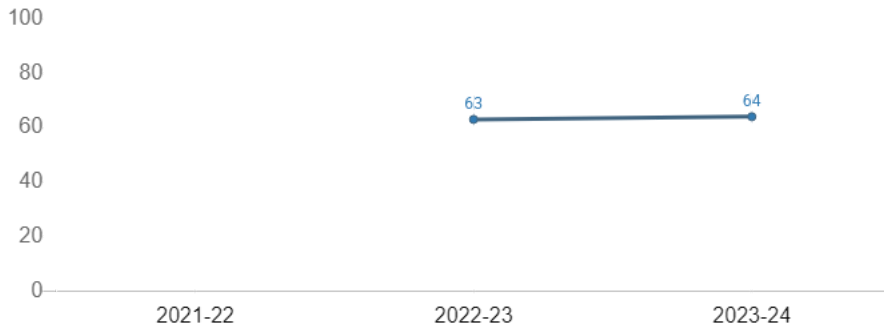

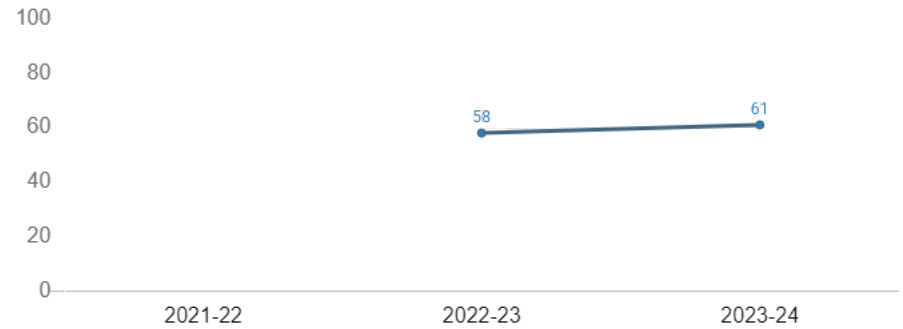

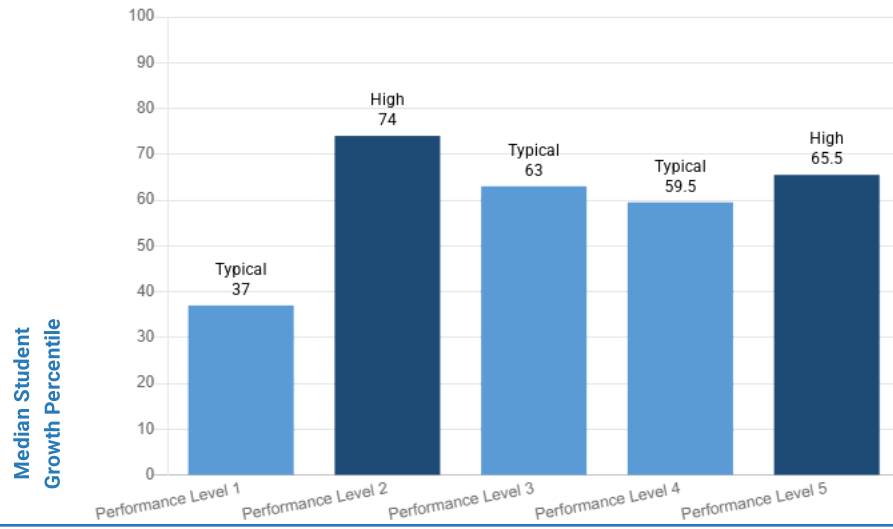

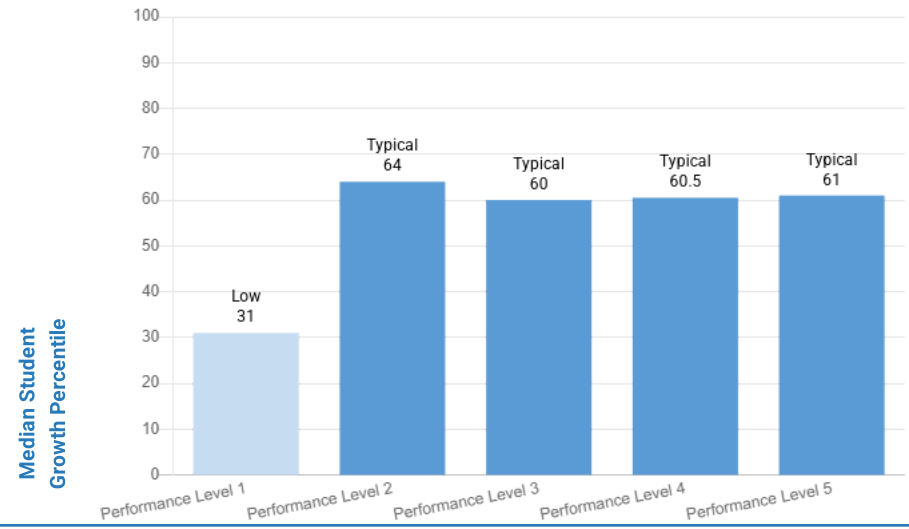

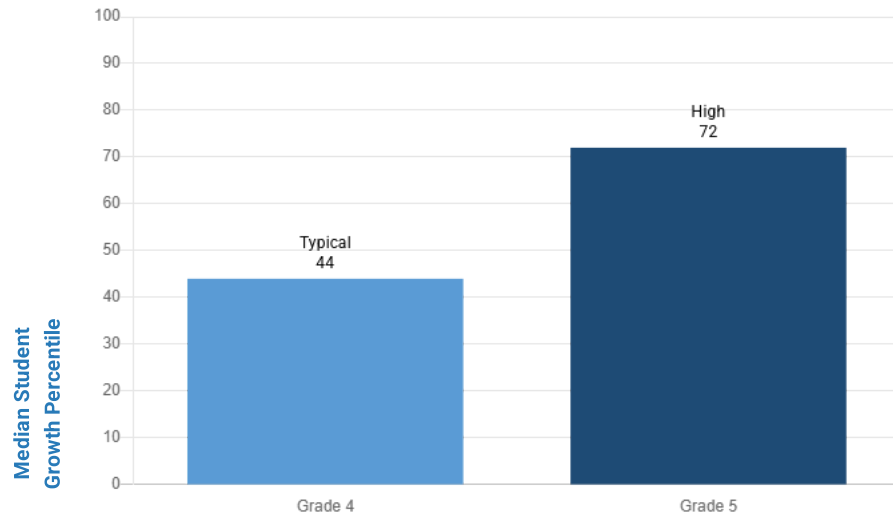

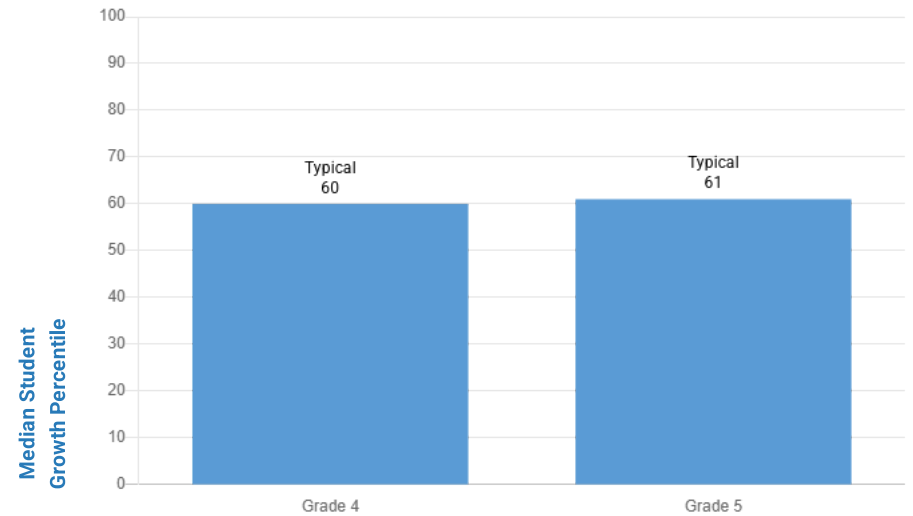

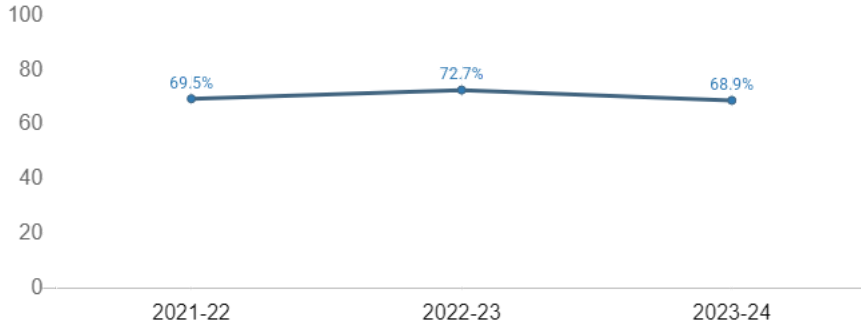

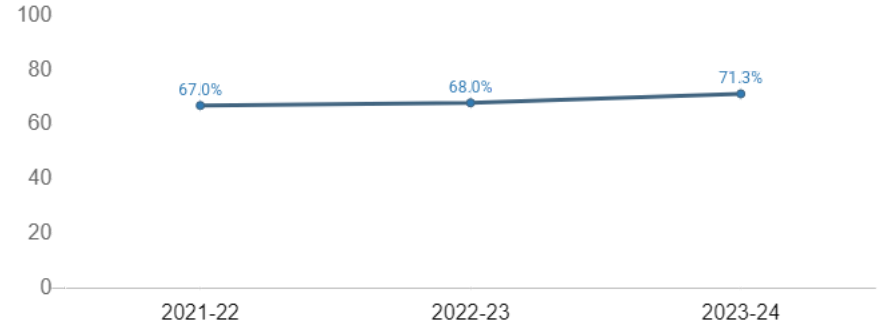
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 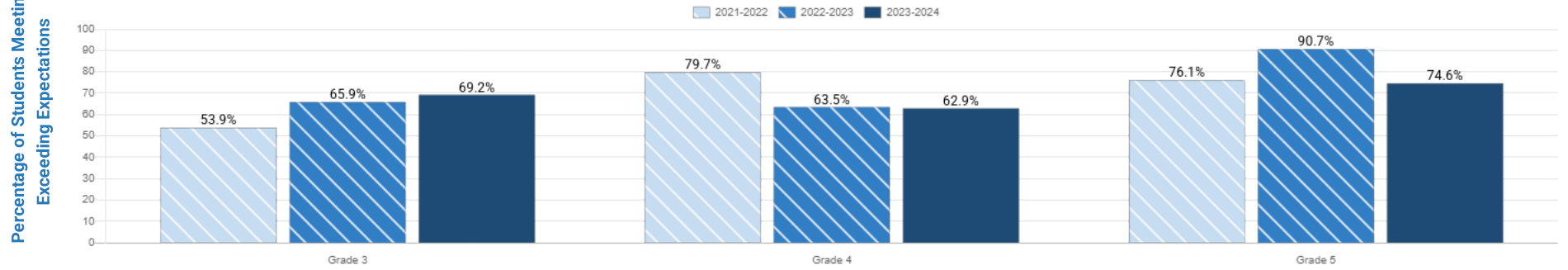

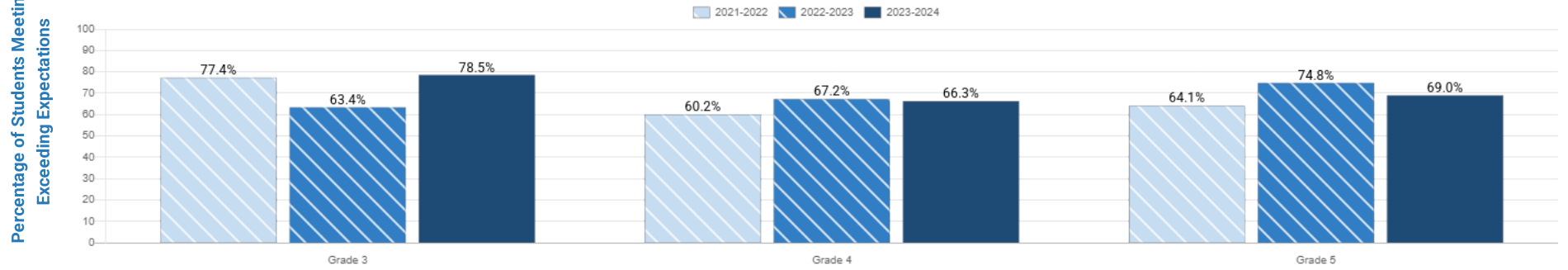

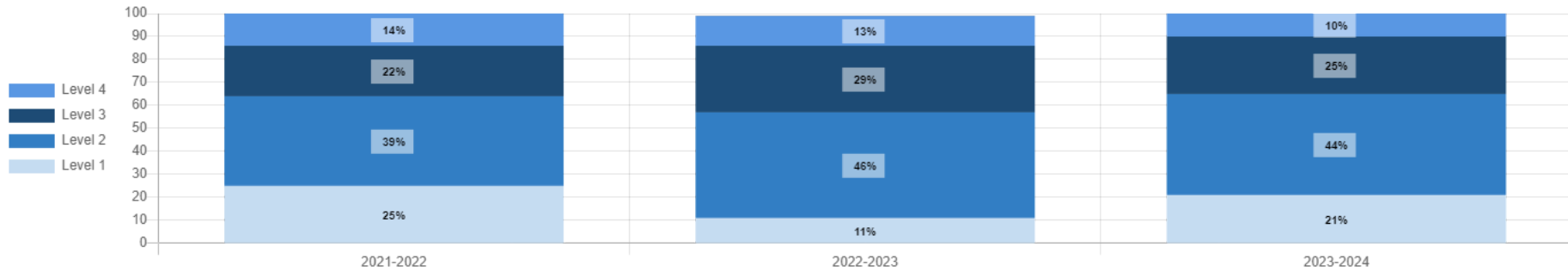

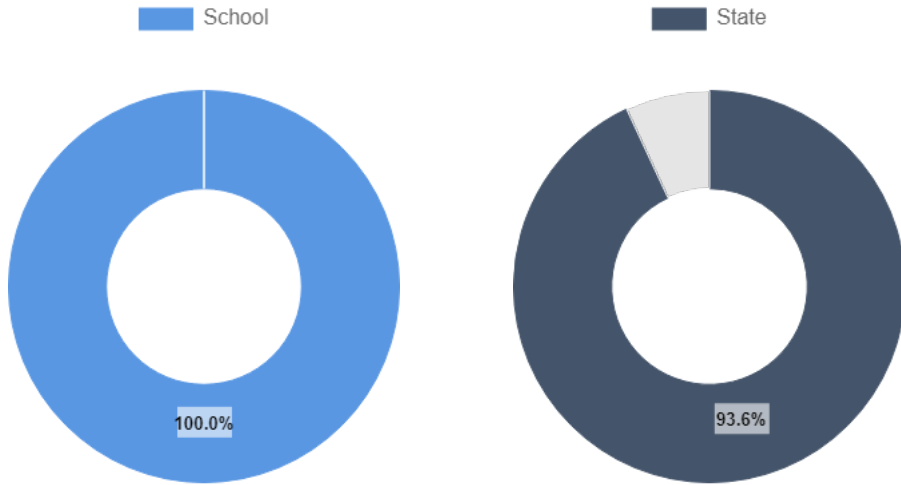

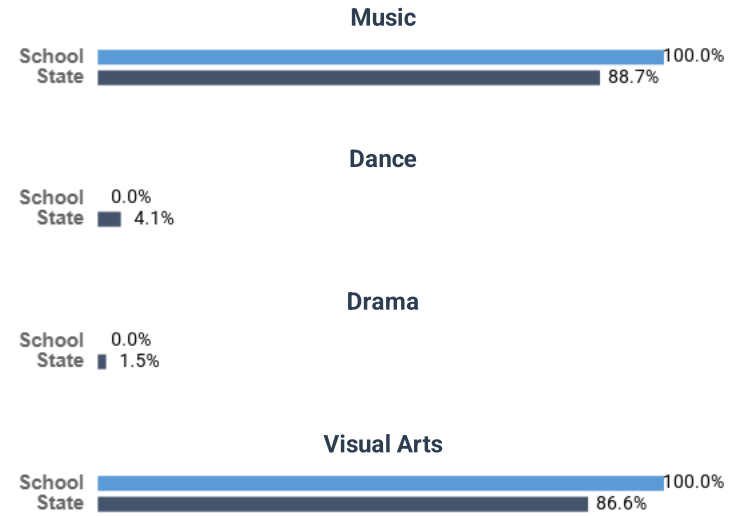

Students enrolled in one or more classes by discipline:



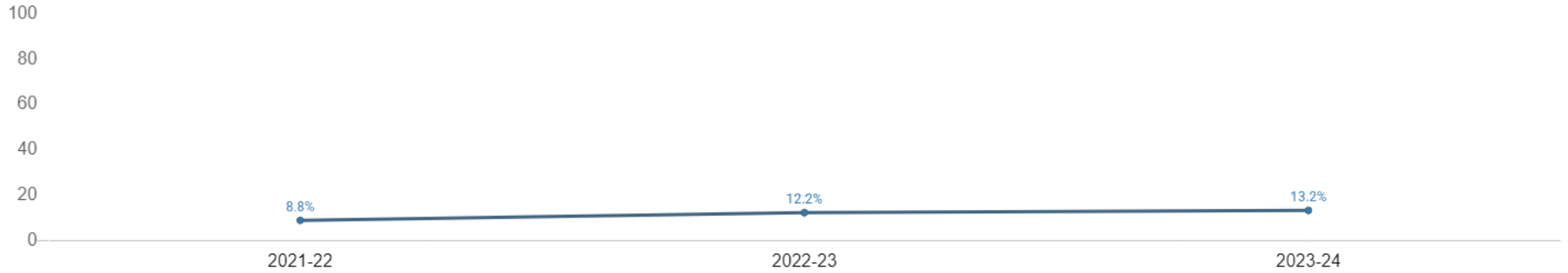

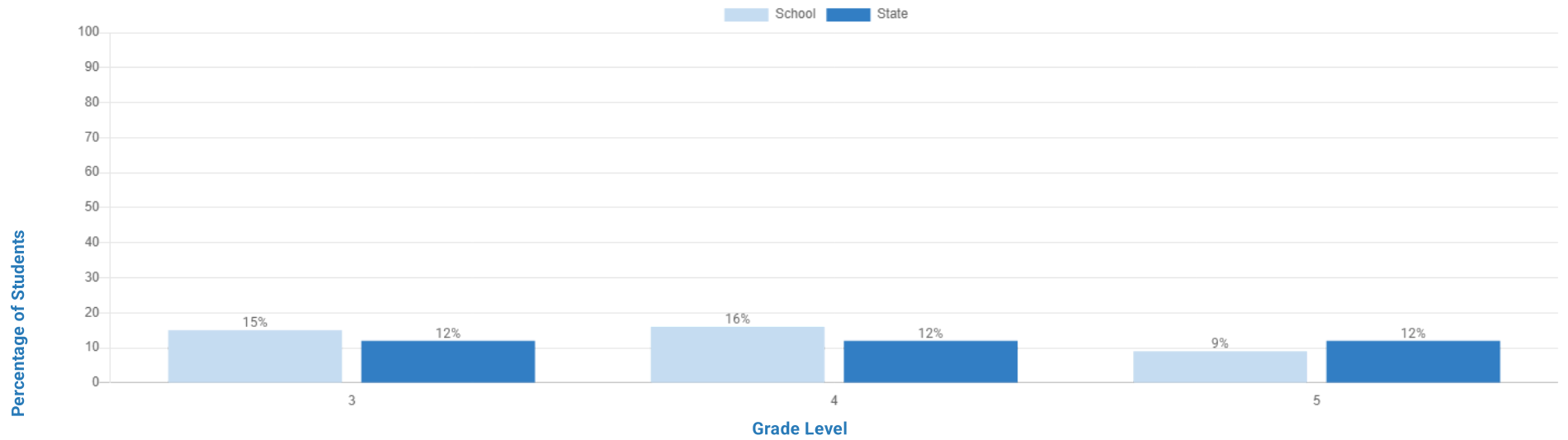

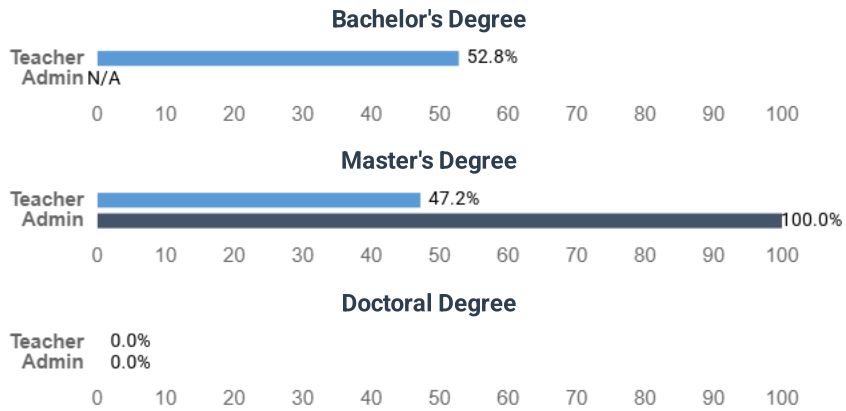

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Services can include: Leveled Literacy Intervention (LLI) that addresses reading comprehension skills, The Wilson Reading System supports students struggling with phonological and phonics skills, small group math basic skills intervention, and the visualizing and verbalizing program. Students with IEPs are served through special class programs (PKD, MD), pull-out resource replacement, and in-class services. Available school-based therapy: Speech-Language, Occupational, Physical, School Counseling, and Social Skills Lessons. The District has a Board Certified Behavior Analyst and each building has a school counselor to support student's needs. Section 504 Plans are provided to qualifying students. Students requiring therapeutic counseling during the school day are provided that service through Care Plus NJ.



Student Health and Wellness:

Health classes are taught that met the NJ State health and physical education standards. Health classes emphasize an introduction to healthy nutrition and physical fitness components. Mental health/ social wellness issues: The school employs full time a school school counselor, school psychologist and school nurse. The school school counselor has developed lesson to promote anti-bullying and support mental/social well being. Nutritional/Breakfast Programs Milk is provided to low income students who qualify.



Parent and Community Involvement:

Brooklake School: B2School Night, Parent-Teacher Conferences, Surveys, We host Principal Forums, SciP Committee, Safety Committee, PTA building meetings, PTA council meetings, weekly meetings with teacher/parents, weekly meetings with principal/parents, principal open hours, meetings with local community agencies (FP Rotary, Library, Police, Fire, etc.), Collaboration with Essex Environment Center, fundraisers for local charities.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The Florham Park School District administers a Climate and Culture survey once a year. Brooklake Elementary School has a Climate and Culture Committee that reviews the information, reports out to staff the results, and creates action plans to address the areas of need.



School Safety:

All doors are locked at all times. Visitors must enter the safety vestibule, sign in at the main office, provide driver's license, and are then provided a visitor's badge. Visitors must have a scheduled appointment. Staff are provided swipe cards to enter specific doors. Evacuation locations have been identified. Safety/Security drills are regularly practiced with staff and students. The district uses a Share911 account as a communication tool with staff and police. Each emergency drill is coordinated with the local police. The district uses A.L.I.C.E. protocol in the event of an intruder. The school has a SLEO-3 officer and the district has an SRO officer. Bollards have been placed at the school. Internal/external security cameras are used to monitor the school and property.



Technology and STEM:

This is a non traditional model of Education in which the classroom resembles a work environment and students contribute to solving problems in the community. STEM careers, experiences and skills drive the curriculum. Curriculum is integrated in authentic problem-based learning that is STEM career-oriented and cross-disciplinary. Students collaborate in teams to solve problems. Teachers facilitate teams of students towards solving problems and developing work for skills commonly the skills required by a STEM businesses in the area or region. Frequently, schools have partnerships with businesses to provide materials, resources, and capital. Every grade level has elements of coding, STEAM challenges, and engineering practices. The 2023-2024 was the 6th year of the full implementation of the STEAM curriculum.. Every K-8 student in the Florham Park School District participates in the STEAM program.
