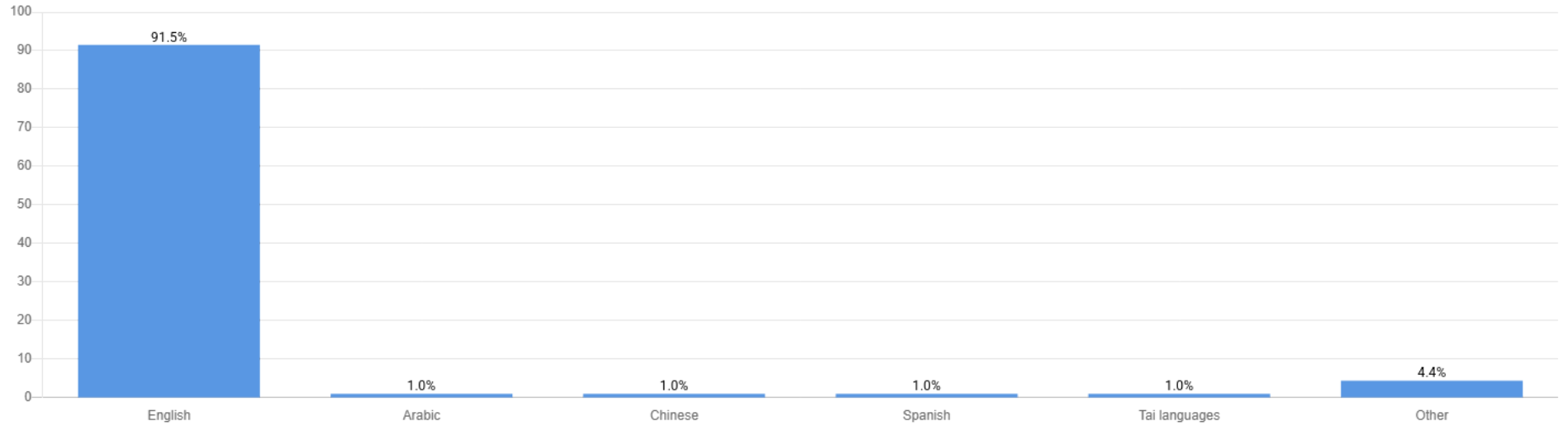

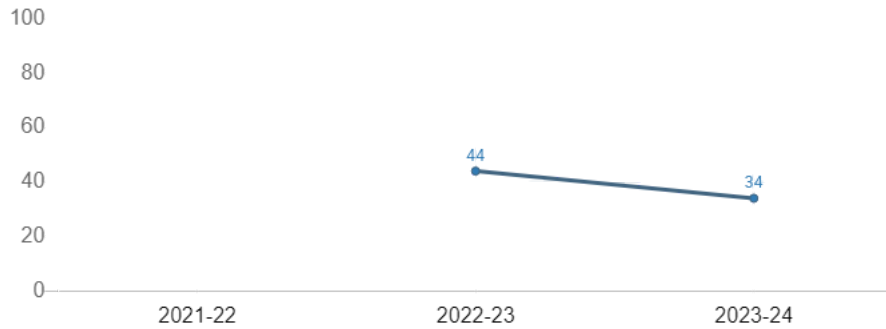

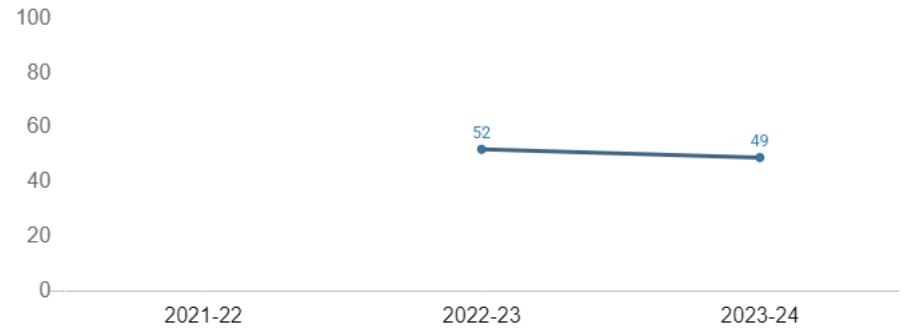

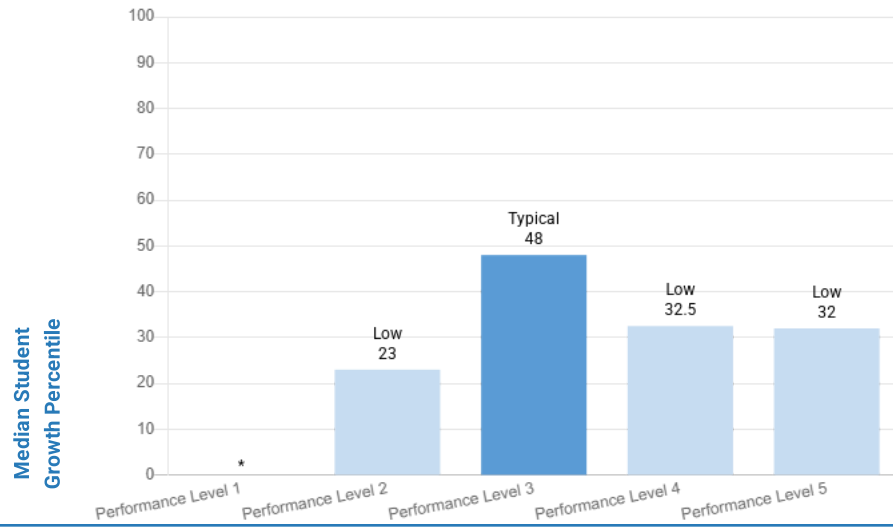

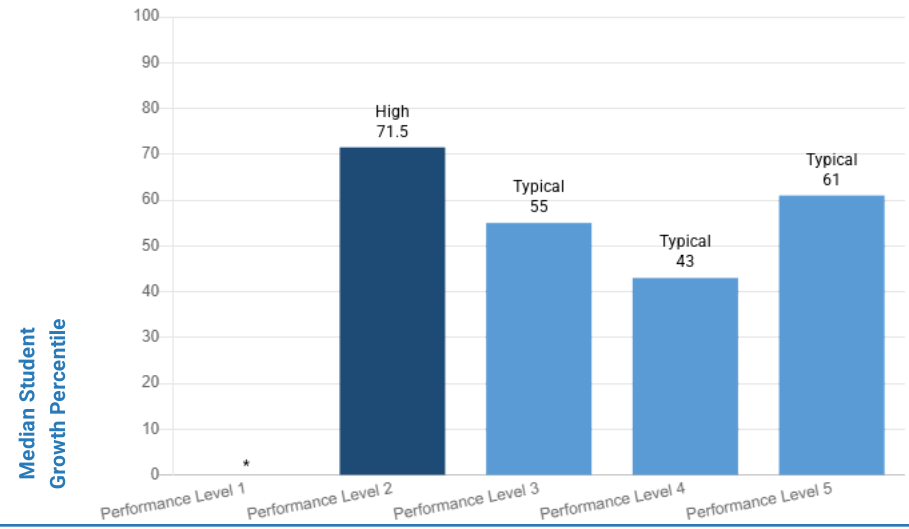

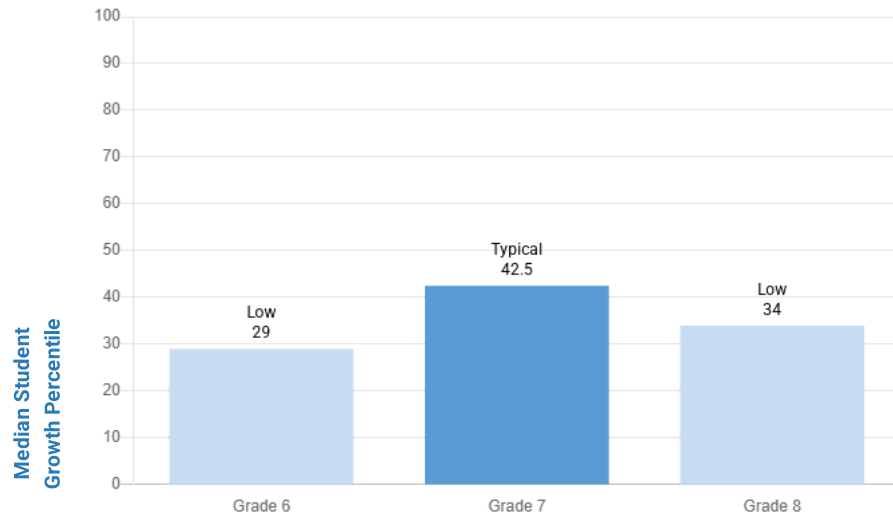

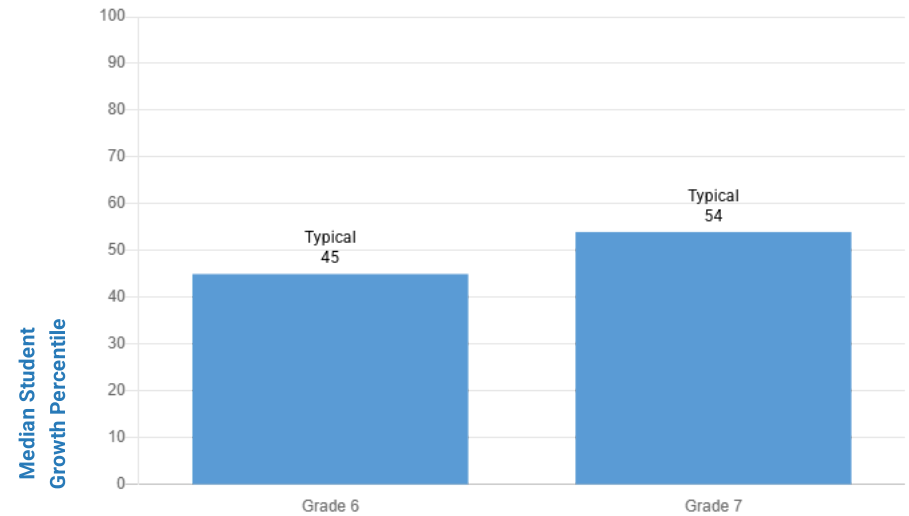

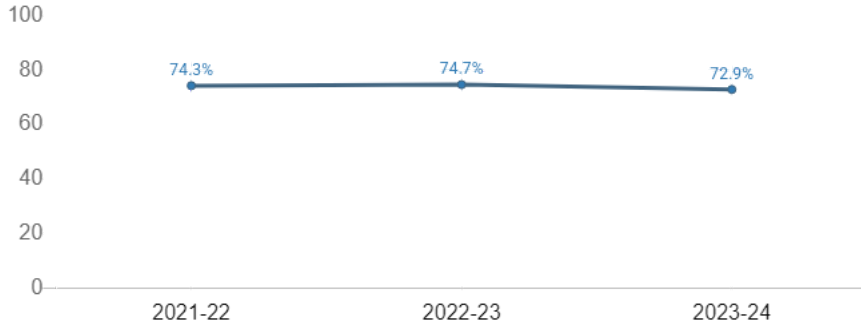

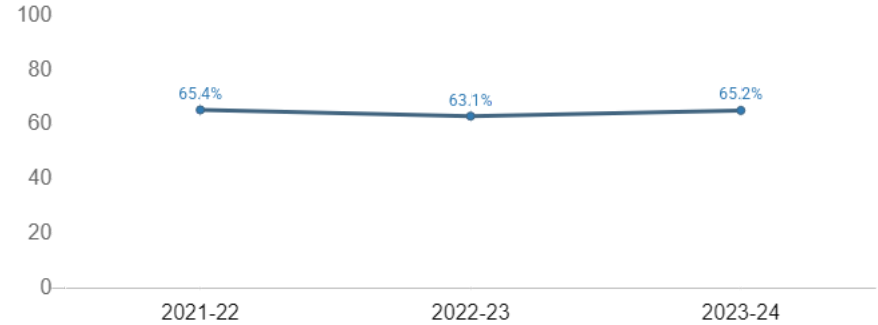
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 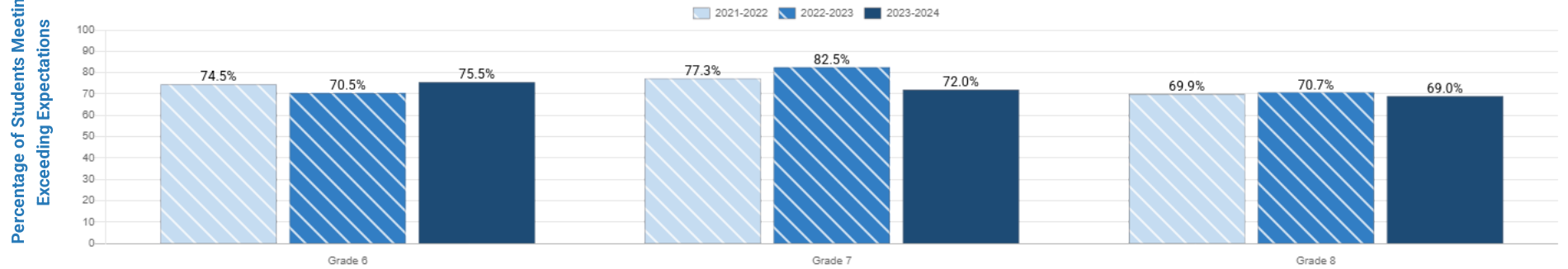

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows status in meeting annual targets. Annual targets are specific to each student group, school, and district and represent the expected proficiency needed to stay on track to meet long-term goals. 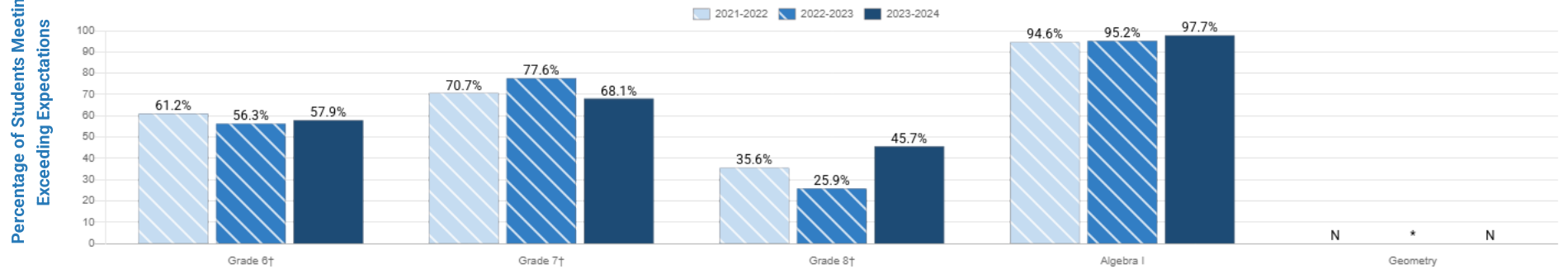

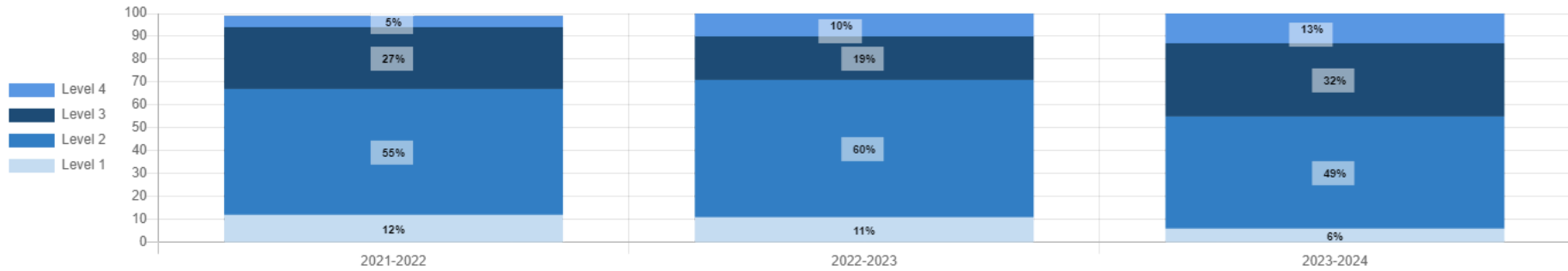

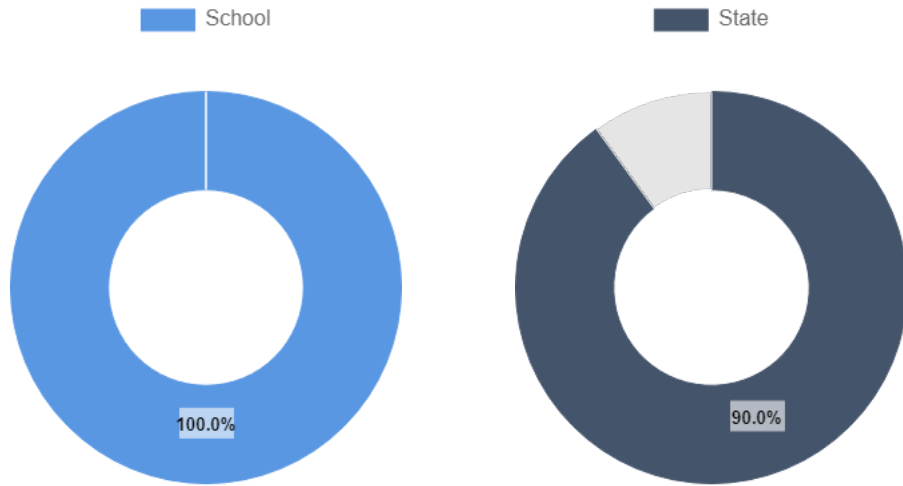

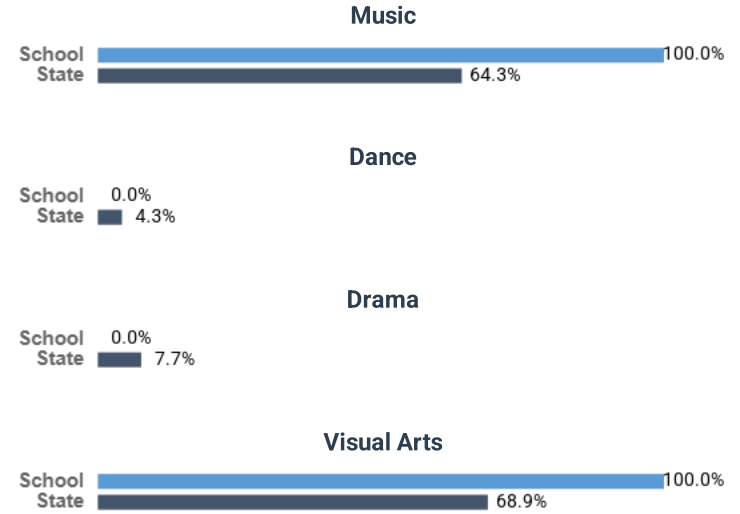

Students enrolled in one or more classes by discipline:



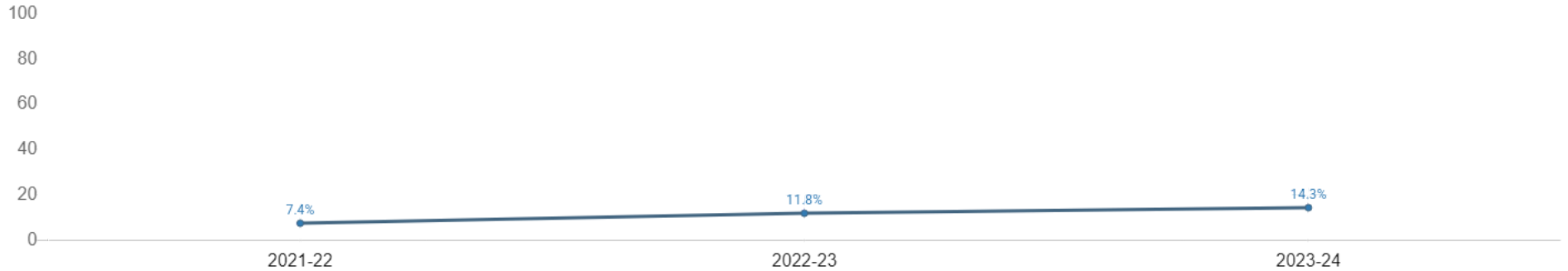

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 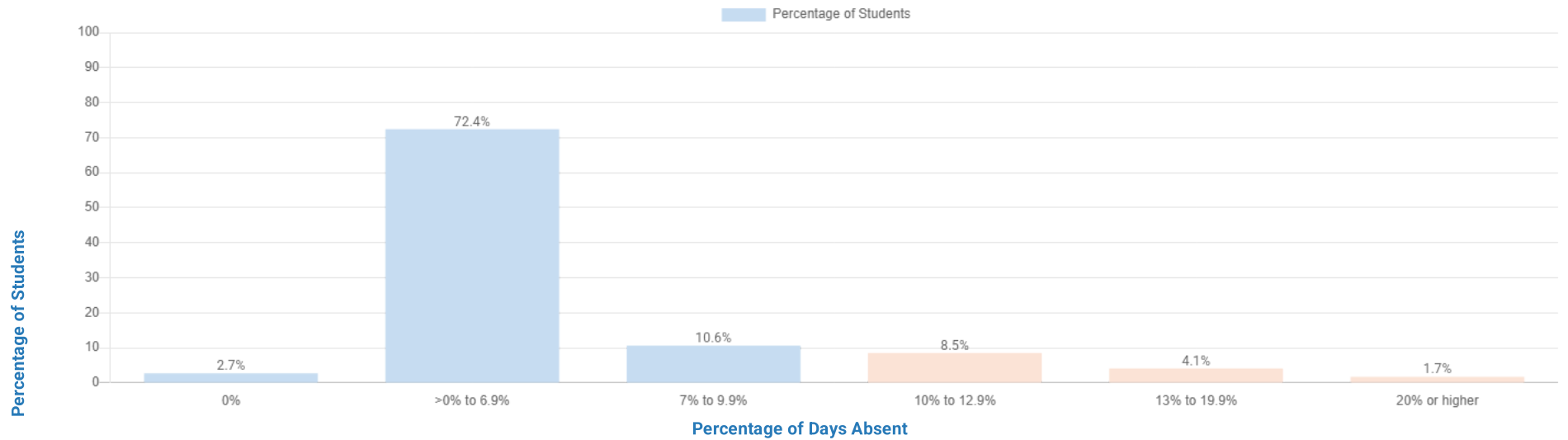

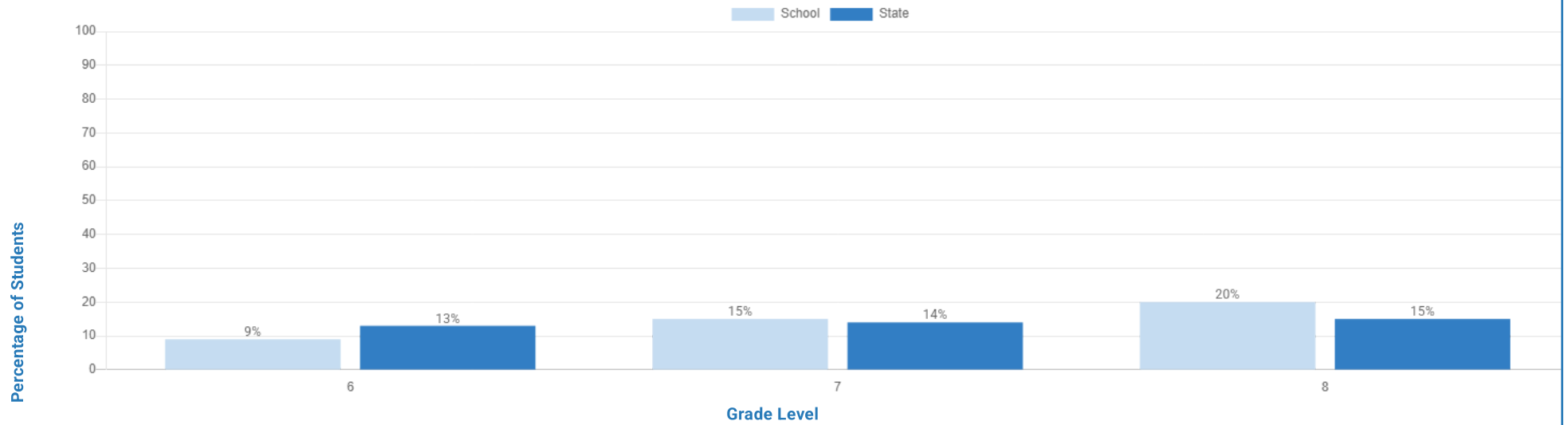

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 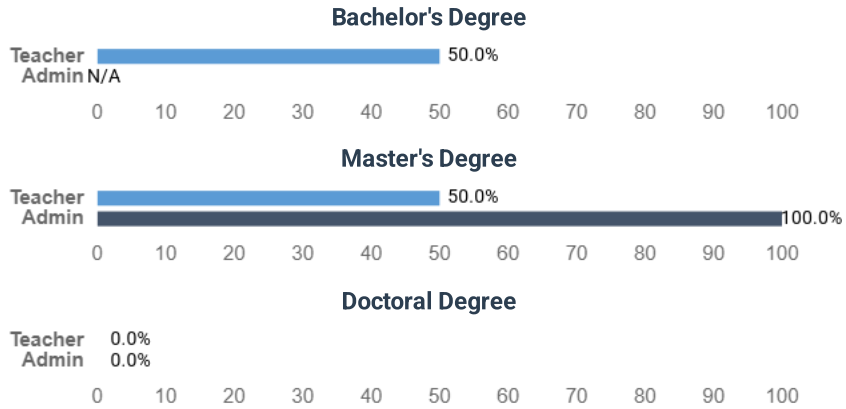

Staff and Professional Learning:

ELA -We are in year 8 of the English Language Arts initiative. After focusing professional development on reading and writing workshop. During these staff development days teachers analyze student data and work with students across the grade level as they practice new methods of instruction. Math - We are in year 7 of working with our district math consultant. Professional development covers many areas of instructional practices based on needs assessments that take place on a yearly basis. Leadership- 10 Ridgedale teachers and 7 administrators participate in a job embedded teacher leadership program. This institute is developmentally intentional as it incorporates adult learning theory, learning-oriented leadership, professional book clubs, and best practices in professional development to support the leadership capacity of informal teacher. STEAM/Science - week long training at the Science Institute learning components.



Student Supports and Services:

Our Schools provide students with support through a multi-tiered system. Students with reading difficulties are served by a Dyslexia Indicators Evaluation Process. Services can include: Leveled Literacy Intervention (LLI) that addresses reading comprehension skills, The Wilson Reading System supports students struggling with phonological and phonics skills, small group math basic skills intervention, and the visualizing and verbalizing program. Students with IEPs are served through special class programs (LLD), pull-out resource replacement, and in-class services. Available school-based therapy: Speech-Language, Occupational, Physical, School Counseling, and Social Skills Lessons. The District has a Board Certified Behavior Analyst and each building has a school counselor to support student's needs. Section 504 Plans are provided to qualifying students. Students requiring therapeutic counseling during the school day are provided that service through Care Plus NJ.



Student Health and Wellness:

Health classes are taught that met the NJ State health and physical education standards. Health classes emphasize an introduction to healthy nutrition and physical fitness components. Family life Health classes which include addressing dating violence prevention, family relationships, drug prevention, dating relationships, disease prevention (AIDS and other STDs), human growth and development and the reproductive system. Emphasize is on making healthy choices. LEAD classes (Law Enforcement Against Drugs) GREAT program (Gang resistance And Education Training) Patriots Club- Students learn and practice respect for country, flag, and self. Mental health/ social wellness issues: The school employs full time a school school counselor, school psychologist and school nurse. The school school counselor has developed weekly advisory lesson to promote anti-bullying and support mental/social well being. Nutritional/Breakfast Programs Milk is provided to low income students who qualify.

School Safety:

All doors are locked at all times. Visitors must sign in at the main office, provide driver's license, and are then provided a visitor's badge. Visitors must have a scheduled appointment prior to being permitted into the school. Staff are provided swipe cards to enter specific doors. Evacuation locations have been identified. Safety/Security drills are regularly practiced with staff and students. The district uses a Share911 account as a communication tool with staff and police. Each emergency drill is coordinated with the local police. The district uses A.L.I.C.E. protocol in the event of an intruder. The school has a SLEO-3 officer and the district has an SRO officer. Bollards and fencing have been placed at the school. Internal/external security cameras are used to monitor the school and property.

Technology and STEM:

The 6-8 grade STEM Lab is a non traditional model of Education in which the classroom resembles a work environment and students contribute to solving problems in the community. STEM careers, experiences and skills drive the curriculum. Curriculum is integrated in authentic problem-based learning that is STEM career-oriented and cross-disciplinary. Students collaborate in teams to solve problems. Teachers facilitate teams of students towards solving problems and developing work for skills commonly the skills required by a STEM businesses in the area or region. Every grade level will have elements of coding, STEAM challenges, and engineering practices. The 2022-2023 was the 5th year of the full implementation of the STEAM curriculum.. Every K-8 student in the Florham Park School District participates in the STEAM program.
