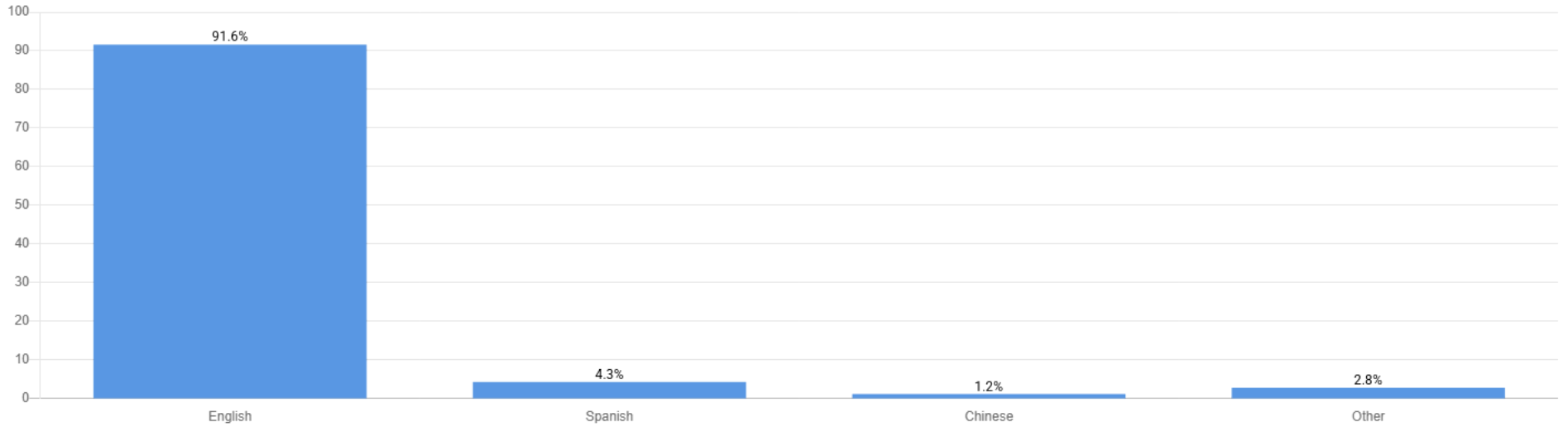

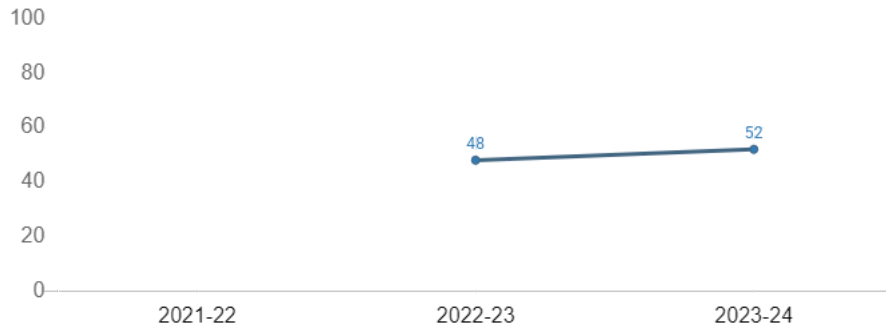

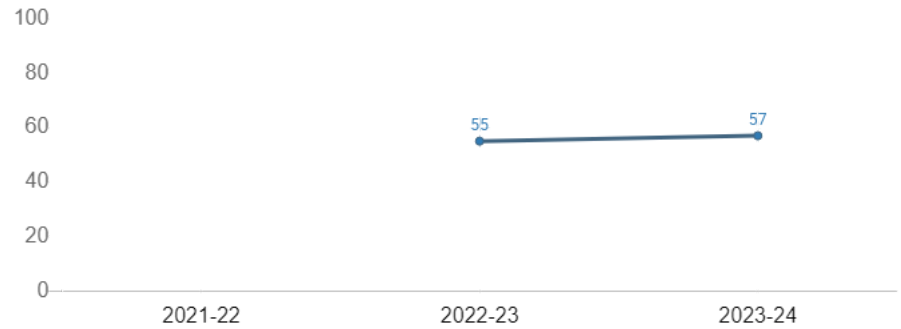

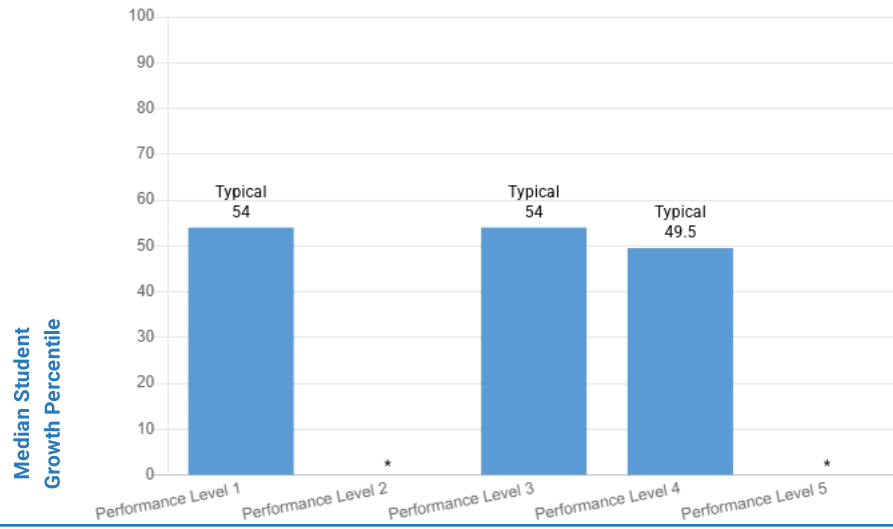

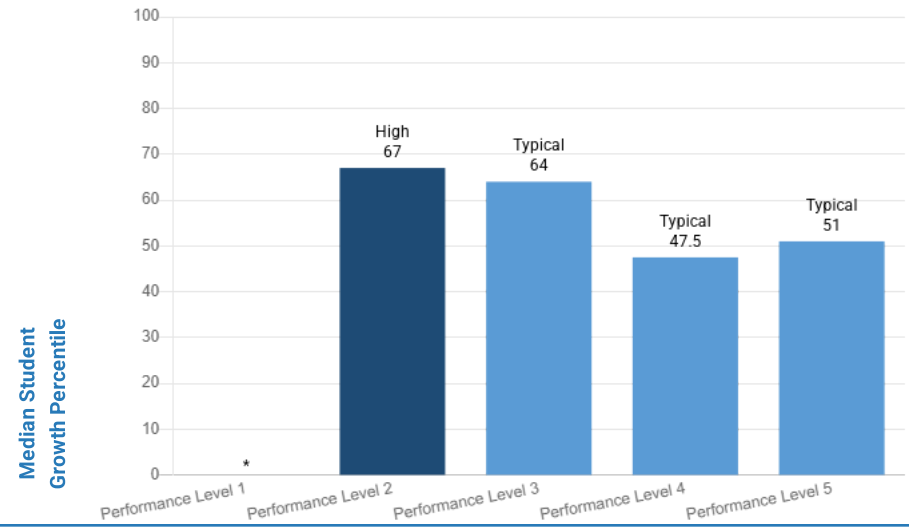

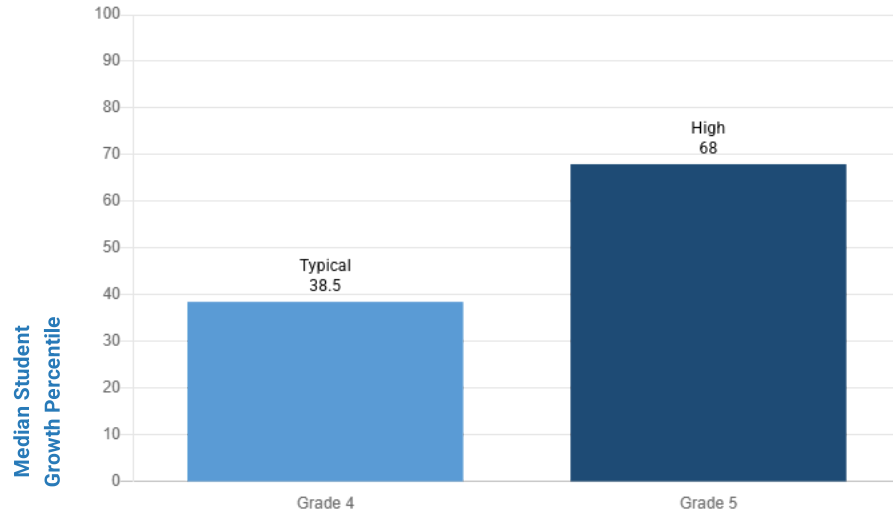

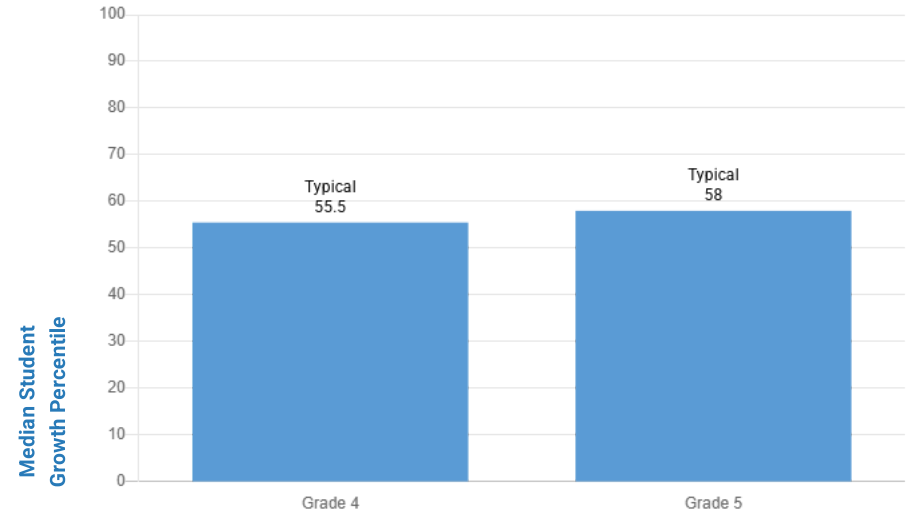

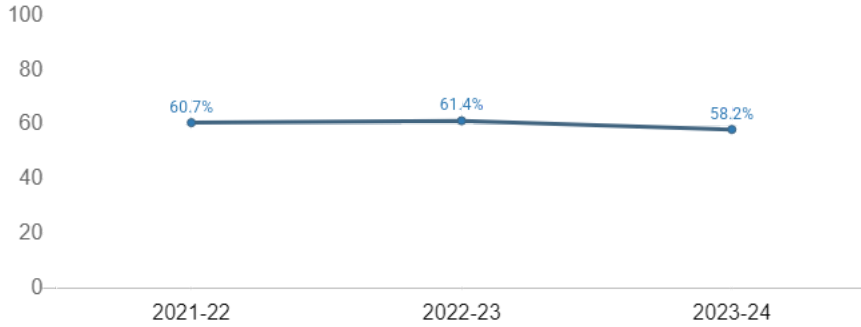

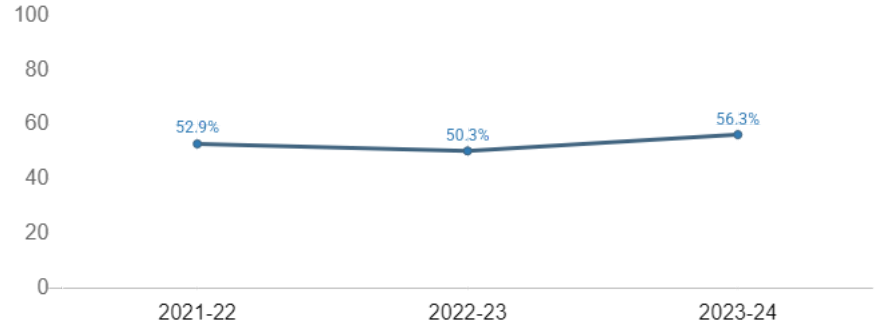
### English Language Arts and Mathematics Performance Trends

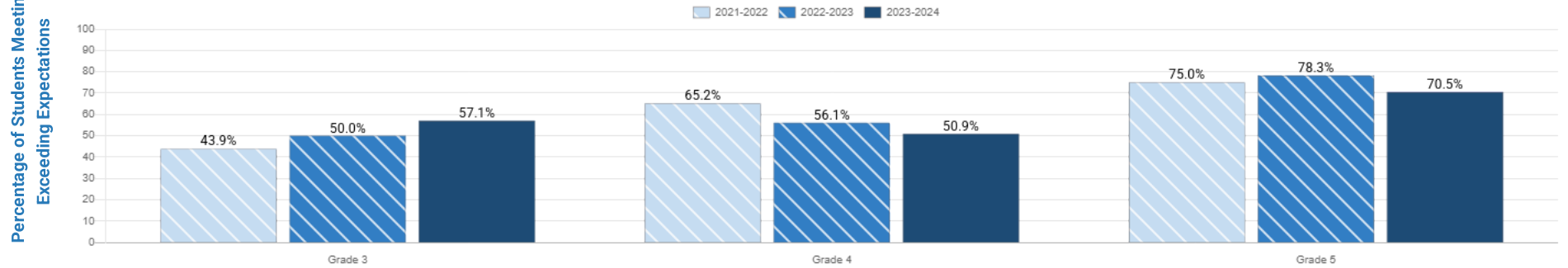

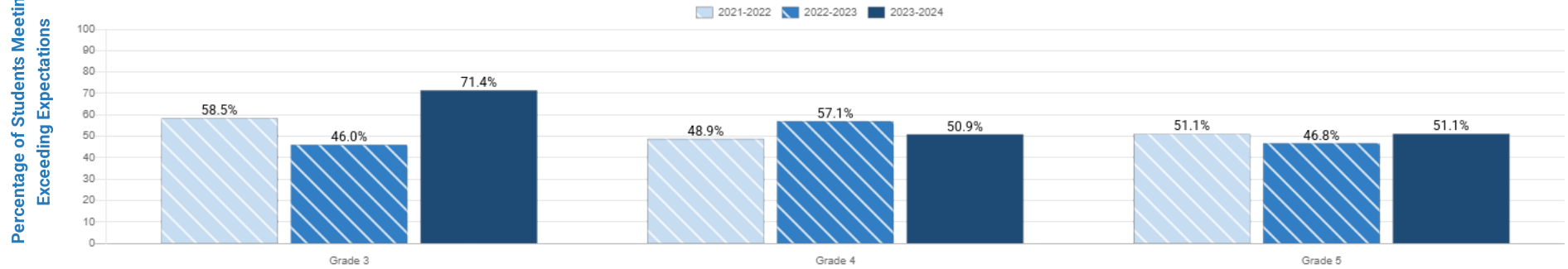

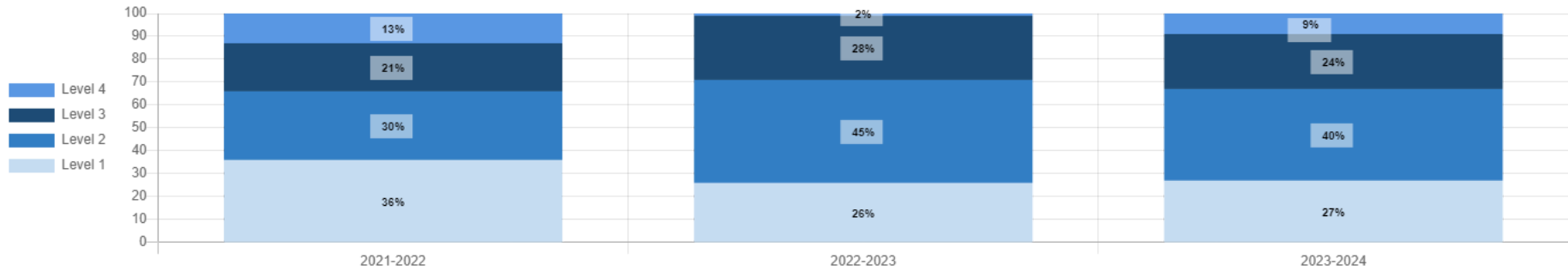

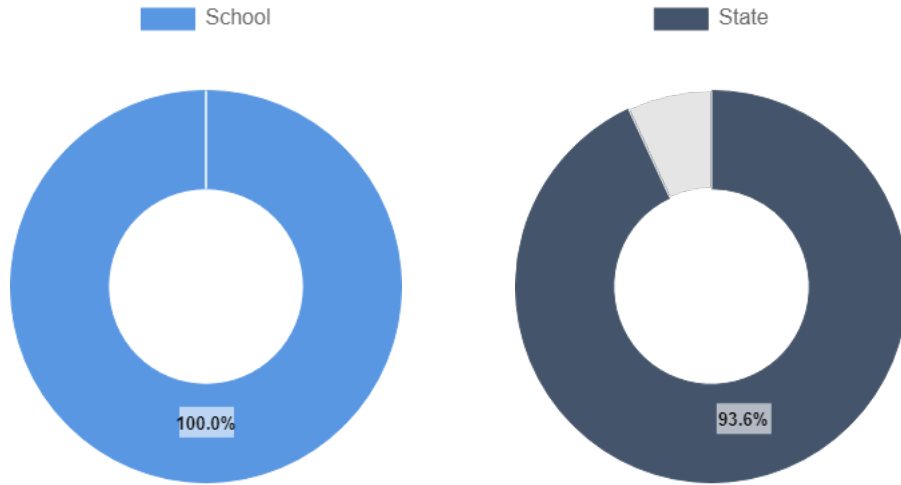

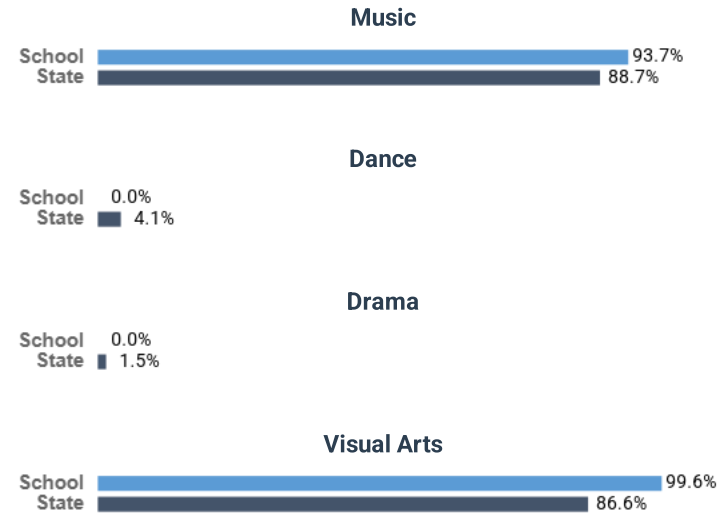

**Students enrolled in one or more classes by discipline:**



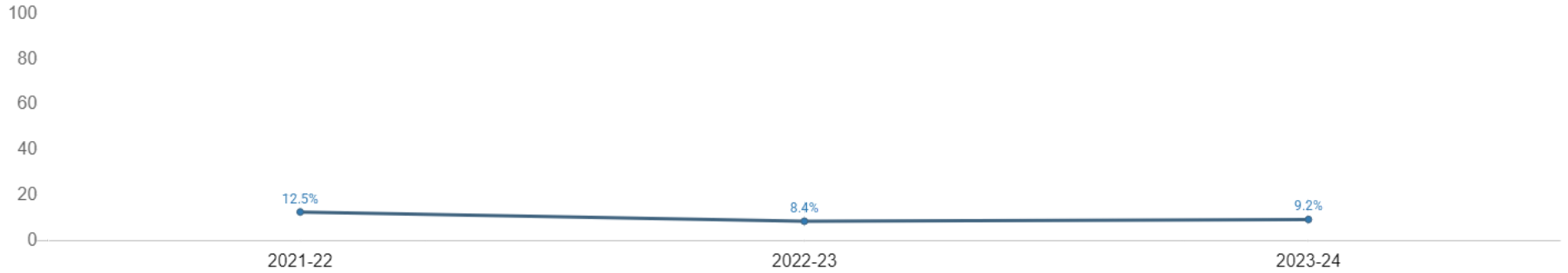

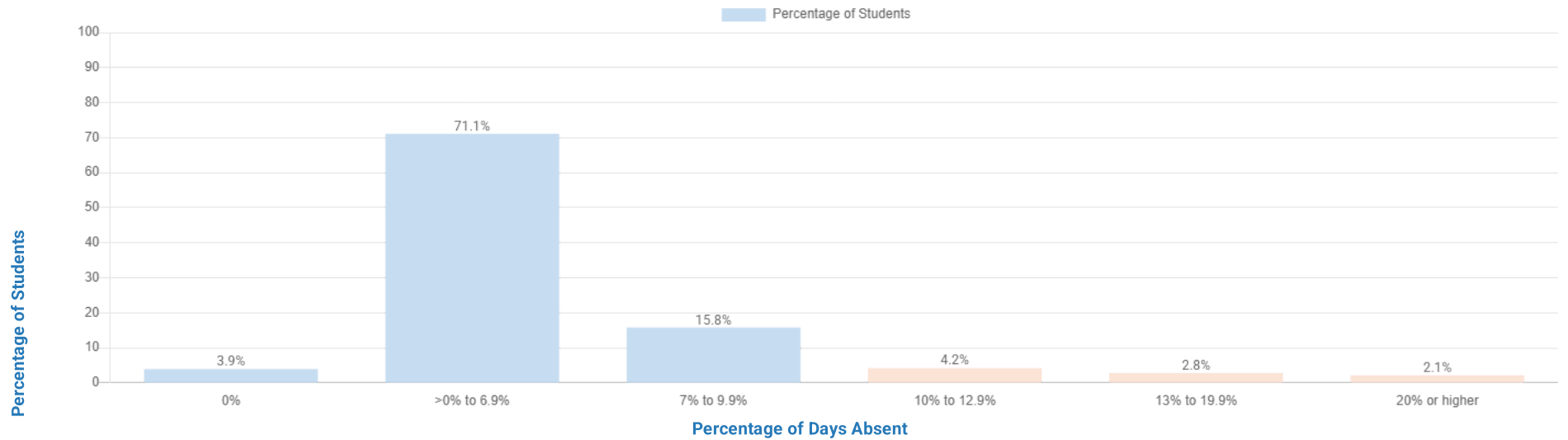

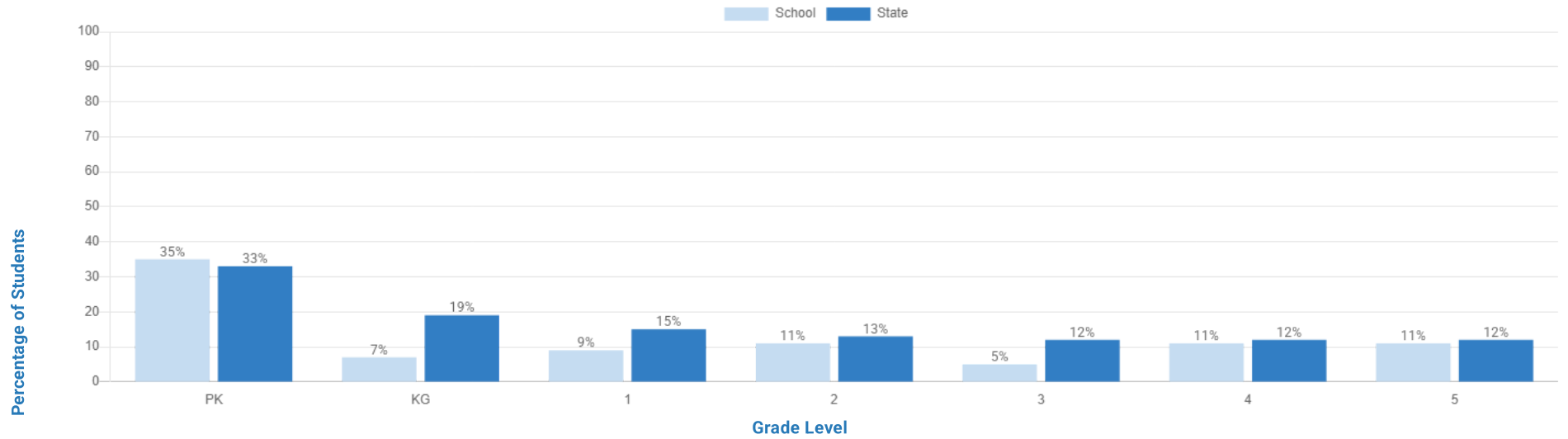

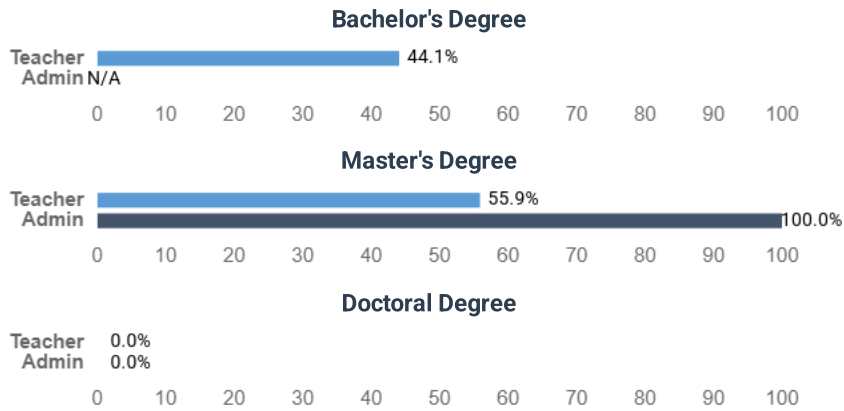

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. District professional development days offered throughout the school year target specific learning strategies and align to our district and building goals. Professional development is differentiated as staff is given choices to select activities that best align to their needs. Professional Learning Communities (PLC's) allow for collaboration and a common understanding to promote a shared vision of a Community That Inspires Excellence.



### Student Supports and Services:

ELL services are provided daily to acquire English language proficiency. Students with disabilities have individual goals addressed through their IEPs. Struggling general education student needs are addressed through our Basic Skills Program. Additionally, struggling students can receive support through our after-school Bridge Program. The Intervention and Referral Services Team identify and offer tiered level of supports for students having difficulty with academics as well as social, emotional, and behavioral development. Daily guidance counselor support is available for all of our students.



### Parent and Community Involvement:

Active PTA provides school and family events to enhance school programs including cultural arts, presentations, family involvement events and regular meetings and communication. Partnerships with local businesses to support student learning and curriculum initiatives play a big role in the community connecting with our students and school.
