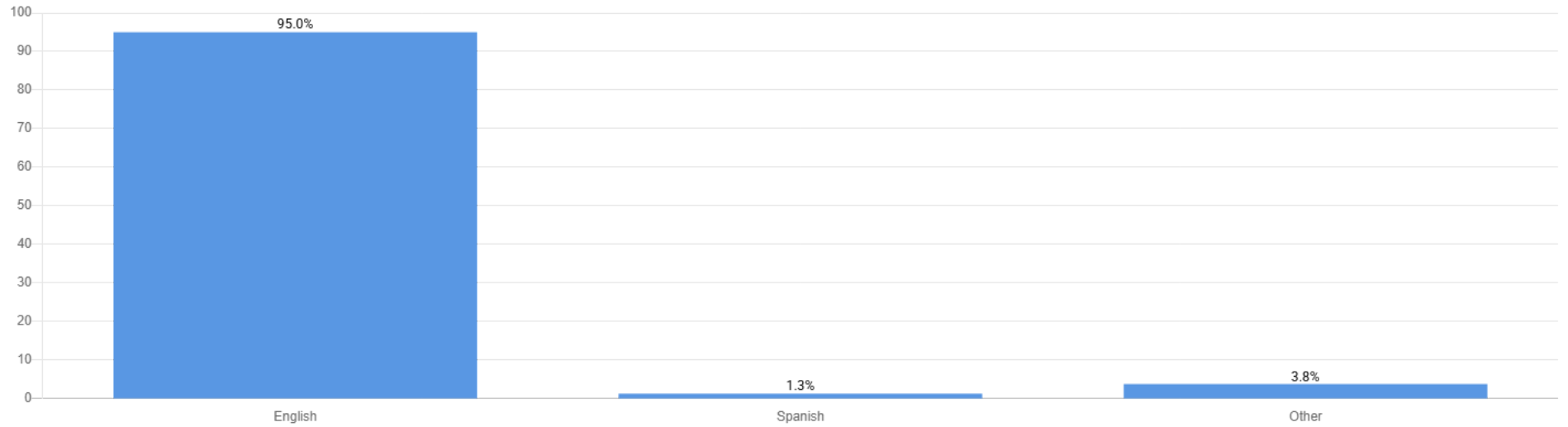

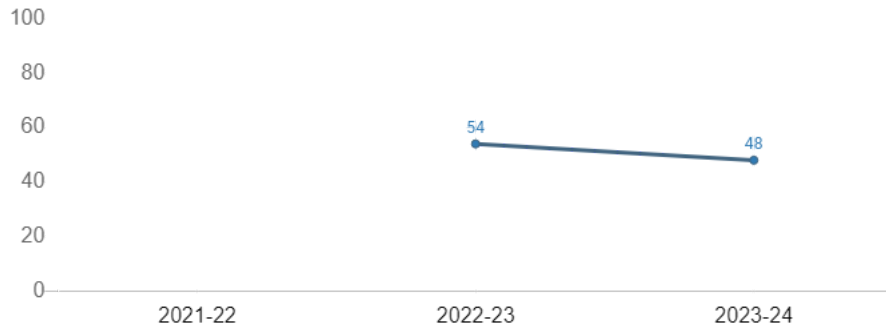

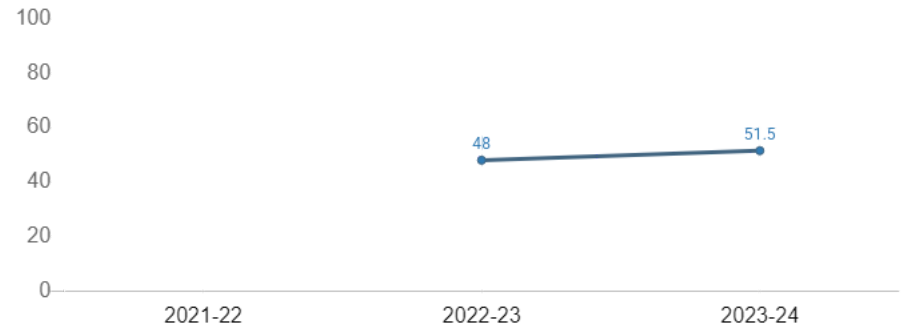

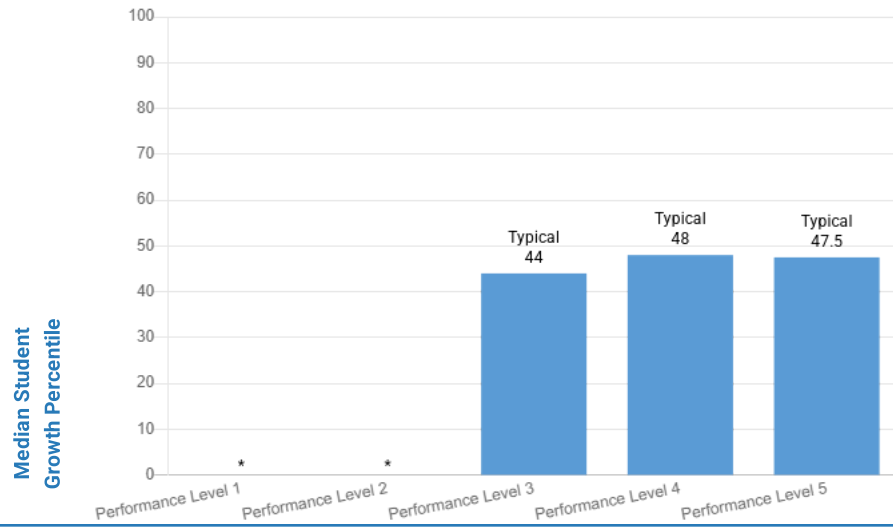

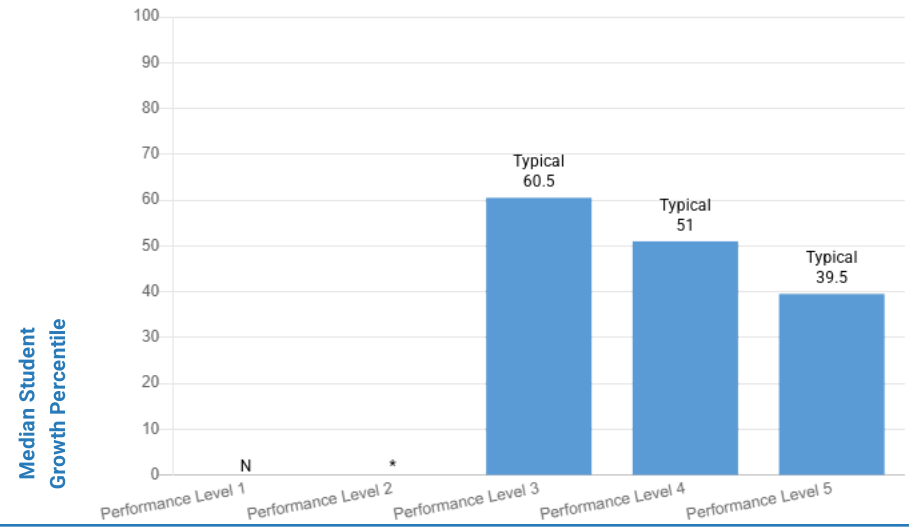

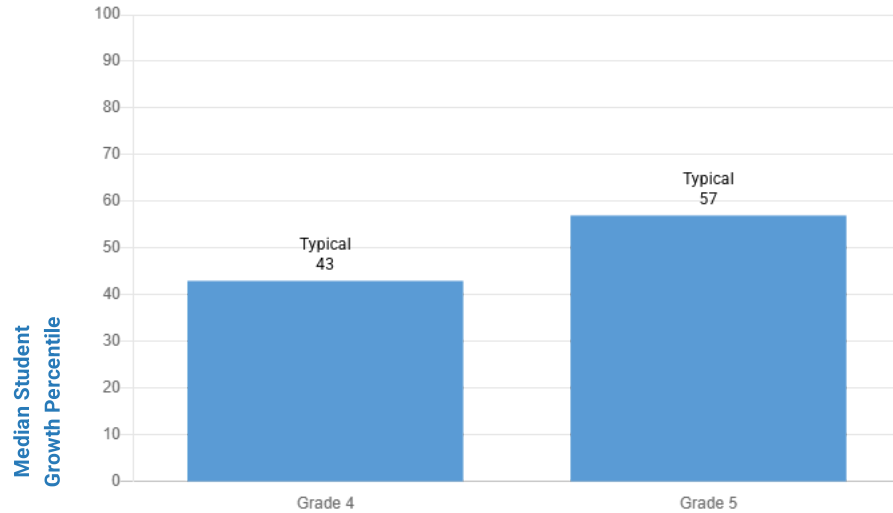

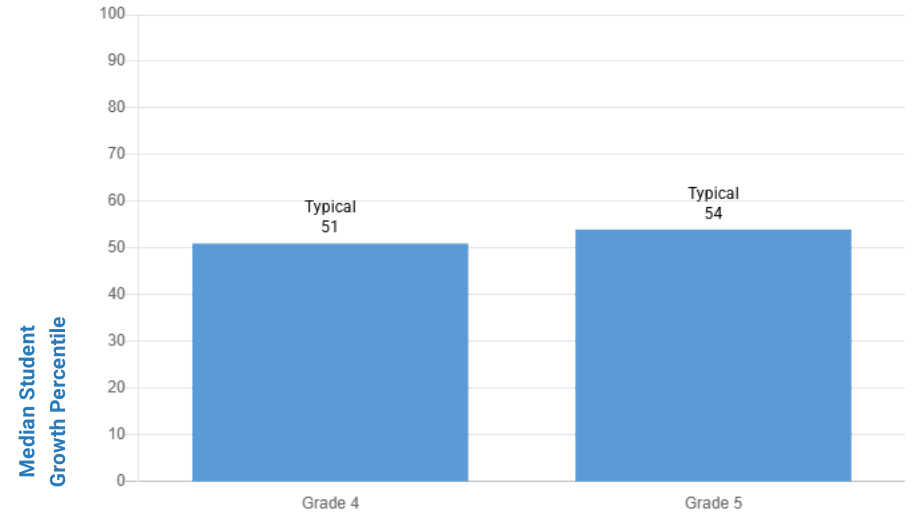

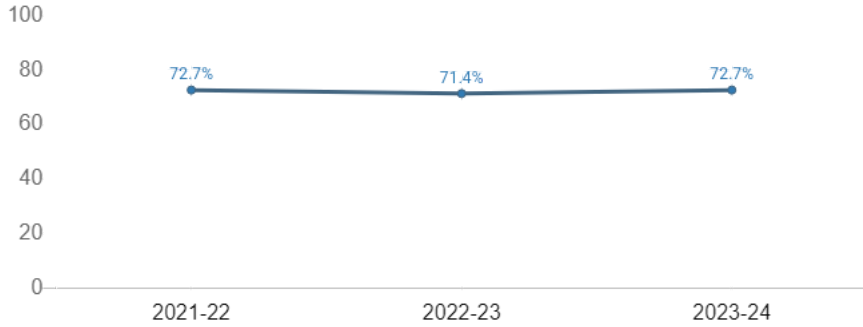

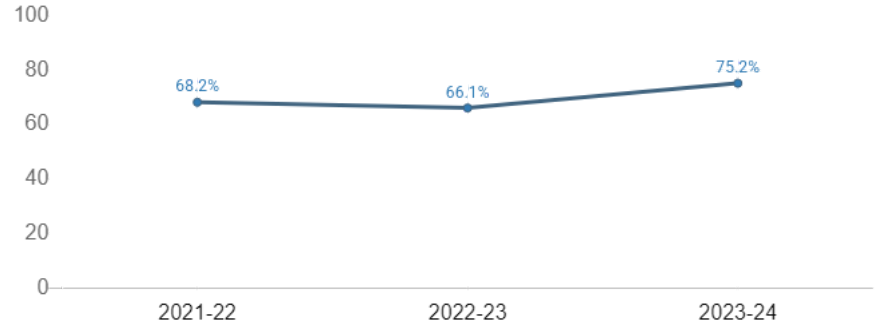
English Language Arts and Mathematics Performance Trends

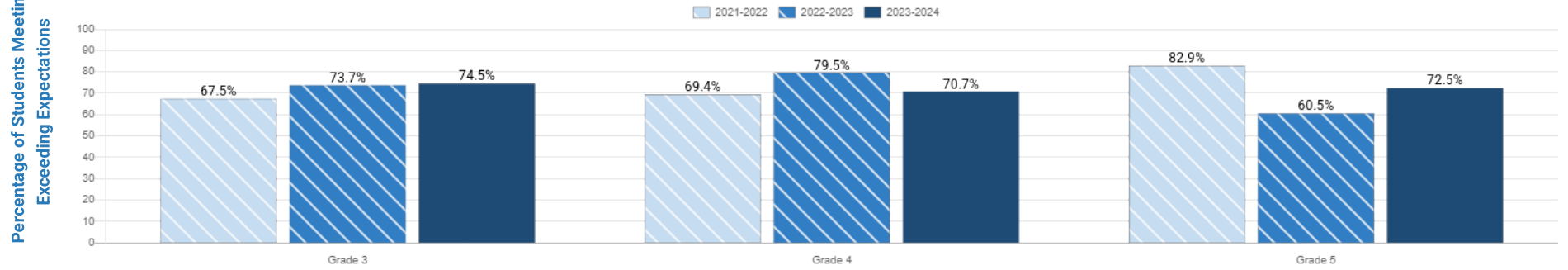

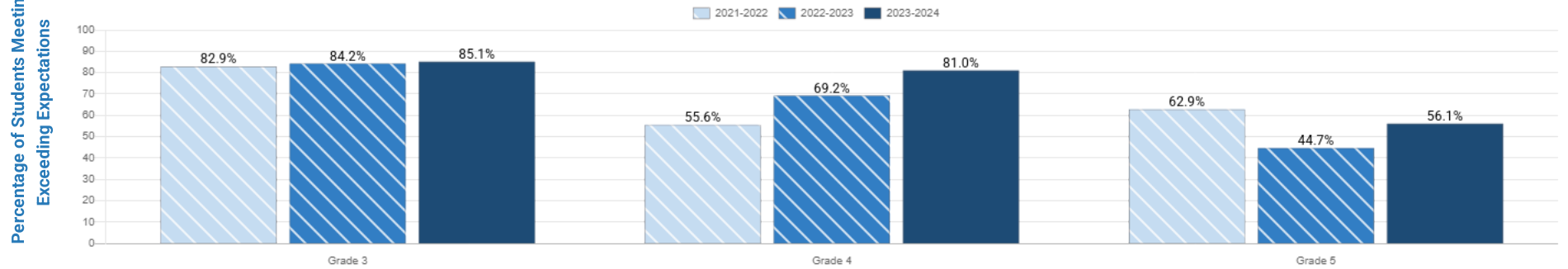

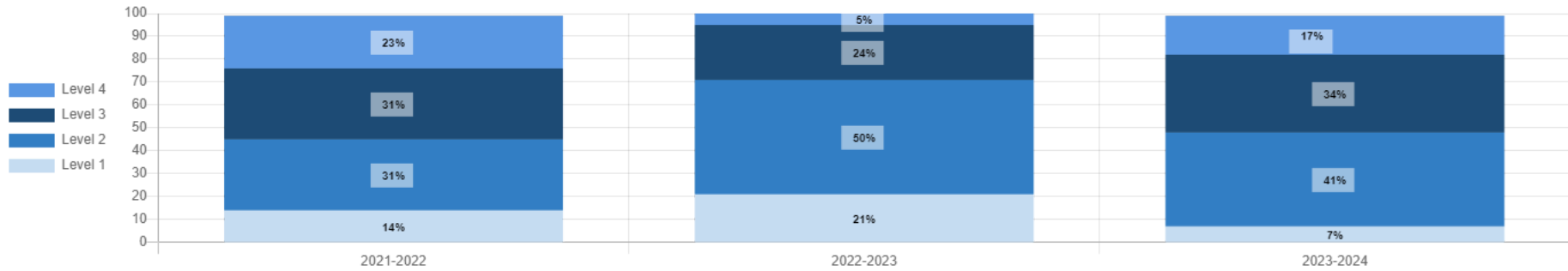

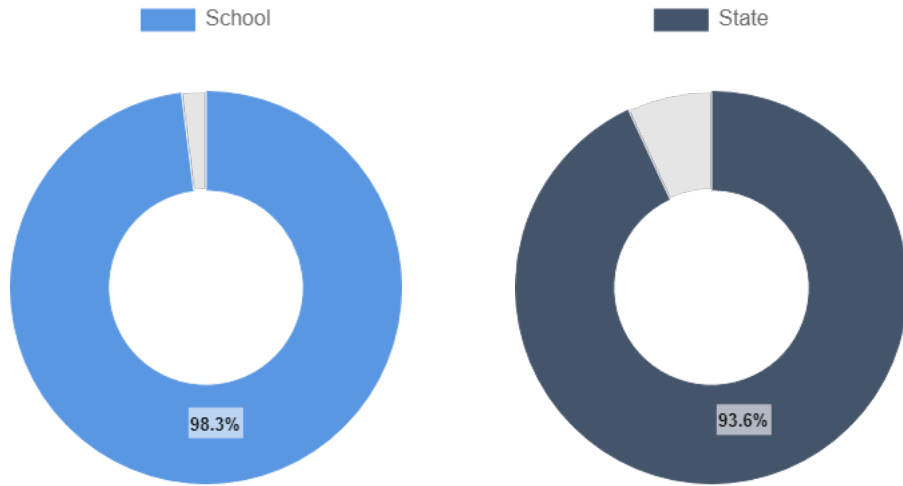

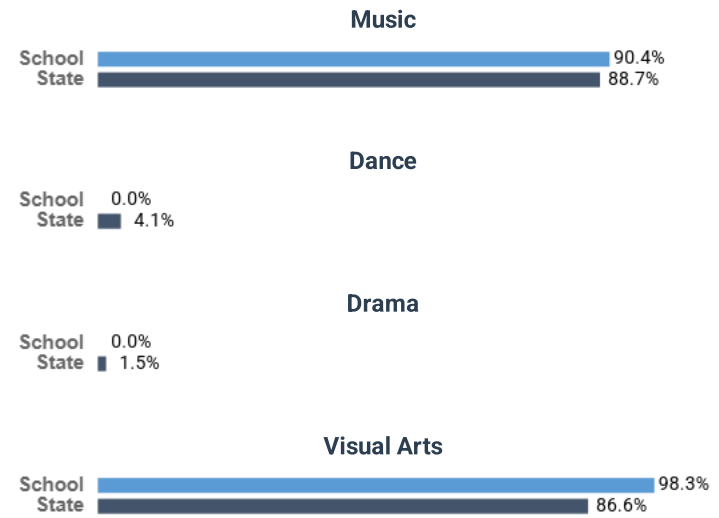

Students enrolled in one or more classes by discipline:



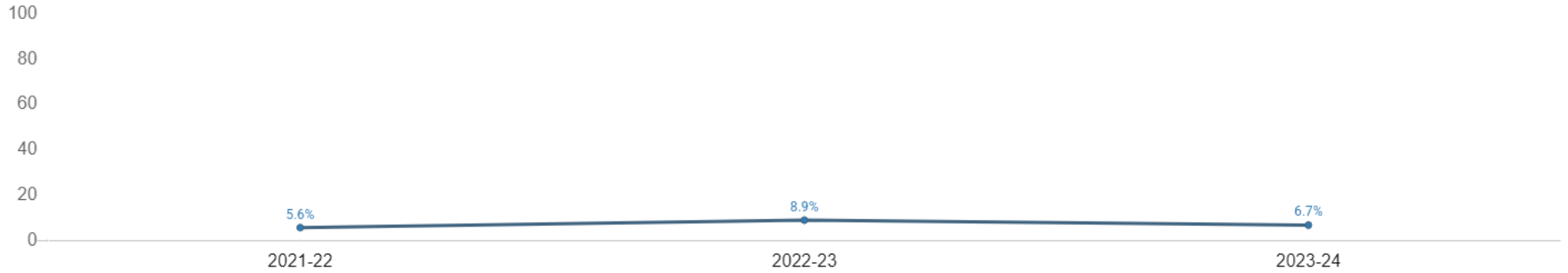

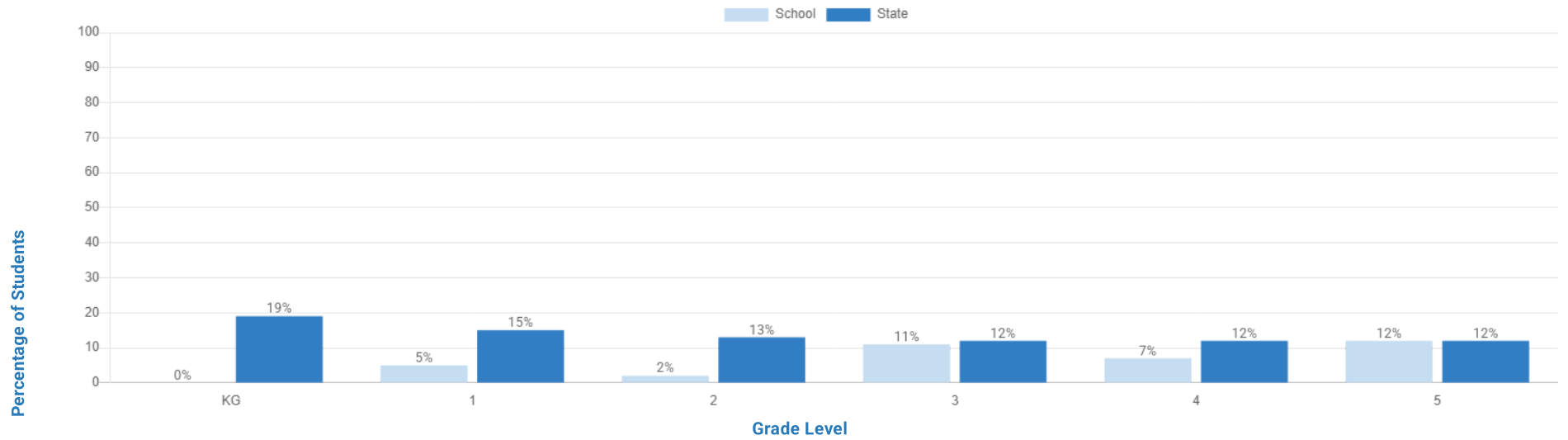

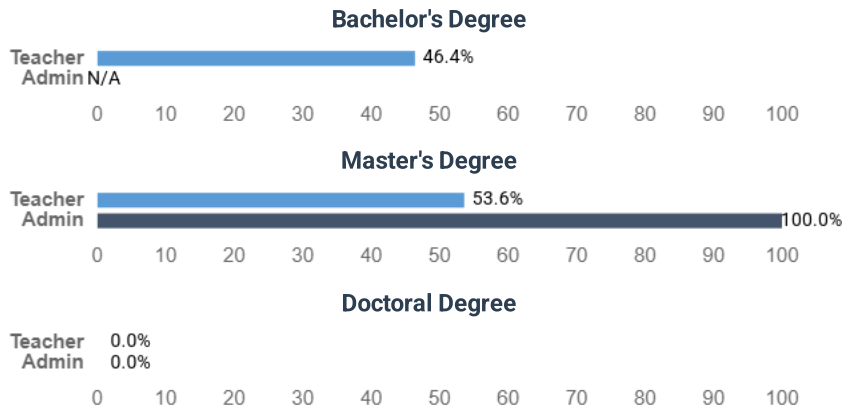

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Highlights:

- Students participate in advanced computer activities including coding, robotics, and app design. Responsible and safe tech use is stressed through recognized best-practice materials.
- Strong community partnerships with local groups and international organizations engage our students in career-ready explorations.
- Enriched, high-engagement learning opportunities exist via an after-school program, cultural arts programs provided by the school and our PTA, and grade level performances.

Staff and Professional Learning:

Professional development takes place on both the school and district level. Grade level and subject-area/department meetings occur monthly to increase collaboration across the district and analyze student data to help improve and guide instruction. Teachers select outside professional development that aligns to their Professional Development Plan and share these experiences with their teammates. District professional development days offered throughout the school year target specific learning strategies and align to our district and building goals. Professional development is differentiated as staff is given choices to select activities that best align to their needs. Professional Learning Communities (PLC's) allow for collaboration and a common understanding to promote a shared vision of a Community That Inspires Excellence.



Student Supports and Services:

Students with a variety of needs are appropriately serviced by trained professionals. ELL services are provided daily to acquire English language proficiency. Students with disabilities have individual goals addressed through their IEPs. Struggling general education student needs are addressed through our Basic Skills Program. Additionally, struggling students can receive support through our after-school Bridge Program. The Intervention and Referral Services Team identify and offer tiered level of supports for students having difficulty with academics as well as social, emotional, and behavioral development. Daily guidance counselor support is available for all of our students and weekly character education lessons, led by the homeroom teacher, address group social and emotional needs.



Parent and Community Involvement:

Our PTA is highly active and promotes an inclusive school environment. They host an array of student, school and family events to enhance school programs, including Cultural Arts presentations, Family Fun Nights, afterschool activities, and regular meetings and weekly communication. Partnerships with local businesses further support student learning and curriculum initiatives. Service projects, including a holiday drive and annual food drive, support the larger community. Parents are invited to grade level performances, school concerts and special instructional fairs. Attendance is always high at all of these events, as well as planned school events like Back to School Night and parent teacher conferences.
