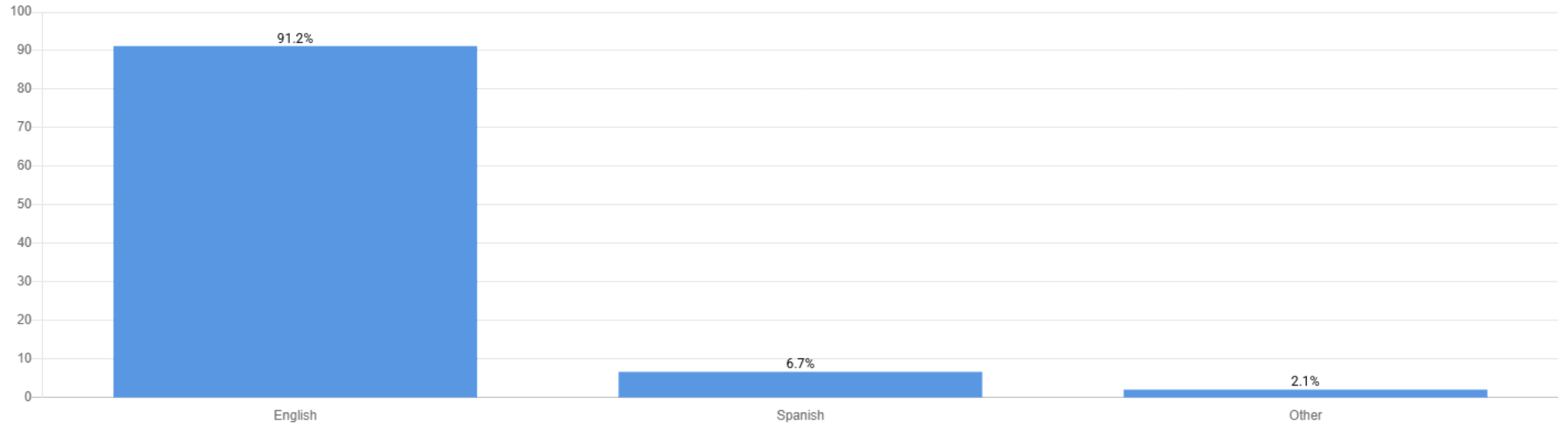

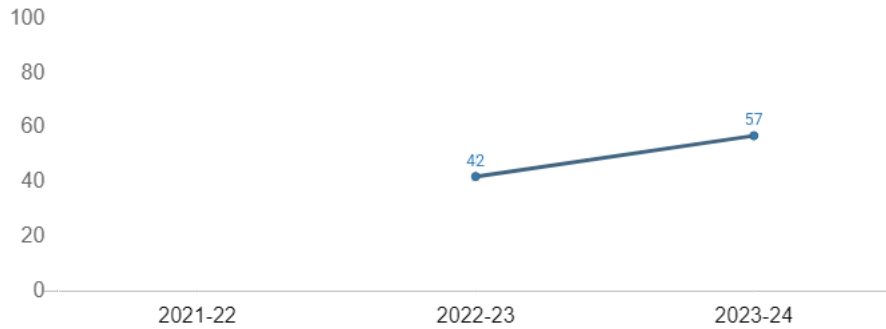

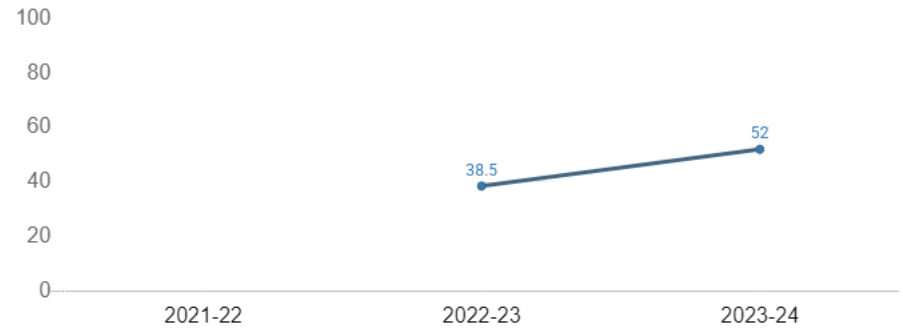

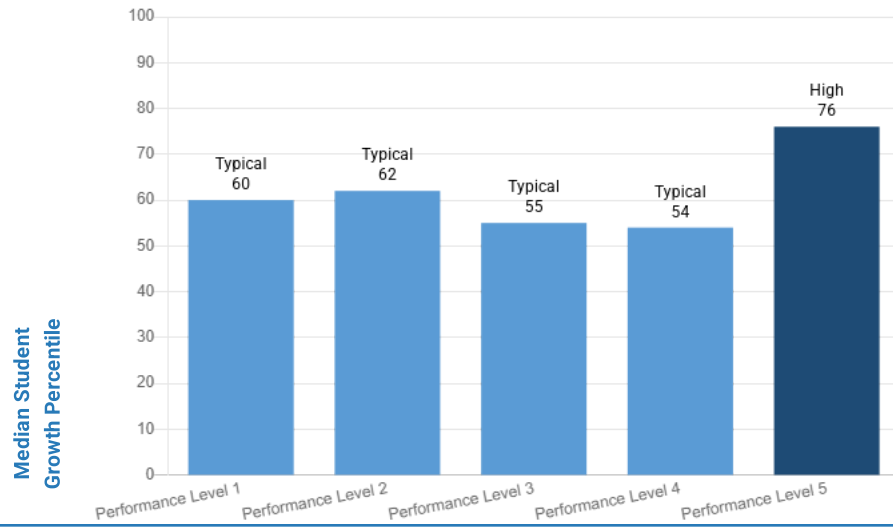

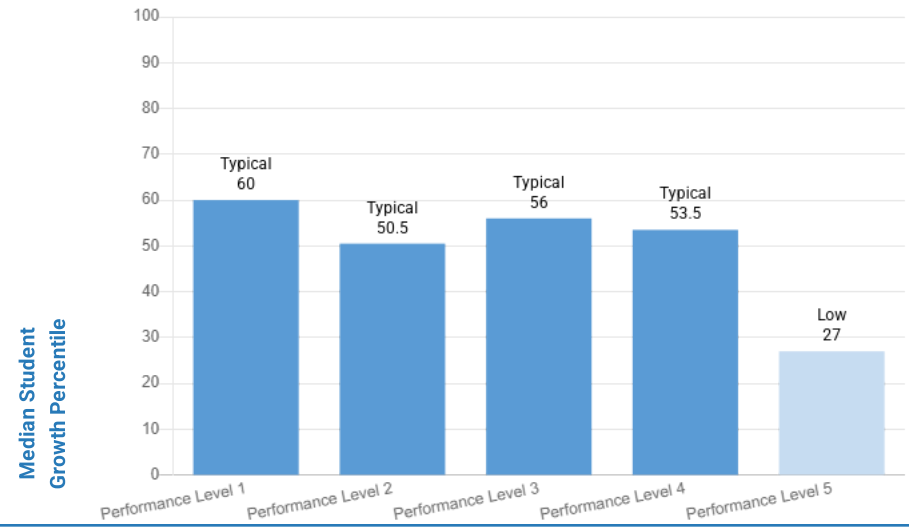

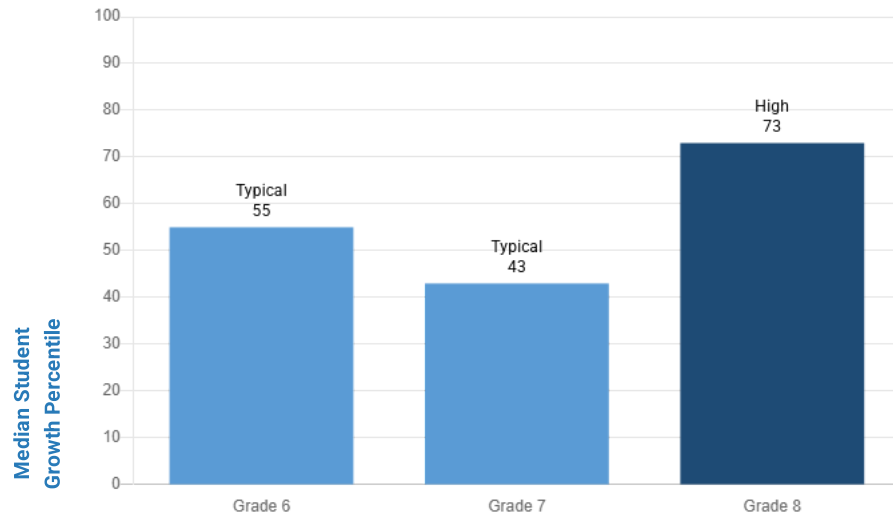

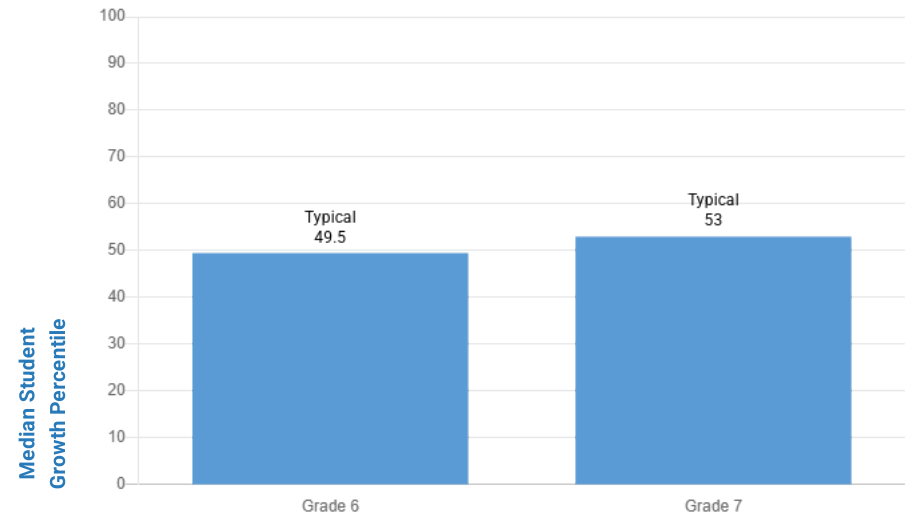

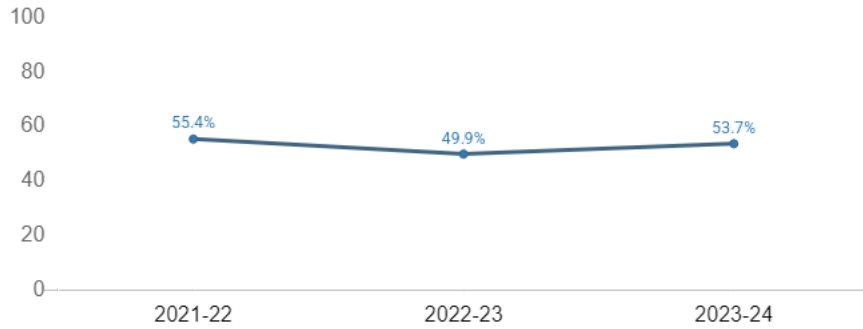

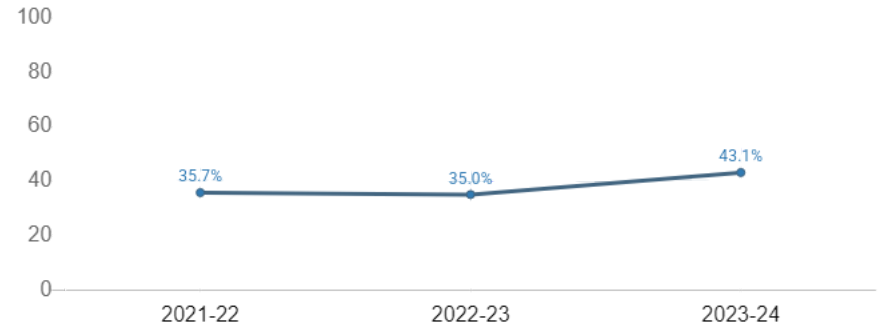
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 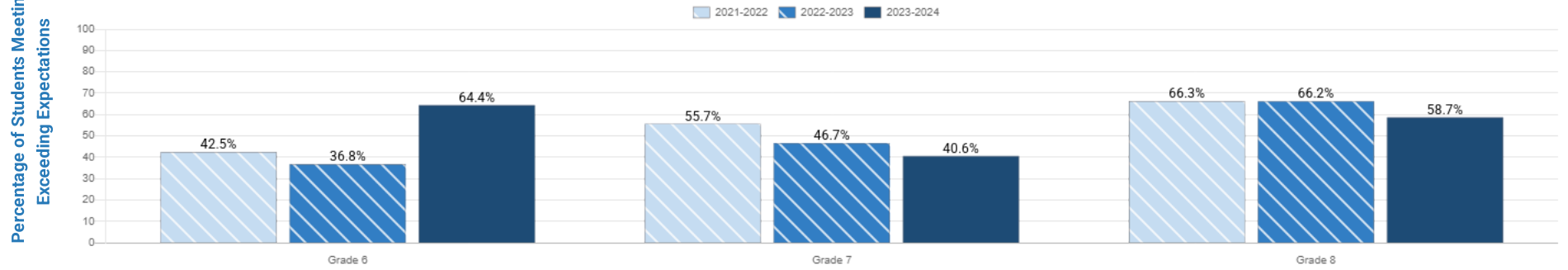

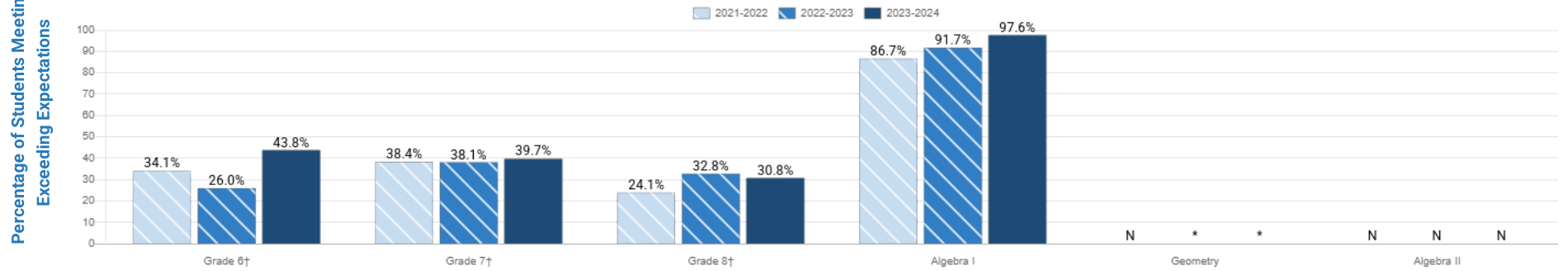

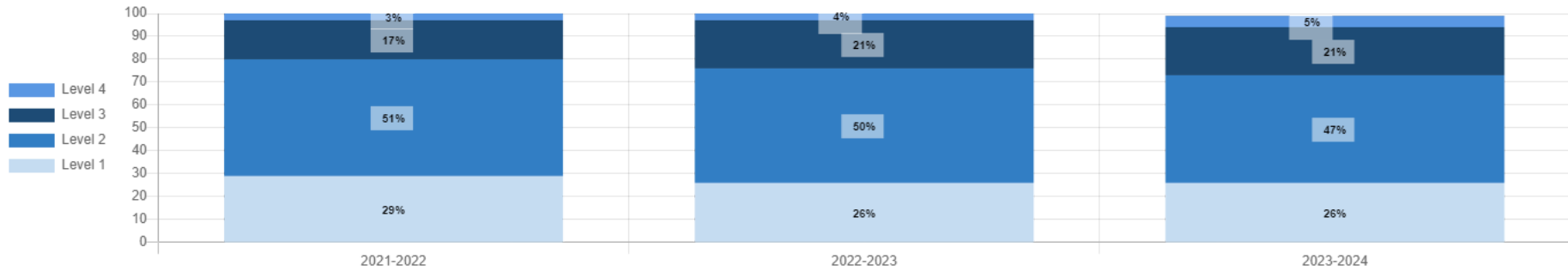

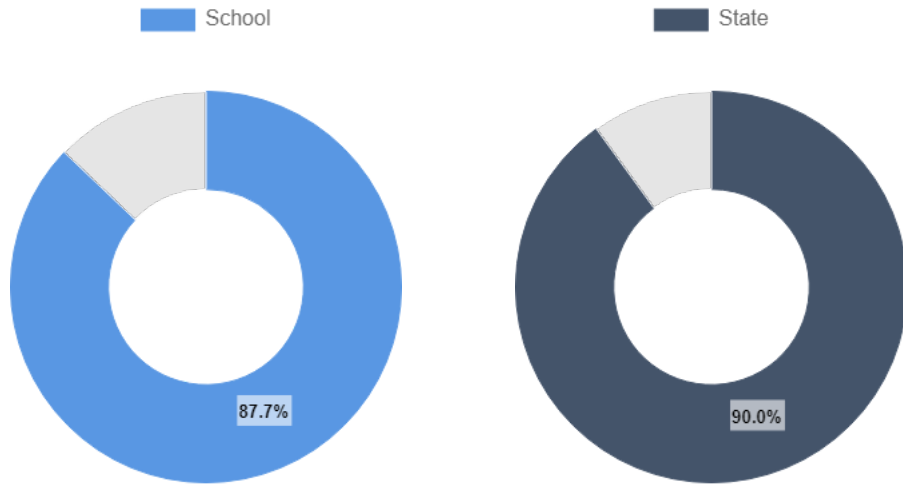

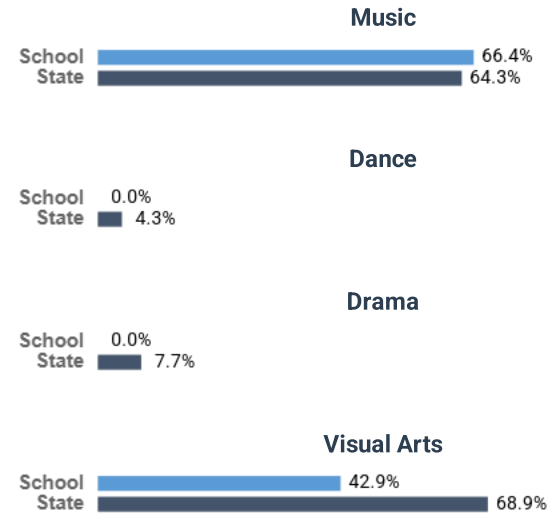

Students enrolled in one or more classes by discipline:



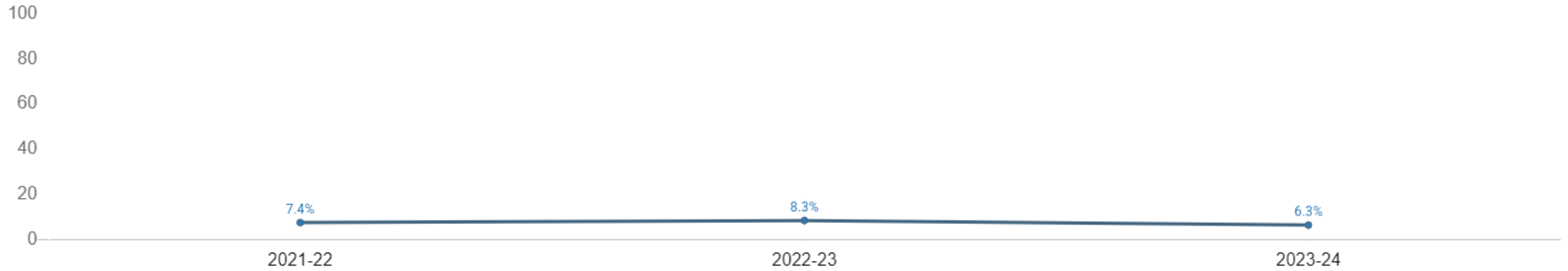

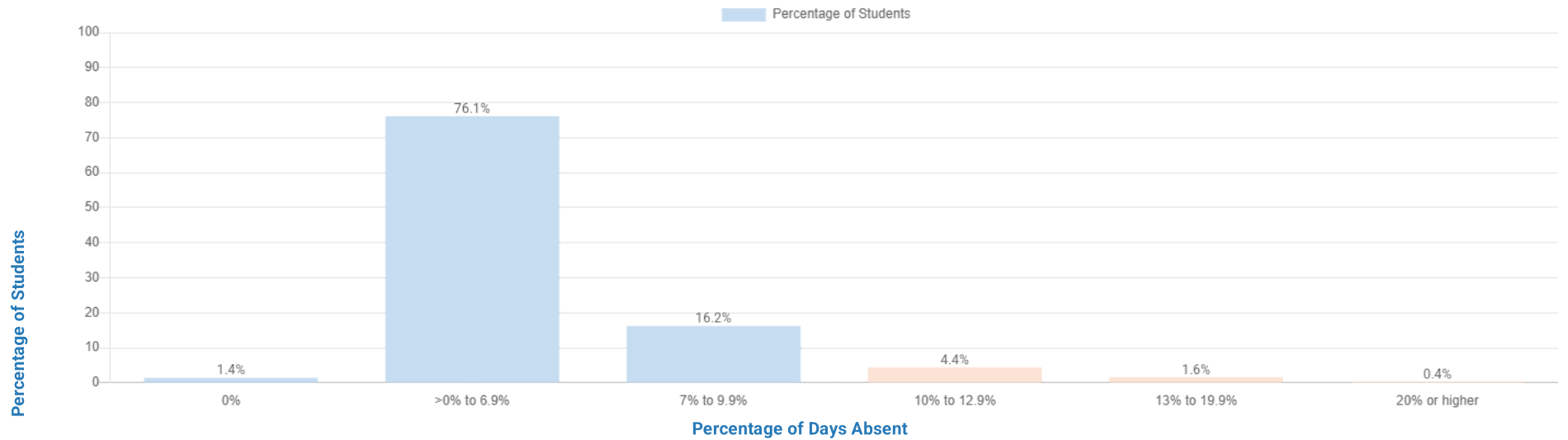

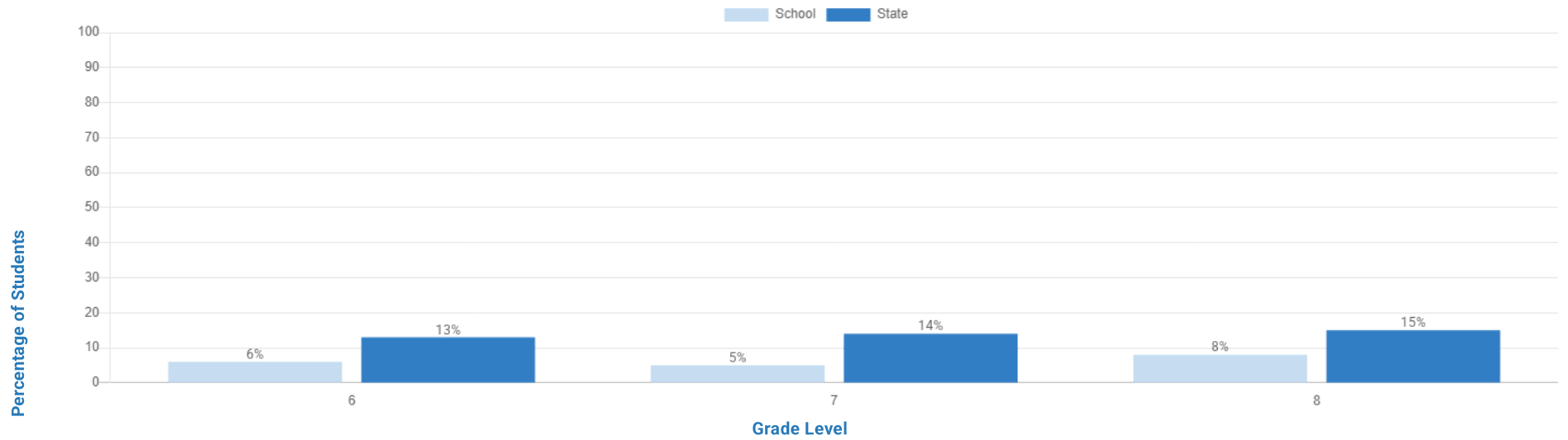

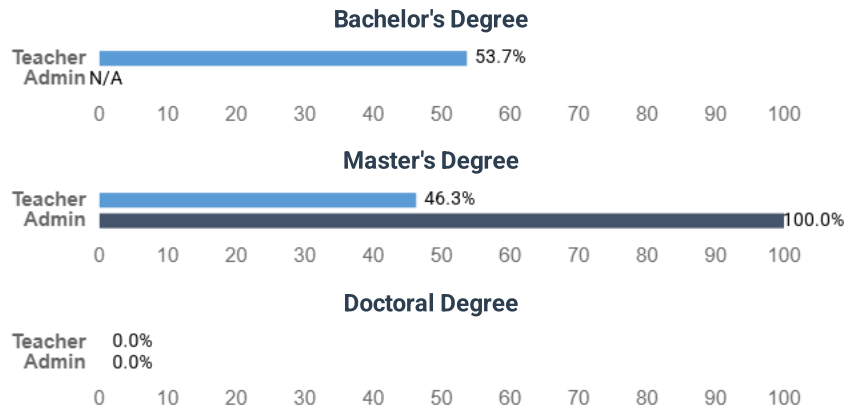

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

Students receive a well-rounded instructional program that is provided through core courses including language arts, math, science, social studies, and health and physical education. All students choose to study either French or Spanish for a full year in their 8th-grade year.



Clubs and Activities:

Students are provided with exciting & engaging extra-curricular learning opportunities through high-interest clubs including Intramural Sports, Yearbook Committee, Student Council, Select Band, and Select Chorus.



Student Supports and Services:

School counselors work closely with students to develop healthy perceptions of themselves, and to believe in their competence and their ability to learn; they are skilled in personal counseling and mental health perspectives. Multilingual learners in grades K-12 receive daily English as a Second Language instruction with a certified Teacher of ESL and district teachers are trained in Sheltered English Instruction. A Tiered System of Support identifies students experiencing difficulties in academic, behavioral, or emotional progress in the general education setting. Students may be referred by their teacher to collect and evaluate relevant data to determine or identify specific barriers to student performance. The committee creates interventions to address education these difficulties in the general education setting.

Every classroom in the district is outfitted with an interactive board or projection system and all teachers have the accessibility to a desktop and personal laptop. All students K-12 are one-to-one with laptops. Technology standards are written into curricula at each grade level providing students with a progressive experience as they learn and incorporate technology into their education. At the primary level, students have the opportunity to use iPads as an additional resource to redefine tasks that were not previously available. As students progress through their education, more intensive technologies such as 3D printers, poster printers, laser printers, robots, drones, filming, and recording devices are made available to enrich the student experience.
