









Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



We host college nights for students and parents. During senior year, we host a variety of workshops that helps us align student strengths and interests to postsecondary goals.



Student Supports and Services:

Kinnelon Public Schools has a Child Study Team comprised of Learning Disabilities Teacher-Consultant and School Psychologist in each of our four schools as well as a district Social Worker, a district Physical and Occupational Therapist. We offer programs on campus for students with Autism Spectrum Disorder, and Multiple Disabilities so that our exceptional students can remain in the district and interact with their same age peers. We have an English Language Learners (ELL) program, Title I Supplemental Instruction programs before/after school, Speech and Language services, Basic Skills Instruction, Social Skills groups, School Counselors and CarePlus NJ Therapeutic Services. We also offer a gifted program for students in K-5 and advanced coursework in grades 6-8. We offer honors, Advanced Placement and other advanced coursework for college credit from Rutgers University and Syracuse University.

At Kinnelon High School, we offer all Advanced Placement Science courses (Biology, Chemistry, Environmental Science, Physics 1 and 2, and Physics C), Advanced Placement Computer Science A and Computer Science Principles, Computer Science 1 and 2, Science Research Course Sequence (Intro to Research Methods I, Intermediate Research Honors, and Advanced Research Methods Honors). We offer Aviation and Aerospace, Introduction to Flight & Aircraft Systems, a Student Technology Association, CAD, Robotics, Barcode of Life, Waksman Student Scholars Program (WSSP), Digital Imaging, Computer Art, Introduction to CGI Animation, various levels of Digital Communications, Science, Technology and Society, Forensics Science, Anatomy & Physiology, Dynamics of Health Care, and Sports Medicine.
