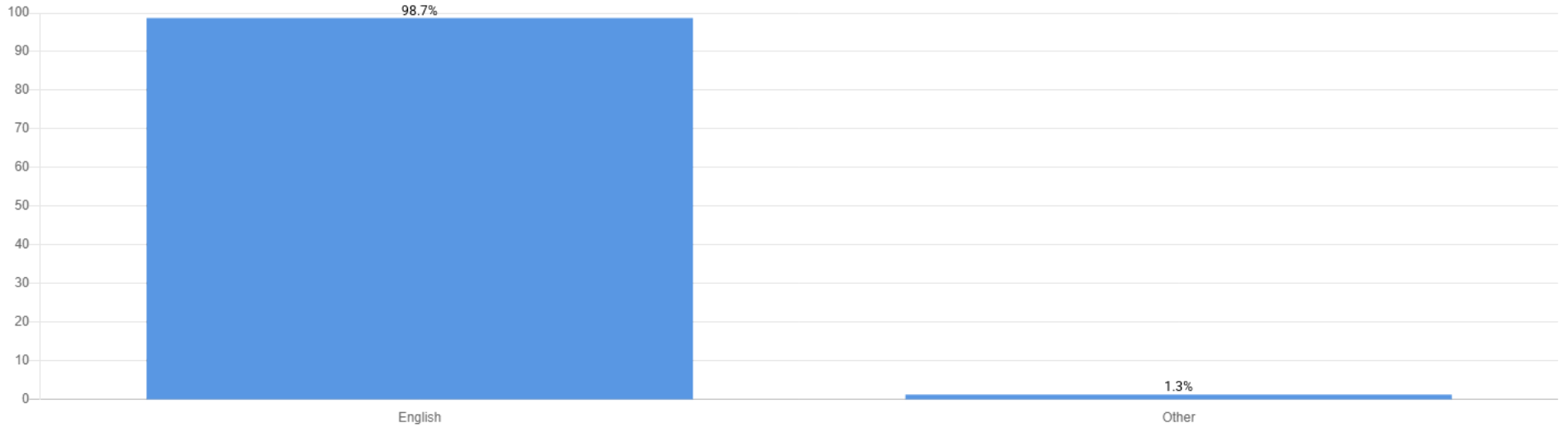

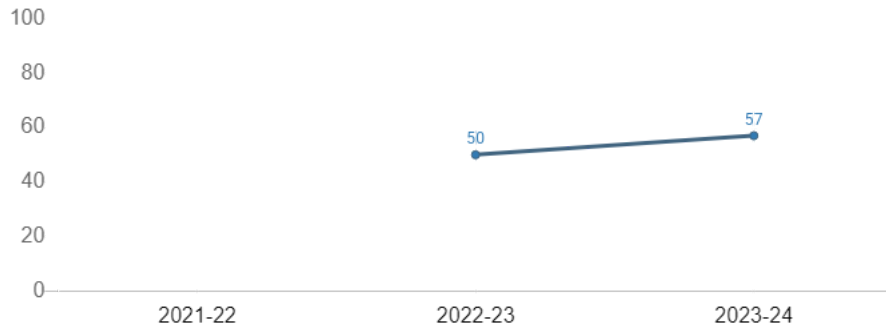

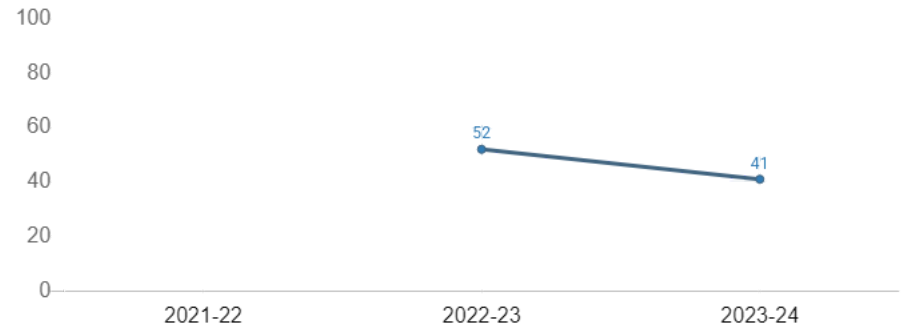

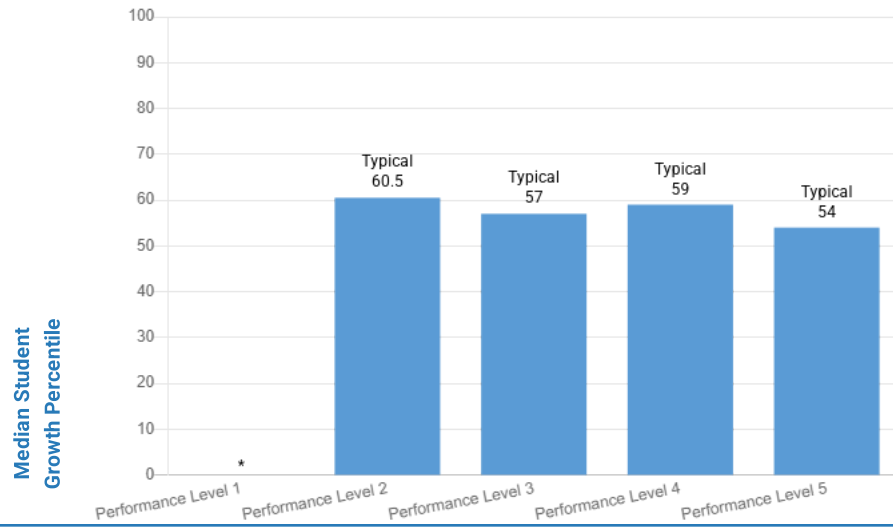

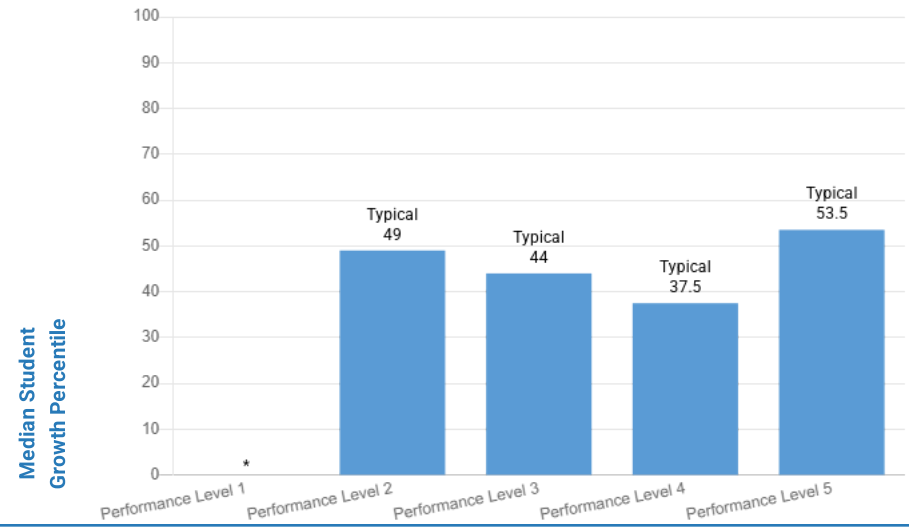

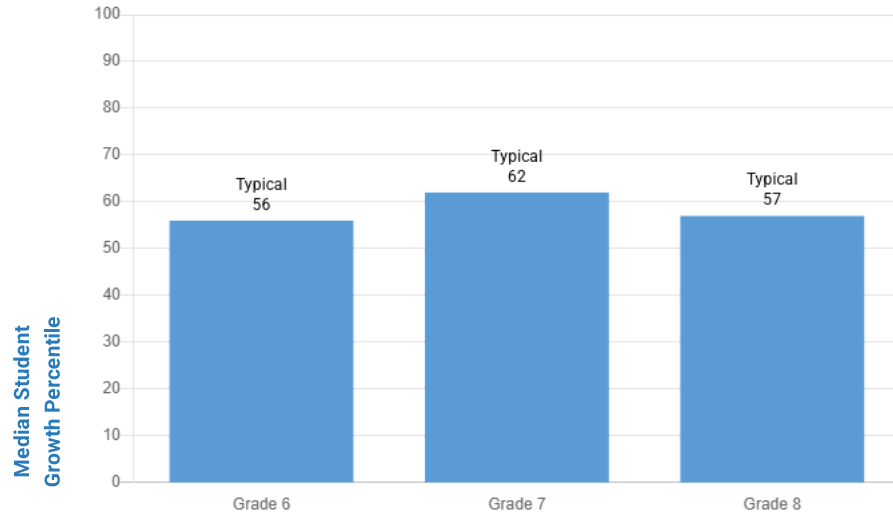

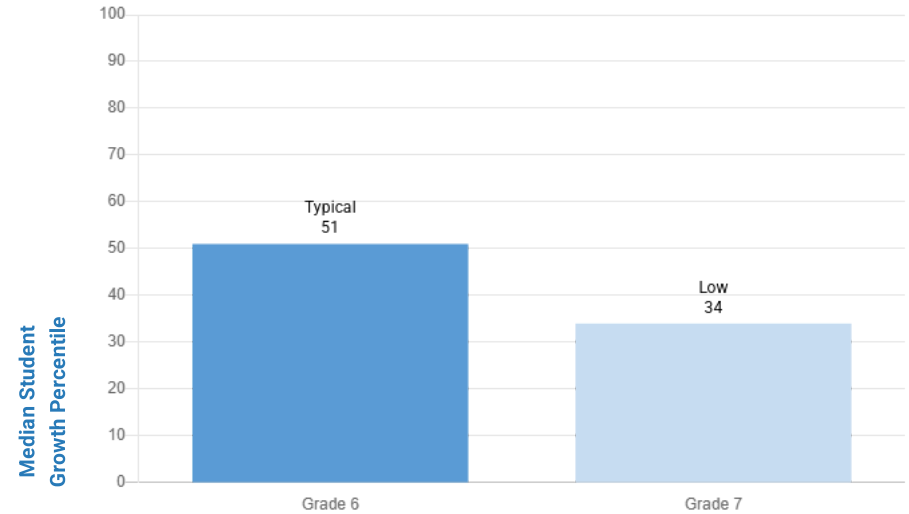

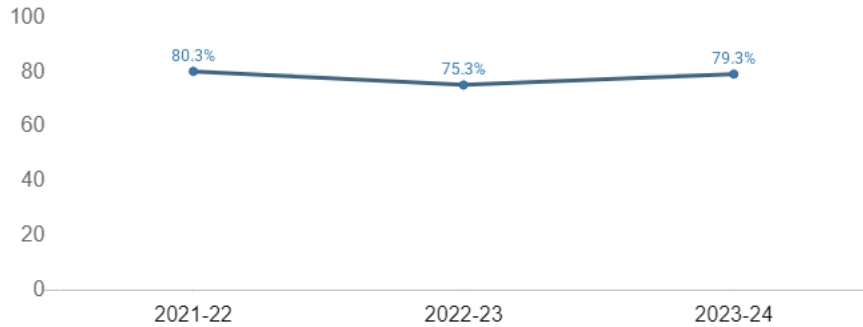

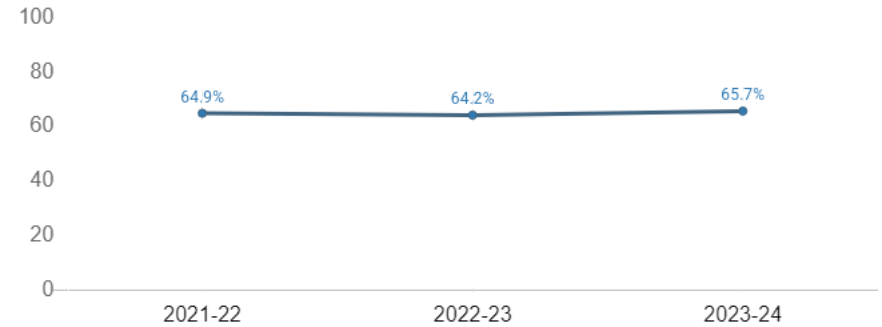
English Language Arts and Mathematics Performance Trends

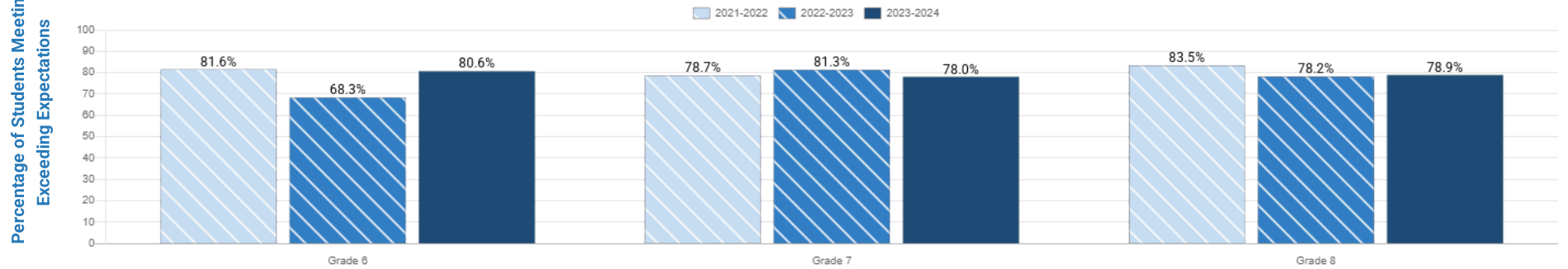

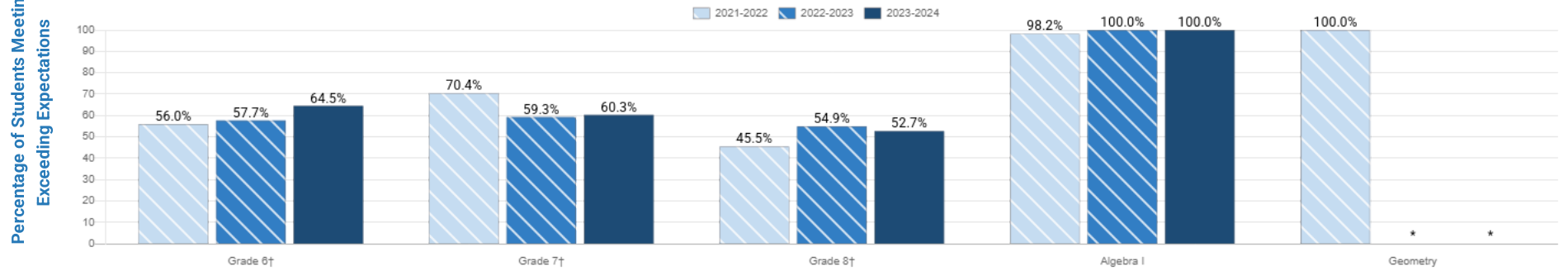

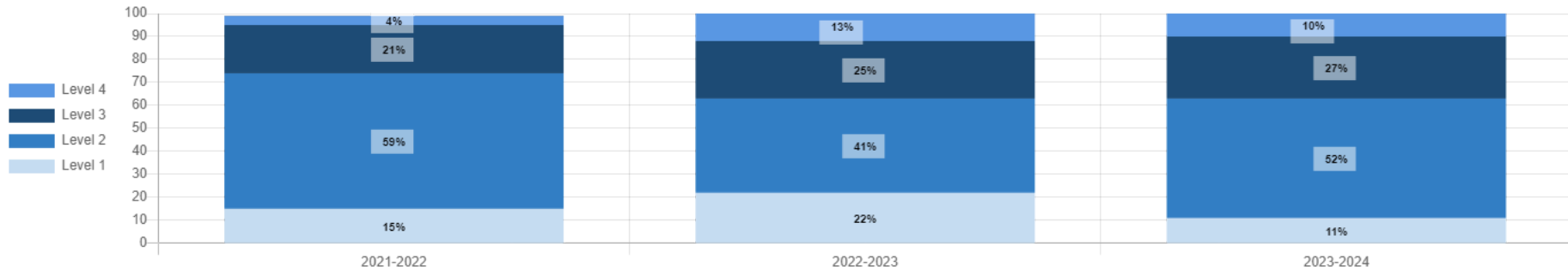

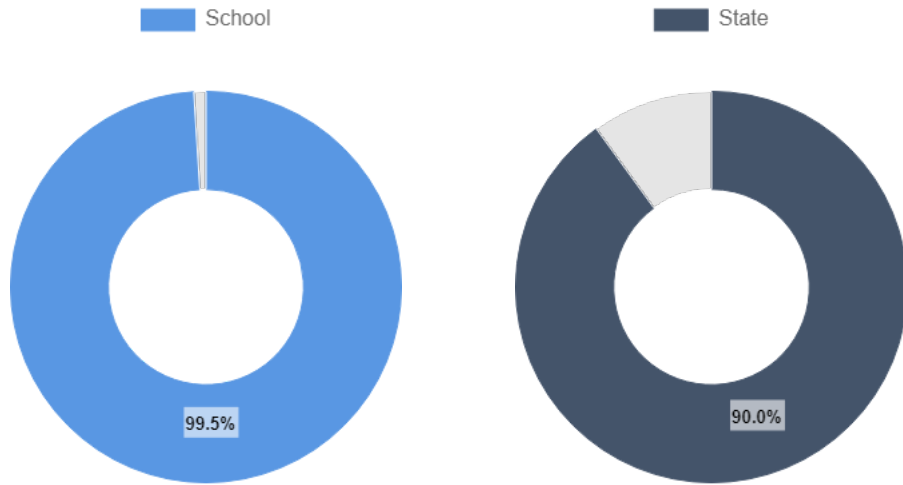

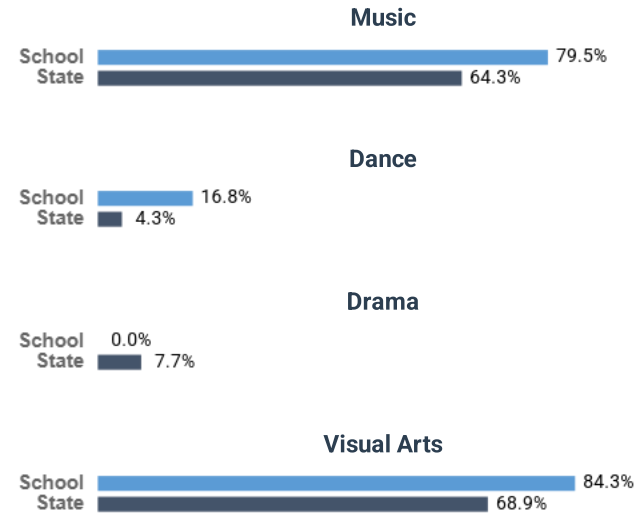

Students enrolled in one or more classes by discipline:



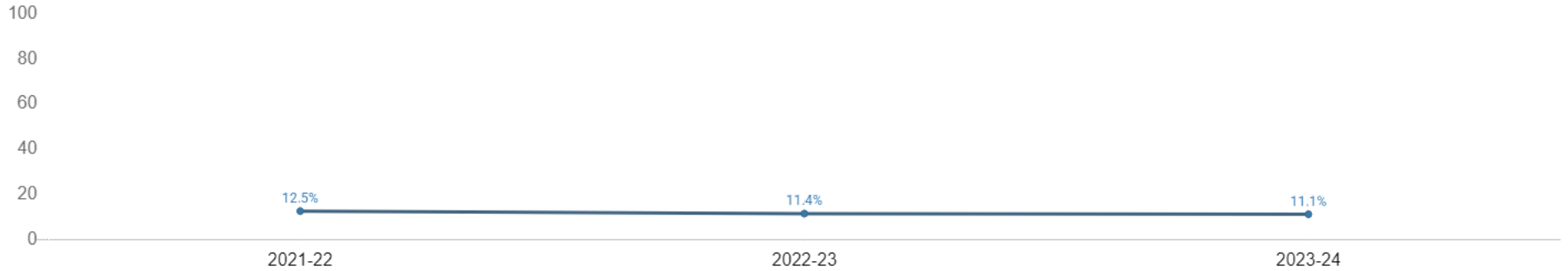

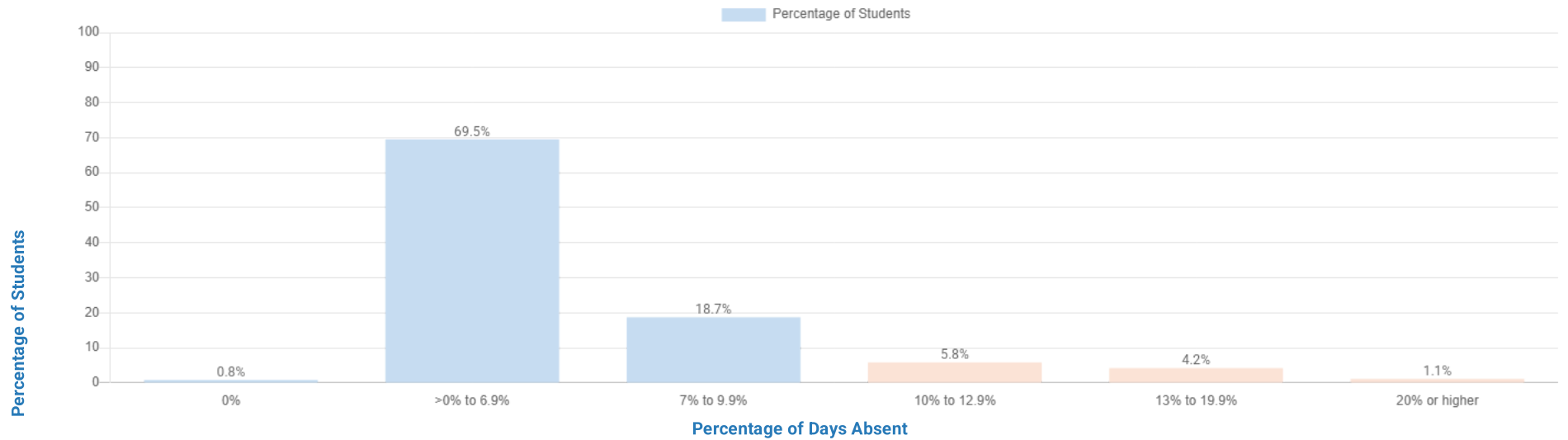

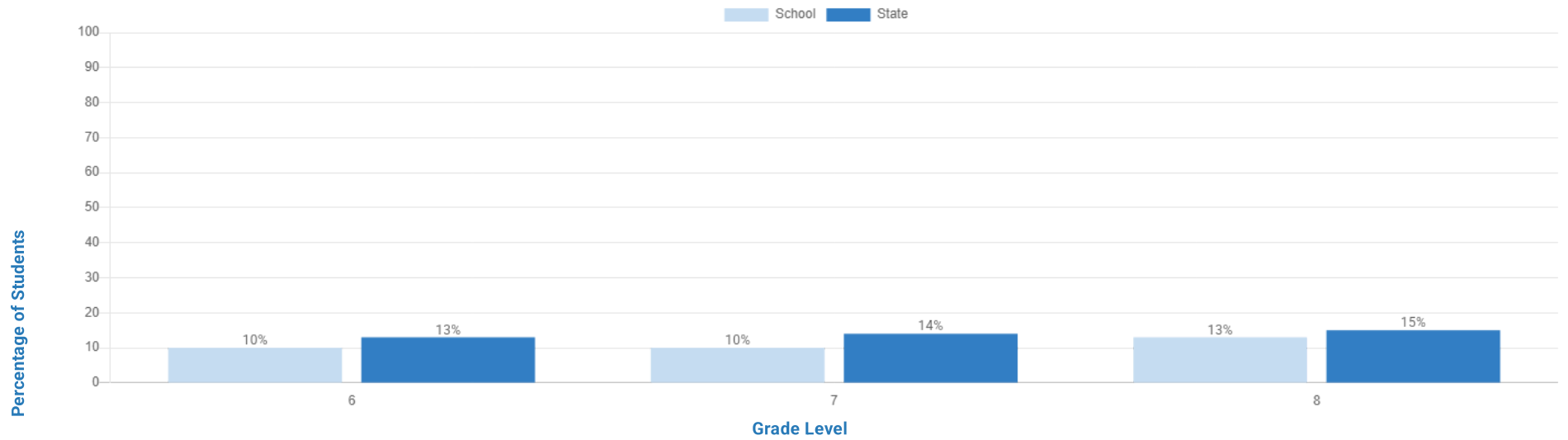

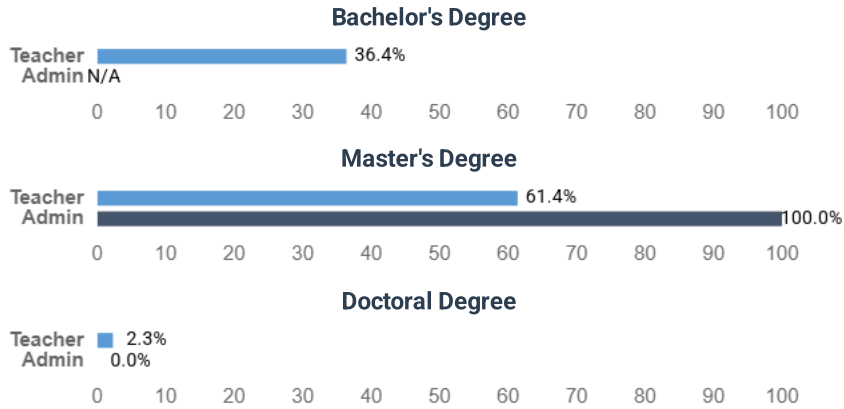

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Technology and STEM:

At Pearl R. Miller Middle School we offer science programming using IQWST (Investigating and Questioning our World through Science and Technology). We provide a Robotics Cycle Program in grades 6, 7, and 8 and computer programming cycle classes in grades 7 and 8. PRM also has a competitive Robotics Club. We have interactive whiteboards in each classroom and document cameras available to all staff. Additionally, all students are provided with chromebooks by our district.



Attendance:

Academically, we offered support for additional instruction in basic skills in both math and language arts in a summer program, as well as in an after-school program during the school year. This is in addition to the support offered through our Guided Study Program (GSP), which takes place during the school day and also offers instruction in basic skills in these subject areas. In the area of mental health, we have one full-time counselor and two part-time counselors, as well as a clinician from CarePlus, to address students' needs. This helps us to support students academically, socially, and emotionally, and to help them get the most out of their school experience.
