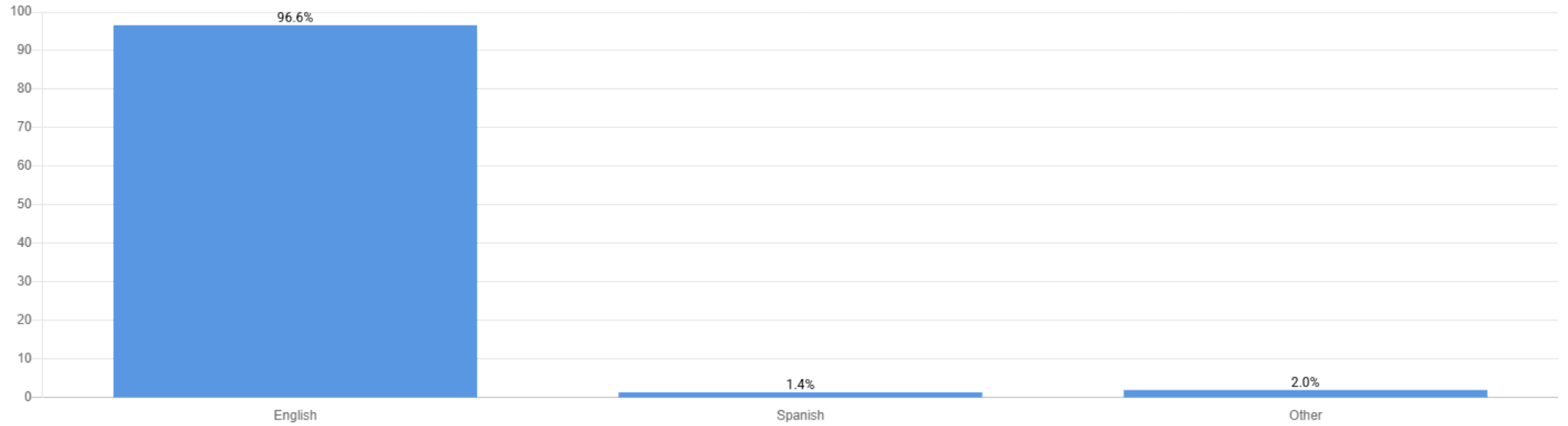

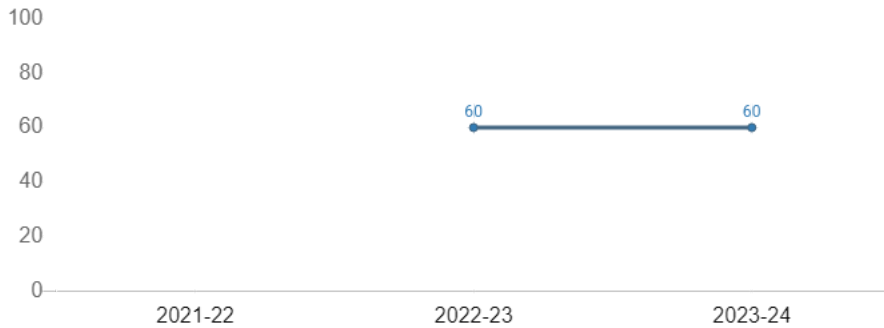

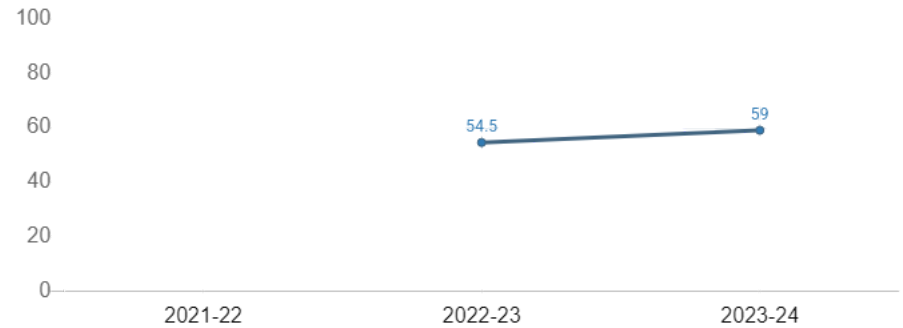

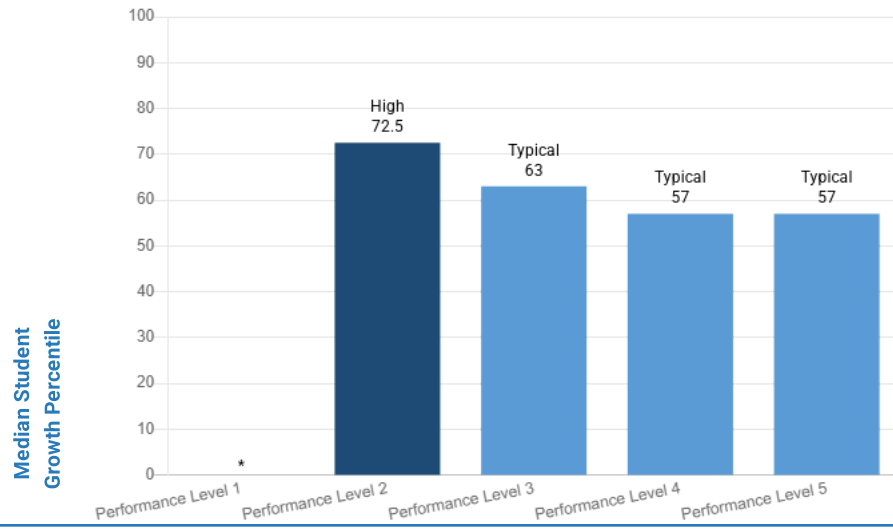

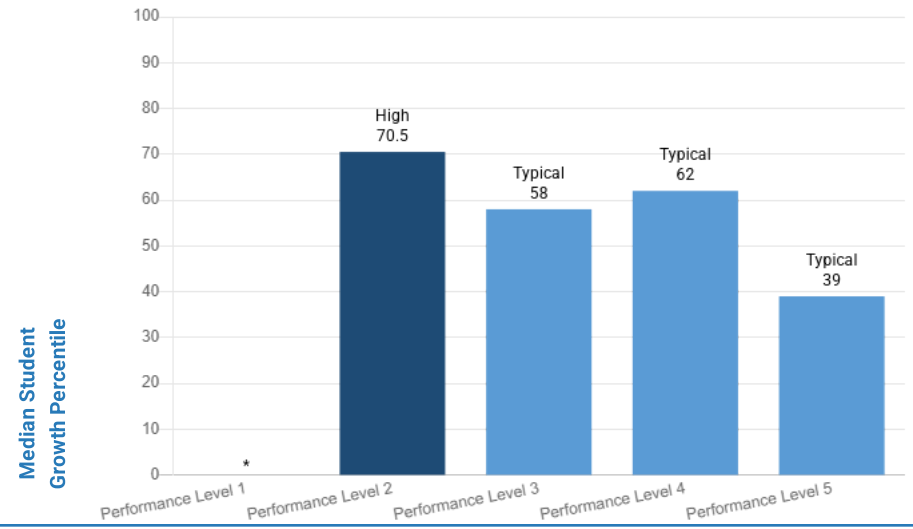

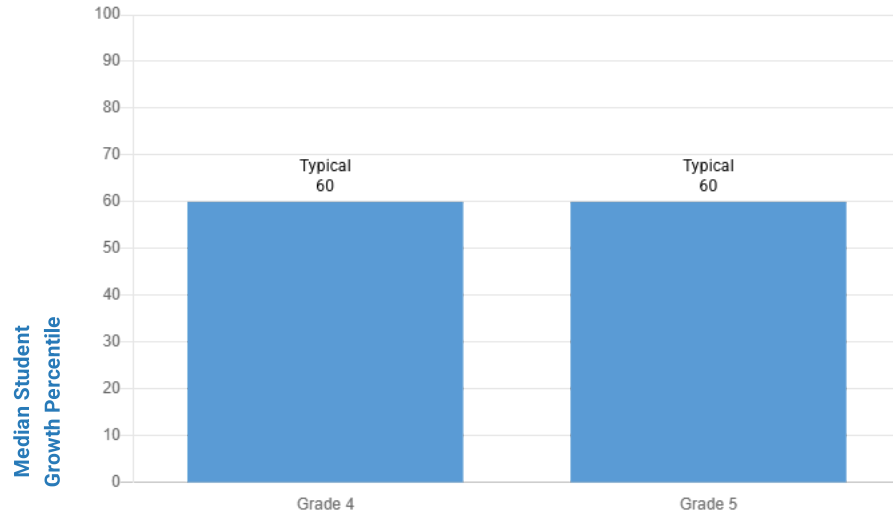

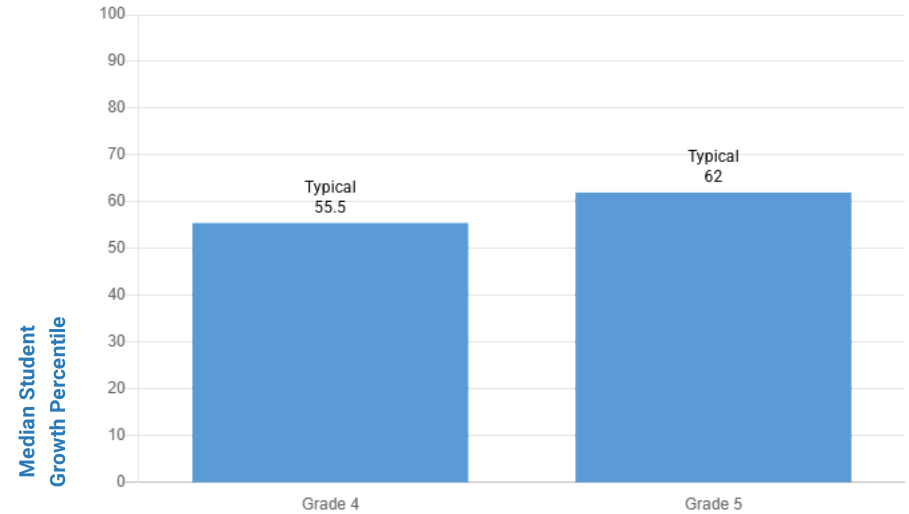

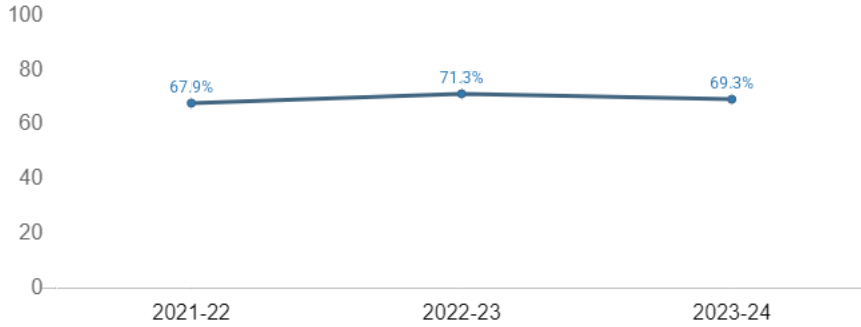

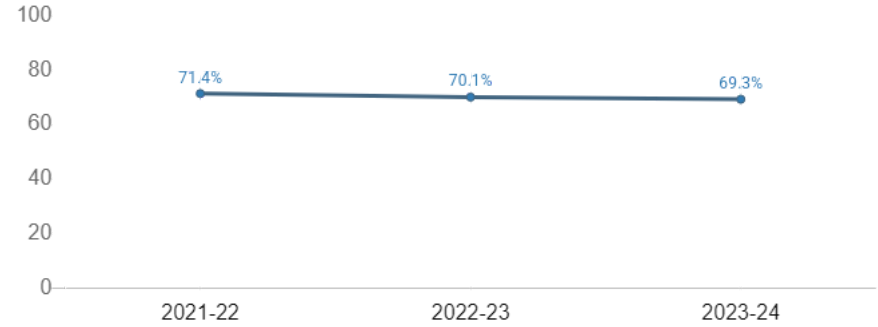
English Language Arts and Mathematics Performance Trends

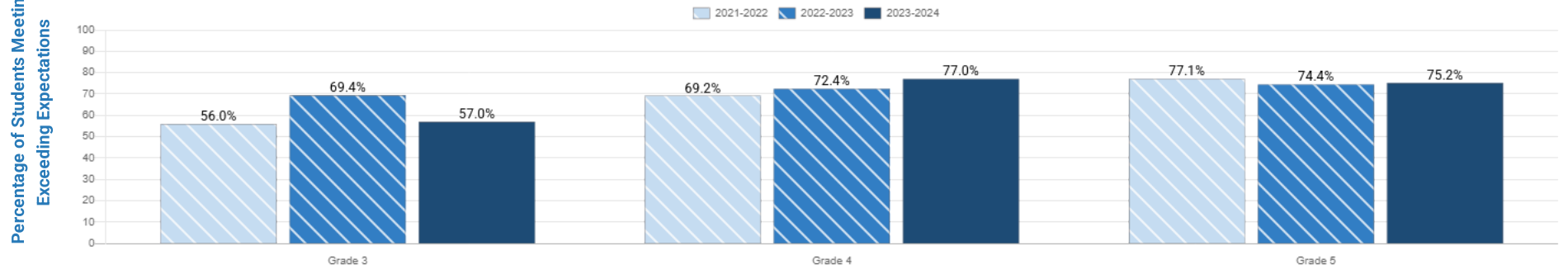

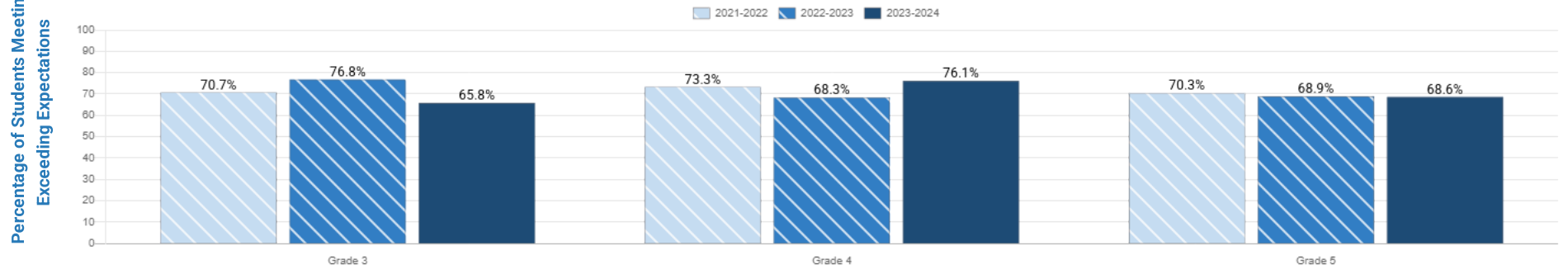

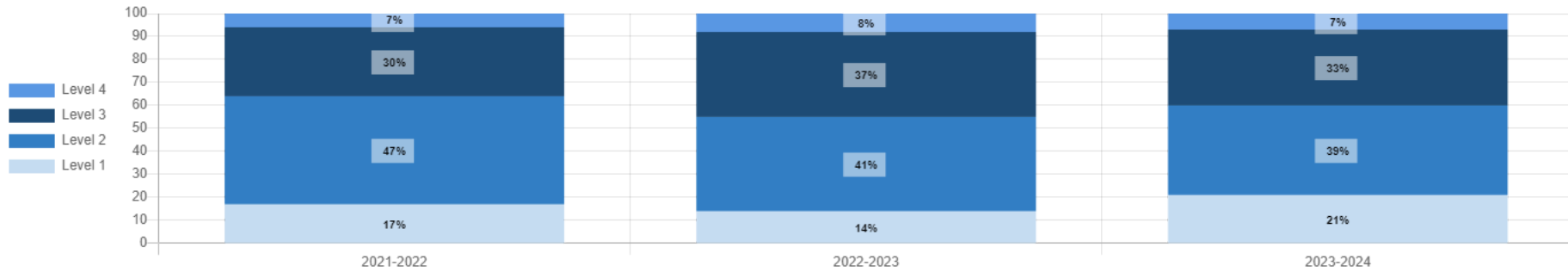

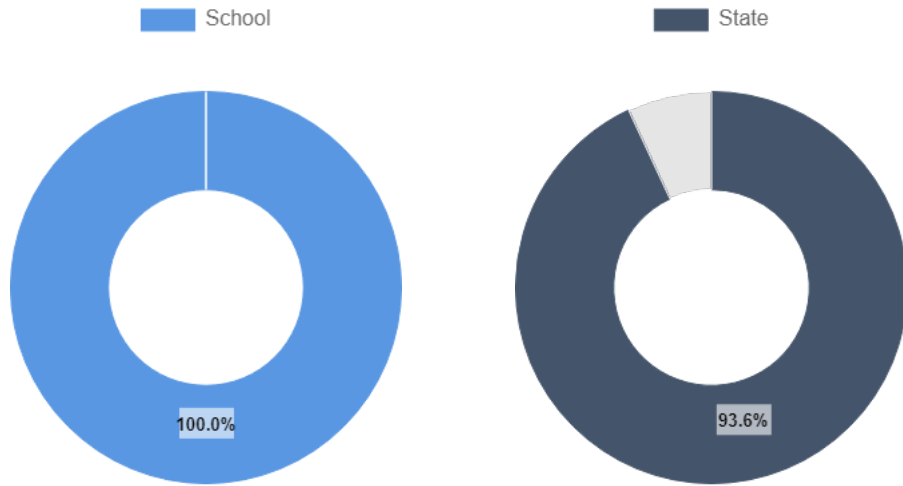

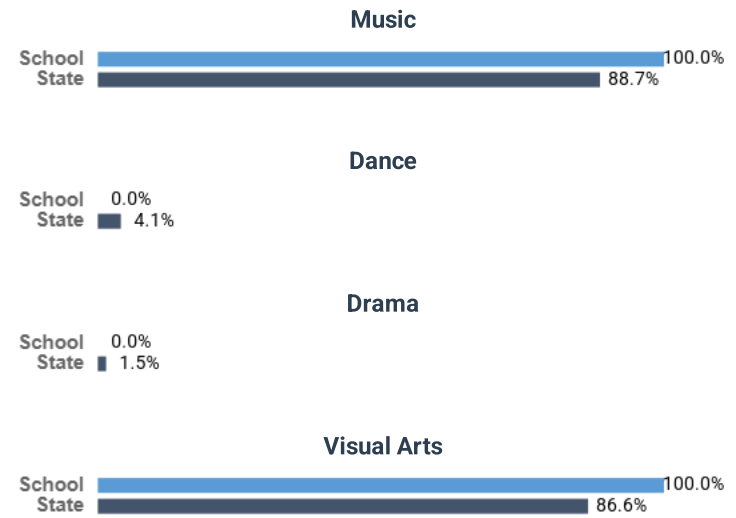

Students enrolled in one or more classes by discipline:



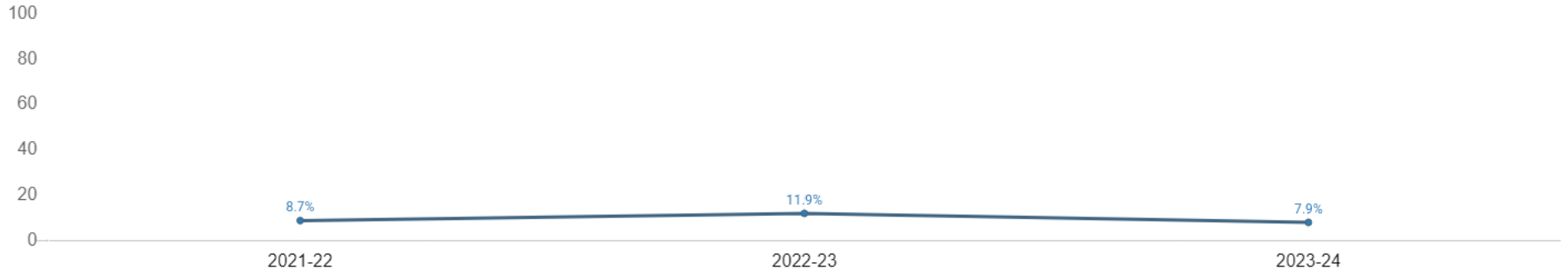

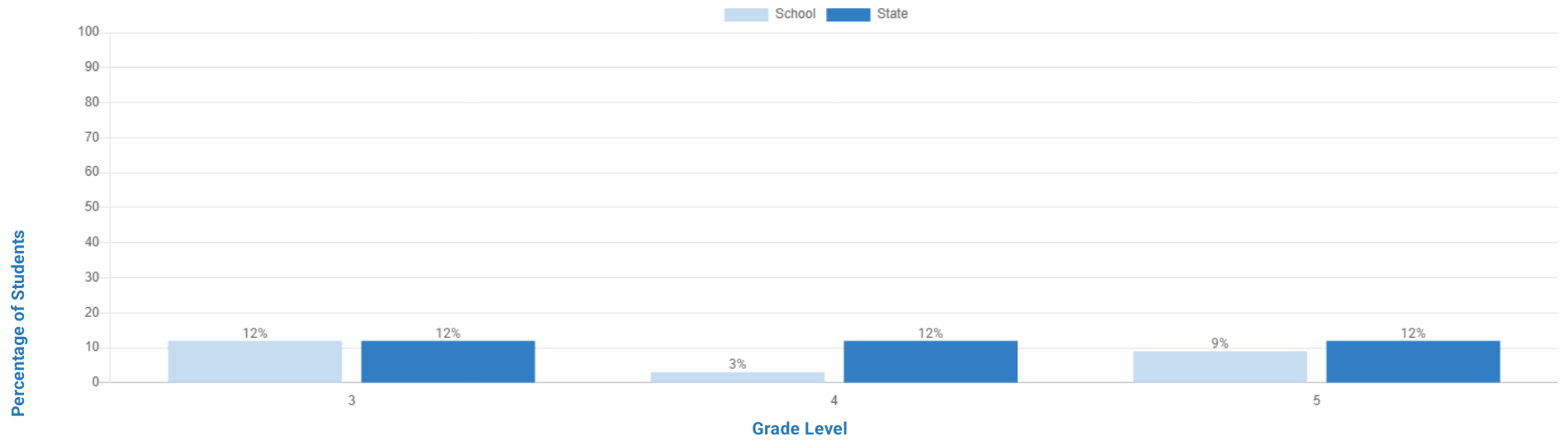

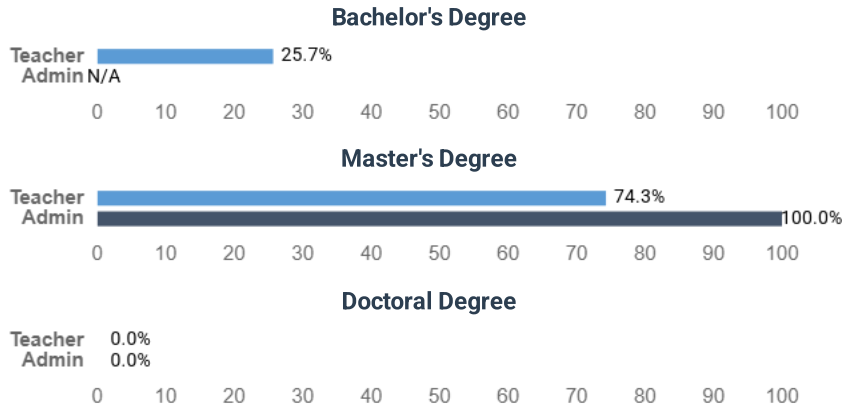

Across the district our staff is engaged in professional learning through a partnership with the Stronge Evaluation Model. Our teachers in grades K-5 and ELA teachers in 6-8 are working with our Curriculum Director, ELA and Math Chairperson, and professional staff developers through HMM at the K-5 level. Our Math teachers at the K-5 level work with our K-5 Math Chairperson to update our teachers in the areas of IXL Takeoff Program, and Science curriculum.
