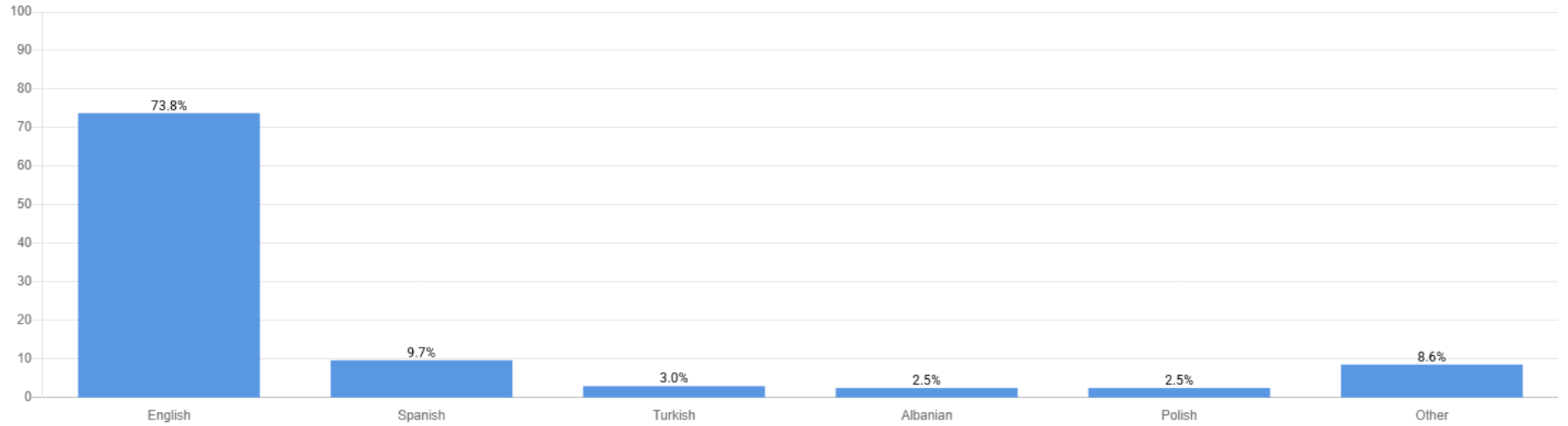

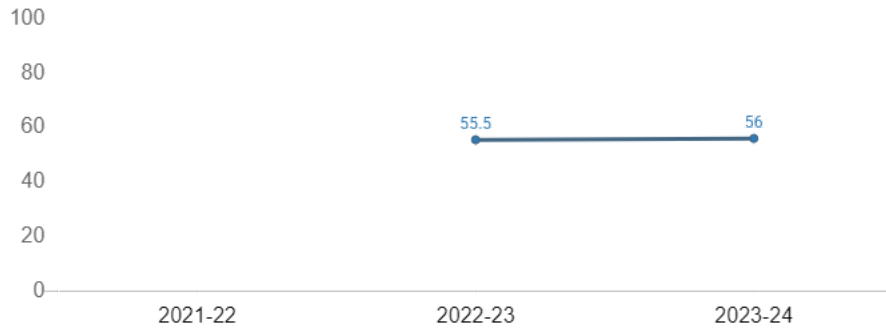

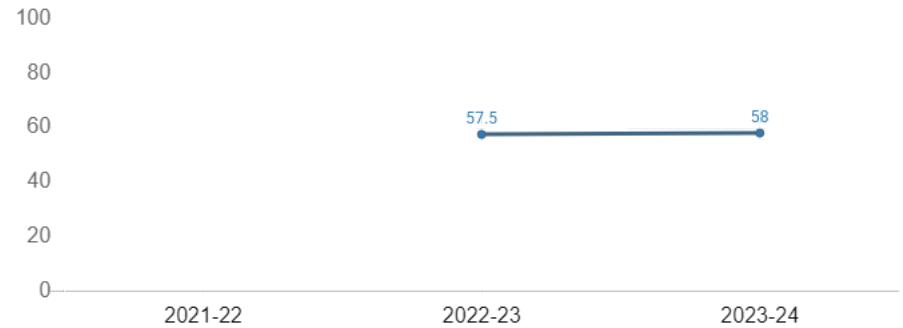

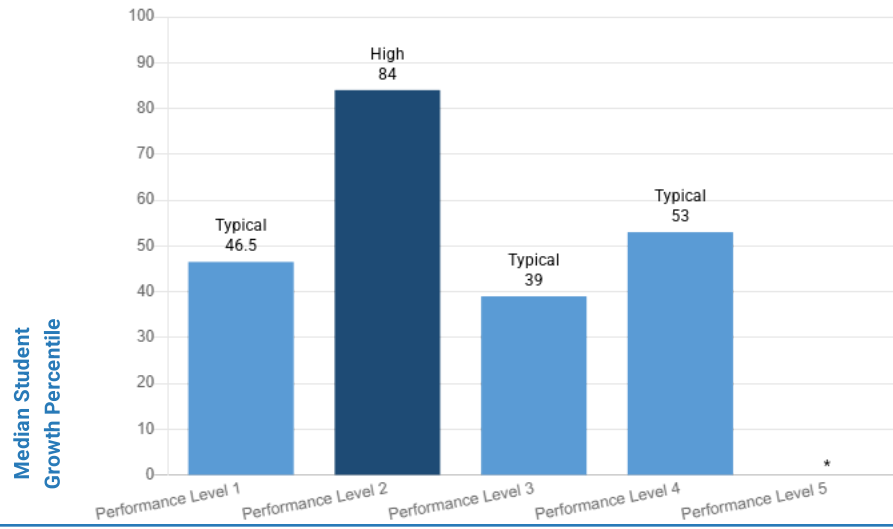

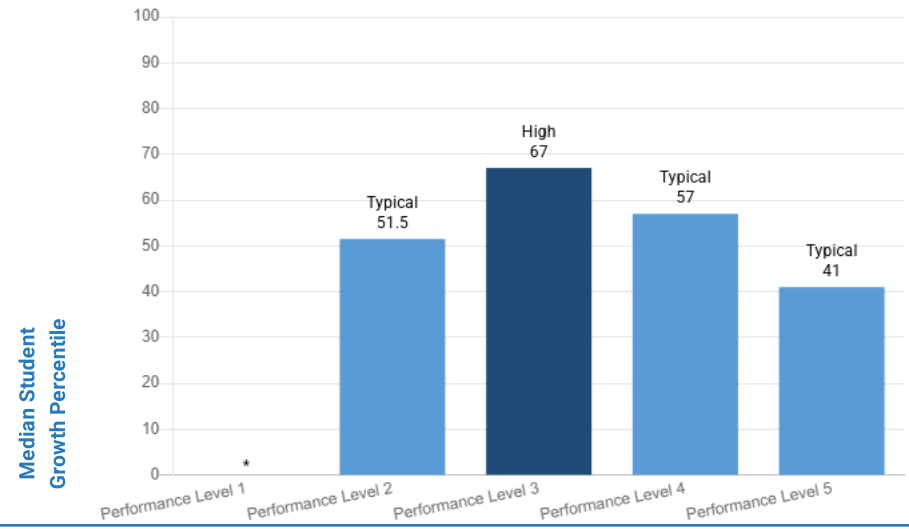

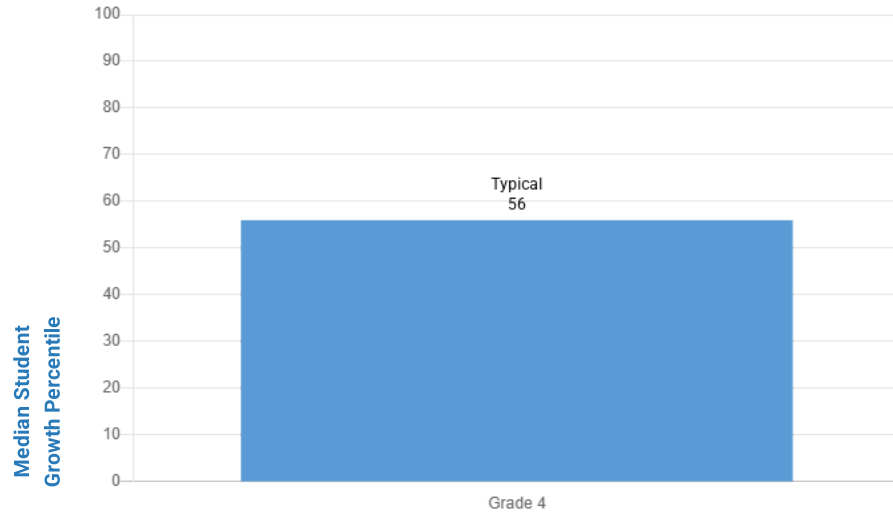

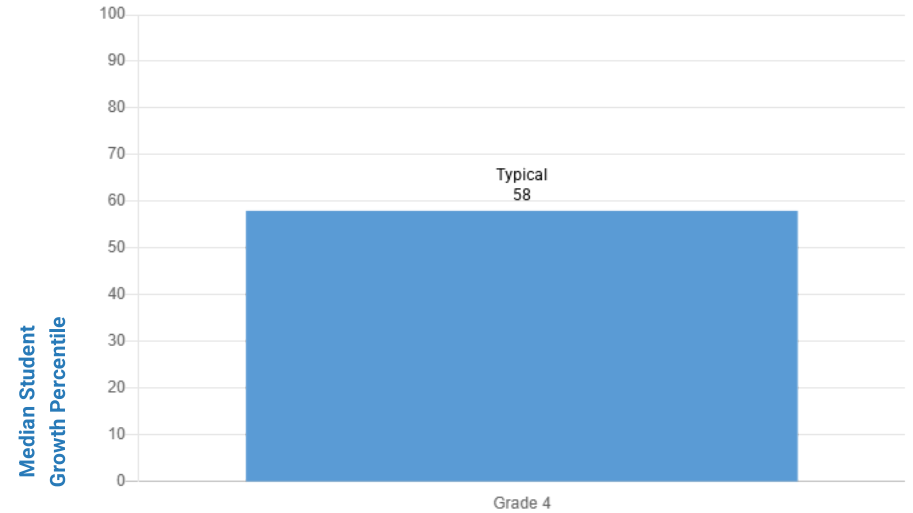

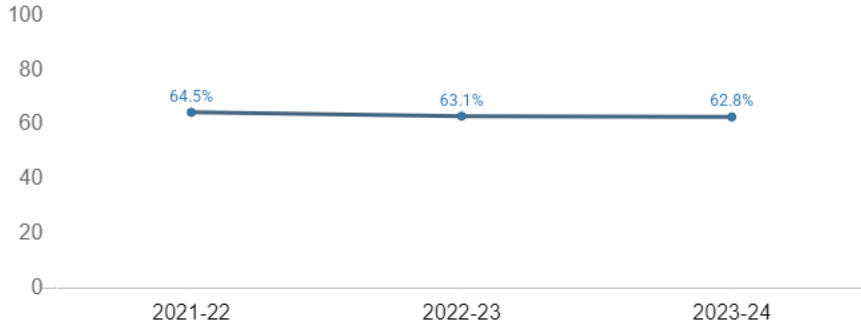

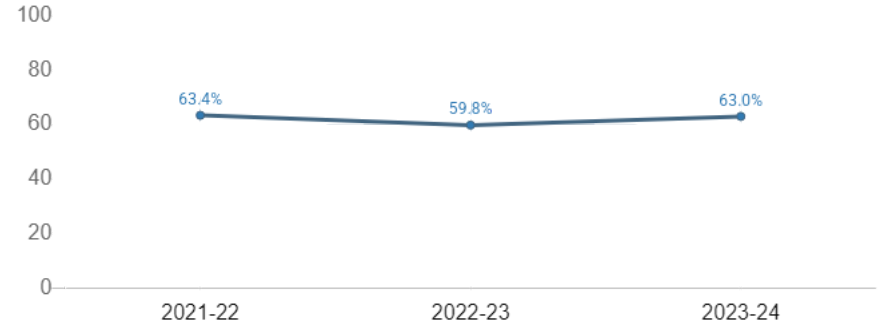
English Language Arts and Mathematics Performance Trends

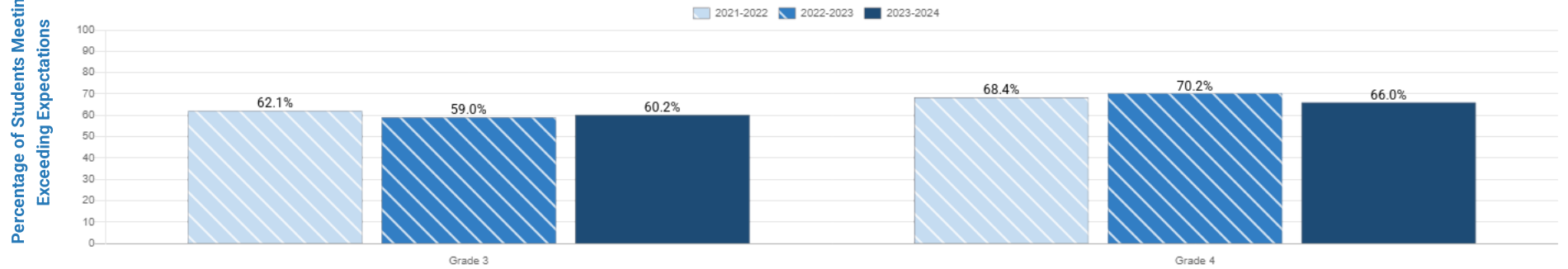

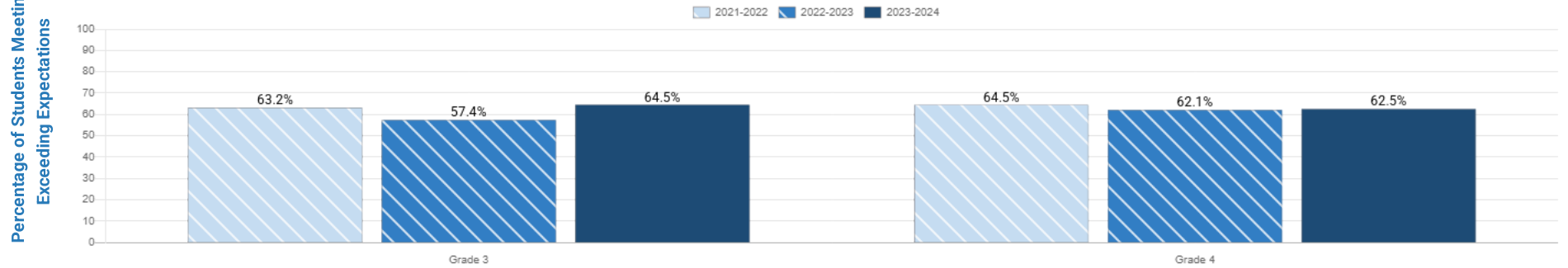

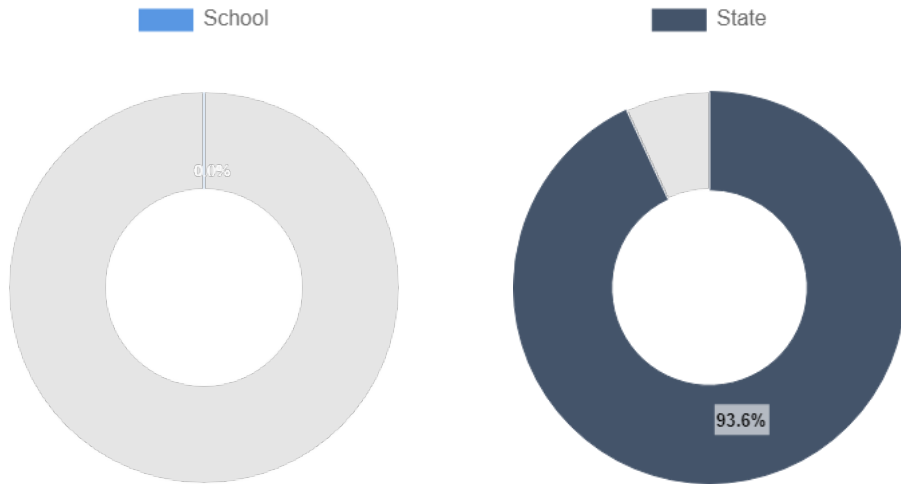

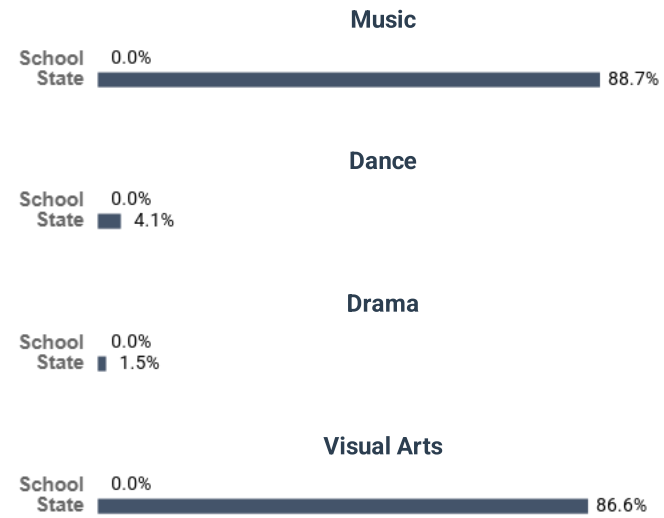

Students enrolled in one or more classes by discipline:



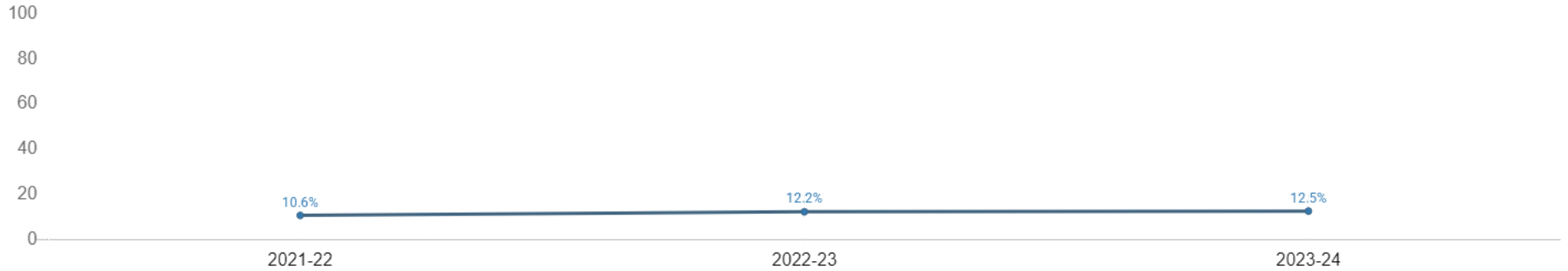

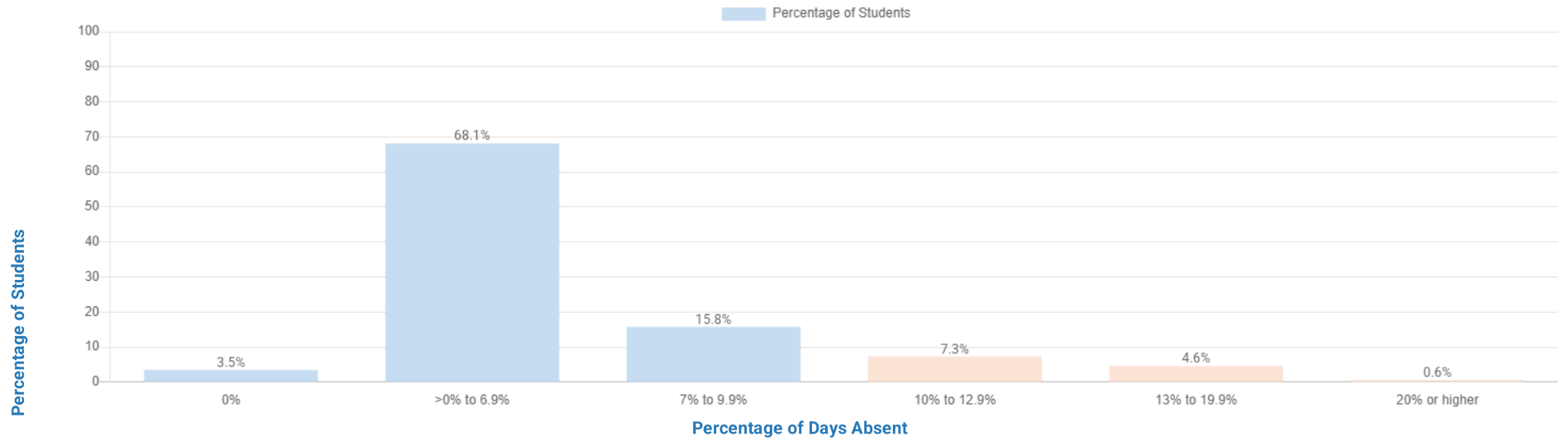

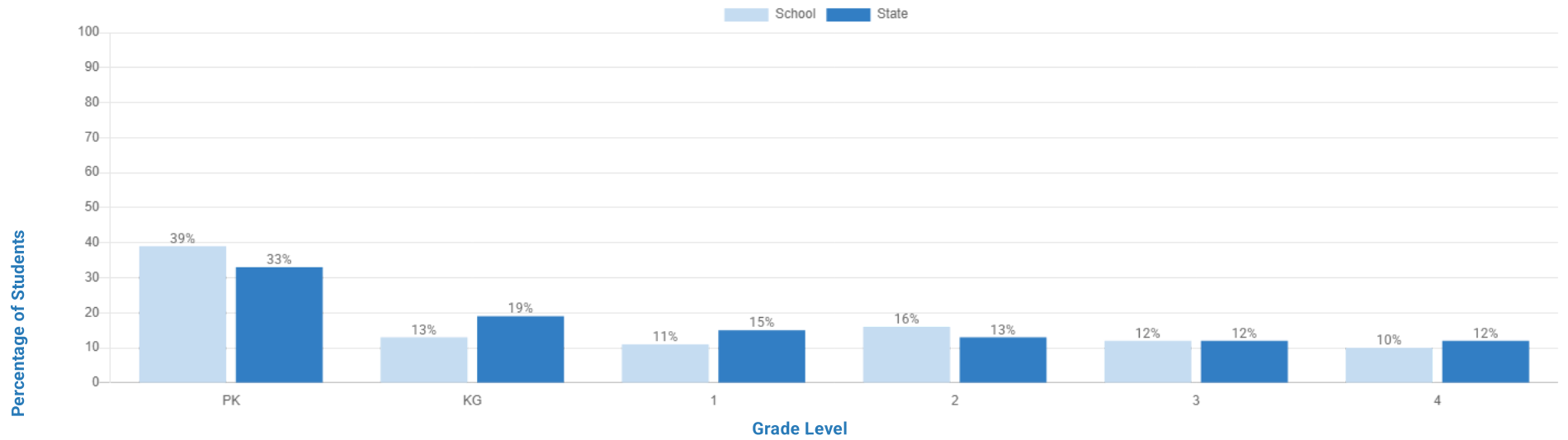

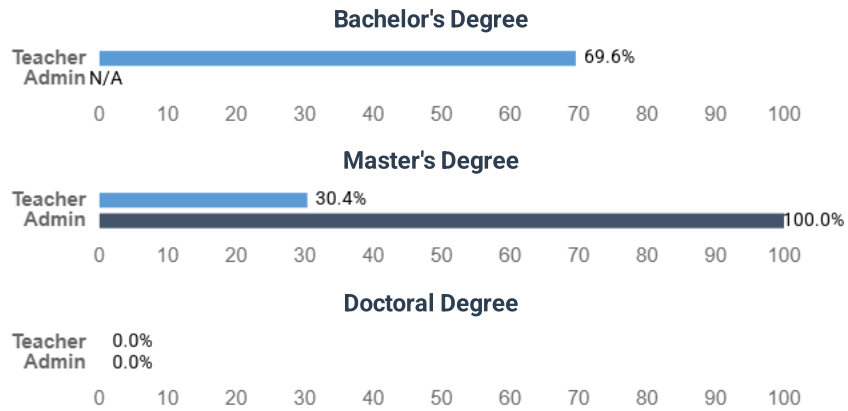

Accountability Summary by Student Group - 2023-24 School Year

- Our school counselor conducts frequent classroom lessons on various character ed. topics, in concert with our character education classes that are built into the schedule of each elementary teacher.



The mission of the Lincoln Park Elementary School is to inspire and empower its children with opportunities that positively shape their lives and help them to become successful, life-long learners who possess the critical thinking, academic, and leadership skills required for the 21st Century.



LPES was proud to receive a grant from the NJHCN, New Jersey Healthy Communities Network, in concert with Atlantic Health Systems and Chilton Hospital for a "climbing wall." The climbing wall has been installed in our gymnasium for a few years now. Our climbing wall is accessible for our kindergarten through fourth graders throughout the school day. We also conducted a climate survey with NJ SCI for parents, staff, and students in grades three and four. Valuable information was received and ideas have been implemented to maintain and improve our school climate for all stakeholders.

Through the Boys and Girls Club of Pequannock, a program is offered to parents for before school care and after school care for a cost.



Staff and Professional Learning:

The school calendar has four full days for in-house staff development. These days provide the staff with professional development opportunities to improve their classroom instruction. Besides these full-day programs, the staff is encouraged to participate in workshops and seminars throughout the county and state. We also collaborate with other local school districts with regard to professional development programs. PLCs meet monthly so that staff can analyze data, work on departmental subjects, and engage in vertical articulation.

The district also financially supports staff members pursuing master's degrees in the educational field. Some staff choose to learn beyond their masters and these efforts are supported as well.

Student Supports and Services:

Our school counselor is available to provide academic and emotional support to our students. In addition to group sessions and individual, short-term sessions; the counselor provides character education lessons to students in their classrooms. Our ESL teacher provides language arts replacement for those who need assistance with learning the English language. We also have basic skills instruction in reading and math, and a program for our gifted students. Children with special needs are served through specialized IEP-driven programs. The schedule has been adjusted to allow for a grade-level intervention period to provide targeted support for all children. Intervention specialists are available for Tier 2 and Tier 3 support, as needed.



Student Health and Wellness:

The school nurse and a select number of students serve on a committee that meets yearly with our food service provider (Pomptonian) to provide input to help improve school lunch offerings. She also works with the middle school nurse and borough health department to ensure that students are up-to-date with vaccinations, health plans are current, and all health office procedures are followed.



Parent and Community Involvement:

The PTO provides various academic and fun activities for the students and materials for the teachers. Teachers can submit grant requests at the end of each year for materials to benefit their classrooms/students. Through one of these grants, the principal and guidance counselor were able to secure a Buddy Bench for the students to use during recess. The Municipal Alliance and Recreation Department provide many activities for our students and their parents. Additionally, members of the Lincoln Park Police Department visit our school frequently, in addition to teaching LEAD to our second and fourth graders.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The District worked with NJ SCI to conduct a climate survey for parents, staff, and students. Data showed that both students and staff enjoyed coming to school/work and there was a feeling of safety amongst both staff and students. Parents responded favorably to their experiences with teachers, administrators, and other school staff members. The survey results continue to steer the direction of the Safety/Climate Team, so that we can continue to foster an environment of academic achievement, inclusivity, and fun.



Facilities:

Our school facility is kept in excellent working order by our custodial staff. In addition to well-sized and well-lit classrooms, we also have a large art room with a multitude of supplies for student projects, a library/media center, a spacious gymnasium, and a separate lunch room with kitchen.



School Safety:

School safety and security are always a top priority at Lincoln Park Elementary School. We continue to work closely with the Lincoln Park Police Department and our district Safety Specialist to upgrade our procedures and security measures that are already in place. The safety of our students and staff are paramount, and we continue to look for ways to improve the security of the building. Once checked in via our Verkada system, visitors to our school only gain access after being buzzed in from our security vestibule. The building is also monitored by numerous cameras located both inside and outside the building.

For our preschool and kindergarten students, access to individual iPads is something of which we are proud.

Our behaviorist has increased hours and provides guidance for teachers in dealing with student behaviors that have increased over the years.

Each month, students from each grade level who exhibit a particular character trait are recognized as our 'Students of the Month.' The staff and student Safety/Climate Team works hard to help improve the climate/culture of our school. LPES is divided into five 'houses' to which all students belong: Mammals, Arthropods, Birds, Fish and Reptiles. Student earn 'House points' for various activities throughout the year. The friendly competition encourages kindness and positive behavior among all students. Data such as test scores, DIBLES and iReady diagnostic testing, report cards, formal and informal assessments, attendance records, and teacher feedback is continually analyzed to determine future directions for our school.
