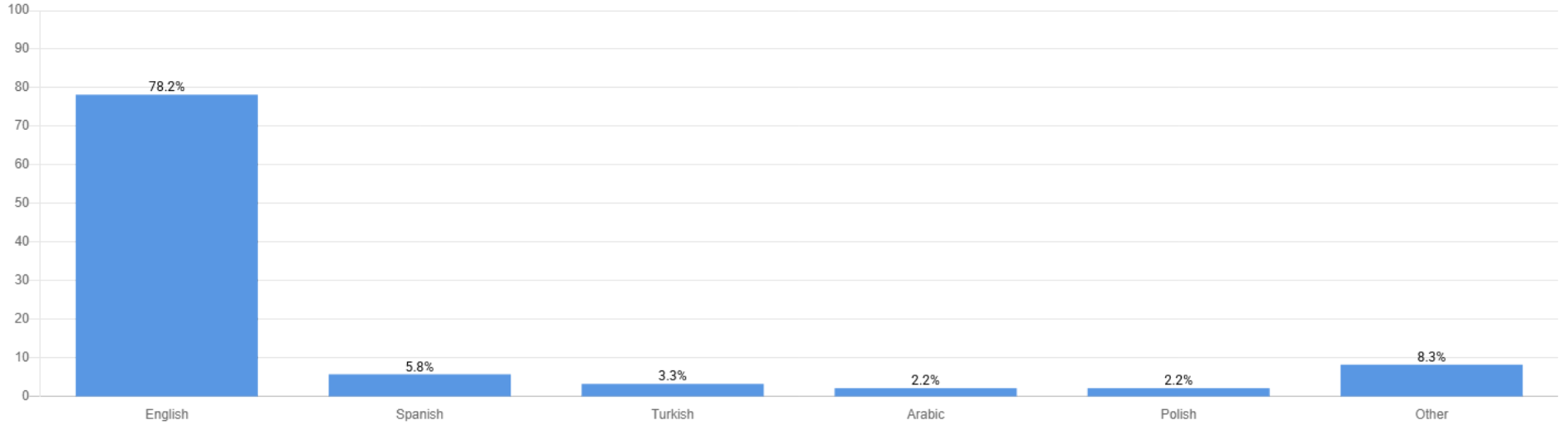

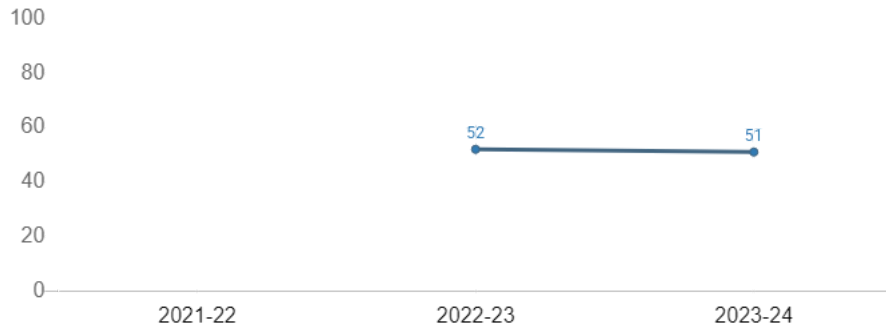

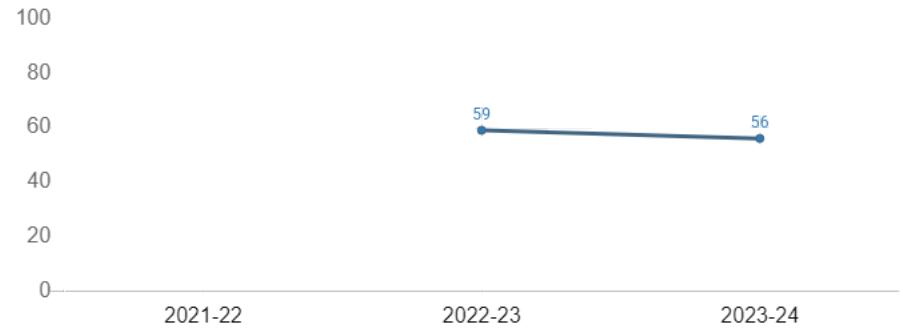

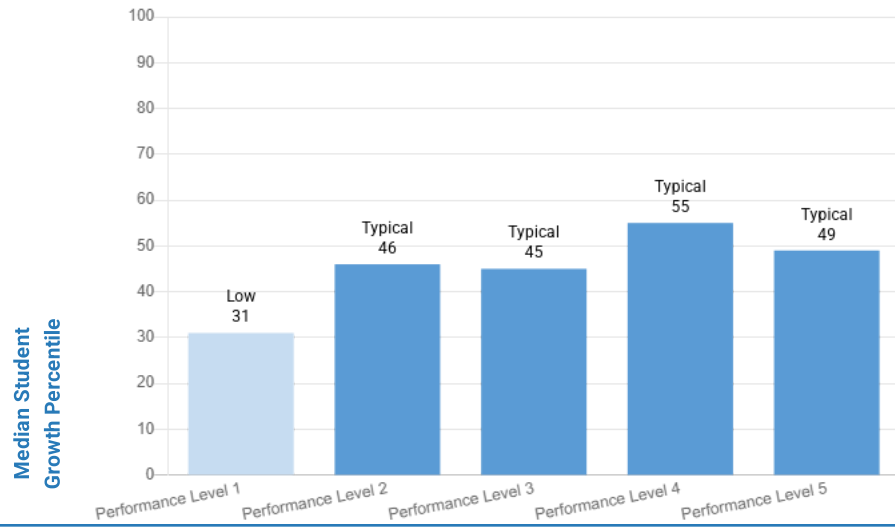

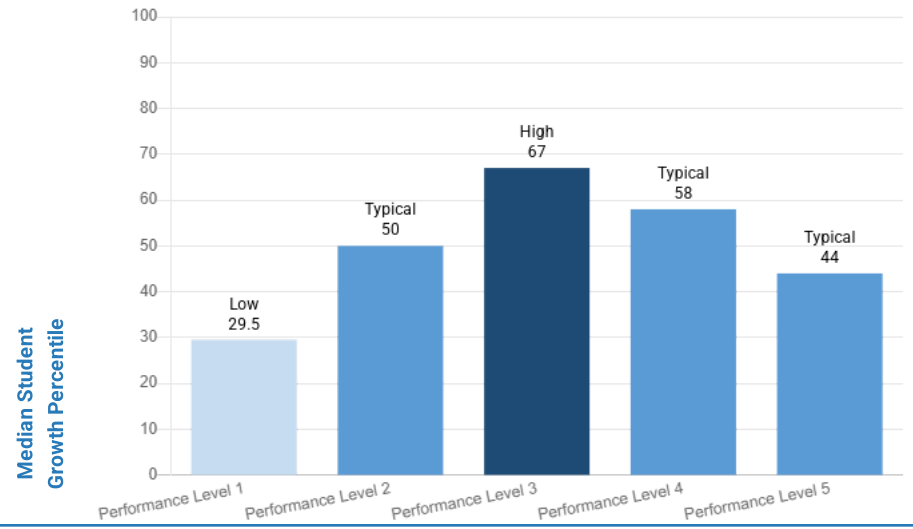

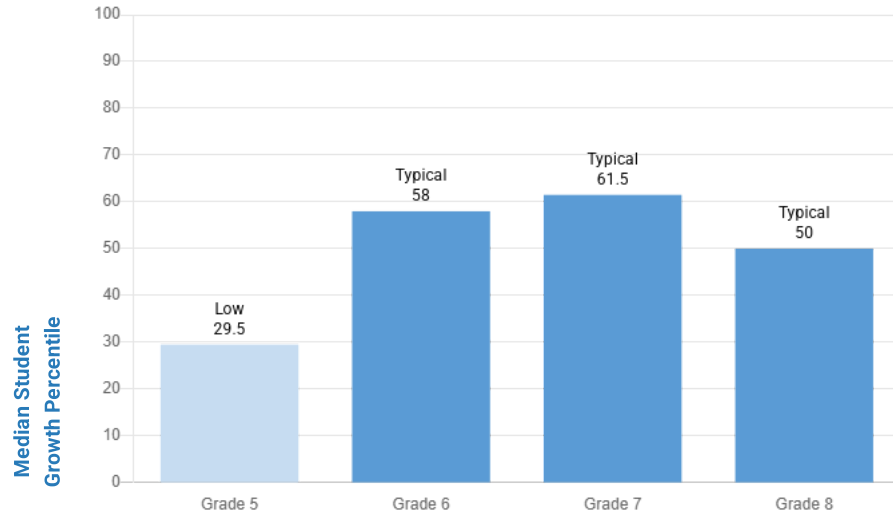

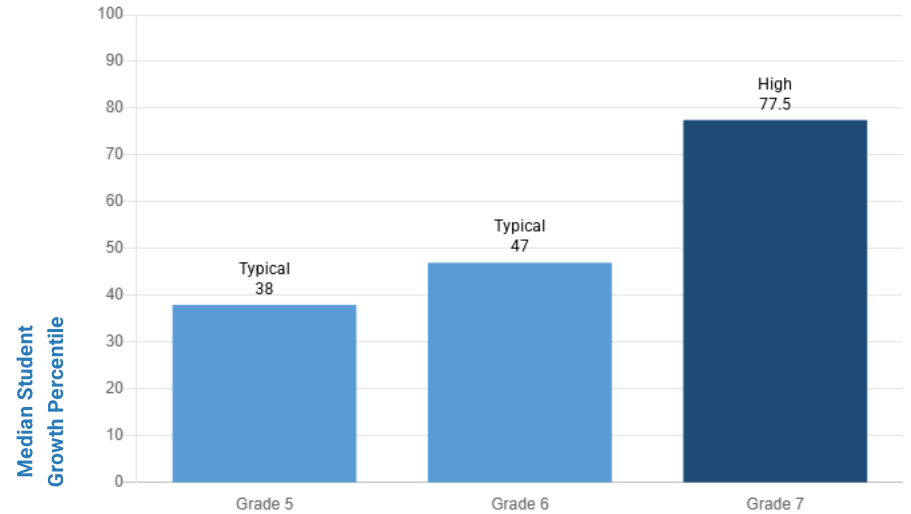

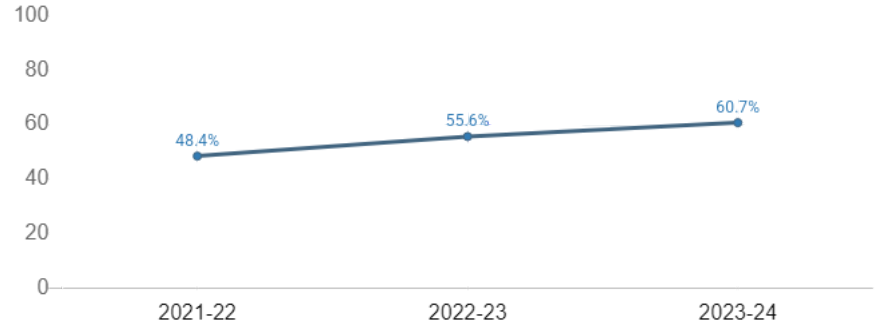
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 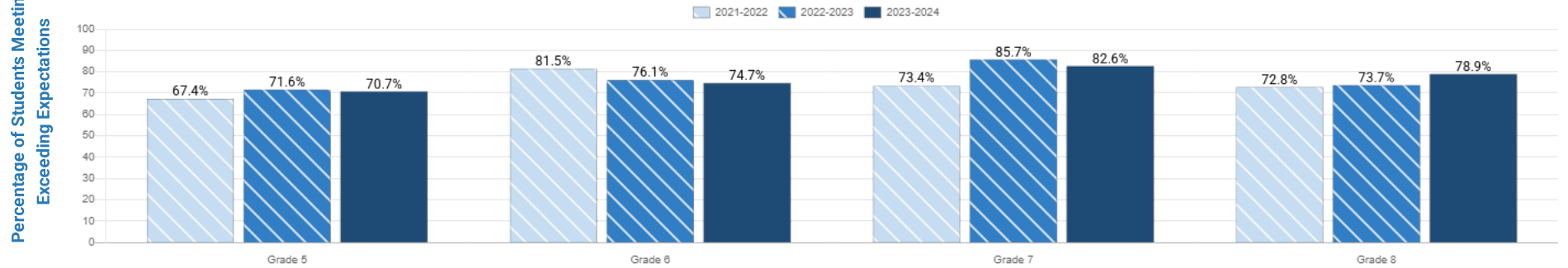

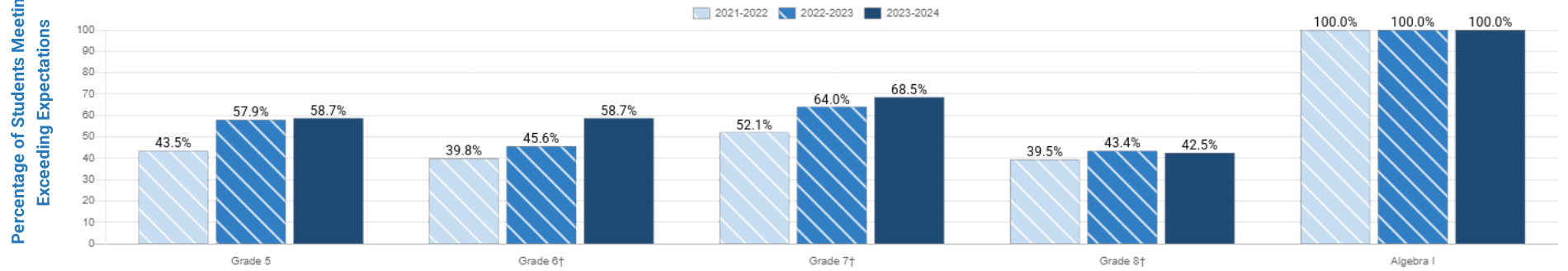

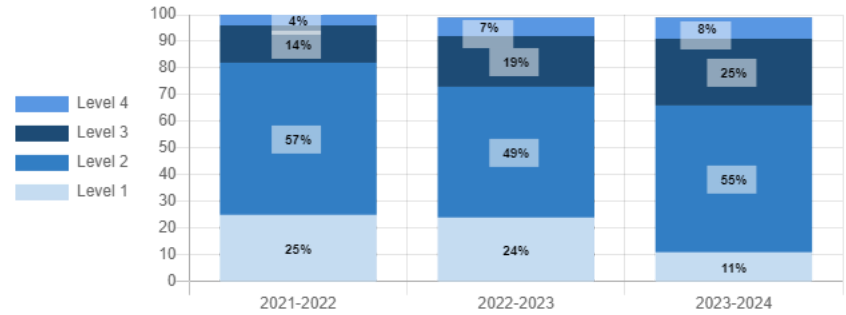

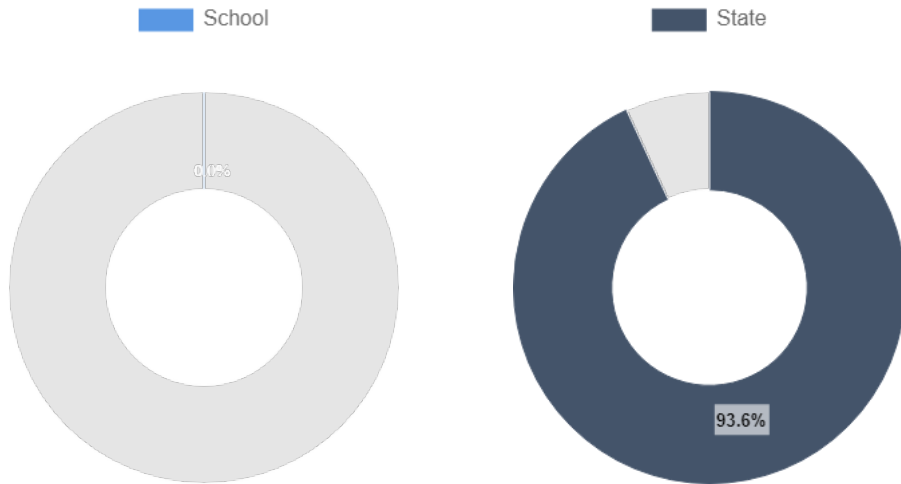

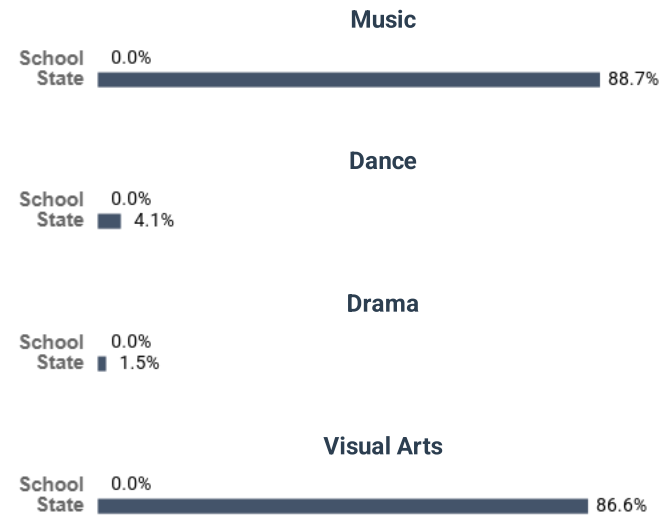

Students enrolled in one or more classes by discipline:



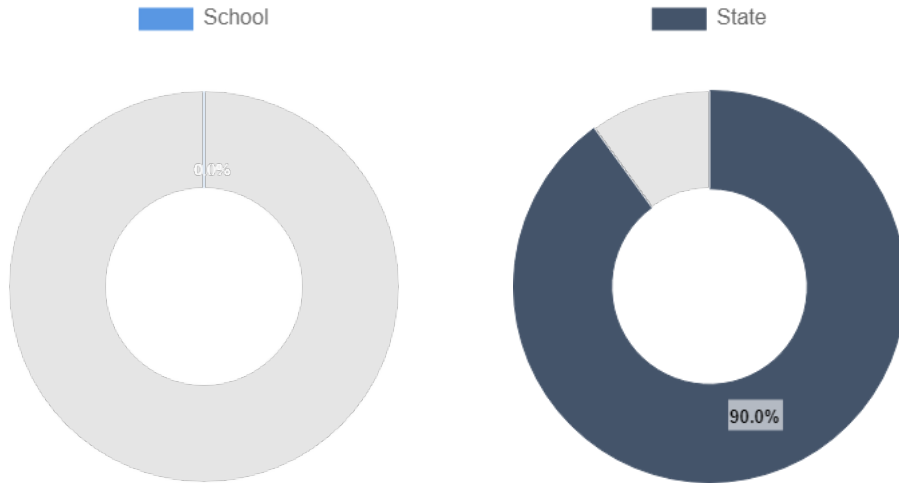

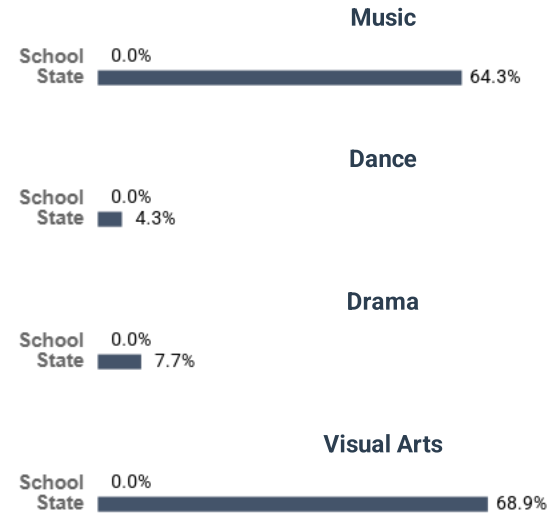

Students enrolled in one or more classes by discipline:



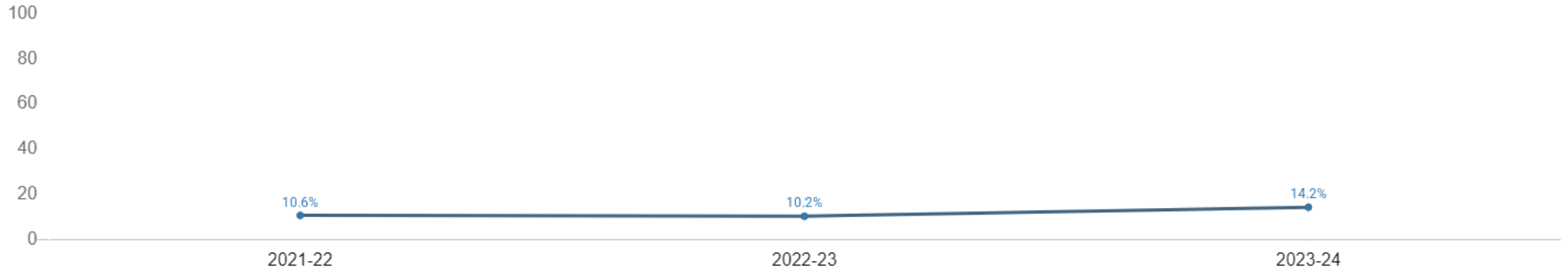

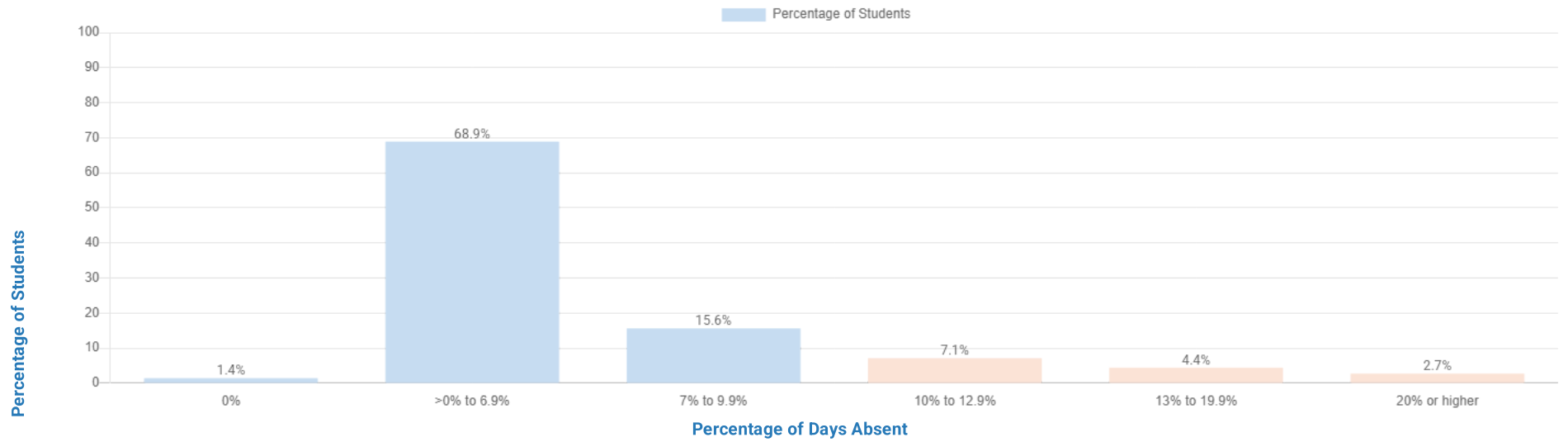

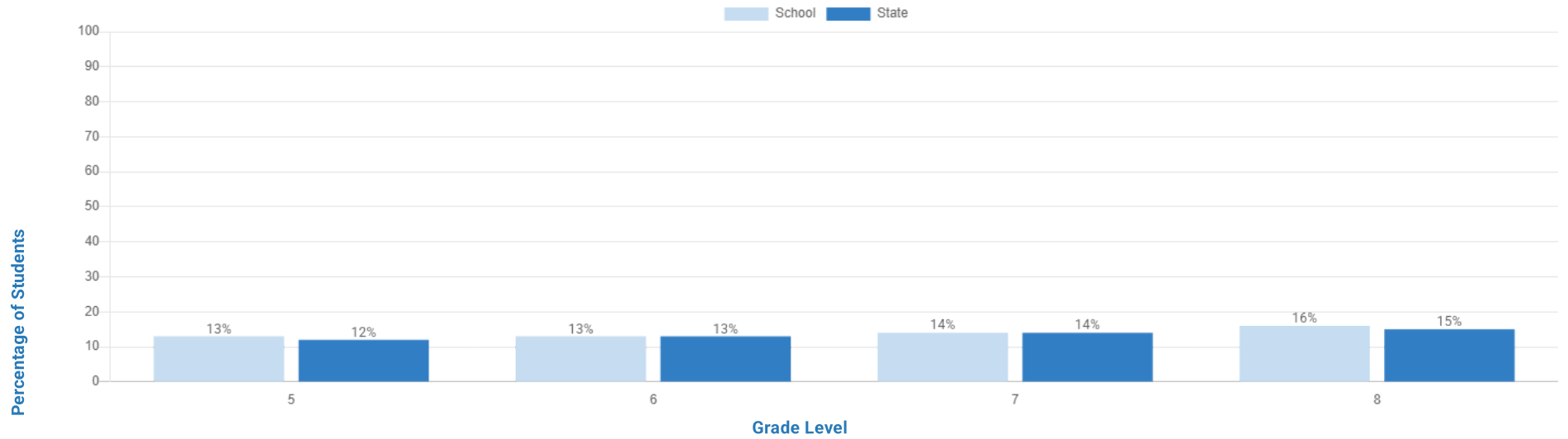

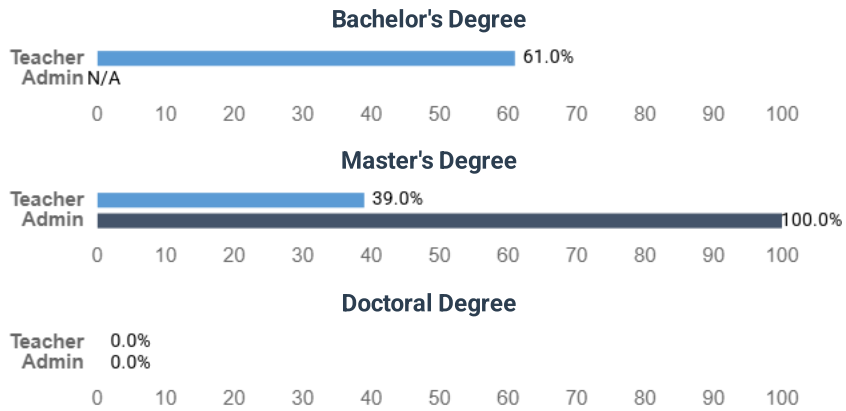

Accountability Summary by Student Group - 2023-24 School Year

- Students in grades 7 - 8 choose an elective course from STEM/ART, Band, and Performing arts. While student is 5 -6 choose an elective in Band or Chorus
- LPMS offers five fall, three winter, and two spring sports programs and ten clubs and extra-curricular activities.



Mission, Vision, Theme:

The mission of Lincoln Park Middle School is to provide our students with learning experiences and skills that will enable them to achieve their maximum potential as productive citizens of the 21st century. In providing a challenging curriculum that integrates the arts and technology into the core academic subjects, we provide our students with opportunities to grow as learners in an environment that is accepting of individual differences where all students can learn and work together.



Awards, Recognition, Accomplishments:

The Lincoln Park Middle School was a recent recipient of the NJ Healthy Communities Network grant. This grant allowed our school to purchase equipment and supplies to reinforce healthy and active lifestyles in our students. This grant also allowed our school to train four staff members in CPR to be trainers, as well as all of the equipment to provide CPR classes. LPMS has also received a grant from Atlantic Health that allowed us to build a Zen garden in our courtyard to create a classroom environment to promote mental health.

Courses, Curriculum, Instruction:

Grades 5 - 8 are departmentalized in heterogeneously grouped classes, with the exception of advanced math and algebra. All subjects are taught in 55-minute blocks on an A/B rotating schedule for all courses, except for the core subjects, which meet daily. Laptops are assigned in our 1:1 program, allowing access to all textbooks electronically. All students in grades 6th-8th at LPMS have a course called Gryphon Goals Daily, which has been created and implemented to address learning loss due to the covid pandemic, as well as to reinforce SEL in our school culture.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Boys & Girls), Cross Country (Boys & Girls), Field Hockey (Boys & Girls), Soccer (Boys & Girls), Softball (Girls)
Sports offered: baseball, basketball, cross-country, field hockey, soccer, softball. In addition to these extra-curricular sports offered in the Gryphons Sports program, cheerleading is also offered during basketball season. Performing alongside our cheerleaders is a Gryphon mascot, occupied by students in grades 6 - 8. Boys and girls alike are eager to perform as the Gryphon mascot during home games.



Clubs and Activities:

A number of clubs are available for the students of LPMS. The drama club puts on a musical performance each spring and is available to students in grades 5 - 8. The broadcast club records the daily announcements and broadcasts the daily via YouTube. We also offer a yearbook club, jazz band, select choir, Student Council, Maker-Space Club, Drama Club, and Climate Committee.

Before and After School Programs:

The LPMS offers academic assistance programs after school for the students as well as clubs and intramural programs.



Staff and Professional Learning:

The school calendar has four full days for in-house staff development. These days provide the staff with professional development opportunities to improve their classroom instruction. Besides these full-day programs, the staff is encouraged to participate in workshops and seminars throughout the county and state. We also collaborate with other school districts in professional development programs. Staff members in grades 6-8 have a weekly PLC time built into their schedule, which is used by the core teachers to compare data trends among the students. There is also a monthly PLC meeting that takes place after school, allowing teachers of all grades an opportunity to confer.



Student Supports and Services:

The school counselor provides support for both academic and emotional issues with which students cope. Guidance is available throughout the day and helps to implement the character education program, in conjunction with the health & PE department through the Gryphon Goals period. Teachers provide additional assistance for students whenever possible both before and after school hours. Our school also has a full-time school psychologist, to offer therapeutic mental health support to our students.

Student Health and Wellness:

The school nurse serves on a committee that meets yearly with the food service provider to improve school lunches. She works with the borough health department to provide supplemental health instruction programs and workshops for the students of LPMS. She also supports the PE/health teachers as they provide health instruction throughout the year.



Parent and Community Involvement:

LPMS partners with the borough police, recreation department and Municipal Alliance to provide many opportunities for our students and their parents. The police work with the school to ensure the best security is in place. The LP Schools PTO works with the middle school to improve the educational experience for students and teachers. Whenever possible, programs for parents are provided with the help of these groups.

LPMS administered a climate survey through NJSCI and analyzed the data through parent, staff, and student teams. The data showed both students and staff are happy coming to school at LPMS and there is a feeling of safety among both students and teachers. Parents responded favorably to their experiences with teachers and administrators. When the district administers a climate survey this spring, we will continue to utilize NJSCI.

Facilities:

Lincoln Park Middle School features the Rose M. Patania Media Center which houses the Maker- Space lab. It is adjacent to the STEM/Computer lab where students gain experience with desktops, supplementing their daily use of chromebooks. The band room includes a soundproof room where small group lessons are provided. The gym boasts a forty-foot rock traverse wall used in our PE classes.



School Safety:

School safety is always a top priority at the LPMS. Emergency drills are performed, assuring the students and staff are well prepared in case of an emergency. The LP police attend the majority of our drills and give continuous guidance and assistance on ways to improve the security and safety procedures of the building.



Technology and STEM:

The LPMS has a dedicated STEM/Computer classroom. The students have the opportunity to take a STEM elective and STEM activities are infused into the school's curricula. The LPMS also offers a MakerSpace program to the students. The 8th grade students are provided with an engineering program before leaving the middle school. All 5th & 6th Grade have computers and STEAM as a cycle course for one trimester of the school year.

The district is using its ESSER funds to address a myriad of issues that the COVID pandemic created. Student mental health has been a priority and additional staff has been brought in to each school. Additional mental health resources have also been provided to students with varying needs. Learning loss from the pandemic is also being address through our language arts program as well as our MTSS program. The district has also been working with community organizations such as the Borough's Health Department and their Infectious Disease Preparedness Generalist. The district has provided targeted support for struggling students through a summer program as well as an after-school academic support program at the middle school. The district increased our behaviorist to a full-time position.

Lincoln Park Middle School is an educational community that serves approximately 400 students in grades five through eight. We challenge our students with a curriculum that is academically rigorous in an environment that is nurturing and supportive. We also offer our students a wide variety of learning opportunities during their middle school experience. LPMS is divided into houses, ACC, SEC, PAC12, & BIG10. This encourages friendly competition while fostering a sense of community across grade levels via our annual House Day and Field Day. Our fundraisers and pep rallies are run through the houses as well. Every classroom has an interactive white board and has full Wi-Fi for our 1:1 initiative. All of our students are able to bring a school-issued laptop home with them. Through continuous and open communication among the staff, we are able to keep abreast of all of our students' needs, both academically and emotionally. We also present lessons or programs addressing substance abuse awareness, anti-bullying and violence, as well as tolerance activities. Cooperative efforts with our community enable our school to keep our students involved in the world around them. Our band and chorus perform at community events beyond our school. Our broadcast crew records the daily announcements and shares them with the larger community via the internet. The broadcast crew also works with our climate committee to produce PSA's for our students. The staff of LPMS strives to create an environment that allows children to recognize and achieve their fullest potential. We work hard to teach our students to respect diversity and the rights of others, preparing them to become active citizens in a rapidly changing society.
