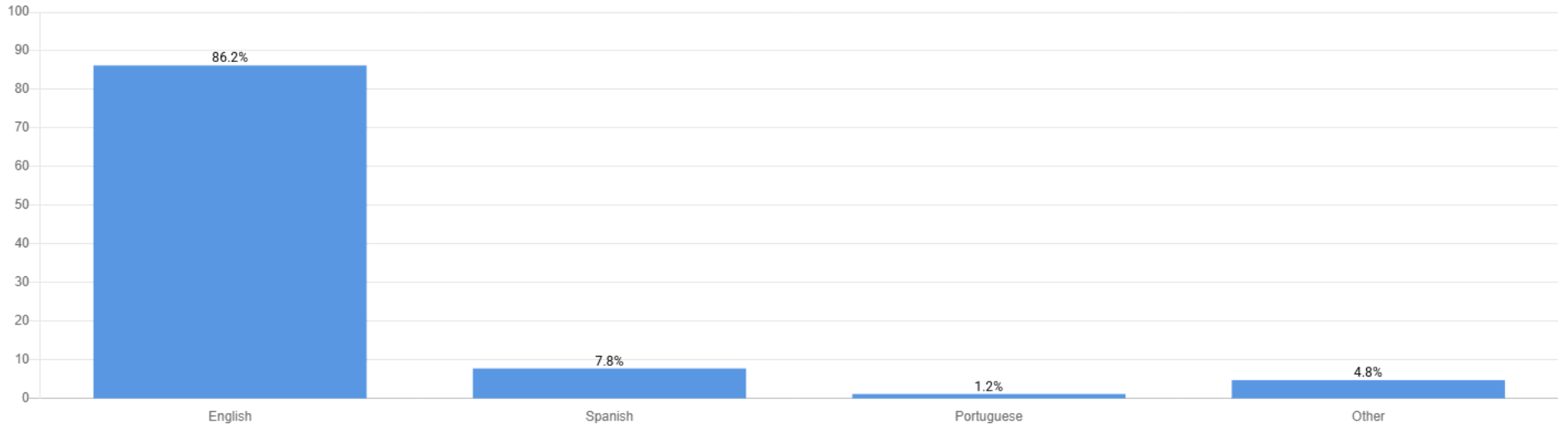

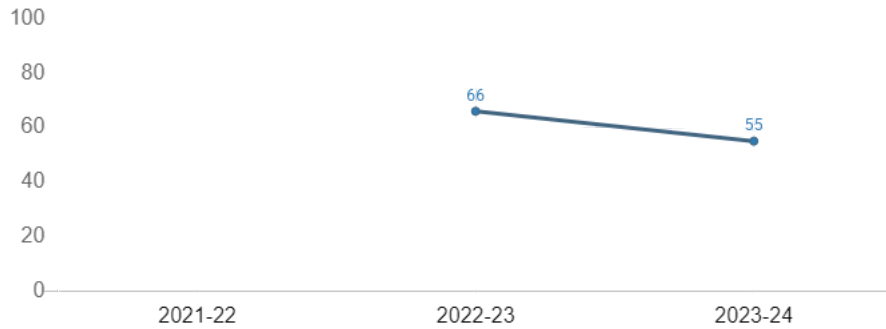

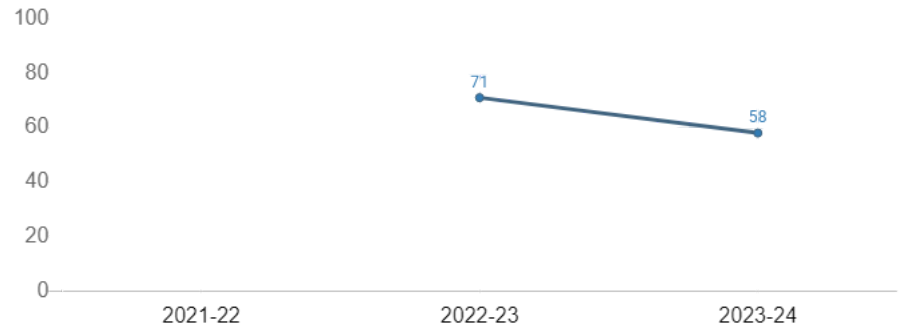

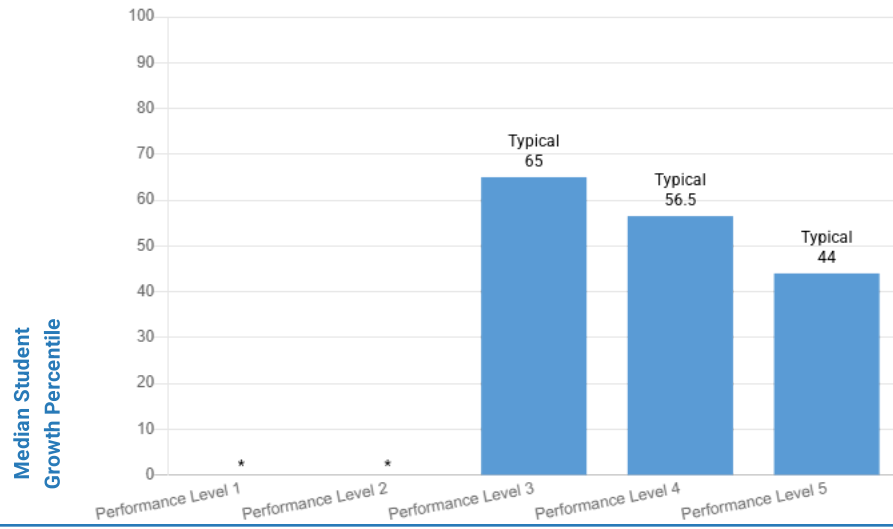

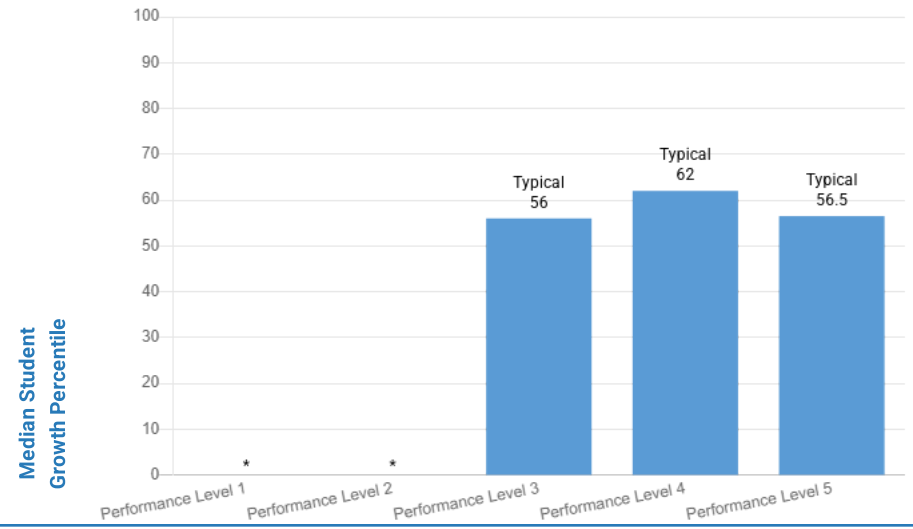

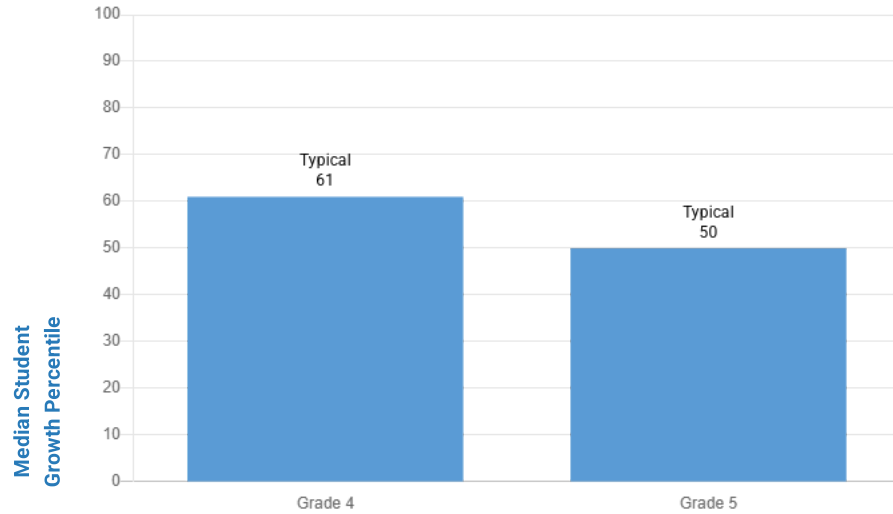

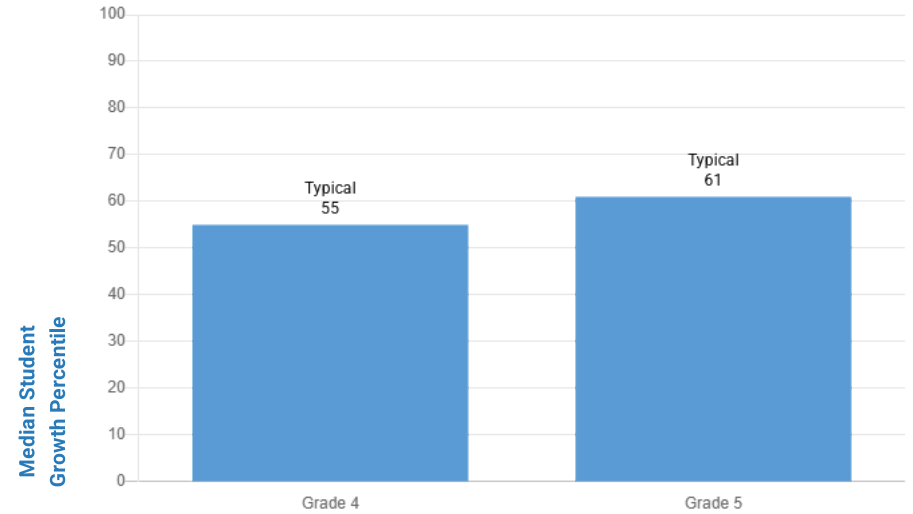

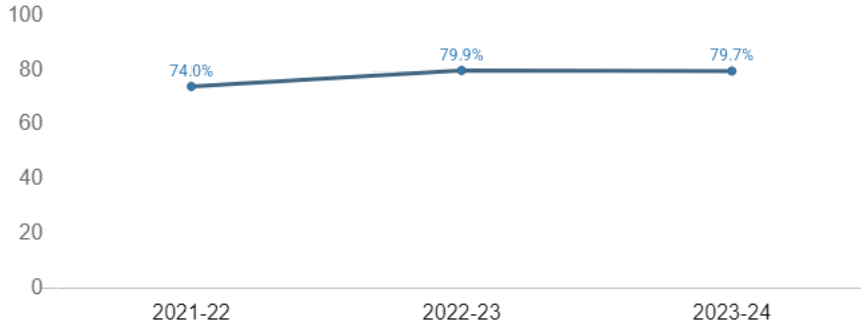

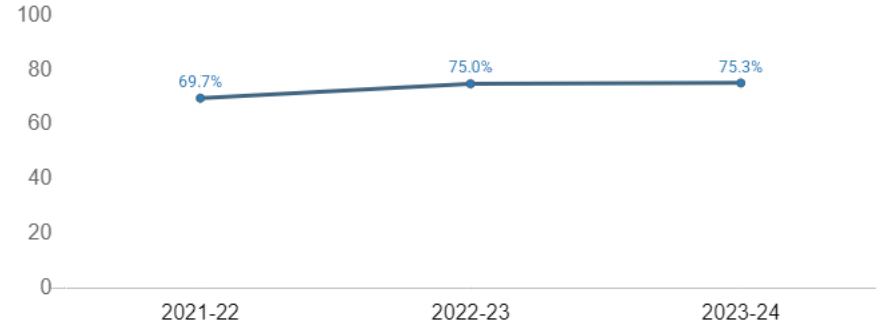
### English Language Arts and Mathematics Performance Trends

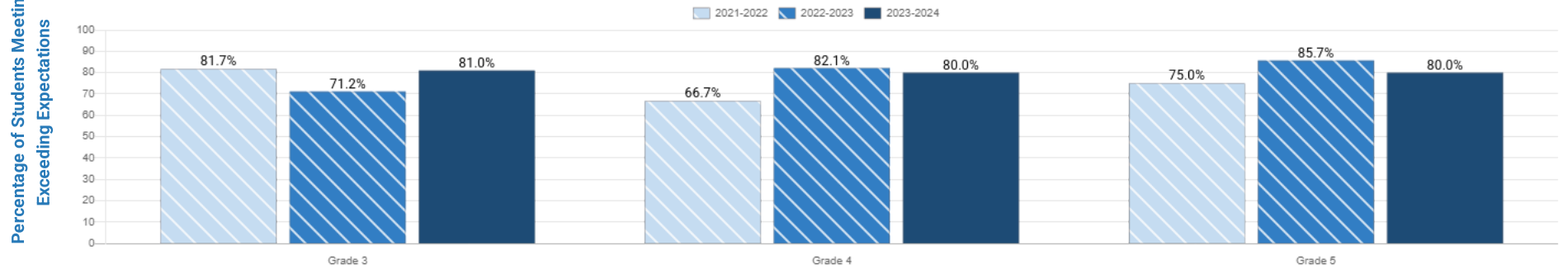

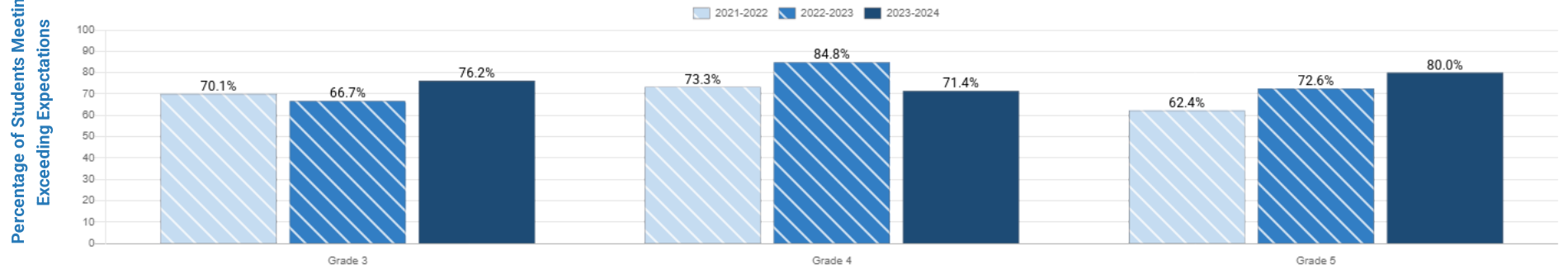

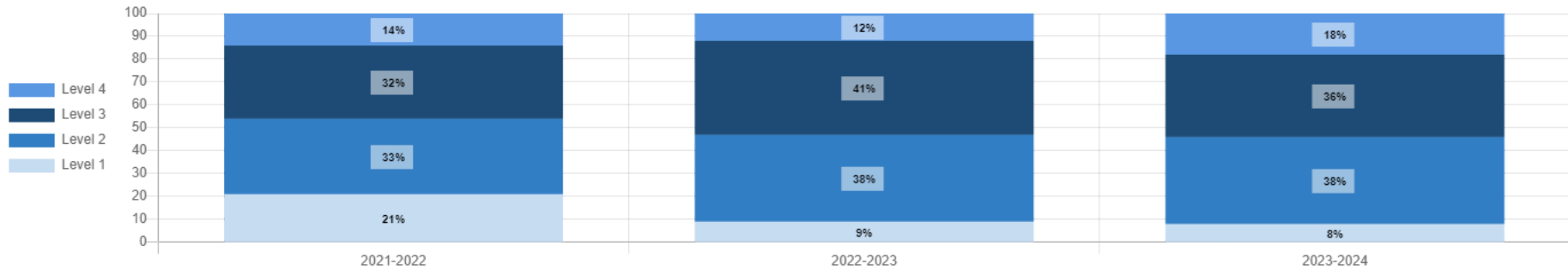

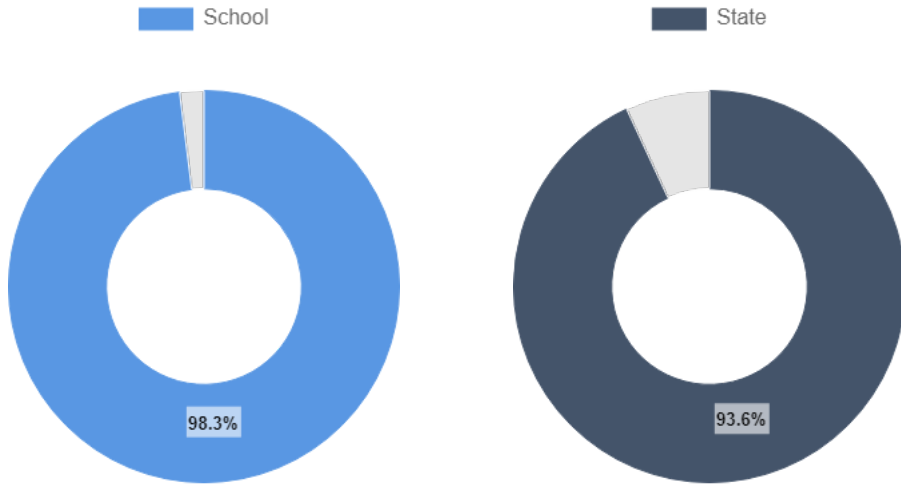

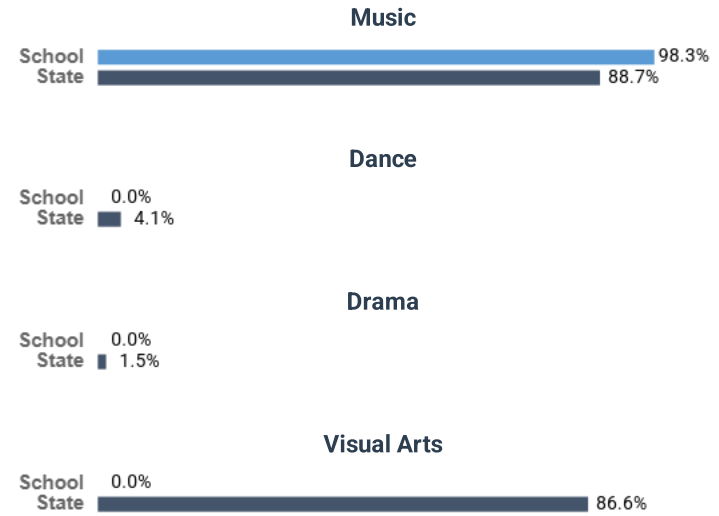

**Students enrolled in one or more classes by discipline:**



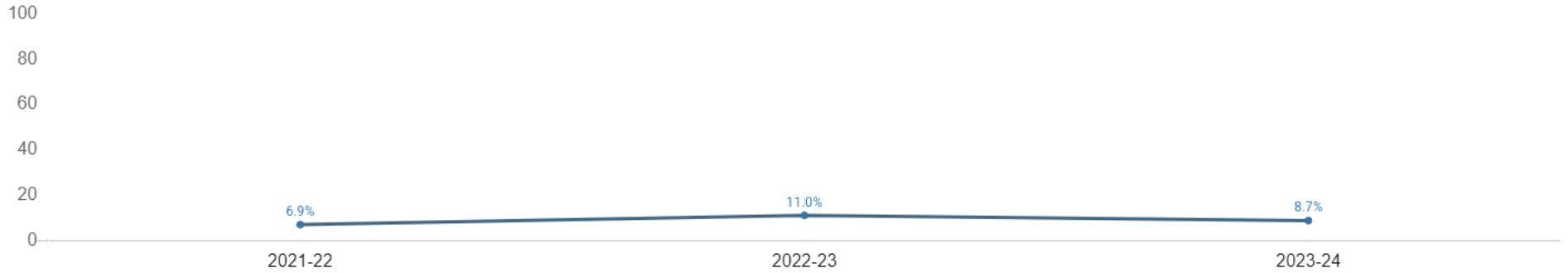
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

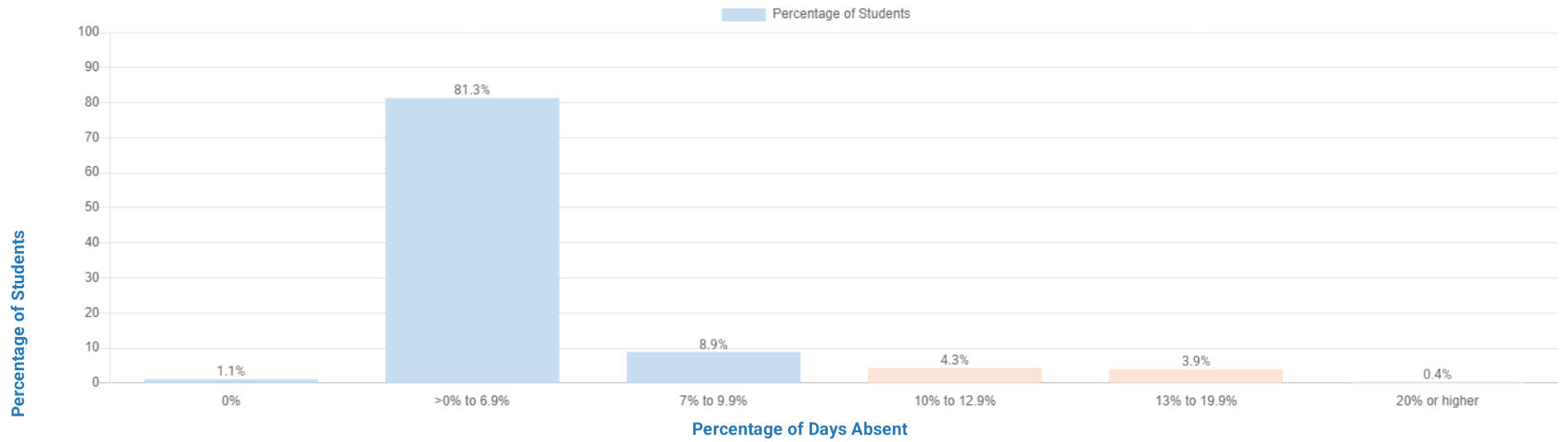

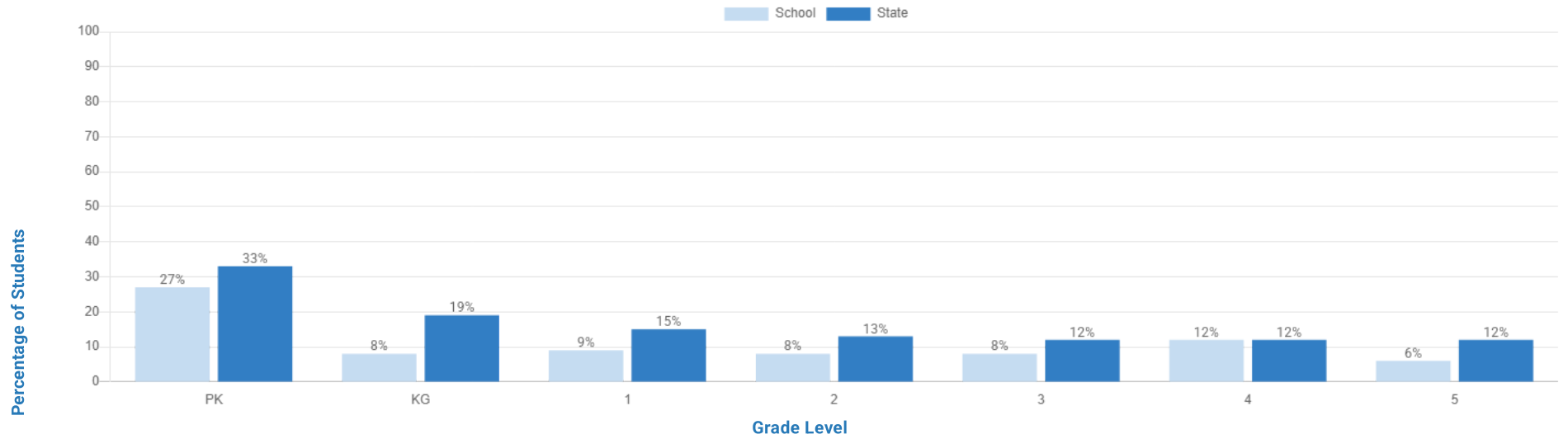

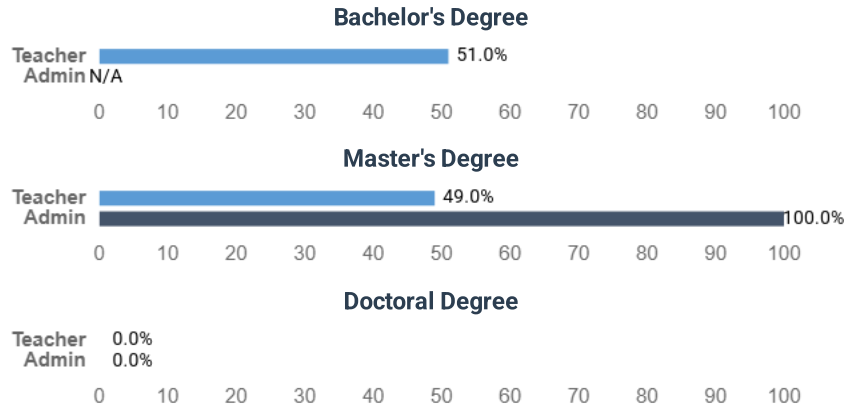

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ### Courses, Curriculum, Instruction:

Balanced literacy, problem solving centered mathematics, STEAM, social studies, science, and character education comprise the elementary curriculum. To track student learning progress, the school Data Team/MTSS Leadership Team collects and analyzes student assessment data to make decisions about ways to support student learning. The STEAM teacher provides inquiry-based STEAM activities in the classrooms and in our STEAM Space/Makerspace. Daily intervention time is conducted within each classroom schedule, to implement targeted interventions within a district Multi Tiered System of Support (MTSS) model to support the students' diverse needs. Character education includes scheduled community circle time, pillars, Zones of Regulation, and the district guidance curriculum.



### Sports and Athletics:

Central Avenue offers a before and after school program. In addition, Central Avenue offers enrichment classes via our PTO. Enrichment includes, but is not limited to, legos, yoga, mindfulness, soccer, and robotics.

### Other Information:

Central Avenue School offers district-wide efforts to meet Common Core standards in the area of mathematics, emphasis focused on development, instructional practice and evaluation of problem-solving abilities; calculator use; and the mastery of computational skills through our Math In Focus Program. Problem-solving evaluation consists of pre- and post-assessments and portfolio activities. Writing workshop settings resulting in language arts portfolios, combined with skill instruction, demonstrate our efforts to meet language arts/literacy standards. Strategies for reading fiction and non-fiction help students attain those standards as well. Authentic performance-based science assessments provide students with opportunities to demonstrate their understanding of science facts and concepts, as well as their application of scientific inquiry learned in our elementary science program. Each year, our school math team participates in the New Jersey Mathematics League contest for fourth and fifth graders. Students in grades five also participate in the International Math Olympiad.
