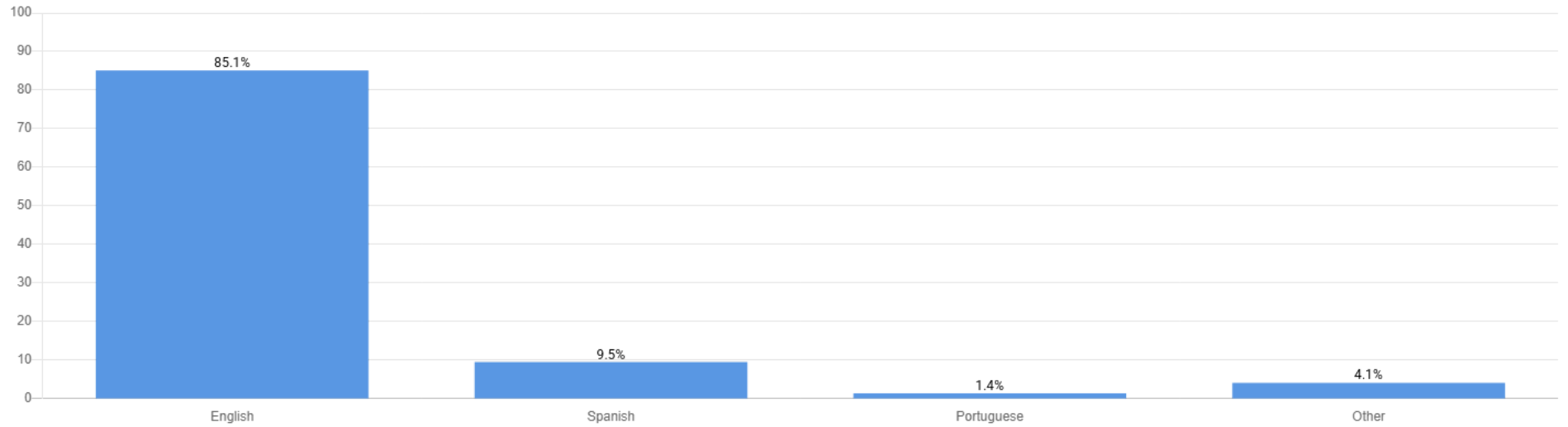

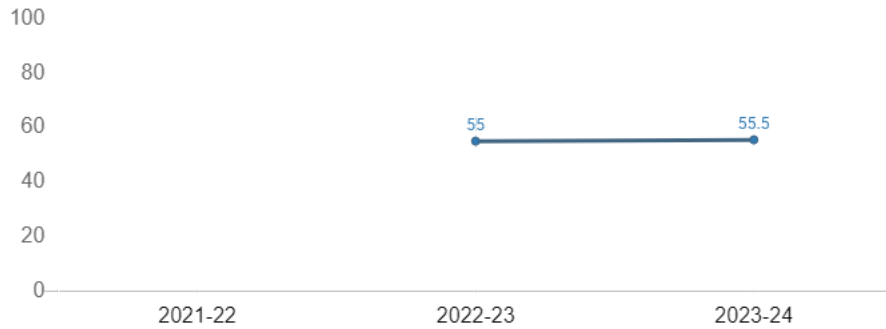

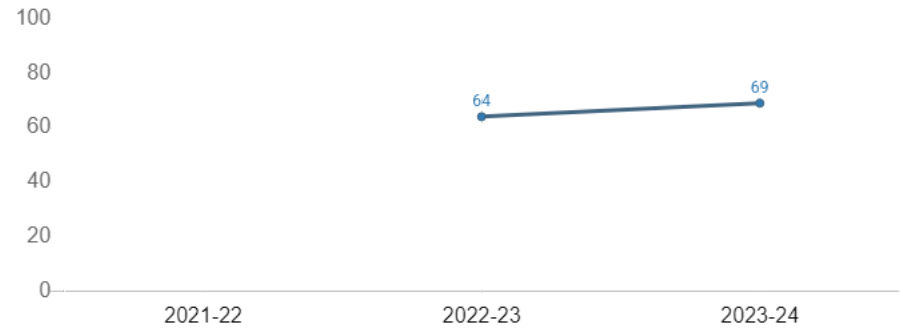

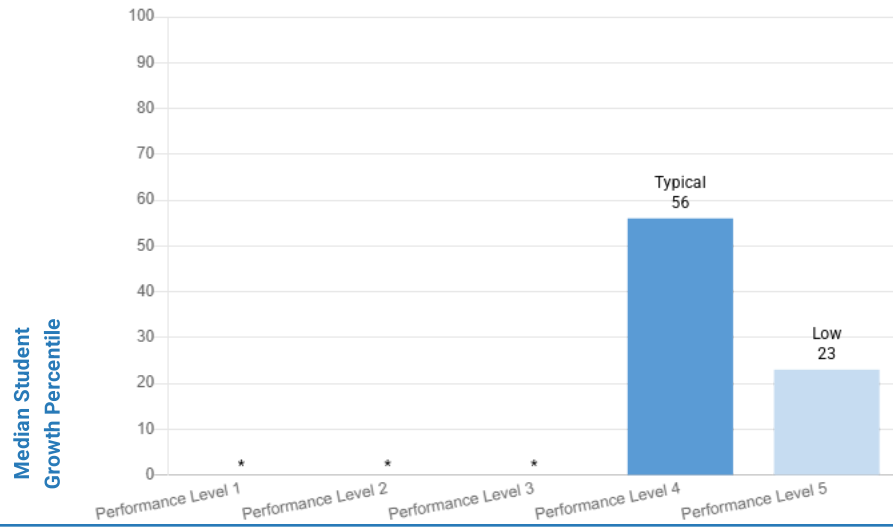

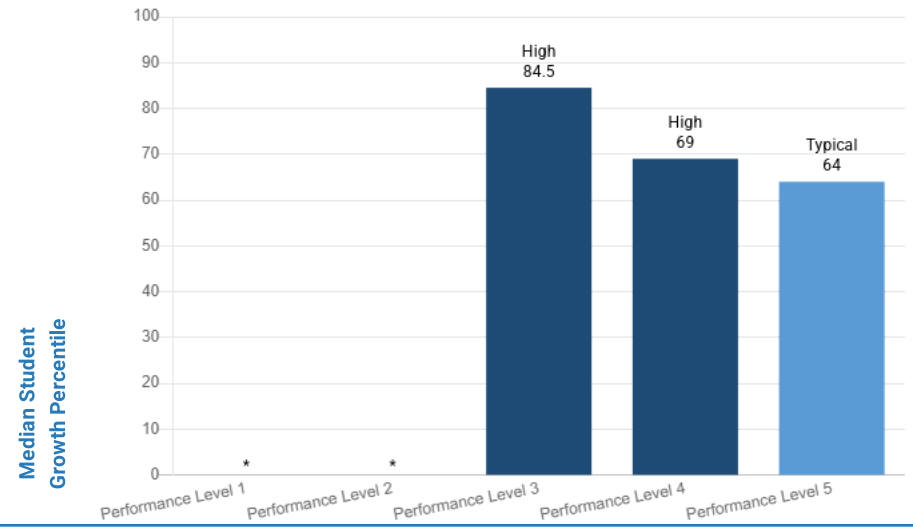

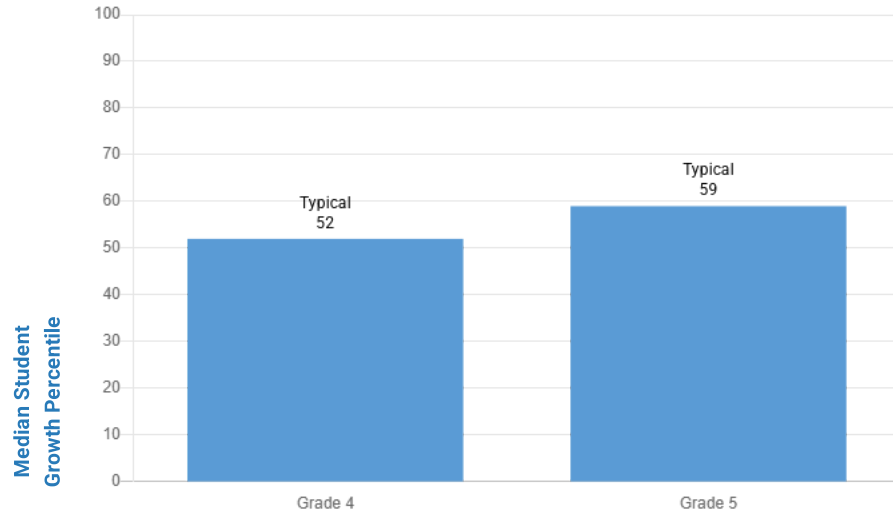

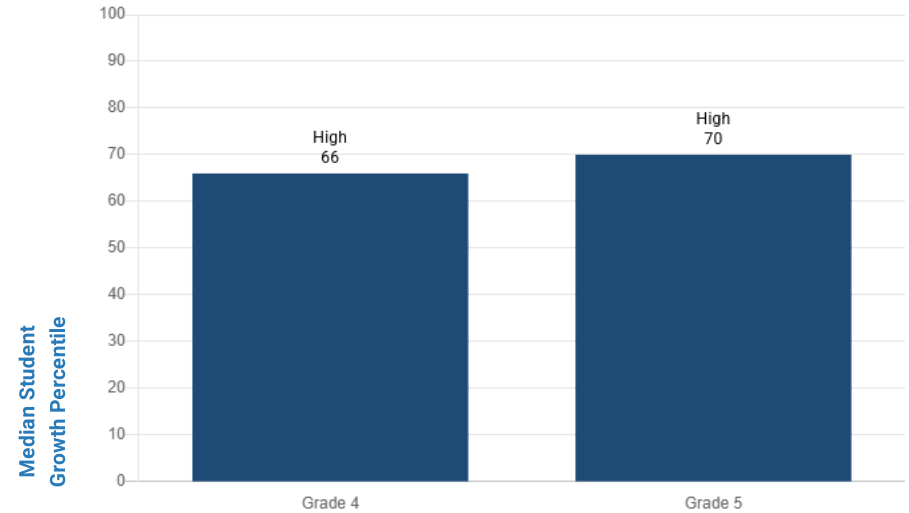

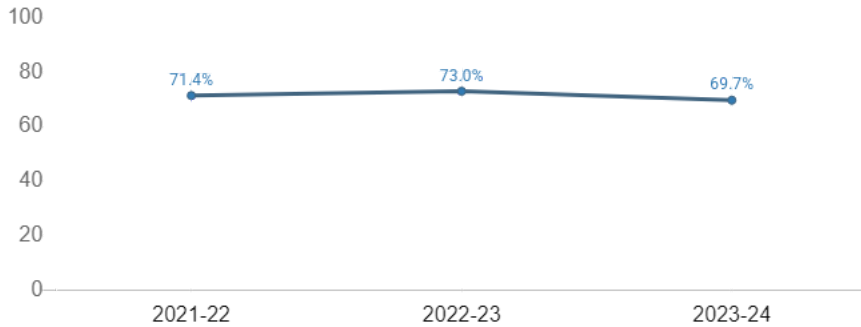

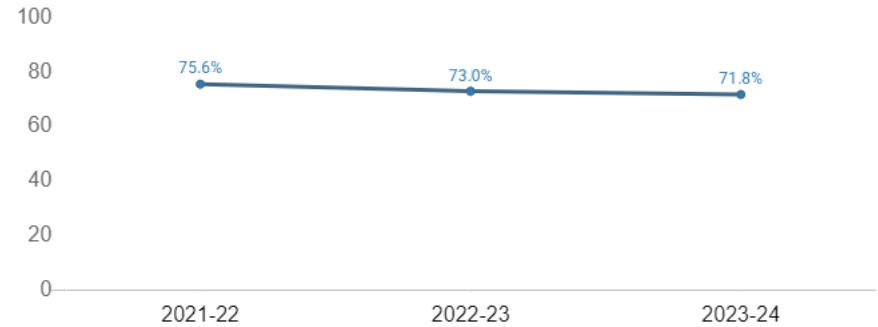
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 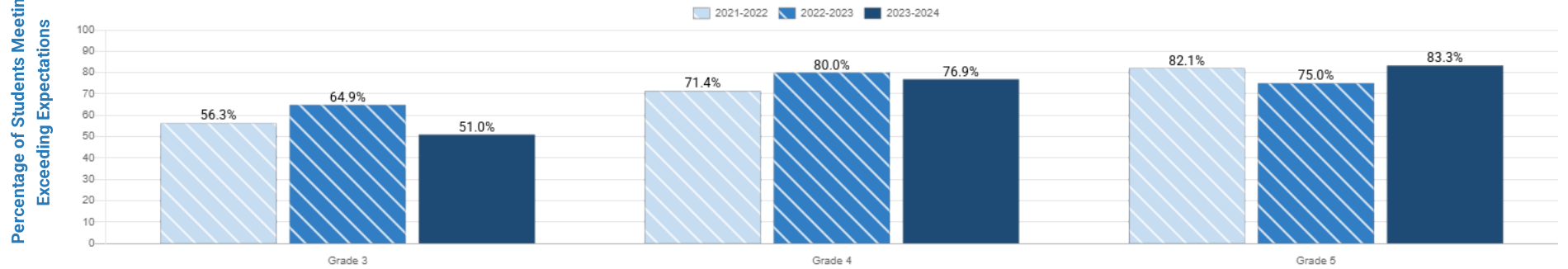

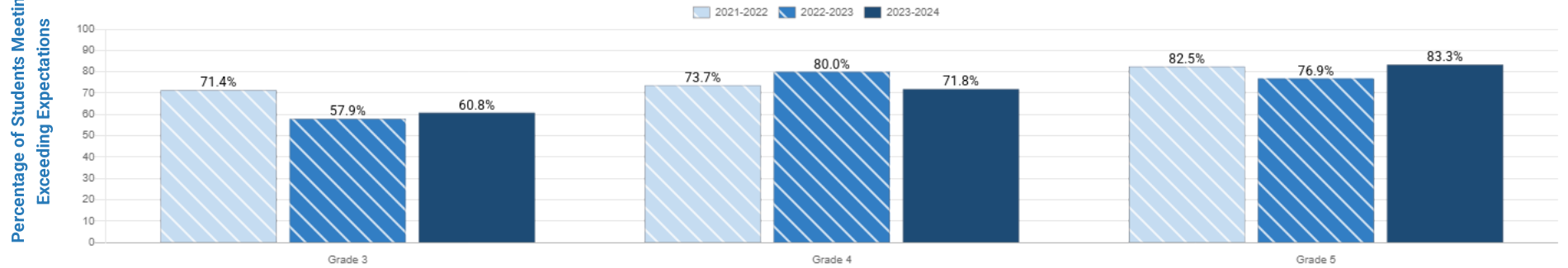

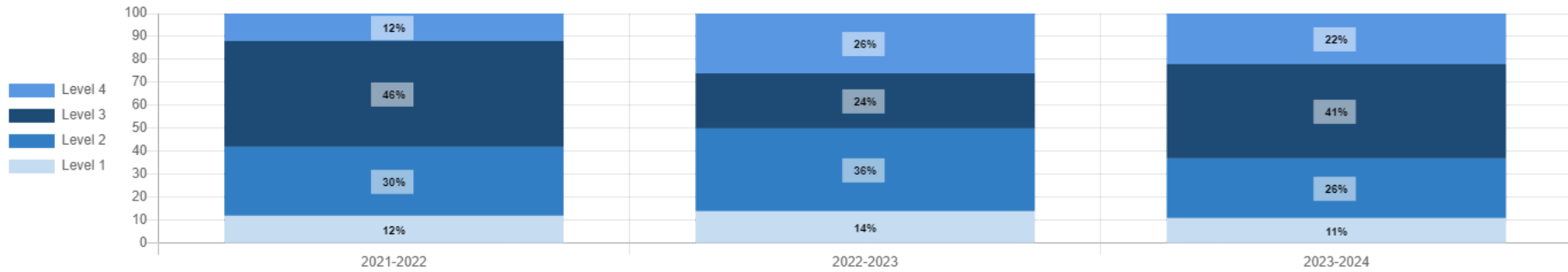

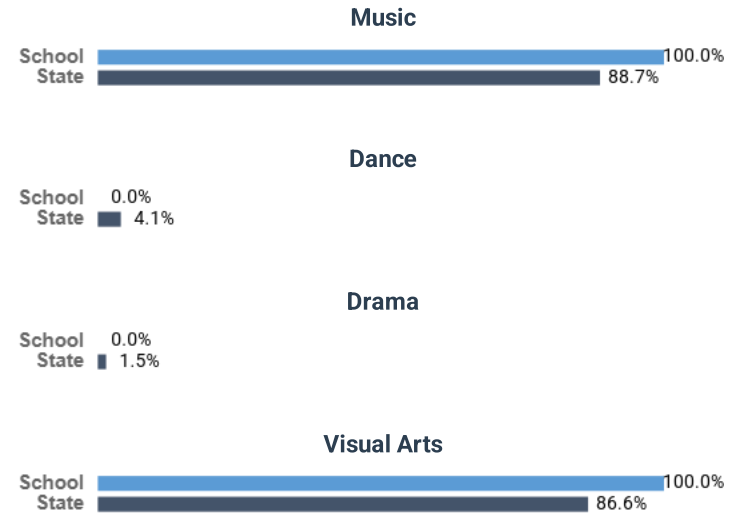

Students enrolled in one or more classes by discipline:



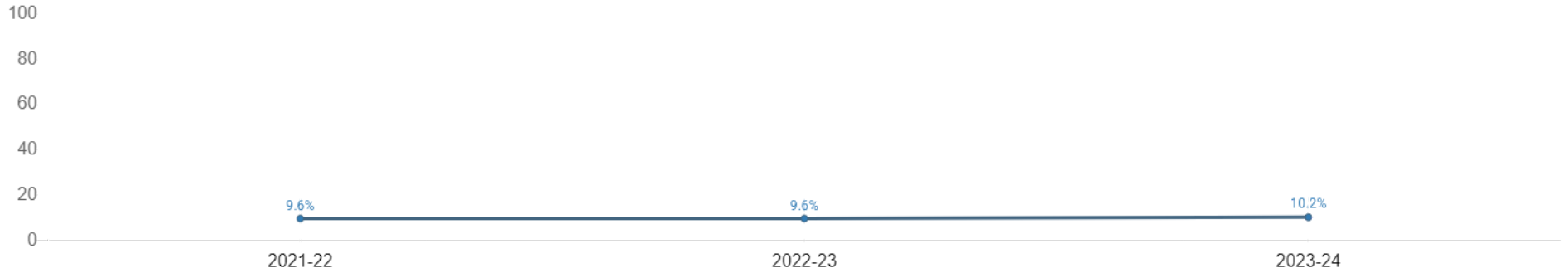

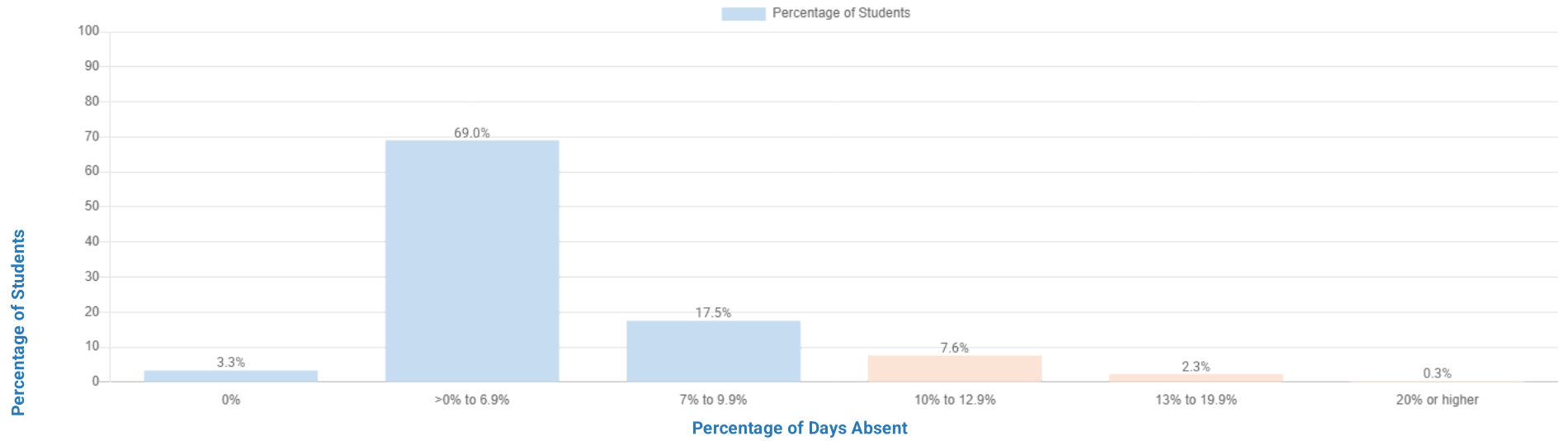

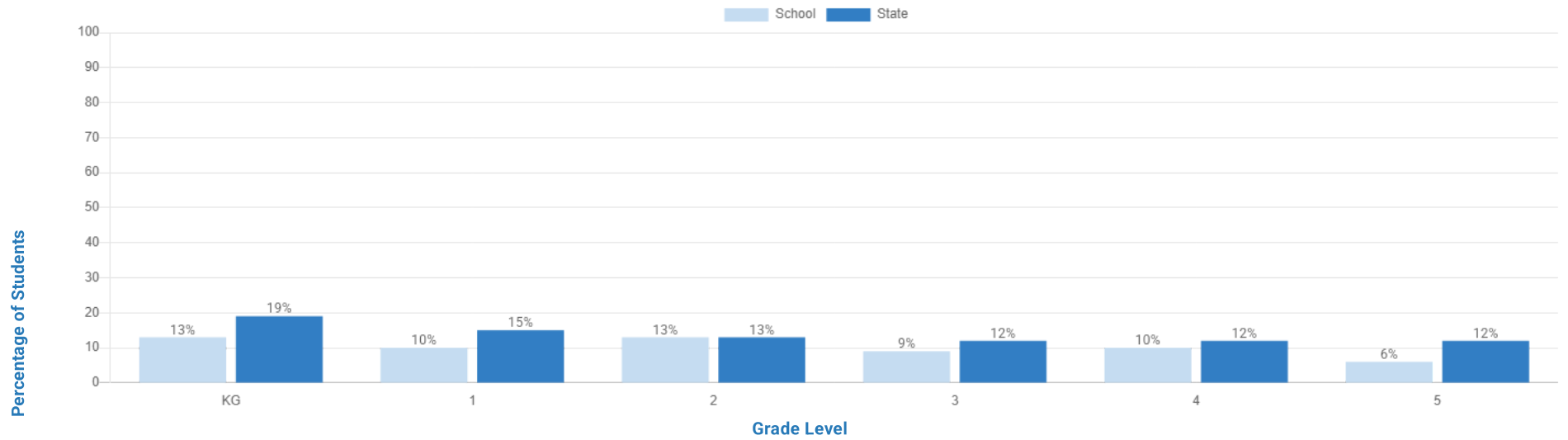

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

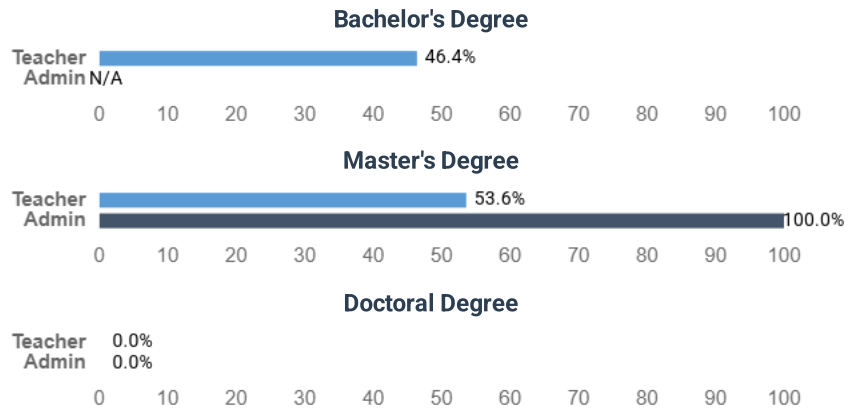

Courses, Curriculum, Instruction:

Balanced literacy, problem solving centered mathematics, STEAM, social studies, science, and character education comprise the elementary curriculum. To track student learning progress, the school Data Team/MTSS Leadership Team collects and analyzes student assessment data to make decisions about ways to support student learning. The STEAM teacher provides inquiry-based STEAM activities in the classrooms and in our STEAM Space/Makerspace. Daily intervention time is conducted within each classroom schedule, to implement targeted interventions within a district Multi Tiered System of Support (MTSS) model to support the students' diverse needs. Character education includes scheduled community circle time and the district guidance curriculum.

Student activities include Student Council, Peer Leaders, STEAM Fair, assemblies, class enrichment experiences, school musical, Band, Orchestra, Chorus, Chess Club, and a variety of enrichment courses are taught by Kings Road School teachers and offered after school.



Staff and Professional Learning:

School professionals engage in continuous professional development, to include during faculty meetings, in professional learning communities, in-service days, and delayed openings. The professional development topics are determined by the curricula, tied to district/school goals, and teacher-selected topics provided by data from a teacher professional development survey. The School Improvement Committee (SciP), composed a survey, surveyed the building level educators, and analyzed the survey data to determine the building-level professional development needs.

Student Supports and Services:

KRS students receive a multitude of specialized supports designed to address students' areas of need within an inclusive school setting. Students receive explicit instruction from certified instructional staff members in order to build key competency and foundational skills. In terms of social and emotional supports, students are supported by class, small group, and individual counseling focused on social skills interventions that are delivered by a full time school counselor. The KRS special education team of certified special education teachers, provide individualized programs for students with disabilities. A school reading specialist and a math interventionist provide interventions within a multi-tiered system of support model. The KRS Intervention & Referral Services Committee creates action plans including classroom interventions for students experiencing academic, behavioral, or social difficulties.



Student Health and Wellness:

We utilize a team approach to student health and wellness that includes our school nurse and guidance counselor. Activities during Safety Week, Respect Week, and Kindness Week focus on the students' safety and emotional wellness. The Responsive Classroom philosophy contributes to supporting the students' emotional and social needs.



Parent and Community Involvement:

The Kings Road School Parent/Teacher Association supports the school by funding teacher grants, holding community events, and volunteering in the school. The KRS PTO received a New Jersey Governor's Volunteerism Award for their equity approach in providing activities for all students. The Madison Education Foundation supports the school by funding grants for items/projects in the school. The Madison Fire Department, the Madison Police Department, the Rotary Club, and the Madison Recreation Department, provide programs and services that include safety and sports for our students.

The Google Classroom platform is utilized district-wide. Teachers implement a blended learning model approach within their instructional practices. The morning announcements feature student/staff birthdays, fun facts, special events, and a word of the day. Frequency modulated (FM) systems provide the students with amplified sound to support teaching and learning. Document cameras are in use to project student work and instructional content during lessons. Bi-weekly faculty meetings are conducted to discuss technology resources, teaching and learning best practices, and to support the teachers with the blended learning model.
