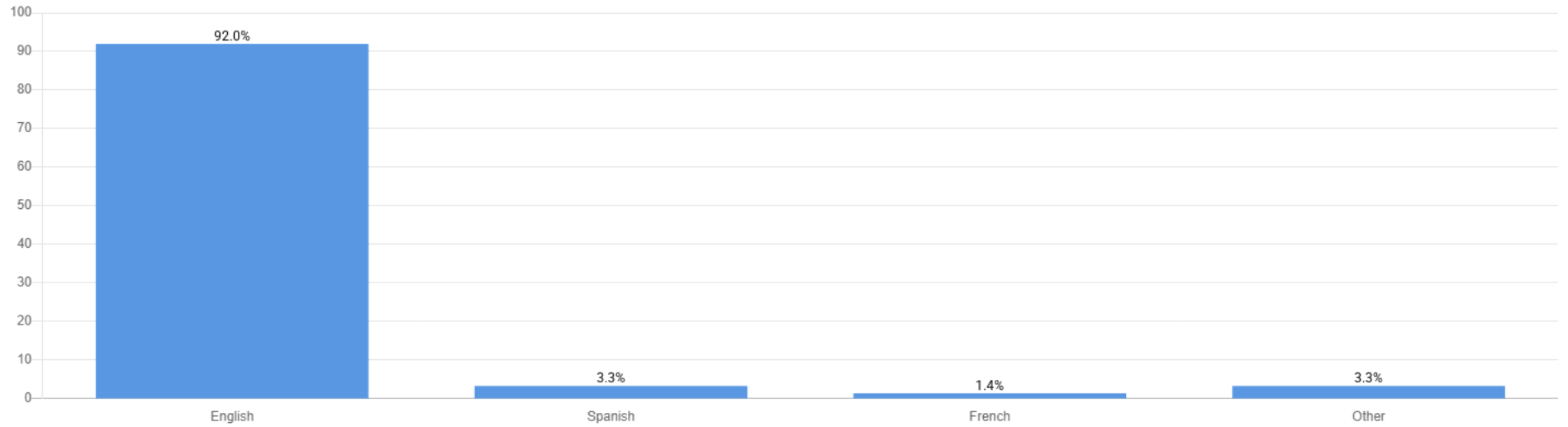

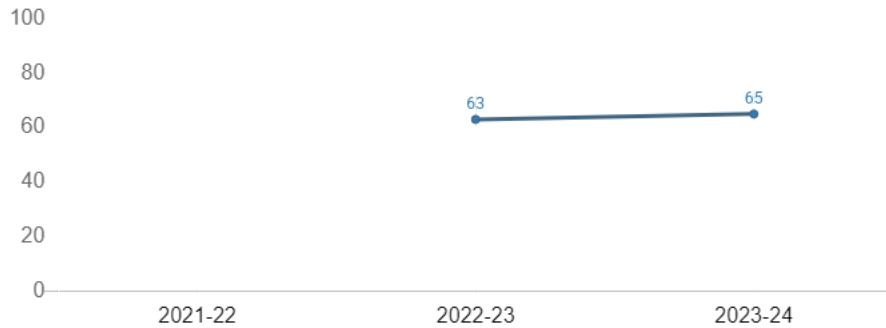

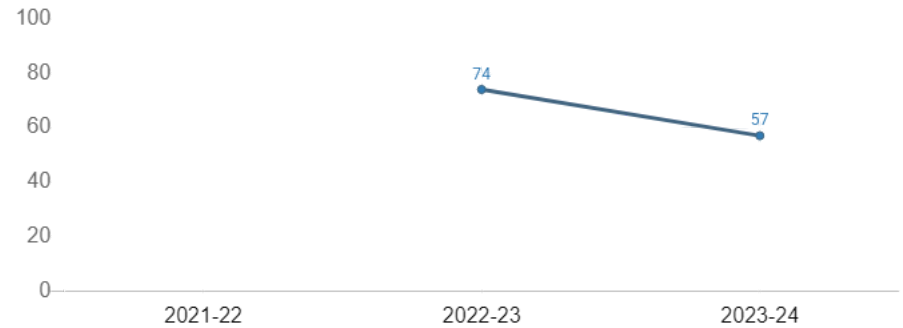

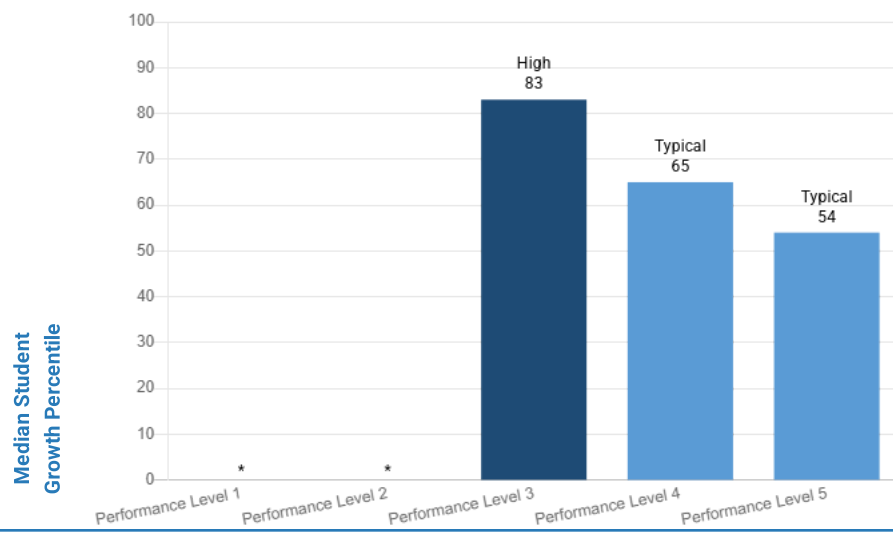

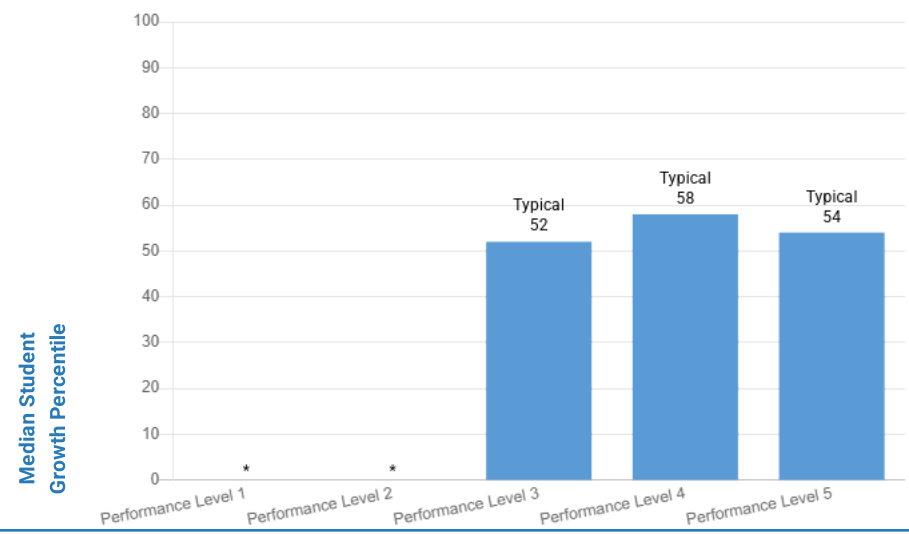

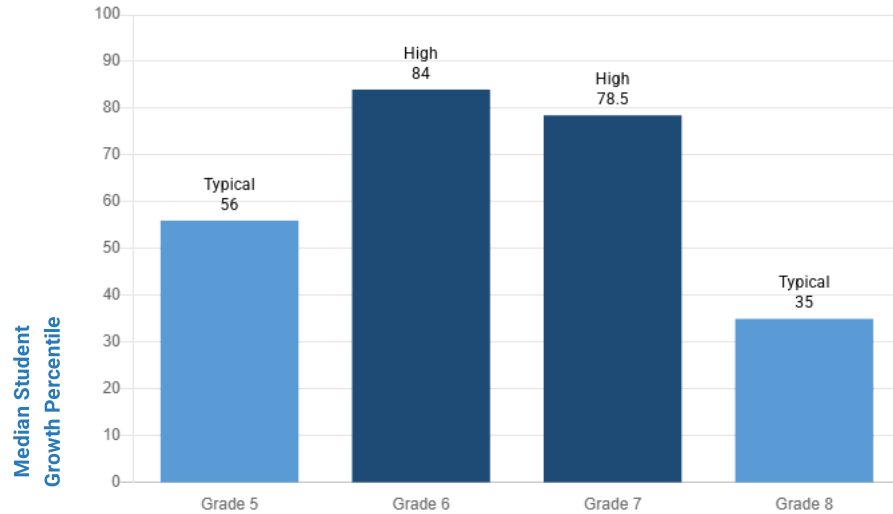

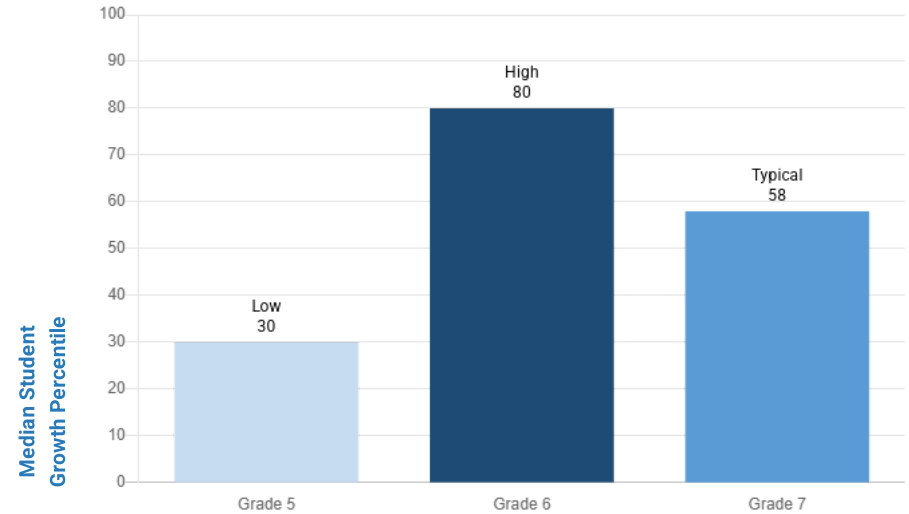

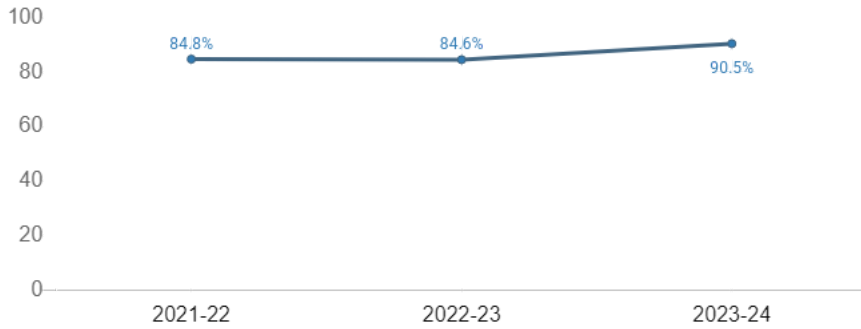

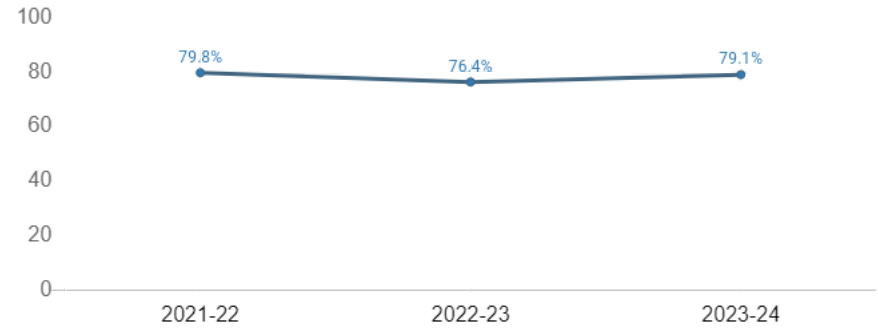
English Language Arts and Mathematics Performance Trends

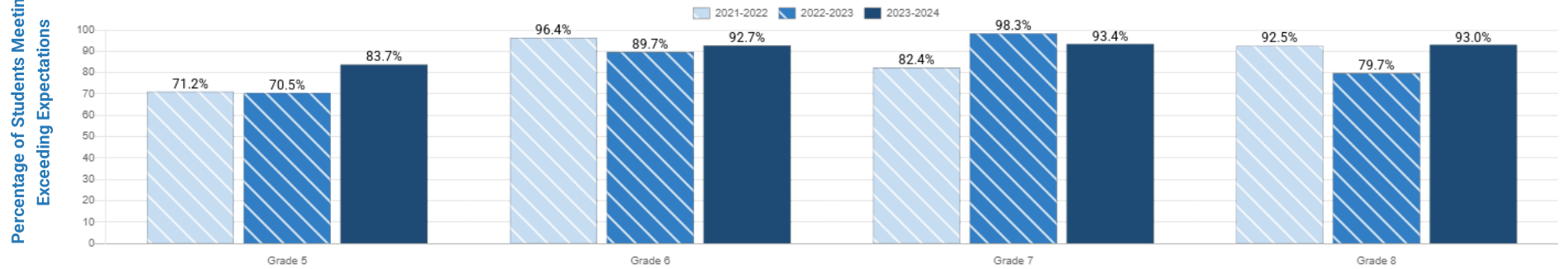

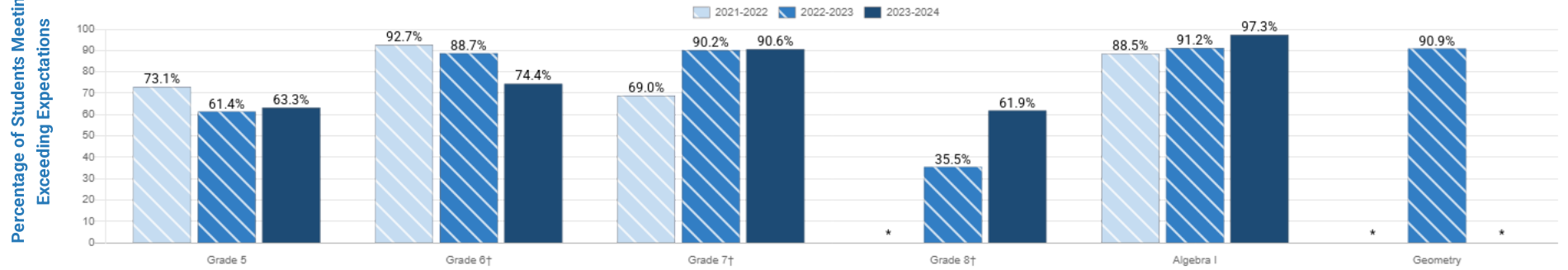

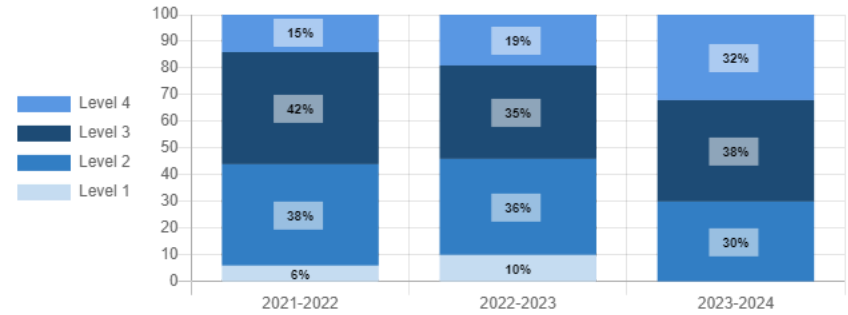

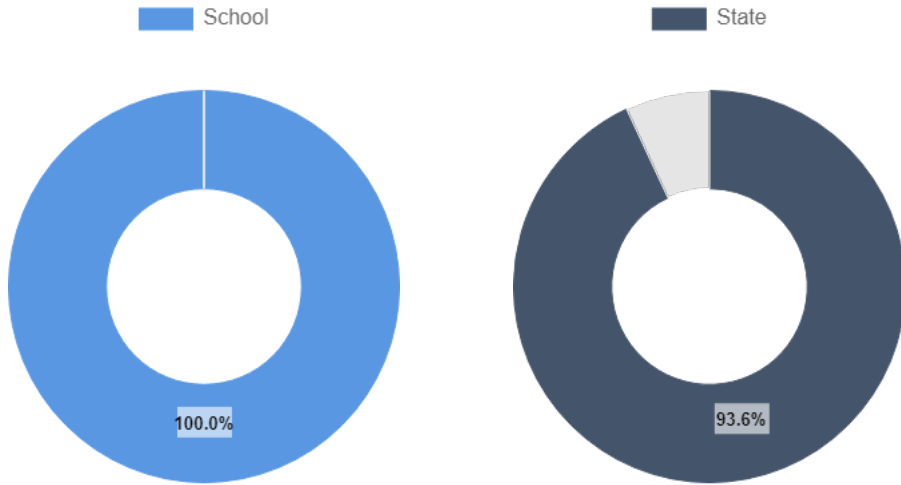

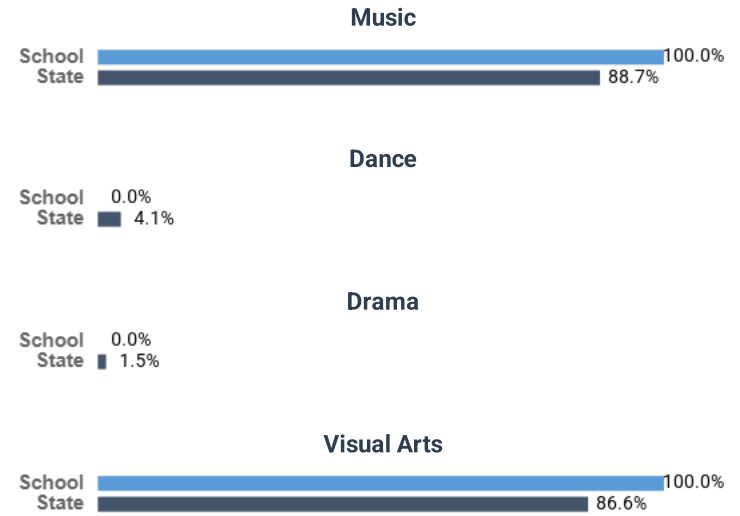

Students enrolled in one or more classes by discipline:



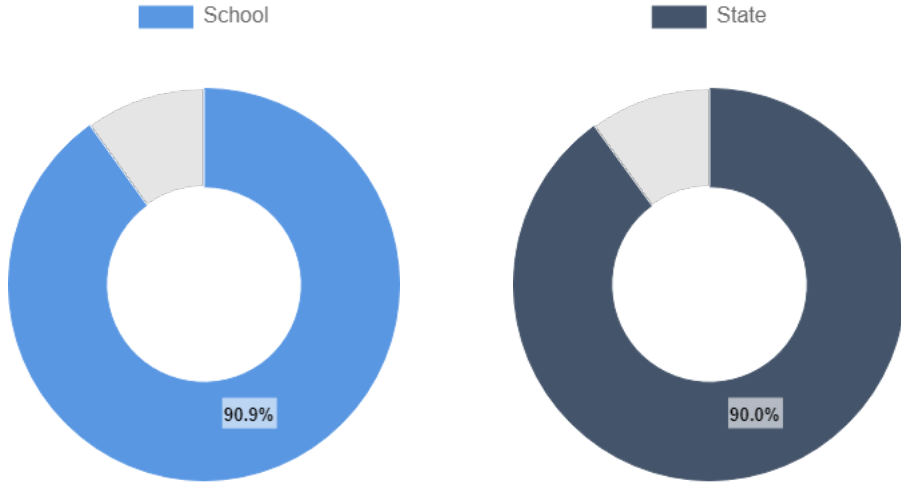

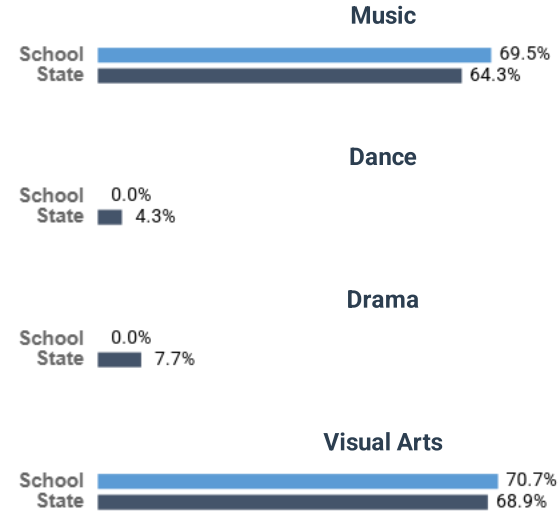

Students enrolled in one or more classes by discipline:



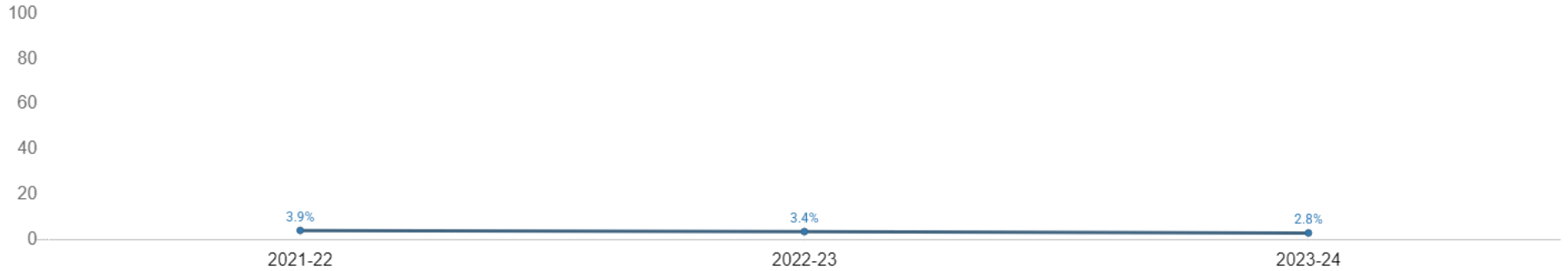

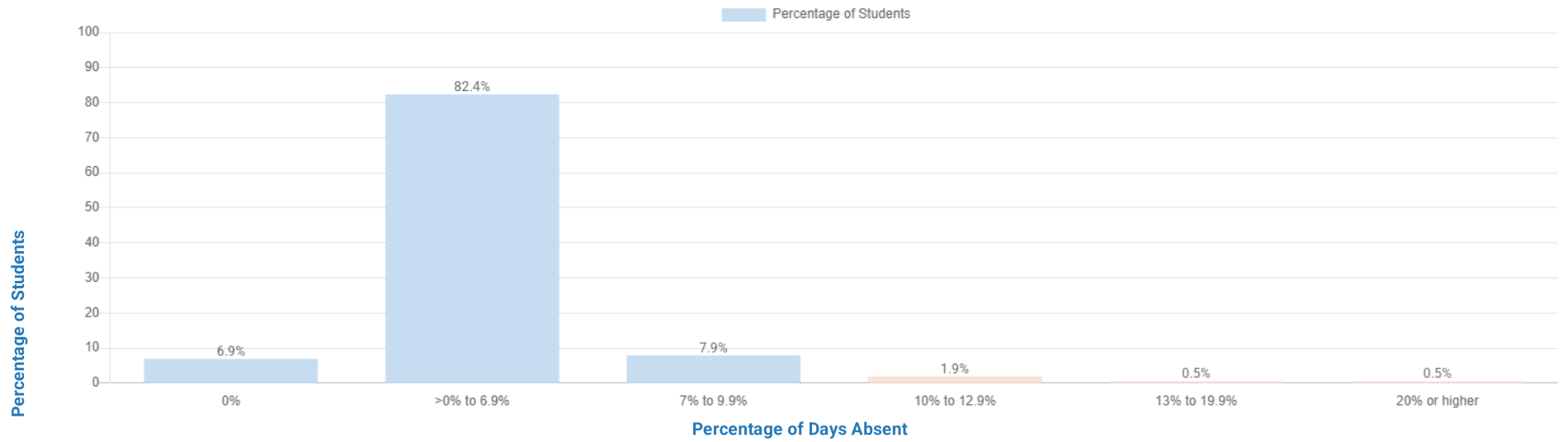

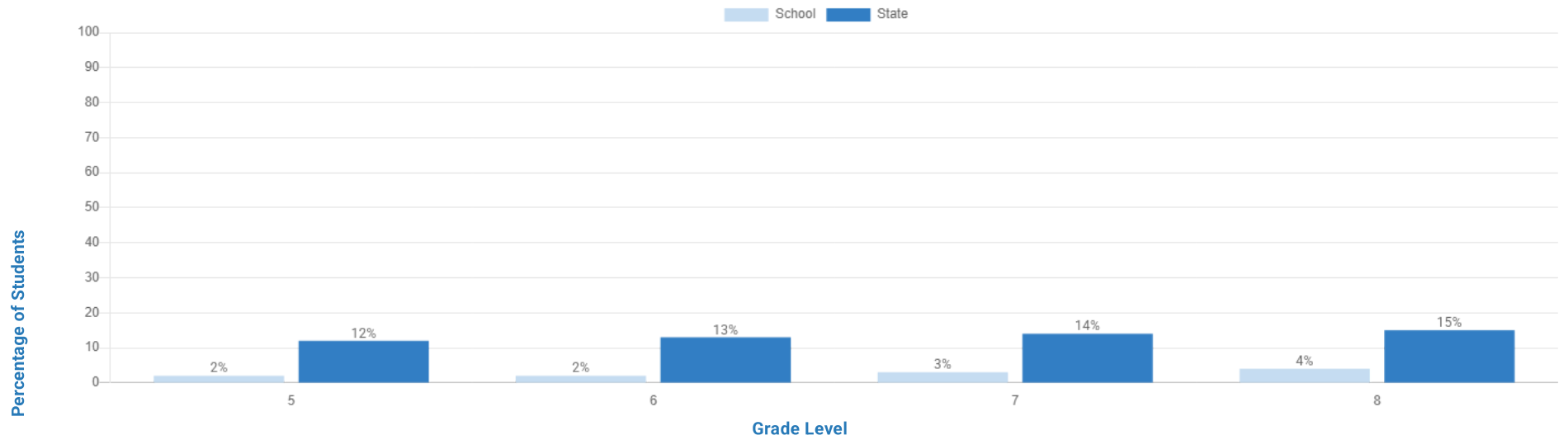

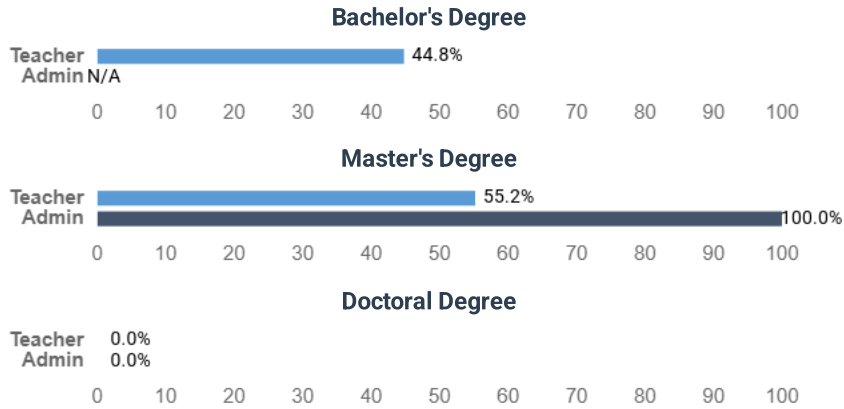

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The District employs a rigorous curriculum including coursework, co-curricular activities, and board approved educational experiences. Through an ongoing review and commitment to the mission of meeting the diverse and unique needs of our students the curriculum in each core discipline is guided by a unifying framework that justifies and gives direction to daily instruction. Students engage in conferencing, peer review, claims-evidence-reasoning, inquiry-based learning, real world experiences and compelling questioning throughout their courses. Every student at Mountain View participates in the Enrichment through Extension and Exploration (EEE) program consisting of standards-driven, core connected courses that integrate 21st Century Skills and standards and explores potential cross-curricular opportunities. EEE also affords time for remediation, reinforcement, and small group learning opportunities to support student growth.



Sports and Athletics:

Mountain View offers Boys & Girls Soccer, Cross Country, Boys & Girls Basketball, Baseball, Softball, and Boys & Girls Lacrosse. Recent championships include Cross Country and Girls' Soccer.

Mountain View Middle School implements a teaming structure, a middle-level best practice. Students at each grade level share the same Language Arts, Social Studies, Science, and Mathematics teachers. Students follow a 7 block schedule, which contains 6- 53 minute Core and Related Arts courses. In addition, all students participate in an Enrichment through Exploration and Extension block, which provides opportunities for extension and enrichment of the core curricula. Finally, students participate in monthly Advisory activities to promote a positive school climate, sharpen conflict resolution skills, and increase upstander behavior. Throughout their four years at Mountain View, students are supported by their academic teams, Guidance Counselor, and student support services. Our re-designations as a New Jersey School to Watch is further evidence of Mountain View's continuous and dynamic implementation of academic and social/emotional practices that support middle level learners.
