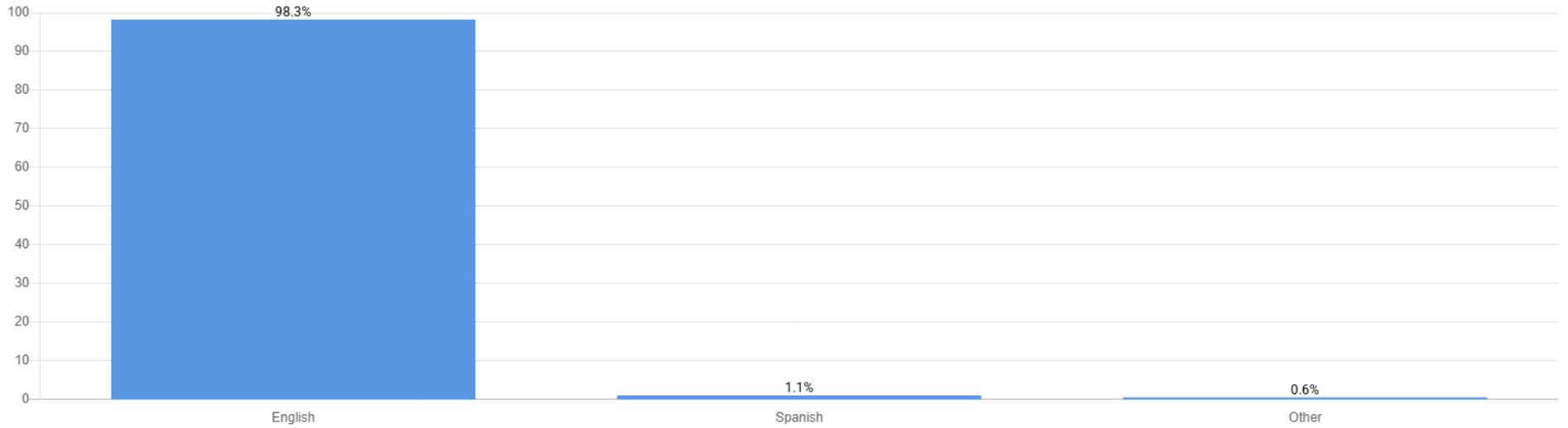

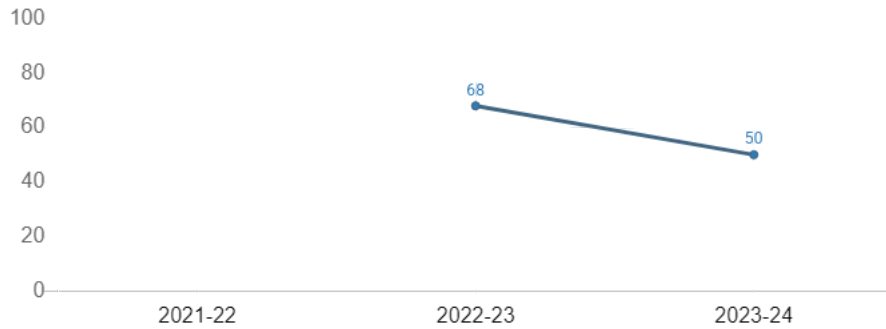

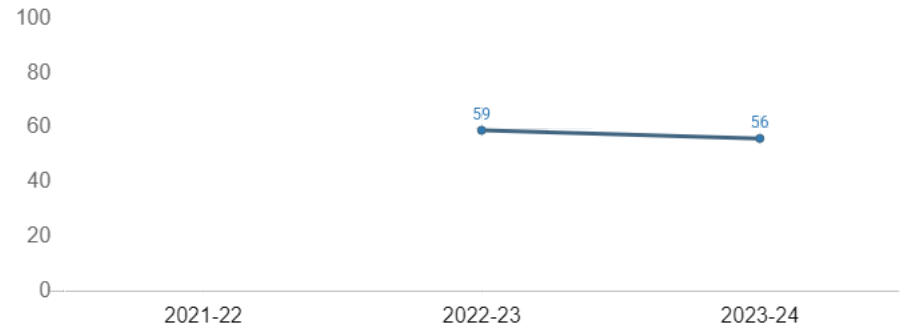

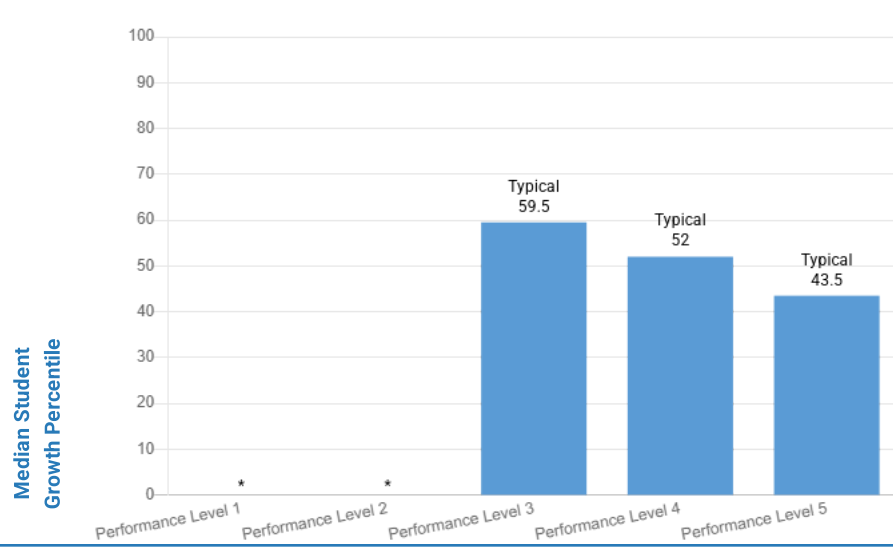

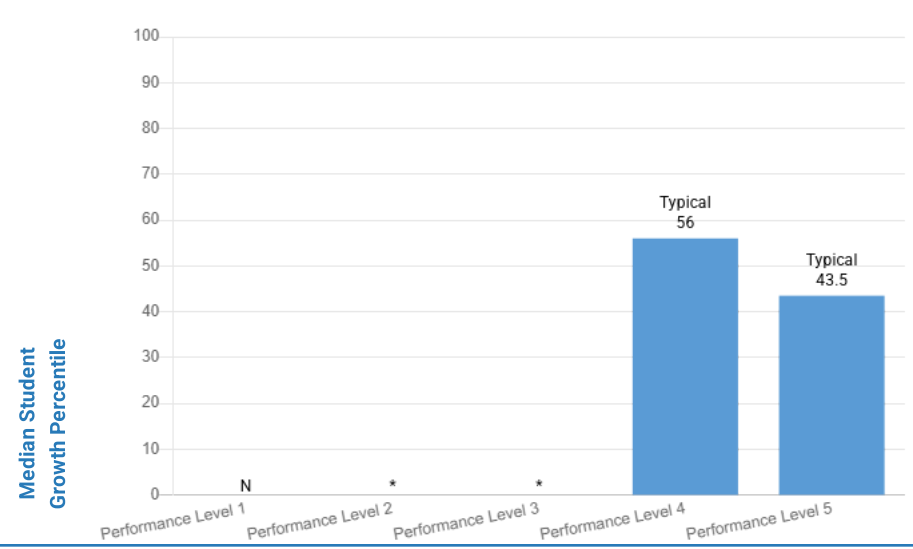

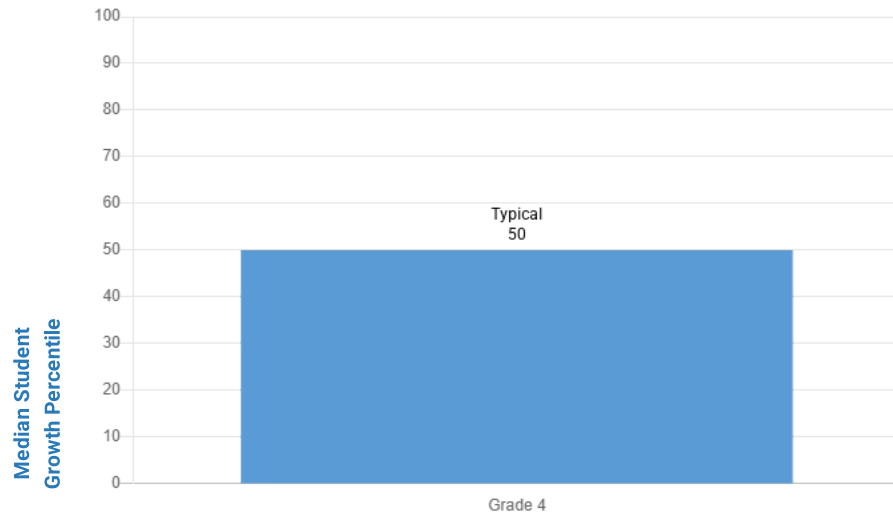

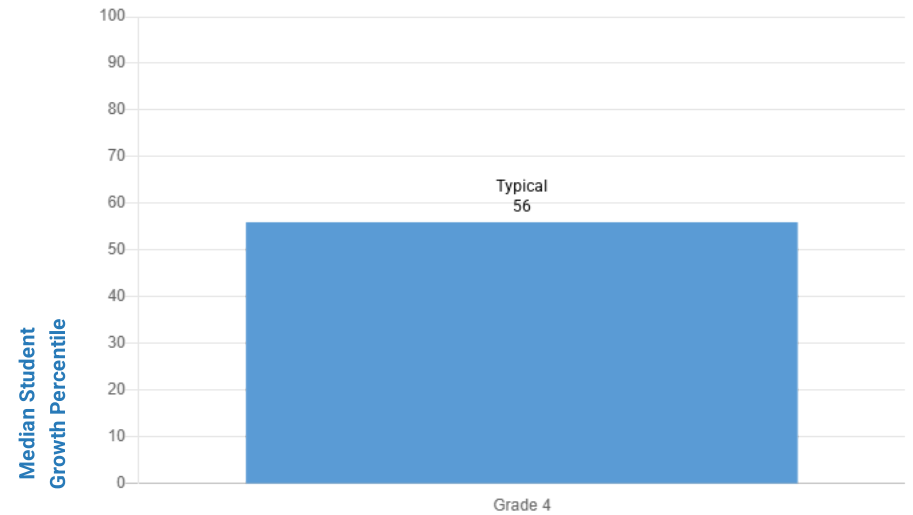

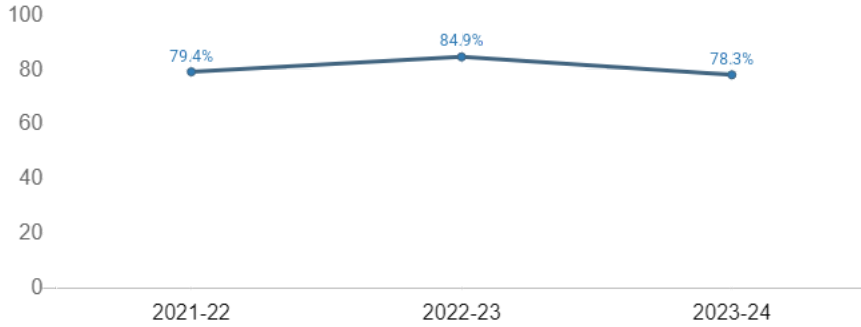

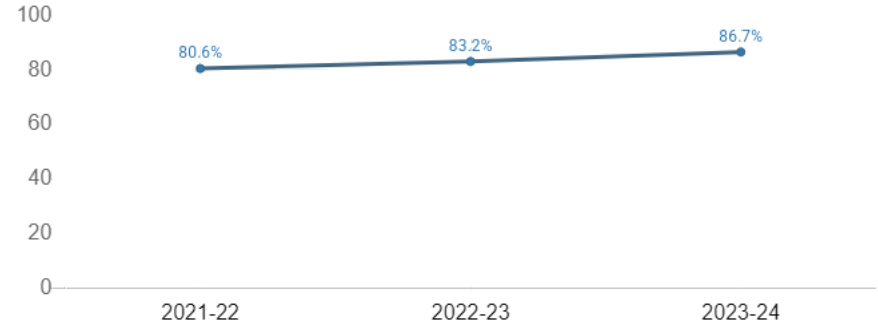
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 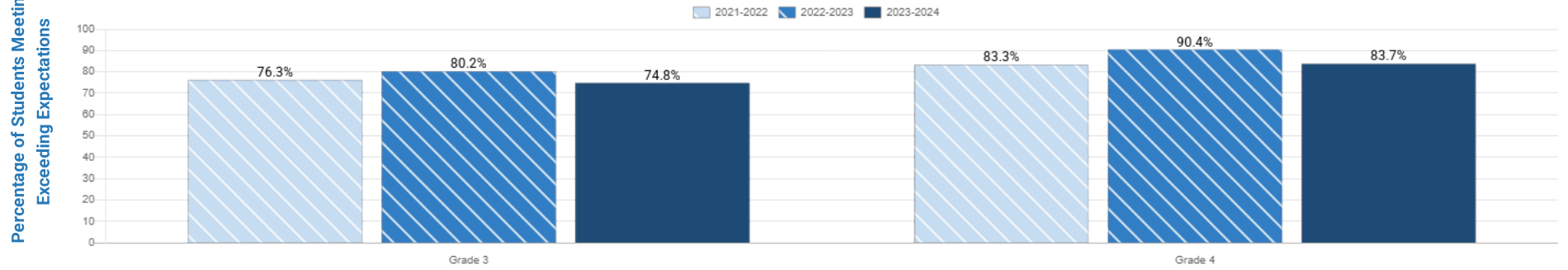

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

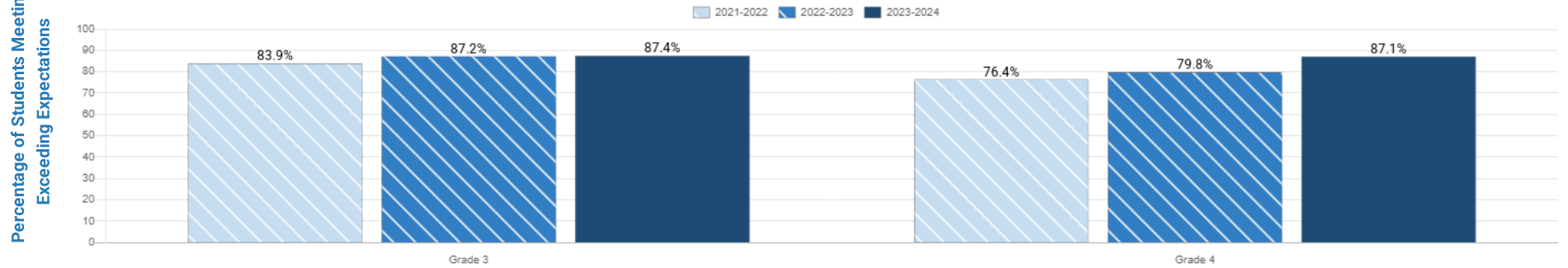

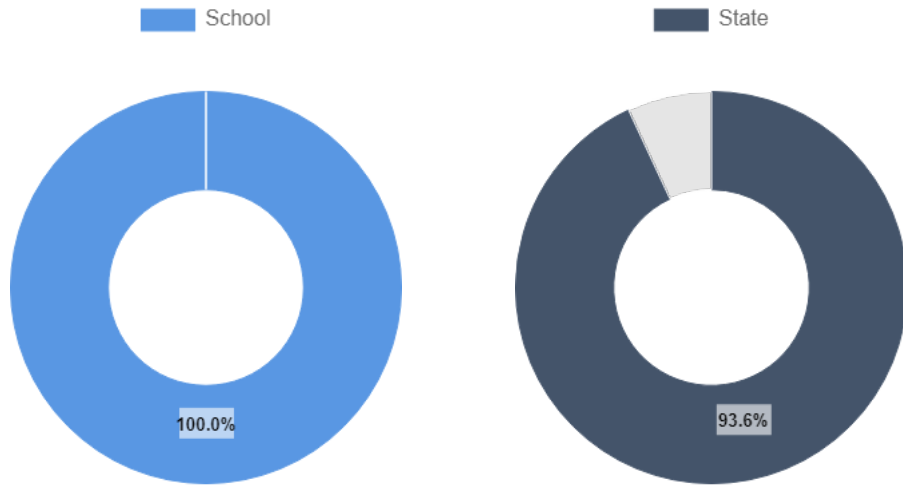

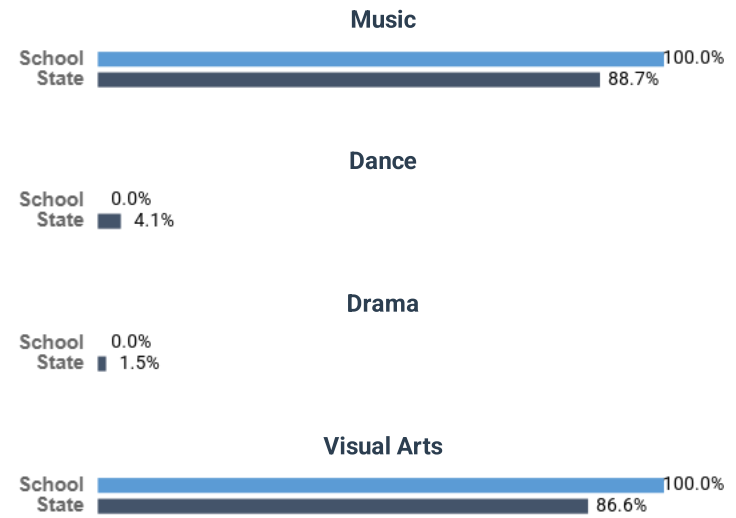

Students enrolled in one or more classes by discipline:



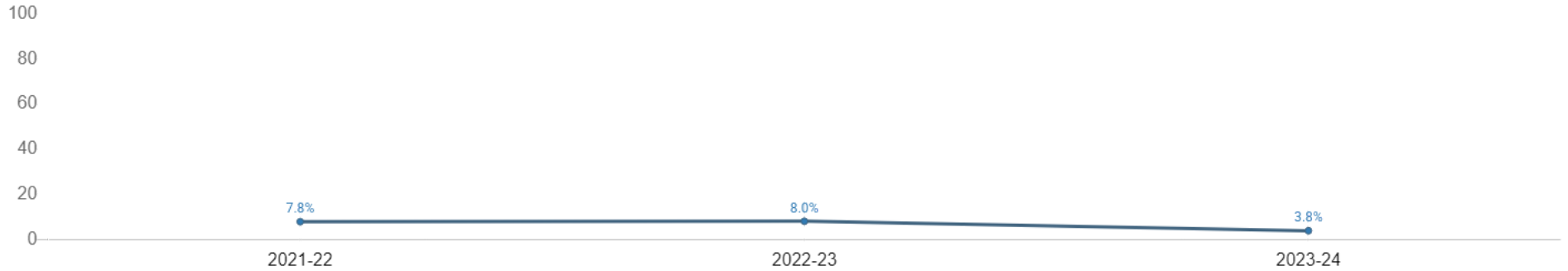

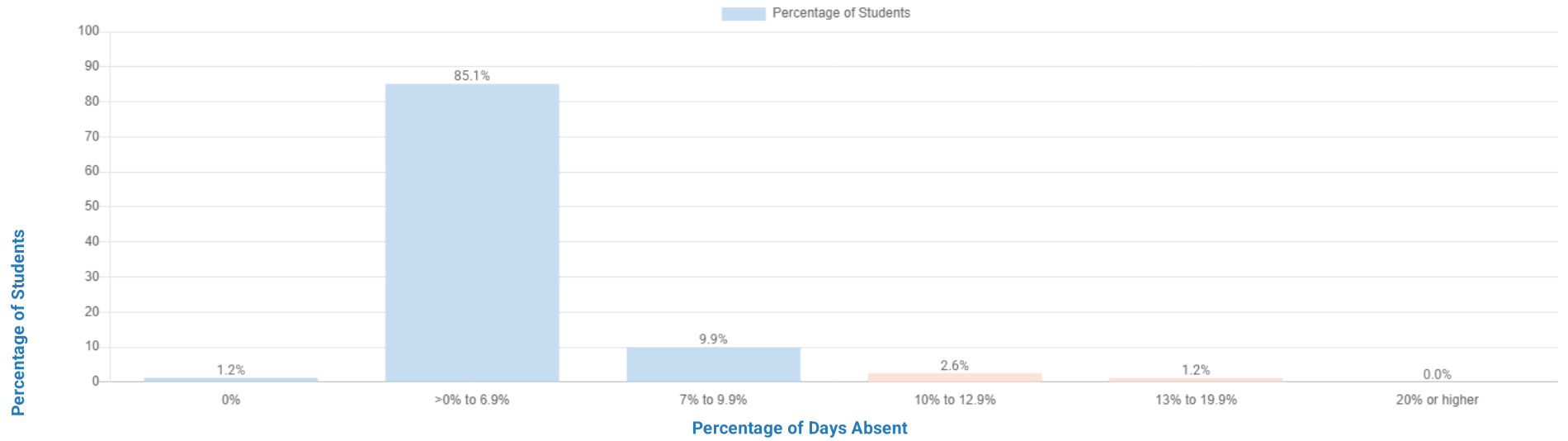

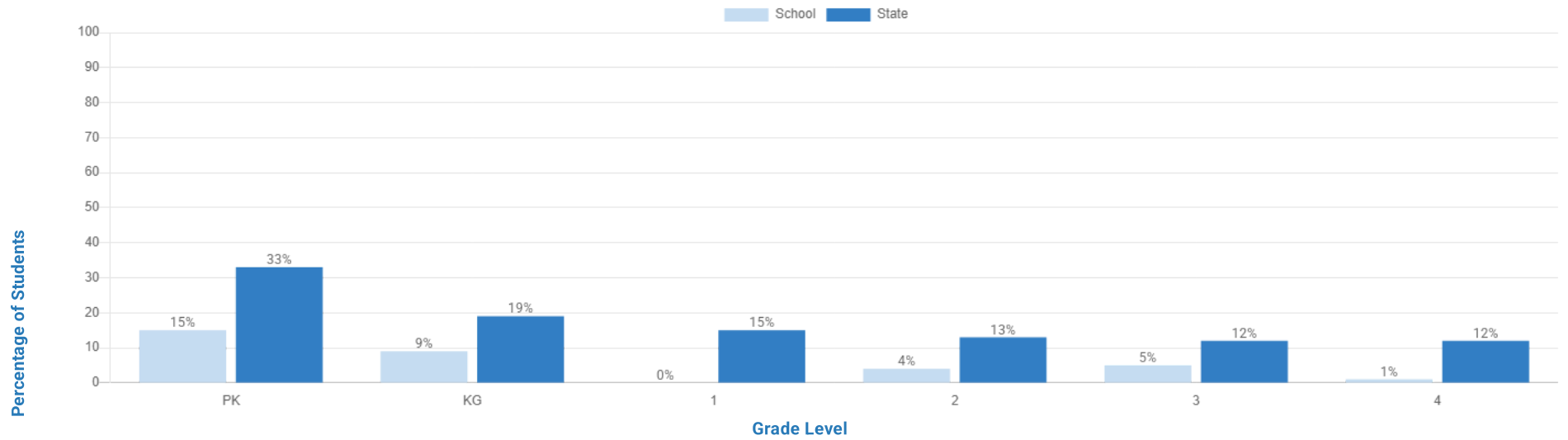

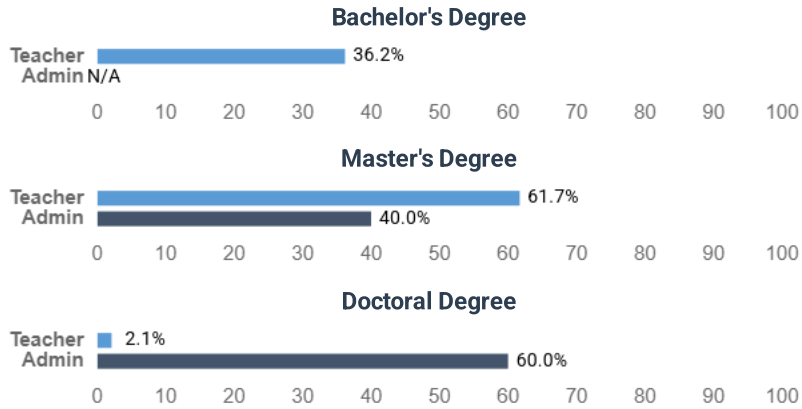

Courses, Curriculum, Instruction:

The school uses a knowledge- and content-based ELA curriculum that aligns with the science of reading, combining skill development with rich content to foster both strong reading abilities and a deeper understanding of the world. By prioritizing background knowledge, the curriculum enhances reading comprehension and encourages lifelong learning. The research-based math program emphasizes deep conceptual understanding, blending discovery, direct instruction, and interactive activities. It balances conceptual knowledge, procedural skills, and real-world application, encouraging students to engage with math through problem-solving and collaborative learning. Formative and summative assessments are used to track student progress toward learning goals and standards. In addition to core academics, students have access to enrichment and accelerated study in both ELA and math. Related arts offerings include art, music, physical education, STEM, library, and world language.



Clubs and Activities:

MTES offers a variety of enrichment opportunities that foster student leadership, creativity, and academic growth. Our students can participate in the MTES Tiger Safety Patrol and Tiger Leaders, where they develop leadership skills while contributing to the school community. Clubs like the Masterminds Writing Club, Art Explorers, and Advanced Artists allow students to explore their artistic and writing talents, while the MTES Band & Strings and Tiger Chorus offer musical enrichment. Additionally, students can engage in academic and recreational clubs such as the Quest, Homework Club and Chess Club, promoting teamwork, critical thinking, and personal development. These opportunities help students grow both inside and outside the classroom. Students may also participate in our Advanced Artists and Art Media Program.

MTES fosters a collaborative environment where teachers actively share ideas and lead innovative initiatives. With 95% of the teaching staff holding advanced degrees, the district prioritizes professional growth by dedicating full and half days each year to professional development and Professional Learning Community (PLC) meetings. These opportunities focus on enhancing teaching practices and student outcomes through book studies, research, and the refinement of instructional strategies. Teachers also engage in two collegial visits annually as part of their Professional Development Plan.



Student Supports and Services:

Mendham Township Elementary School provides a wide range of educational services to students in need of additional academic support. Students with special needs are serviced through the multidisciplinary Child Study Team. Our Early Intervention Preschool serves children ages 3-5 in an inclusion classroom setting. Resource and In-Class Support services are available for eligible students K-4. Supplementary instruction is provided in our Learning Lab Program for math and ELA.

The Elementary School has a Technology Lab and a Makerspace. Formal computer education begins as early as Kindergarten and continues through grade 8. Students are provided with Chromebooks starting in grade 1. Student in grades Prek-4 participate in weekly STEM classes. Additionally grades 3 & 4 attend Makerspace weekly. The MTSD has stayed on the cutting edge of new technologies for education introducing wireless laptops, Smartboards, podcasting, blogging, an informative website, and many other technologies that enhance our student's education. Every classroom in the district is equipped with a Smartboard.

Early childhood education improves the emotional, social and physical development of young children. Our high quality, developmentally appropriate programs positively affect children's cognitive abilities and social development.
