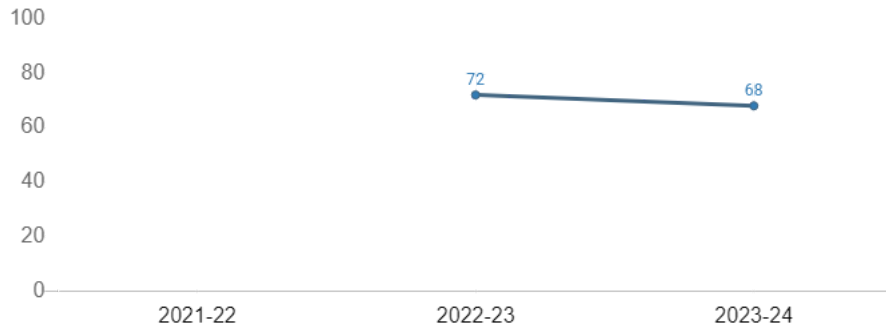

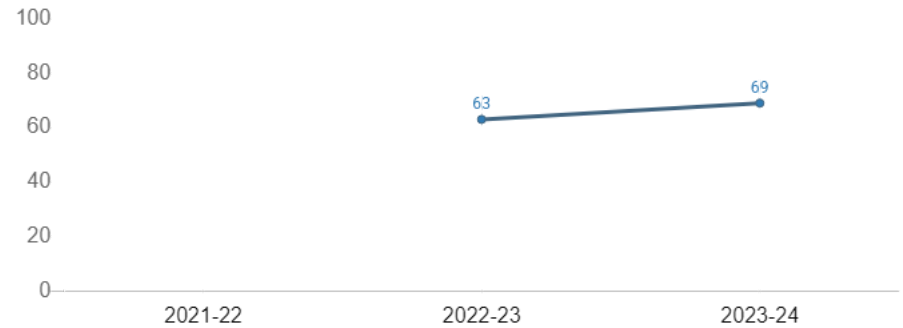

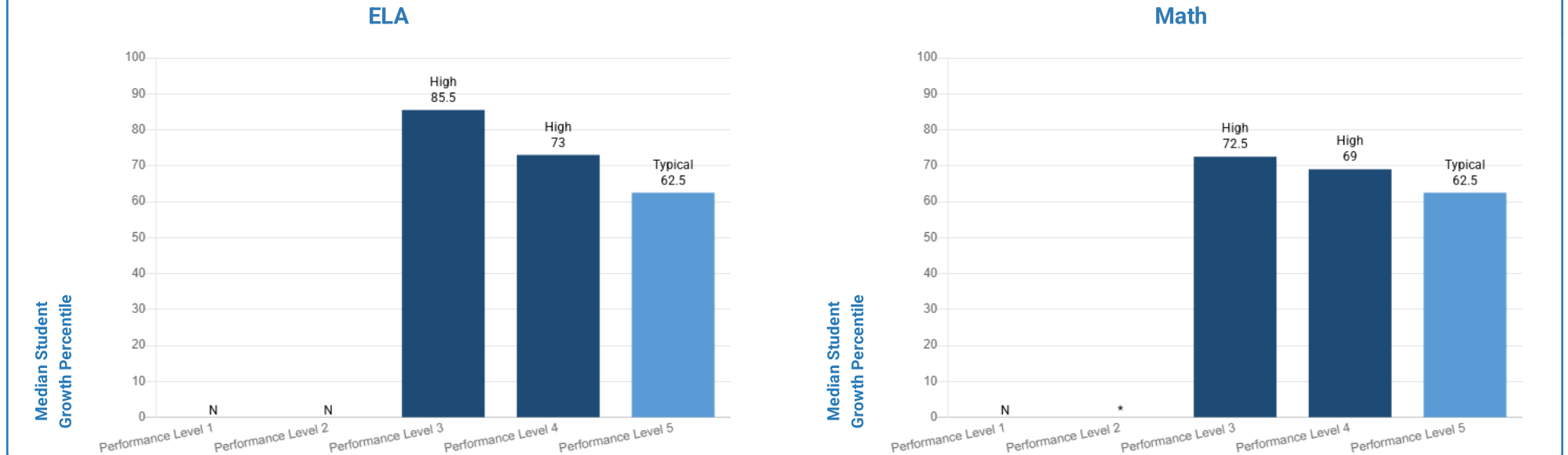

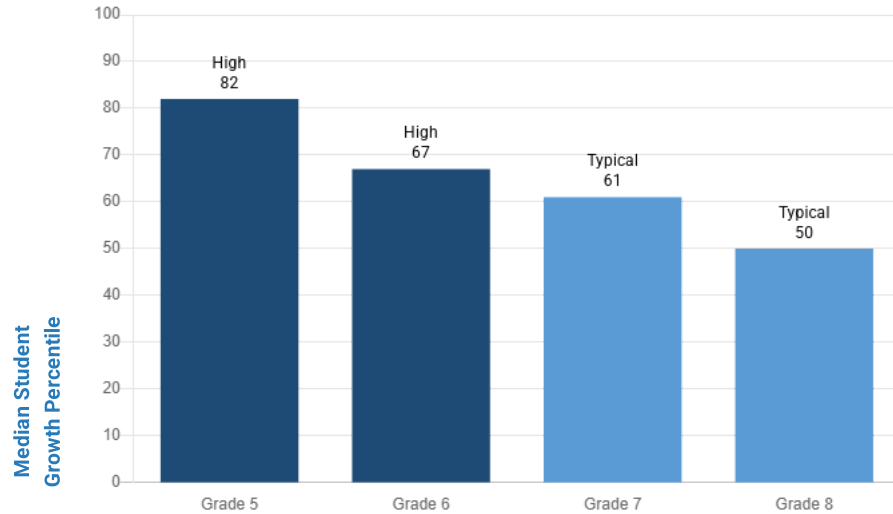

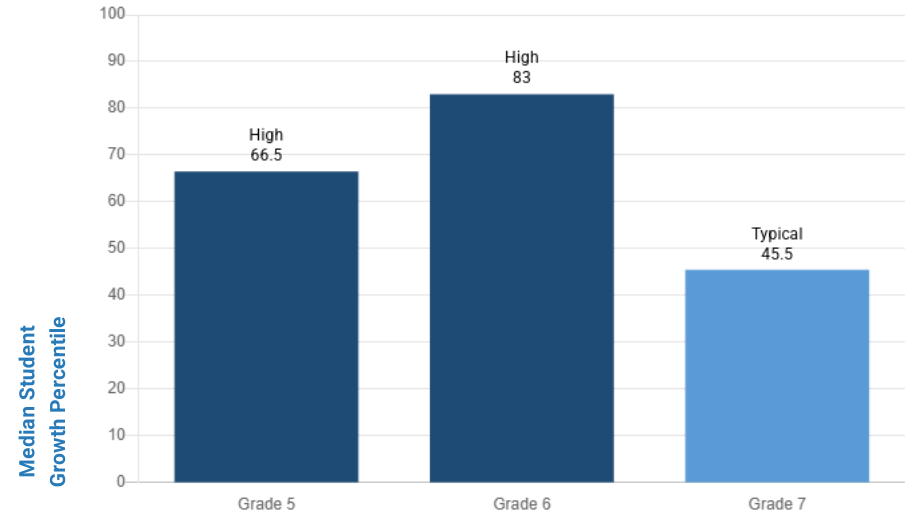

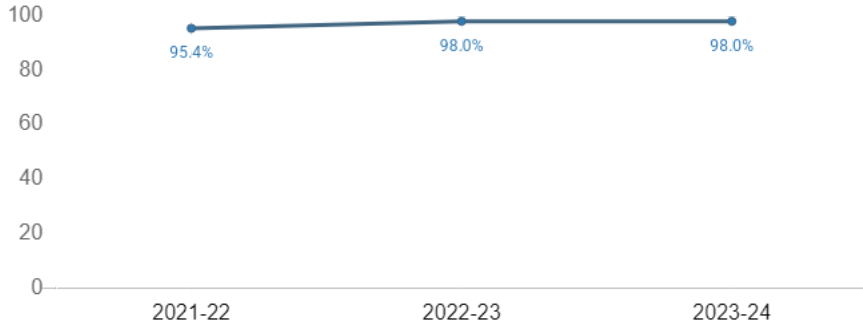

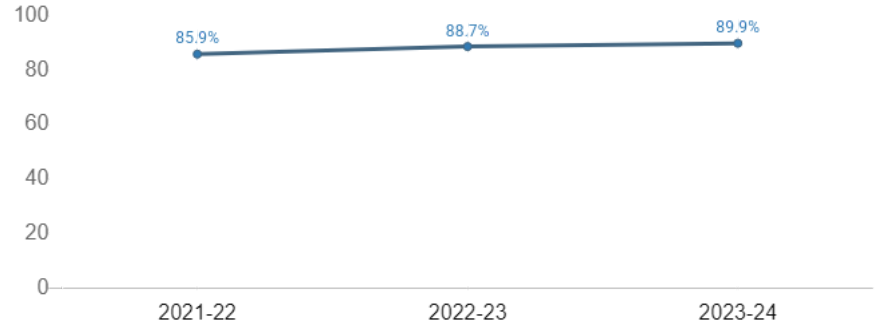
English Language Arts and Mathematics Performance Trends

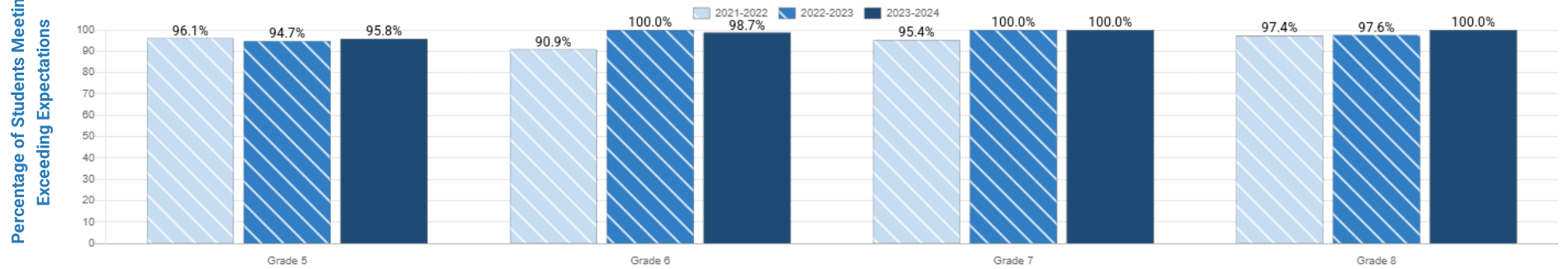

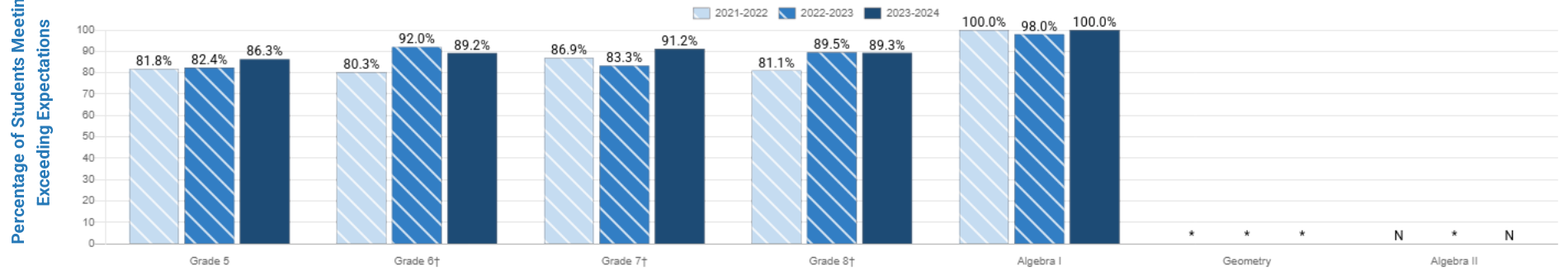

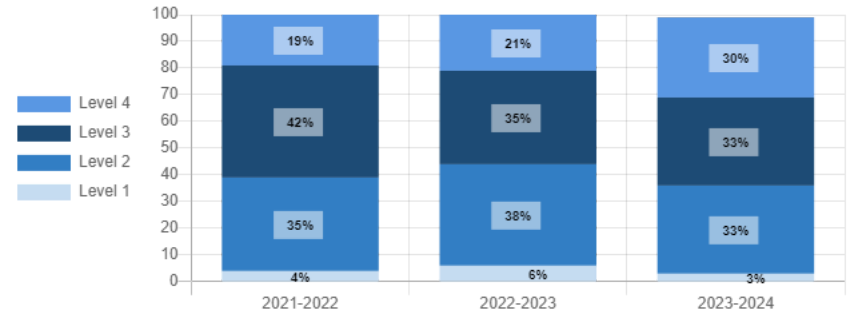

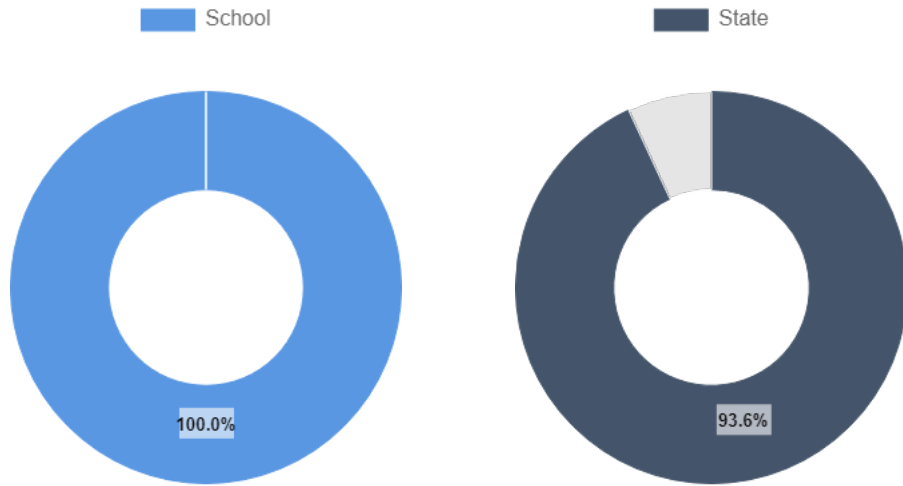

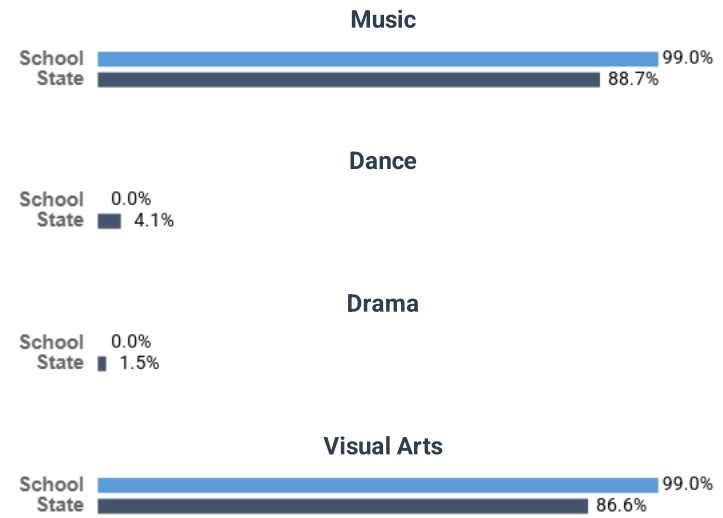

Students enrolled in one or more classes by discipline:



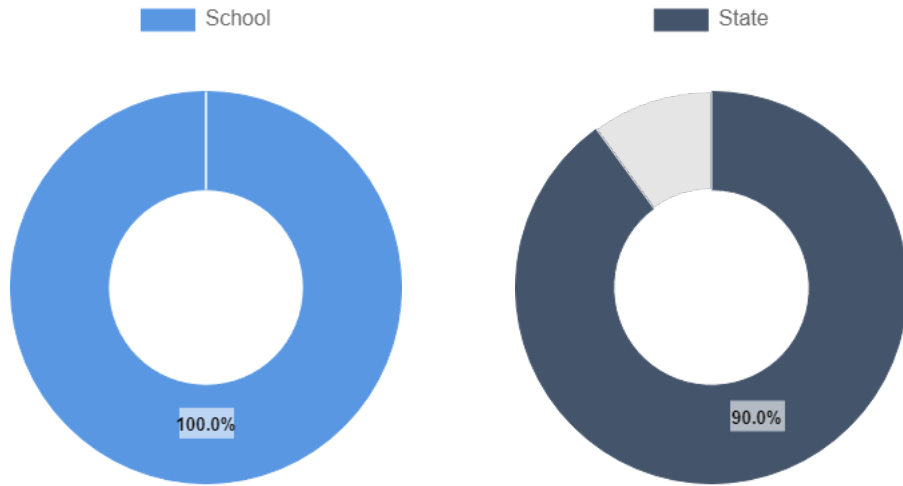

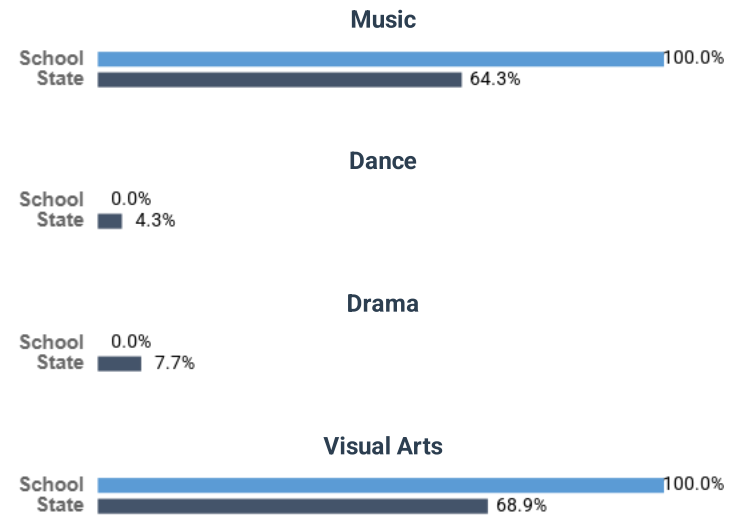

Students enrolled in one or more classes by discipline:



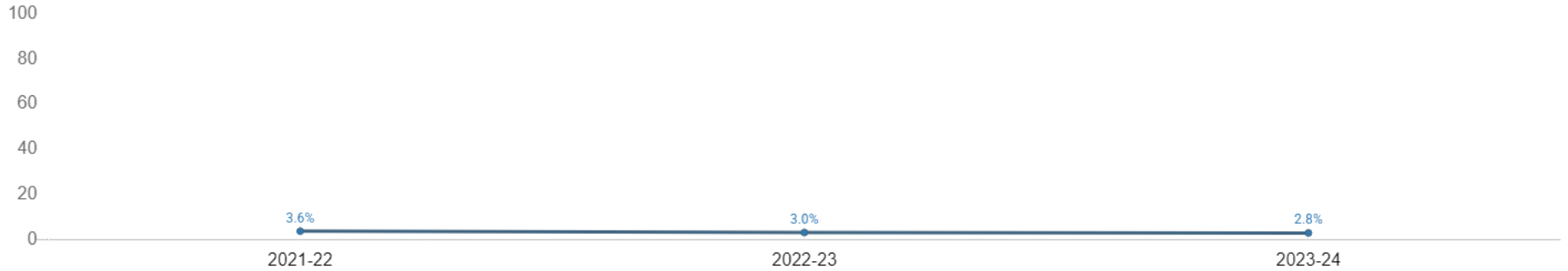

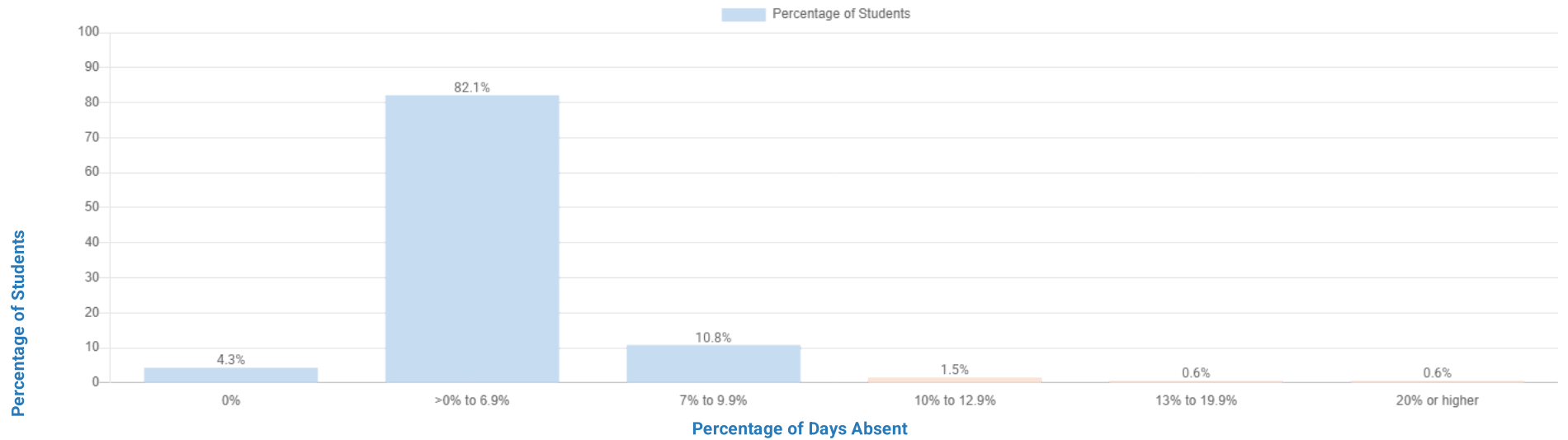

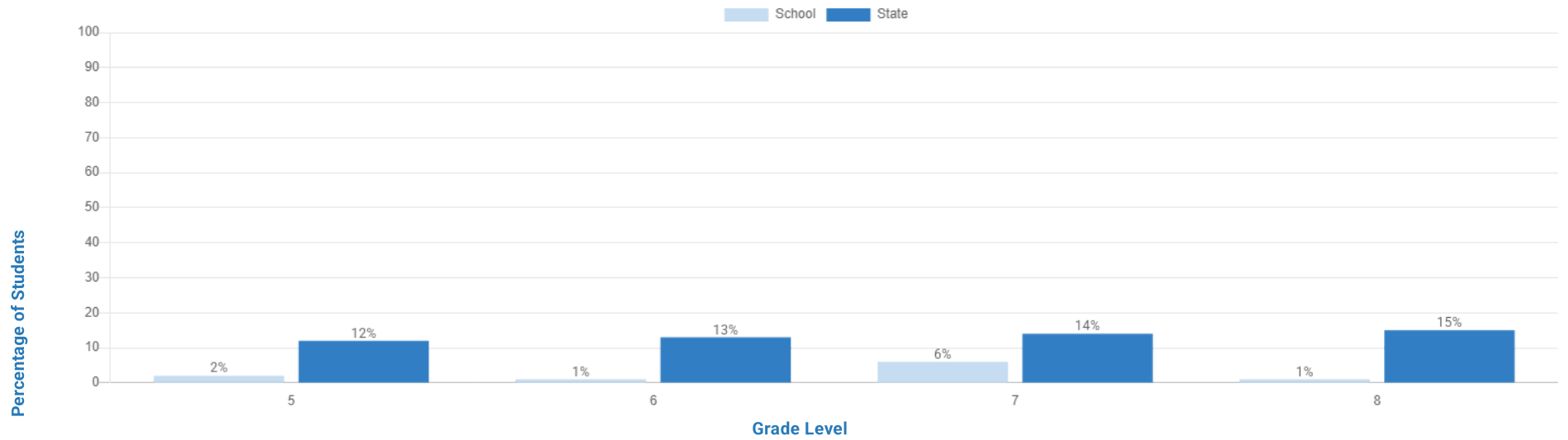

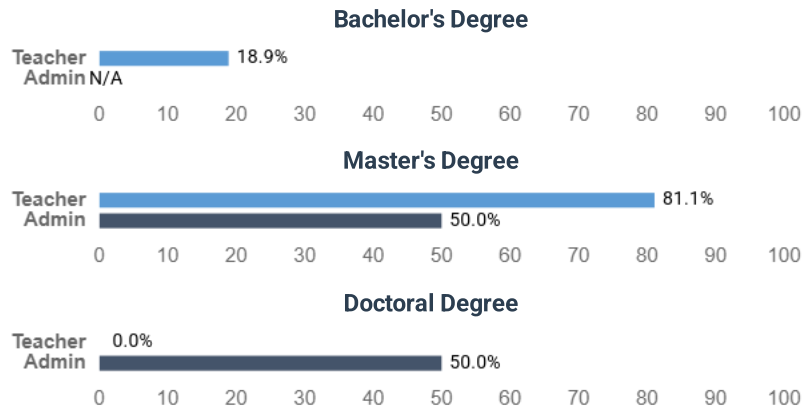

Accountability Summary by Student Group - 2023-24 School Year

Before and After School Programs:

Three days per week, MTMS offers an afterschool homework club, where students can work quietly under the supervision of a teacher. There is also a daily afterschool math lab period for those who wish to get extra help - there is even a nightly virtual extra help math class. Before school, MTMS boasts zero period programming that includes band, orchestra, chorus, art, math, English, and writing courses. The district demonstrates commitment to zero period programming by providing busing for all zero period participants.



Staff and Professional Learning:

Professional Development opportunities for teachers may take many forms, ranging from mentoring, induction, external study for advanced degrees, and ongoing collaboration between faculty and administration. All MTMS teachers participate in formal collegial visits to learn from each other and grow as professionals. In addition to daily grade level team and department meetings, teachers meet monthly in small groups to study scholarly articles in the field of education.
