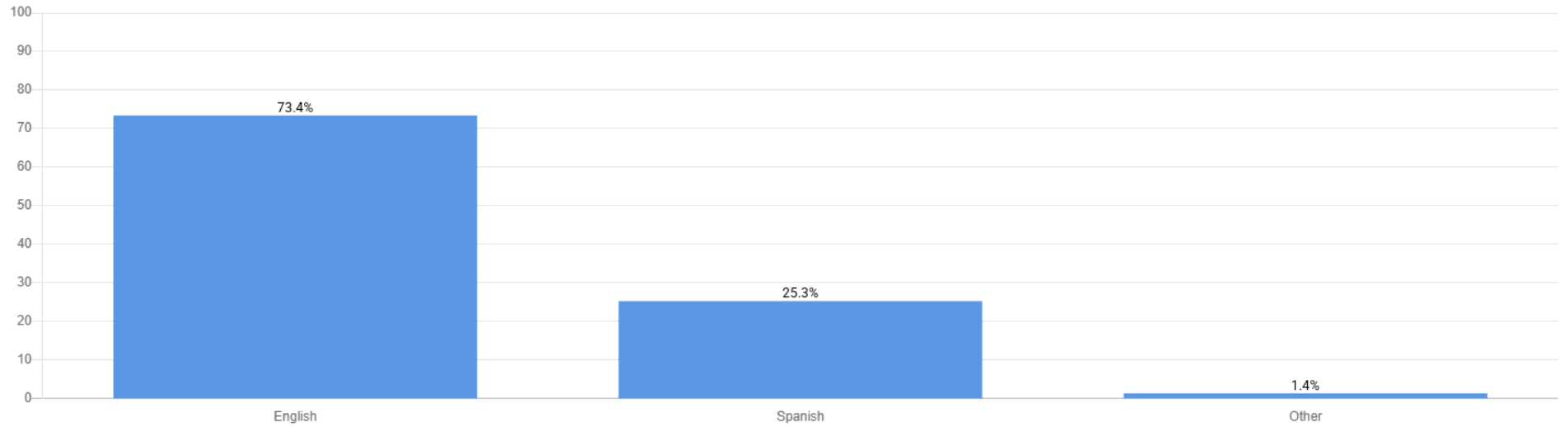

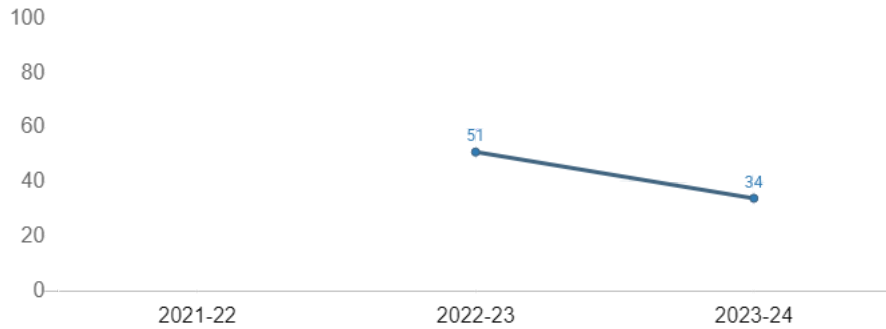

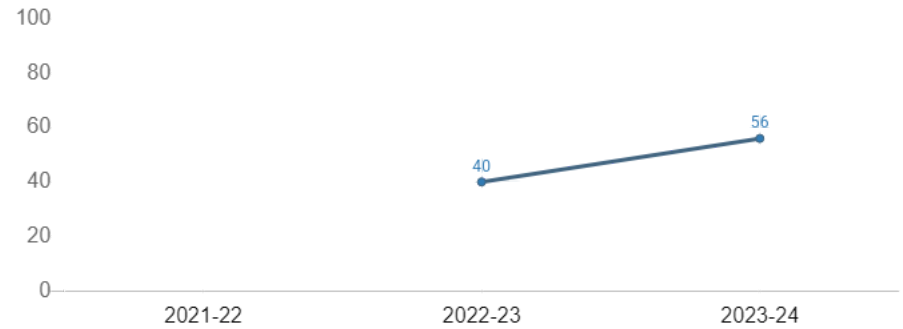

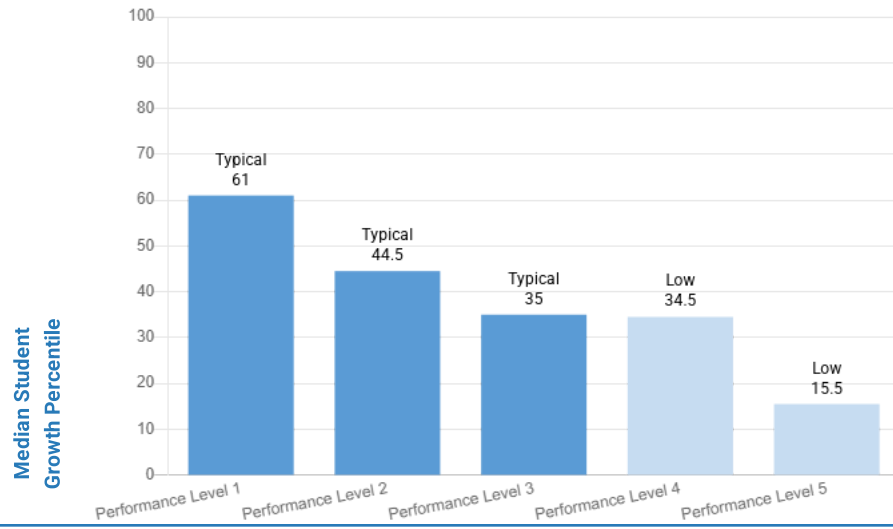

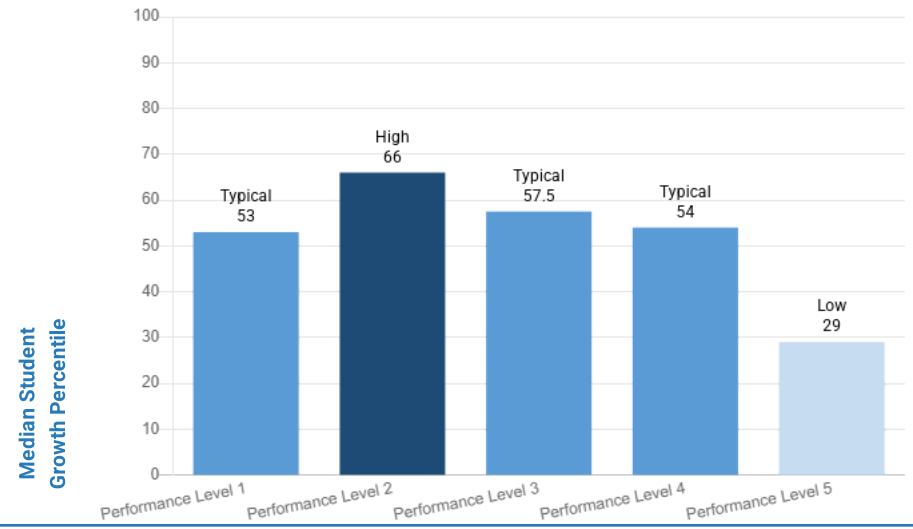

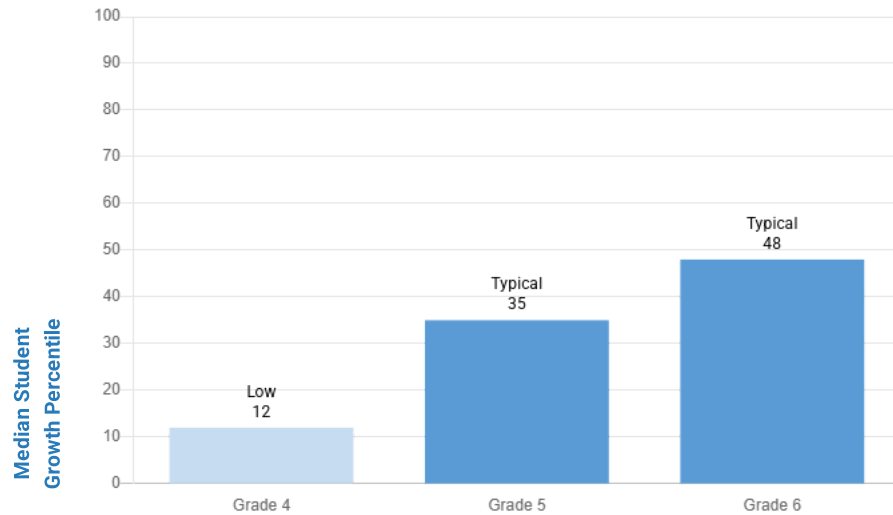

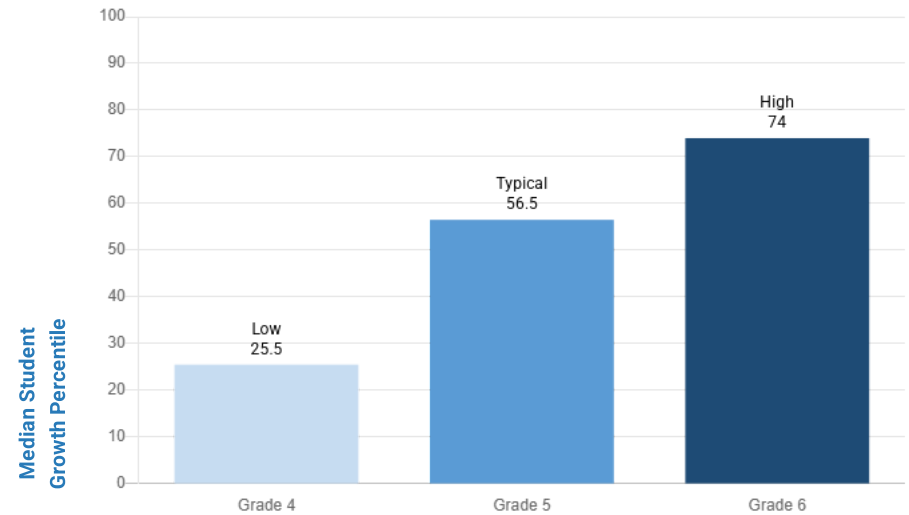

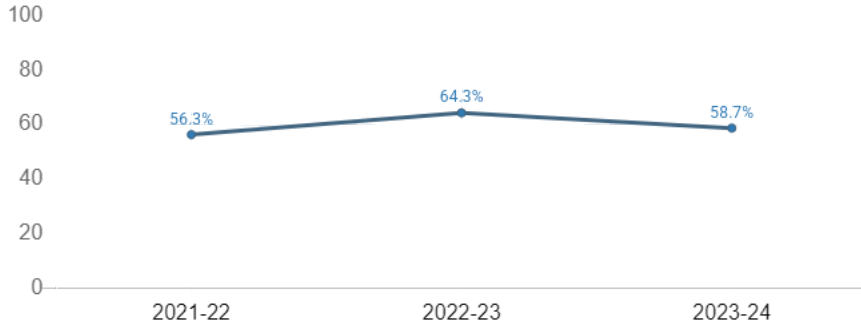

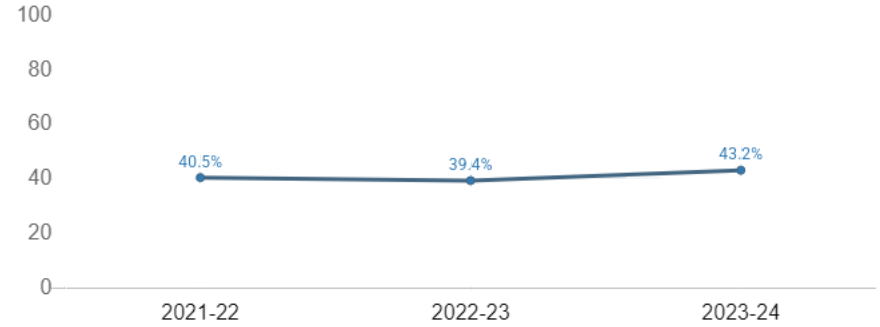
English Language Arts and Mathematics Performance Trends

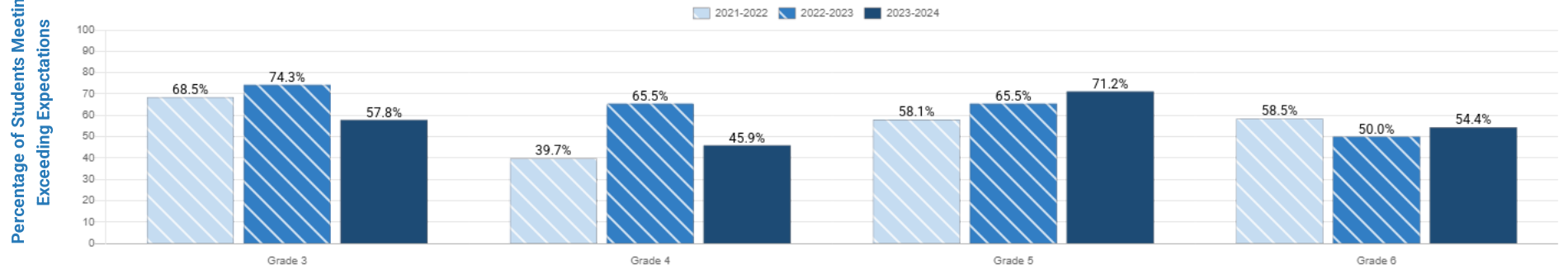

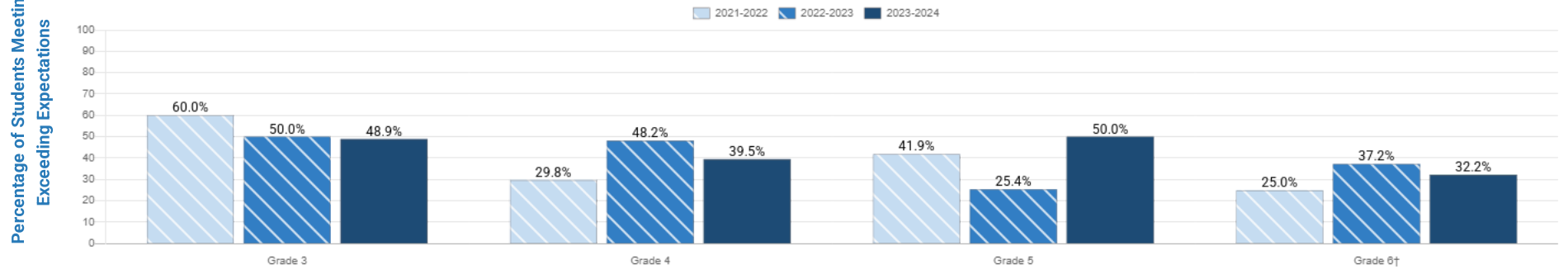

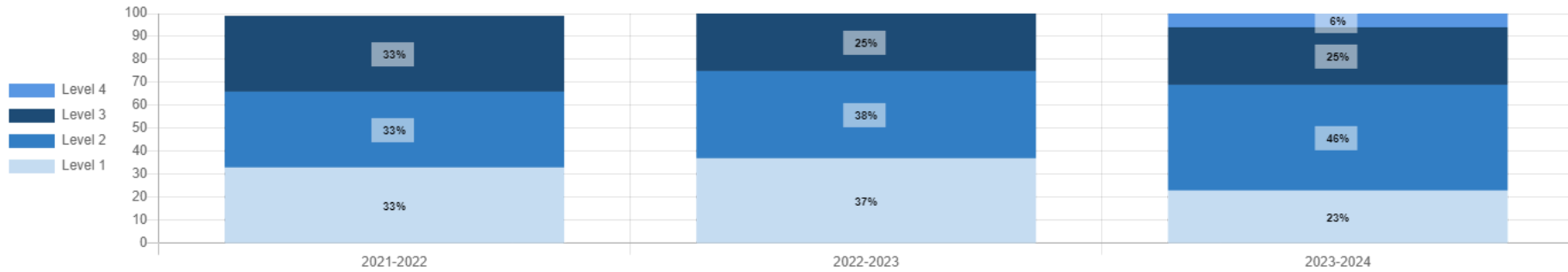

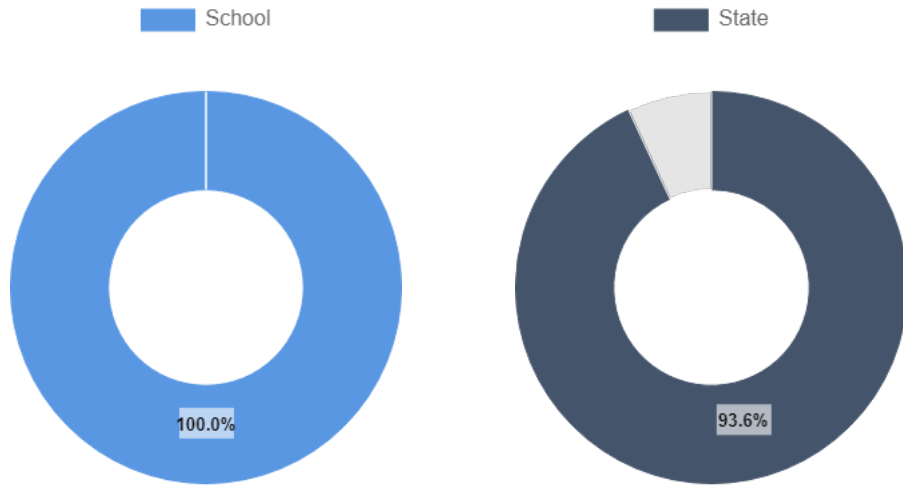

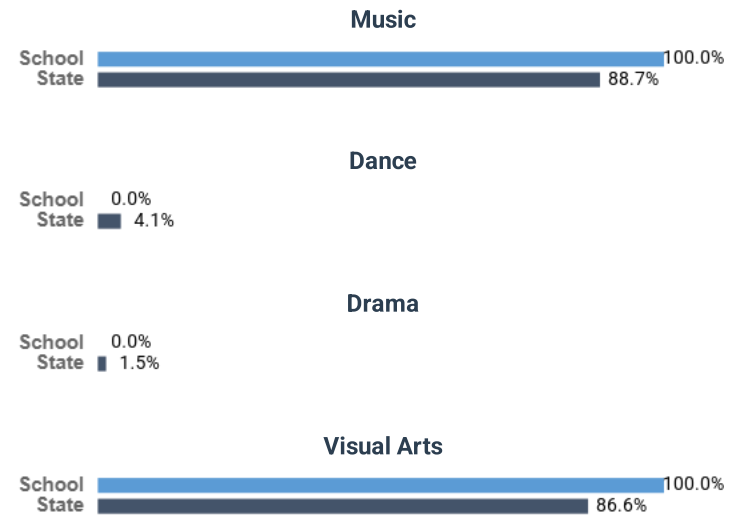

Students enrolled in one or more classes by discipline:



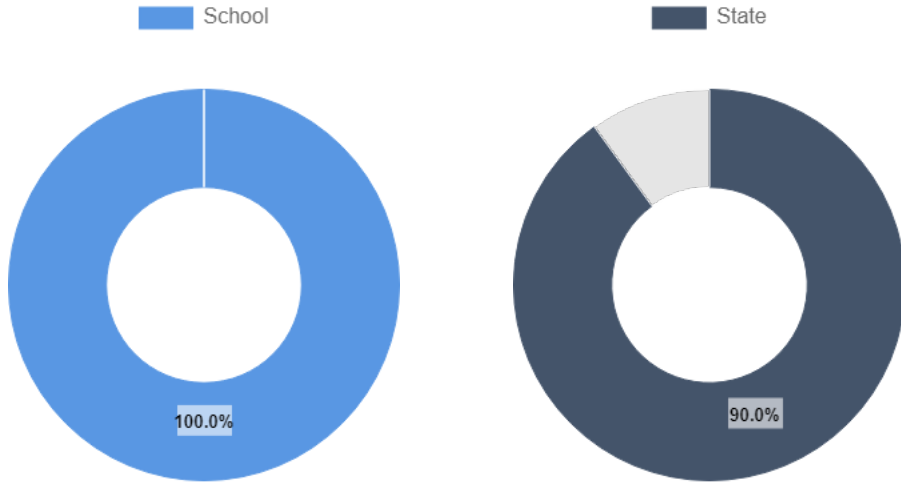

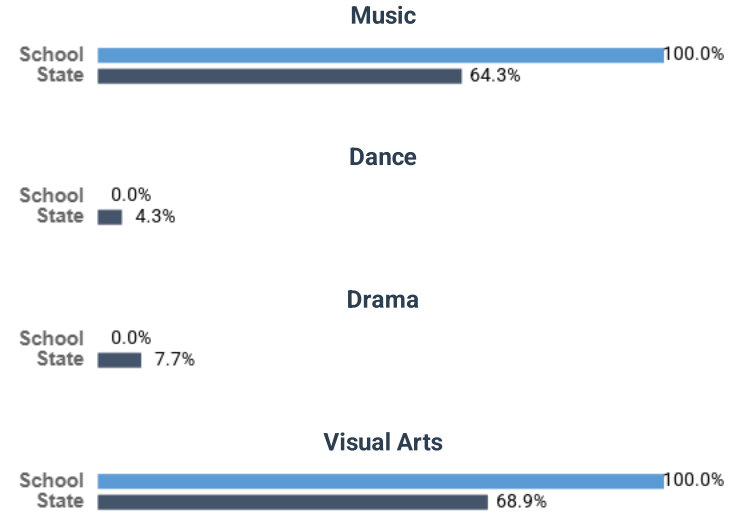

Students enrolled in one or more classes by discipline:



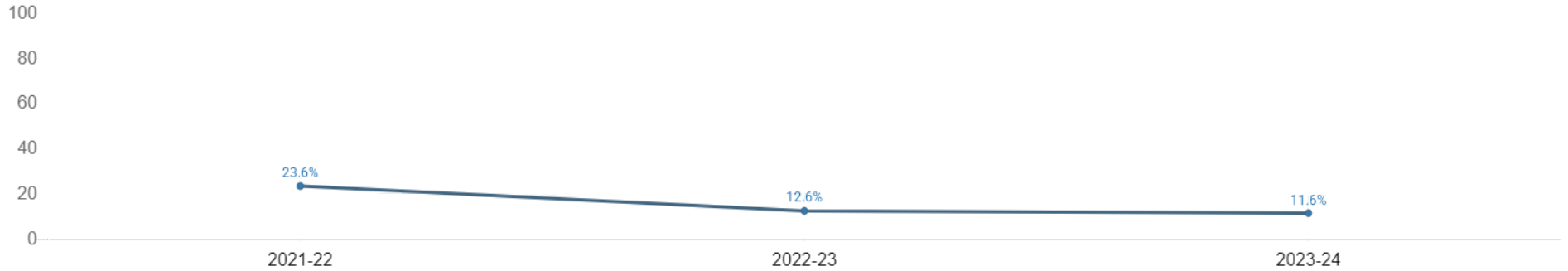

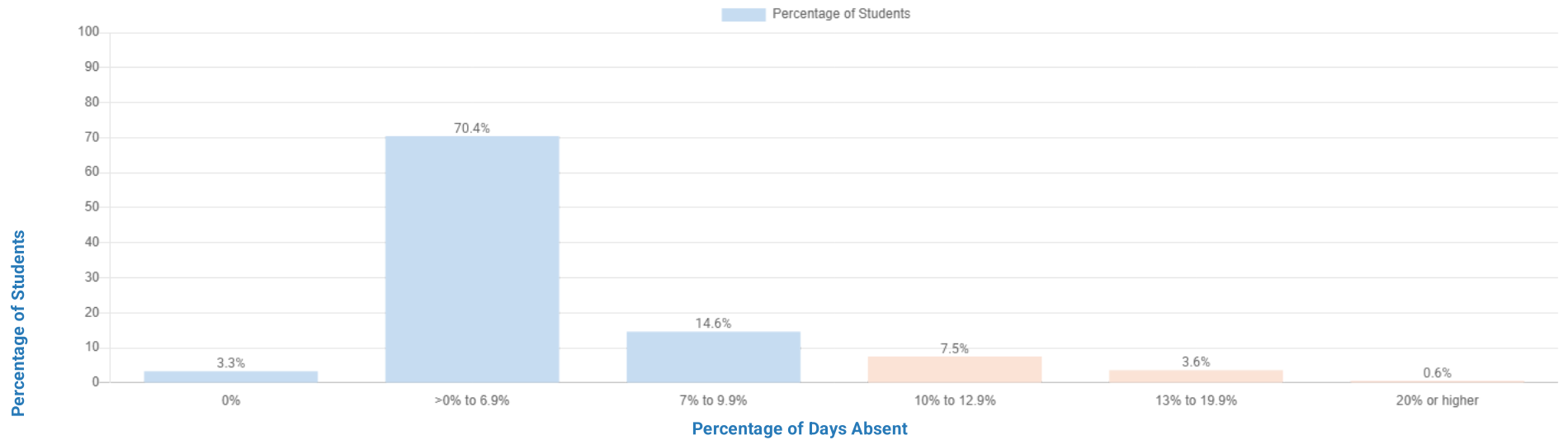

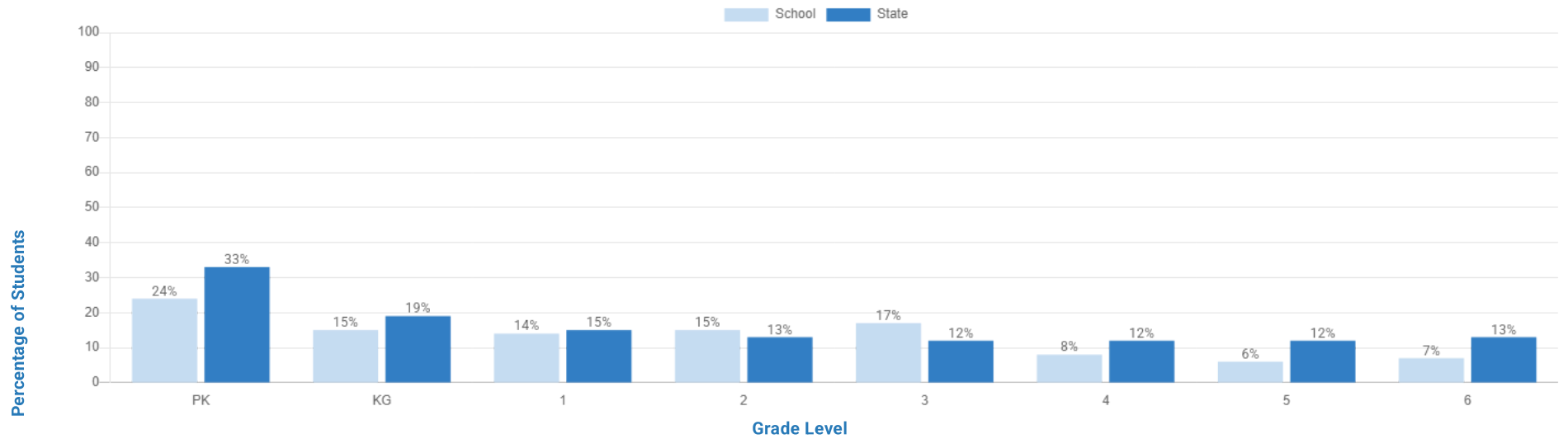

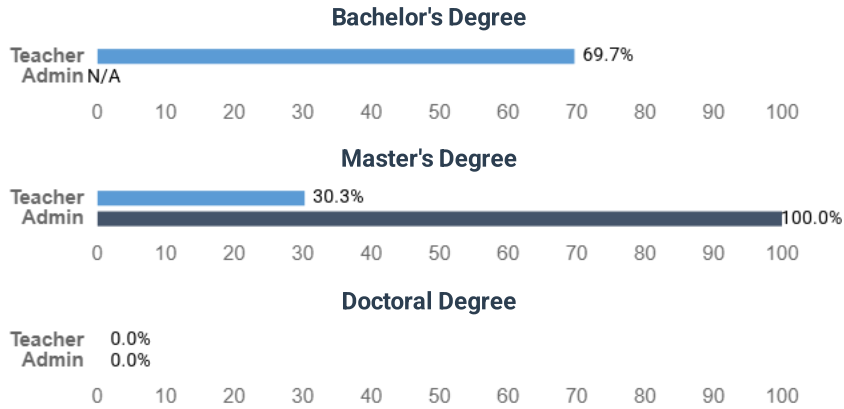

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Canfield Avenue School programs align with the New Jersey Student Learning Standards and Next Generation Science Standards, ensuring a rigorous education. Workshop models in Reading, Writing, and Math provide personalized instruction, alongside a Gifted and Talented program, tutoring, and multilingual learner support. The school features an innovative STEAM classroom, fostering creativity and critical thinking, and uses the Learner-Active, Technology-Infused Classroom (LATIC) model to promote student-driven learning. All students receive Chromebooks, accessing digital tools and platforms, while preschoolers benefit from the Creative Curriculum. Specials include Music, Multimedia, STEAM, PE, Health, Art, and World Language, creating a well-rounded learning experience.



Clubs and Activities:

Students at Canfield Avenue School can enhance their learning experience through a variety of after-school clubs that extend the curriculum and educational programs. The Mine Hill School District is committed to fostering professional growth and learning for its staff, offering a range of opportunities to enhance teaching practices and student outcomes. Many teachers have received training in the Learner-Active, Technology-Infused Classroom (LATIC) model, which emphasizes student-centered learning. Early Childhood Education:

The Mine Hill School District offers a high-quality preschool program funded through the state's Preschool Expansion program, providing FREE preschool for all resident 3- and 4-year-olds. To accommodate more students, the district partners with a private provider, ABC Growing Tree, in addition to its in-district classrooms. All preschool class sizes are capped at 15 students and include at least one certified teacher and one aide, ensuring individualized attention and support. The program utilizes the Creative Curriculum and the GOLD assessment program to deliver consistent, developmentally appropriate learning experiences across all classrooms. A dedicated Preschool Instructional Coach ensures that classrooms are equipped with top-quality materials and resources and provides professional training to preschool staff, creating an exceptional foundation for young learners.
