







# Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

With established articulation and dual enrollment programs, students can earn college credits as part of their high school program with Centenary University, County College of Morris, Fairleigh Dickinson University, Montclair State University, New Jersey Institute of Technology, Ramapo College, Rider University, Rutgers University School of Health-Related Professions, Seton Hall University and William Paterson University. Ninety-five percent of MCST full-time students go on to postsecondary institutions.

MCST provides an array of services to our student body. Students with disabilities have a dedicated child study team and are provided services per their IEPs. Certificated school counselors manage the implementation of 504 plans, in addition to providing counseling support and college and career guidance. Morris County School of Technology (MCST) offers two types of Career and Technical Education (CTE) programs for Morris County High School students. Academies are four-year, full-time programs combining comprehensive academics with career and technical education (academy) classes. Each individual full-time academy offers students a challenging CTE program of study and a rigorous academic foundation. While the New Jersey Department of Education mandates 120 credits for graduation, MCST's CTE program requires students to achieve a minimum of 150 credits, as well as complete a 120-hour Work-Based Learning Experience in a related career field in order to receive a high school diploma. The academy programs require students to work as members of a team, problem-solve, self advocate and use effective communication and presentation skills. Project-based, student-centered learning and authentic assessment are the primary instructional strategies to adequately prepare students to work in a global community. Share-time programs provide half-day specialized CTE training as part of a student's junior and senior year of high school. The share-time CTE programs offer opportunities for students to earn industry-recognized credentials which can lead to employment while also preparing students to succeed in a variety of postsecondary education options. One of the fifteen programs offered is for students with greater individualized needs requiring a smaller class size. All share-time students benefit from business and industry collaboration and a hands-on approach to instruction.
