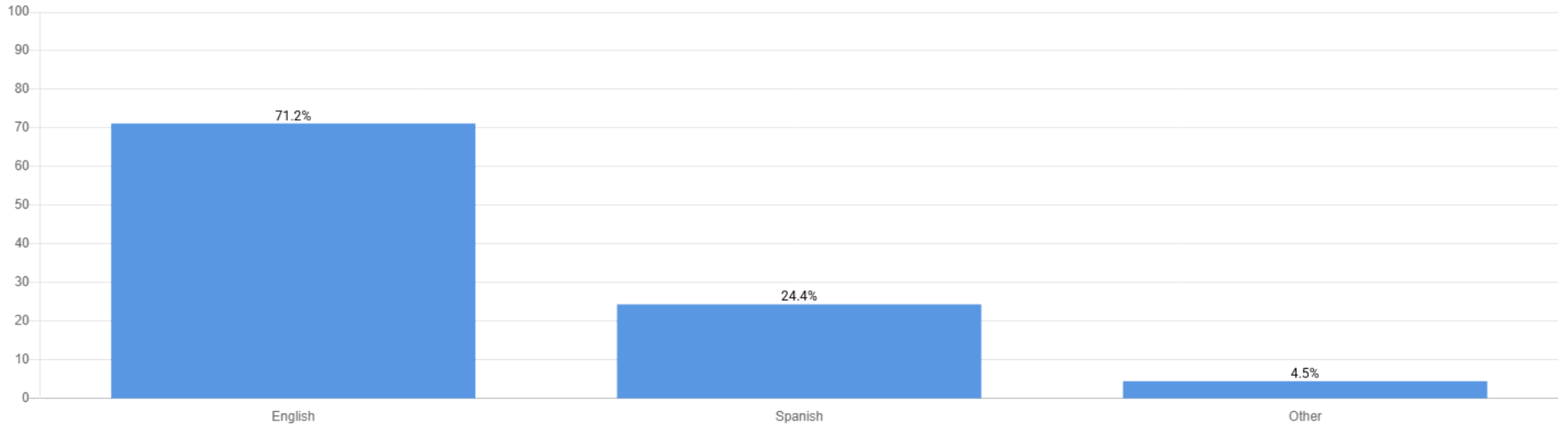

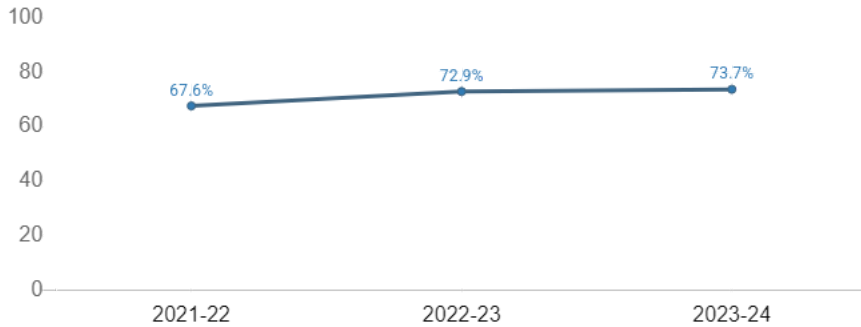

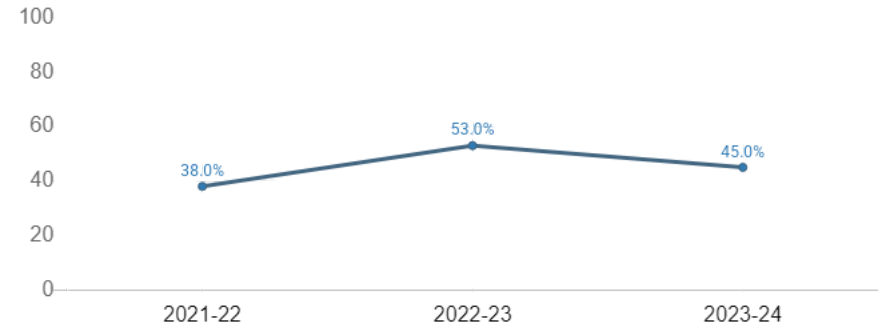
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 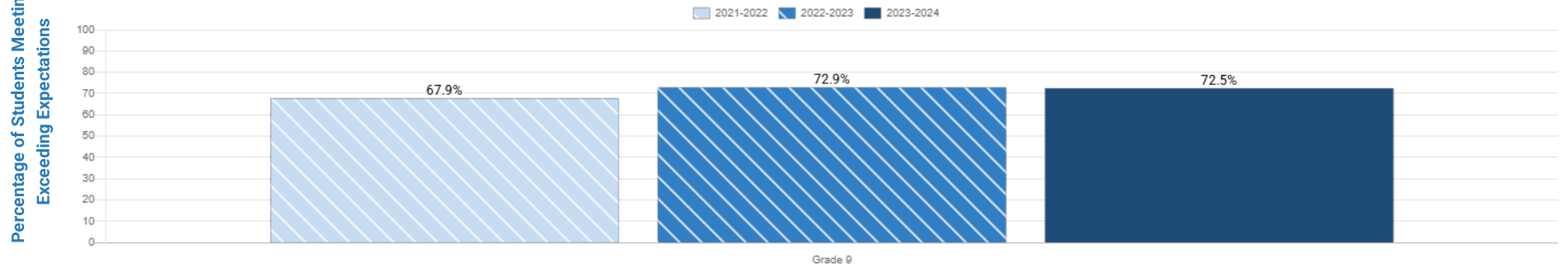

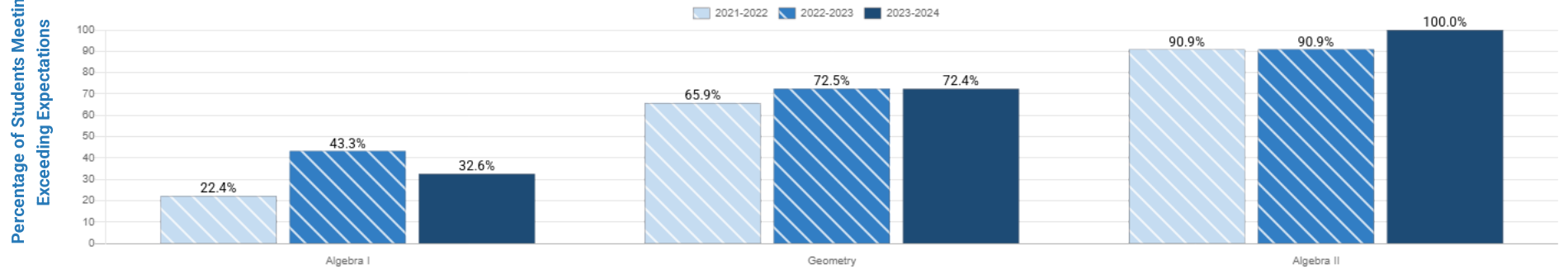

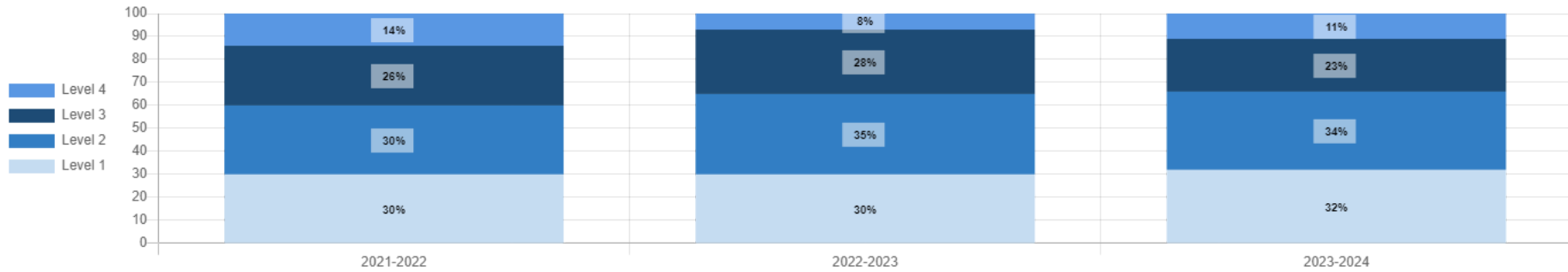

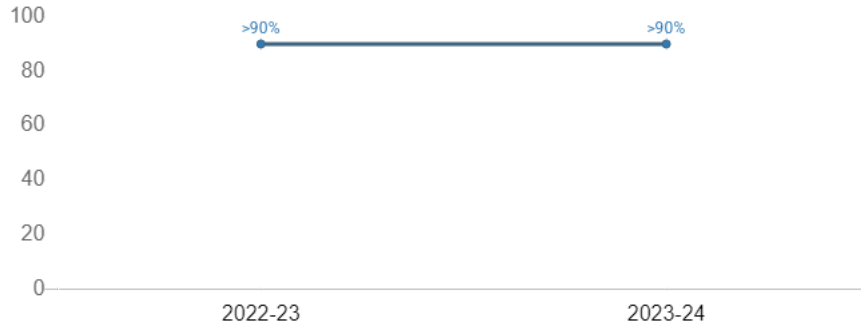

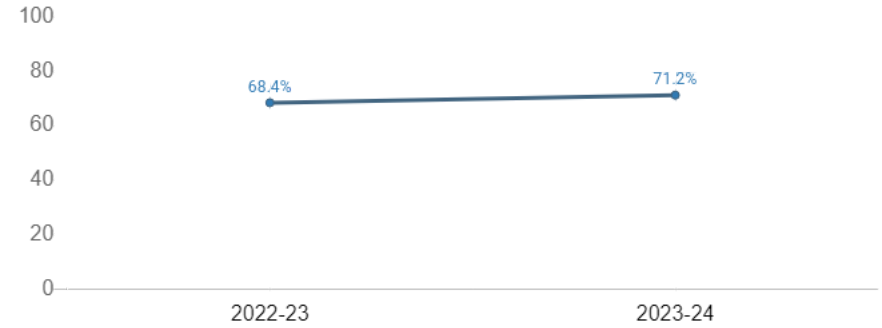

Students taking one or more AP or IB exam

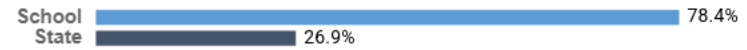

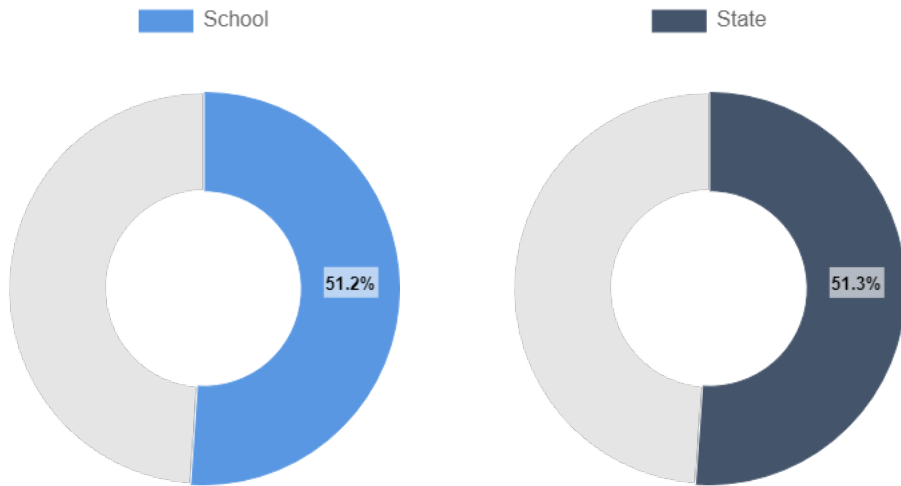

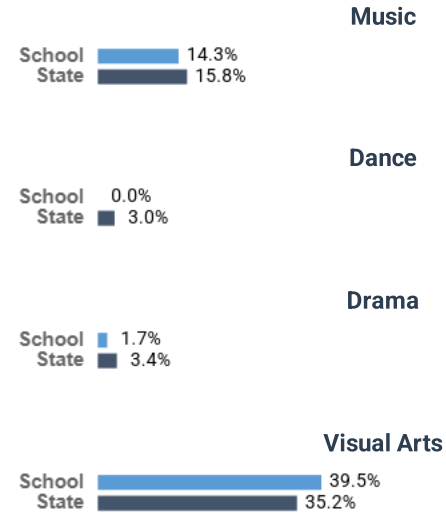

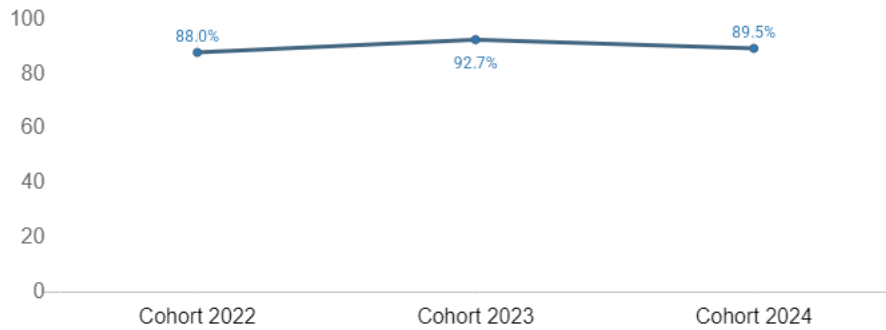

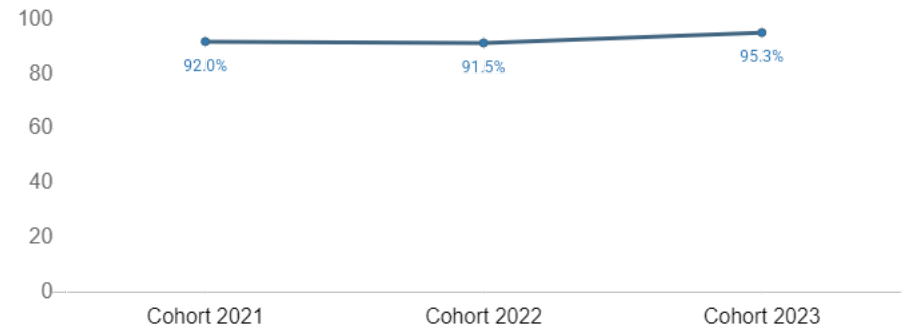

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

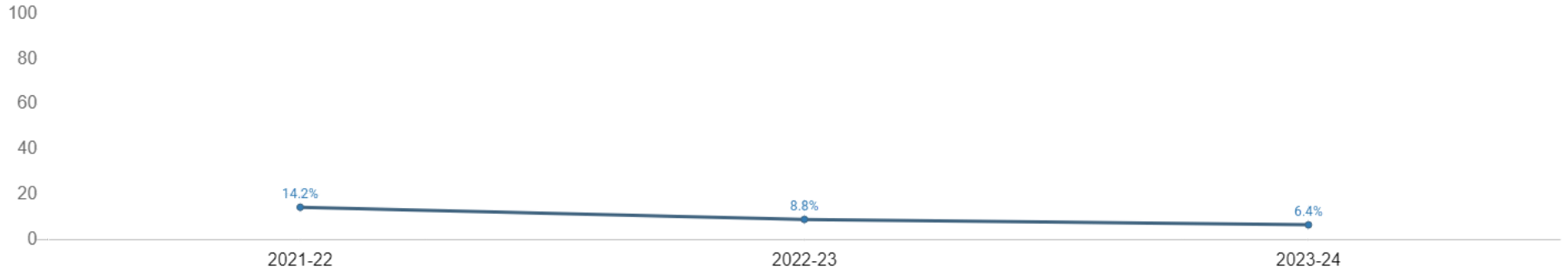

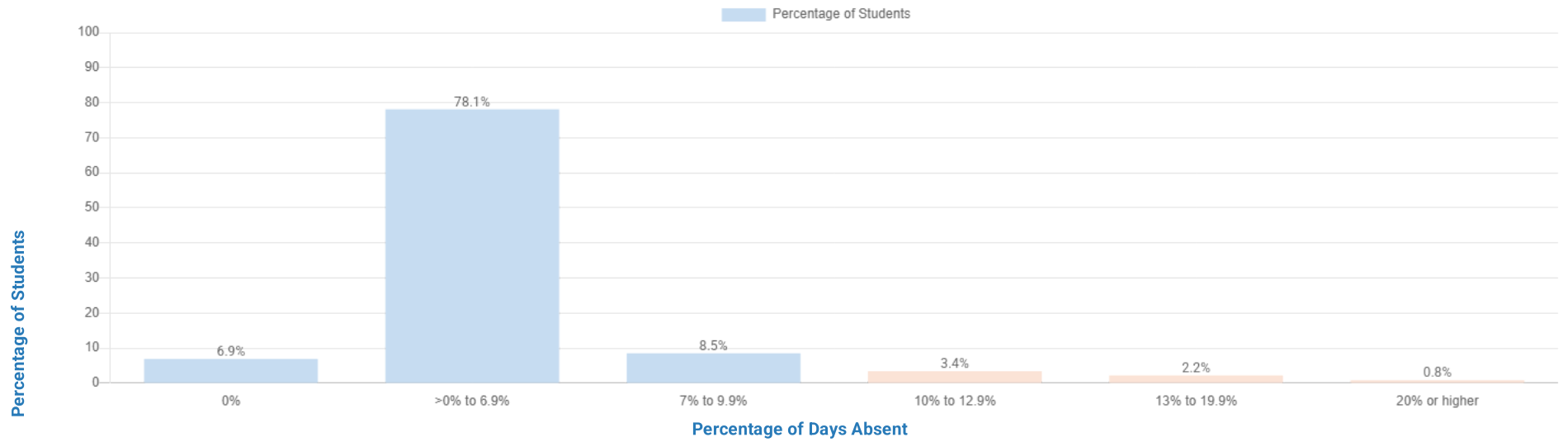

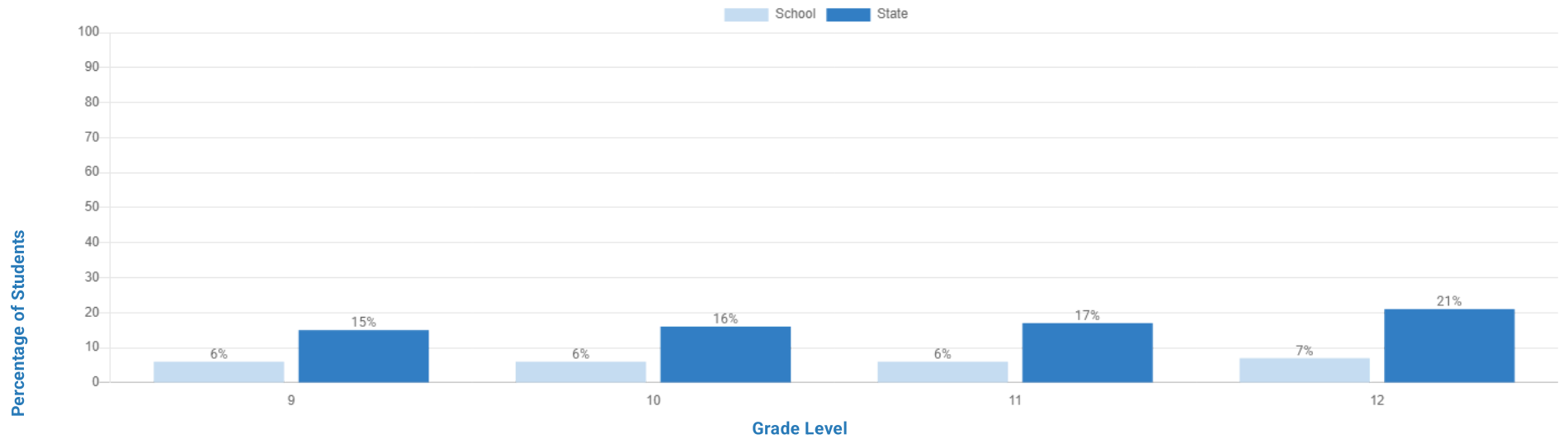

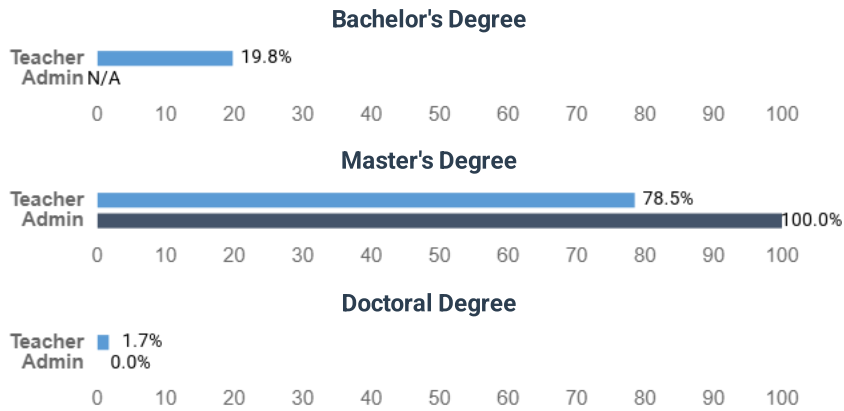

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Morris Hills High School has been named to the AP District Honor Roll several times, including this year, earning a bronze ranking. The College Board's Annual AP District Honor Roll recognizes districts for increasing access to Advanced Placement coursework for all students while maintaining or increasing the percentage of students earning scores of 3 or higher on AP exams. The U.S. News & World Report Best High Schools rankings for 2024 include data on more than 18,000 public high schools in 50 states and the District of Columbia. Morris Hills High School is ranked 56th within New Jersey.

Before and After School Programs:

Utilizing ESSER funds, Morris Hills High School offers PM academic support after school to students in English and mathematics. The PM support is taught by a certified English teacher and a certified math teacher. Morris Hills High School also offers an ELL after school homework club for our ELL students. Furthermore, the library is opened after school for students to utilize to complete work, research, and obtain extra help.



Staff and Professional Learning:

Morris Hills High School has implemented an Instructional Coaching Model which focuses on collecting, analyzing, and utilizing data to identify students needs, assess changes in classroom instructional practice, and measure student progress with a reflective, non-evaluative context. Additionally, the district offers an extensive after school staff development program. Workshops are presented by teachers to their colleagues. These workshops cover topics such as teaching strategies, how to use data effectively, and wellness.



Postsecondary Information:

84% of the graduates from the Class of 2024 attended either a two or four-year college or university. Other students join the military or enter the workforce. Students have access to a College and Career Center and Naviance software to understand college possibilities, explore admission statistics, explore occupations, and identify possible majors. Our Advanced Placement test results indicated that 91% of 389 students received scores of 3 or higher on their AP exams.

Student Supports and Services:

Morris Hills High School offers peer tutoring. Morris Hills High School houses a strong ELL Program, assisting students in learning English. Furthermore, the school is sensitive to the needs of our special education population and provides an education in the least restrictive environment. Morris Hills High School also partners with Effective School Solutions (ESS) to meet the needs of students and their families by implementing culturally inclusive mental health programs. Furthermore, Morris Hills High School has a full time Reading Specialist to work with all students utilizing the Reading Plus Program, as well as a Math Interventionist utilizing the ALEKS Program. The district has allocated ESSER funds to provide students with additional academic and mental health resources. Supports include in-person after-school assistance in mathematics and Language Arts, instant, on-demand online tutoring in all subject areas through Princeton Review/Tutor.com, summer enrichment opportunities.



Student Health and Wellness:

Morris Hills High School has a Wellness Committee that meets throughout the year. Through the work of the committee Morris Hills High School piloted a Mindful Morning Program with selected teachers. A mindful morning is about finding a quiet moment of peace through the practice of mindfulness. By practicing mindfulness first thing in the morning, you are setting yourself up for a calmer and more reflective mindset. Every day at the beginning of the first block, students can listen to the guided audio selected from the curated list, listen to their teacher recite a script, or practice mindfulness in silence. Additionally, the Wellness Committee has worked with the cafeteria vendor to provide healthy breakfast and lunch choices for our students. Furthermore, therapy dogs were brought to Morris Hills High School to assist in mental wellness.



Parent and Community Involvement:

Parental involvement in our Home and School Association has helped promote a strong sense of school community within our school. This sense of community, in turn, allows us to successfully combine various sending communities of students into a united student body. Also, the Home and School Association has helped the high school with facility upgrades through fundraising efforts. ASPEN is the student information system and it contains a parent/student portal. Morris Hills High School partners with various community organizations to present on various topics affecting the school community at large. The school communicates with parents/guardians utilizing School Messenger software and ASPEN. Open communication with parents is accomplished by housing a "Headlines" section on the school website. The "Headlines" section contains all pertinent information and letters submitted by the high school Principal.

School Safety:

The Morris Hills High School Crisis Management Plan serves as an operating guide for a wide range of emergencies. We have installed emergency blue strobe lights and sirens in both the interior and exterior areas of Morris Hills High School. We have adopted the ALICE Protocol for active intruder situations. Share 911 is utilized by faculty members to use smartphones, tablets, computers, or any web-based device to provide real-time information with regard to emergency situations to first responders and colleagues. Multiple cameras have been installed throughout the campus. Morris Hills High School has a full-time Class 3 Officer present in the building. Morris Hills High School utilizes Gaggle for the 2023 - 2024 school year.



Technology and STEM:

Morris Hills High School has implemented a 1:1 Chromebook initiative. Every 9th grade student receives a Chromebook that is used to foster creativity, critical thinking, and collaboration. Students are provided daily access to valuable applications and resources to strengthen student achievement across the curriculum and foster the development of 21st century skills.

Morris Hills High School offers an Exploring Childhood course. This course provides the student, who is interested in pursuing a related career or who enjoys the enthusiasm and innocence of children, with the opportunity to interact with preschool-age children in a classroom setting. High school students will be challenged better to understand the development of young children, themselves, their relationships with their parents and their future parenting styles. Students will learn how to plan age-appropriate activities to foster positive self-esteem, understand social/emotional growth, promote language acquisition, plan for both small and large motor development, and enhance conceptual skill development of the preschool-age child. The high school students become the teachers and create interesting activities for young children who are learning to interact with others, explore their environment and build self-confidence.



Attendance:

The district has allocated ESSER funds to provide students with additional academic and mental health resources. Supports include in-person after-school assistance in mathematics and Language Arts, instant, on-demand online tutoring in all subject areas through Princeton Review/Tutor.com, summer enrichment opportunities, and additional mental health staffing. Morris Hills High School utilized Lifelines for the 2023 - 2024 school year. The interactive Lifelines Program covers many topics and gives students the opportunity to develop a plan of action if they are in danger of hurting themselves. The Child Study Team works with students about mental health and how to seek help if they are worried about themselves or a friend. Morris Hills High School using a program called SOS Signs of Suicide.
