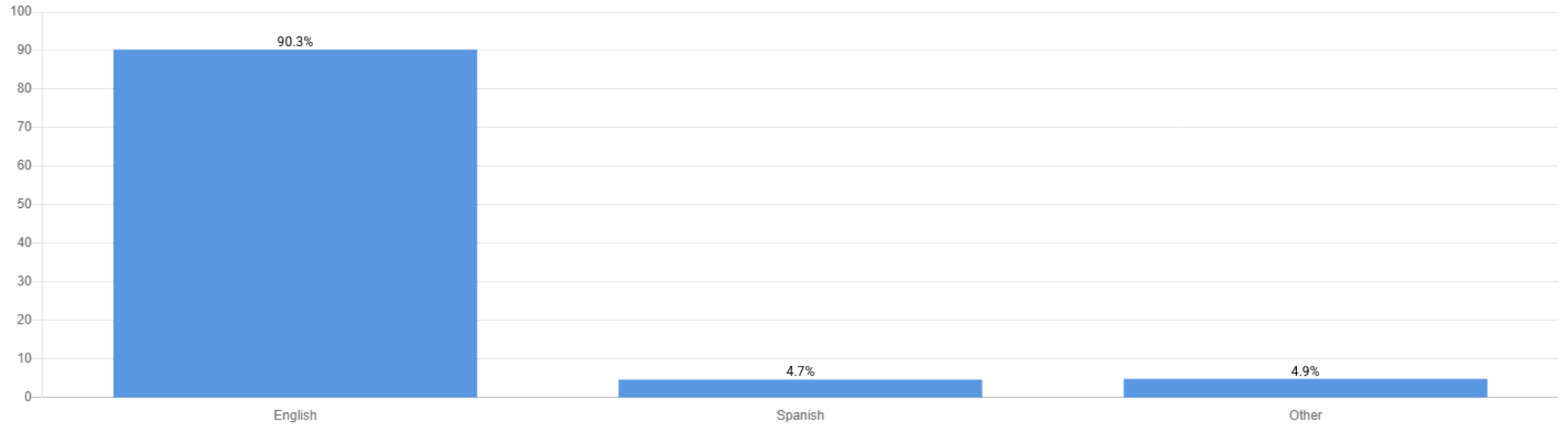

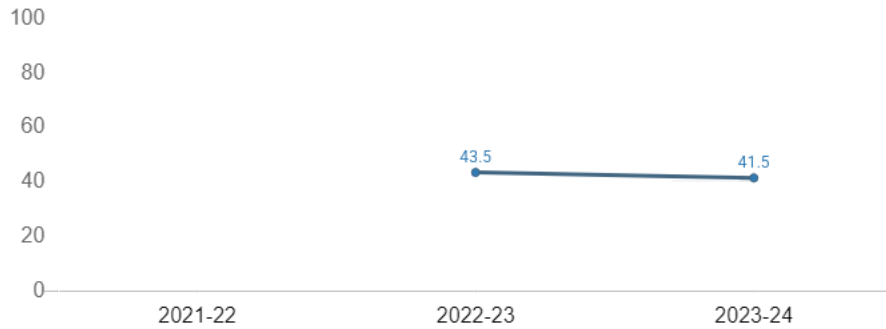

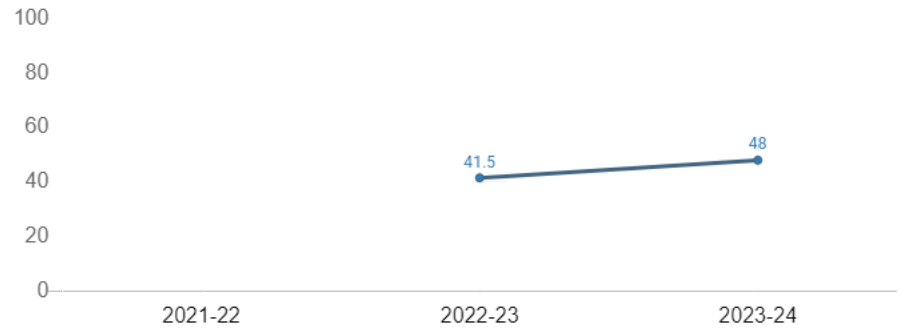

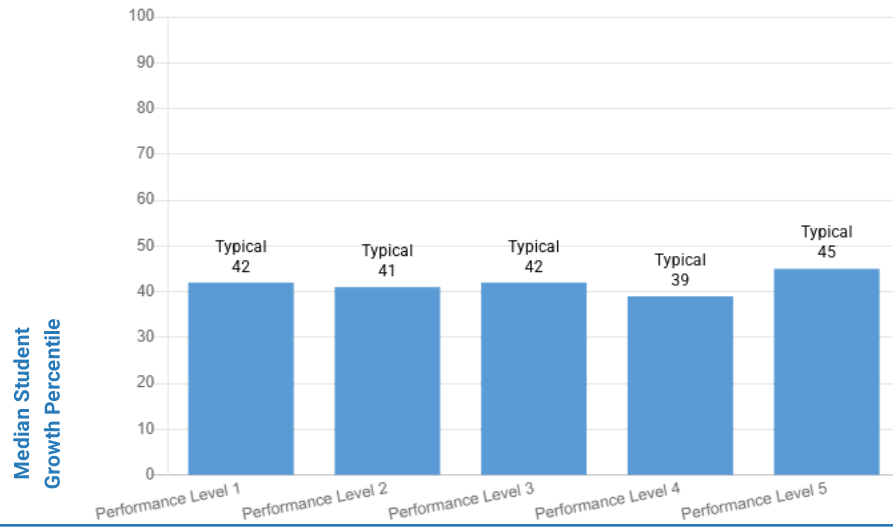

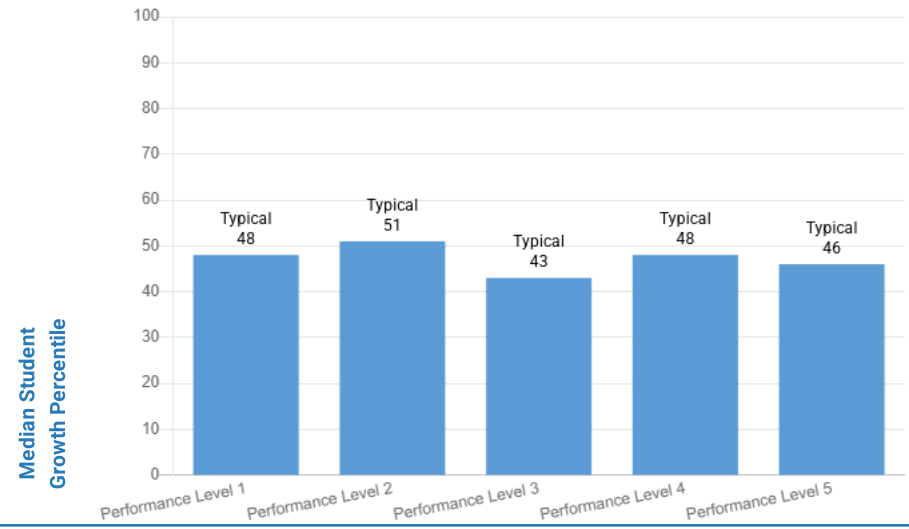

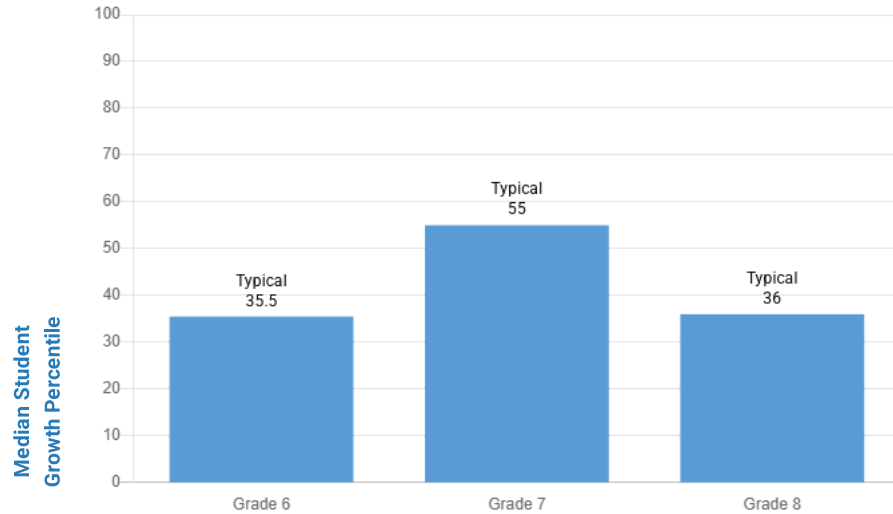

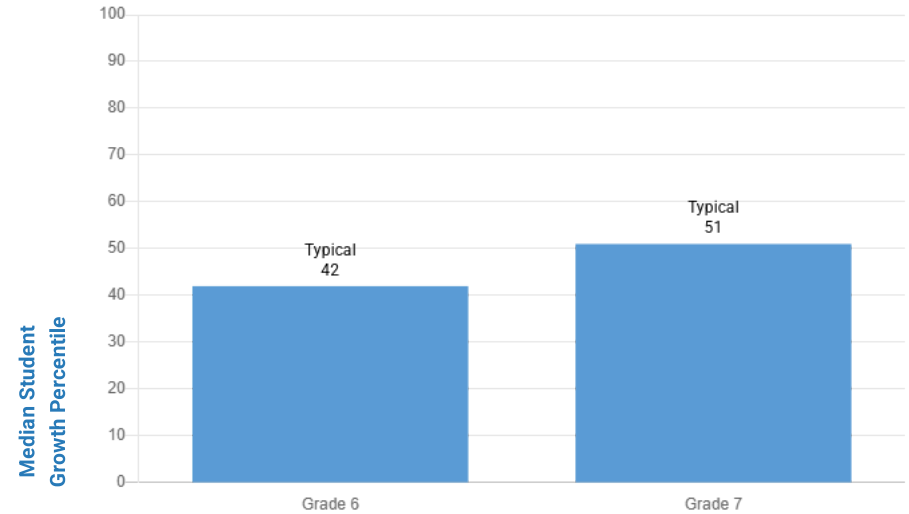

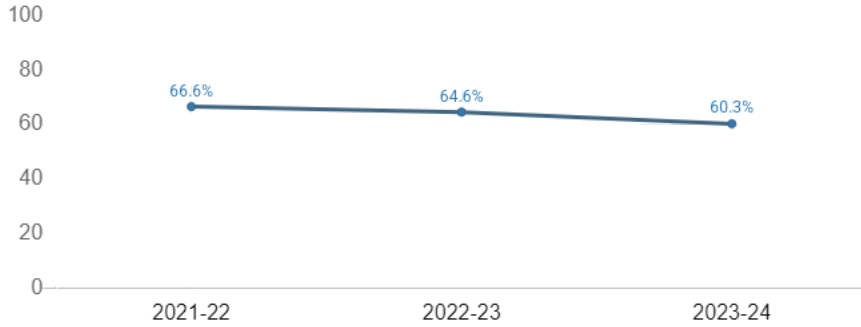

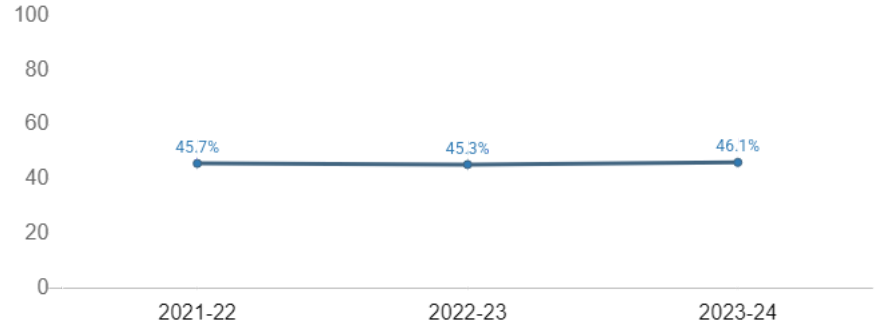
English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance

Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. 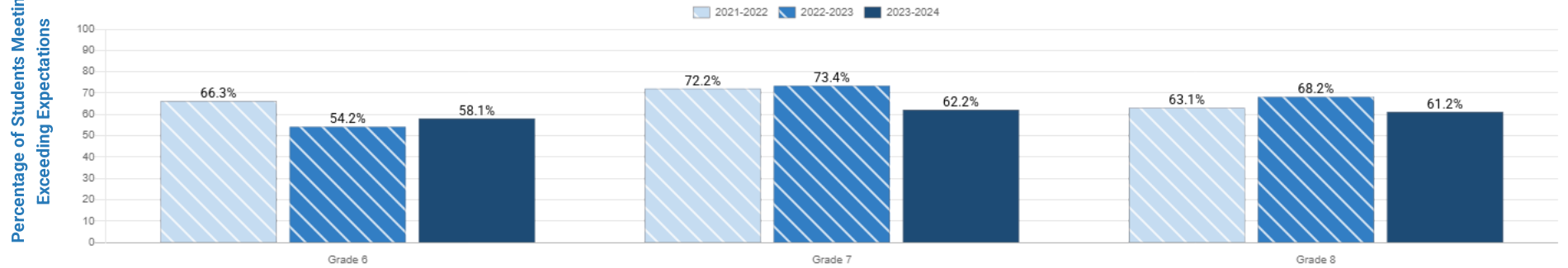

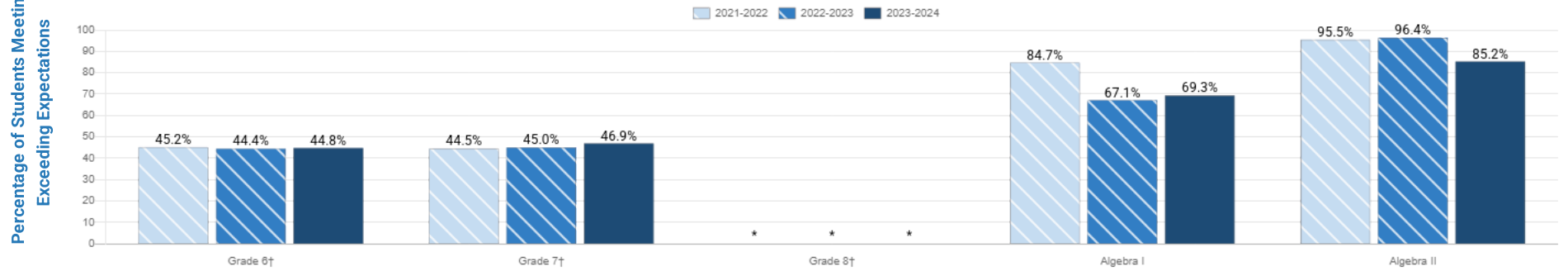

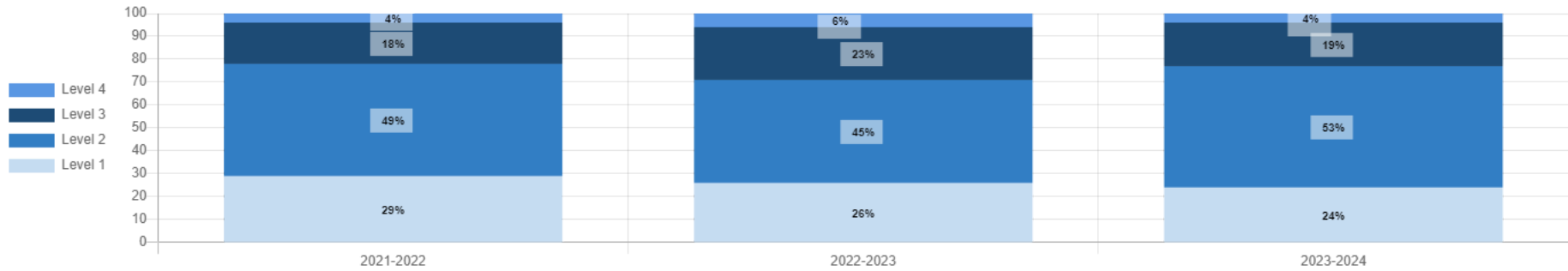

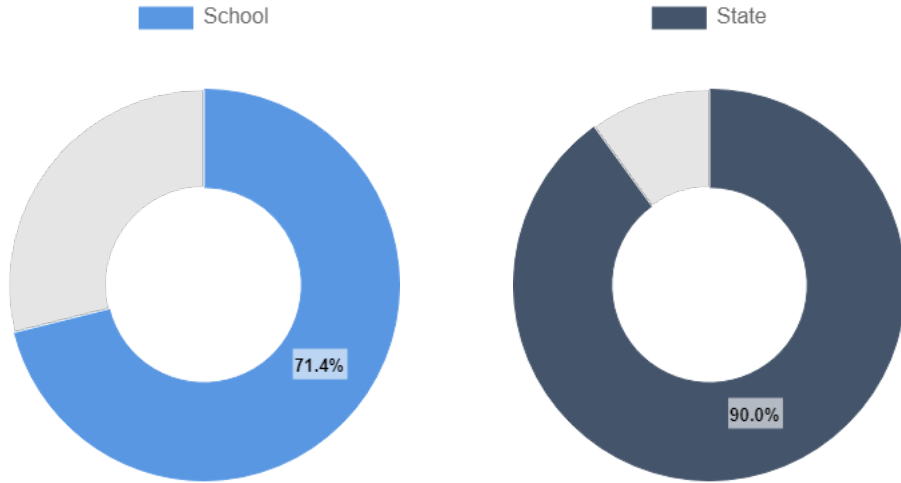

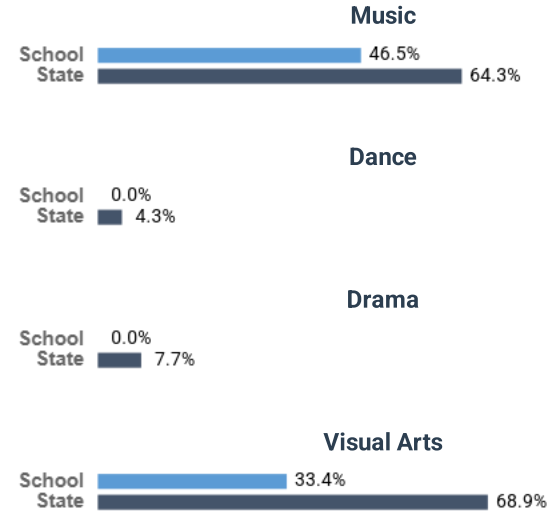

Students enrolled in one or more classes by discipline:



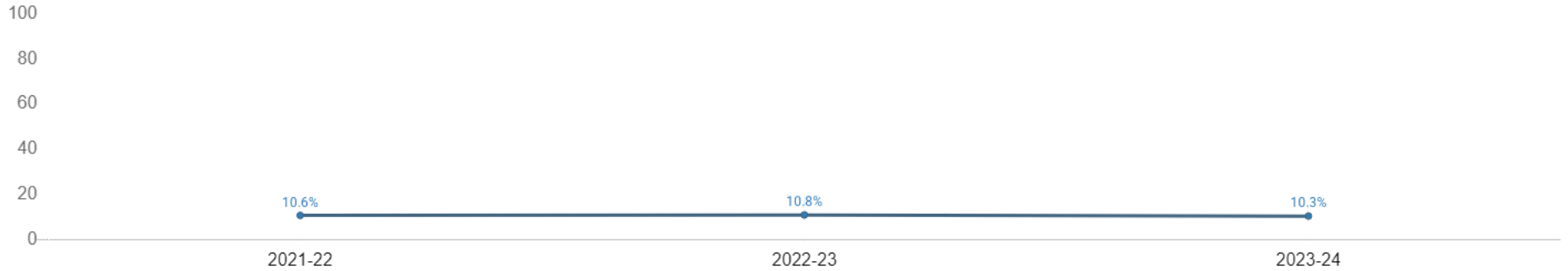

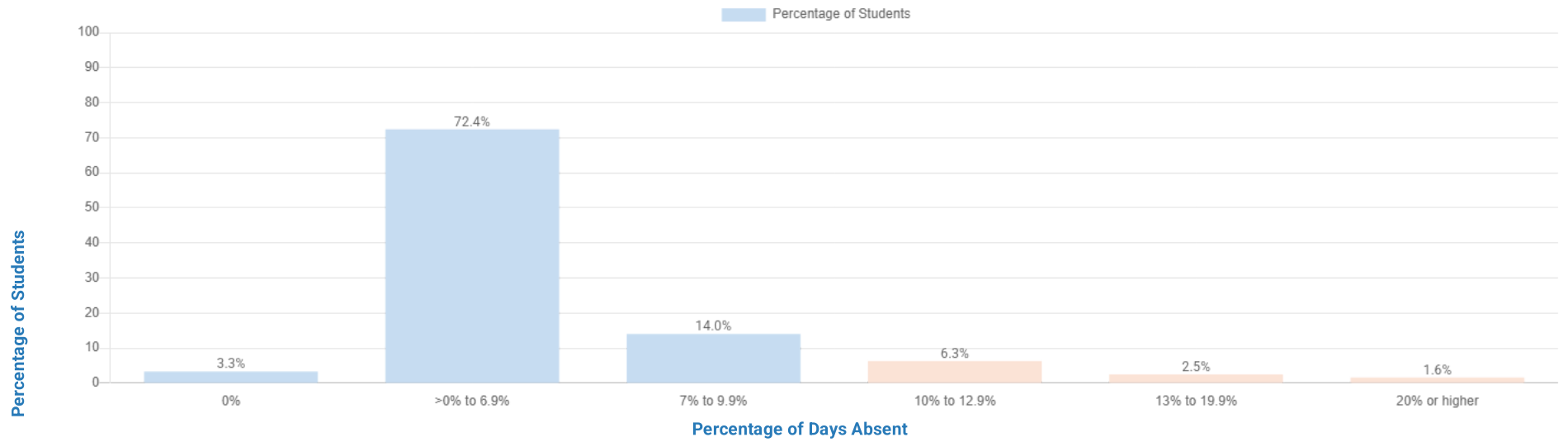

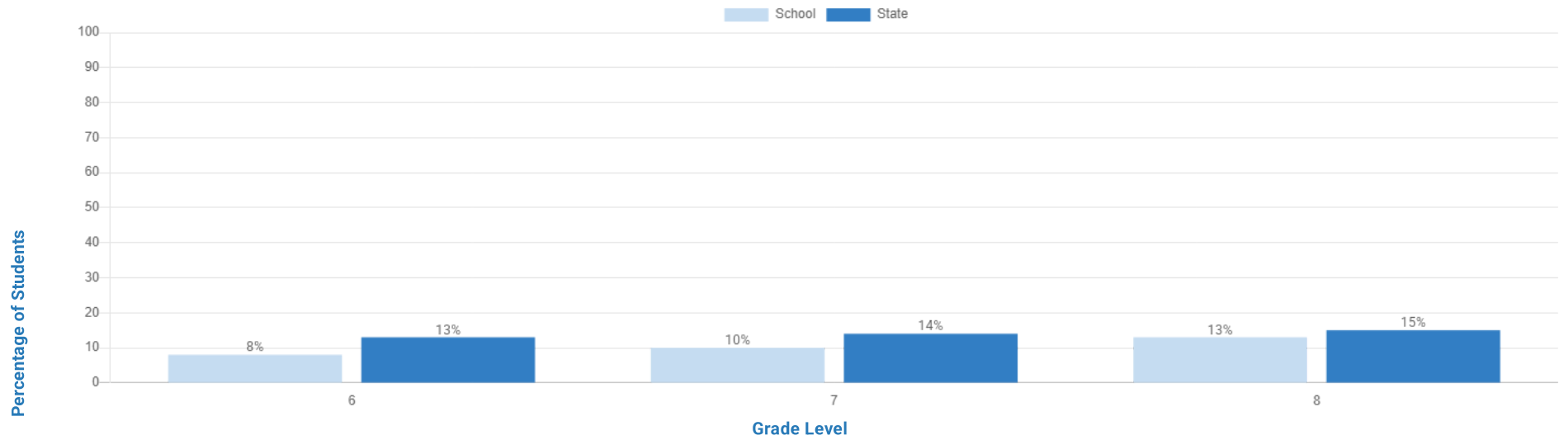

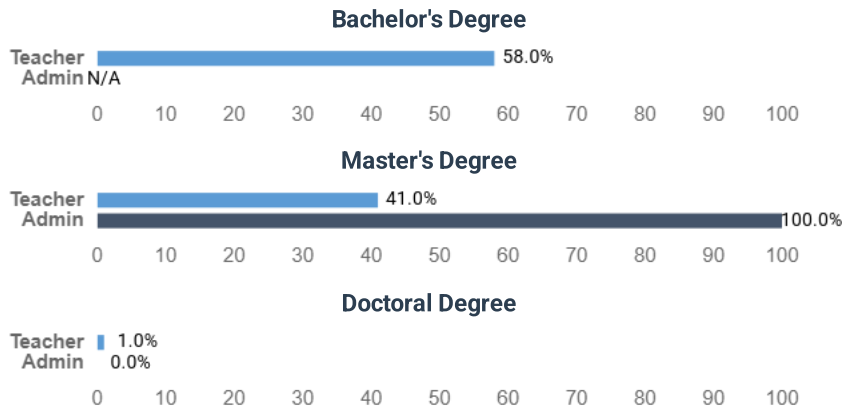

School Safety:

Student safety is our top priority. All visitors must scan their license before entering the building through our double door system and must wear a visitor's badge while in the building. Multiple security guards are present throughout the day as well as at after school events. All exterior doors are alarmed and locked. Staff members gain access to the school through a key fob swipe system. All staff members and visitors can be identified by their ID badges. ID lanyards must be worn by all staff members and visitors at all times. Security cameras have been installed both inside and outside of the building. We have added a security office within our vestibule that has double locked entry doors.



Technology and STEM:

All classrooms are equipped with a SMARTBoard or Promethean Board and we are 1:1 with student chromebooks. We have a state of the art Makerspace. Computer devices with flexible seating have been upgrade in our computer and technology labs.
