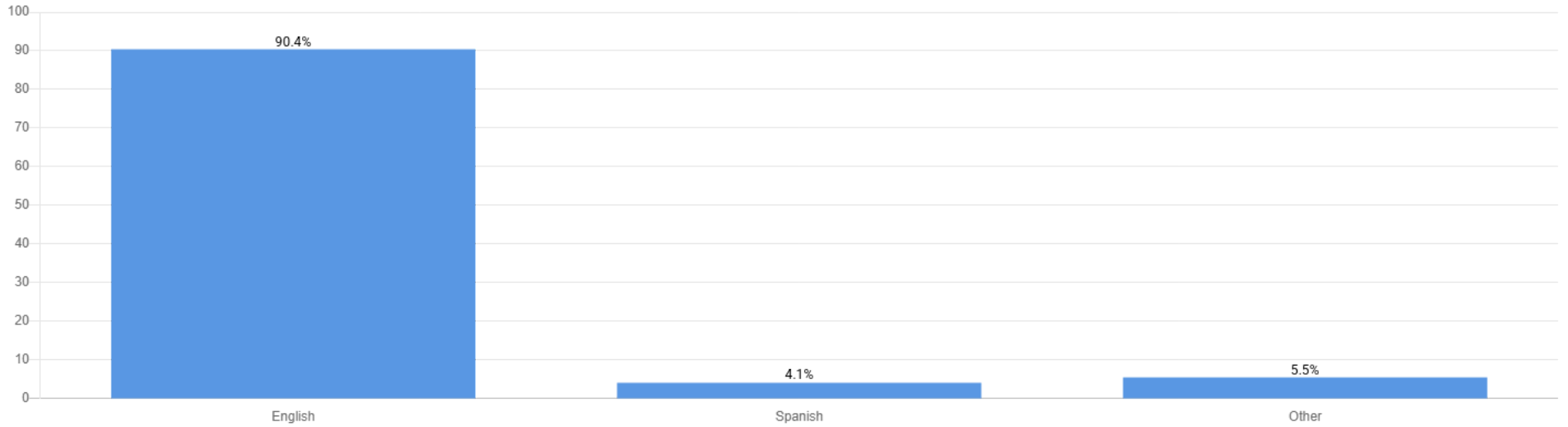

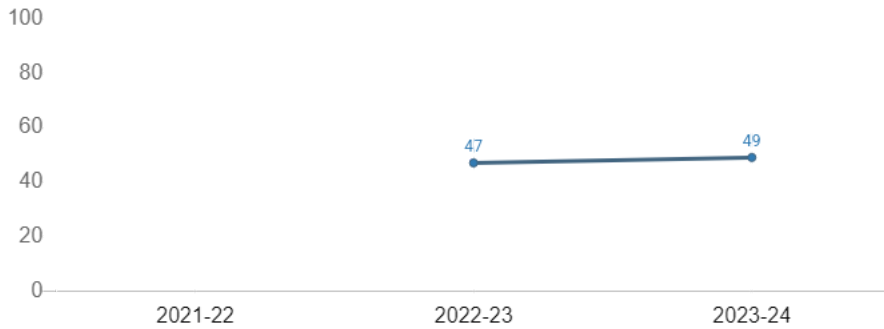

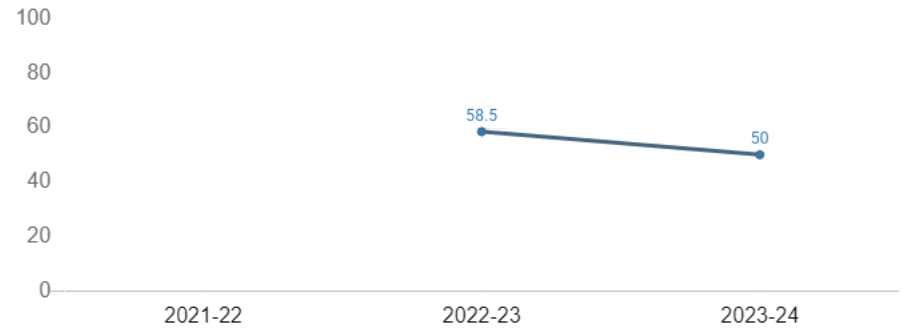

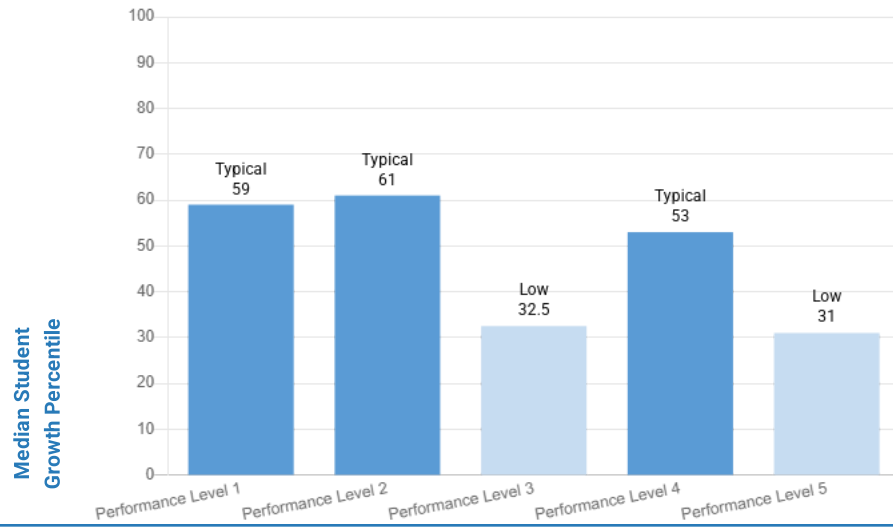

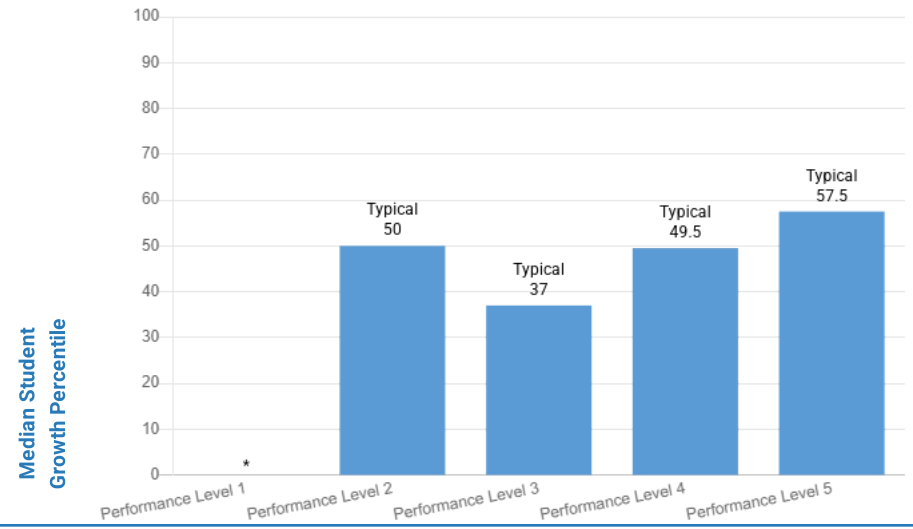

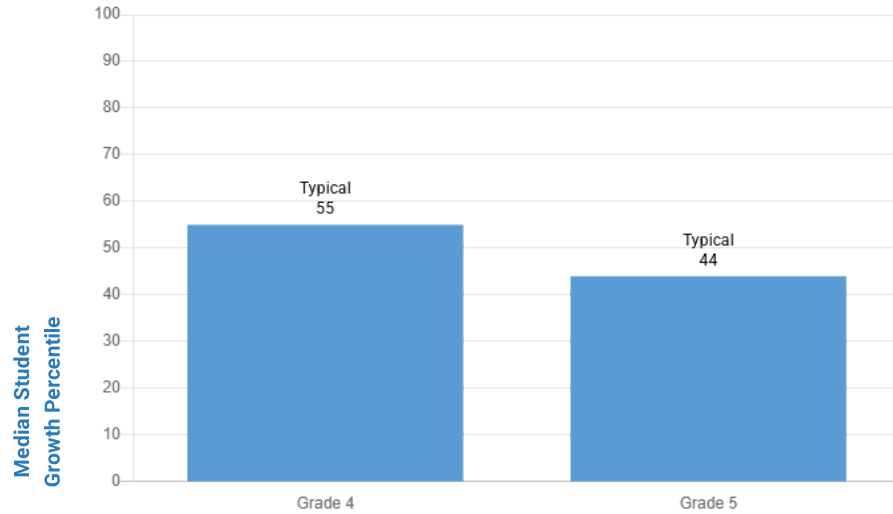

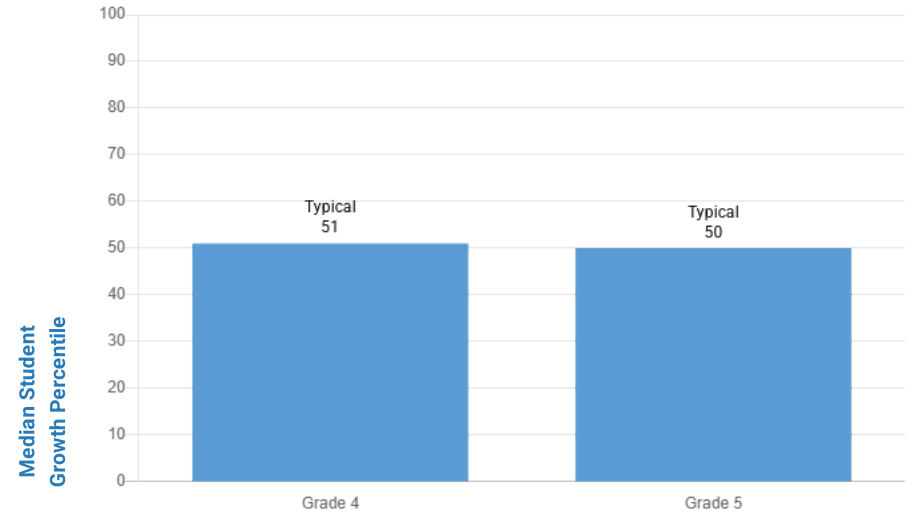

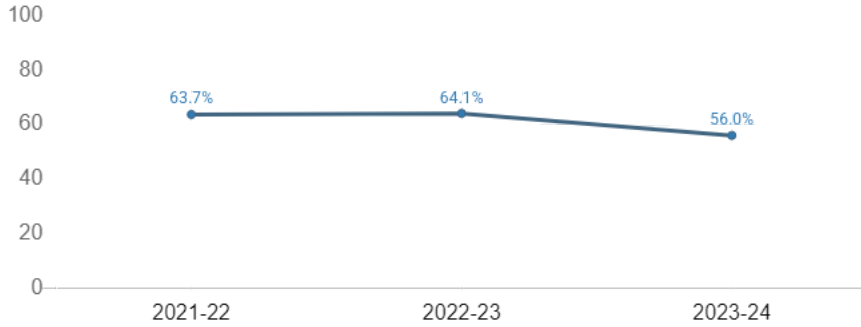

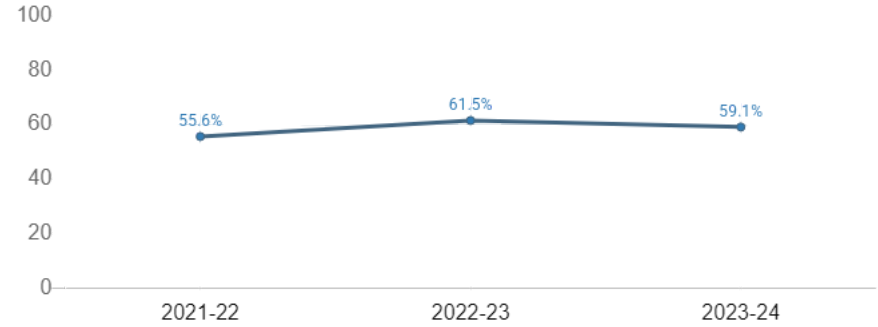
### English Language Arts and Mathematics Performance Trends

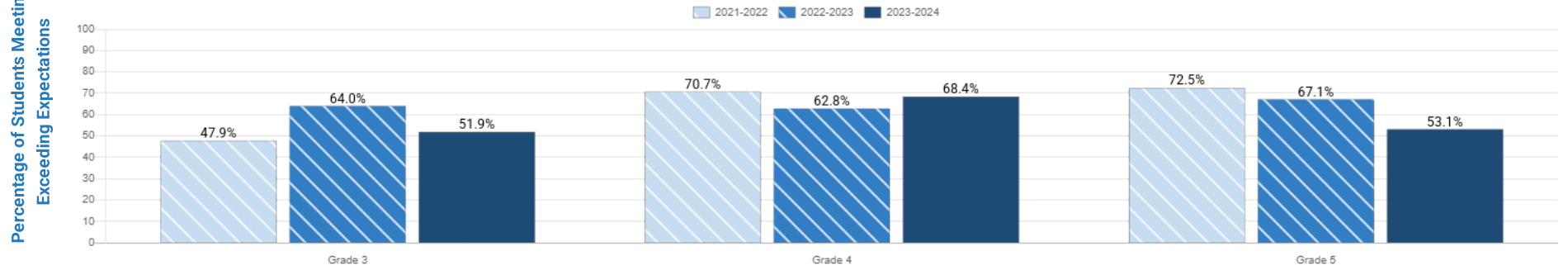

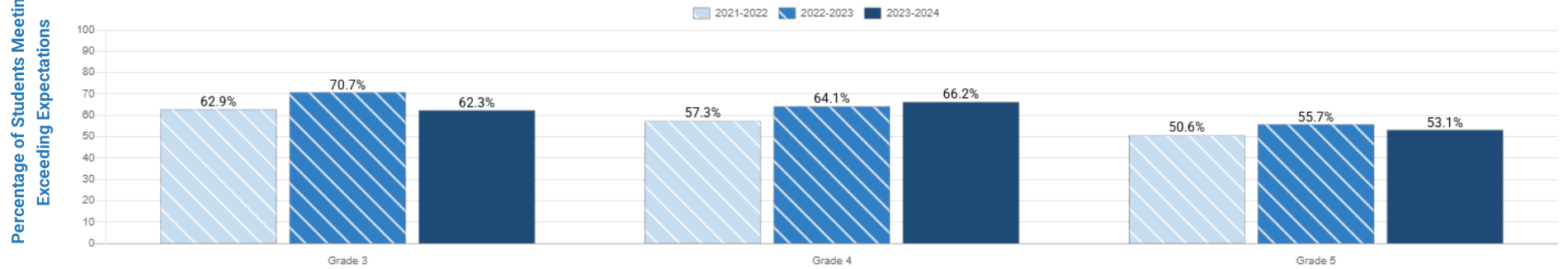

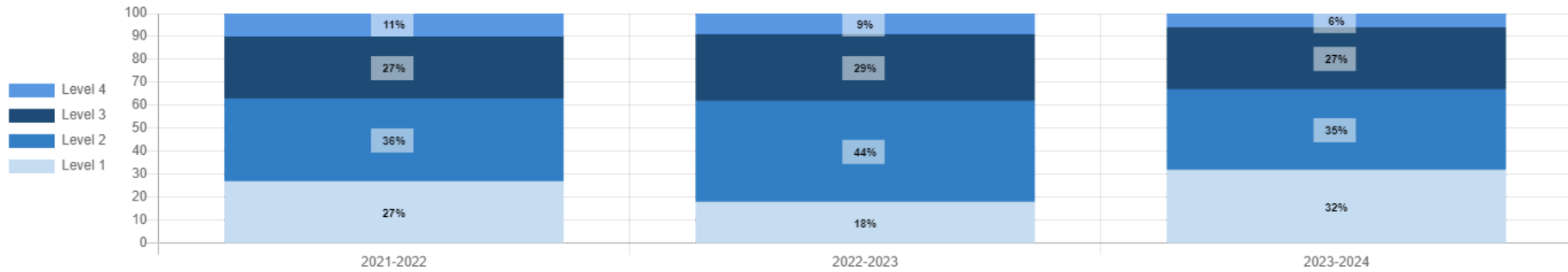

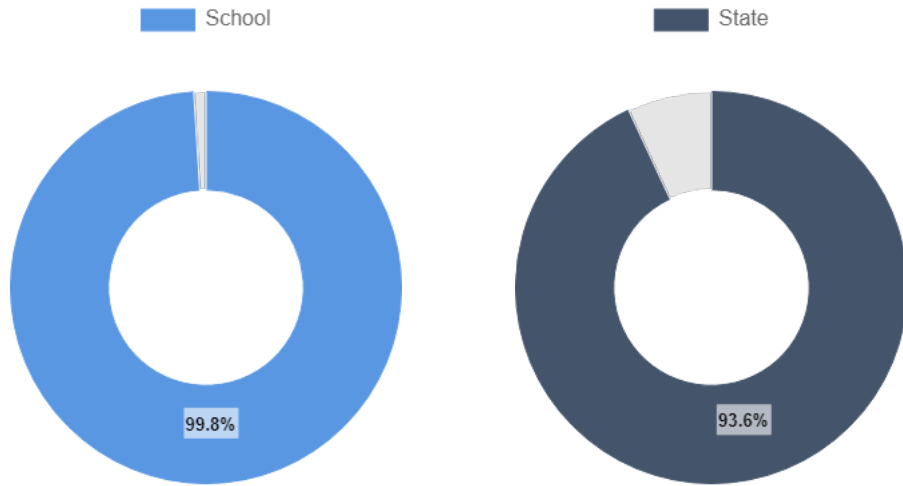

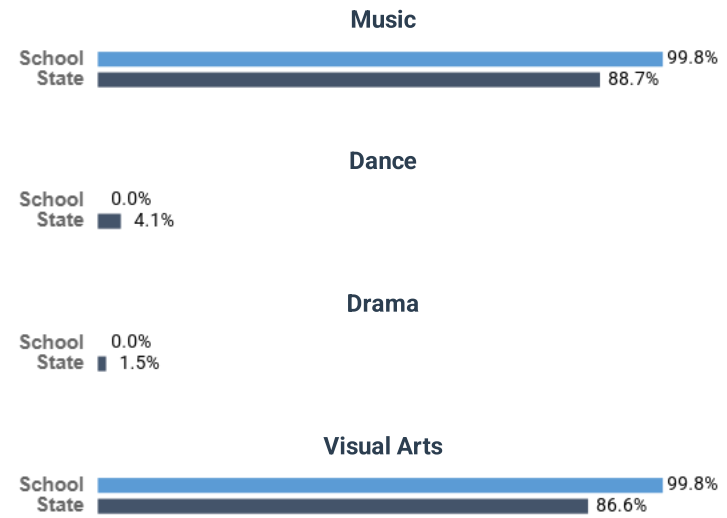

**Students enrolled in one or more classes by discipline:**



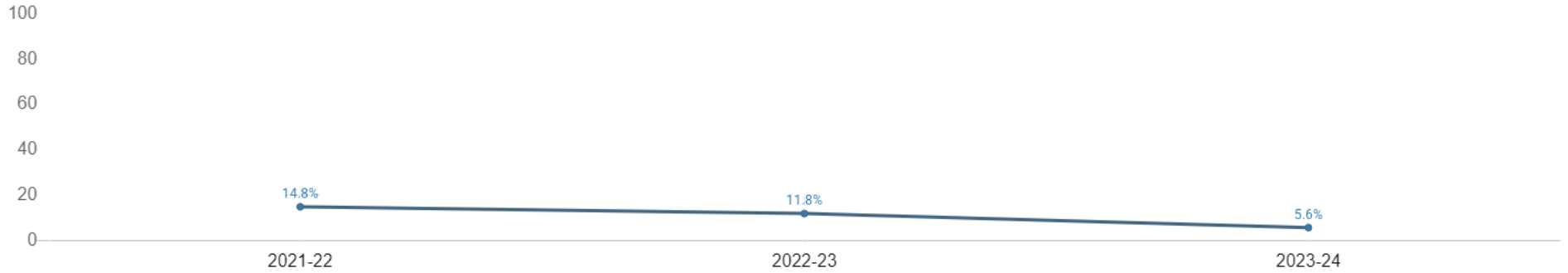

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 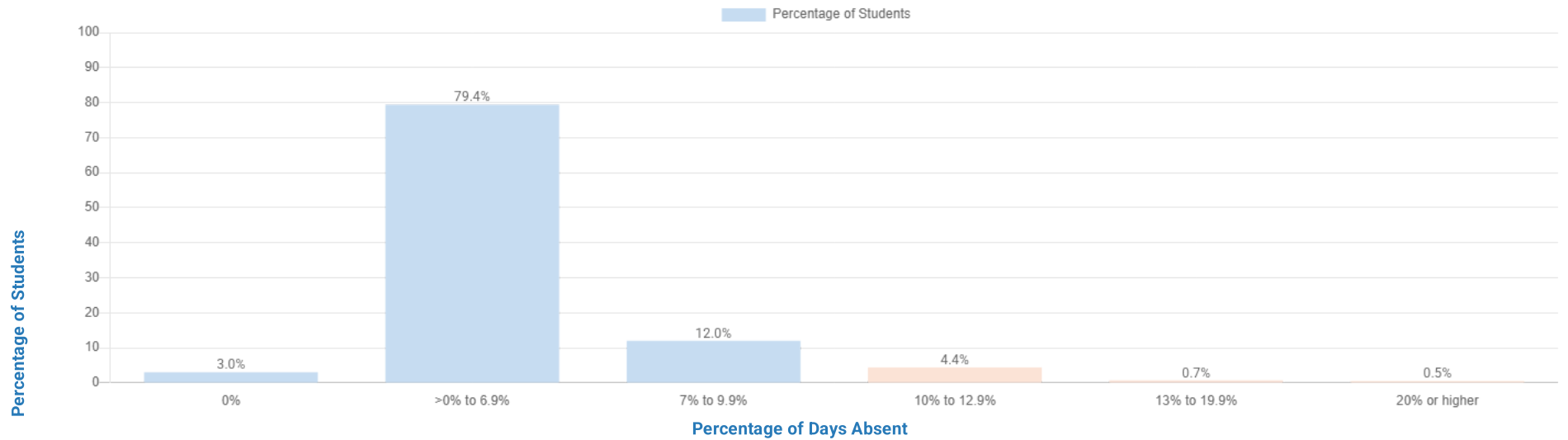

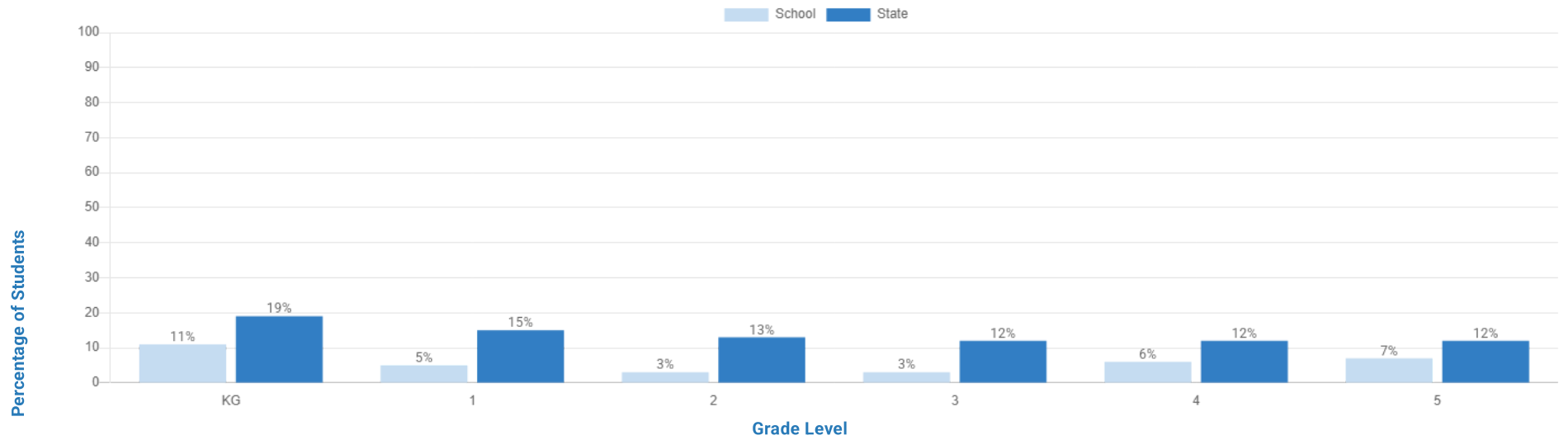

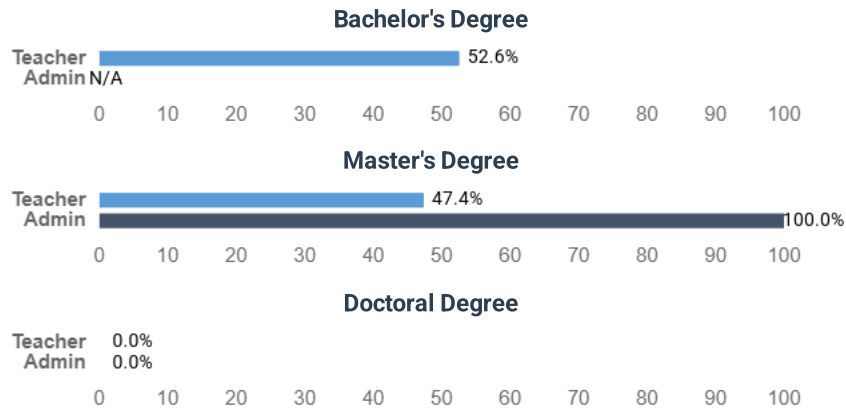

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Our district has developed an integrated learning curriculum that promotes critical thinking, collaboration, differentiation, personalized learning, and innovation. Special programs are developed to identify and support students across the learning spectrum. Our educational programs provide support to ALL students.

### Staff and Professional Learning:

Teachers and instructional support staff benefit from professional development days and have opportunities to attend training throughout the school year. They gather weekly in Professional Learning Communities (PLCs) to address the needs of all students. Our special program staff members meet monthly. Faculty, department and grade level meetings occur three times a month, and tech coaches offer continuous professional development to help teachers implement best practices and instructional platforms, including the integration of Artificial Intelligence in the classroom. Members of the Child Study Team and related service providers regularly train staff in ASD classrooms on effective communication with non-verbal learners. The Reading Specialist provides training on Foundations and the accurate administration of running records. All teachers receive ongoing professional development, including demo lessons and debrief sessions in The Science of Reading and Conquer Math in 4th and 5th grade



### Student Supports and Services:

Multi Language Learners receive supports and services from a certified MLL teacher. Students with disabilities receive supports and services per their IEPs. Students struggling in the areas of math and reading receive tiered RtI services from the reading specialist and math interventionist. Students struggling socially and emotionally receive tiered RtI supports from the school counselors. Additionally, students receive academic supports through the after school Mt. Olive Success Academy as well as academic RtI and behavioral RtI.



### Student Health and Wellness:

All students engage in 30 minutes of recess daily. All students engage in daily SEL lessons. Our school counselors and members of the Mount Olive High School National Honor Society conduct in classroom SEL lessons throughout the year. Our 3rd grade students participate in the Footprints for Life, a research-based primary prevention program that builds assets and teaches important life skills to students. Kindergarten -5th grade students receive health lessons per the NJ Health and Physical Education standards. Our 5th grade students participate in the LEAD (Law Enforcement Against Drugs) program in conjunction with our local police department.

New playground equipment and Four Square courts were added this year.

### School Safety:

Student safety is our top priority. All visitors must scan their license before entering the building through our double door system and are required to wear a visitor's badge while inside. This year, we have added a second security guard who is present throughout the day and at after-school events. All exterior doors are alarmed and locked, and staff members gain access to the school using a key fob swipe system. Both staff and visitors are easily identifiable by their ID badges, which must be worn on lanyards at all times. Additionally, security cameras have been installed both inside and outside the building, security film added to our main lobby windows, and our playgrounds and recess areas are gated for added safety.



### Technology and STEM:

All classrooms are equipped with a Smartboard or Promethean Board and we are 1:1 with student Chromebooks. All classrooms were equipped with new Chromebooks in the 2022-2023 school year. Students attend Library each week. In addition to traditional library book borrowing, students in all grades learn coding, computer programming, and 3-D print design. They engage in STEM activities and Computer Science activities both in their homeroom classes and in the Media Center (Library)
