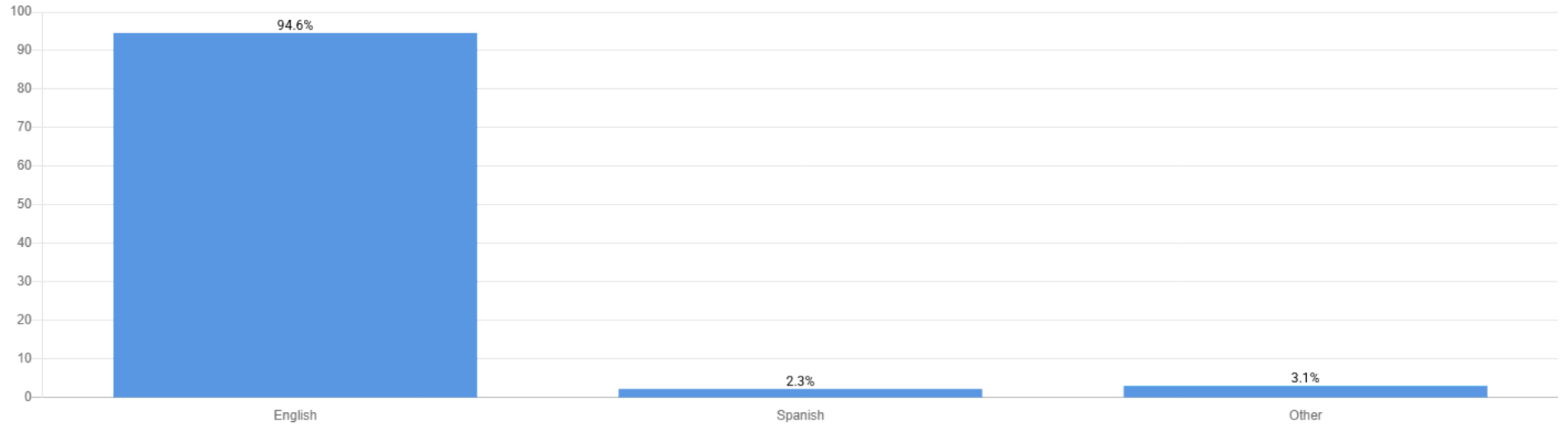

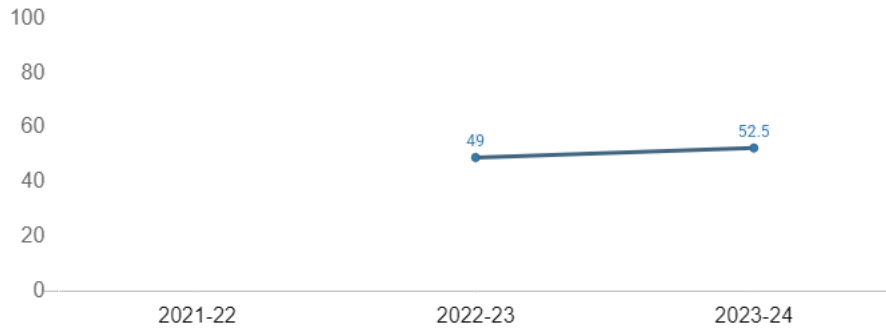

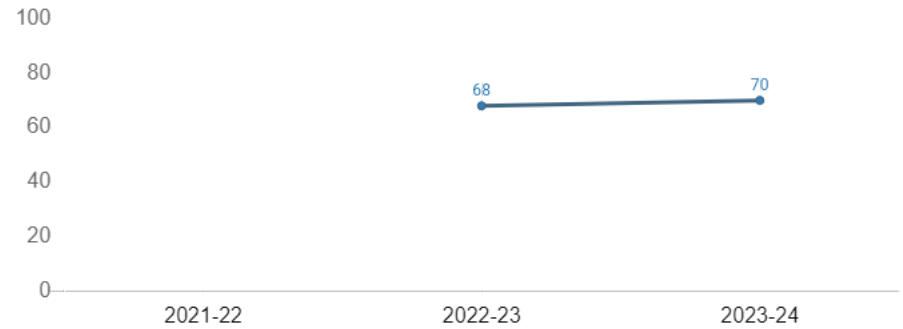

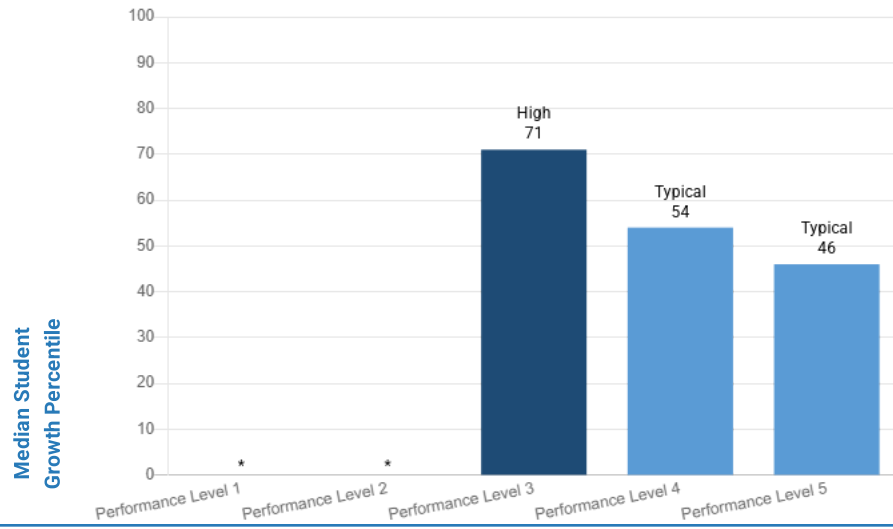

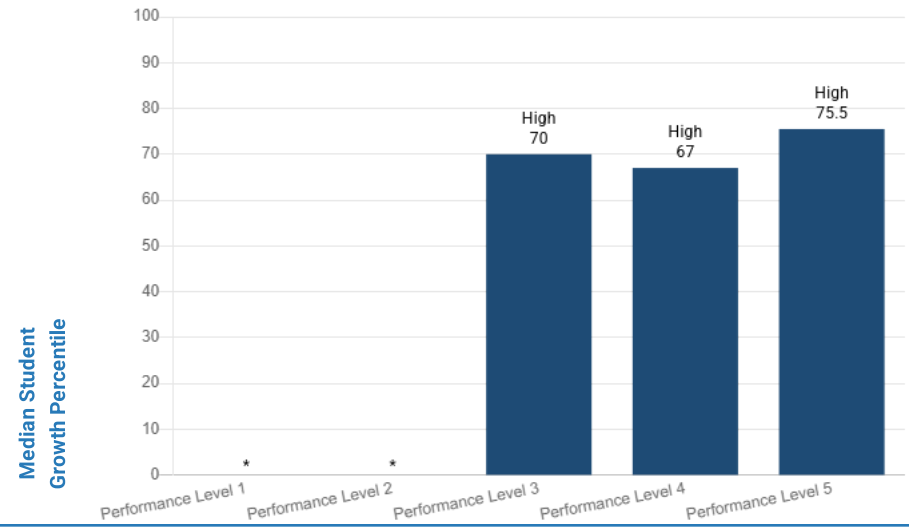

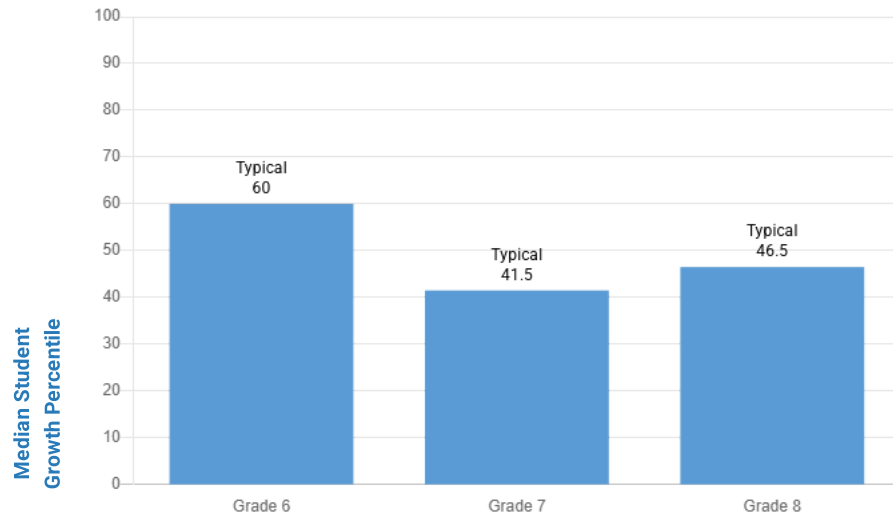

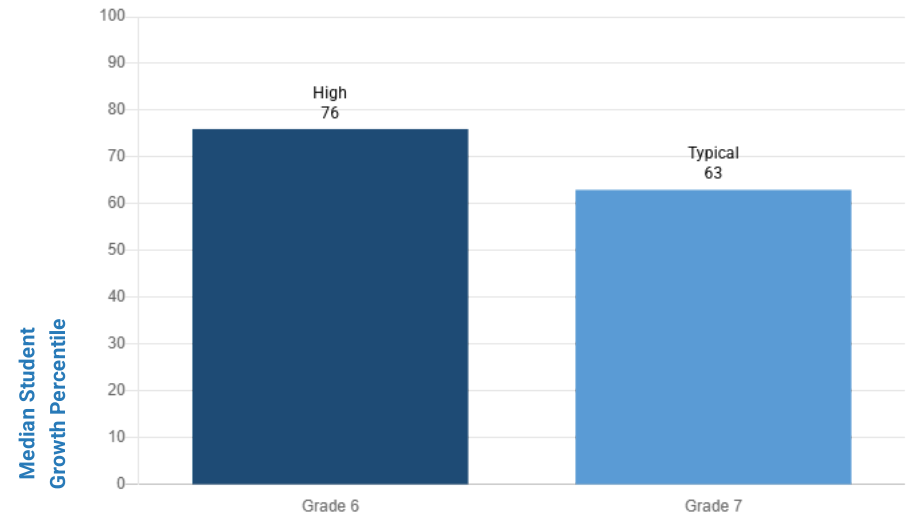

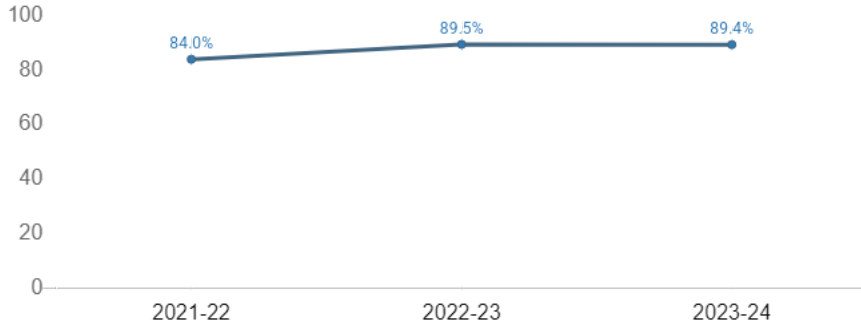

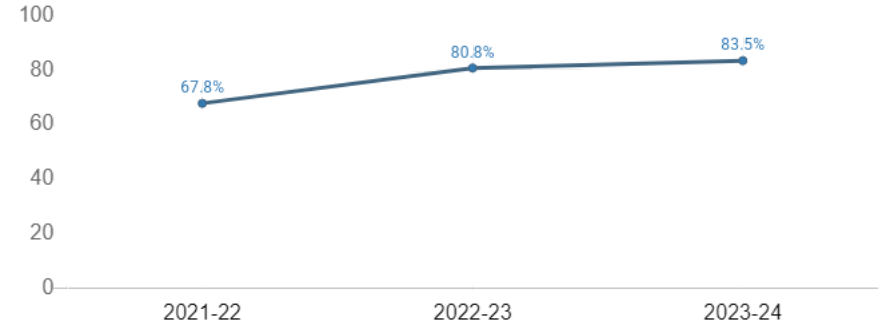
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 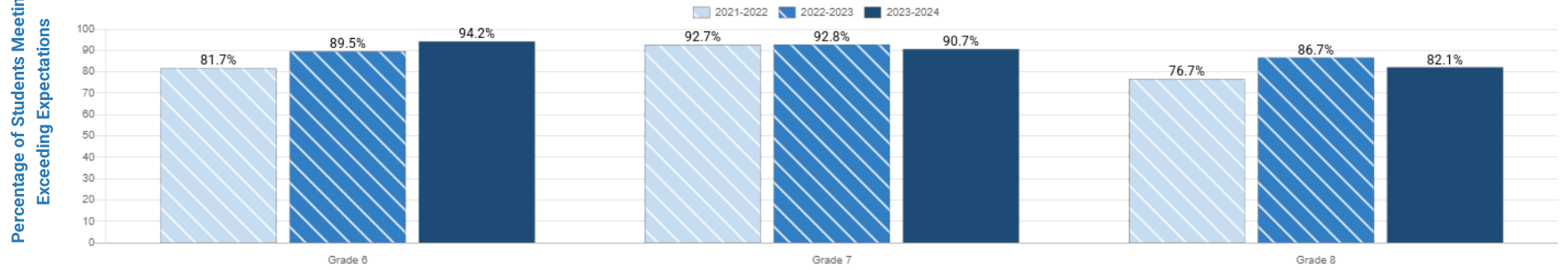

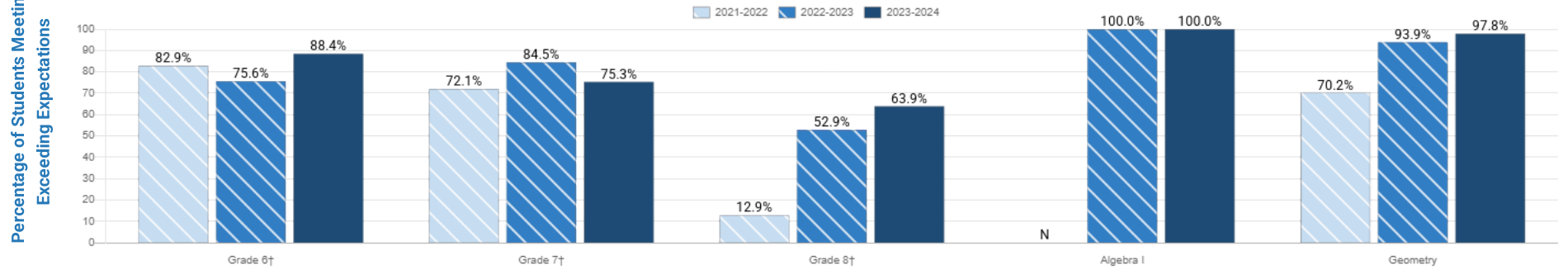

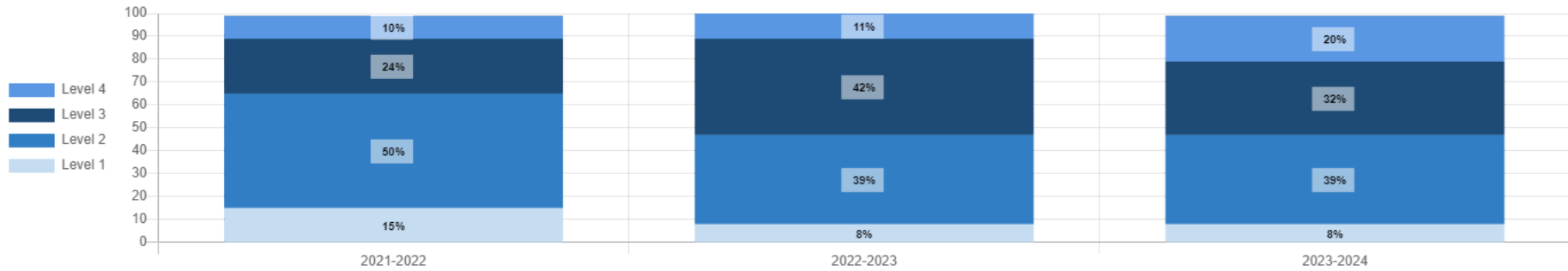

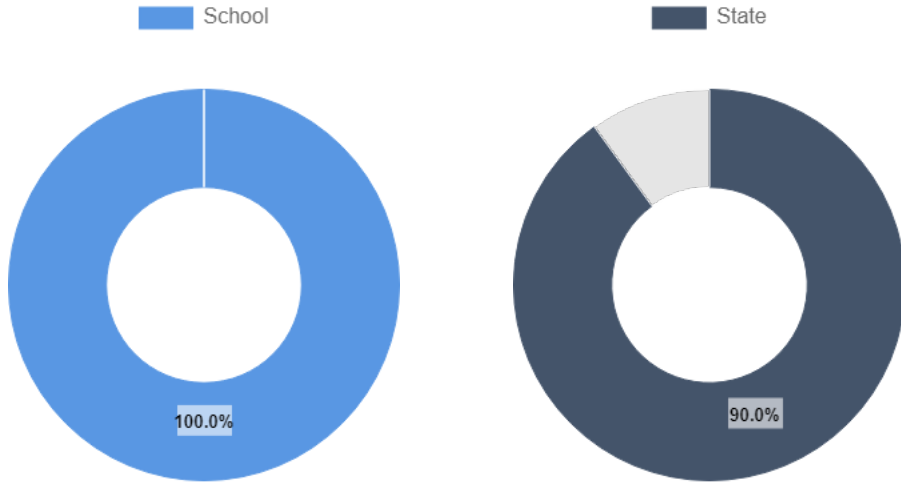

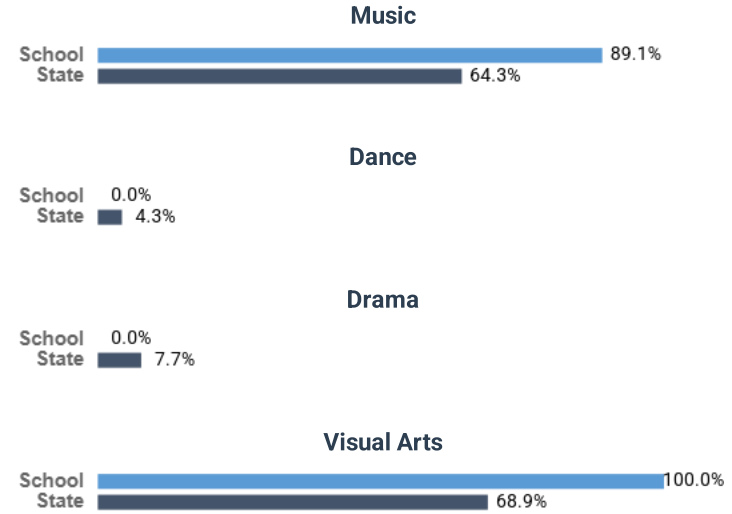

Students enrolled in one or more classes by discipline:



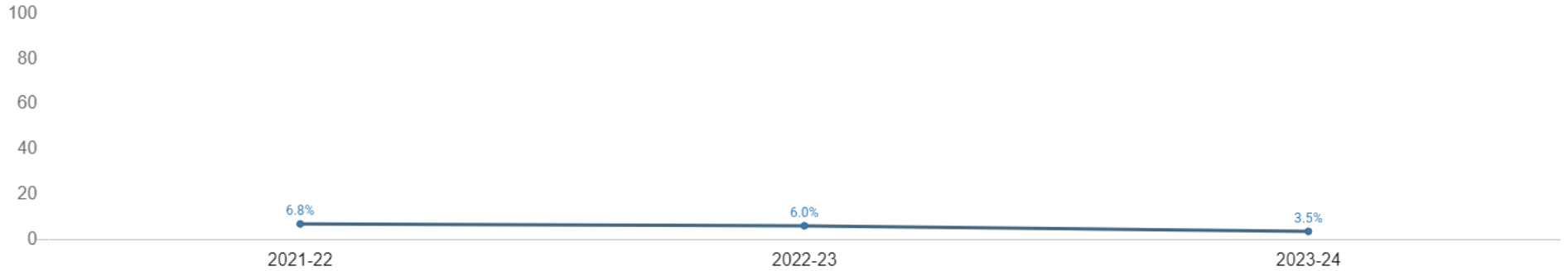

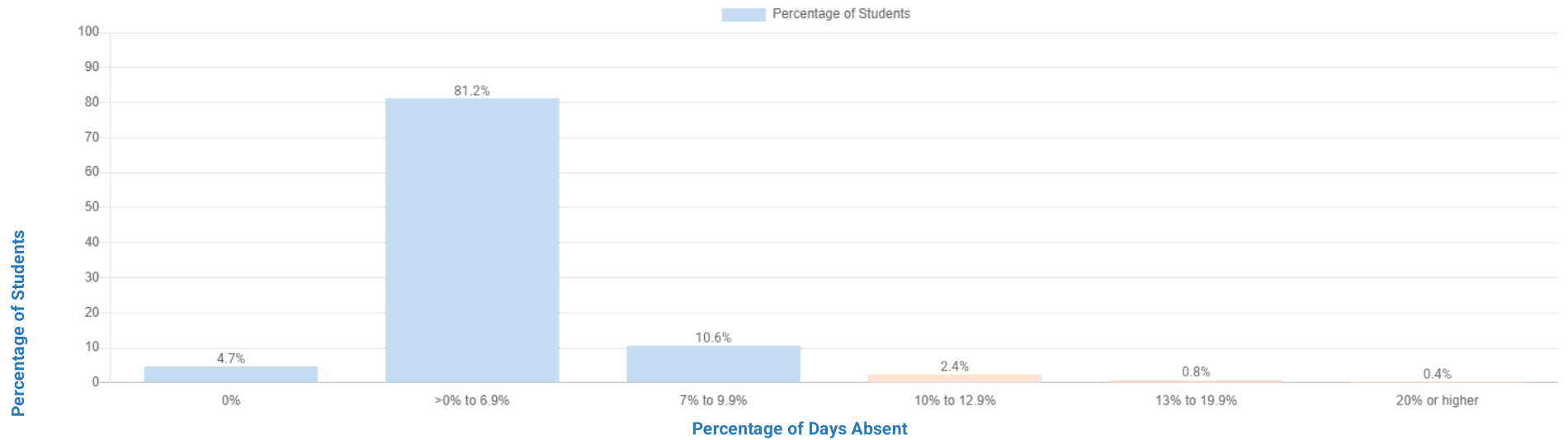

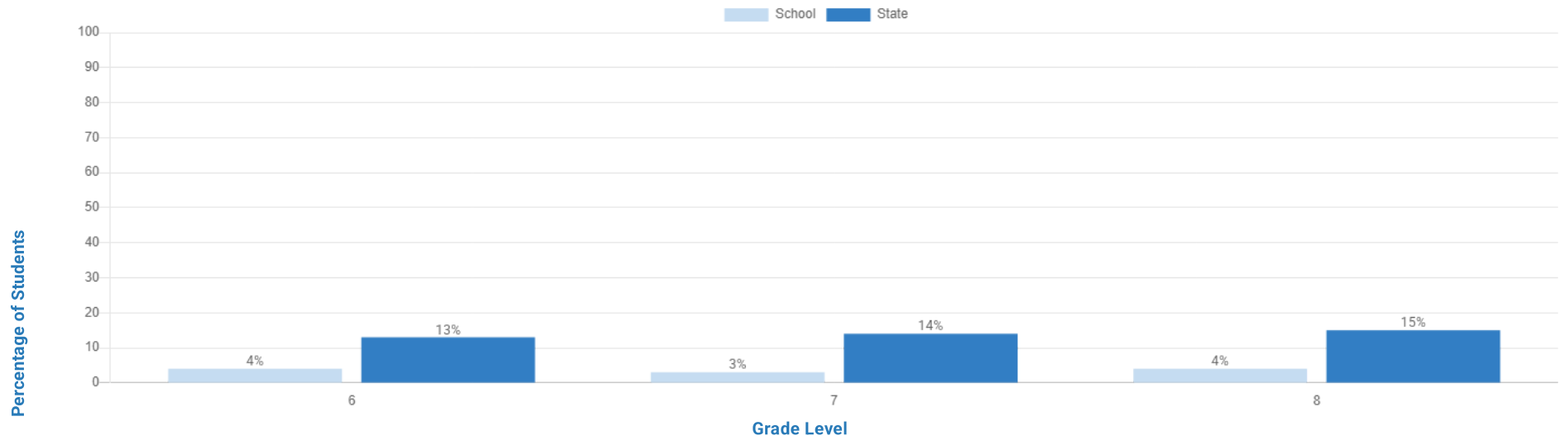

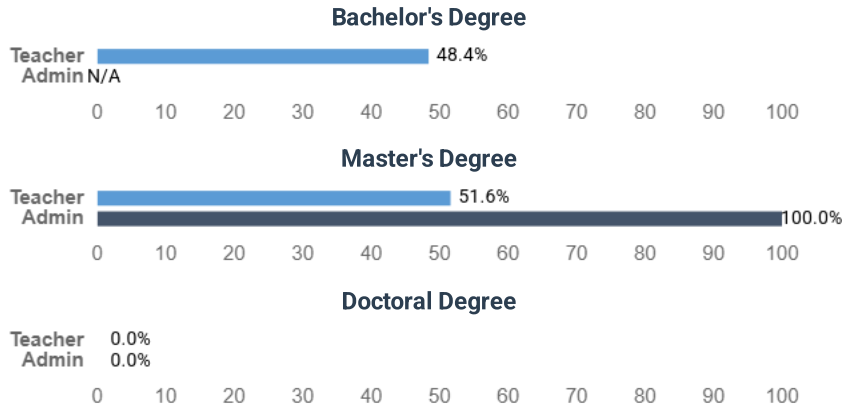

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Briarcliff Middle School staff regularly engage in professional development through monthly Professional Development meetings, online webinars/modules, professionally run workshops, and collegial approaches such as peer coaching.



Student Supports and Services:

Briarcliff Middle School has a School Counselor and Special Services Case Manager who works closely with the Administration. We also have an NTSS team that assists in supporting students considered at-risk. We have an effective program for struggling students called strategies and intervention program. Students also have access to an after school homework program on Mondays and Wednesdays.

Briarcliff Middle School created a school wellness committee last year. This committee assisted in the creation and implementation of a school culture survey. Briarcliff has also partnered with the Director of Special Services and an outside agency (Sage Thrive) to provide monthly training to our staff in the areas of student and staff wellness, along with strategies to deal with mental health issues in school. Briarcliff has both a Mental Health Team and a Threat Assessment Team as required by the new state mandate.

Mountain Lakes Education Foundation, Laker Sports Club and Friends of the Arts sponsor various grants and fund our students educational, athletic and artistic endeavors. The Principal meets several times a year with a Parent Advisory Council and has 3 open forums for parents to come and meet with him. This year we also coordinated a book study with parents and staff.

School Safety:

Briarcliff Middle School works very closely with the Mountain Lakes Police Department. We recently installed a security vestibule at our main entrance. We have a renovated security camera system with 36 cameras combined inside and outside. The Briarcliff Safety Team meets several times a year to review HIB and discipline data. This team consists of an SRO, Principal, Security Leader, Teachers, and Parents. This team makes recommendations to the school to improve the school culture and overall security of the school.



Technology and STEM:

Briarcliff MS has a computer lab for our computer classes. We also have Chromebook carts for each academic classroom. Each classroom is equipped with a new Aquios Board which does not need a projector. Briarcliff also has started using a makerspace that was recently built.



Attendance:

To address the needs of our students, Briarcliff has facilitated an after school Strategies and Intervention Program which was funded by ESSER funds. The grant funds were also used to help purchase Link-It to help us identify struggling students. We have also used ESSER funds to purchase My Robin which provides our school with supports and resources for our students and staff in the area of mental health.
