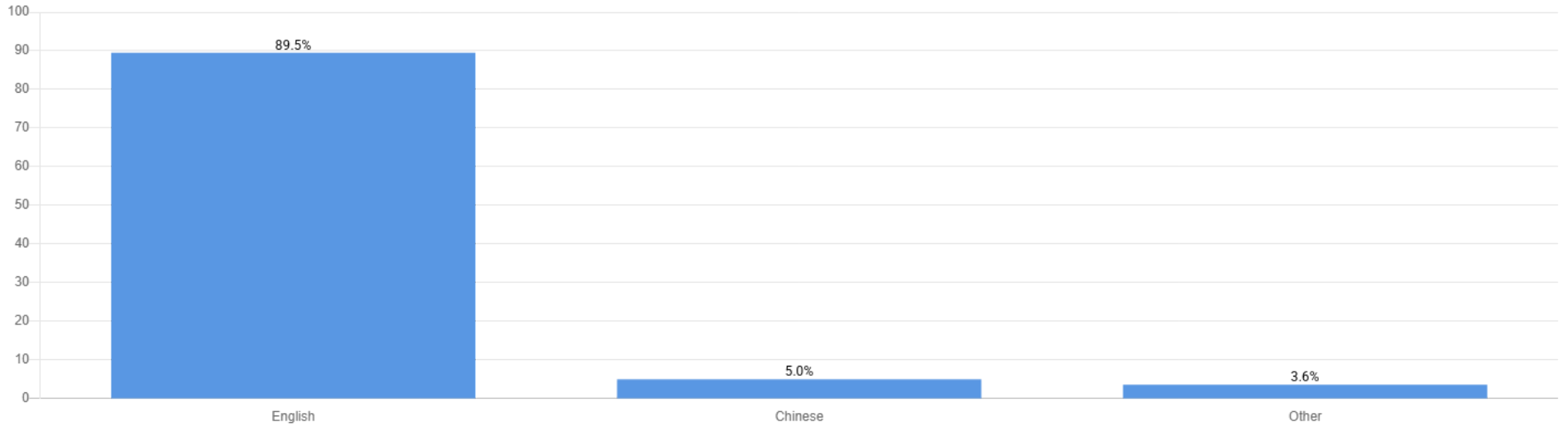

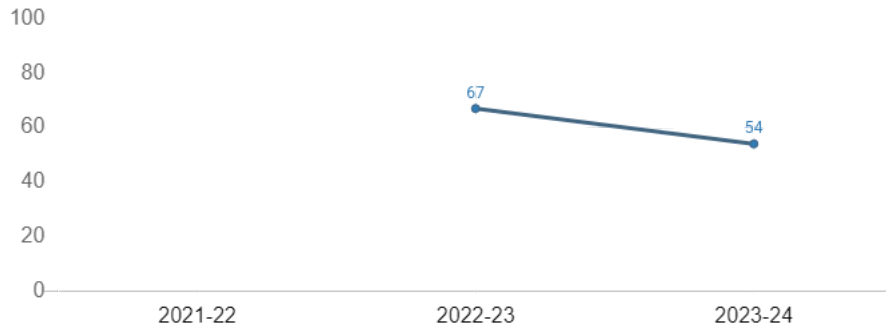

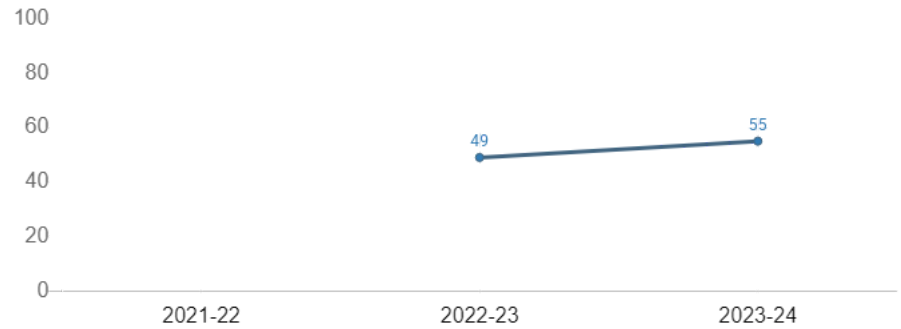

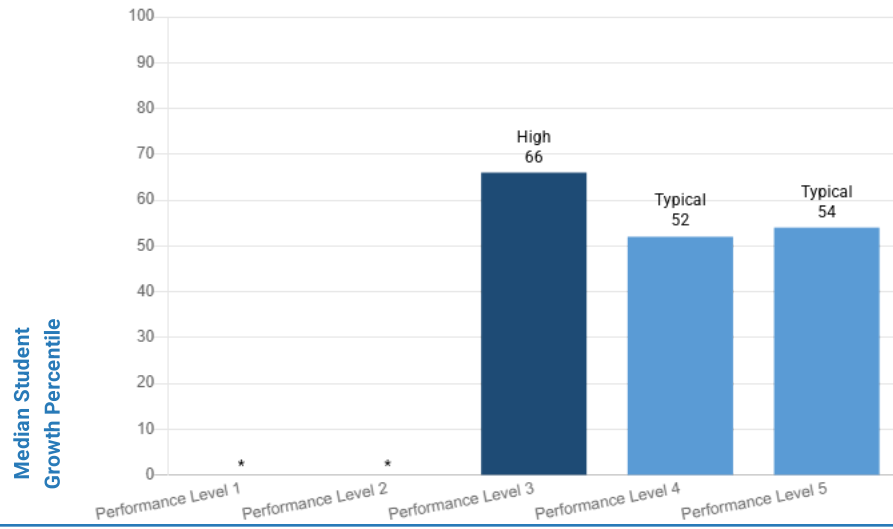

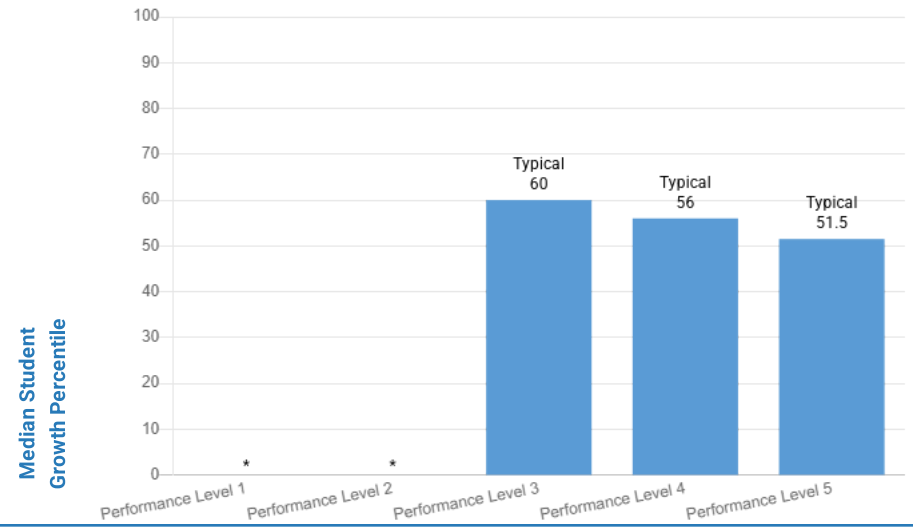

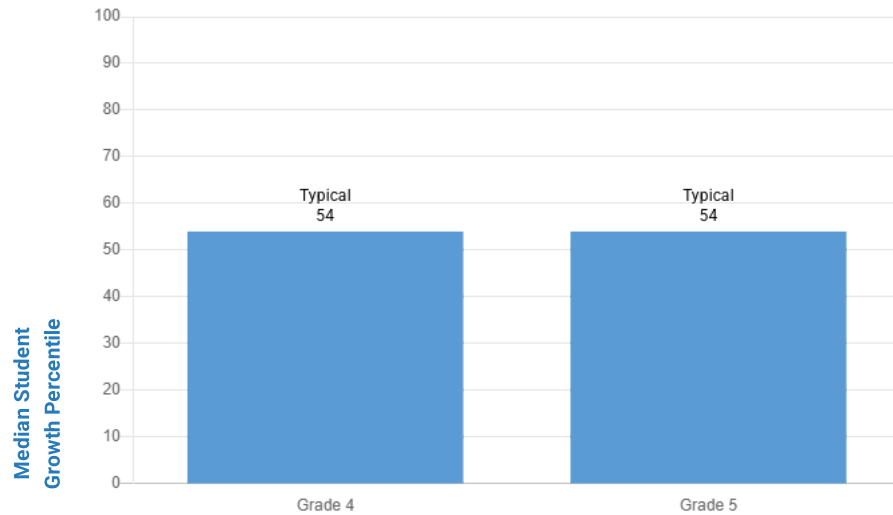

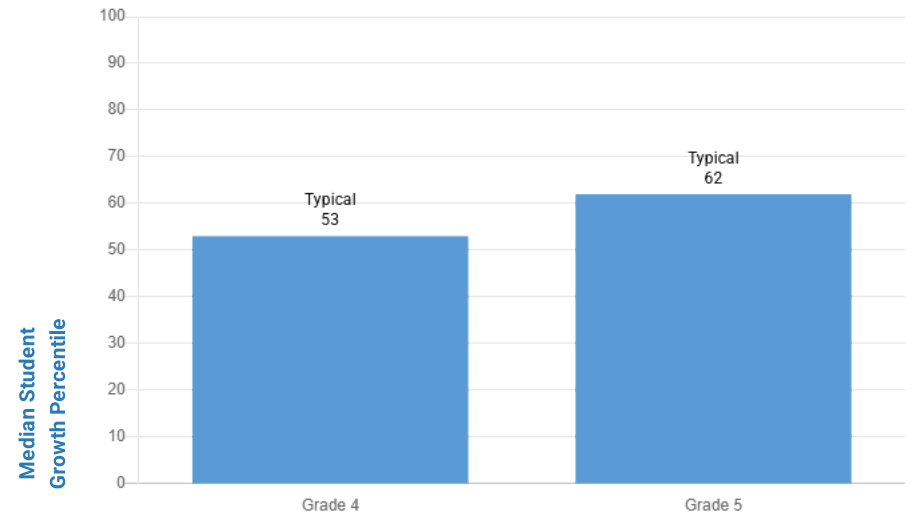

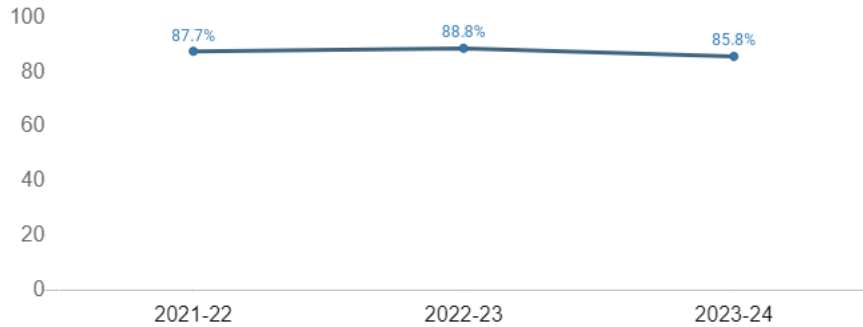

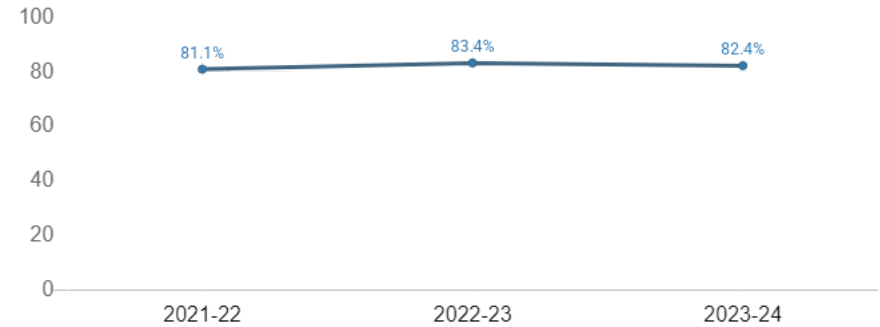
English Language Arts and Mathematics Performance Trends

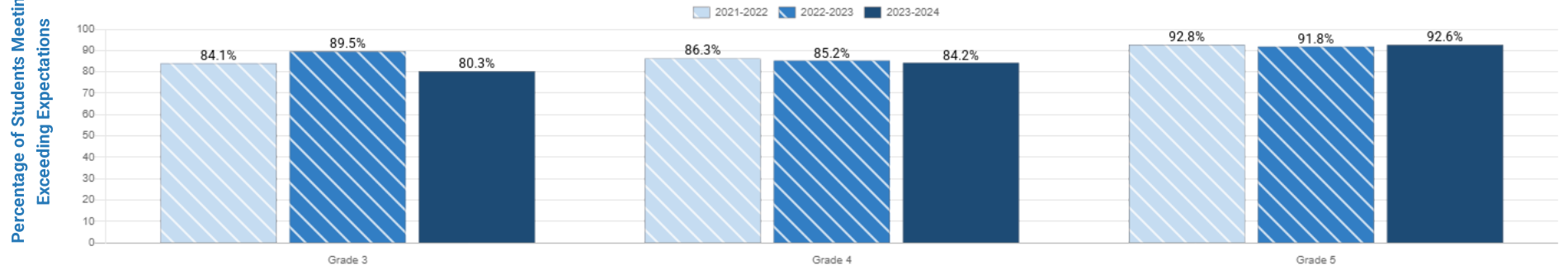

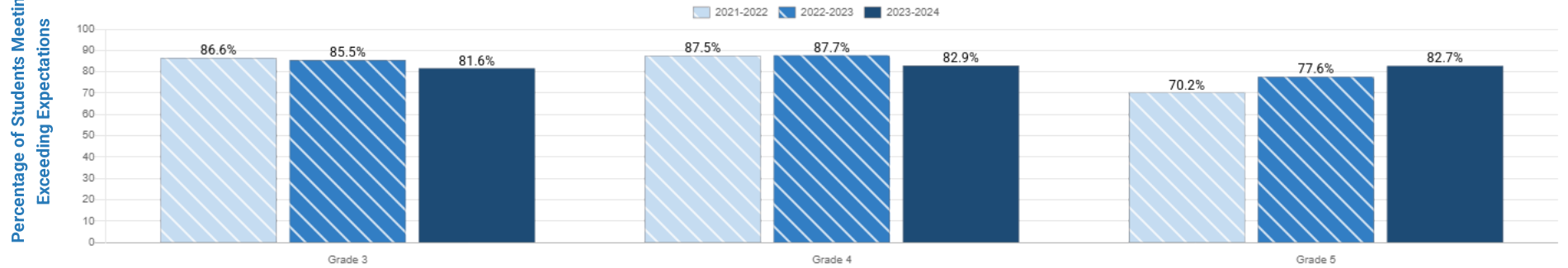

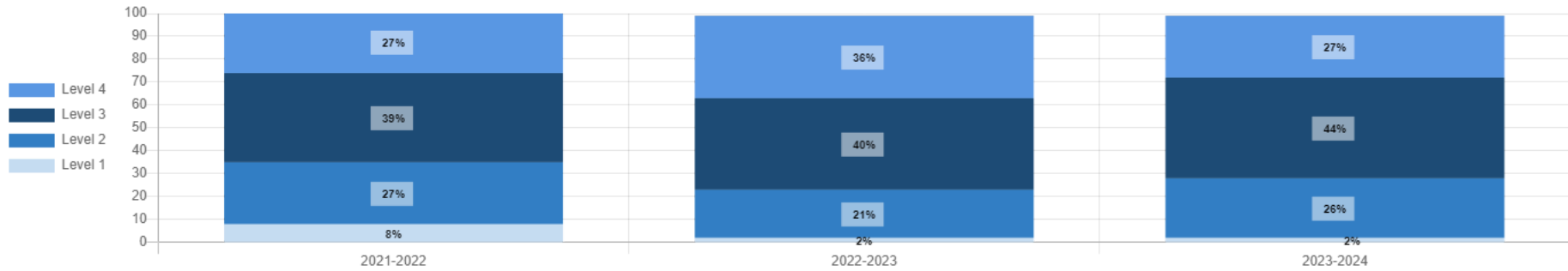

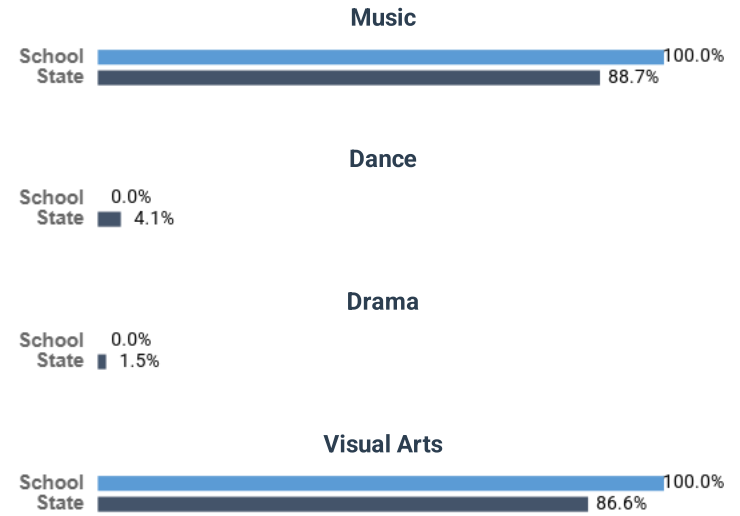

Students enrolled in one or more classes by discipline:



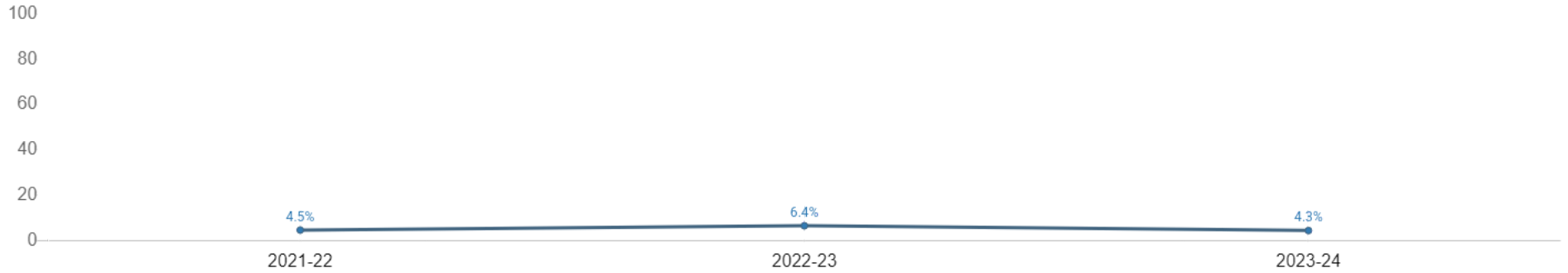

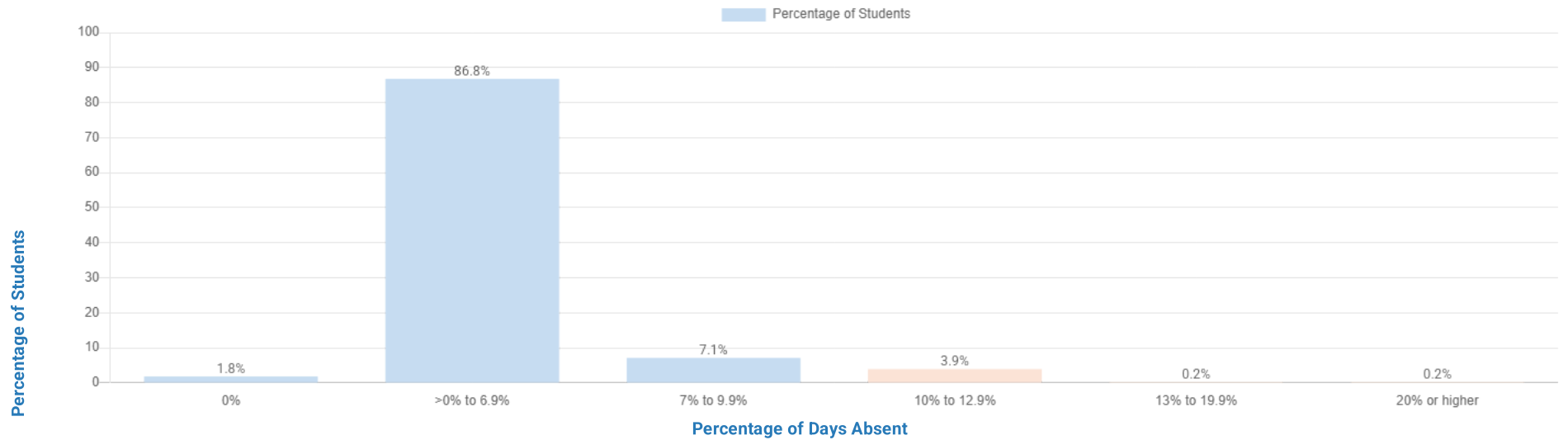

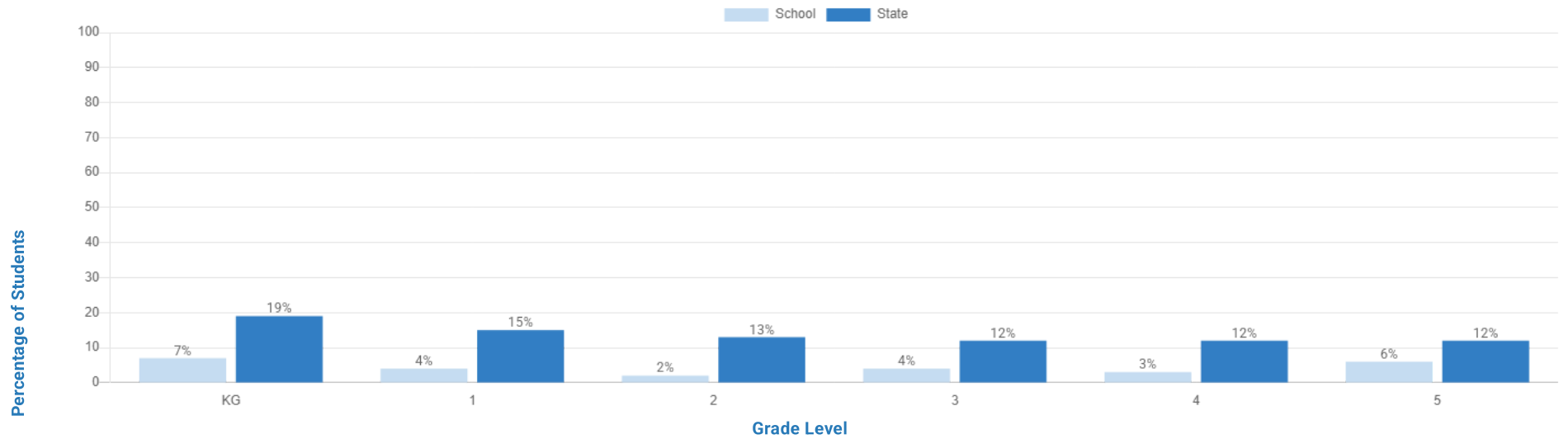

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 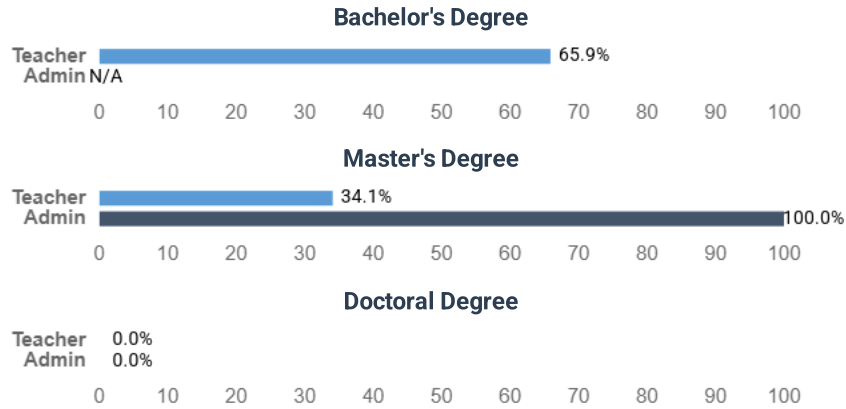

Our Intervention and Referral Services (I&RS) committee is designed to assist teachers and students who are experiencing learning, behavioral, and social and emotional challenges. We also engage in partnerships with related services personnel - OT, PT, Behaviorist and Counseling. We offer a variety of programming for our special education students. We also mainstream students that are deaf or hearing impaired in a supported space. Our full time school counselor also works with staff, students and parents. This year, we partnered with Linkit to utilize the Intervention Manager platform. This platform houses student data and easily updates to include informative reports to track students progress across all tiers of intervention.



Student Health and Wellness:

We recognize the critical elements of Social Emotional Learning. We implement strategies to embrace the whole child through mindfulness and calming techniques. Our Physical Education program is designed to expose students to a wide variety of activities to promote a strong, healthy body. Our lunch provider and School Nurse encourage and provide healthy choices. This year, we launched the Wingman Program where fourth and fifth graders were trained as Wingman Leaders. Wingman leaders then turnkey strategies that inspire others to go above and beyond, instilling in them the courage and leadership to create strong, inclusive school communities. We partnered with MyRobin programming for school wide initiatives like Mantra Day and SEL Day. We introduced monthly pet therapy sessions for students where students spend a few minutes engaged with a pet and school counselor.

Facilities:

Wildwood School was built in the 1950's and has two significant additions over the last decades. Most recently a new state of the art kitchen and cafeteria. All classrooms are equipped with Smartboards and a red cat system to support all of our learners, mobile devices such Chromebooks. Students also enjoy learning in an outdoor classroom space to infuse lessons in our natural environment. We have recently installed new playground equipment, new flooring, a full basketball court and picnic table area was installed not only for students of Wildwood, but for the community.



School Safety:

A robust security plan are developed in collaboration with the Mountain Lakes Police Department. Our School Safety and Security Team meet regularly to update and revise plans as necessary. The team meets after each drill to debrief and discuss. The team also observes drills to gain a deeper understanding of procedures. This year, we will engage in additional training for our team.

Technology and STEM:

Our Library and Computer Lab were redesigned to allow for Maker Space projects, coding opportunities and long term STEM activities. Chromebooks, smart tv/smartboards are accessible to all students.



Early Childhood Education:

In collaboration with all preschool and early intervention schools in the area, we are able to align skills and curriculum to ensure kindergarten readiness. Teachers from the local preschools, including the Ivy Hall program within the Mountain Lakes Public School system, engage in articulation during Kindergarten Orientation to learn more about the students that will transition to kindergarten.
