













Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

We offer a comprehensive college preparatory program with Honors and AP courses in Math, English, Science, World Languages, Social Studies, Business, Music, Art, and Computer Science. Additionally, students can participate in dual-enrollment programs with NJIT and Fairleigh Dickinson University. Our elective offerings are diverse, spanning all subject areas, including Culinary Arts, Auto Repair, CAD, and Industrial Arts Technology. Our one-to-one Chromebook program supports access to core and supplemental texts, while Google Classroom extends learning beyond the classroom. For courses not available in person, students can enroll in online classes through Virtual High School. The World Language curriculum emphasizes communication, cultural appreciation, and global connections. We offer a STEM Pathways program that provides enrichment, hands-on collaboration, professional experiences and opportunity for distinction. Homework typically requires about 40 minutes per major subject.

Staff and Professional Learning:

Our professional development efforts have been centered around two key district strategic goals: deeper learning and wellness. To support these goals, our administrators have participated in numerous courses, conferences, and readings on deeper thinking and visible thinking strategies. This knowledge has been shared with staff through department meetings, building-level initiatives, and a district-wide deeper thinking focus group. We are also committed to fostering student wellness and social-emotional learning (SEL), working with teachers to embed equity, opportunity, empathy, and kindness into instruction, classroom management, and school-wide procedures. Additionally, we emphasize teacher collaboration by dedicating time for colleagues to work, plan, and reflect together.
