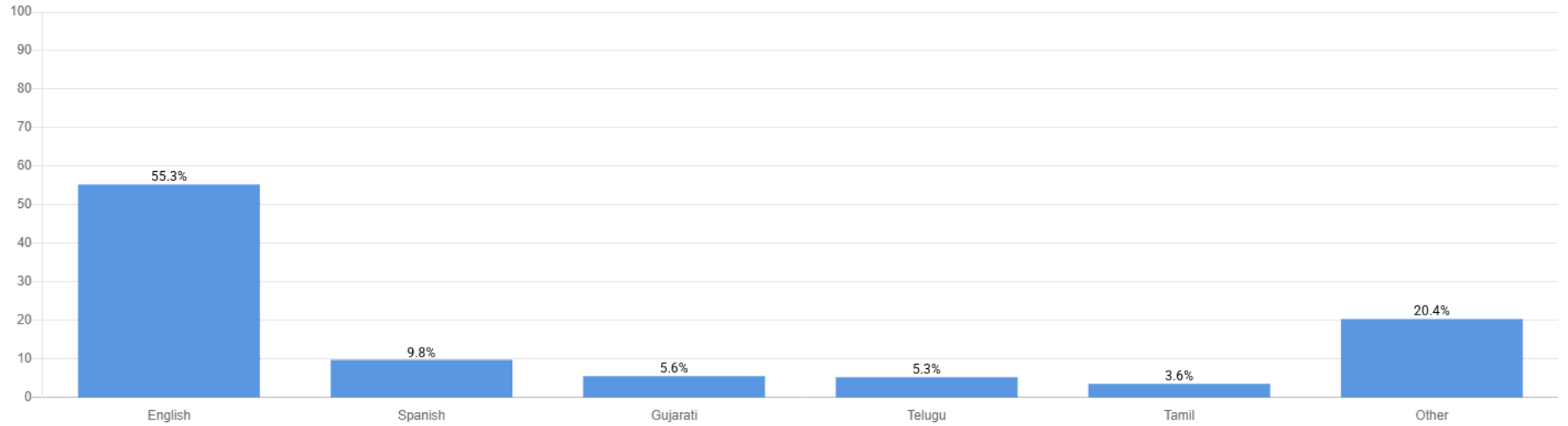

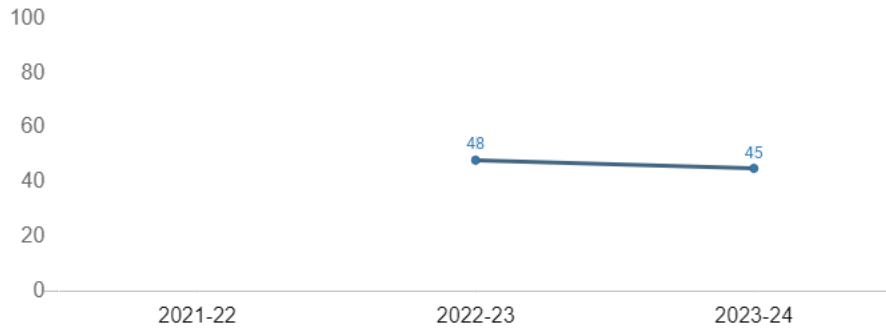

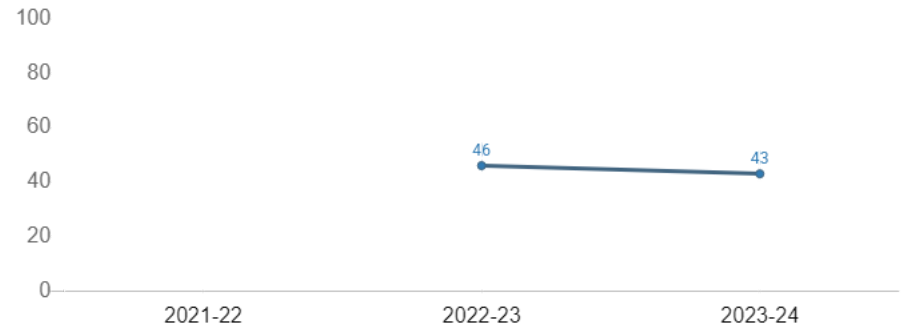

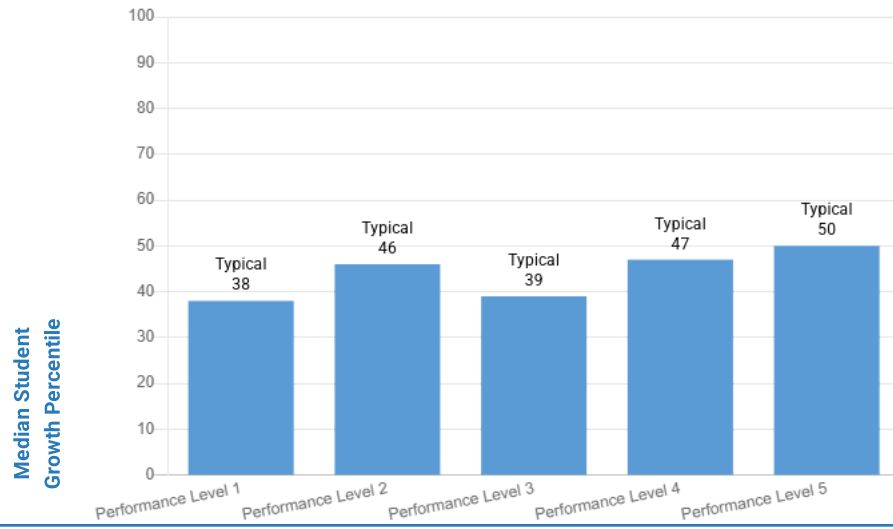

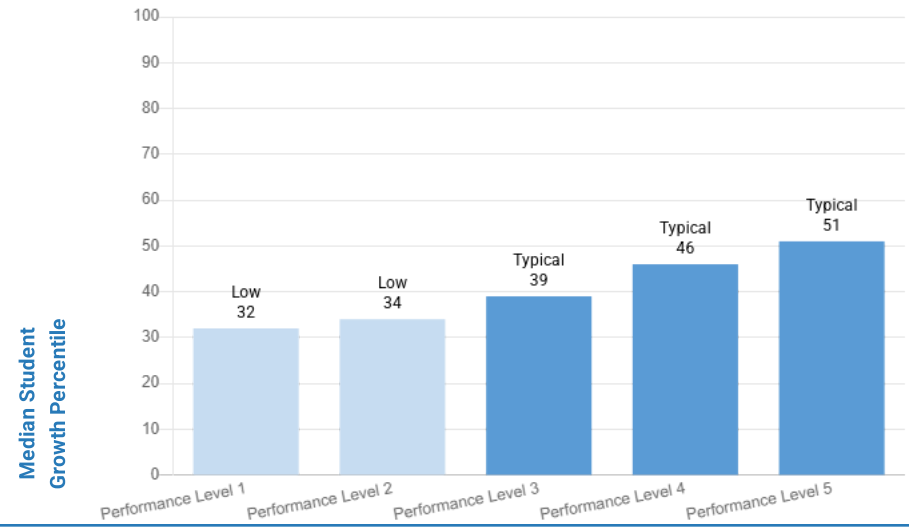

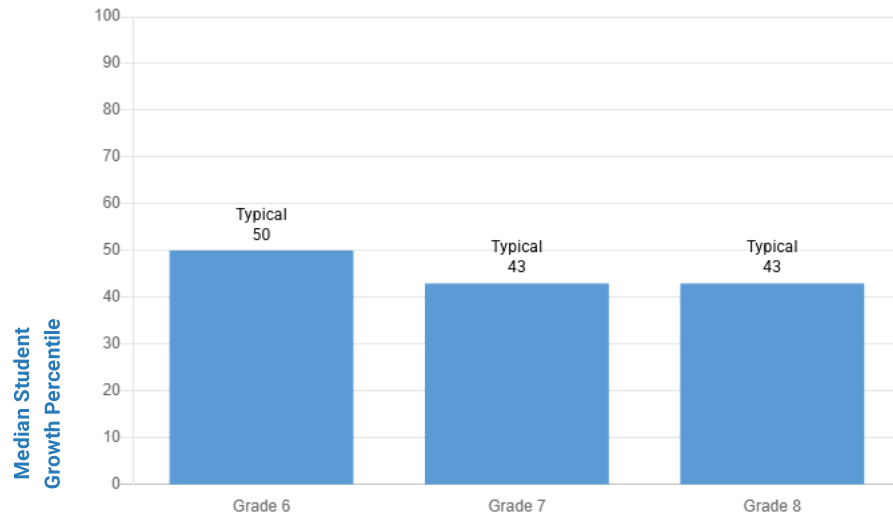

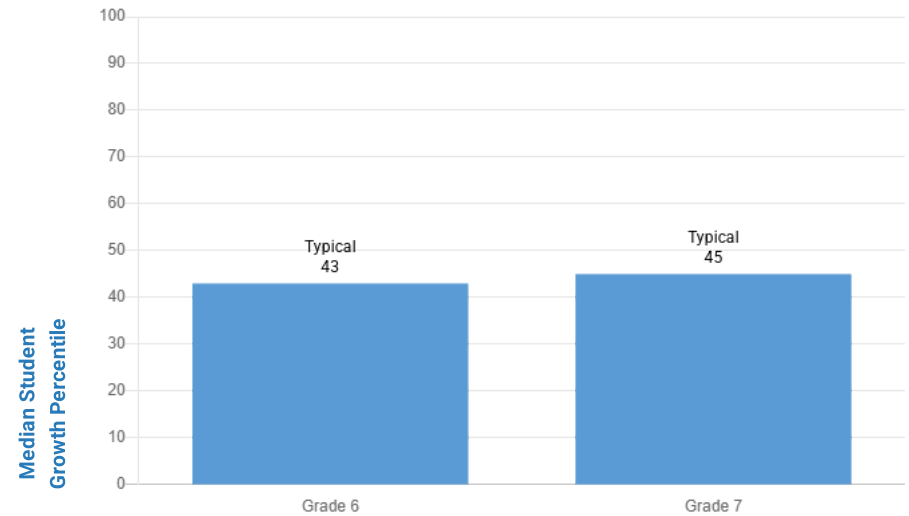

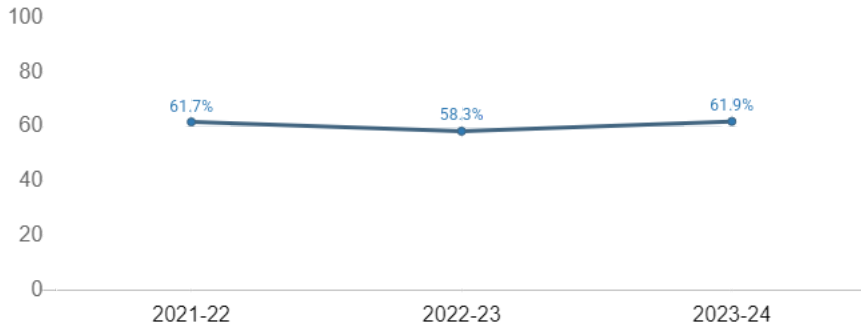

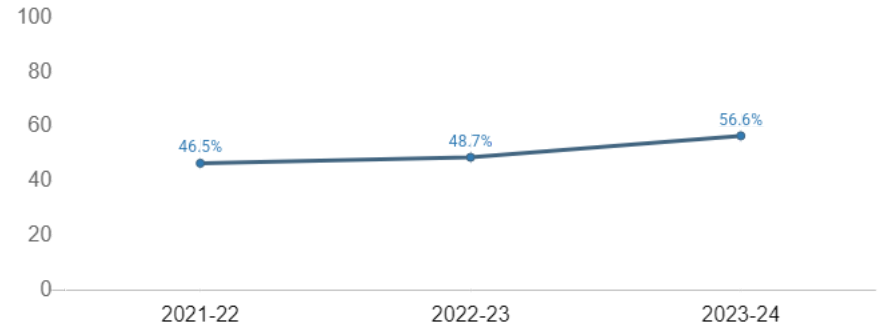
### English Language Arts and Mathematics Performance Trends

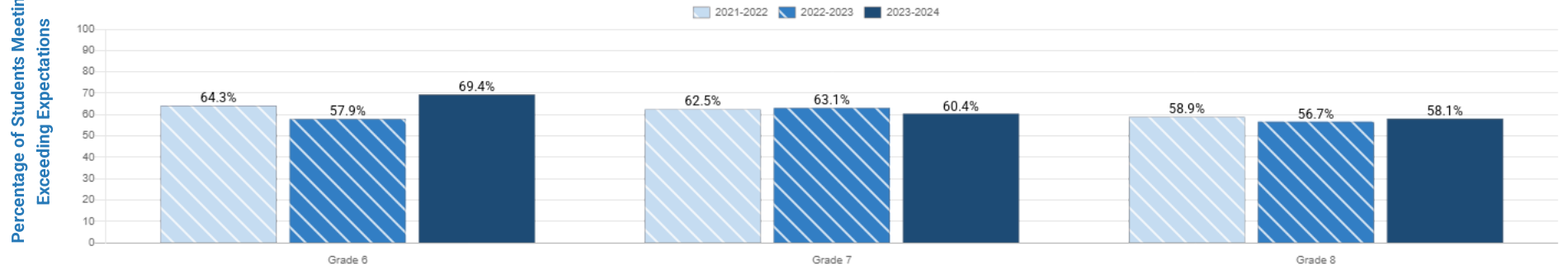

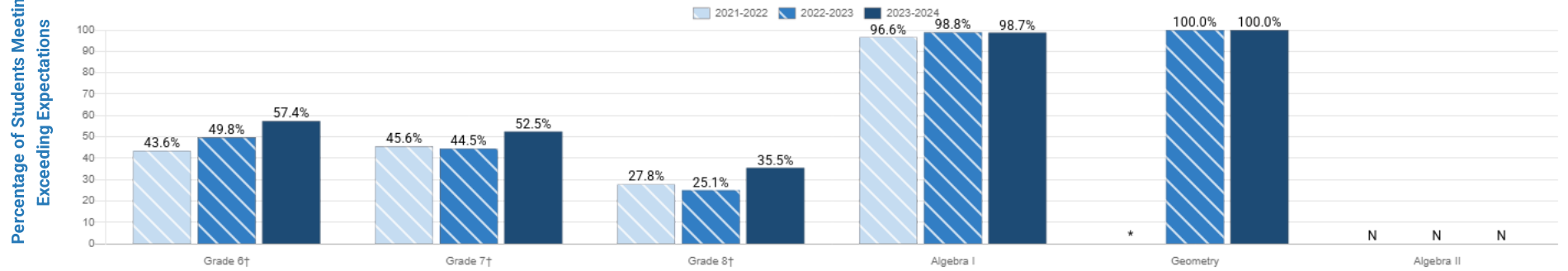

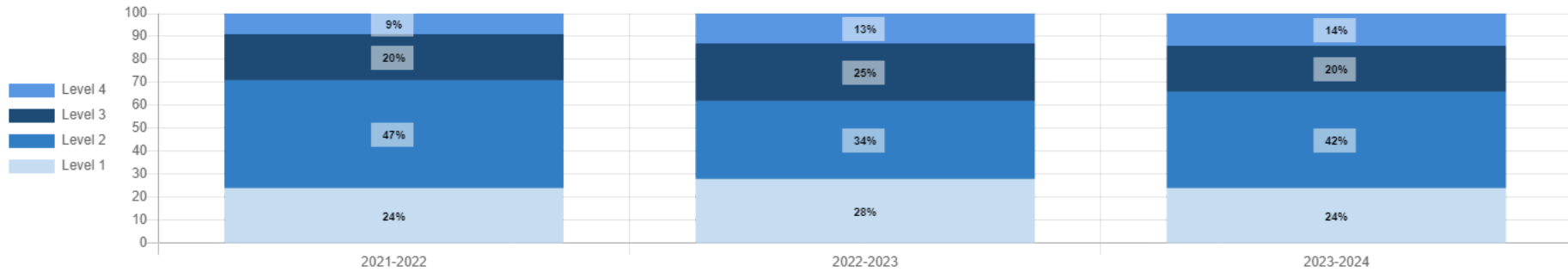

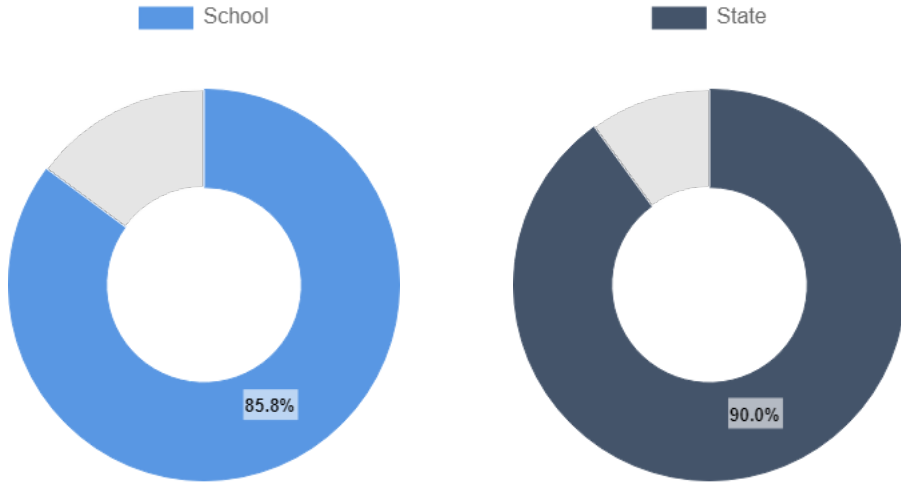

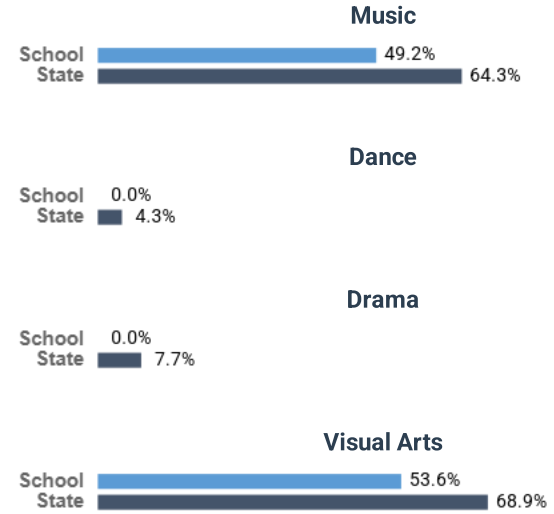

Students enrolled in one or more classes by discipline:



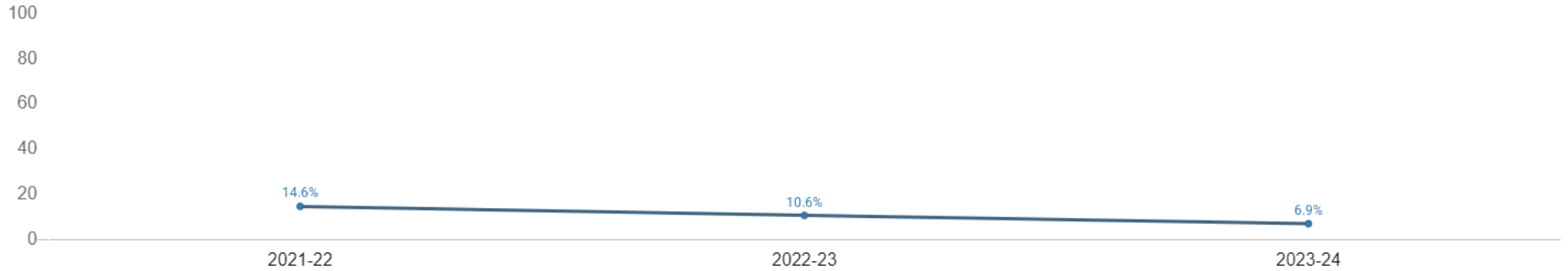

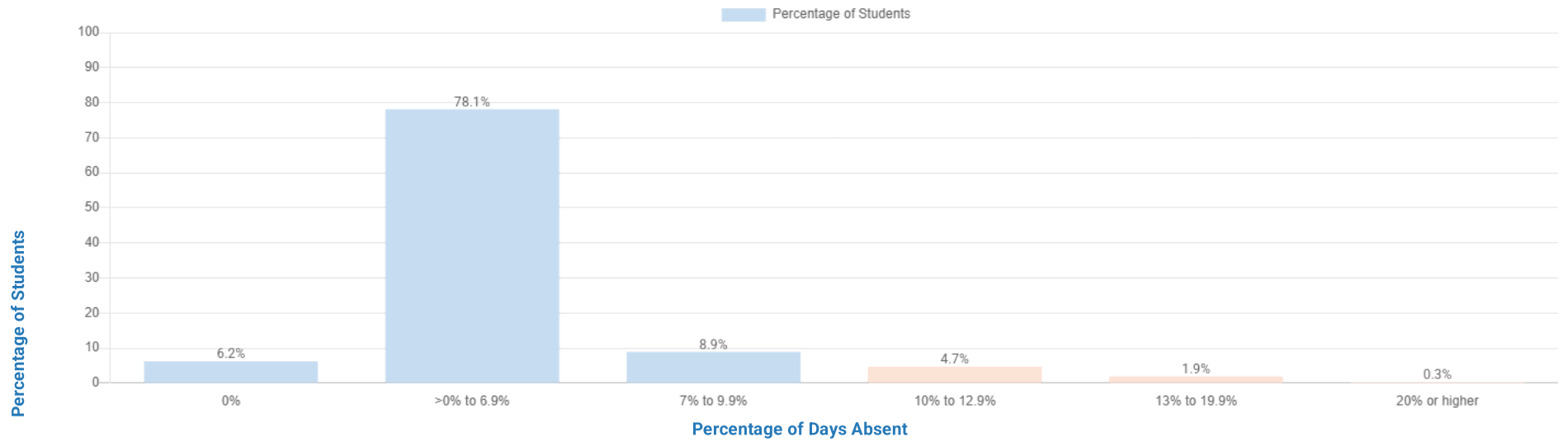

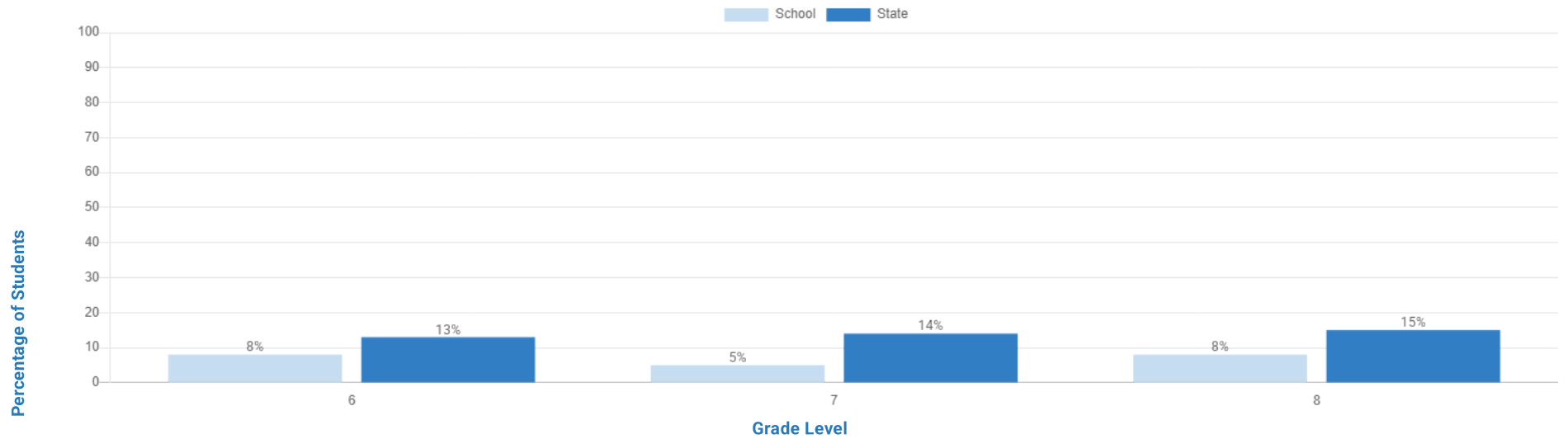

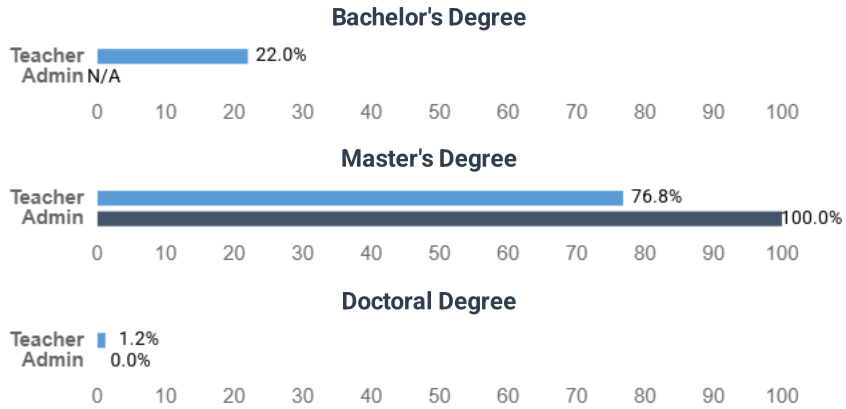

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

In Math, we offer accelerated courses for Grades 6-8, with options for both Algebra 1 and Geometry in Grade 8. Advanced levels are available in Social Studies and ELA for Grades 7-8, and we provide an advanced Science option for 8th-grade students. Our elective offerings include Art, Robotics, Coding, Culinary Arts, Literature, Music, Industrial Arts, and Engineering, supporting the exploratory focus of middle school education. In World Languages, students have the option to study Spanish, French, or Italian. Many courses utilize Google Classroom, giving students convenient access to course materials and resources both at school and at home. Homework is designed to extend learning and typically requires 30-45 minutes per subject.

### Staff and Professional Learning:

In ELA, we continue to emphasize the integration of the Reading and Writing Workshop model across our courses. We have established literacy centers staffed by literacy coaches who provide professional development on best practices in literacy instruction. In Social Studies, teachers engage students in critical thinking through primary and secondary source analysis, as well as Document-Based Question (DBQ) activities. Mathematics teachers, now in their third year of implementing the Math Workshop model, are continually refining strategies to promote Growth Mindsets in students. We place a strong emphasis on teacher collaboration, dedicating time for colleagues to work, plan, and evaluate together. At the middle school level, we hold weekly advisory groups focused on teaching essential social-emotional learning (SEL) skills and fostering relationship-building among students.



### Student Supports and Services:

Special Education programs: Multiple Disabilities Program, Language Learning Disabilities Program, Emotional Regulation Impairment (ERI) Program, Resource Replacement Program, In-class Resource Support. Support Services From: Physical Therapy, Occupational Therapy, Speech and Language Services, Teacher of the Deaf and Hard of Hearing, Behaviorist, School Counselors, SAC, Social Worker, School Psychologist, LDT-C, General Education Social Worker, Intervention and Referral Services. ELL students are provided at least one full period of ESL instruction per day from a certified ESL teacher. Students in High-Intensity ESL programs receive 2 periods of ESL per day from a certified ESL teacher.



### Student Health and Wellness:

School Breakfast program is offered. Students engage in PE and Health every day for 46 minutes. There is a Certified Food Handler as the Food Service Manager. Standards based nutrition education is offered in a variety of subjects.
