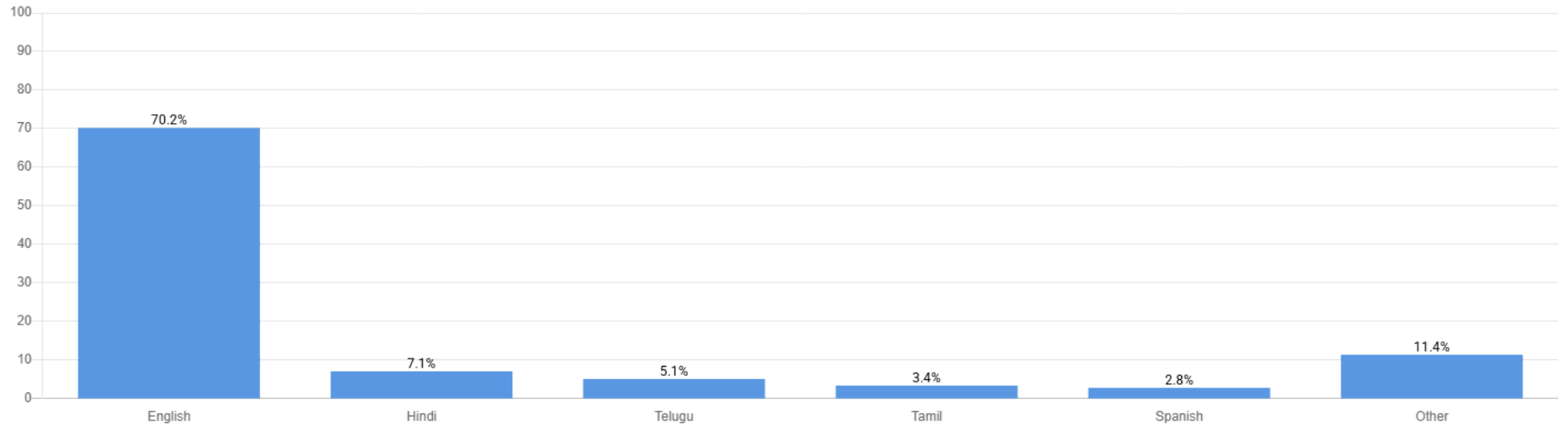

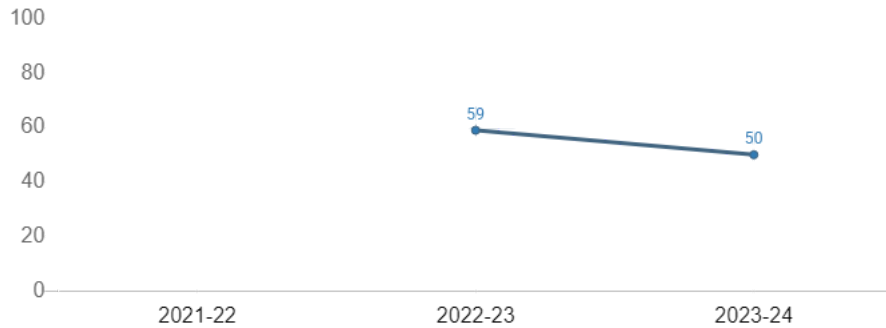

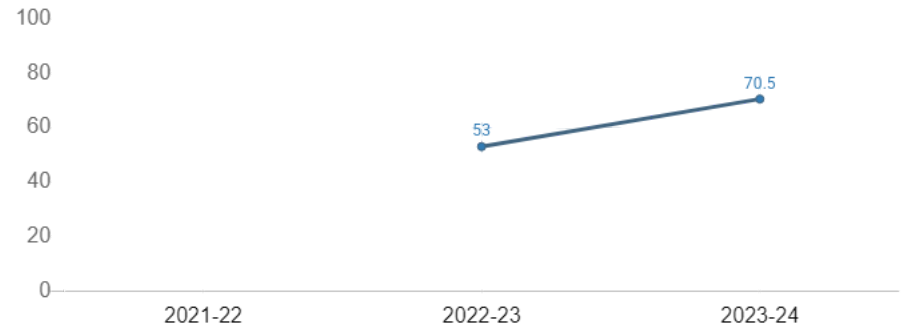

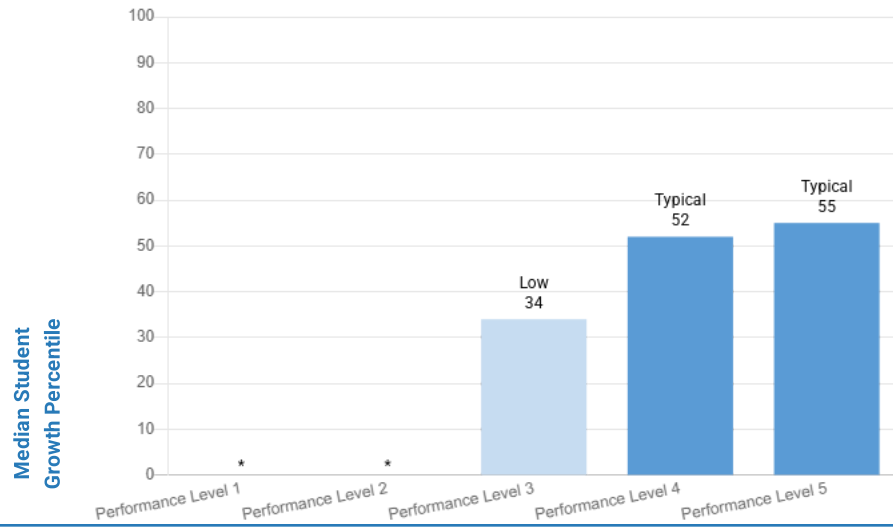

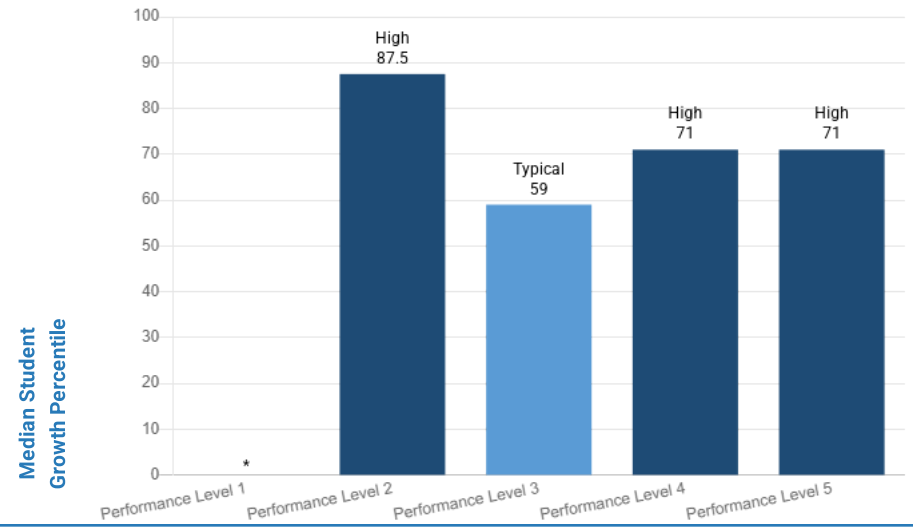

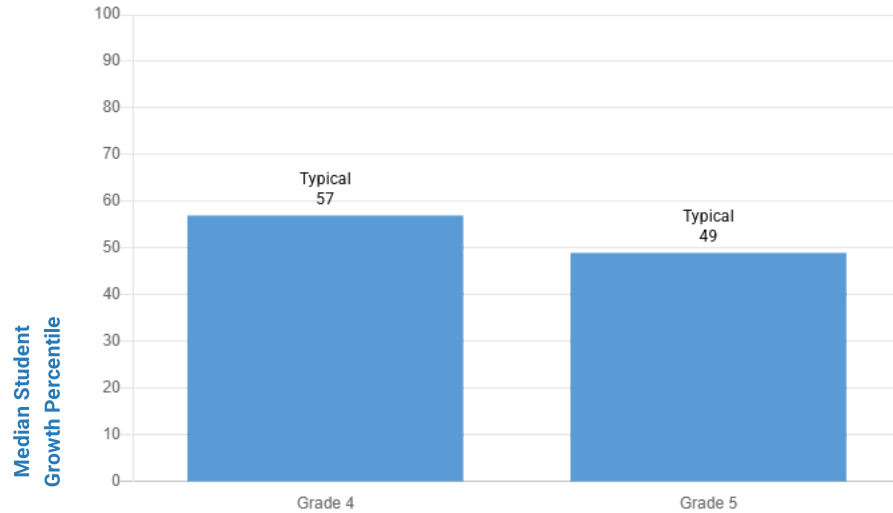

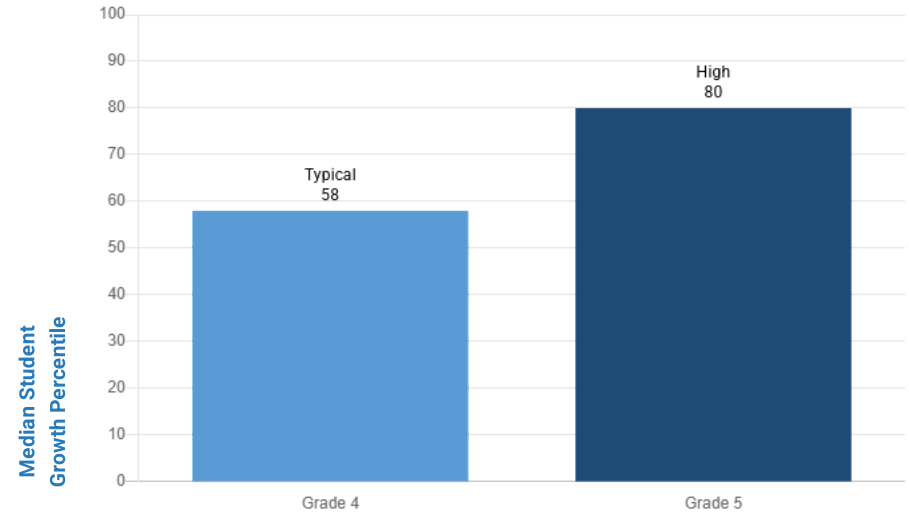

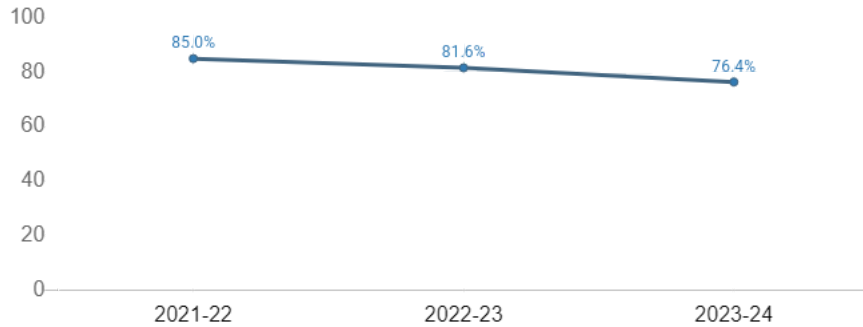

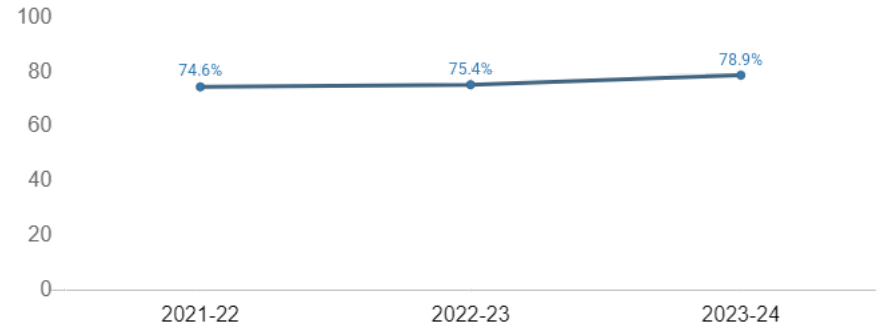
### English Language Arts and Mathematics Performance Trends

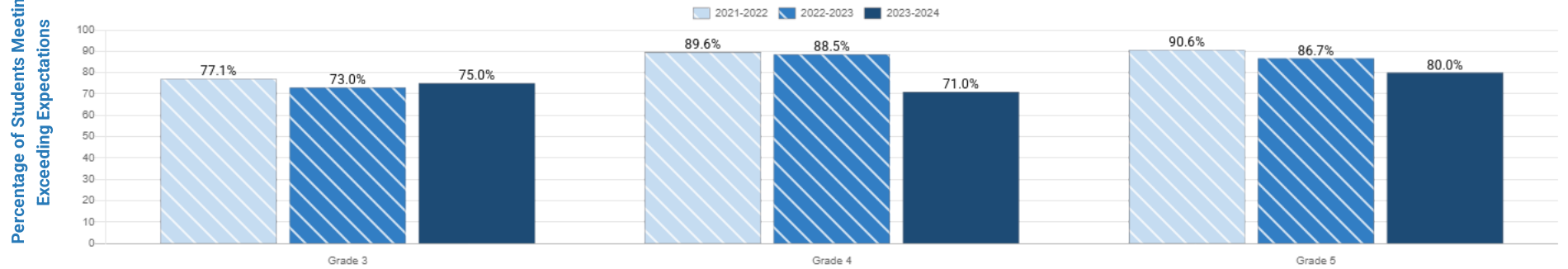

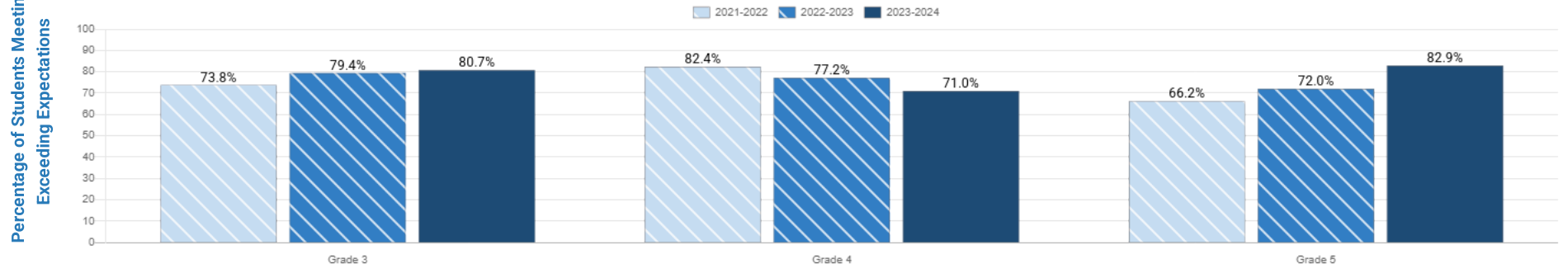

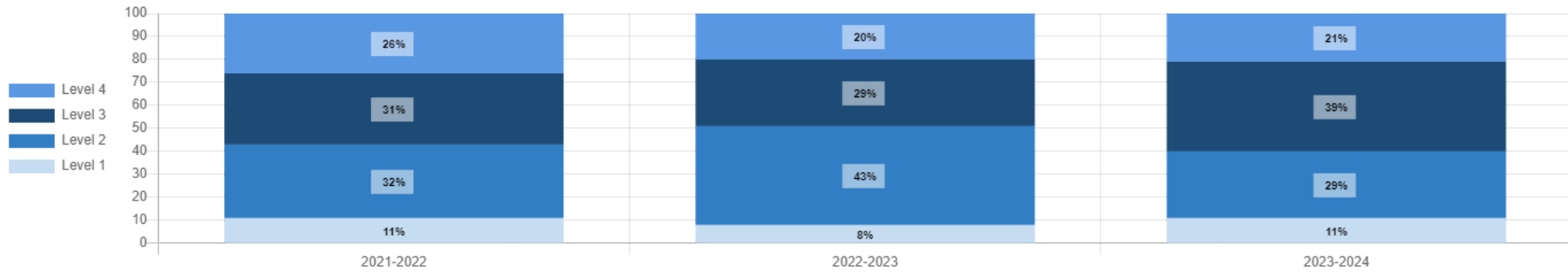

**Students enrolled in one or more classes by discipline:**



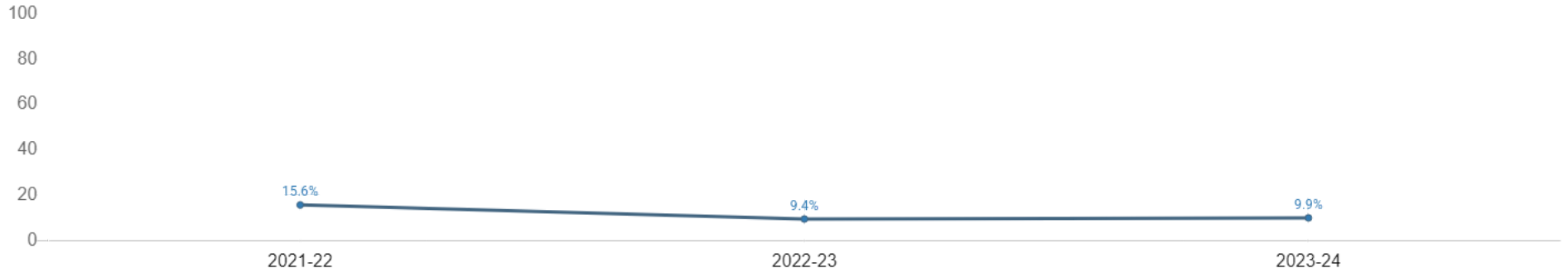

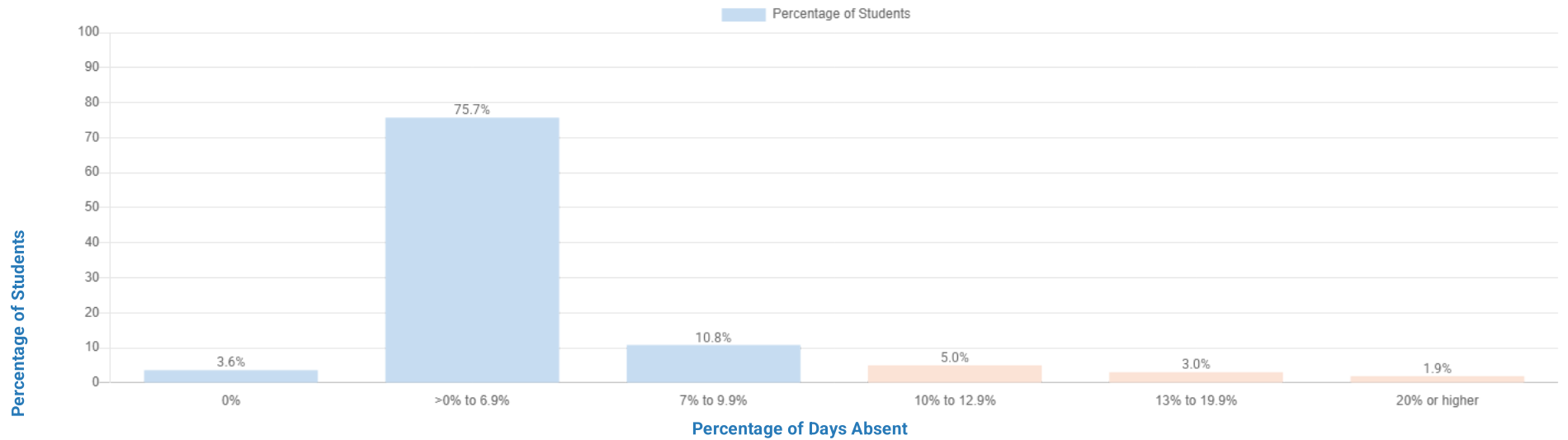

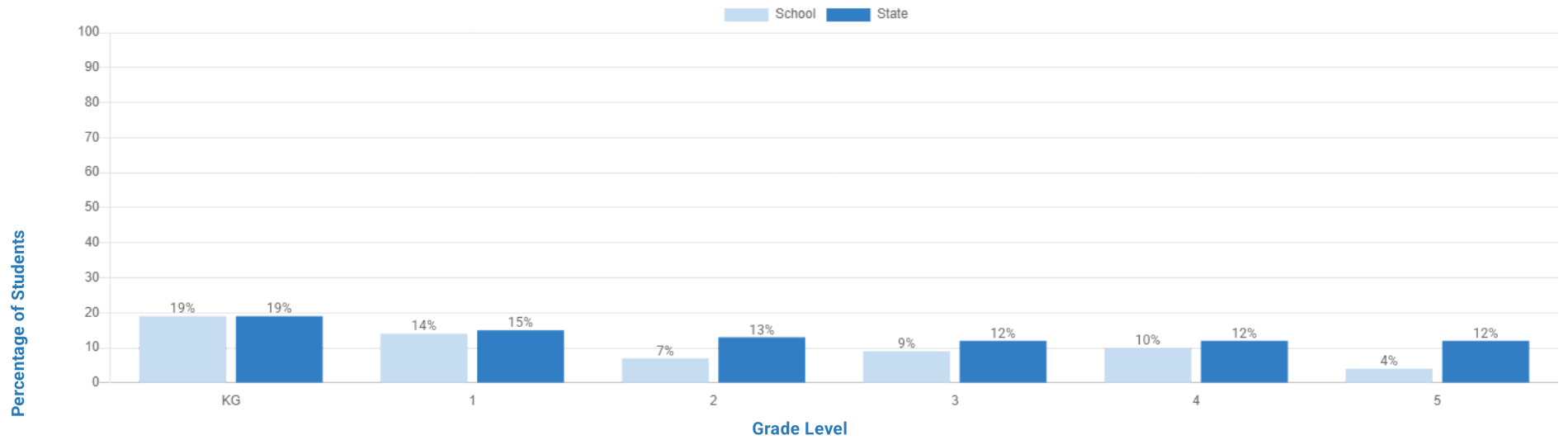

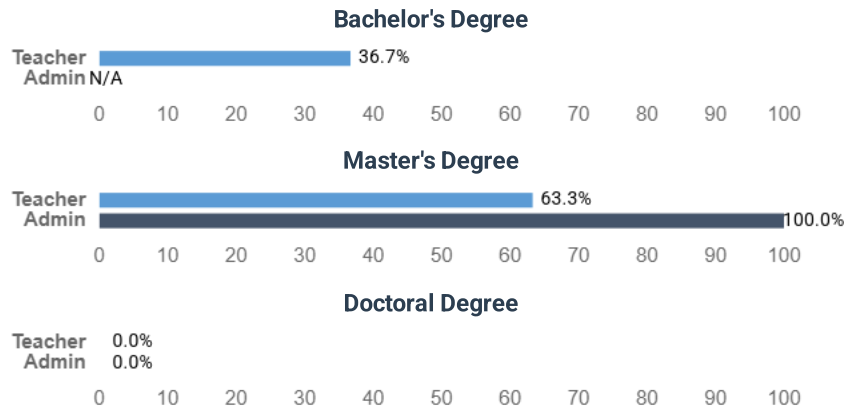

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Mission, Vision, Theme:

The mission of the Parsippany-Troy Hills Township School District, in partnership with families and the greater community, is to challenge and nurture all students academically and to develop confident learners who are compassionate, generous, appreciative, and invested in their diverse world. ### Courses, Curriculum, Instruction:

For Literacy, we implement the Reading and Writing Workshop model, while our Math curriculum is guided by Envision Math. Envision includes an online homework component accessible to both students and parents, and it allows teachers to create personalized learning plans for individual students. In Science, students engage with the FOSS (Full Option Science System), which offers an interactive online platform featuring virtual labs, animations, and virtual field trips. Our Social Studies curriculum is supported by Nystrom Young Citizens, providing leveled readers to strengthen literacy skills alongside digital resources. Our homework policy allocates 10 minutes per subject.



### Sports and Athletics:

Physical education is a very important part of the total education of a child. Our program contributes to the development of the whole student, including the areas of physical abilities (psychomotor), intellectual development (cognitive), and a sense of fair play and good sportsmanship (affective behaviors). Each student is unique and is encouraged to do their best.



### Clubs and Activities:

Our students are offered many opportunities to get involved outside the classroom, allowing them a chance to grow academically and socially. They can participate in Art Club, Music Club, Band, Strings, Chess Club, Kindness Club, Battle of the Books, and Basketball. Leadership is fostered through K-Kids, Peer Tutors, Safety Patrol, and Student Council.

### Staff and Professional Learning:

During our Professional Development Days and meetings, we provide training on implementing the Reading/Writing Workshop, Foundations, and Leveled Literacy Intervention (LLI). Since this is our first year with Envision Math, we have dedicated significant time to hosting presenters for staff and reinforcing key skills and strategies through department meetings. Science teachers participate in collaborative work by grade level and subject area to ensure consistency and innovation. Additionally, we continue to focus on student wellness and social-emotional learning (SEL), striving to integrate equity, opportunity, empathy, and kindness into our instruction, classroom management, and building procedures. At the elementary level, we incorporate daily morning meetings to teach essential SEL skills and foster strong relationships.



### Student Supports and Services:

Special Education programs: Preschool Disabled, Autism, Multiple Disabilities Program, Language Learning Disabilities Program, Emotional Regulation Impairment (ERI) Program, Pull Out Resource Support Program, In-class Resource Support. Support Services From: Physical Therapy, Occupational Therapy, Speech and Language Services, Teacher of the Deaf and Hard of Hearing, Behaviorist, School Counselors, SAC, Social Worker, School Psychologist, LDT-C, Reading Specialist, Basic Skills Math Instructor, Interventionists. Additional: Supplemental before school ELA and Math Instruction, Intervention and Referral Services, Character Education, College and Career Counseling. Sanford Harmony SEL program in all classrooms. ELL students are provided at least one full period of ESL instruction per day from a certified ESL teacher. Students in High-Intensity ESL programs receive 2 periods of ESL per day from a certified ESL teacher.



### Student Health and Wellness:

School Breakfast program is offered. Students have PE twice a week for 30 minutes and receive health instruction plus brain breaks/SEL three times a week for 30 minutes from the classroom teacher. Students also engage in 30 minutes of daily recess. Sanford Harmony SEL program in all classrooms. There is a Certified Food Handler as the Food Service Manager. Standards based nutrition education is offered in a variety of subjects.

Mt. Tabor School ensures student success by utilizing a variety of excellent approaches and programs. Differentiated approaches include peer collaboration, authentic tasks, learning centers, guided reading groups, and the use of instructional technology in both the classroom and computer lab. Math instruction is based on the rigorous and challenging Common Core Standards and includes the use of manipulatives and web-based technology. Language Arts instruction provides integrated experiences in reading, writing, listening, and speaking using a workshop approach. Science instruction emphasizes the New Generation Science Standards with engaging STEAM activities. We also have specialists in physical education, art, vocal and instrumental music, guidance, and library/media. Other available services include special education, a program for the academically gifted, speech, basic skills, and ESL. In addition, our Child Study Team ensures that students in need are placed in appropriate programs. Parent involvement is a vital component of Mt. Tabor's education program. Our PTA sponsors cultural arts programs that support our instructional goals and numerous parent volunteers assist with classroom activities virtually, lend a helping hand in the media center when possible, and serve on decision-making committees.
