
















English Language Arts and Mathematics Performance Trends











Students enrolled in one or more classes by discipline:









Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators



Accountability Summary by Student Group - 2023-24 School Year

For Literacy, we implement the Reading and Writing Workshop model, while our Math curriculum is guided by Envision Math. Envision includes an online homework component accessible to both students and parents, and it allows teachers to create personalized learning plans for individual students. In Science, students engage with the FOSS (Full Option Science System), which offers an interactive online platform featuring virtual labs, animations, and virtual field trips. Our Social Studies curriculum is supported by Nystrom Young Citizens, providing leveled readers to strengthen literacy skills alongside digital resources. Our homework policy allocates 10 minutes per subject.



Sports and Athletics:

Foundational skills for various sports are offered through a comprehensive physical education curriculum. These physical education foundational skills also teach children the value of sportsmanship and physical wellness to lead a healthy and happy lifestyle.



Clubs and Activities:

Students have the opportunity to participate in numerous experiences which enhance their education and community awareness. Activities include but are not limited to: Student Council (i.e. food/toy drives), Junior Achievement, Coding, Sign-Language, K-Kids, Jr. Great Books, Legos and Yoga.

Staff and Professional Learning:

During our Professional Development Days and meetings, we provide training on implementing the Reading/Writing Workshop, Foundations, and Leveled Literacy Intervention (LLI). Since this is our first year with Envision Math, we have dedicated significant time to hosting presenters for staff and reinforcing key skills and strategies through department meetings. Science teachers participate in collaborative work by grade level and subject area to ensure consistency and innovation. Additionally, we continue to focus on student wellness and social-emotional learning (SEL), striving to integrate equity, opportunity, empathy, and kindness into our instruction, classroom management, and building procedures. At the elementary level, we incorporate daily morning meetings to teach essential SEL skills and foster strong relationships.



Student Supports and Services:

Special Education programs: Preschool Disabled, Autism, Multiple Disabilities Program, Language Learning Disabilities Program, Emotional Regulation Impairment (ERI) Program, Pull Out Resource Support Program, In-class Resource Support. ELL students are provided at least one full period of ESL instruction per day from a certified ESL teacher. Students in High-Intensity ESL programs receive 2 periods of ESL per day from a certified ESL teacher.

School Breakfast program is offered. Students have PE twice a week for 30 minutes and receive health instruction plus brain breaks/SEL three times a week for 30 minutes from the classroom teacher. Students also engage in 30 minutes of daily recess. Sanford Harmony SEL program in all classrooms. There is a Certified Food Handler as the Food Service Manager. Standards based nutrition education is offered in a variety of subjects.

Other Information:

Northvail continues to be a school proud of the high expectations it has for student achievement in conjunction with the development of students' interpersonal skills, personal and social responsibility, and self esteem. Programs are offered which meet the needs and diverse learning styles of all our students in kindergarten through fifth grade. Students learn mainly in a small group format that allows for one on one student interaction with the teacher. Instruction is planned to employ a hands on multi-sensory approach to learning, incorporating kinesthetic, tactile, visual and aural learning styles. Interdisciplinary connections and technology are integrated throughout the various subject area curricula, reinforcing skills needed in the 21st century. Each fifth grader has a one-to-one chromebook device. Additionally, students receive weekly instruction by certified specialists in physical education, vocal and instrumental music, library/media, and art. Other services offered to students include: a guidance program with a full-time guidance counselor, a full-time nurse, a Child Study Team, special education, speech, OT and PT sessions, reading and mathematics basic skills instruction as well as Gifted Reach Out (GRO) and English as a Second Language (ESL) programs. Parent involvement at Northvail School is integral to effective learning and development of skills. The Northvail Community encourages parents to work with their child at home to reinforce learning. Furthermore, every child is provided enrichment activities (cultural arts assemblies, field trips, etc.) organized and funded by the ongoing efforts of the Northvail PTA.
