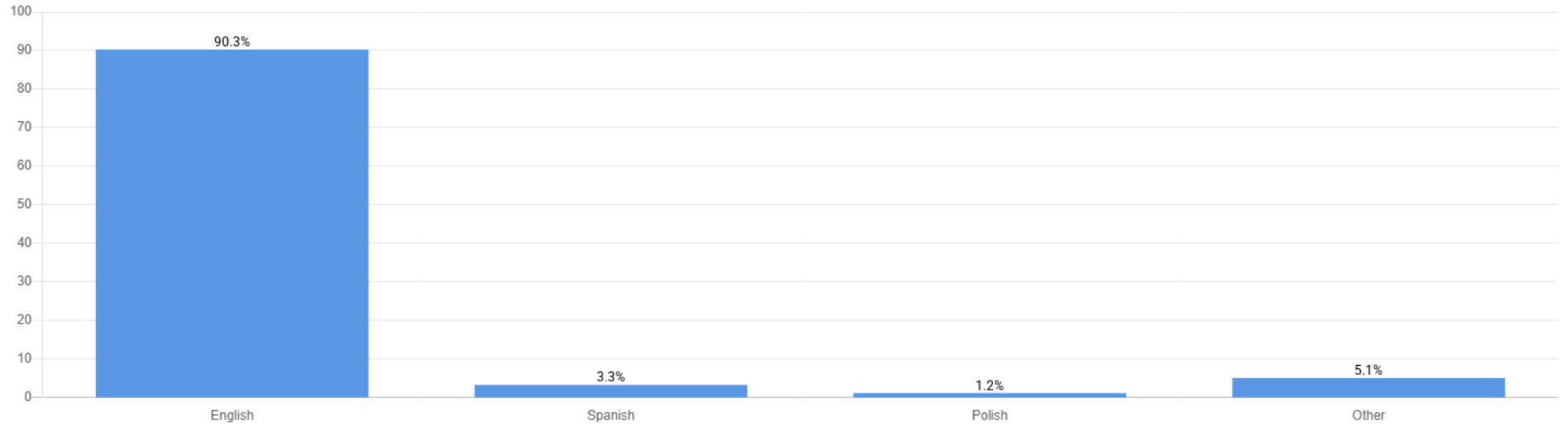

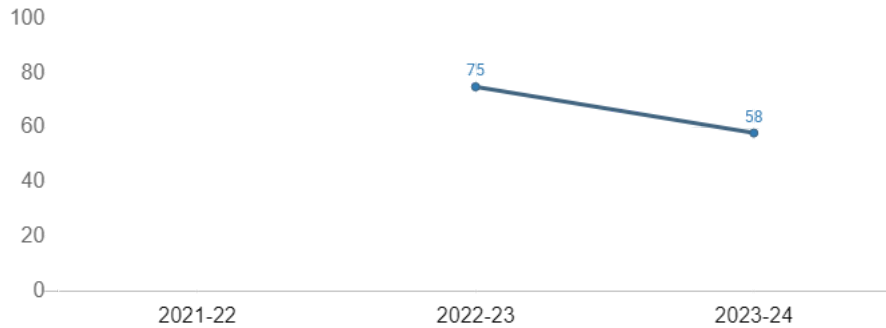

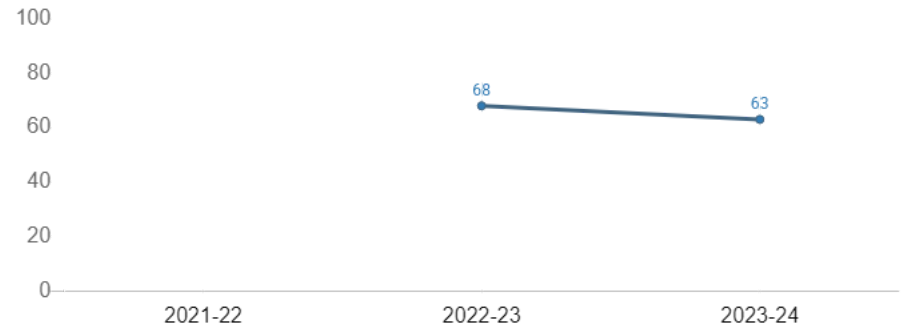

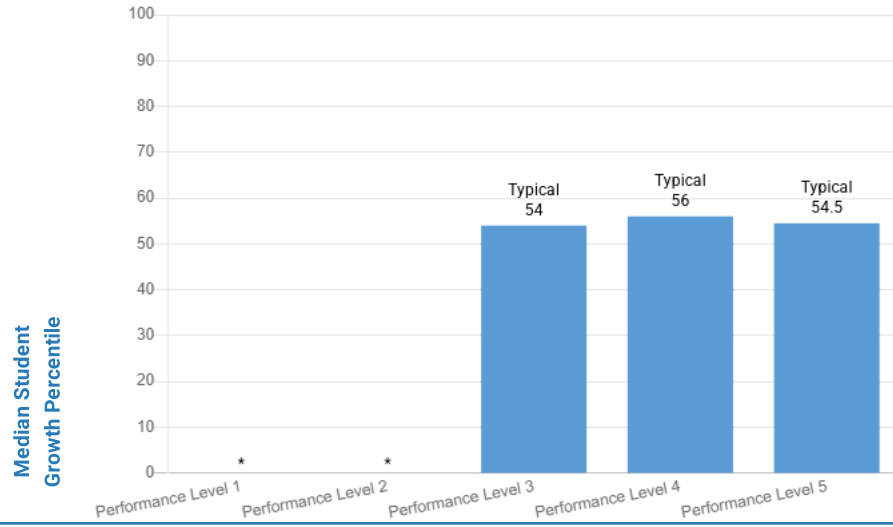

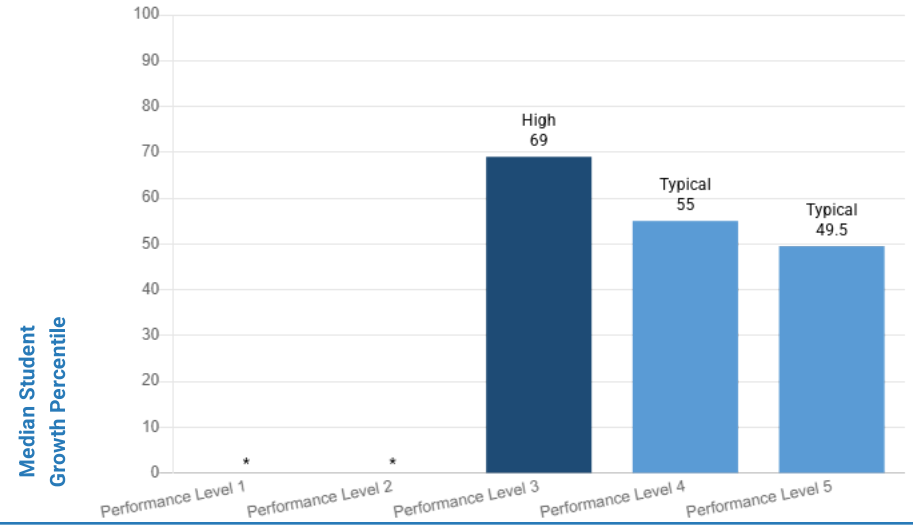

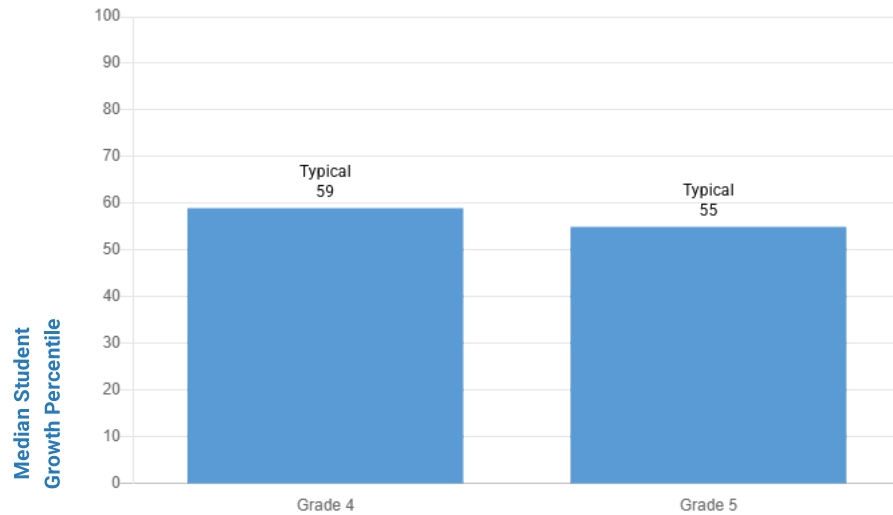

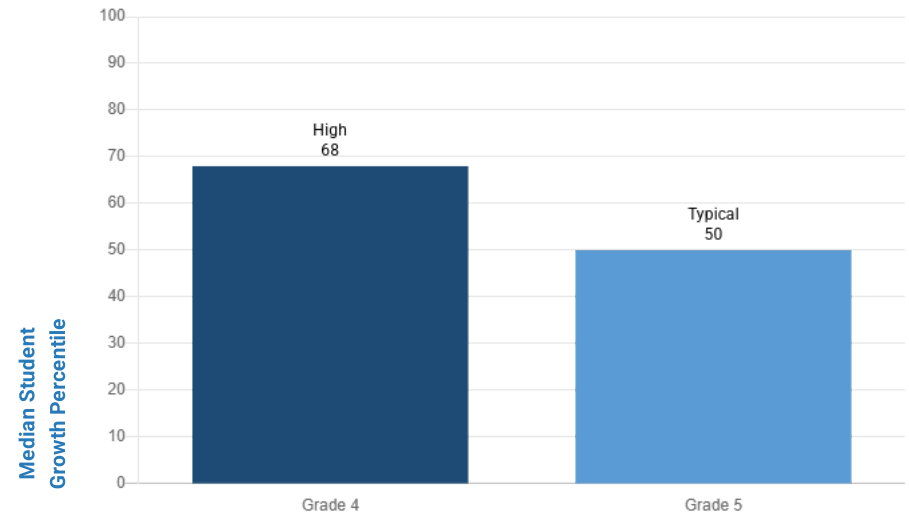

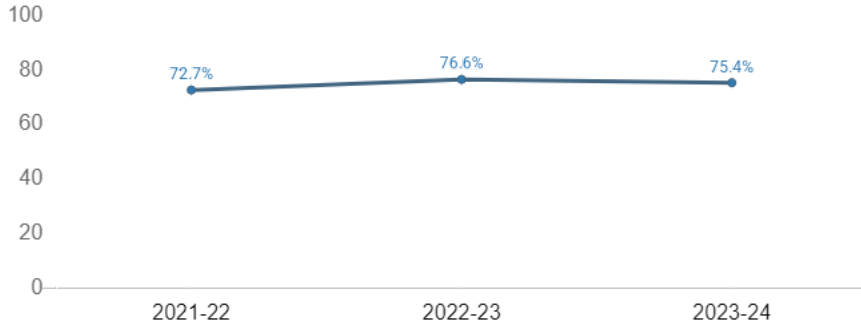

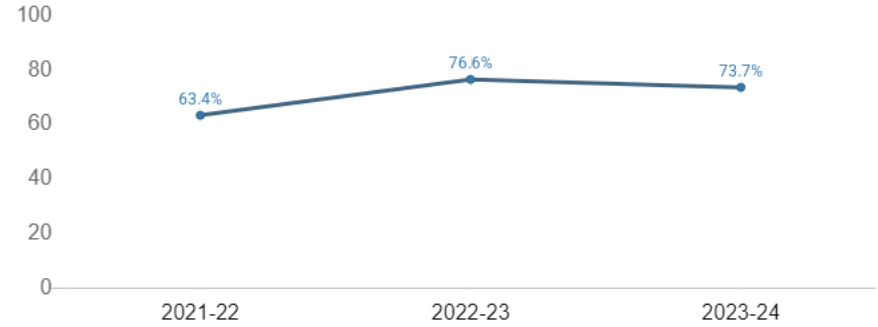
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 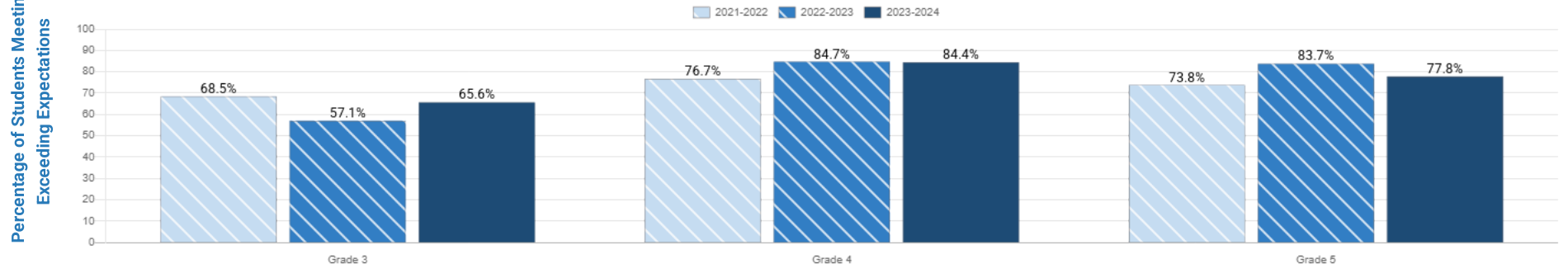

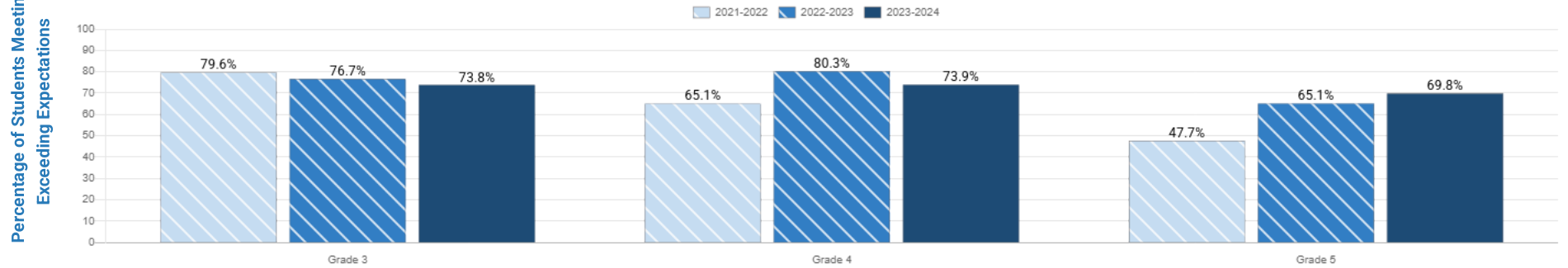

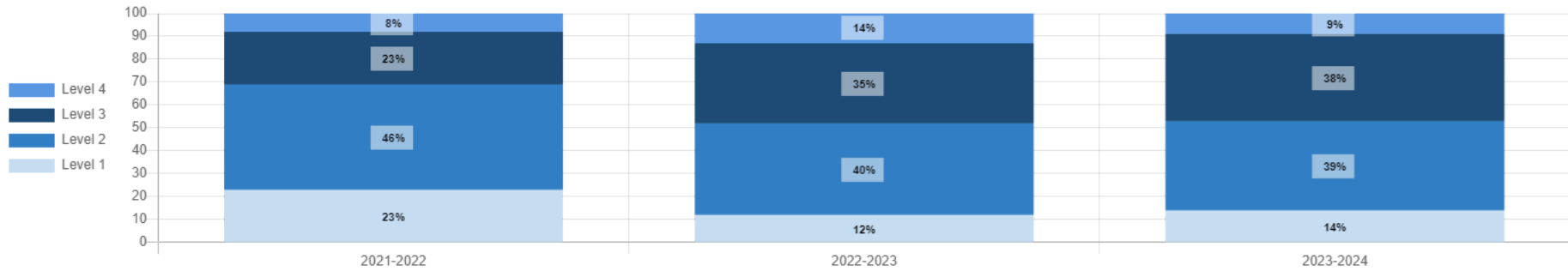

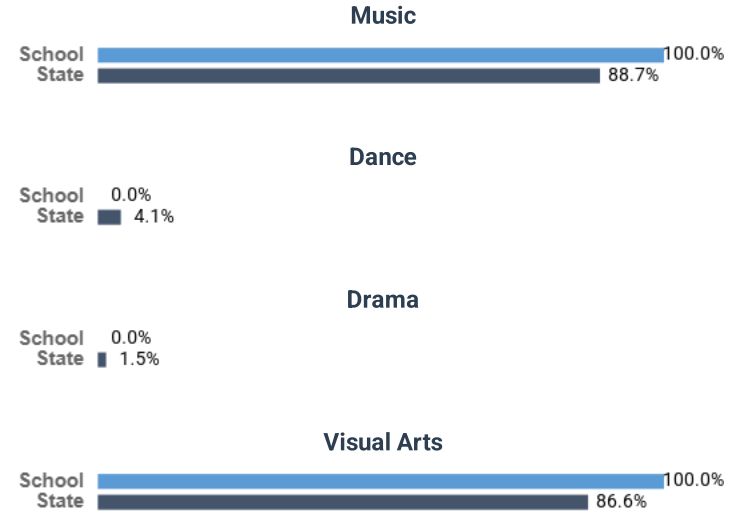

Students enrolled in one or more classes by discipline:



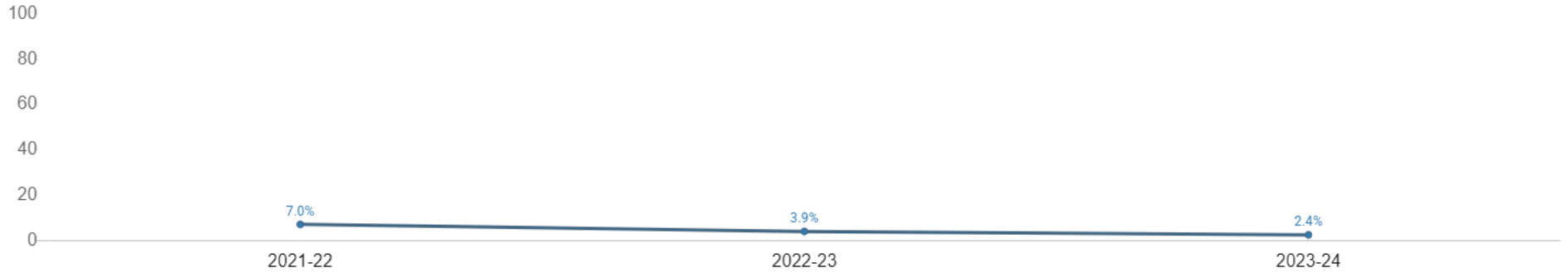

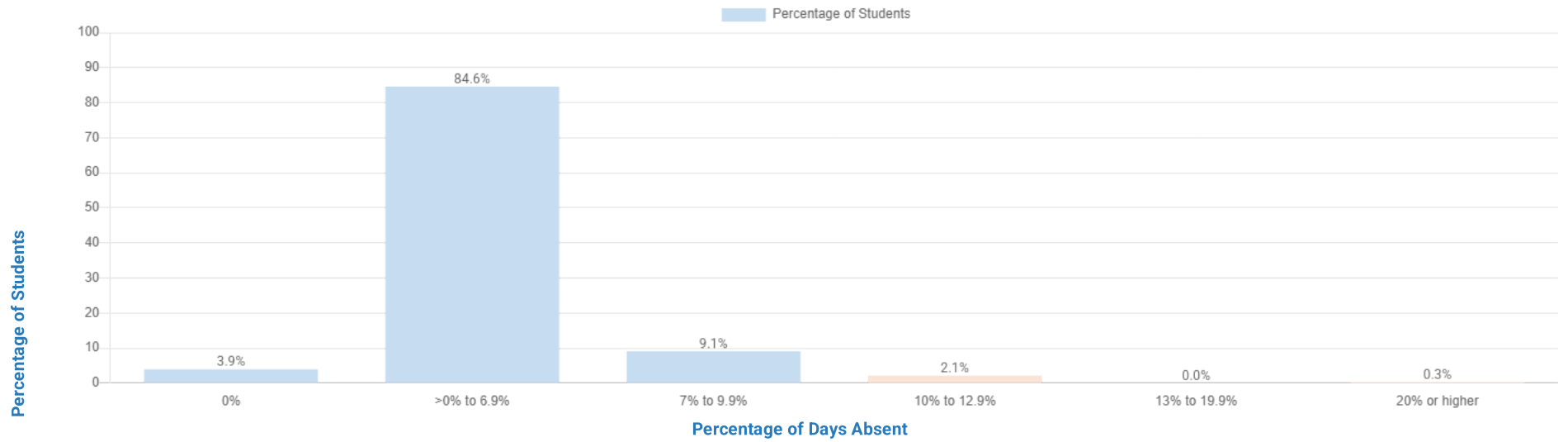

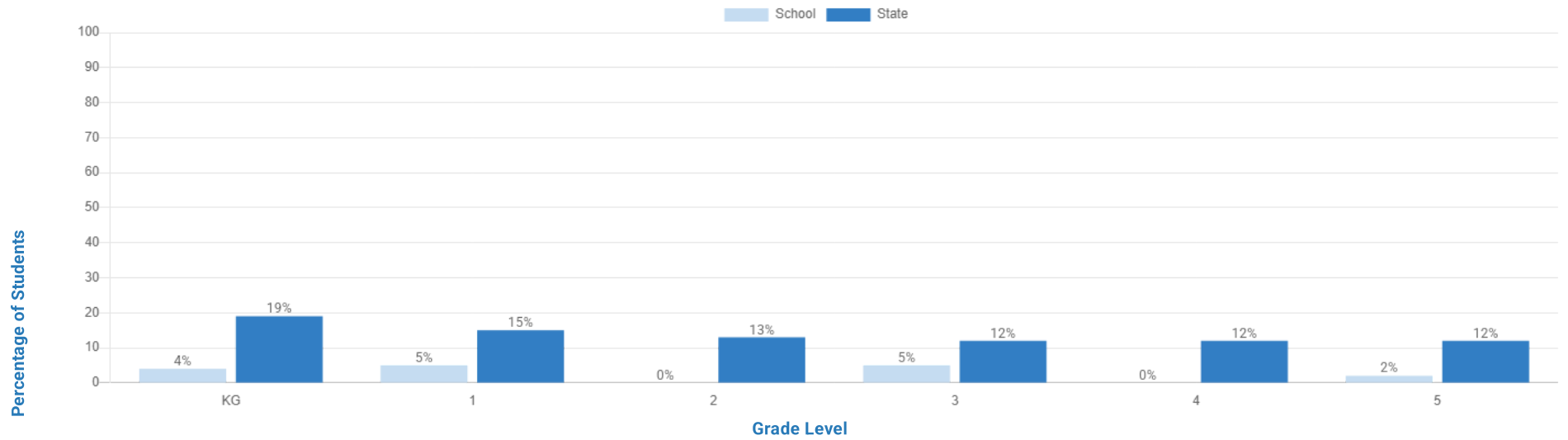

Staff

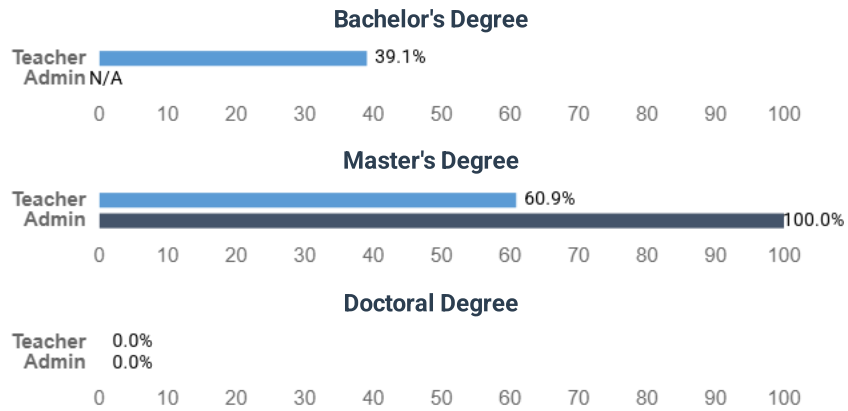

The School District has 3 full days of PD per year with one day reserved for the District Education Summit. Topics for workshops are generated by our SciP teams. The School District currently has 4 additional 1/2 day PD days built into the school calendar for staff. All staff are encouraged to attend workshops both in and out of district as well as other professional learning opportunities. Additional opportunities include power PDs, lunch and learns, book studies, articulation meetings, and Twitter PLNs.

Student Supports and Services:

The Pequannock Township School District provides all students with supports and services. The District supports ELL through a supplemental program. The District uses a multi-tiered approach for special education students including resource center, ICR, LLD, and programs for students with multiple disabilities. RTI and I&RS teams assist students struggling academically and behaviorally. Additional programs are provided by school counseling staff and CST members.



Student Health and Wellness:

The Pequannock Township School District emphasizes wellness for all. Each school establishes its own school safety, climate team, and wellness council. Our curriculum encourages healthy life choices for students including nutrition and exercise. All students participate in physical education aligned to the NJSL and the Shape America Standards. Our students participate in numerous activities celebrating fitness such as Jump Rope For Heart, field day, Red Ribbon Week, and Week of Respect.
