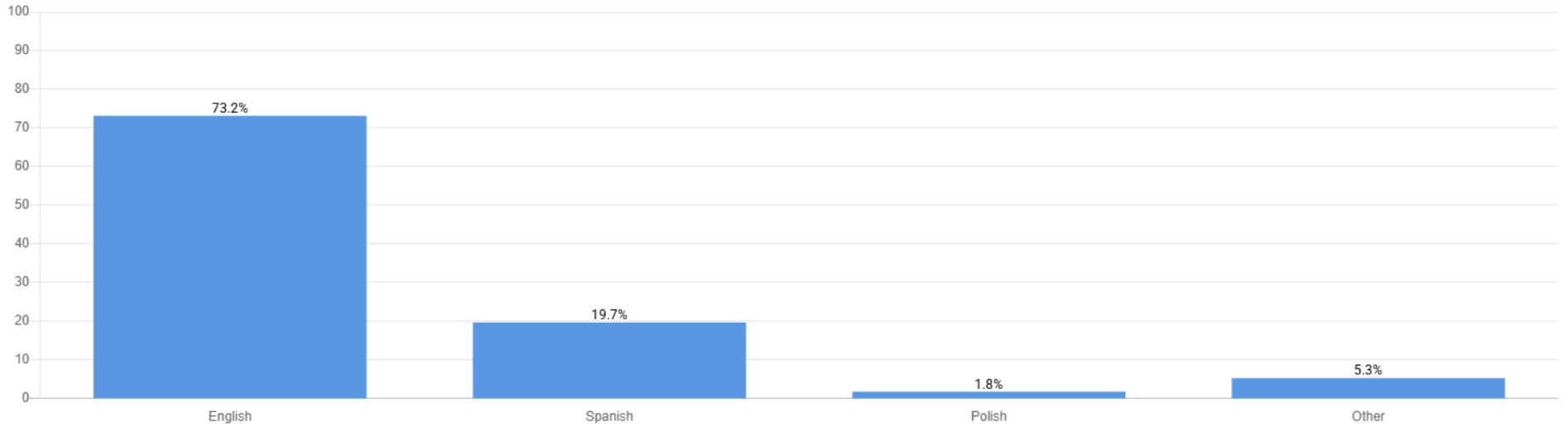

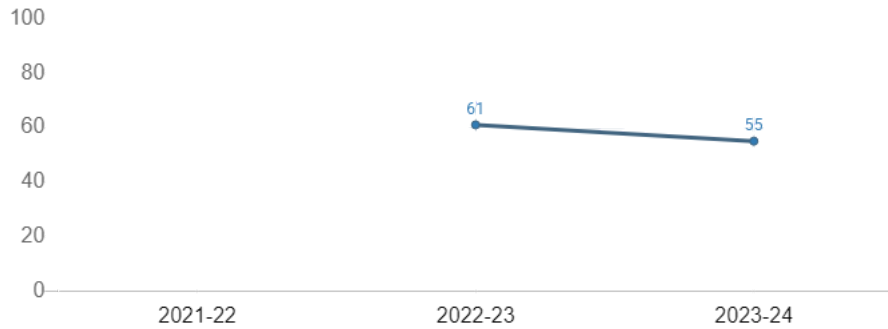

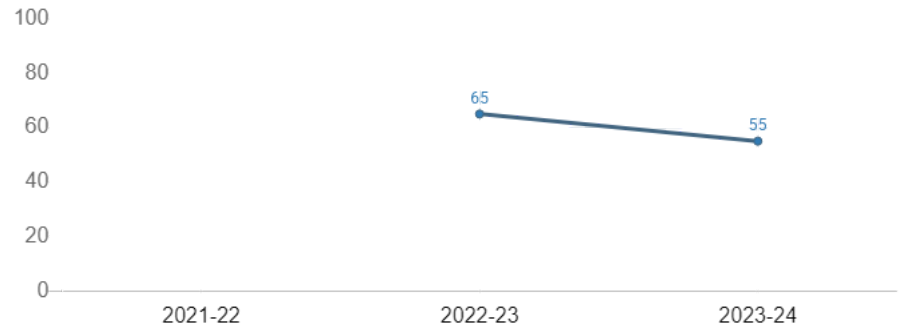

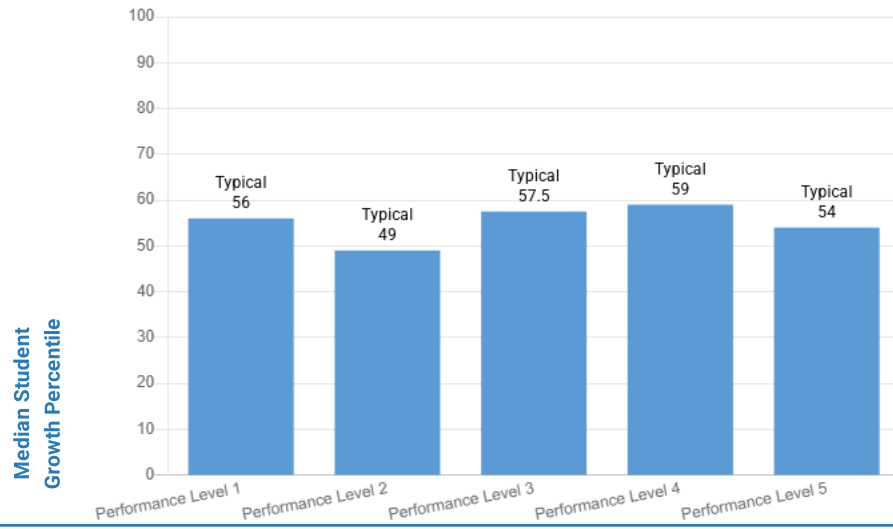

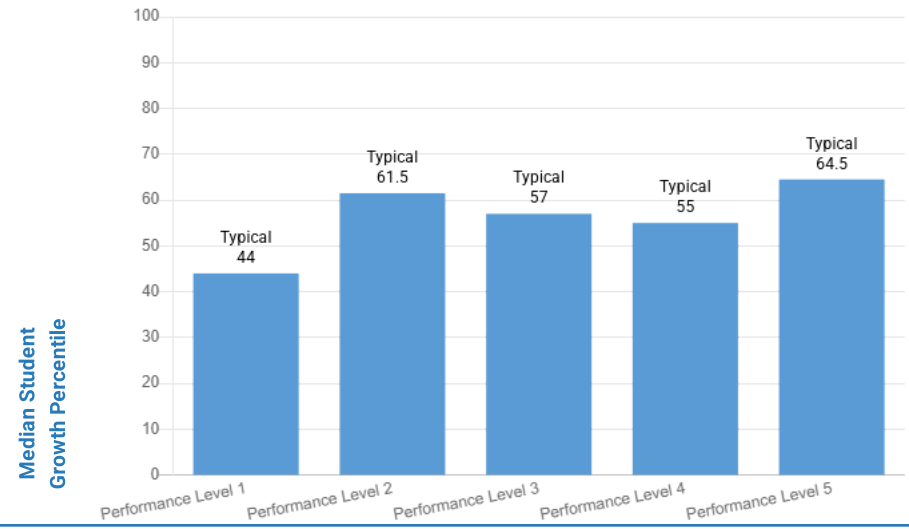

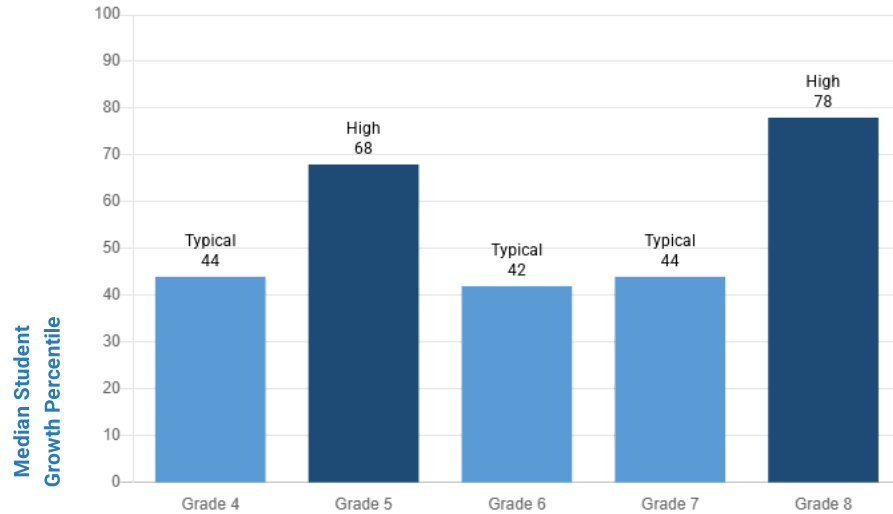

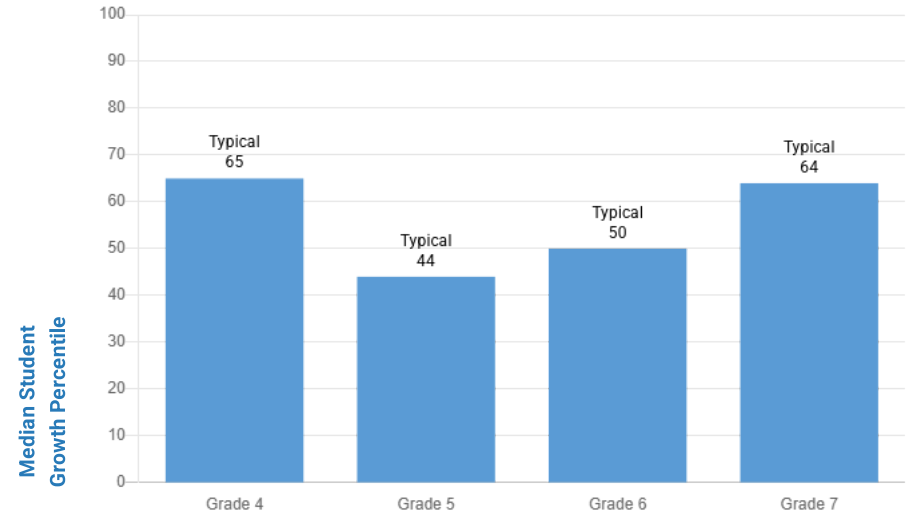

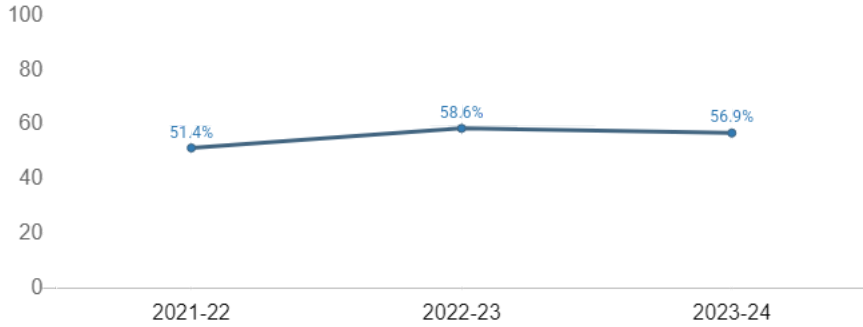

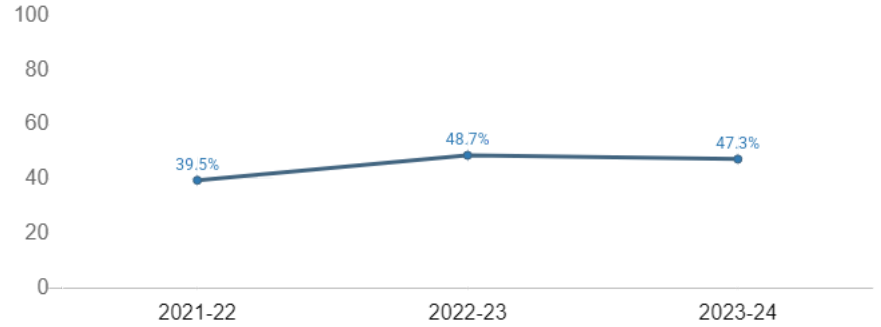
English Language Arts and Mathematics Performance Trends

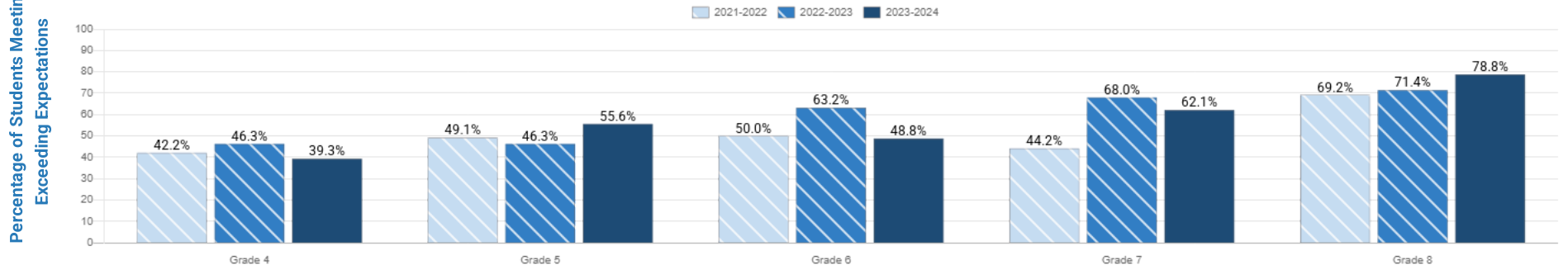

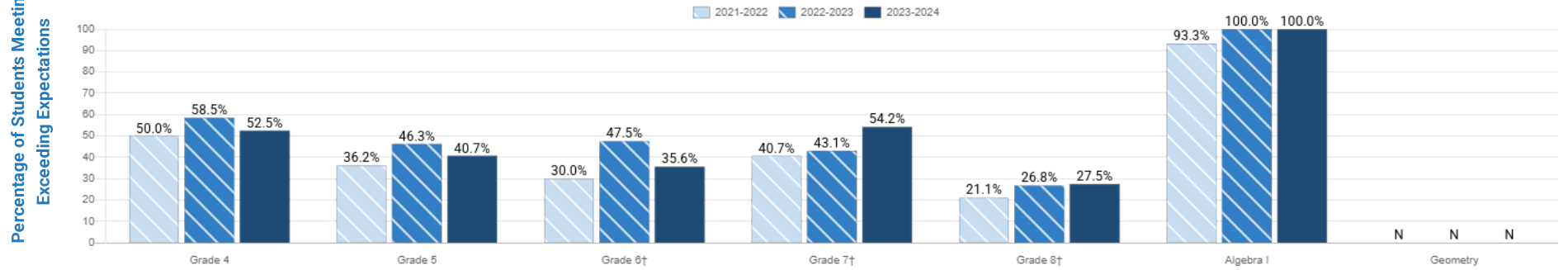

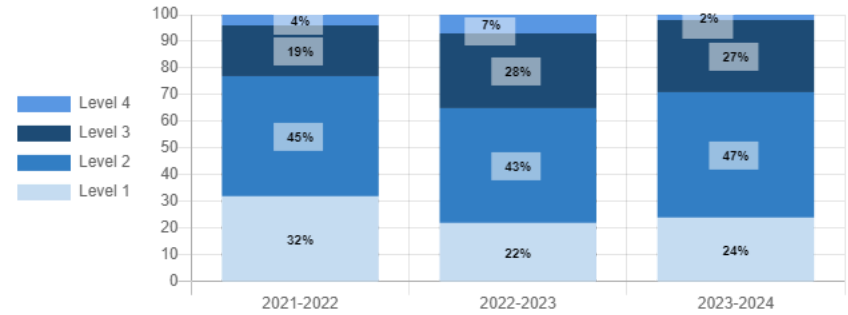

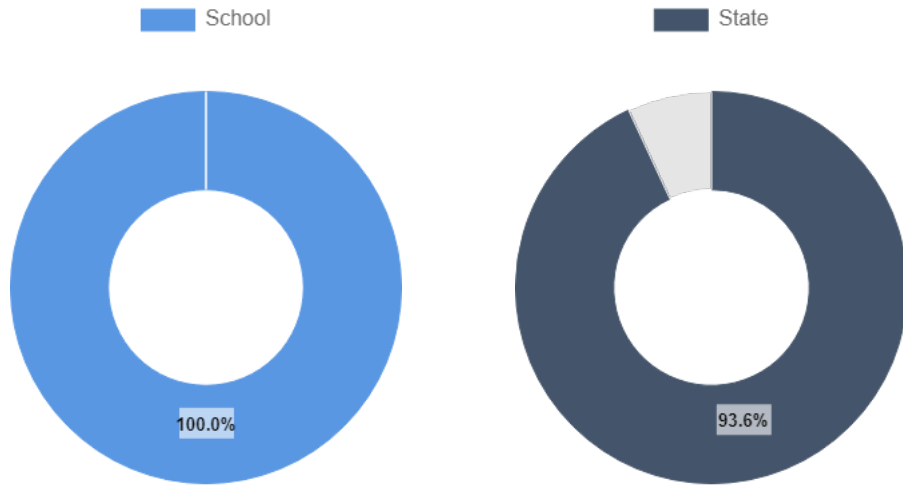

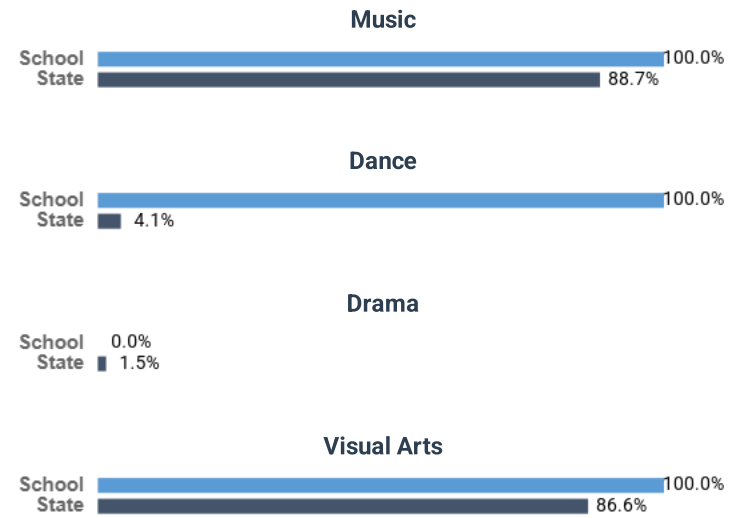

Students enrolled in one or more classes by discipline:



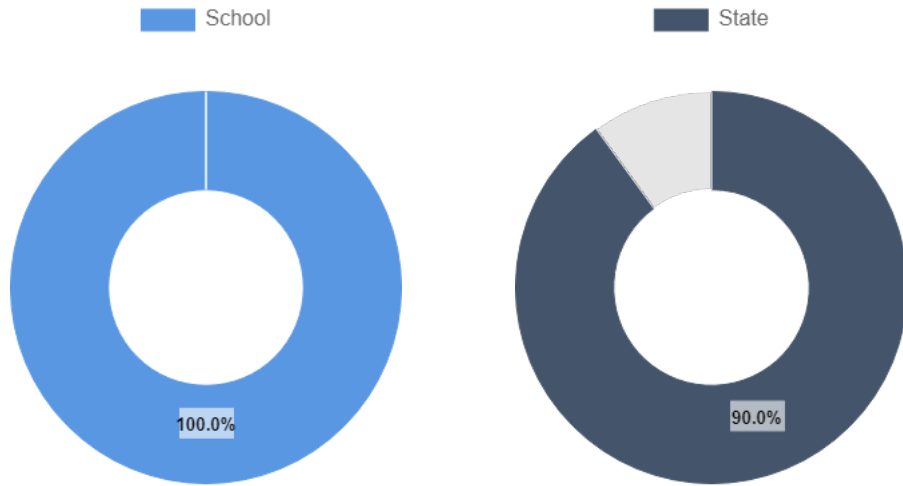

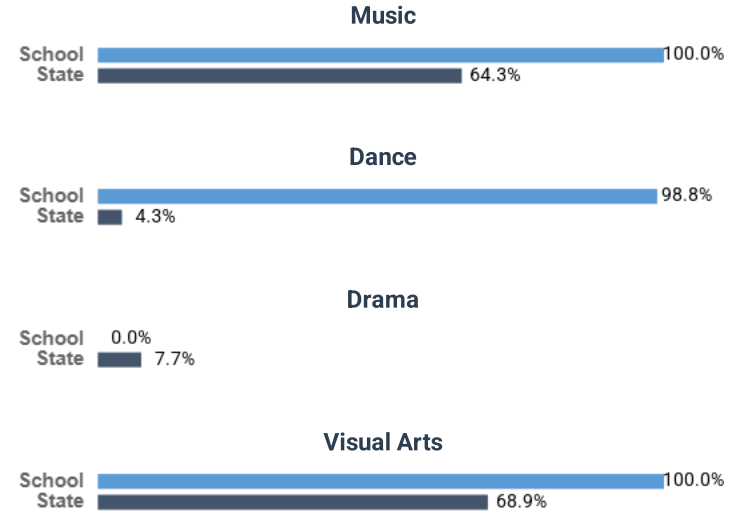

Students enrolled in one or more classes by discipline:



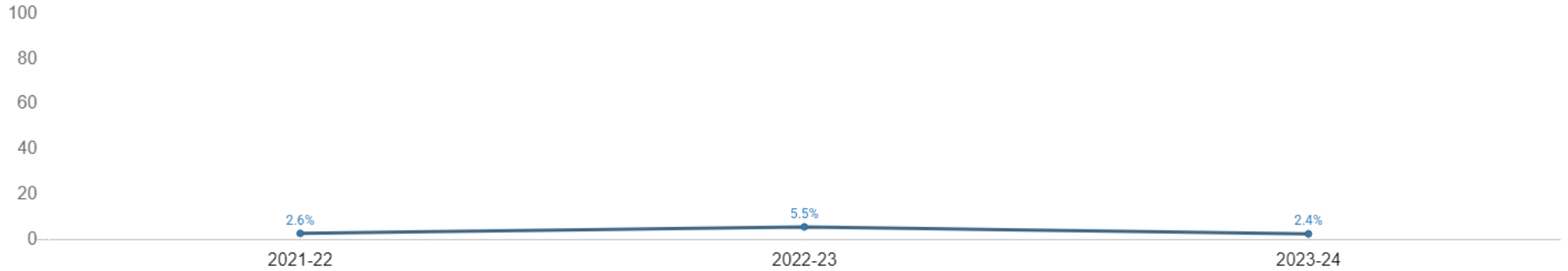

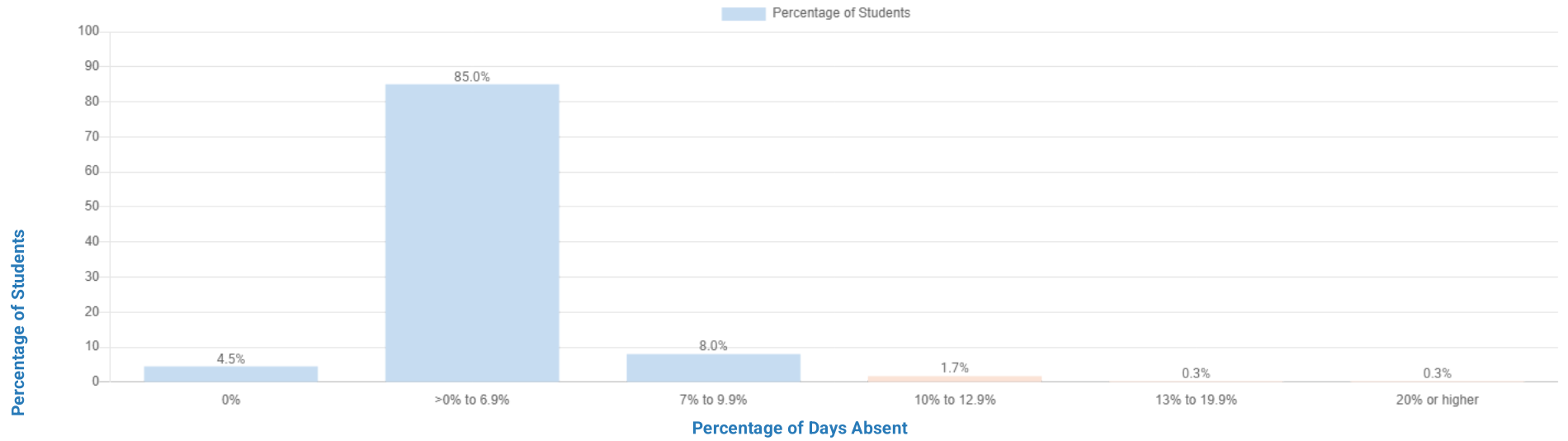

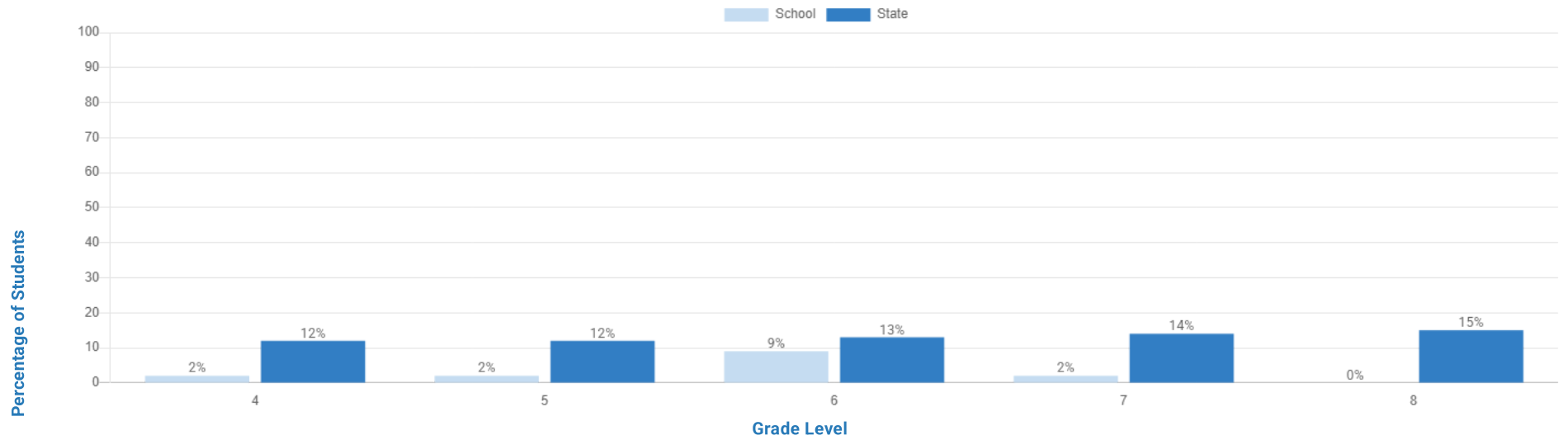

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Each year Thomas Jefferson School recognizes both teachers and support staff through the Governor's Educator of the Year Awards all of which are nominated by parents, staff themselves and students. Individual students as well as student groups are also celebrated for their academic achievements and as well as their efforts in extra-curricular endeavors.

All academics are aligned with NJSLs. Core subject areas include math, language arts literacy, social studies and science. Thomas Jefferson School has traditionally been a Group 1 or Group 2 school, in the Greater Morris County Junior School Coaches Association (GMCJSCA). The school offers 7 interscholastic squads (Girls' Soccer, Boys' Soccer, Girls' Basketball, Boys' Basketball, Softball, Baseball, and Co-ed Cross Country). The school also fields a Co-ed Volleyball Team, which competes against some local schools. There is an Athletic Coordinator who facilitates scheduling, ordering, transportation, and booking officials.

After the Bell is an intervention program offered to students in grades 4-8, after-school, 3 days a week. It is staffed by certified teachers and is offered to students who meet the designated criteria.

All staff are offered opportunities for both in-house and out-of-district professional learning. Besides teacher in-service days, staff can take advantage of embedded and ongoing PD hosted by colleagues focusing on technology and other relevant topics. In addition, staff is involved in Professional Learning Communities that meet regularly and include district-wide representation

The Special Education program offers support for students with special needs. Resource centers are provided to eligible students in English Language Arts and Math as well as comprehensive Multiple Disabilities and a Learning and/or Language Disabilities Program. In addition, the school provides an innovative Basic Skills Program emphasizing individual instruction and tiered interventions. Lastly, ML learners are provided with ESL Teacher support and interventions.



Student Health and Wellness:

Thomas Jefferson has its own school counselor for grades 4-8 to support the health and well being of students and their families. Specific therapeutic services include, but are not limited to the following: individual counseling sessions, group counseling sessions, family counseling, classroom observations, consultation with teachers and staff, crisis intervention and home visits. Accommodations will be made for all grade levels (elementary vs. middle school) as well as for students with disabilities.



Parent and Community Involvement:

Parents have access to essential academic and attendance information through the Parent Portal on Realtime, the District Student Information System. Students also benefit from the district Home and School Association and the Rockaway Borough Educational Foundation that sponsors fundraising to support activities that are not covered by the regular budget. Both district schools have strong partnerships with community groups such as the RBPD, RBFD, the local library, and the Rotary Club.

Facilities:

Thomas Jefferson School opened its doors over fifty years ago to serve the growing school population in Rockaway Borough. Today it houses district students in grades four through eight. Current facilities include traditional classroom spaces, a full-size gymnasium, a remodeled library/media center, a science lab, art and music rooms and a 4th-grade wing to support students transitioning from Lincoln Elementary. All student classrooms are air-conditioned.



School Safety:

Rockaway Borough is very proud of its safety initiatives in both school buildings, especially in regard to our collaboration and coordination with local first responders. Our Emergency Management Plan is updated yearly and dictates our practices, procedures and responses pertaining to monthly security drills and protocols. There are security cameras in both buildings along with the outside campus with access to administration as well as the local police through streaming video. To respond to building intruders, the entire staff as well as students have been trained in the A.L.I.C.E. protocol by the Rockaway Borough Police. Starting in 2018-19, the district has also acquired the services of a Class III officer and installed a computerized identification system to screen and monitor school visitors. In the 2022-2023 school an additional Class III Officer was hired, to have one stationed in each school building.

Technology and STEM:

Technology integration is a top priority at Thomas Jefferson as it is throughout the district. A 1:1 initiative was implemented during the 2017-18 school year was extended during the 2018-19 school year to provide ALL students in 4th-8th grades with Chromebook devices. In addition, we have continued to upgrade our Smartboards in all classrooms, as well as offer each teacher a document camera for daily use. To support technology skills and overall integration as well as STEAM initiatives across the curriculum, all students in grades 4-8 receive instruction in Technology along with carry over instruction in our CID (Creativity Innovation and Design) course.
