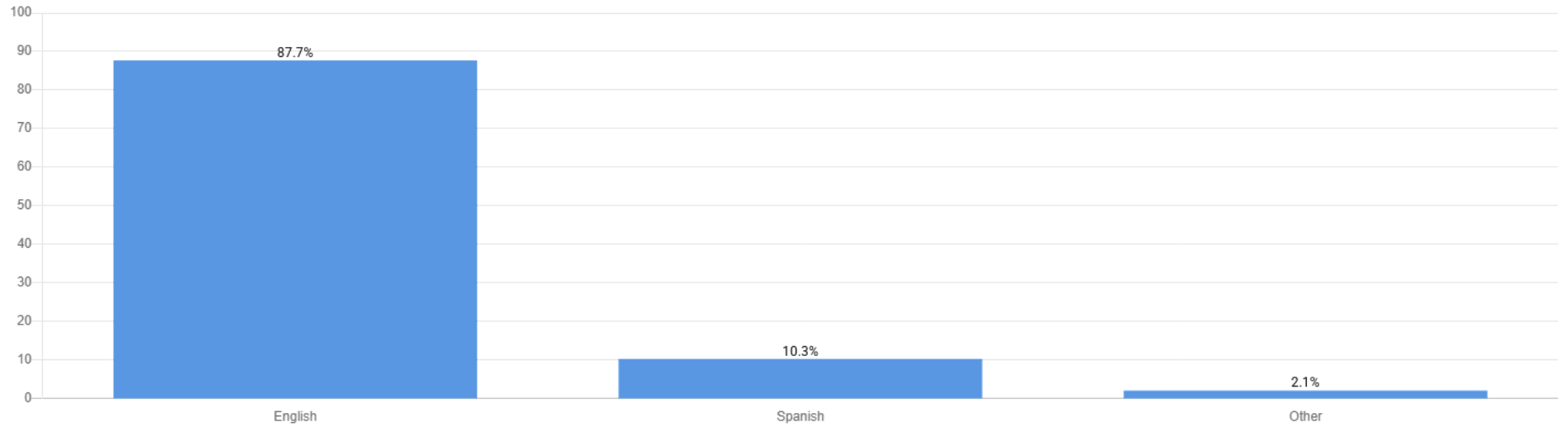

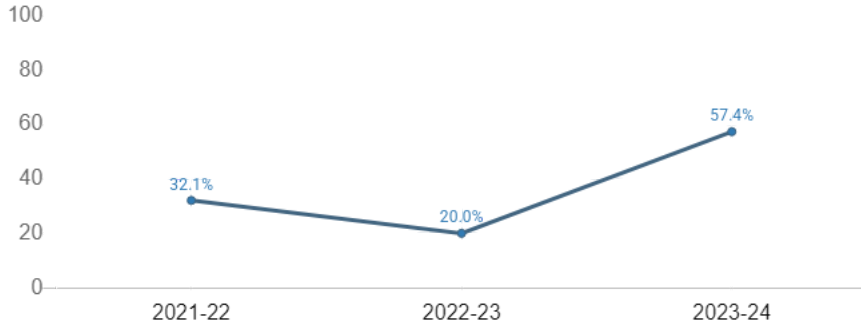

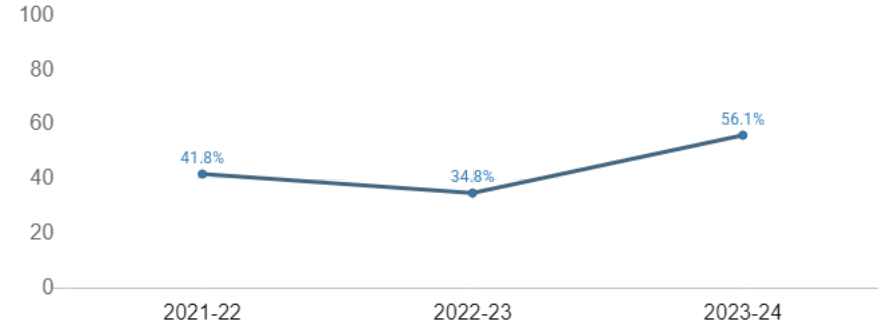
English Language Arts and Mathematics Performance Trends

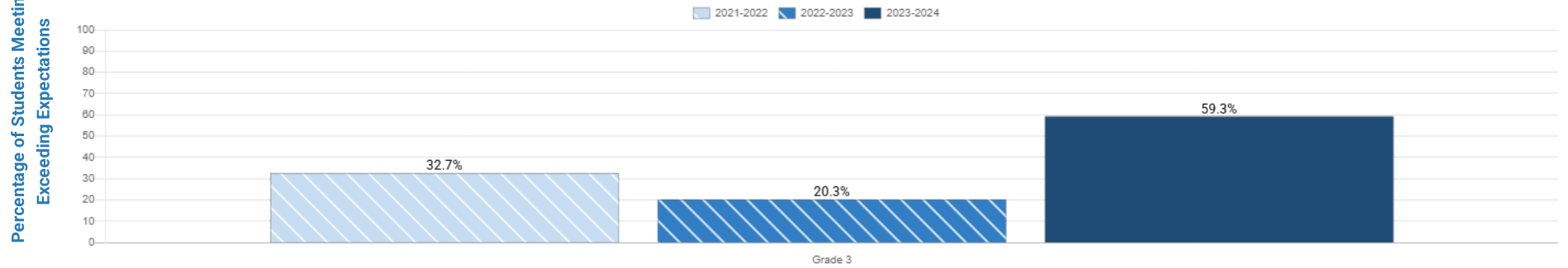

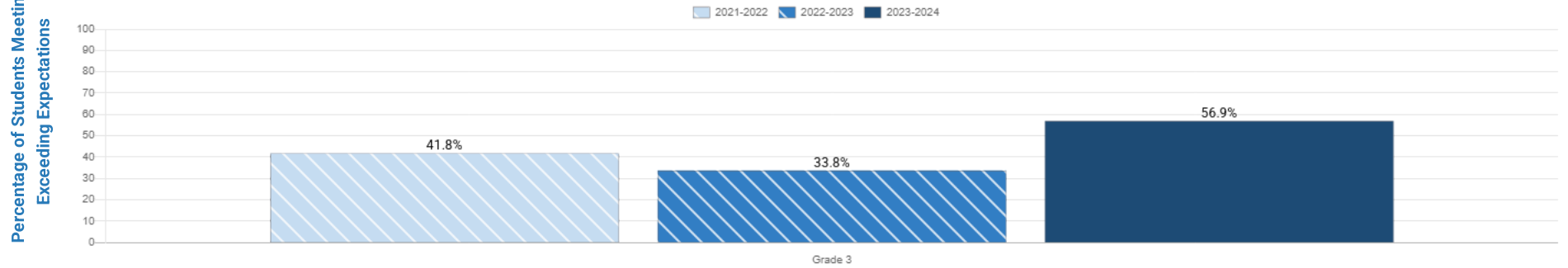

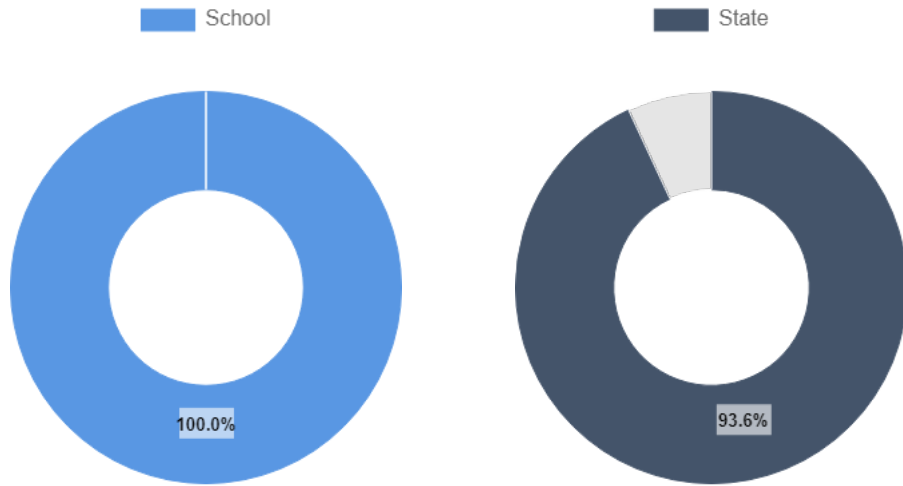

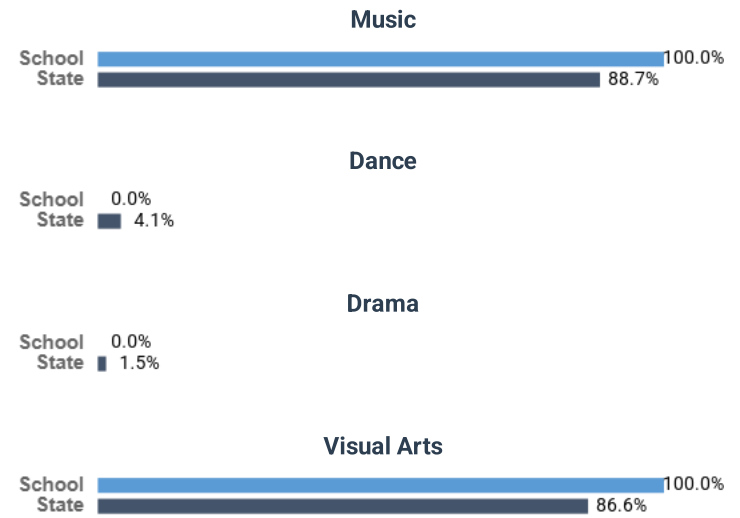

Students enrolled in one or more classes by discipline:



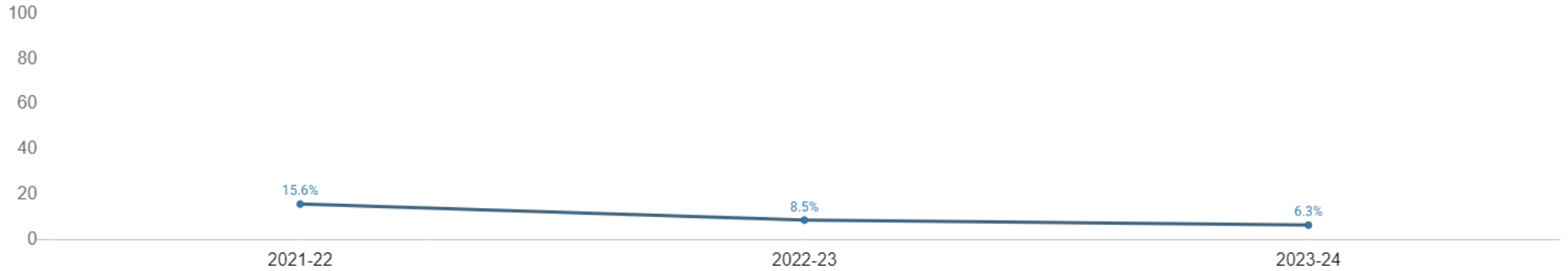
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. 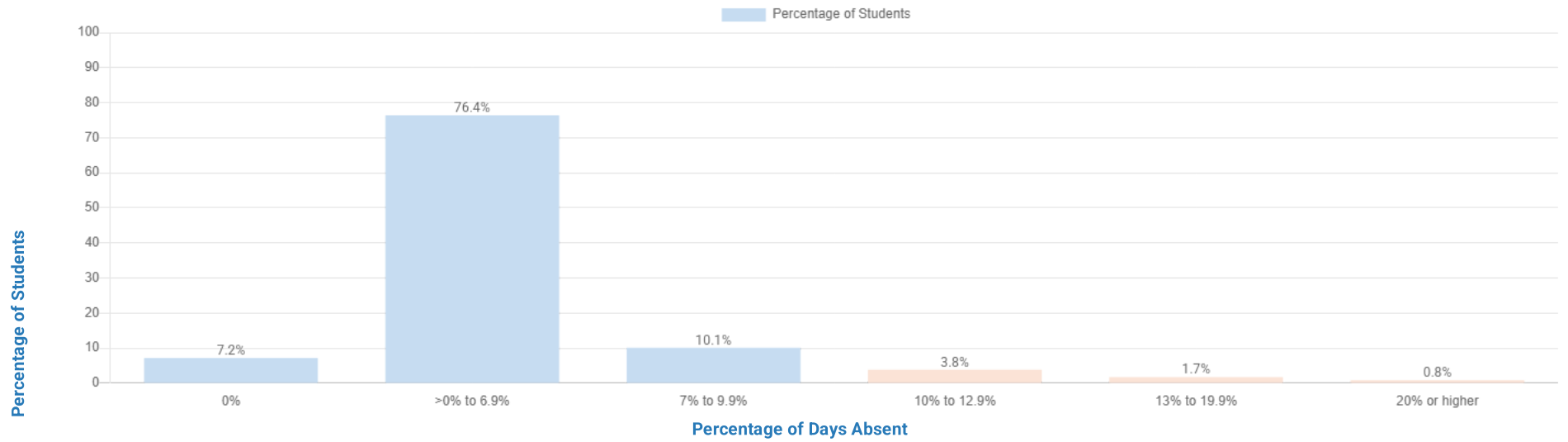

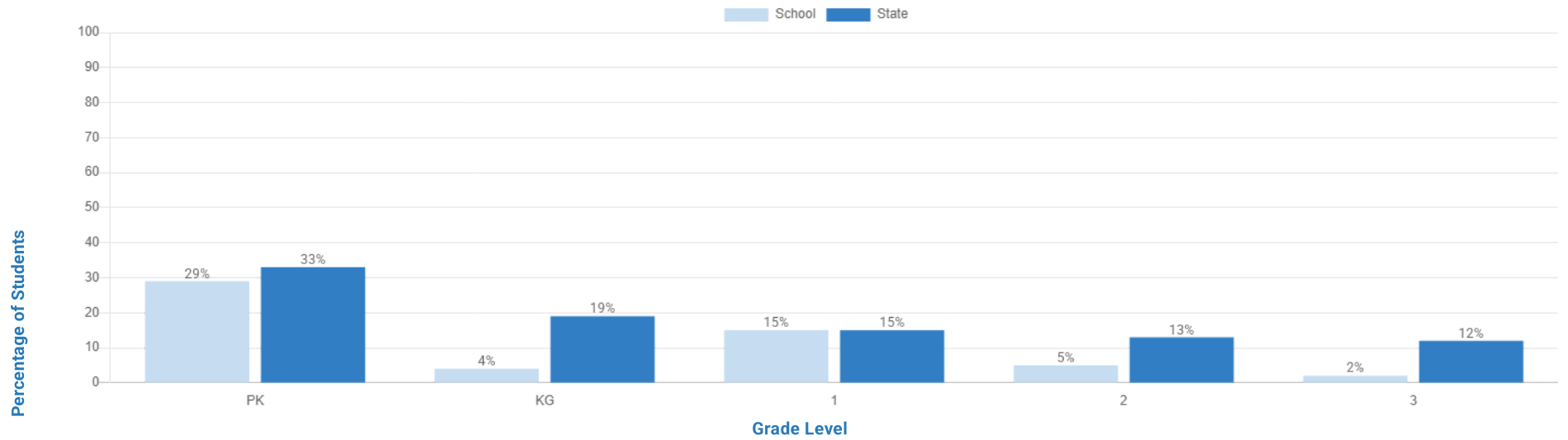

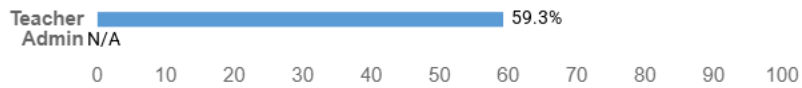

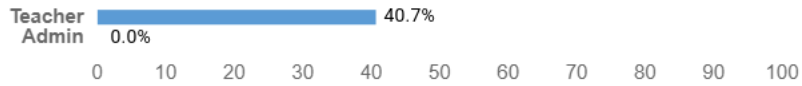

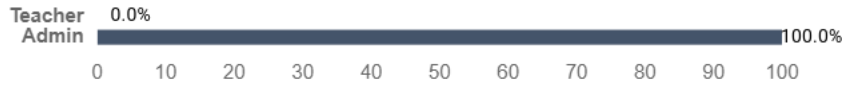
Bachelor's Degree

Accountability Summary by Student Group - 2023-24 School Year

Ready Set Go, a before school intervention program serving students in K-3rd grade and After the Bell, an after-school intervention program, are offered to students in grades 1-3 and funded through grant monies. All programs are staffed by certified teachers & offered to students who meet the designated criteria.



Staff and Professional Learning:

All staff are offered opportunities for both in-house and out-of-district professional learning. Besides teacher in-service days, staff can take advantage of embedded and ongoing PD hosted by colleagues focusing on technology and other relevant topics. In addition, staff is involved in Professional Learning Communities that meet regularly and include district-wide representation



Student Supports and Services:

The Special Education program offers support for students with special needs. Resource centers are provided to eligible students in English Language Arts and Math as well as comprehensive Multiple Disabilities and a Learning and/or Language Disabilities Program. In addition, the school provides an innovative Basic Skills Program emphasizing individual instruction and tiered interventions. Lastly, ML learners are provided with ESL Teacher support and interventions.

Student Health and Wellness:

Lincoln has its own school counselor for grades 4-8 to support the health and well being of students and their families. Specific therapeutic services include, but are not limited to the following: individual counseling sessions, group counseling sessions, family counseling, classroom observations, consultation with teachers and staff, crisis intervention and home visits. Accommodations will be made for all grade levels (elementary vs. middle school) as well as for students with disabilities.



Parent and Community Involvement:

Parents have access to essential academic and attendance information through the Parent Portal on Realtime, the District Student Information System. Students also benefit from the district Home and School Association and the Rockaway Borough Educational Foundation that sponsors fundraising to support activities that are not covered by the regular budget. Both district schools have strong partnerships with community groups such as the RBPD, RBFD, the local library, and the Rotary Club.

Facilities:

Lincoln is a school steeped in community and educational tradition. Opening its doors in 1914, it has proudly served students in Rockaway Borough for over 100 years as both an elementary and a high school. While the building has been around for decades, it is wired for the future with internet access in all areas of the building and technology applications for all grades. All classrooms are air-conditioned.



School Safety:

Rockaway Borough is very proud of its safety initiatives in both school buildings, especially in regard to our collaboration and coordination with local first responders. Our Emergency Management Plan is updated yearly and dictates our practices, procedures and responses pertaining to monthly security drills and protocols. There are security cameras in both buildings along with the outside campus with access to administration as well as the local police through streaming video. To respond to building intruders, the entire staff as well as students have been trained in the A.L.I.C.E. protocol by the Rockaway Borough Police. Starting in 2018-19, the district has also acquired the services of a Class III officer and installed a computerized identification system to screen and monitor school visitors. In the 2022-2023 school an additional Class III Officer was hired, to have one stationed in each school building.



Technology and STEM:

Technology integration is top priority in Lincoln Elementary as it is throughout the district. Every classroom in the building is fitted with a Smartboard, a document camera, and now a 1:1 Chromebook initiative. In addition, all students K-3 receive regular instruction in keyboarding and technology with an emphasis on digital citizenship and coding.

Early Childhood Education:

Lincoln Elementary offers an inclusive preschool program for students ages 3-5. The program for gen ed students includes half-day sessions and is tuition based with acceptance through a yearly lottery. As part of the curriculum, students receive instruction in other areas such as physical education, library, music, art and technology, all by certified content area teachers. Special education students may receive full day instruction along with any other related services deemed necessary through their IEPs.
