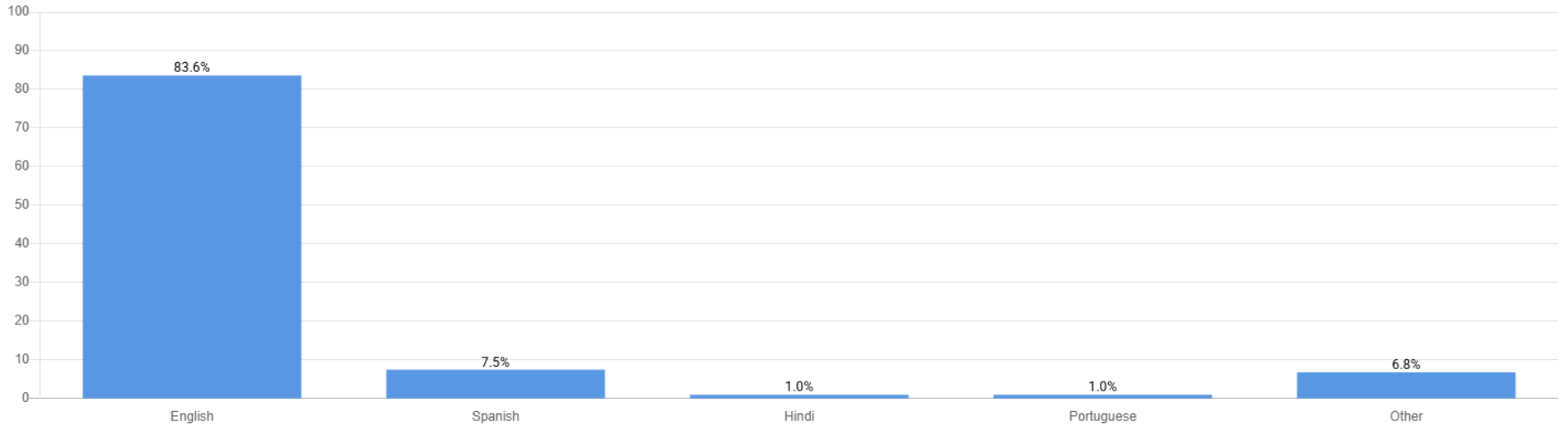

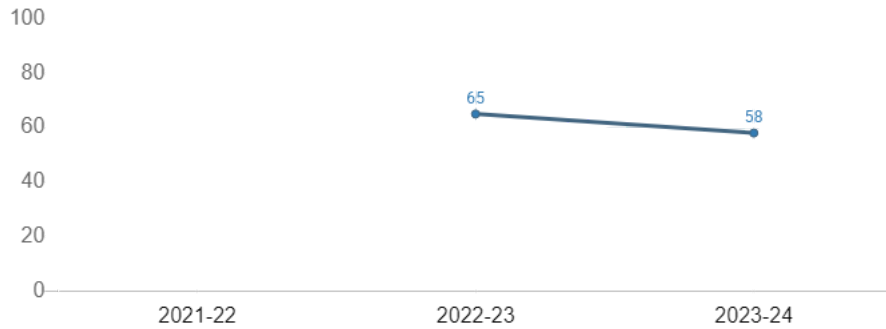

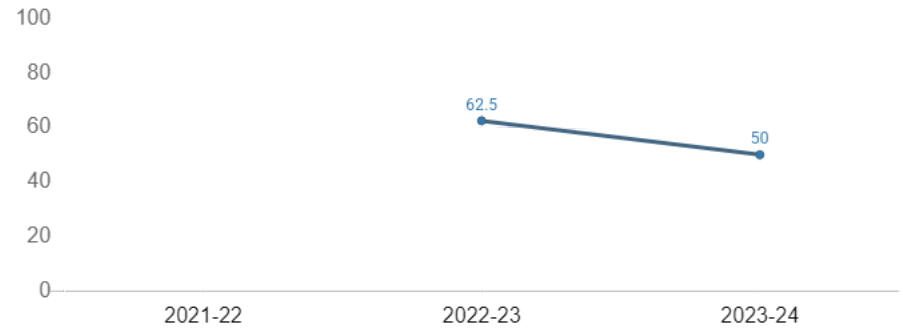

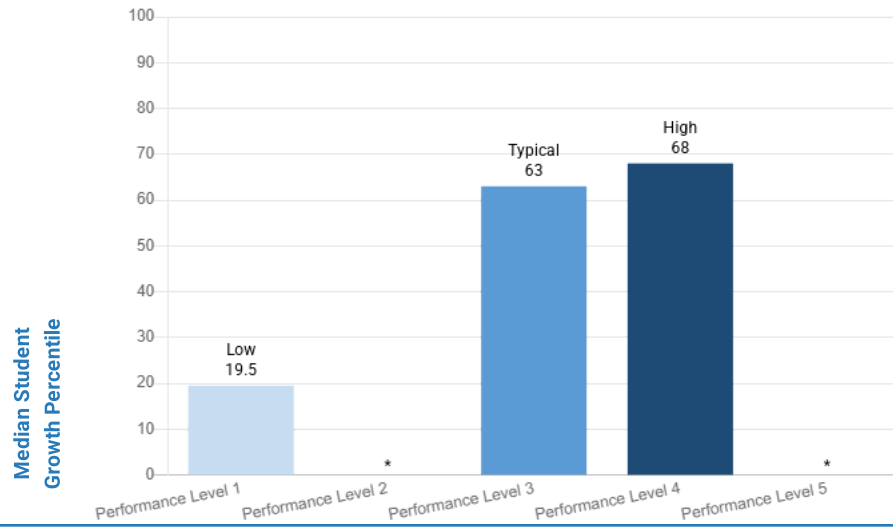

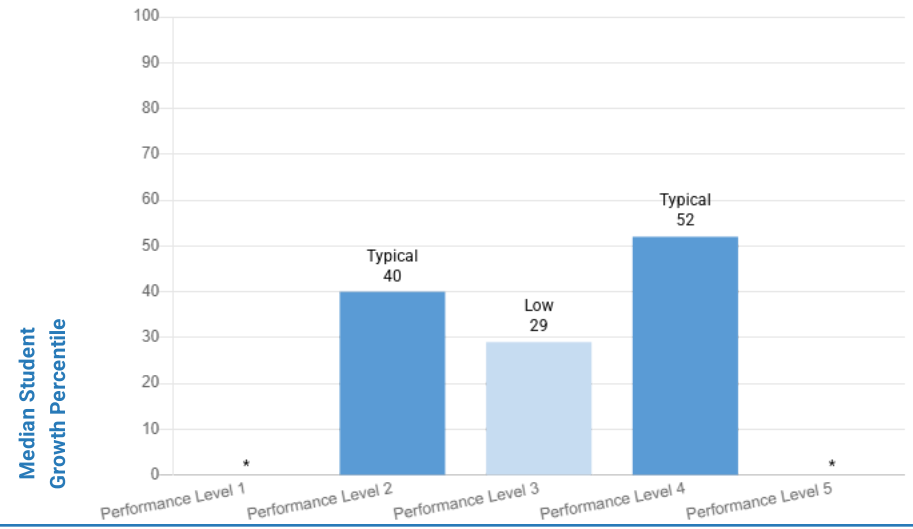

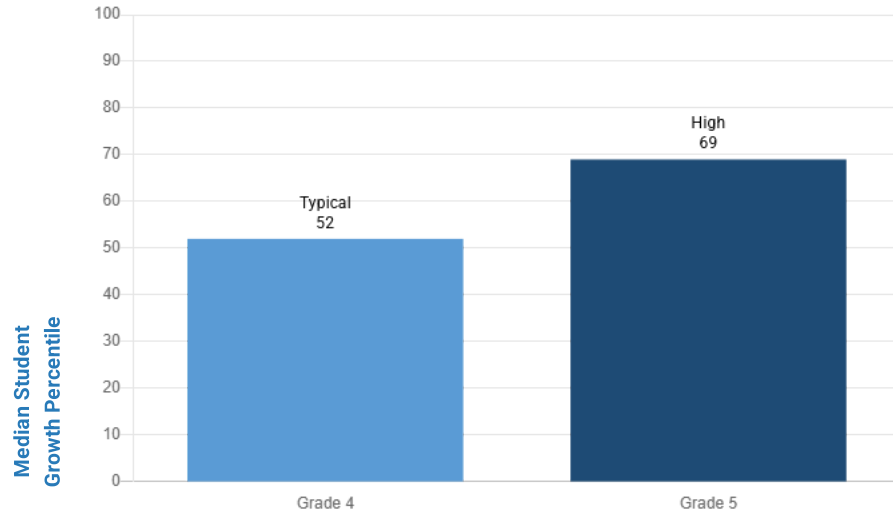

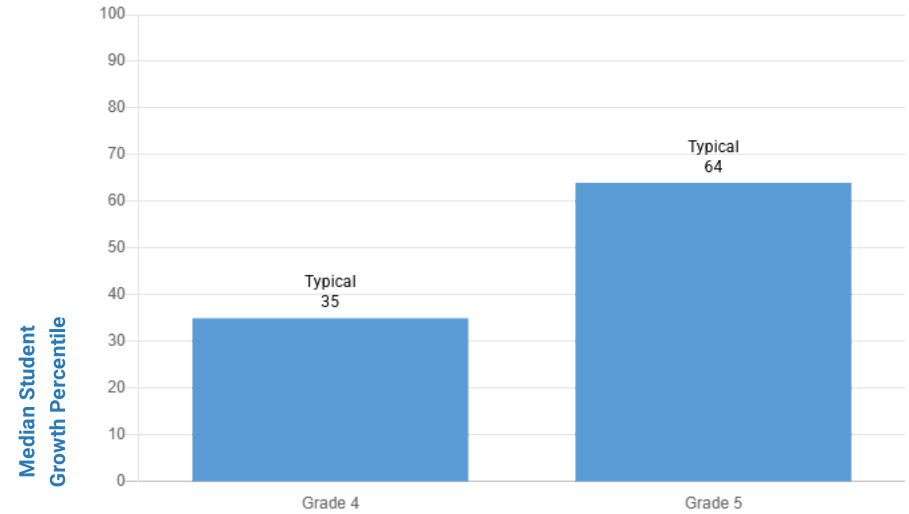

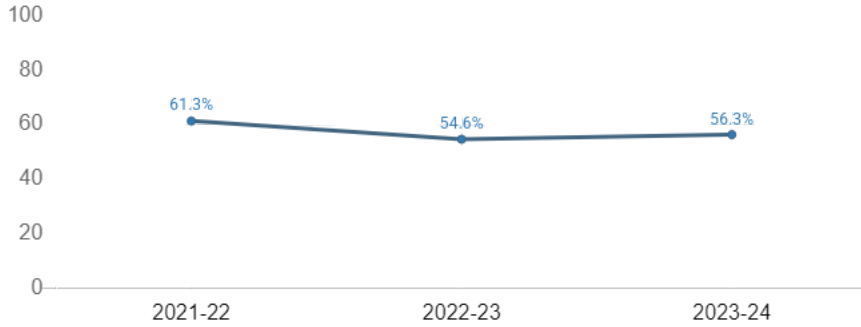

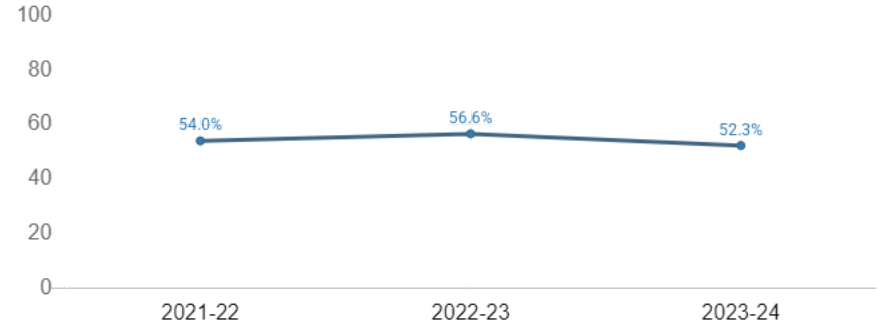
### English Language Arts and Mathematics Performance Trends

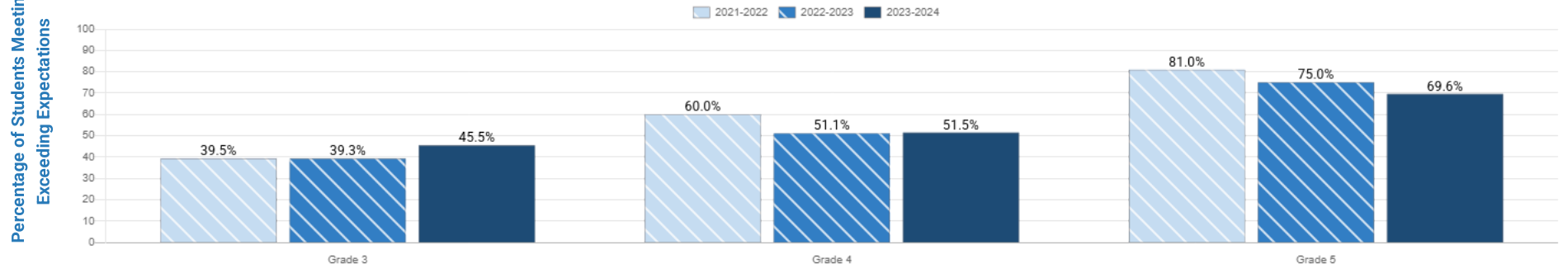

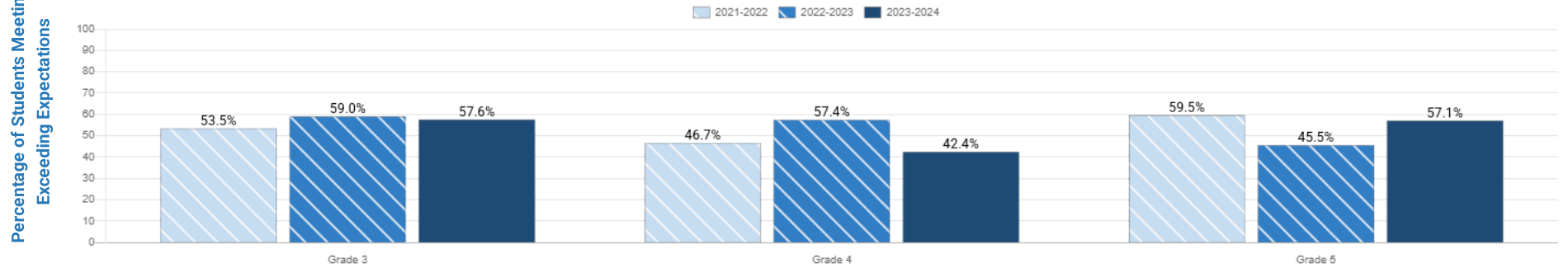

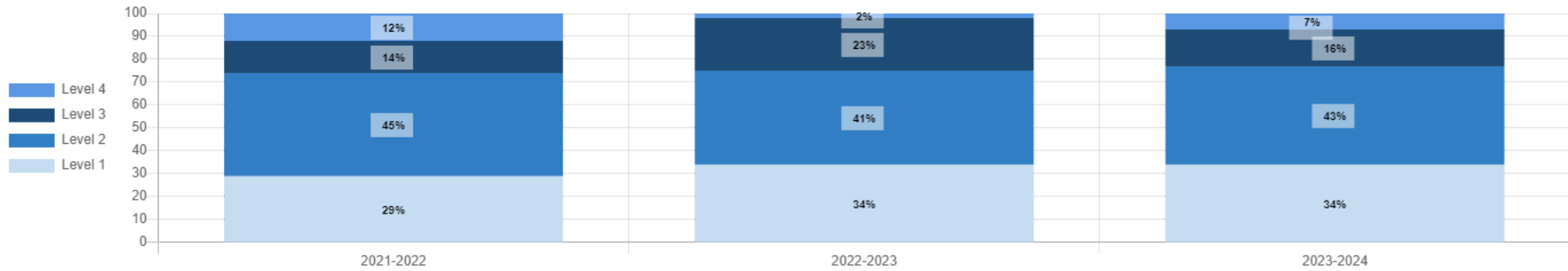

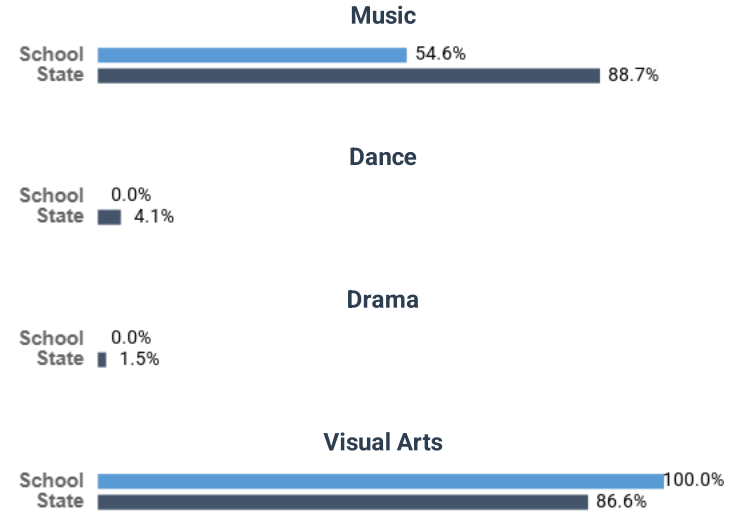

**Students enrolled in one or more classes by discipline:**



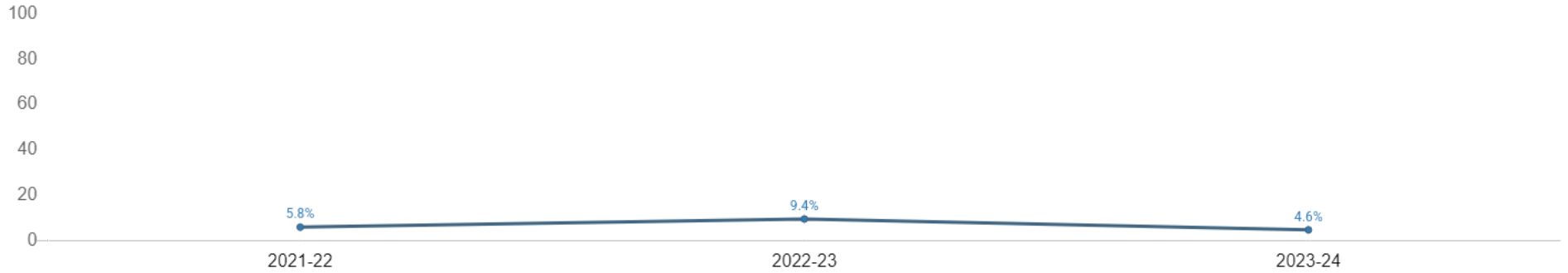

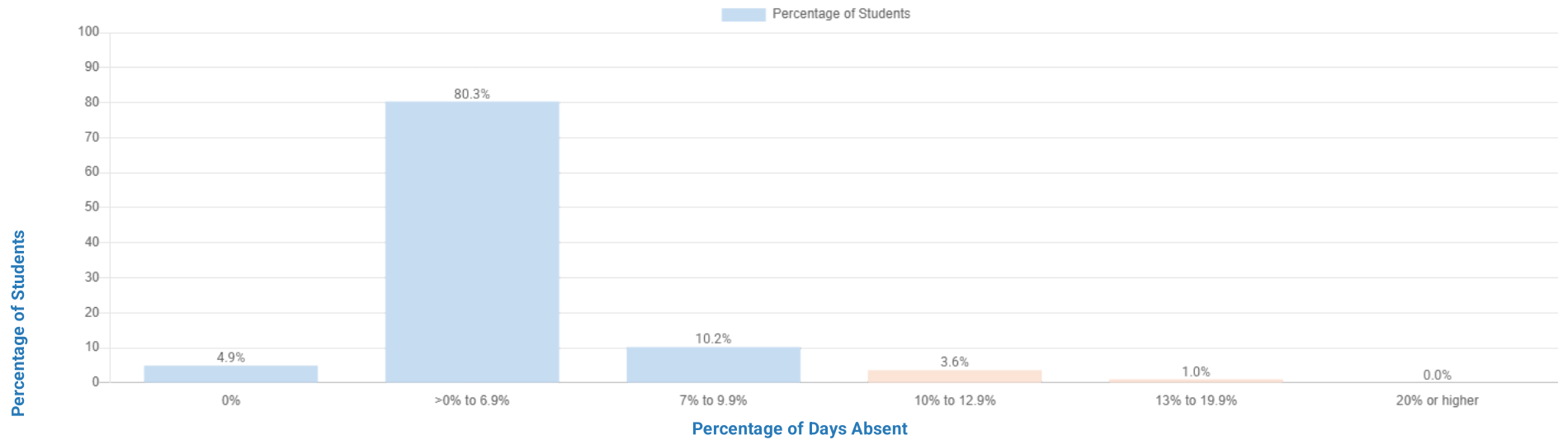

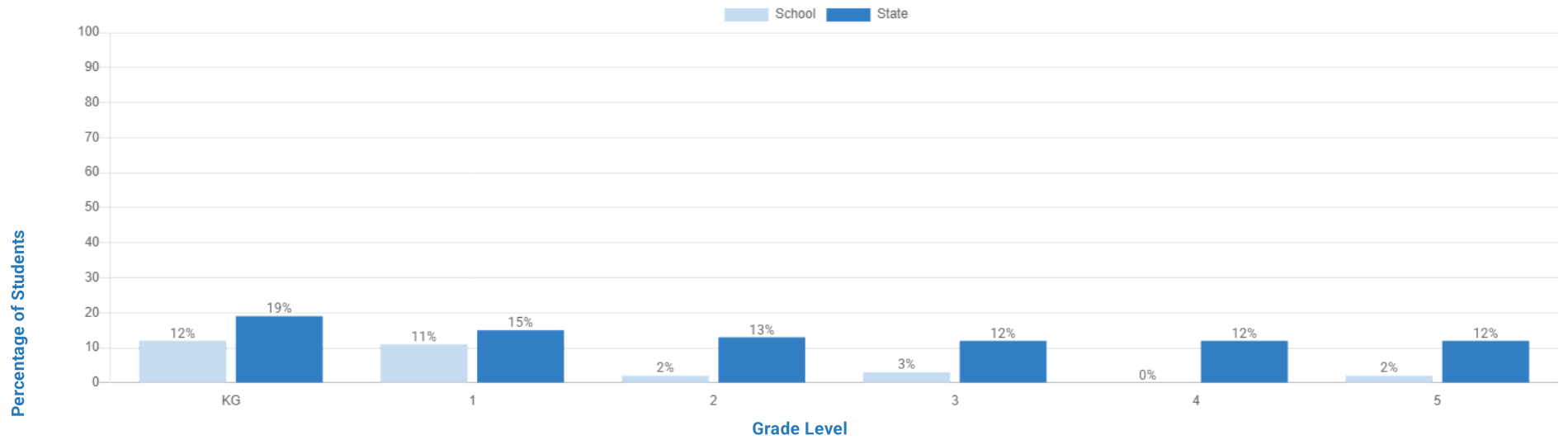

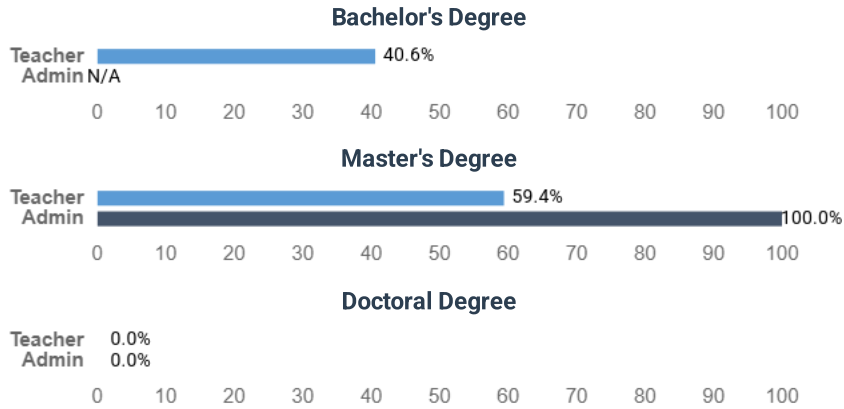

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. At Dennis B. O'Brien we offer instruction in Math, Language Arts, Science, Social Studies. Staff engage in targeted professional development and professional learning communities with a focus on effective instruction and improving student growth through academic data analysis as well as executive functioning skills. Our staff are a highly dedicated team that seek out professional opportunities, grants and ways to improve in order to better themselves and the school community.
