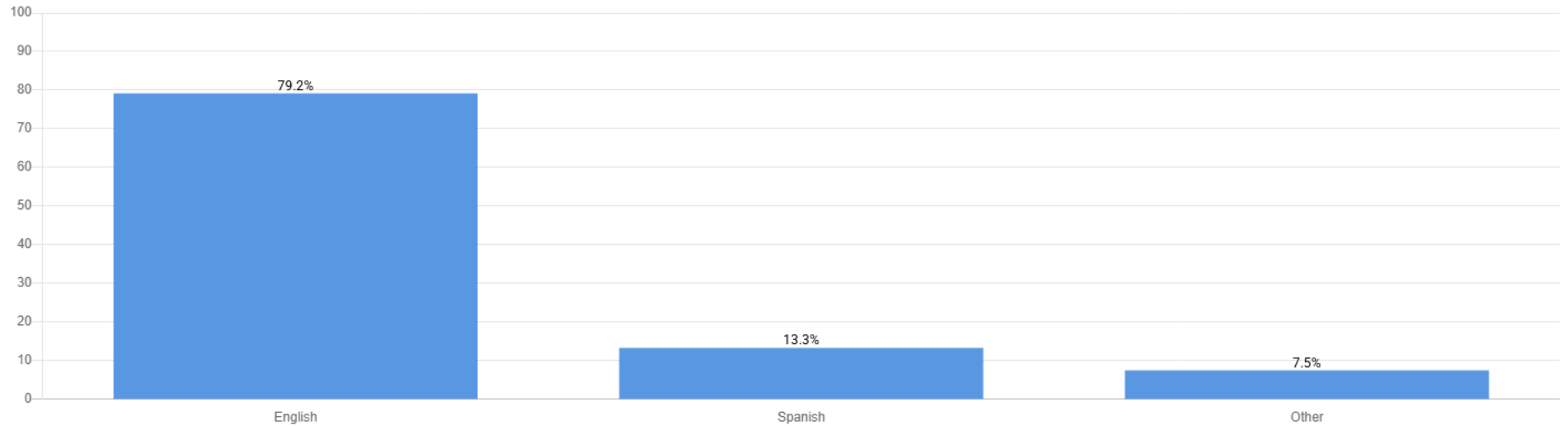

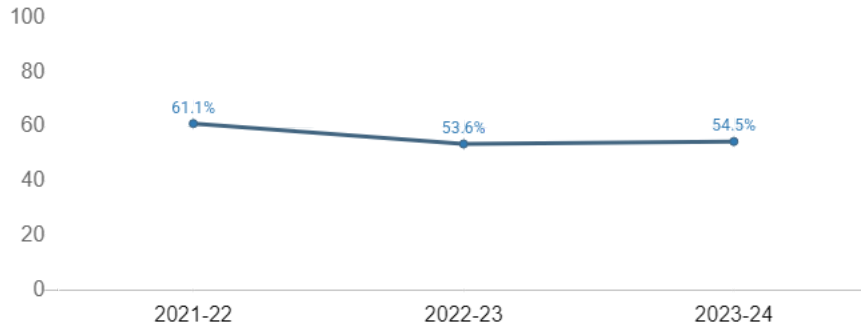

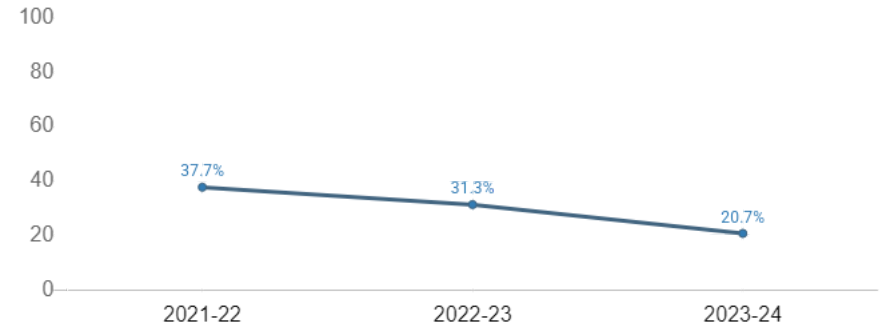
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 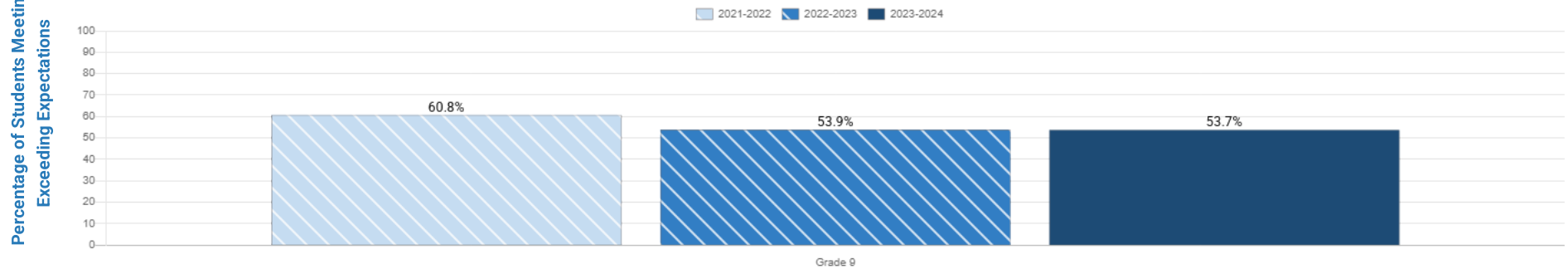

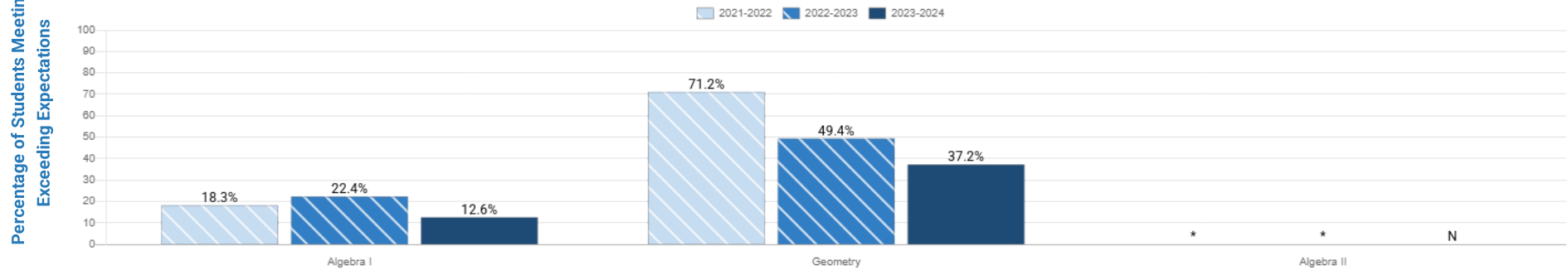

The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

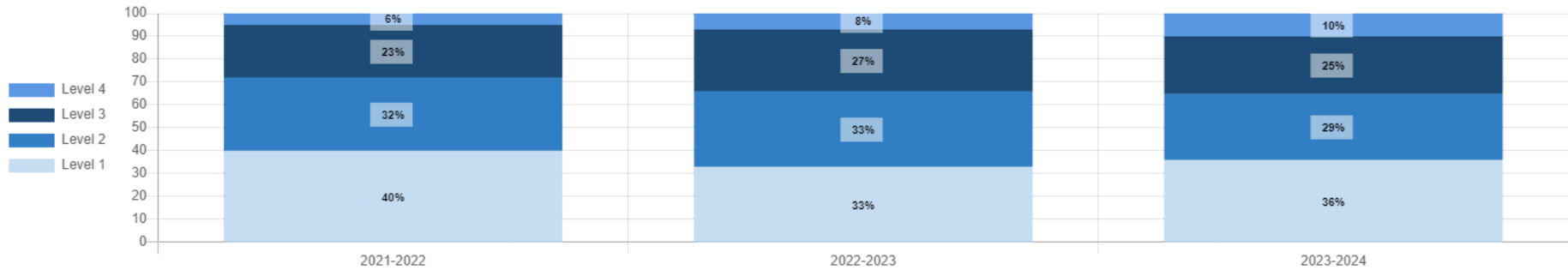

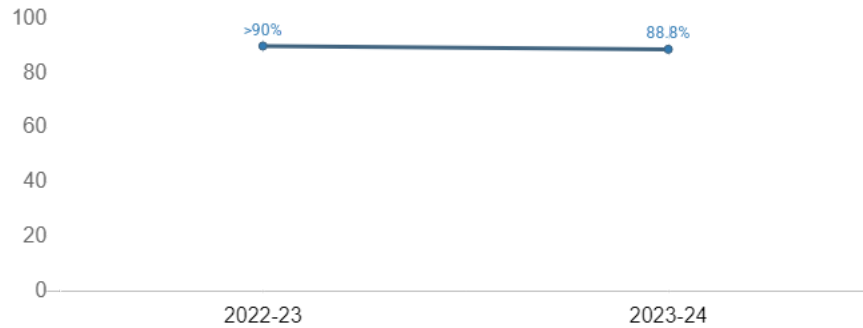

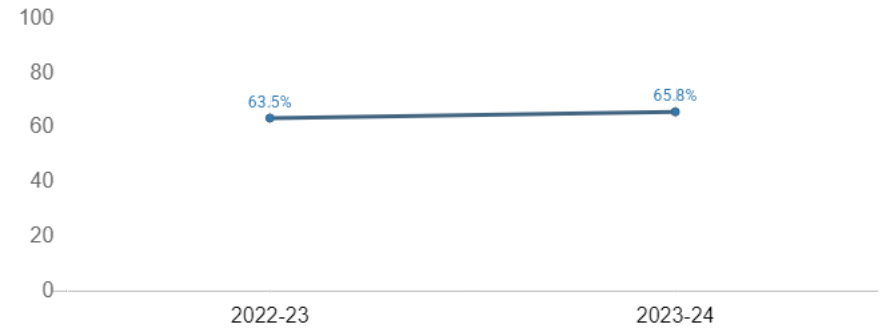

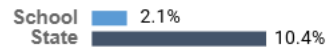

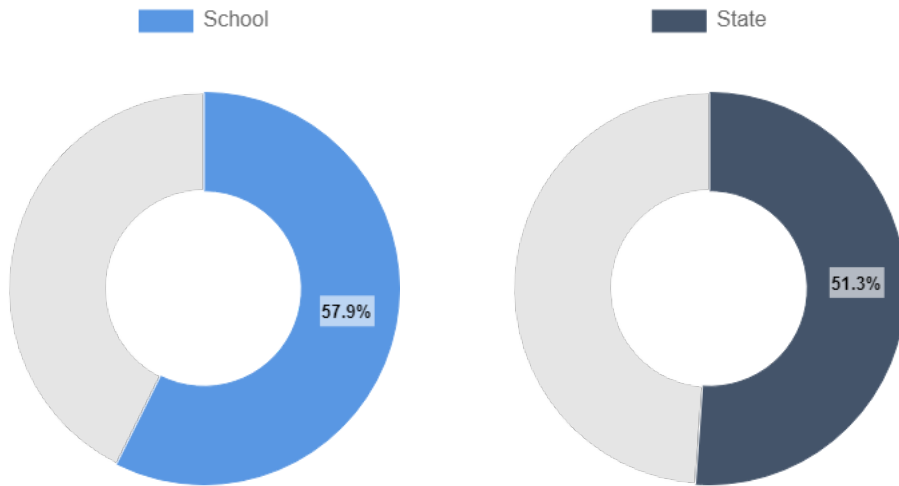

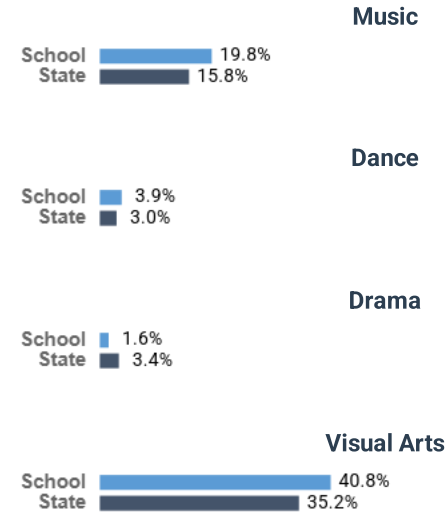

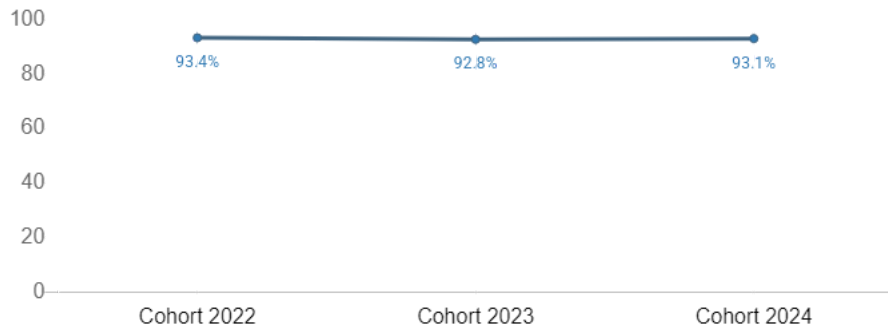

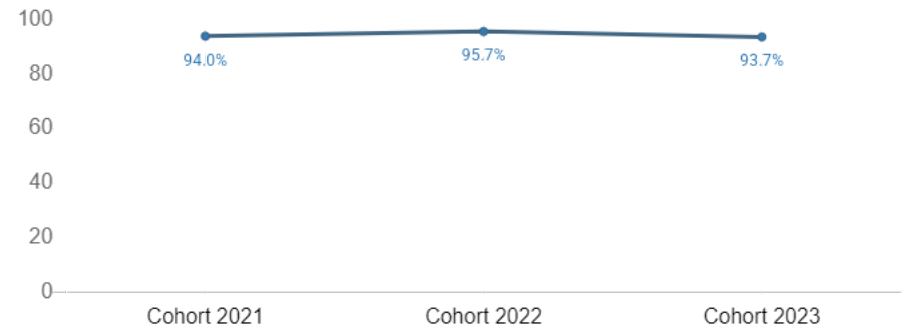

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

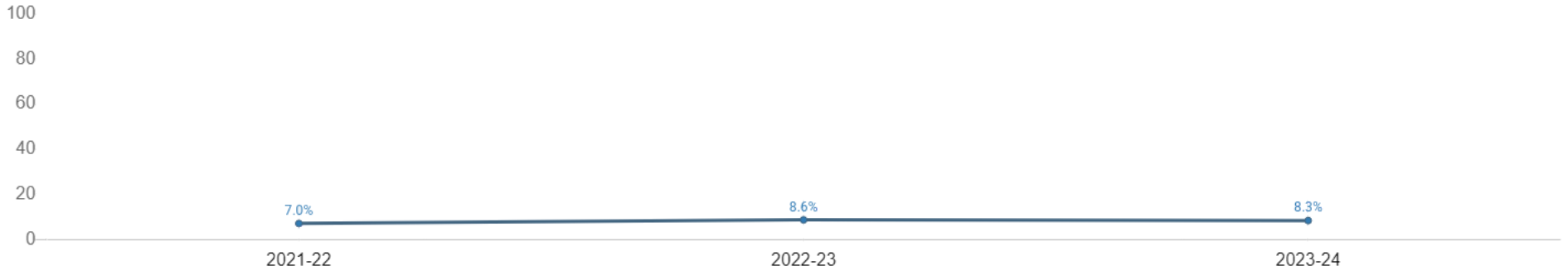

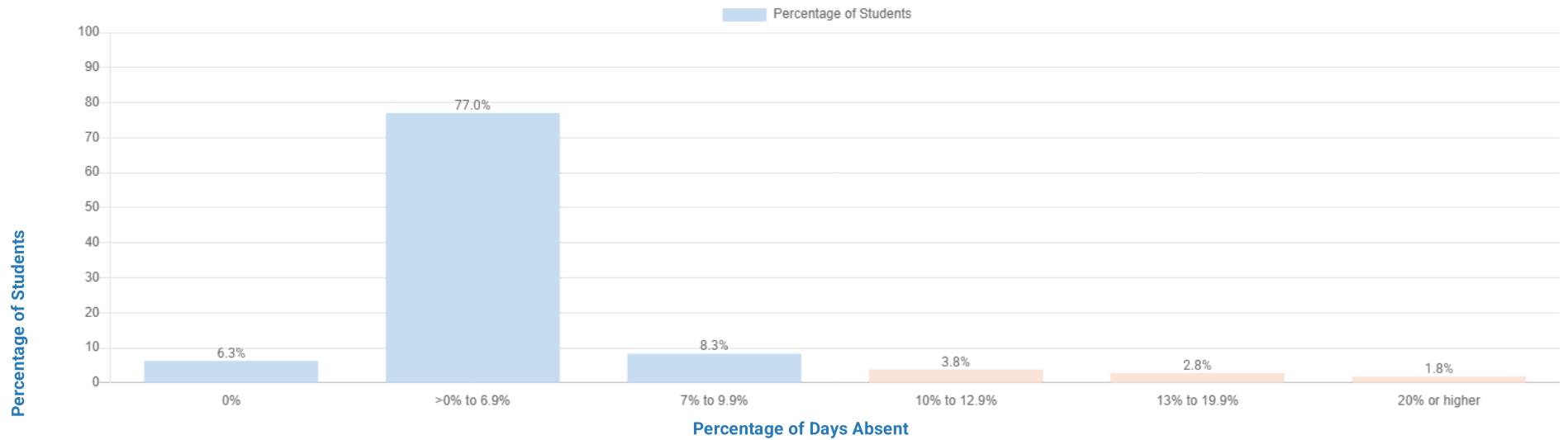

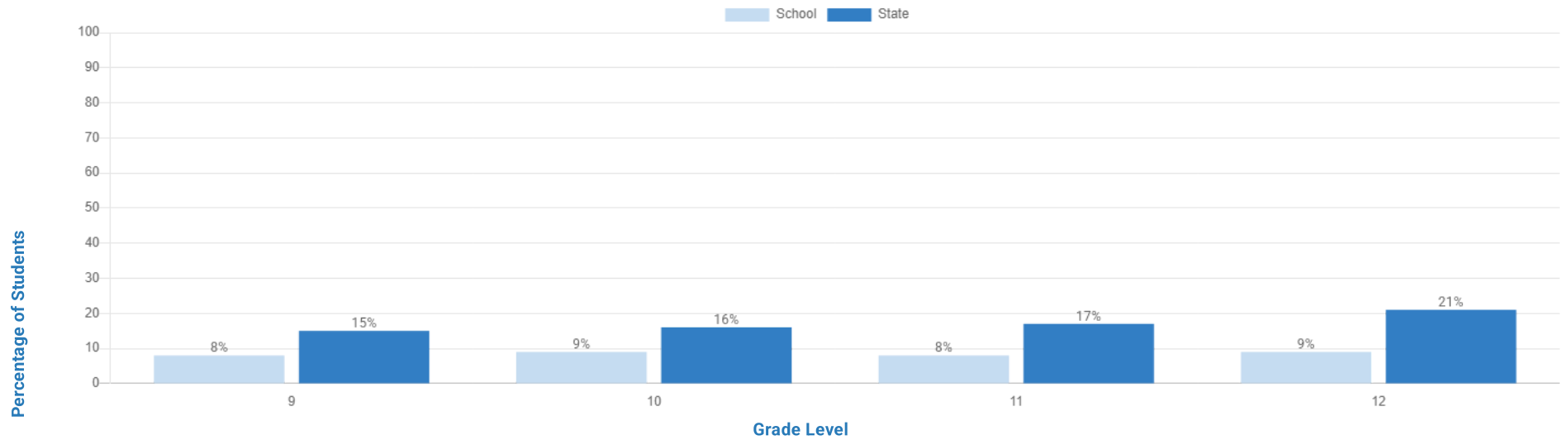

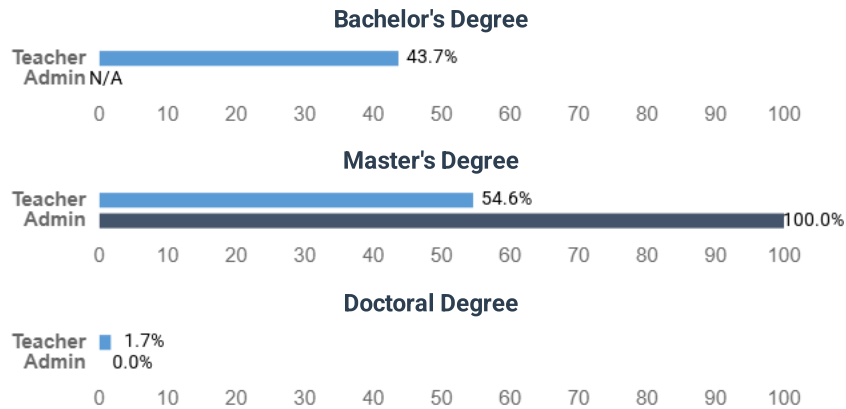

Before and After School Programs:

Along with our formal clubs and activities, informal programming for students seeking extra help in coursework, opportunities for using technology, and quiet study time both before and after school hours are provided in the media center, and in certain classrooms. Peer tutoring is often a component of this program.



Staff and Professional Learning:

Roxbury High School's staff pursues professional development opportunities through in-district attendance at teacher developed professional programs; and through online coursework, graduate studies, and attendance at professional conferences. Time has been built into the alternating day block schedule for Professional Learning Communities to meet; and for staff to participate in instructional rounds, where faculty visit the classrooms of colleagues to promote their own professional growth. This year, teachers have been encouraged to do instructional rounds in different buildings or districts. Staff also participate in Principal's Academies. These academies are held monthly and focus on all aspects of high school education including but not limited to: Mandatory Reporting, Enhance Standardized Testing Training, SEL, LGBTQ, Advisory, etc.



Postsecondary Information:

We are proud of the efforts of our Guidance Department to help students forge a Four-Year Plan for Career and College. We sponsor numerous College Fairs to initiate the college search process. Counselors work closely with students and their families throughout the college search and application process by researching schools, testing students, submitting applications, and exploring funding options for college. In 2023, almost 90% of our students continued their formal education after graduation. About 3% of students entered the workforce. Roxbury High School graduates are also represented in all branches of the military.

Student Supports and Services:

We provide outstanding services for students with IEPs in the least restrictive environment. A wide range of special programs, integrated with regular education classes, affords all of our students a positive learning experience. In-Class Resource, Academic Centers, and ESL classes meet specific educational needs. The service learning and student empowerment programs teach pupils to advocate for themselves. A transition coordinator supports the transition to post-graduation experiences through various Community-Based Instruction opportunities. Thrive Alliance provides therapeutic support for Classified and General Education students as appropriate.



Student Health and Wellness:

Roxbury High School's Health and Physical Education curriculum emphasizes lifetime fitness, proper nutrition, mindfulness, and positive social interaction. Students may choose High Performance, Wellness, or Traditional PE classes depending on their preference. A High Elements course promotes team building and cooperative learning. Electives provide the opportunity to understand the physiology and psychology of exercise science. The state has recognized our Physical Education program as a model for others. Over the last few years, many teachers at RHS have promoted mindfulness and have incorporated brain breaks. Equipment and facility upgrades are addressed to promote good health and aesthetics. A newly created Zen Den is an area to be used for student emotional regulation.



Parent and Community Involvement:

Roxbury High School is currently in the process of resurrecting a formal Home School Association. Roxbury High School also has well-organized parent booster clubs that are involved with and support the mission of their respective programs and, by proxy, the school program. The Guidance Department presents and sponsors numerous parent programs. All of our co-curricular programs conduct community service programs in conjunction with parent groups. Significant community involvement contributes to the success of unique programs like Every 15 Minutes, Alive at 25, and Project Graduation.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Each year, at the conclusion of the school year, a school climate survey is administered to the high school staff. The results of the survey are analyzed by the administrative team, concerns are identified and responses are prepared. The survey results are shared with the staff prior to the start of school. An action plan is presented to the staff at the opening of school meeting. All of this information is provided to the Central Office Administration. This year we surveyed students and parents about school culture and climate, as well as restorative justice.



Facilities:

The facility at Roxbury High School supports the curricular and co-curricular programs offered. Facility needs are evaluated and plans are made to address those needs for the following summer. Some of those projects include Science lab refurbishment and kitchen updates. Currently there are CAD and Graphics labs, state-of-the-art music and dance facilities, a television studio, and fitness and weight rooms. The turf field and track have also been redone in the past few years, and RHS has a modern Media Center. The Robotics lab continues to support our ever-growing and very successful Roxbotix team. An old Auto Shop has been repurposed into a Structural Design and Fabrication lab. This provides students with hands-on opportunities to design and build shop with state-of-the-art tools and practical applications; and it currently houses a dwelling that is being built for Habitat for Humanity.



School Safety:

Roxbury High School implements a variety of safety and security drills to prepare students to react to emergency situations. Our staff and students take an active role in the planning and process of the drills. All Safety and Security drills are done with the presence of the Roxbury Police Department. In the Summer of 2017, a Security vestibule was built to ensure the safety of all stakeholders at Roxbury High School. New cameras and a video system were installed to increase coverage and security throughout the building.

Technology and STEM:

Roxbury HS is one of five schools in NJ that host AOPA's You Can Fly program in grades 9-12. This four-year high school aviation STEM program falls along two tracks- pilot & unmanned aircraft systems or drones. This program conforms to math & science standards and, in keeping with career & technical education best practices, will lead to certification or an industry-accepted test, such as the FAA Private Pilot knowledge test or a Part 107 drone pilot certification. One teacher and 3 students have attained their pilot's license. We also present other opportunities for students to experience elements of STEM. In our Media Center students have access to 3D printers & can manipulate gadgets in a small makerspace. In our Engineering program students are afforded with opportunities to design & create useful, practical mechanisms. Roxbury HS also offers a Computer Science class where students practice coding & create online programs.



Early Childhood Education:

For over 20 years, Roxbury High School has provided a preschool program for the community. We have two preschool programs at Roxbury High School. One program is for children aged four, the other is for children aged three. High School students who supervise the preschoolers in these programs have the "Teaching Young Children" class every day. Our students get to know the preschool students and establish positive relationships with each preschooler. Some of our high school students participated in the same program when they were three or four years old.



Attendance:

During the 2023-2024 a series of adjustments were made to continue improving student attendance in Roxbury High School. This change begins with the addition of a homeroom which was added to the bell schedule allowing students to transition into their school day. This 7-minute block allows students to report to school with students in their respective grade levels with two teachers assigned to each room. Each student will have the same homeroom teachers and homeroom to report to creating opportunities for students to establish positive relationships with both peers and staff. A therapeutic room was created to allow a safe, calm and inviting space for students to utilize when having difficulty socially or emotionally. This space is also used for students who are having difficulty entering or attending classes as a location for students to utilize when re-entering the building. Roxbury High School has been able to reduce its chronic absenteeism by 0.9% for the 2023-2024 school year.

Other Information:

To prepare all of our students for pursuit of their future endeavors: -Roxbury High School uses an alternating day extended period instructional schedule. Unique features of the schedule include a variable instructional period (VIP) for students and scheduled Professional Learning Community (PLC) time for the faculty. In Program Resource and Instructional Centers address the educational needs of students. -The curriculum includes over 40 honors courses and 26 AP courses, including the AP Capstone offerings. High interest electives support college academic readiness. -Certified as a "Green School", we have implemented a range of sustainability and conservation protocols. -We employ a one-to-one technology program where all students are outfitted with Google Chromebooks that, along with school-wide wireless connectivity, propels the use of technology to the forefront in the learning process. -Roxbury is an Interdistrict School of Choice for the Fine and Performing Arts. -A unique "Artists in Residency" program provides access to performing and visual artists for our instrumental, vocal, dance and visual arts students. -School designed character education programs such as "Peer to Peer" and "Freshman Seminar", along with many service organizations, promote positive growth for students in the affective domain. -More than 75% of the student population participates in co-curricular clubs and athletics. -Many of the more than 40 clubs and co-curricular programs have earned significant recognition for their performance. We have competitive Debate and Robotics teams. The Echo Yearbook has earned awards from the GSSPA in each of the last eight years. The student run Mini-THON program raised over \$400,000 in contributions over the last 10 years to fight childhood cancer.
