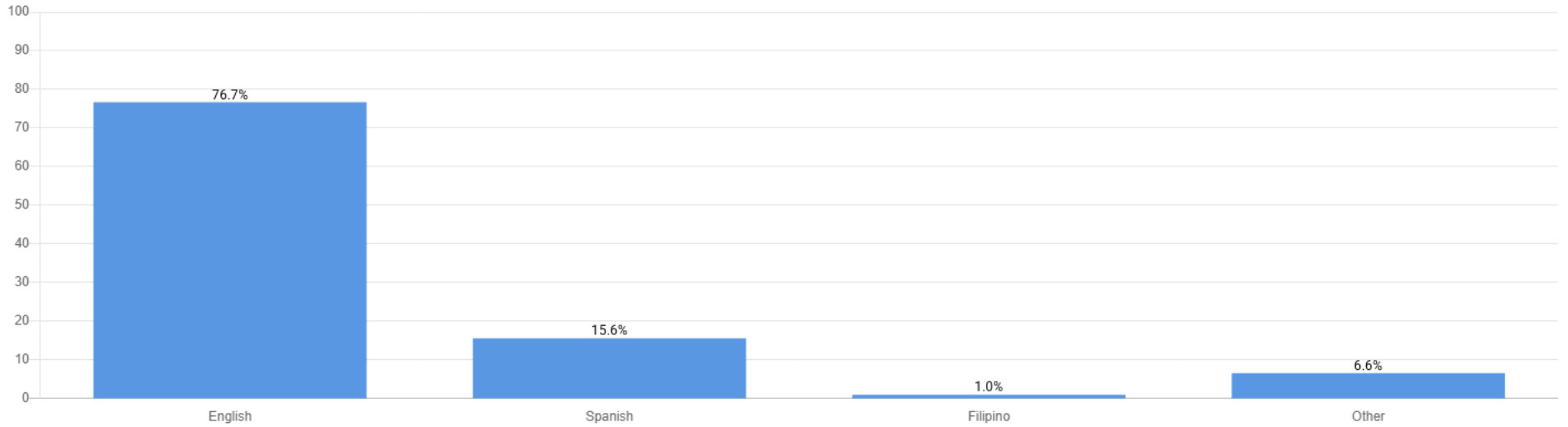

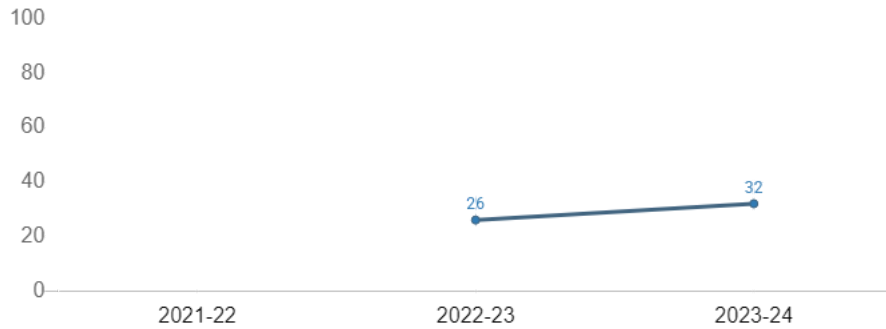

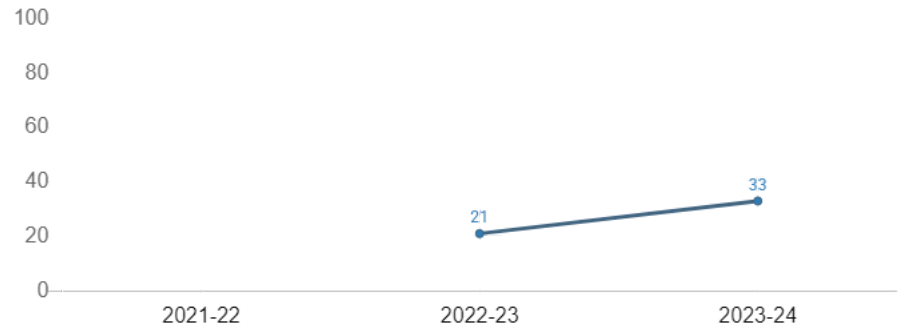

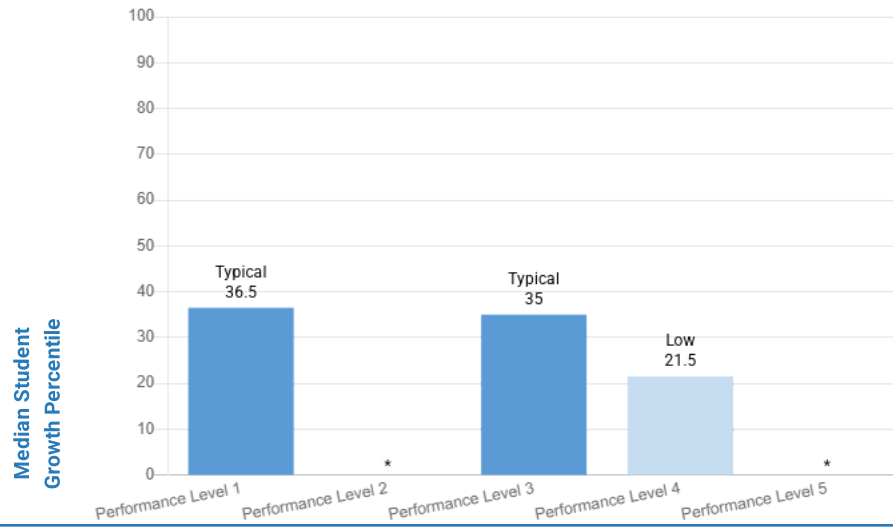

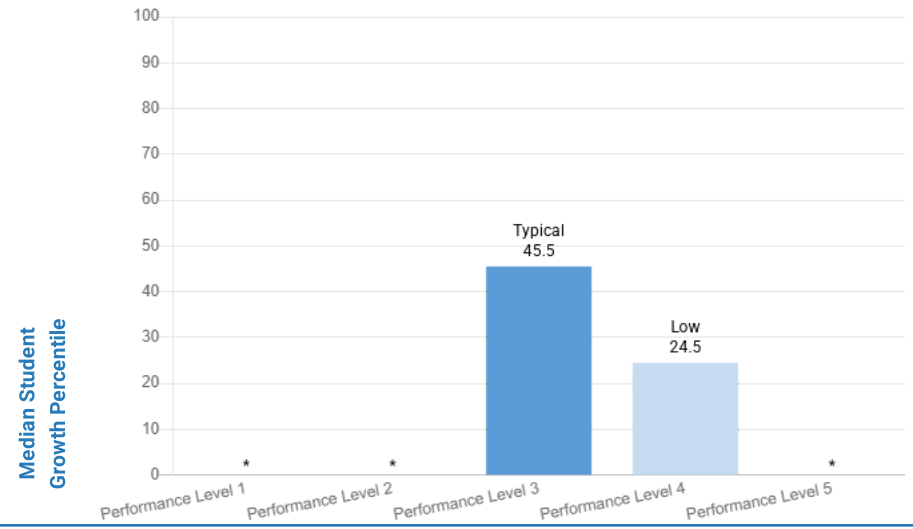

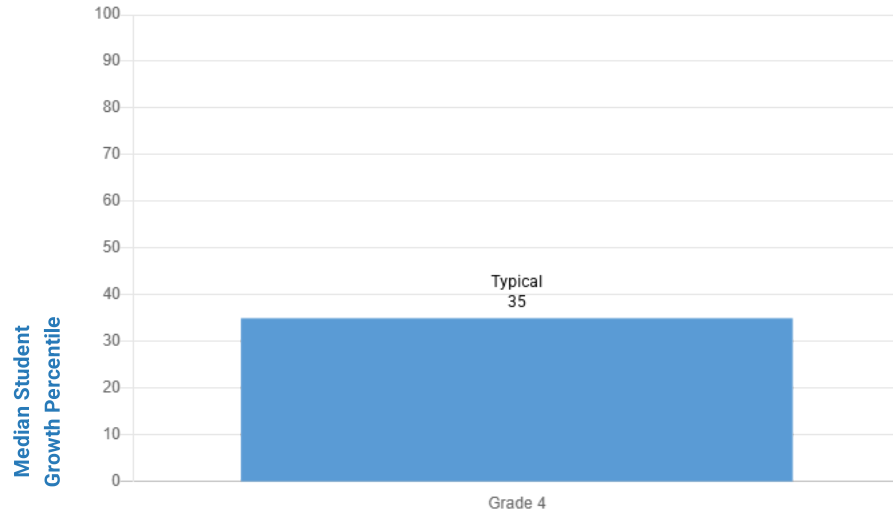

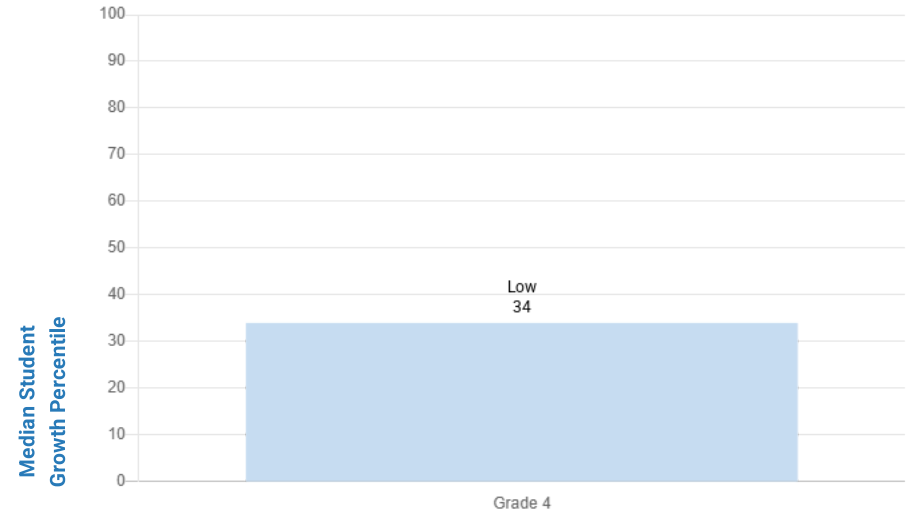

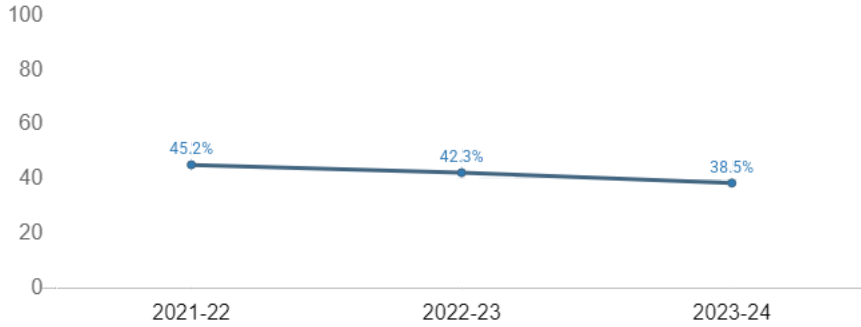

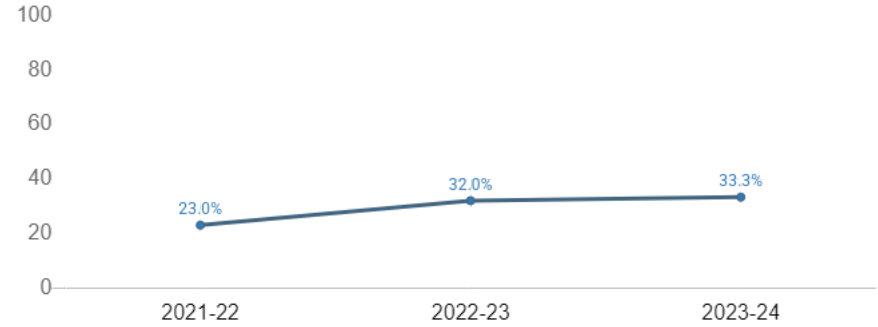
### English Language Arts and Mathematics Performance Trends

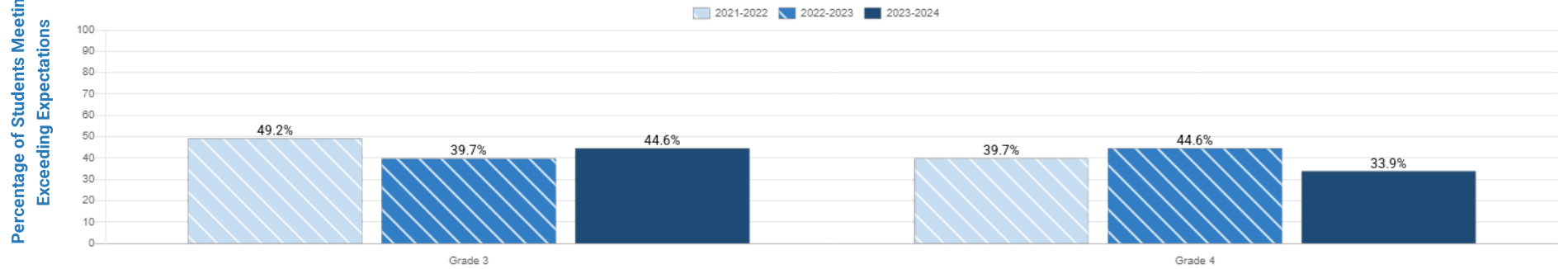

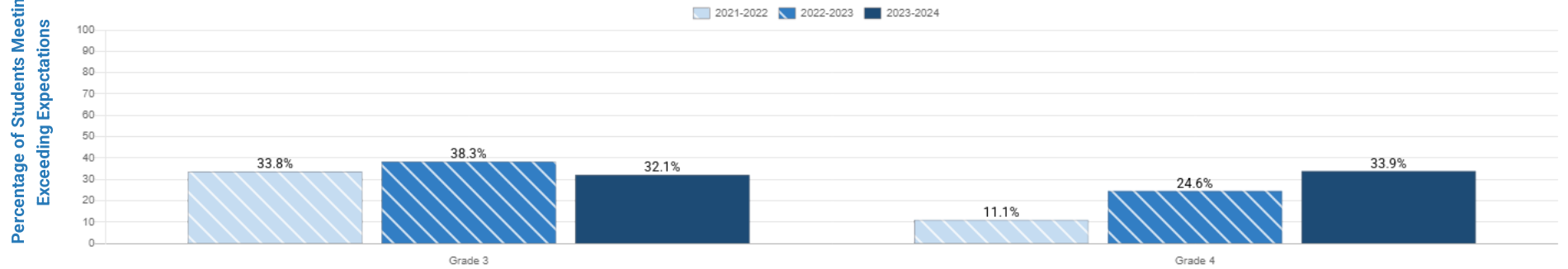

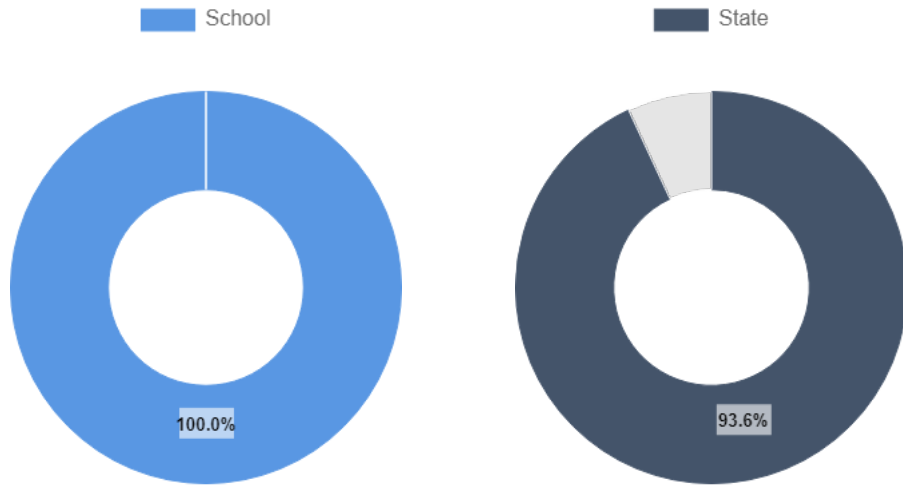

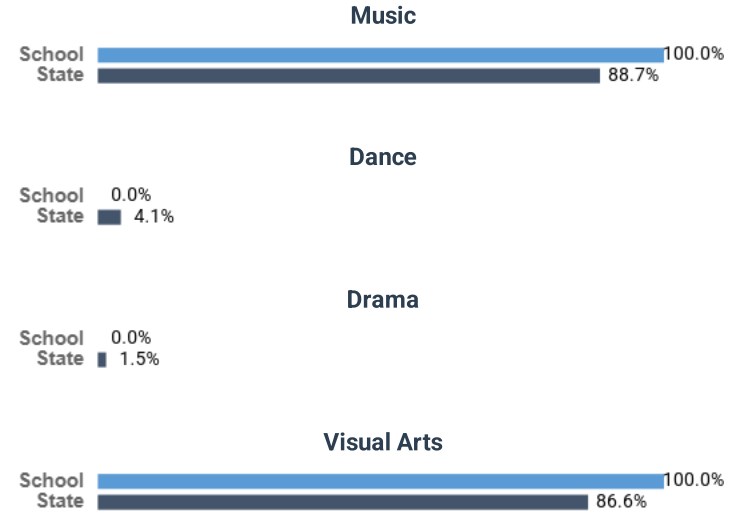

**Students enrolled in one or more classes by discipline:**



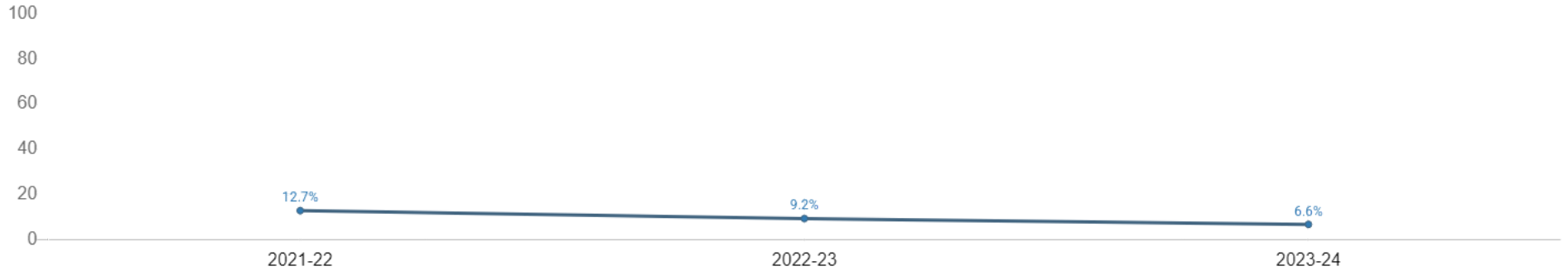

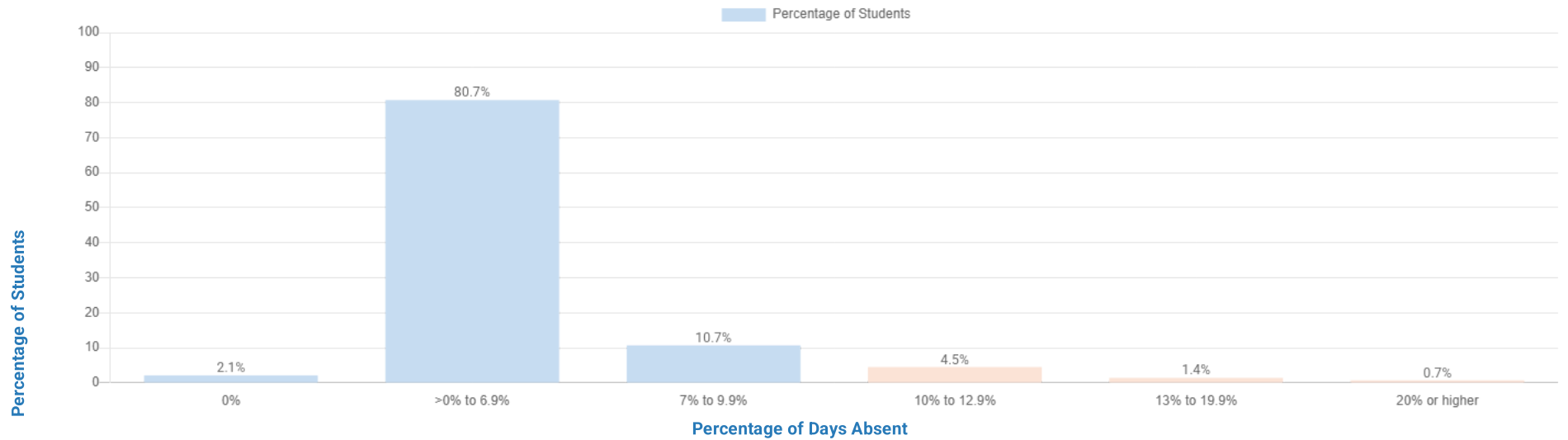

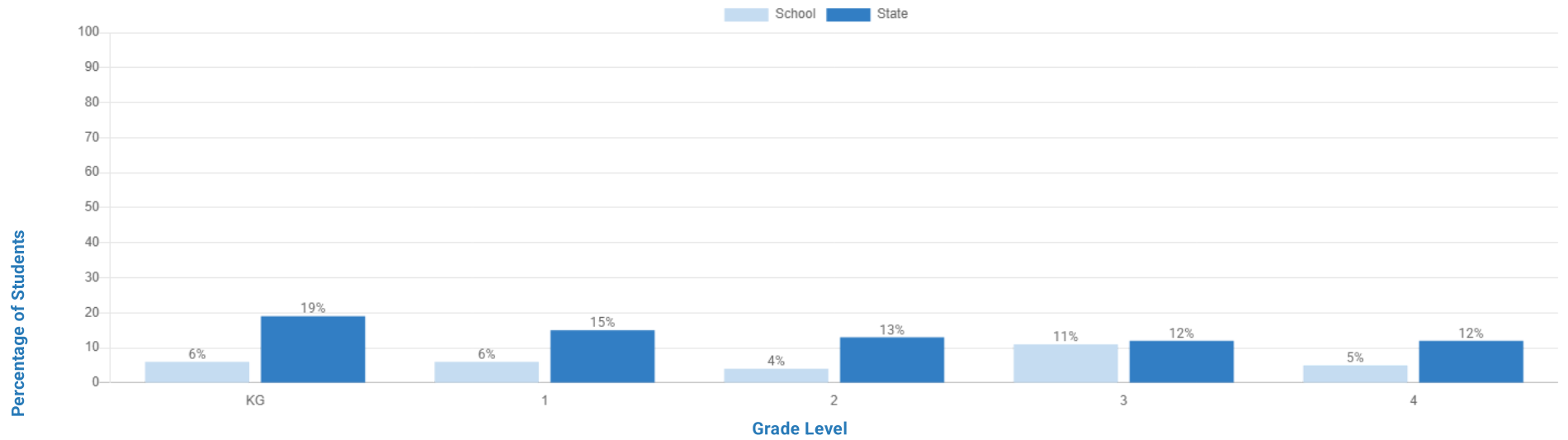

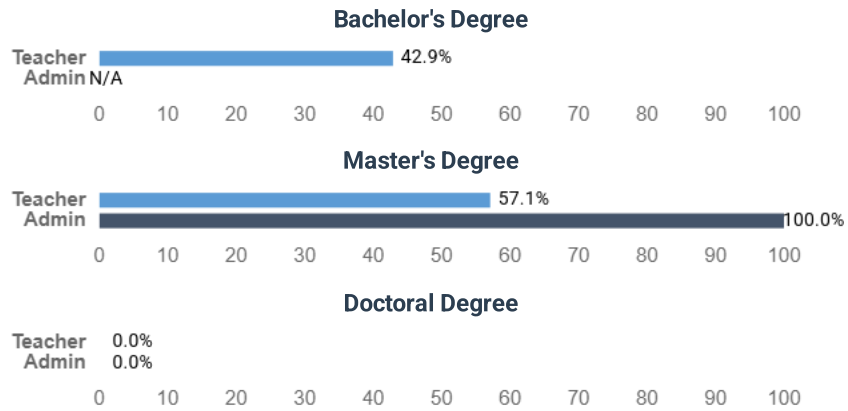

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. ### Highlights:

- Silver Certified School, through Sustainable Jersey for Schools. Students and staff continue to work towards enhancing sustainability through our recycling efforts and refillable water stations.
- The school's core values program (Franklin School RULES) provides students with specific reinforcement and acknowledgement for positive character interactions.
- At Franklin School, professional development is a priority. These include in-district workshops, push-in learning experiences, summer sessions, and peer observations.



### Mission, Vision, Theme:

Franklin School has a student population of approximately 290 students in grades kindergarten through four. The students, staff, and parents work together as a school community to enable each child to reach his or her individual potential. The goal is to create a warm, safe environment that fosters the development of the whole child - socially, emotionally, and cognitively. Additionally, the staff of dedicated teachers continually utilize best practices to differentiate instruction for students.



### Awards, Recognition, Accomplishments:

Prior to the 2023-2024 school year, Franklin School was recognized as a State School of Character for involving all stakeholders to create a strong community that supports character for all. Since then, the school has used the feedback provided to continue to support all stakeholders. Franklin School participates in several community service projects and fundraising opportunities throughout the year. Examples of these projects include food drives and creating blankets for children in hospitals. Also, the service opportunities benefit local and national organizations including Roxbury Social Services and the St. Baldrick's Foundation.

### Courses, Curriculum, Instruction:

Instruction at Franklin School is differentiated to meet the individual needs of all learners. Teachers work collaboratively in Professional Learning Communities and develop lesson plans based upon individual student needs, talents, abilities, and preferred learning styles. In addition, teachers strive to utilize technology as an effective teaching tool in order to prepare Franklin students to become 21st century learners. Social-emotional learning, wellness and mindfulness activities are also woven into daily classroom activities, and teachers utilize these activities to enhance student learning and address students' emotional needs.



### Clubs and Activities:

Fourth grade students have an opportunity to participate in a service-oriented club called Early Act, which is sponsored by the local Rotary. Students learn that service to others is important, and get the opportunity to help others through organizing schoolwide service projects such as food and clothing drives to benefit the local community. Early Act serves as a foundation for the Interact Club at Roxbury High School and has student officers who run the meetings throughout the year.



### Before and After School Programs:

Our school welcomes scouting, art classes, science enrichment projects and many other community programs for after-school enrichment offered through the Roxbury Community School.

### Staff and Professional Learning:

Staff members at Franklin School are a professional group. They are continually collaborating and working on improving their skills. Teachers meet weekly in Professional Learning Communities (PLCs) to collaborate on lesson plans and projects. In addition, staff members regularly participate in a variety of professional development opportunities to update their skills and incorporate best practices into their daily routines. Teachers are also encouraged to take part in professional learning opportunities that they feel would most benefit their teaching and their students.



### Student Supports and Services:

Franklin School offers a variety of services for students with special needs, including two Language Learning Disability (LLD) classrooms serving students in grades K through four; and Out-of-Class Resource (OCR) classes serving students in grades two through four. There is also an In Support of Learning program for students who struggle academically. In this program, four staff members, two full-time and two part-time, service students from all grade levels who are struggling academically in reading and/or math. Students receive additional support in these areas in small groups. Additionally, the school staff includes specialists in Speech & Language, English as a Second Language, Hearing Impairment, Guidance, Occupational Therapy, and Physical Therapy.



### Student Health and Wellness:

Students receive direct instruction in physical education which is designed to foster a lifelong, healthy lifestyle with an emphasis on wellness. This is supplemented with a daily recess period. Additionally, Franklin students are encouraged to advocate for themselves and others and are taught to develop strategies to solve problems. The school counselor conducts regular classroom lessons to this end and teachers incorporate Health and Wellness opportunities into their daily lessons during the time dedicated each day for Social and Emotional Learning (SEL). Teachers also have the opportunity to collaborate with a mindfulness expert regularly to assist them with planning and implementing mindfulness techniques in the classroom.

### Parent and Community Involvement:

Parents & guardians at Franklin School are supportive and involved in the education of their children. The Parent Teacher Association keeps parents informed & provides a wide variety of enriching activities for students and families. There are many exciting assemblies presented to students throughout the school year, & parent volunteers help to organize student participation in all of these programs. The PTA also sponsors family activity nights and assists with Field Day (known as FES RULES Day in 2023-2024). Weekly digital newsletters are sent out to parents from the school and the Parent Teacher Association to foster communication and participation in school events and activities.



### Facilities:

Franklin School continues to make use of its Outdoor Classroom which provides a natural setting where classes can connect with nature and observe different plant life. Teachers utilize this space for other instructional purposes as well as wellness activities. In addition, the technology lab and media center have been redesigned to further implement a makerspace in an effort to foster creative thinking and exploration during STEAM activities. The maintenance and food services departments also work collaboratively with the staff and students to maintain our sustainability and recycling efforts. Finally, the school is located in close proximity to the outdoor pavilion, an area which is utilized for instruction regularly.



### School Safety:

Franklin School continues to utilize rigorous security measures including a security vestibule, security cameras both inside and outside of the building, and on-site security guards. All visitors must follow security procedures to enter the building, including running driver's licenses through LobbyGuard and wearing a personalized security badge for the duration of the visit. In addition, the School Safety Team meets multiple times throughout the year to discuss and review safety procedures and protocols. This team consists of staff members and a parent representative, as well as the Roxbury School District Director of Security. Also, fourth grade students are given the opportunity to be Safety Patrol Members. They are trained by the school counselor and are involved in maintaining safety procedures throughout the school building and on the buses.

### Technology and STEM:

Franklin School has a wide variety of technology available for teachers and students to use to enhance instruction. Every student and staff member in the school has received a Chromebook to allow for virtual instruction, if needed. Additionally, there are two iPad carts with 30 iPads on each housed within the building; and many classrooms also have five to ten iPads stationed in them for student and teacher use. There is a redesigned technology lab and media center to further promote a Makerspace area. Along with this, teachers provide virtual reality opportunities for students via Google Expeditions that are related to their instruction. Many Franklin School teachers also utilize OSMO to help teach students problem-solving skills, and students participate in the district's STEAM Expo where they design their own experiments and research.



### Attendance:

In order to encourage regular attendance, our school, in alignment with our district policy, notifies parents regularly of excessive absences. Letters are sent home to those families that are over the absence threshold for appropriate attendance. If the student continues to progress in absence after the ten-day letter is sent, our Intervention and Referral Service Committee addresses the issue in accordance with the district's attendance policy. Of course, FES utilizes positive reinforcement in order to promote attendance for all students. We facilitate many fun activities, such as spirit days, school events, assemblies, and rewards that encourage the students to participate. By wanting to be a part of the school day and not to miss school activities, student attendance is predicted to improve.

### Other Information:

Franklin School was first identified as a Title I school during the 2016-2017 school year. The Title I funds that are granted allow various programs to run to provide assistance for students who are struggling academically. One such program is the S.A.I.L. Summer Program. This operates during the month of July and serves students in grades K-4 who are in need of extra academic support. Title I funds have also been used to develop and implement an early intervention program for kindergarten students called Kinder S.T.A.R.S., which targets kindergarten students who are in need of additional support. Students in grade 1 who are in need of additional support receive services through this funding as well. In addition, Title I funds are used to support a Parent Academy that operates several times a year and offers parents various opportunities to receive guidance in assisting their children as they develop at home. Franklin School is also one of two elementary schools in Roxbury selected to participate in the NJ Tiered System of Supports for Early Reading grant. This three-year grant, which is a partnership between the NJDOE and Rutgers University, engages district staff and administration in a coaching model to enhance the effectiveness of reading interventions. A number of staff at FES receive support regarding intervention systems and procedures, as well as ensuring essential components of NJTSS are being integrated effectively. Coaching is provided by State-Level NJTSS-ER coaches to district staff working in schools that serve students in K-3. This grant and its actions emphasize improvement in both early literacy and reading achievement in K-3. Participation provides rigorous teaching strategies and learning practices, and data-driven support. At Franklin School, administration and the school's In Support of Learning teachers join district administration as members of the grant's Leadership Team.
