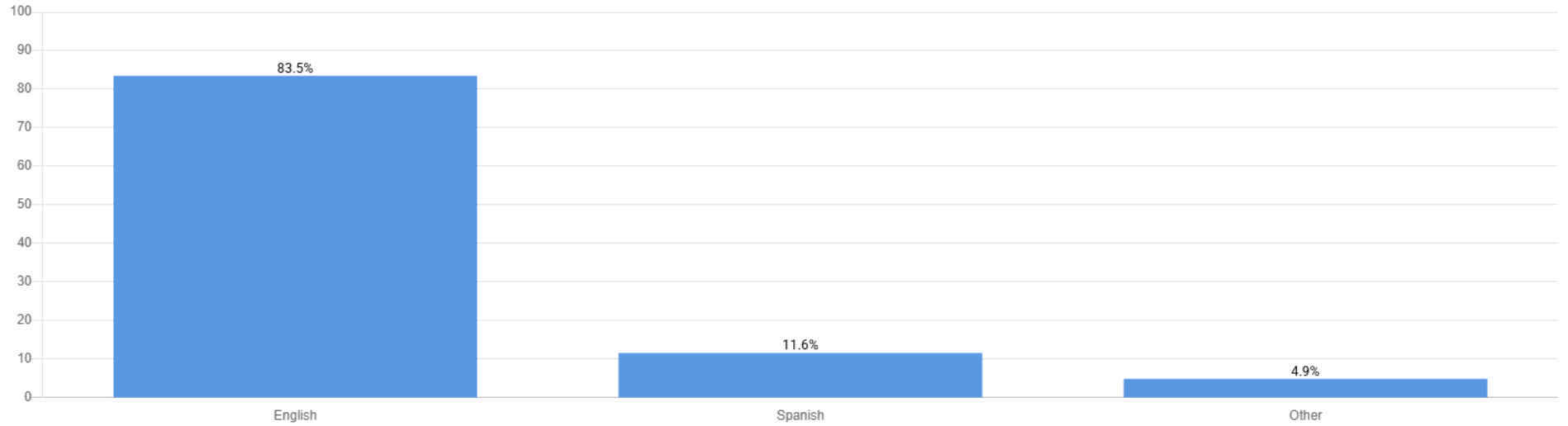

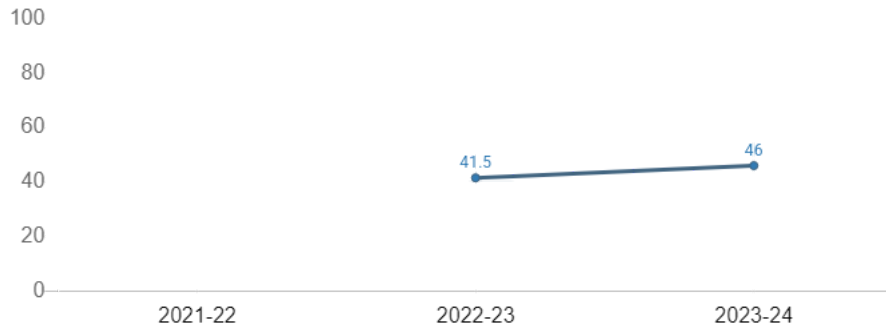

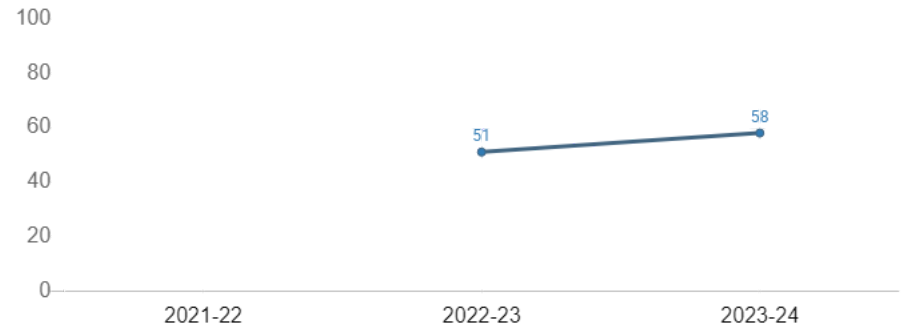

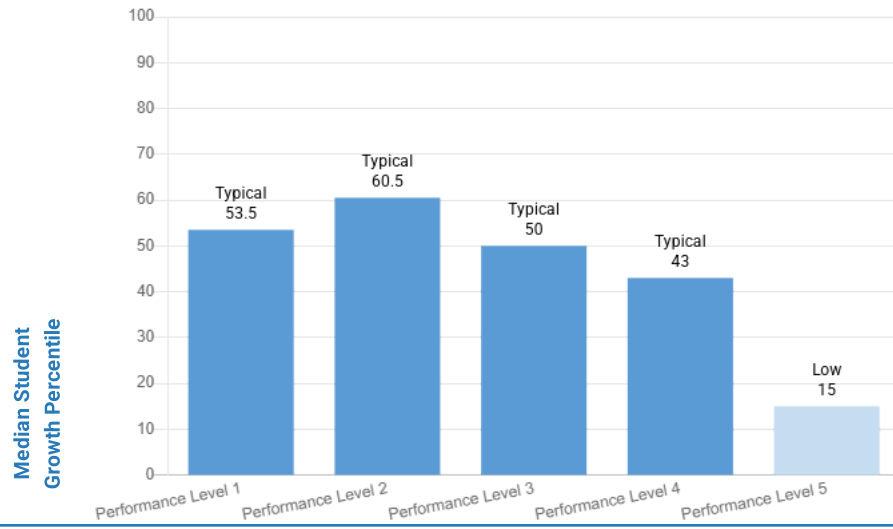

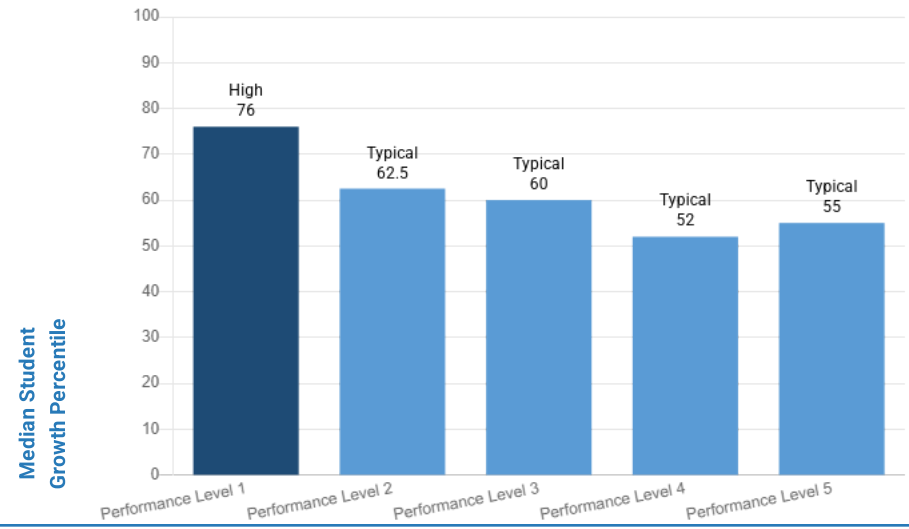

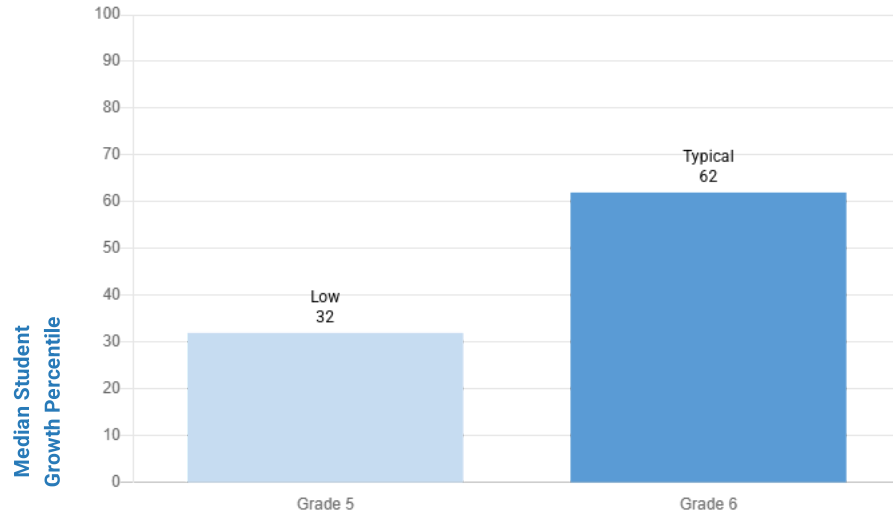

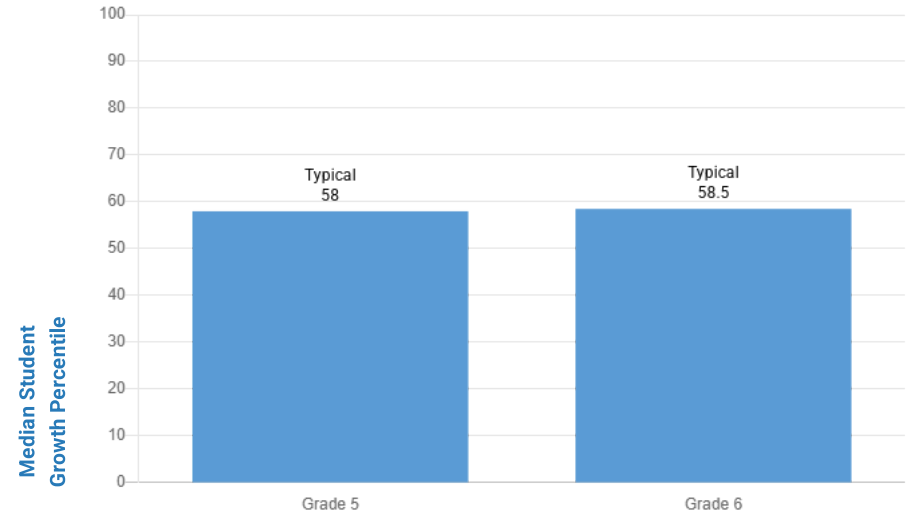

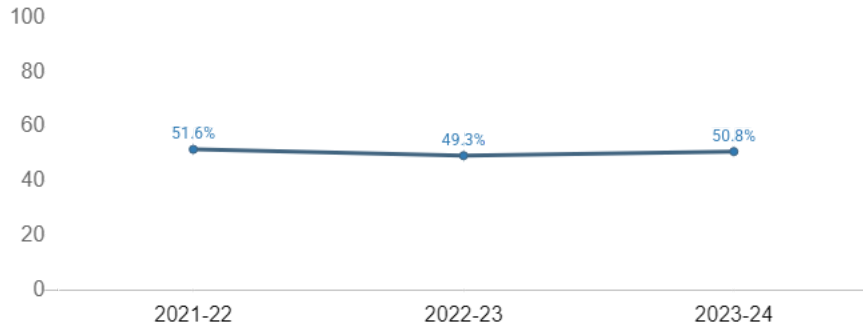

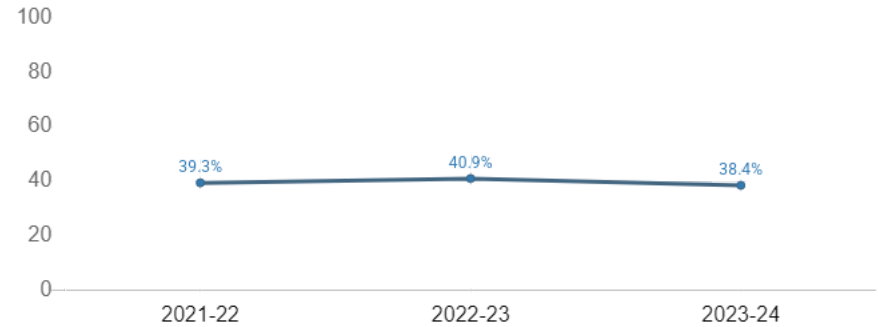
English Language Arts and Mathematics Performance Trends

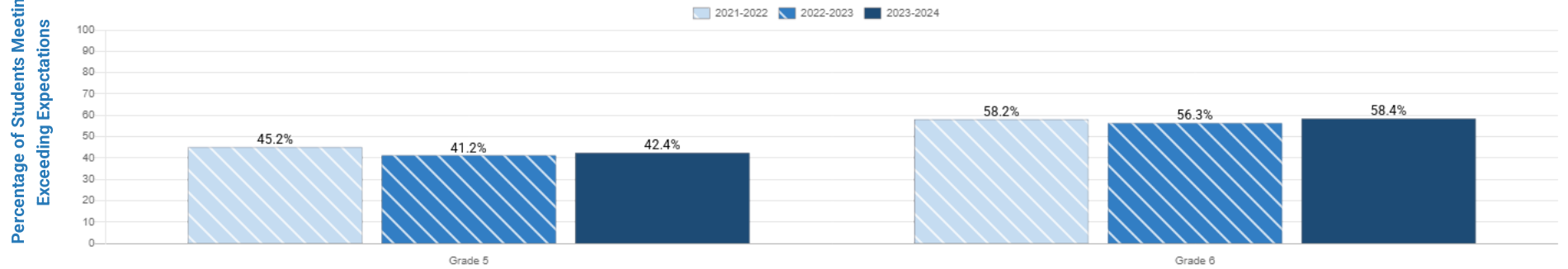

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 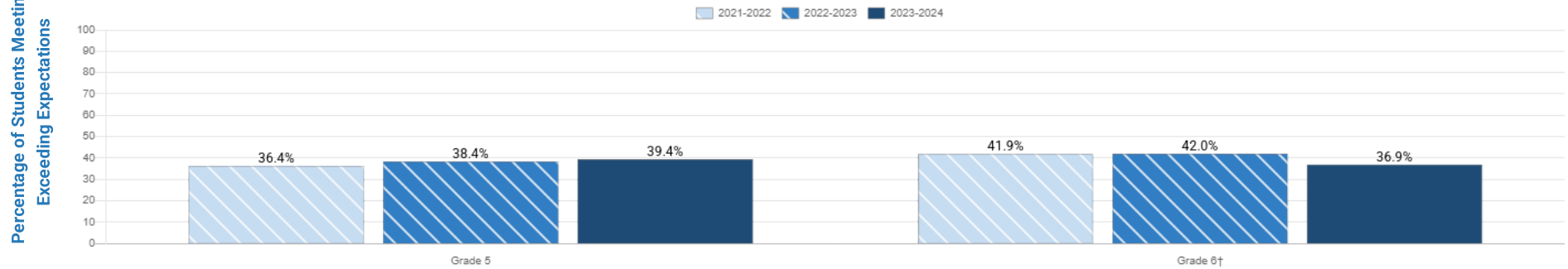

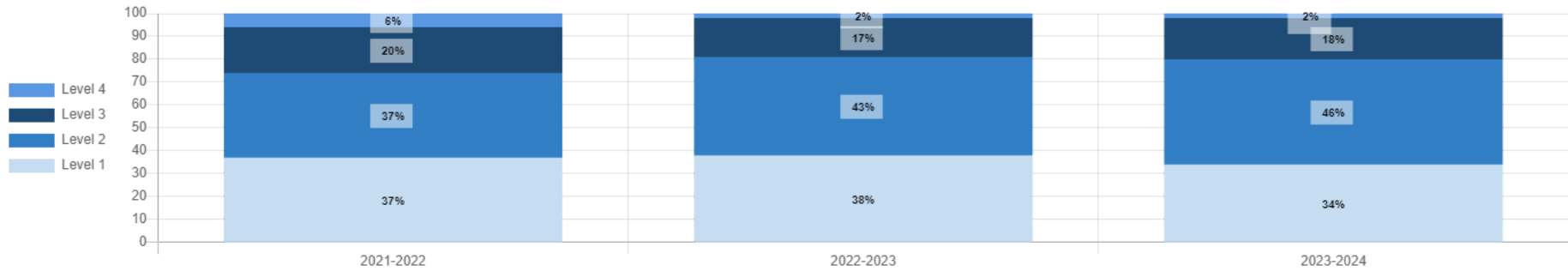

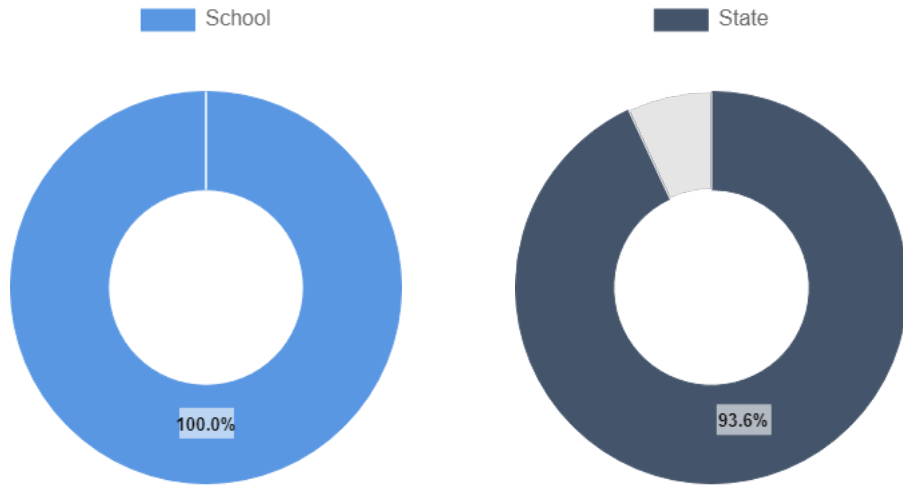

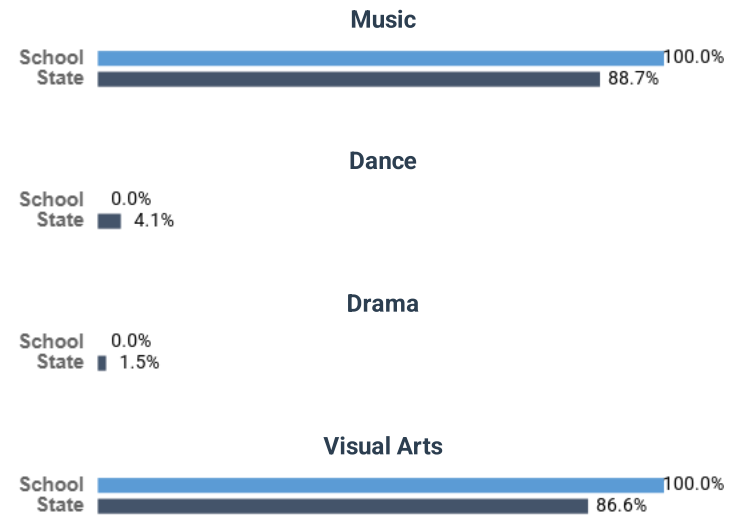

Students enrolled in one or more classes by discipline:



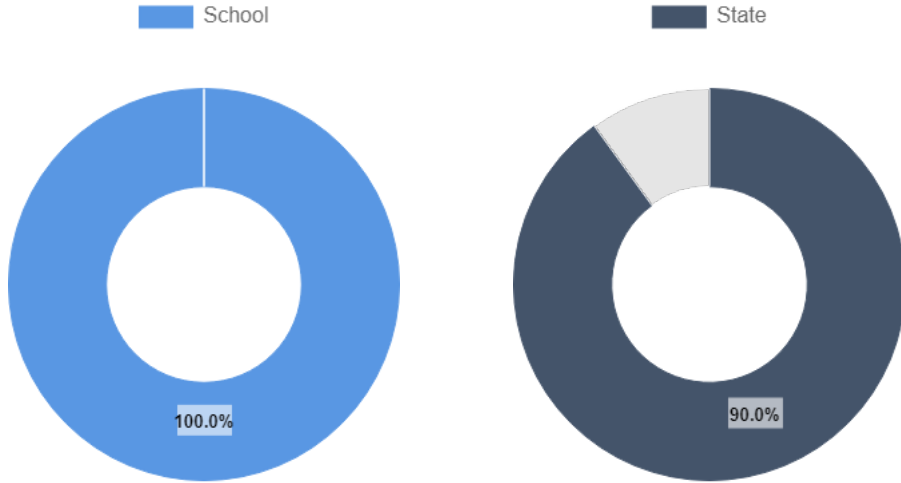

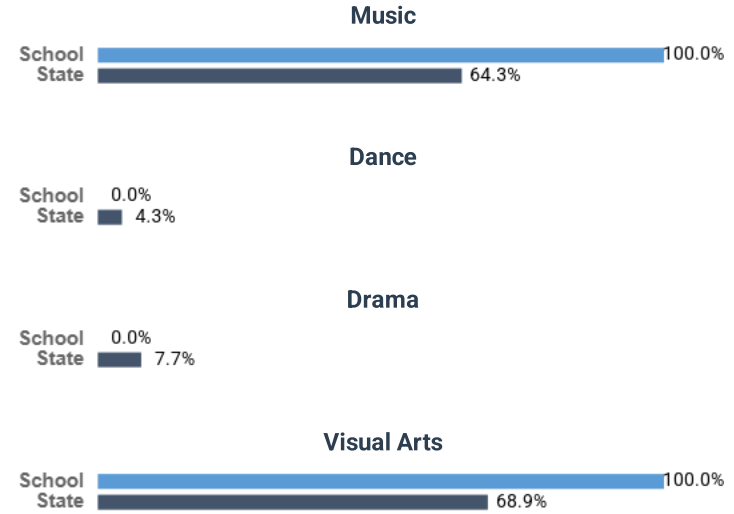

Students enrolled in one or more classes by discipline:



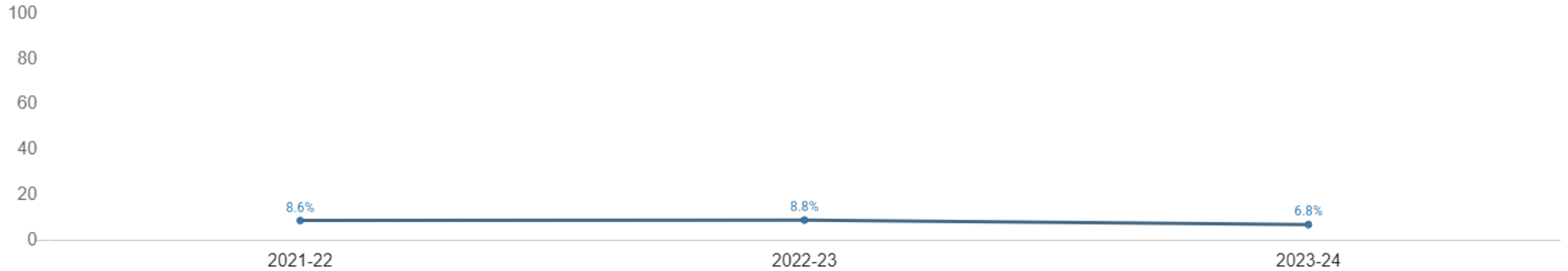

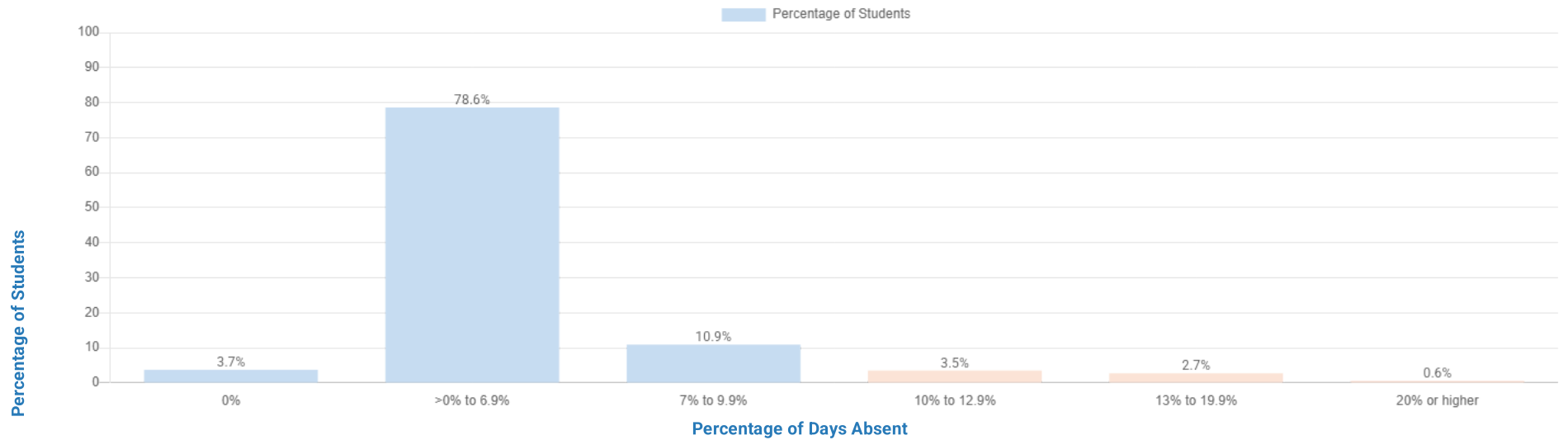

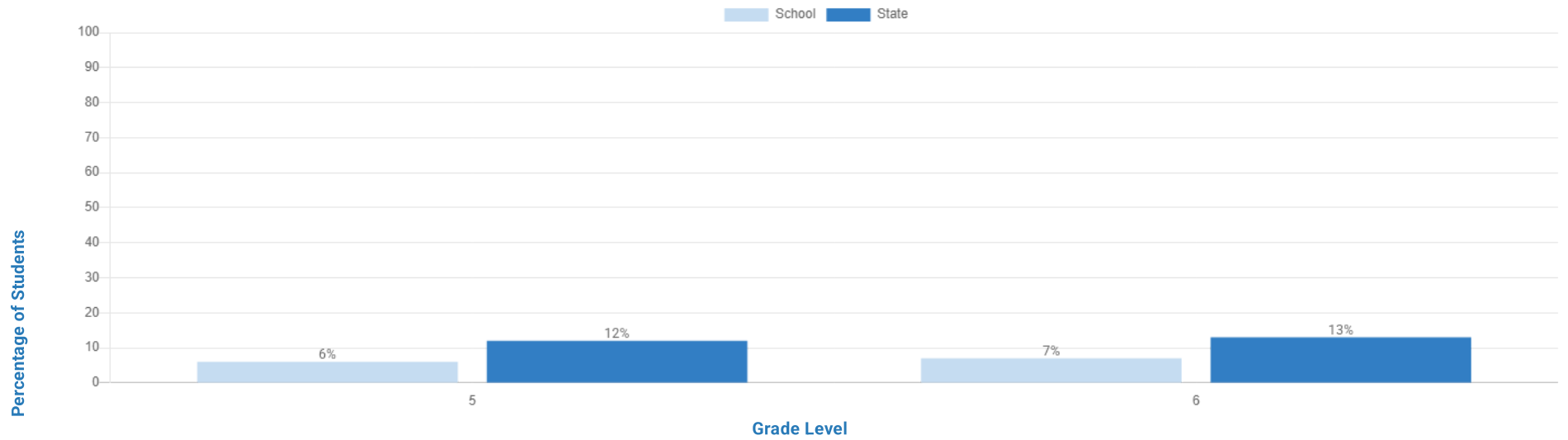

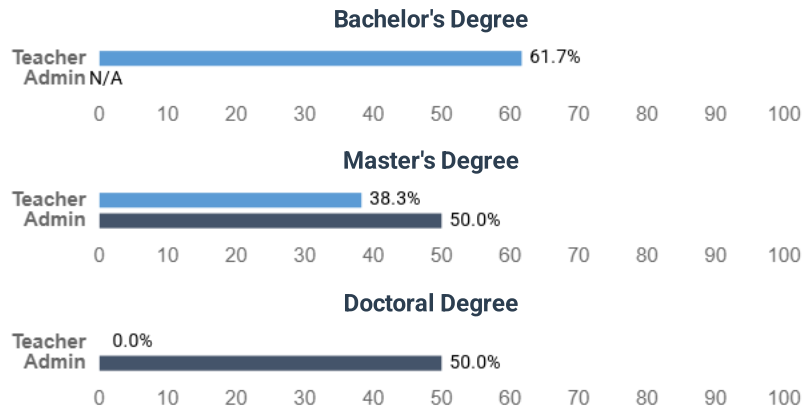

Accountability Summary by Student Group - 2023-24 School Year

Lincoln Roosevelt Elementary School is committed to providing students with a well-rounded education. Our curriculum is aligned with state standards and designed to promote 21st-century learning skills. Students engage in a variety of cycle classes that emphasize art, music, foreign language, and technology. In addition, students have the opportunity to participate in enrichment activities such as band, orchestra, and choir. Each day, students benefit from a designated time called "LAP" (Learner Assistance Period), where they can receive additional support from teachers or engage in further enrichment programs that help foster tiered level of supports of all learners.

Our school proudly offers a variety of after-school enrichment programs through the Roxbury Community School portal, including scouting, art classes, STEM, coding, skiing, snowboarding, and many other community-driven opportunities. Additionally, we are pleased to offer High-Intensity Tutoring to help students address learning gaps. These tutoring sessions are designed to provide targeted support in small groups of three or fewer students.



Staff and Professional Learning:

Subject-specific supervisors for grades K-6 play a vital role in overseeing and guiding the development of curricular programs, ensuring that they continuously evolve to meet the needs of our students. The New Jersey Student Learning Standards serve as the foundation for our curriculum, while allowing the flexibility to remain responsive to the individual needs of students and the broader community. Content area supervisors actively collaborate with staff on various initiatives to shape the direction of our curricular programs. Extensive collaboration takes place among teachers at each grade level through a learning community model, fostering interdisciplinary experiences, promoting professional growth, and stimulating meaningful discussions.



Student Supports and Services:

The Special Education Department at Lincoln Roosevelt provides a high-quality program that supports students in the least restrictive environment, with tailored programming designed to meet individual needs. The school offers a range of support services, including in-class, out-of-class, LLD (Learning and Language Disabilities), and REACH programs to address the diverse academic needs of students. Additionally, Lincoln Roosevelt provides specialized support for Multilingual Learners and utilizes an I&RS (Intervention and Referral Services) committee to assist struggling students. The school staff also includes a team of specialists in Speech and Language, English as a Second Language, Hearing Impairment, Guidance, Occupational Therapy, and Physical Therapy.

They take leadership roles in running book fairs, purchasing items for the students, coordinating student end-of-year activities, and providing assemblies for the school focused on character development.

Additionally, regular meetings of the Climate and Culture Committee are held to continuously guide the school in a way that adapts to the evolving needs of the school community.

Facilities:

Lincoln Roosevelt School's media center has been equipped with Chromebooks and iPads, providing students with a diverse range of research tools. The Roosevelt building has recently undergone substantial upgrades, including the installation of new windows, with the second phase of the renovation continuing through the 2023-2024 school year. The school has enhanced its security infrastructure with an upgraded surveillance system and the installation of keyless entry access points, ensuring the safety of both staff and students. In classrooms, new ceilings have been installed to reduce noise and improve energy efficiency. Technological upgrades were made to install modern BenQ boards to replace old equipment. A new turf athletic field was installed to benefit physical education classes and support community athletic programs. New natural gas generators are being installed to ensure that learning can continue uninterrupted during power outages.



School Safety:

Lincoln Roosevelt prioritizes the safety and security of the school community by implementing a range security measures. These include a security vestibule, surveillance cameras, and on-site security personnel. All visitors to the school are required to follow protocols: they must scan a valid ID card, have their photo taken, wear an identification lanyard, and then be escorted to their destination. LRS regularly conducts comprehensive emergency drills to familiarize both students and staff with the various safety protocols and procedures they would need to follow in the event of an emergency. Lincoln Roosevelt has established specialized teams focused on preparedness for a wide range of emergency situations. The LRS School Safety Team and the Medical Emergency Response Team meet multiple times throughout the year to review and update safety protocols. These teams work collaboratively to ensure that safety procedures are well understood for any potential emergency.



Technology and STEM:

Students have the opportunity to engage with makerspaces located in the media center, where they can explore hands-on learning experiences. To further enhance creativity and innovation, 3D printers have been provided to 6th grade science and STEM teachers, enabling students to actively design and bring their projects to life. Additionally, end-of-year projects have been developed, offering students the chance to collaborate on team-based activities that challenge them to apply cross-curricular skills to solve complex tasks. STEM classes have been redesigned to replace the traditional computer class, providing students with increased access to coding and the opportunity to build and program functional robots.

Letters are sent home to those families that are over the absence threshold for appropriate attendance. If the student continues to progress in absence after the ten-day letter is sent, our Intervention and Referral Service Committee addresses the issue in accordance with the district's attendance policy. Of course, L/R utilizes positive reinforcement in order to promote attendance for all students. We facilitate many engaging activities, such as spirit days, school events, assemblies, and rewards that encourage the students to participate. By wanting to be a part of the school day and not to miss school activities, student attendance has a greater likelihood of improving.
