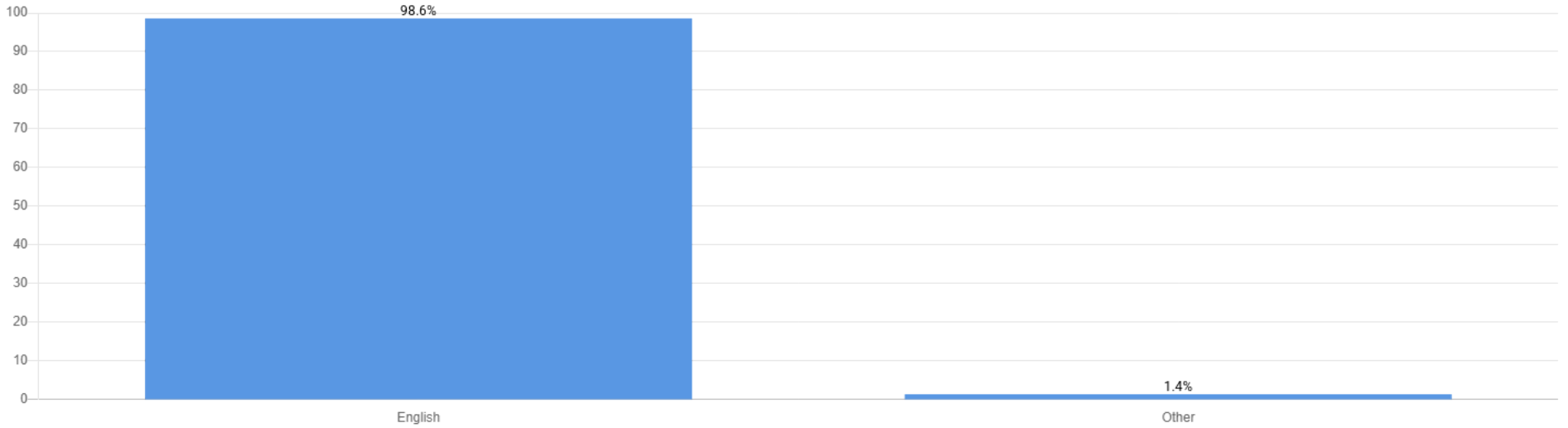

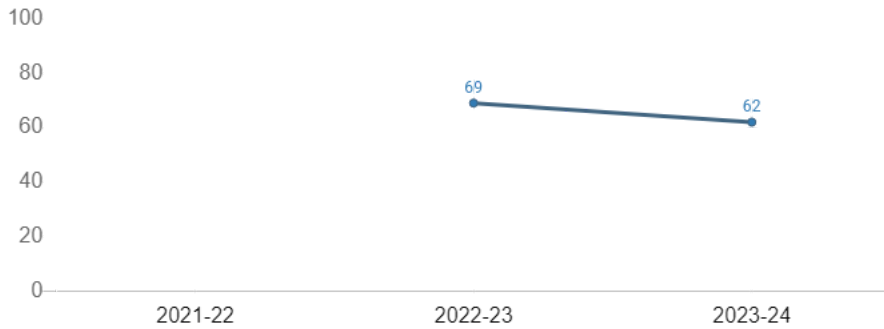

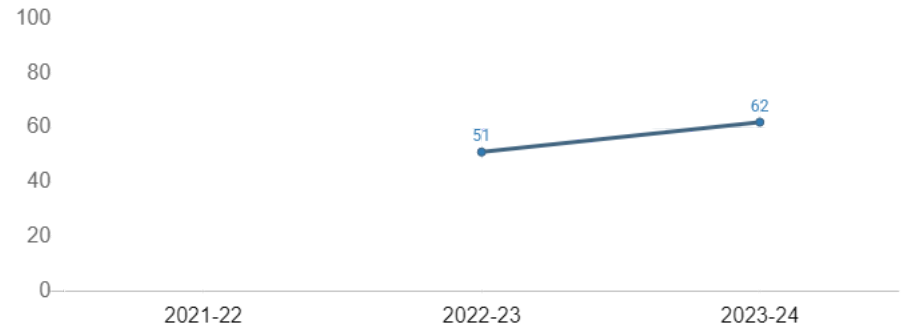

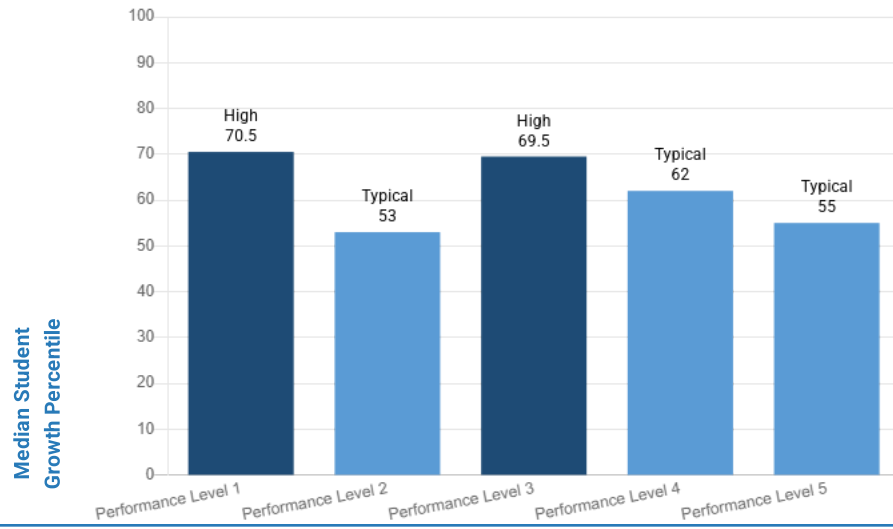

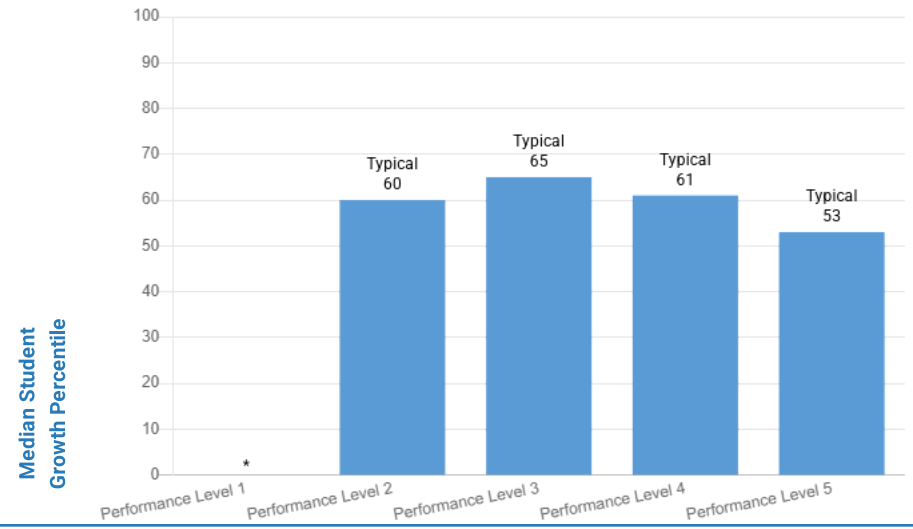

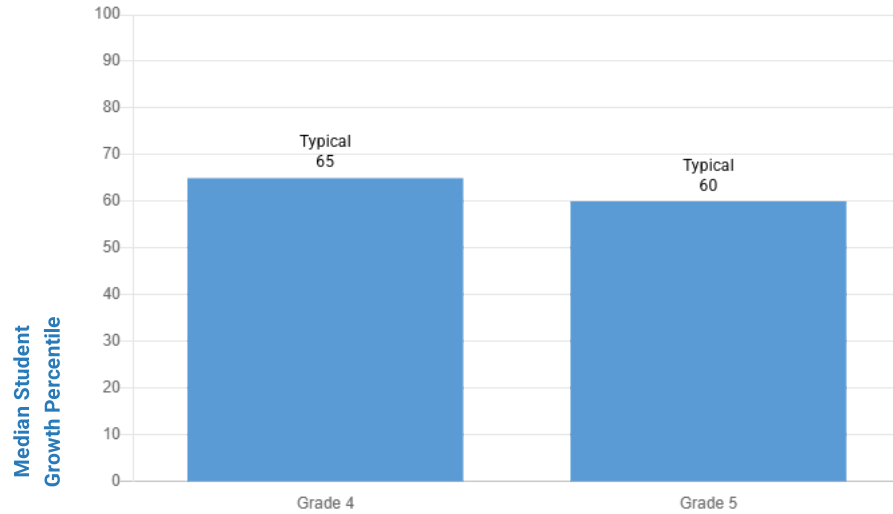

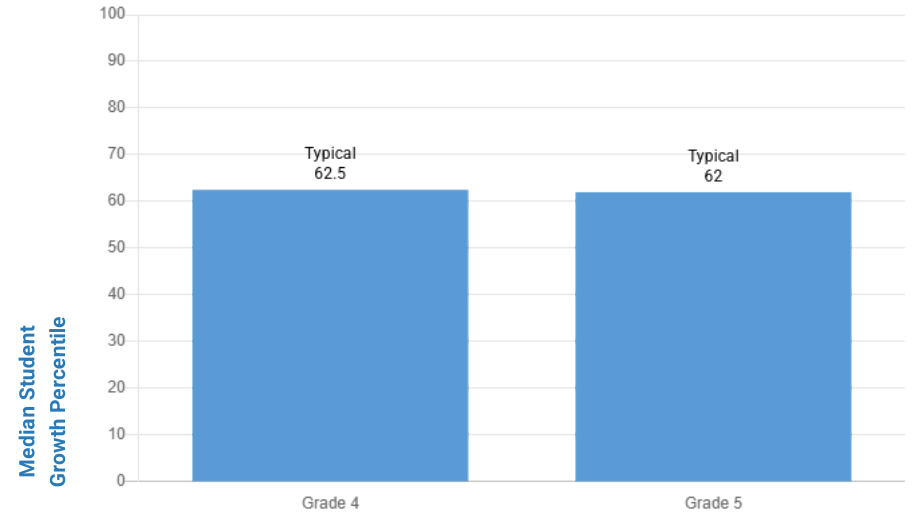

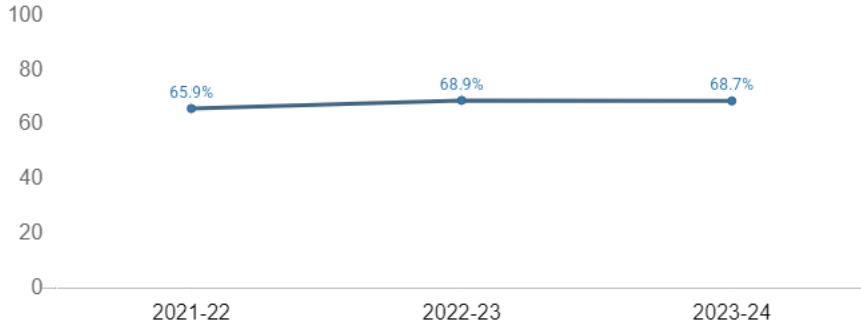

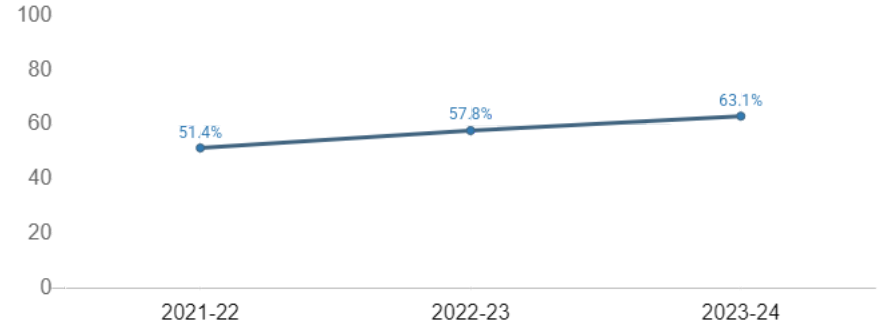
### English Language Arts and Mathematics Performance Trends

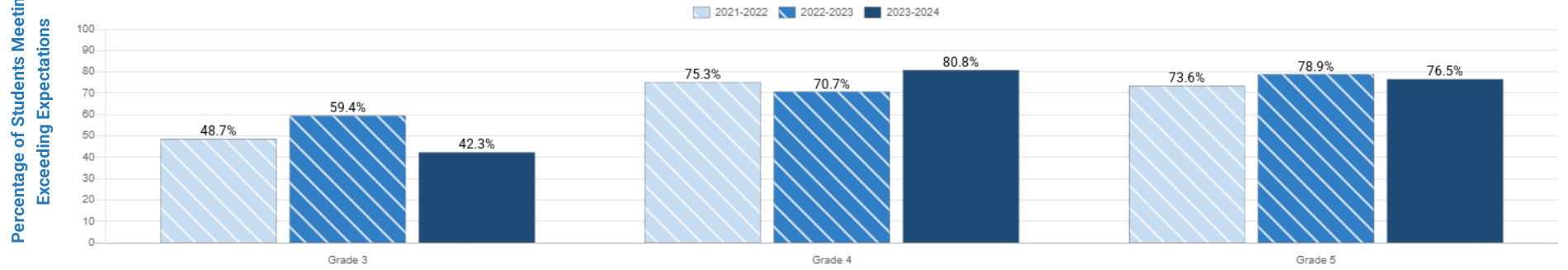

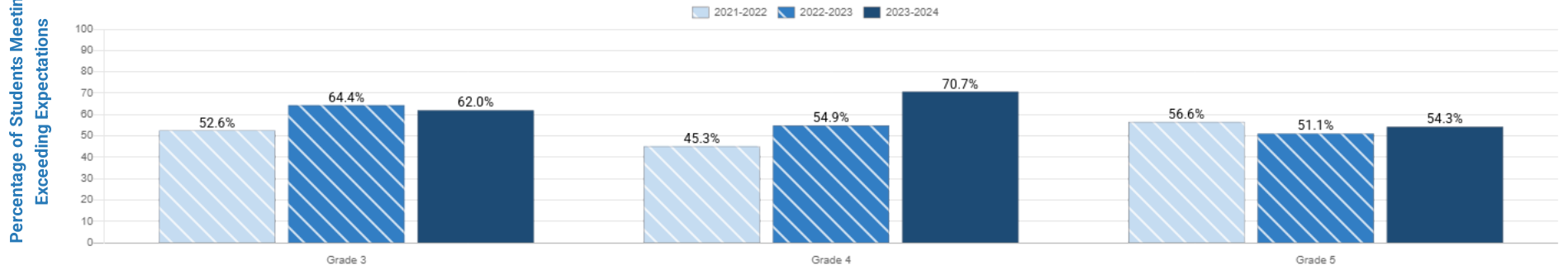

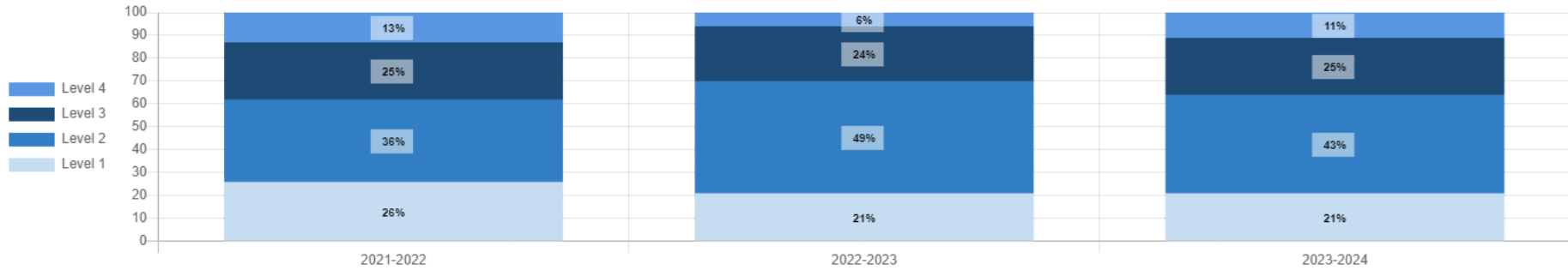

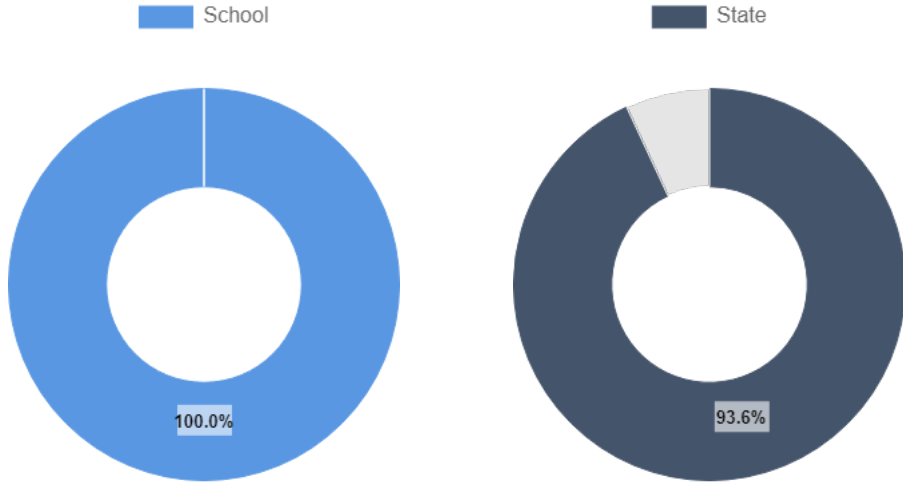

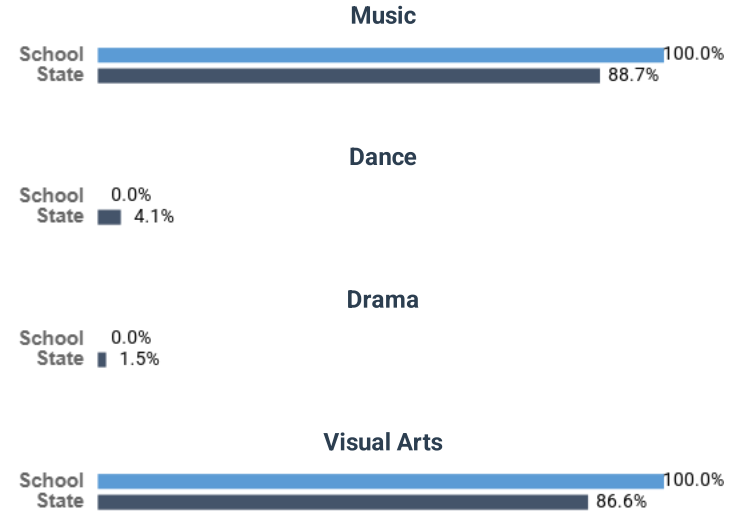

**Students enrolled in one or more classes by discipline:**



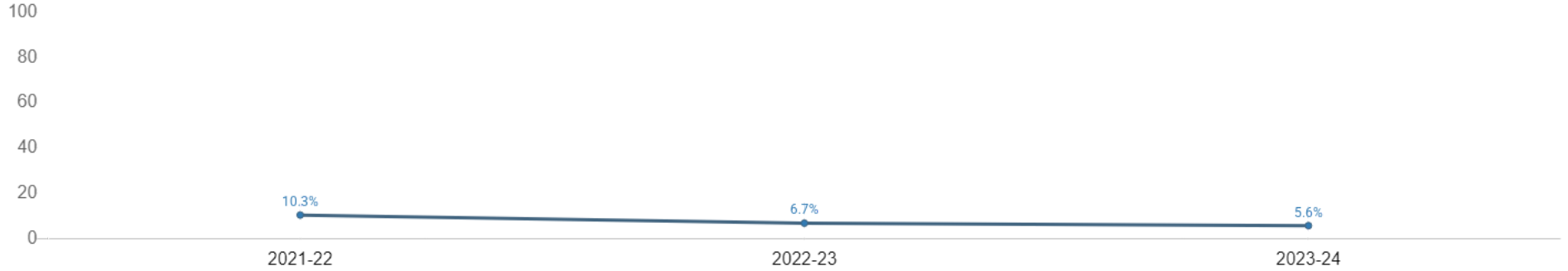
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 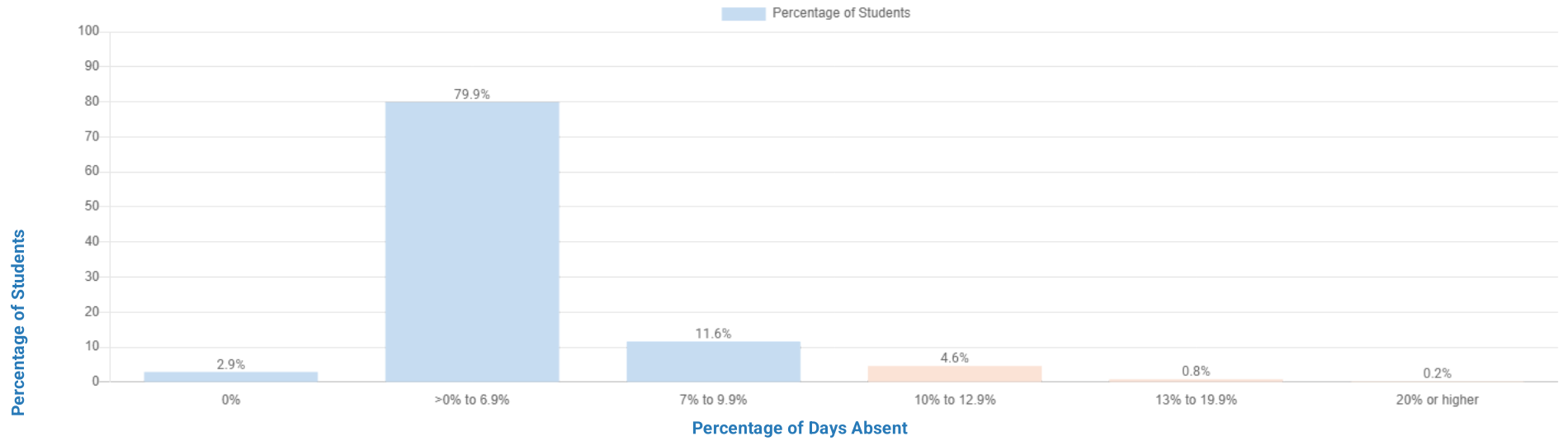

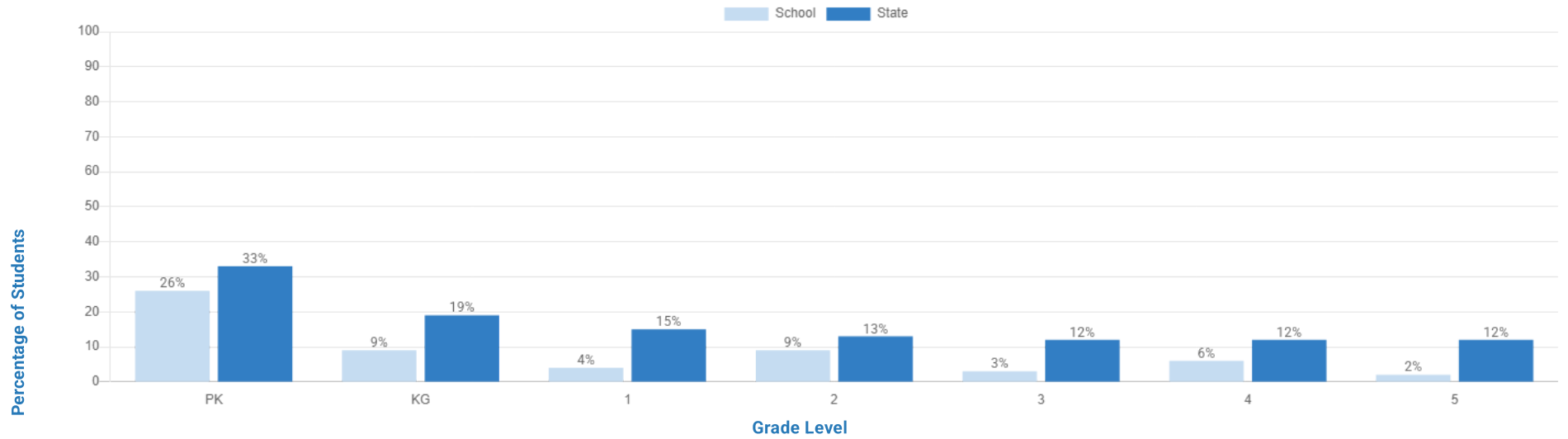

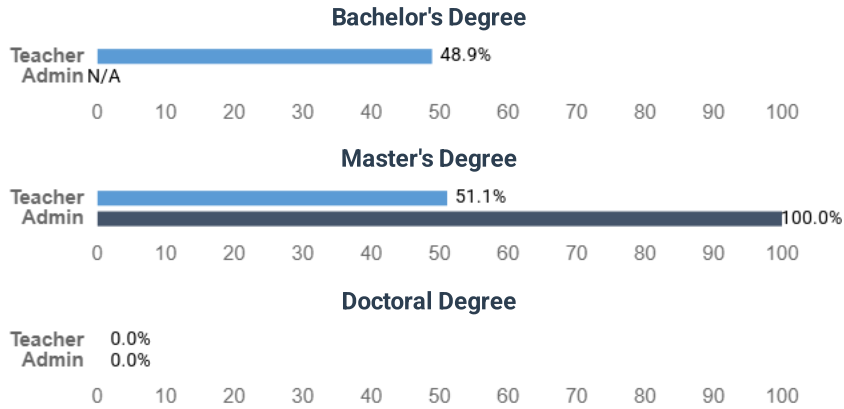

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. ### Courses, Curriculum, Instruction:

Curriculum and instruction revolves around best practices of student-centered learning experiences across the content areas. Curriculum is aligned to the NJSL Balanced literacy and the workshop model is our approach to literacy instruction, using best practices of formative assessment to plan for differentiation. We provide daily discovery experiences to construct learning.



### Before and After School Programs:

The Musconetcong Valley Community Association provides after school child care for our families. After school activities classes are provided by the non-profit Long Valley Junior Women's Club C.A.R.E. program. The C.A.R.E program offers after school enrichment classes to all surrounding area elementary school-aged children at low tuition rates for courses such as piano, dance, yoga, cooking, sports skills, karate, S.T.E.M and more.



### Staff and Professional Learning:

Job-embedded professional learning occurs throughout the school year provided by our district literacy and STEM coaches through the use of Lab Classrooms, who also provide support during PLCs and team meetings. Professional Learning Communities are educator-driven based on the identification of student learning needs informed by current data. Four district-wide professional development days include presenters from the district, universities, and professional organizations, as well as faculty-led learning sessions. We are also in our first year of working with the New Jersey Council for Inclusive education to make FKS a more inclusive environment for all.

### Student Supports and Services:

A dedicated Child Study Team provides evaluation for and coordination of Special Education and related services. Co-taught mainstream classrooms are an option along the special services spectrum from grades K-5. MLL services are available to students who qualify. A school counselor trained in child development, learning strategies, self-management, and social skills supports students through this important period in a child's life. A multi-disciplinary, general education process for implementing targeted interventions and Section 504 accommodations by need are available. Our nurses also play an integral role in the support of student emotional and physical wellness.



### Student Health and Wellness:

Students receive explicit instruction in the fall and spring in mindfulness and self-regulation from a local psychologist and child therapist. School activities and events are designed to promote healthy habits of nutrition and wellness throughout the school year. Physical Education and Health classes emphasize lifetime fitness and wellness encouraging healthy brains and bodies, cooperative games of skill, sportsmanship, and good decision making. Our school-wide approach to character education, The Four Paws of the Wolf, promotes a culture in which all students are welcomed, valued, and feel connected to their school.



### Parent and Community Involvement:

Our active and generous PTA provides educational and social opportunities for students and their families that supplement our curriculum through grade-level and school-wide assemblies, author visits, and numerous evening events. Parents are welcomed in the school by participating as Mystery Readers, classroom volunteers, chaperoning field trips, and assisting with grade level events. Our school and district communicate primarily with a multifaceted, digital system of community-wide announcements for events and notices. The use of Google Classroom by many teachers and teacher websites are effective means of communication with classroom communities and provide online resources to support their child's learning at home.

### Facilities:

Our facilities are operated and maintained with children and staff at the heart of our focus. Our dedicated custodians of the Kossmann (1979) and Flocktown (1968) buildings ensure a safe, inviting, and well-kept environment that support children in their learning and growth. All staff take responsibility for reporting maintenance needs and identifying potential safety issues.



### School Safety:

The safety of our children, faculty/staff, and the security of our school buildings are our highest priorities. Several security features installed and procedures implemented in recent years include: interior and exterior cameras and PA systems; locked and monitored main entrance vestibules; impact resistant glass film on all windows and doors; school-wide lockdown notification system; visitor sign-in and identification system; required picture ID of all faculty and staff; a consistently enforced Student Code of Conduct; implementation of Restorative Justice practices; Gaggle monitoring software of student digital content; universal emergency response procedures; CPR, AED, and Epi-Pen trained staff; Columbia threat assessment protocol; and a dedicated School Resource Officer.



### Technology and STEM:

Our STEM education program coaches students to develop the problem solving, creative, and analytical thinking needed to become a productive global citizen of tomorrow. Through the use of the Engineering Design Process (EDP), students are taught to systematically work through problems while utilizing current technologies and the Science and Engineering Practices (SEPs). STEAM projects provide ample opportunity for the purposeful teaching of the SEP's and the EDP, as well as, integrate curricula content from multiple disciplines and current global issues. Grades 3-5 have three impressively equipped maker-space carts and, thanks to a generous PTA grant, students have access to two 3-D printers.
