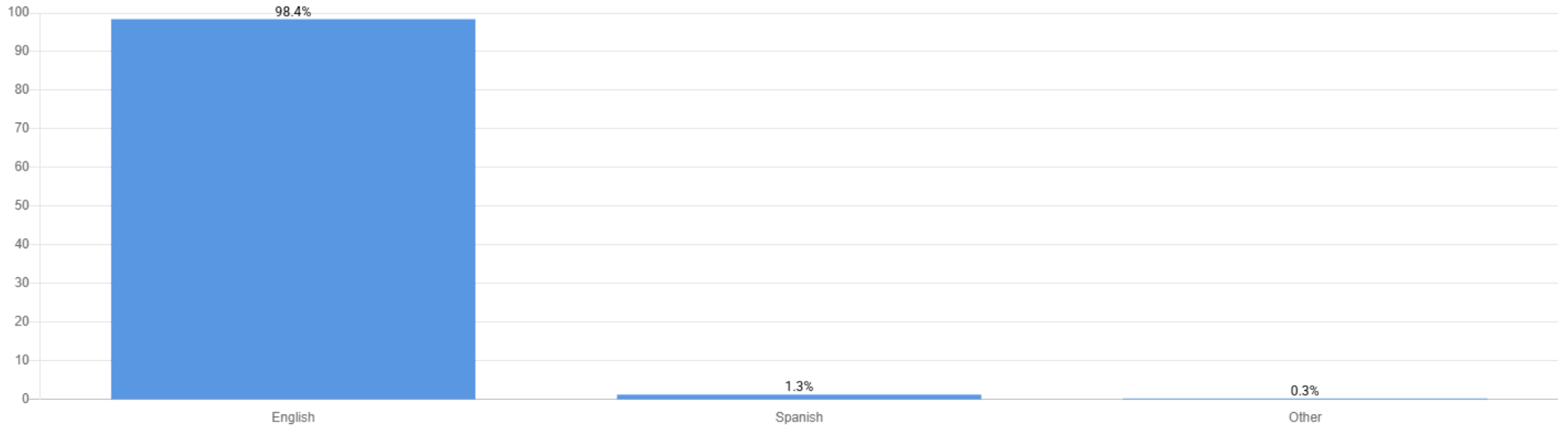

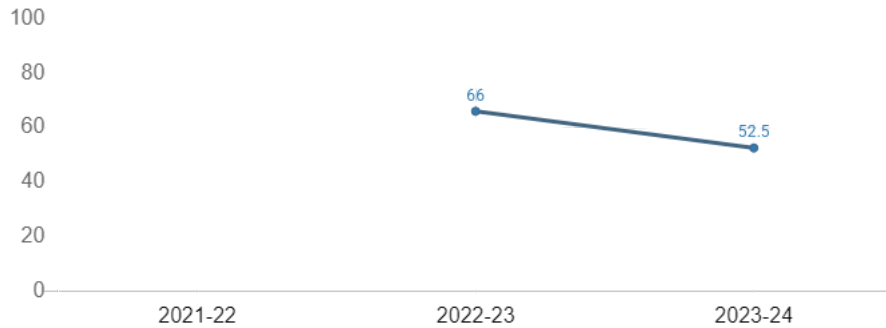

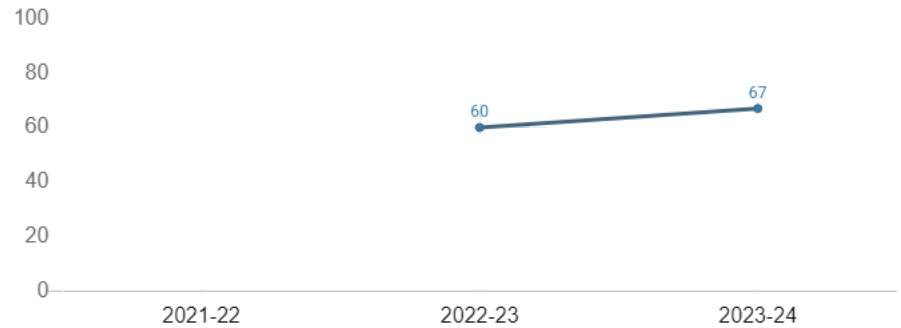

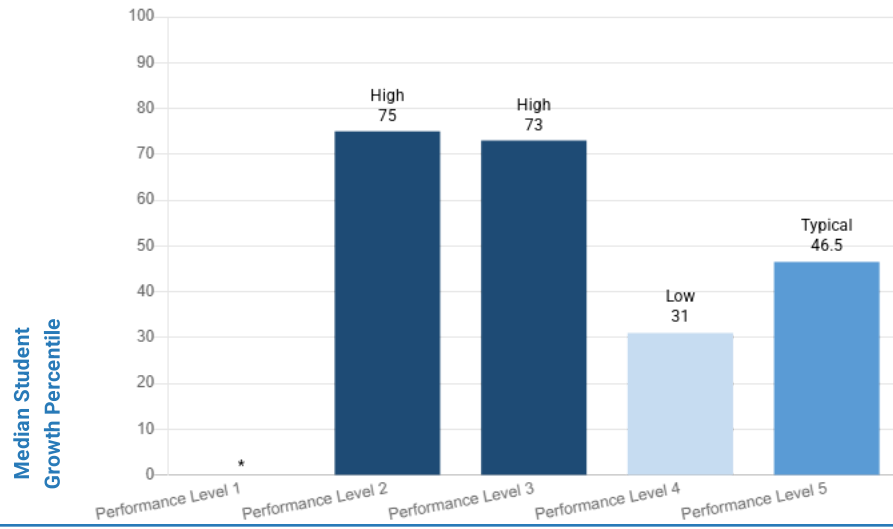

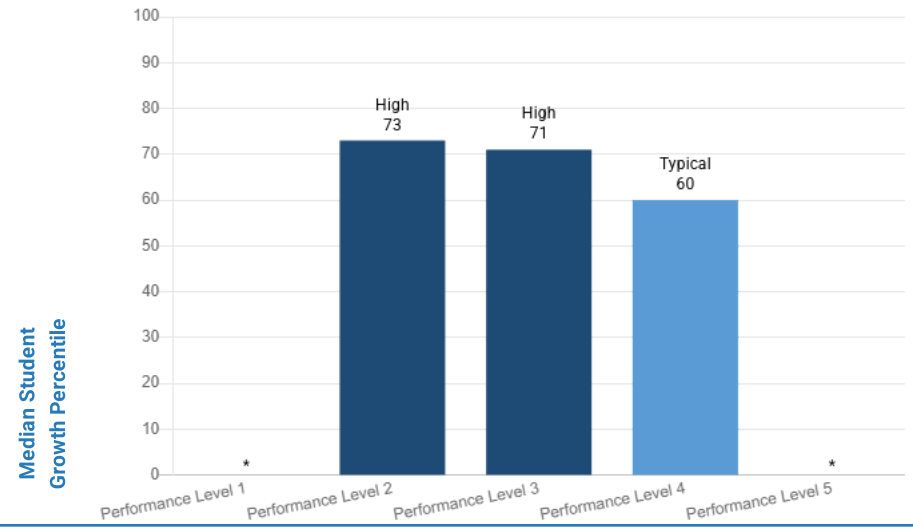

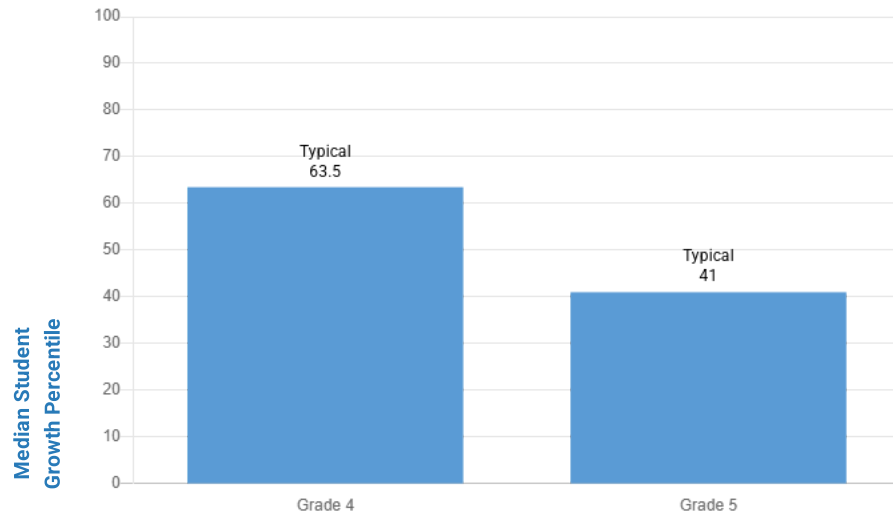

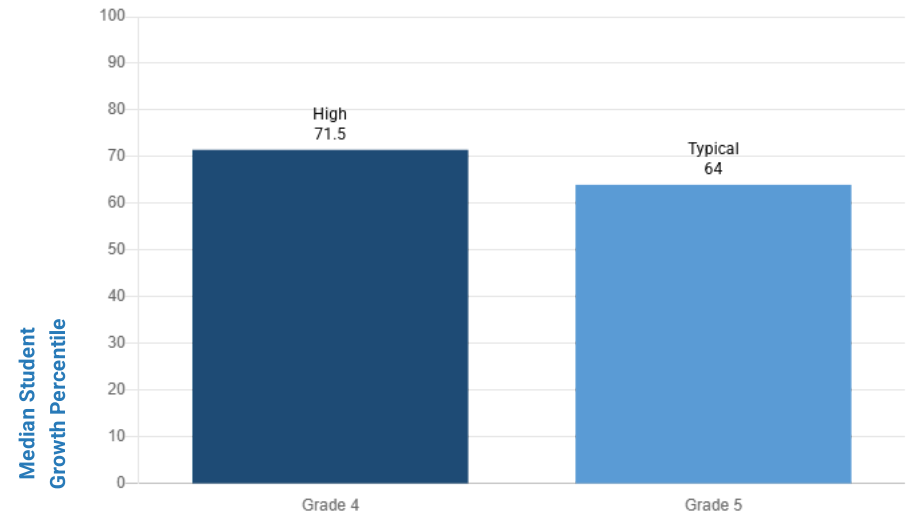

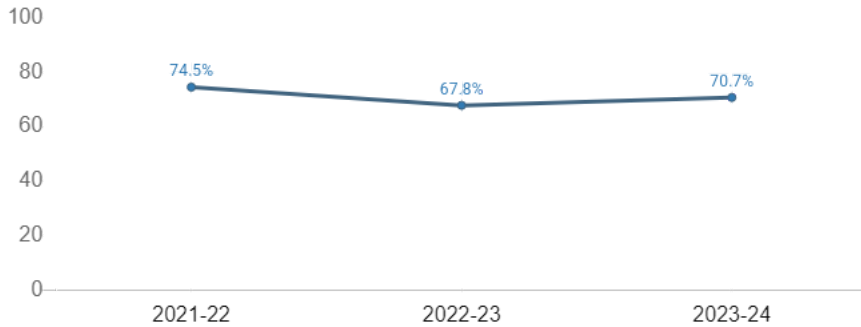

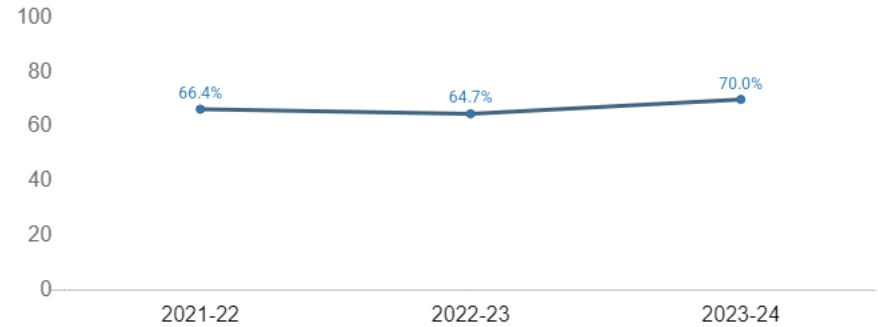
### English Language Arts and Mathematics Performance Trends

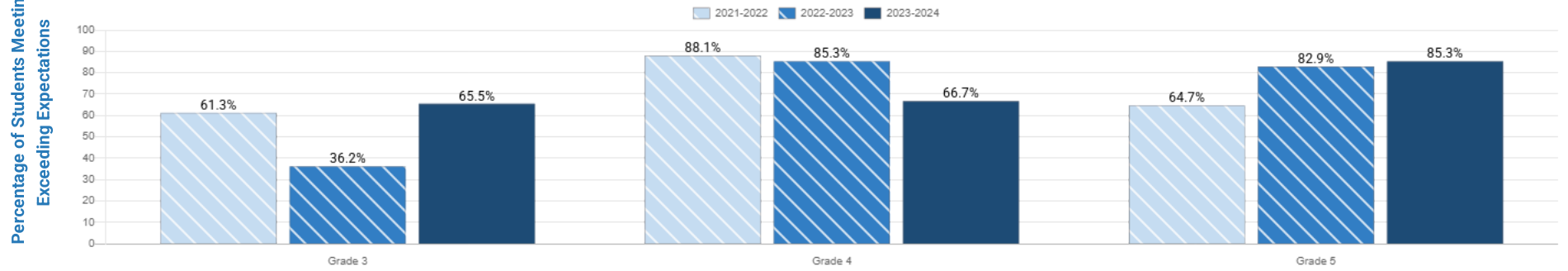

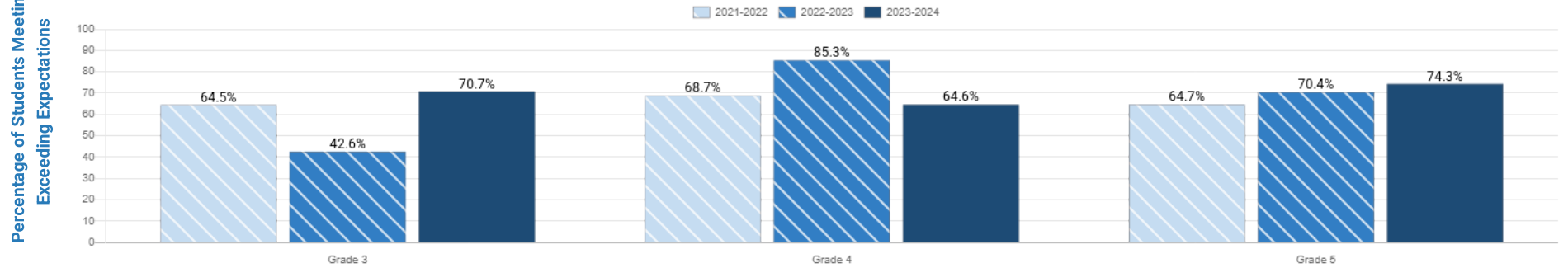

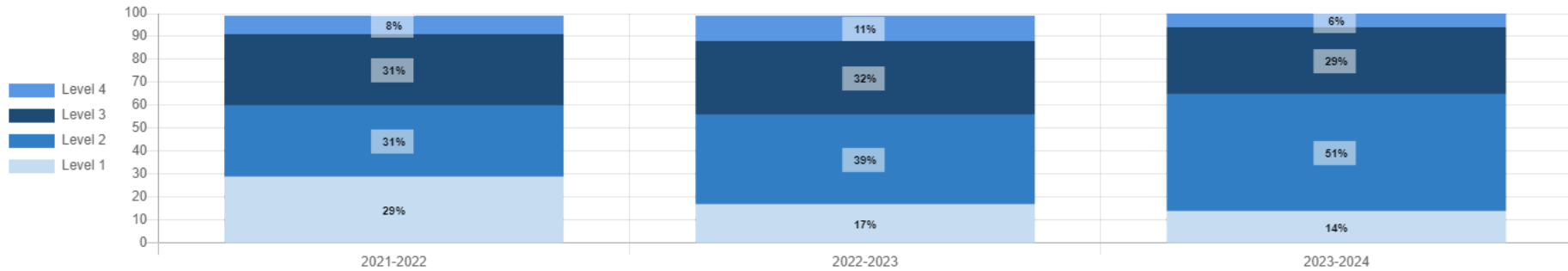

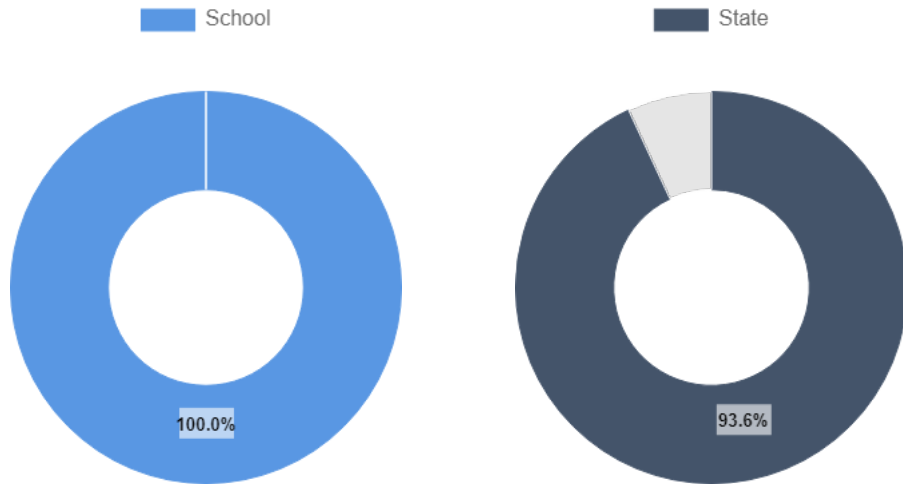

**Students enrolled in one or more classes by discipline:**



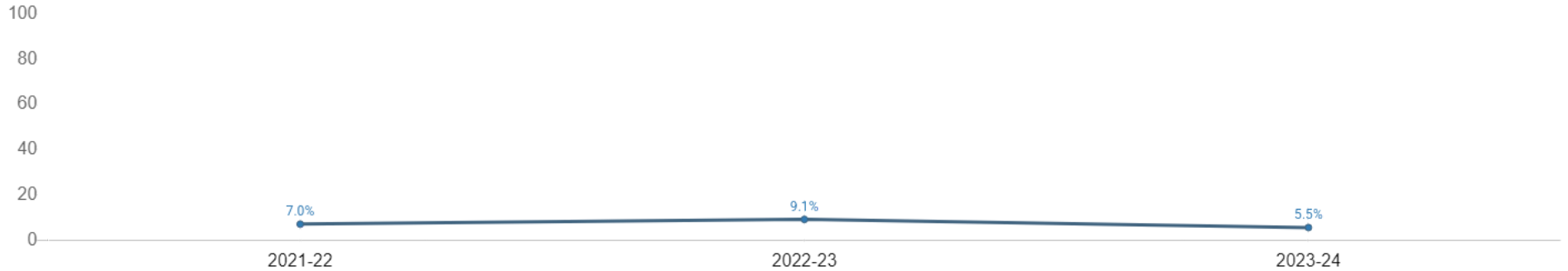

Students with fewer than 45 days in membership are excluded from attendance calculations.

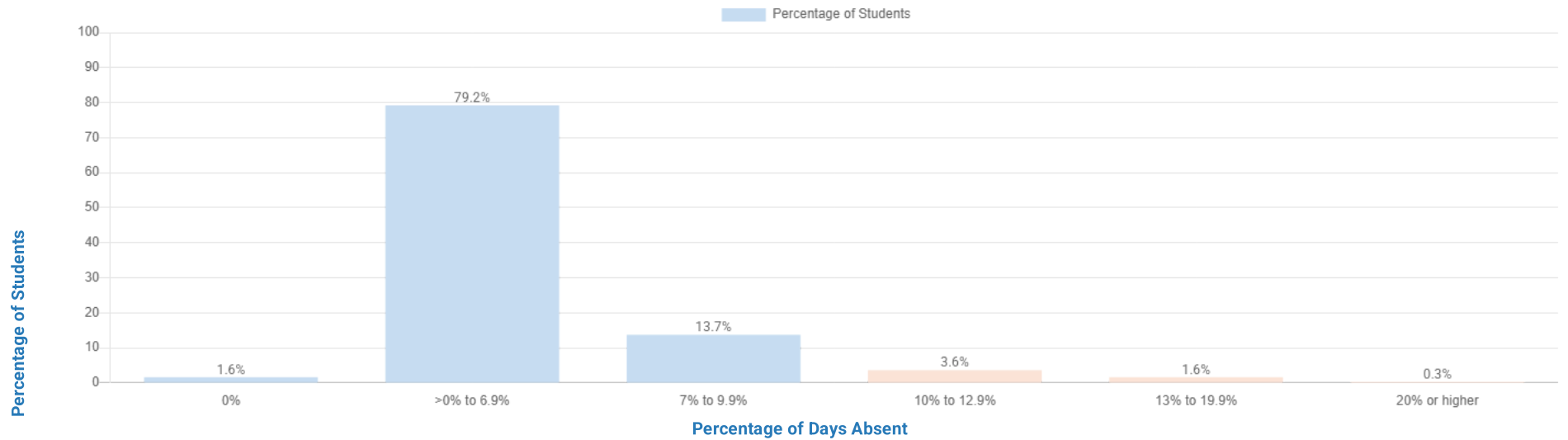

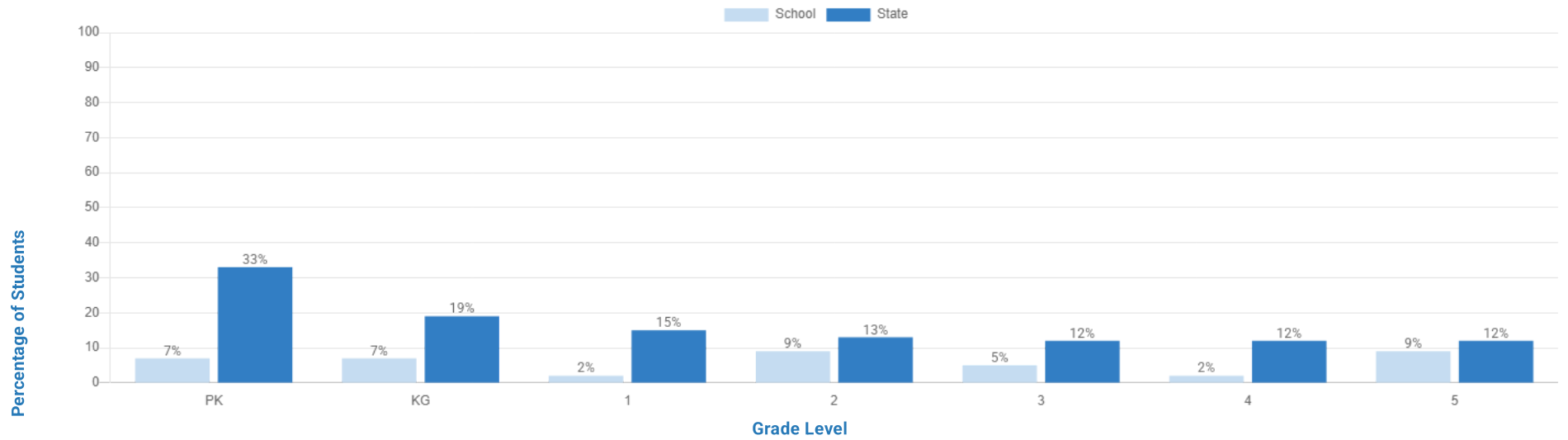

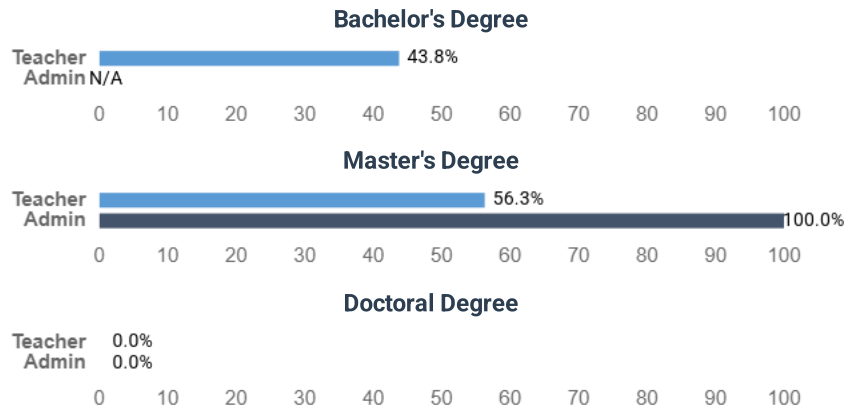

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Curriculum and instruction revolves around best practices for student centered learning experiences. Curriculum is aligned to standards and is revised on a regular basis. Instructional practices are supported by professional development opportunities within and outside of the district. Staff members continue their education through online, hybrid, and traditional methods and are supported by curriculum coaches.



### Before and After School Programs:

The Musconetcong Valley Community Association provides after school child care for our families. After school activities classes are provided by the non-profit Long Valley Junior Women's Club C.A.R.E. program. The C.A.R.E program offers after school enrichment classes to all surrounding area elementary school-aged children at low tuition rates for courses such as piano, dance, yoga, cooking, sports skills, karate, S.T.E.M and more.

Old Farmers Road School maintains a dedicated Child Study Team as well a Social Worker to provide comprehensive support for our learners including Intervention & Referral Service Programs, ADA 504 Planning, and Special Education and Related Service delivery. Professionals meet regularly to discuss student progress and collaborate to intervene as needed. A Multi-Tiered System of Supports framework is in place to provide tiered interventions based on level of student needs. We have a team of coaches and interventionists to support student and teachers through this framework.



### Student Health and Wellness:

District policies are designed to promote attention to nutrition and wellness throughout the school day. Our District Food Service provider is cognizant of student needs and national expectations. Physical Education and Health classes make connections between diet, physical fitness, and emotional wellness. Our nurse spearheads many proactive health measures throughout the school year for students and staff, such as Wellness Week.

OFRS regularly hosts Veterans and community volunteer programs. Our facilities are operated and maintained with children and staff at the heart of our focus. All school buildings are designed and maintained to provide a safe and welcoming environment to help children achieve their maximum potential. Following all state laws and proactively implementing our own high standards, our district utilizes a full building ownership approach with all staff being involved and encouraged to share ideas, report maintenance needs, and identify potential safety issues.



### School Safety:

The safety of our children, faculty/staff, and the security of our school buildings are our highest priorities. Several security features installed and procedures implemented in recent years include: interior and exterior cameras and PA systems; locked and monitored main entrance vestibules; impact resistant glass film on all windows and doors; school-wide lockdown notification system; visitor sign-in and identification system; required picture ID of all faculty and staff; a consistently enforced Student Code of Conduct; implementation of Responsive Classroom practices; Gaggle monitoring software of student digital content; universal emergency response procedures and Standard Response Protocol; CPR, AED, Epi-Pen, and glucagon trained staff; Columbia threat assessment protocol; a dedicated School Resource Officer. The district has partnered with Priority of Life Training and Consulting LLC to plan comprehensive Reunification Plans.



### Technology and STEM:

Our STEM education program coaches students to develop the problem solving, creative, and analytical thinking needed to become a productive global citizen of tomorrow. Through the use of the Engineering Design Process (EDP), students are taught to systematically work through problems while utilizing current technologies and the Science and Engineering Practices (SEPs). STEM projects provide ample opportunity for the purposeful teaching of the SEPs and the EDP, as well as, integrate curricula content from multiple disciplines and current global issues. Grades 3-5 have three impressively equipped maker-space carts to enhance instruction. Our G+T Teachers push in to all grade levels to enrich students with engaging and developmentally appropriate coding lessons. Plans for a new STEM LAB to further enhance our program are underway.

Our child-centered, K through 5th grade school is one of three outstanding elementary schools in Washington Township - Long Valley. Our commitment is to educate the whole child, taking care to meet his/her academic, social, emotional, and wellness needs. We provide our students with a life-long love of learning and a challenging educational program that develops skills and knowledge necessary to lead successful, meaningful lives. In order to accomplish these goals, our highly qualified educators employ a variety of strategies and techniques: hands-on activities, learning centers, workshop formats, cooperative learning, small group, and direct instruction to meet the individual needs of learners. We provide a balanced literacy program that integrates reading, writing, speaking, listening, and viewing across the curriculum. Reading A to Z supplemented with Fountas and Pinnell, Orton-Gillingham, Good Habits Great Readers and Empowering Writers programs anchor literacy instruction. The Eureka 2 Math program serves as the primary resource for our mathematics instruction. Additional components of our core curriculum include FOSS Science, Social Studies, Health, and a full complement of Related Arts. Students special needs are met by a group of highly qualified teachers who promote an inclusive learning environment. A Gifted and Talented program is also offered. Parent involvement is a fundamental component of our school. The Old Farmers Road PTO provides substantial support for both classroom teachers and special programs and projects that could not otherwise be achieved.
