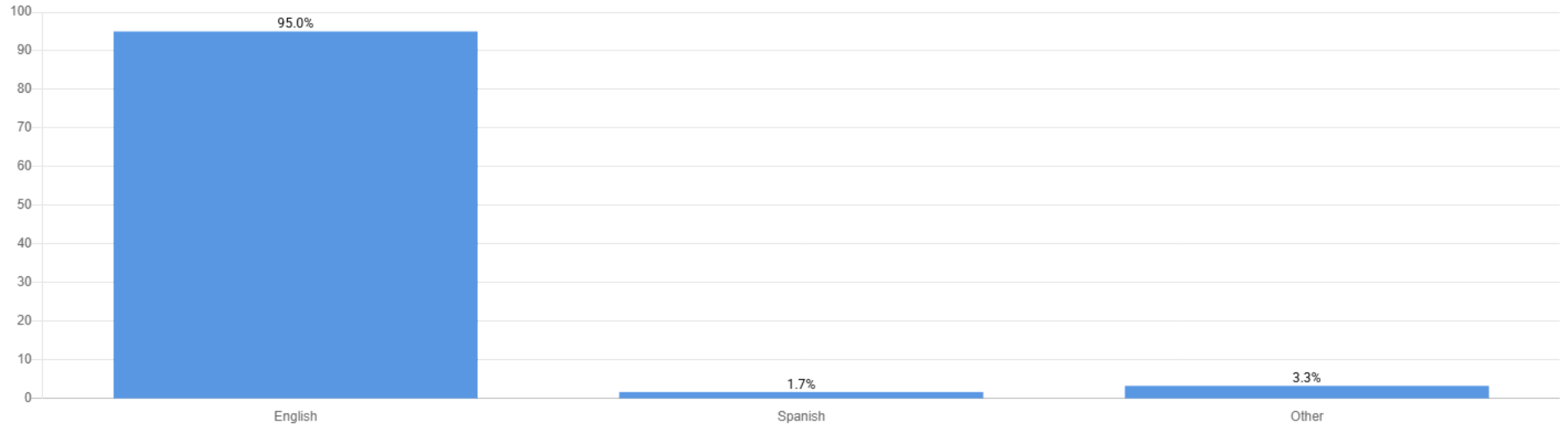

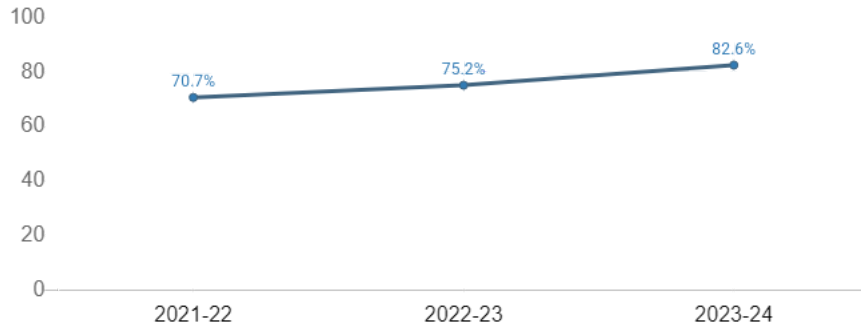

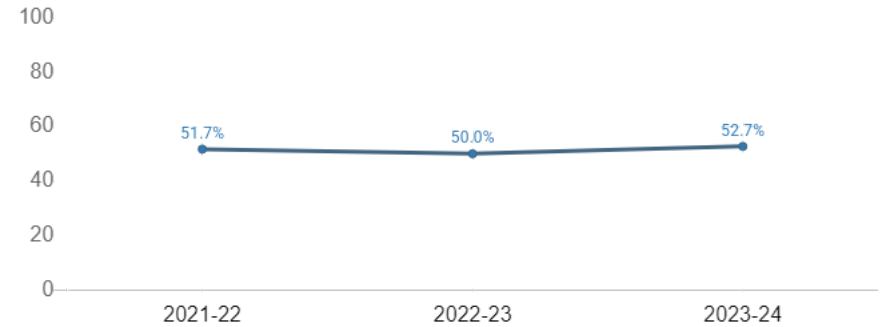
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 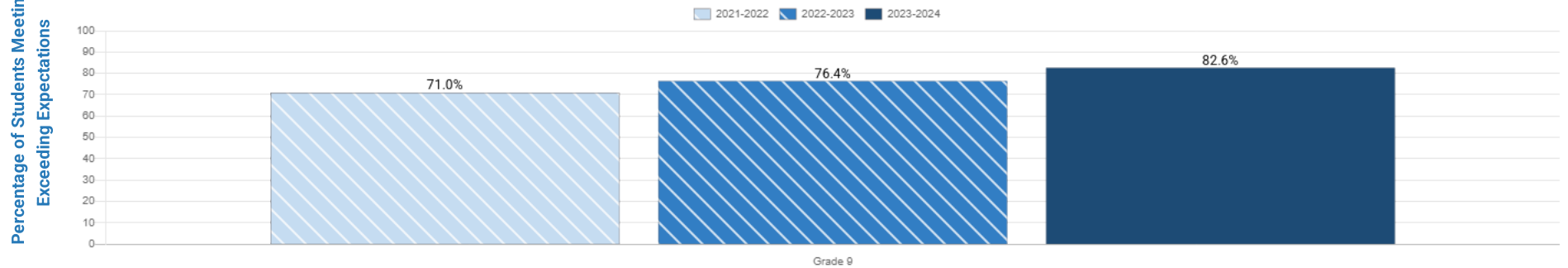

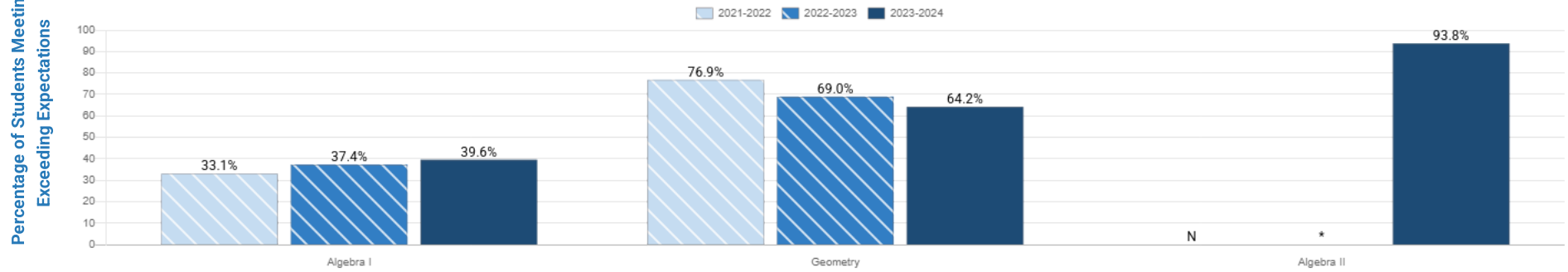

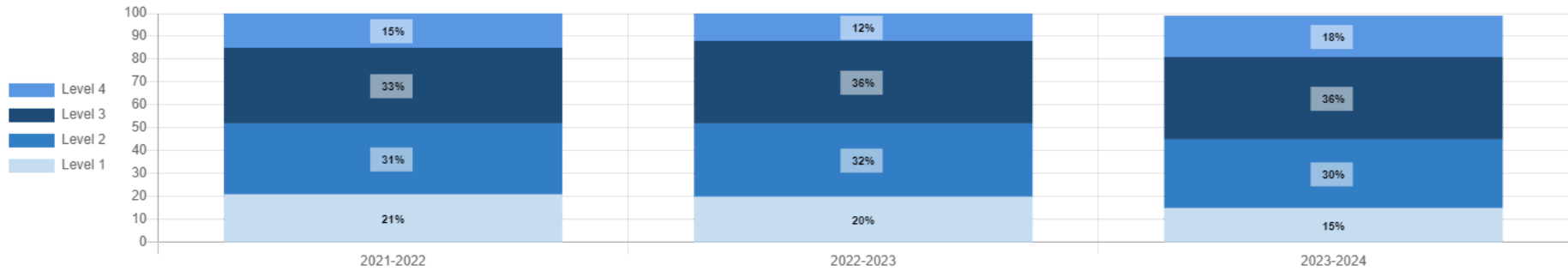

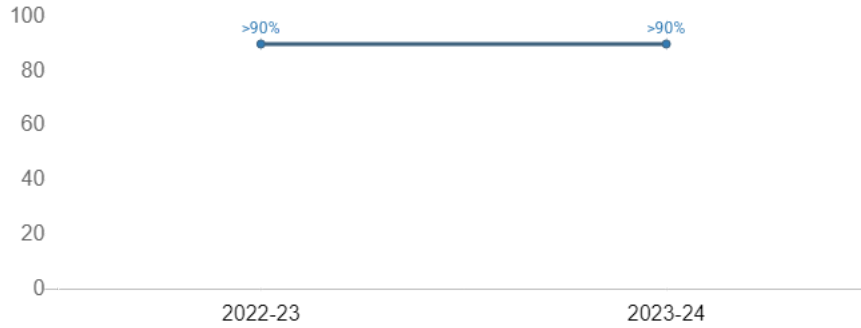

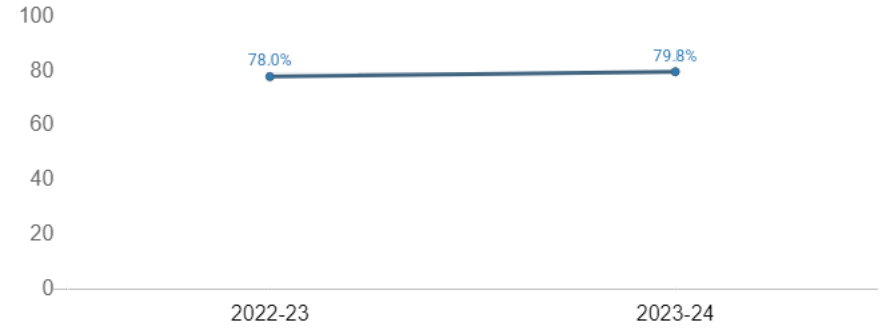

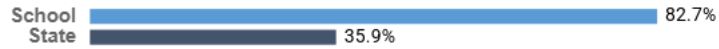

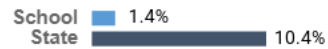

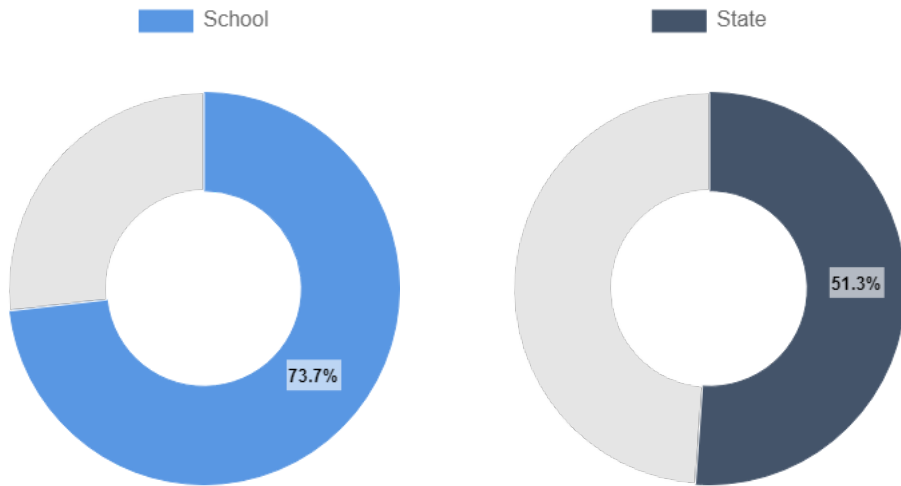

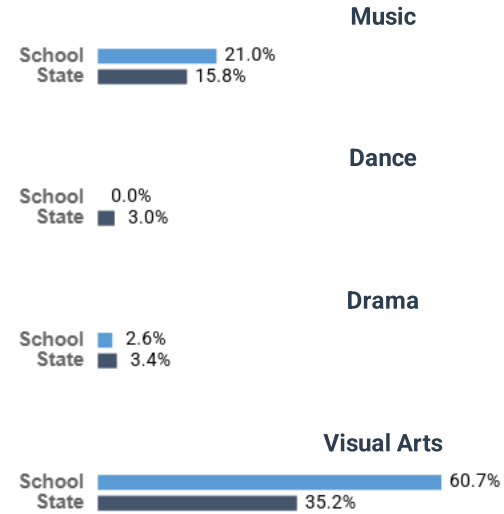

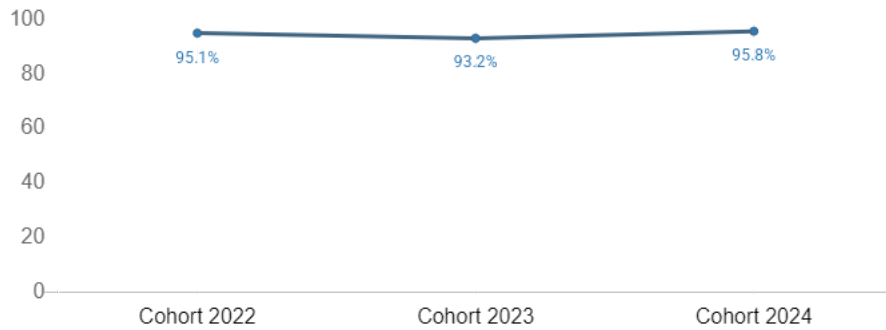

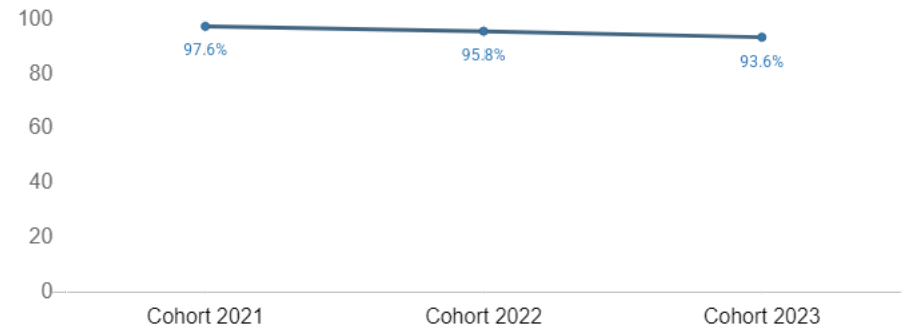

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

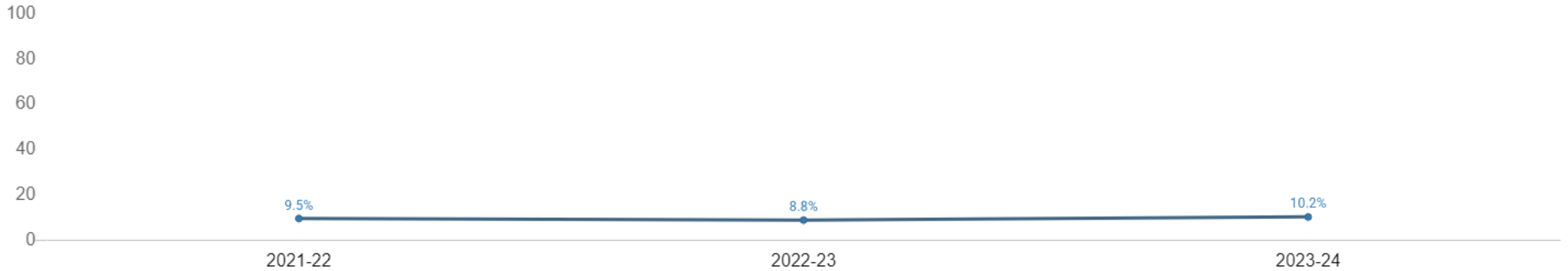

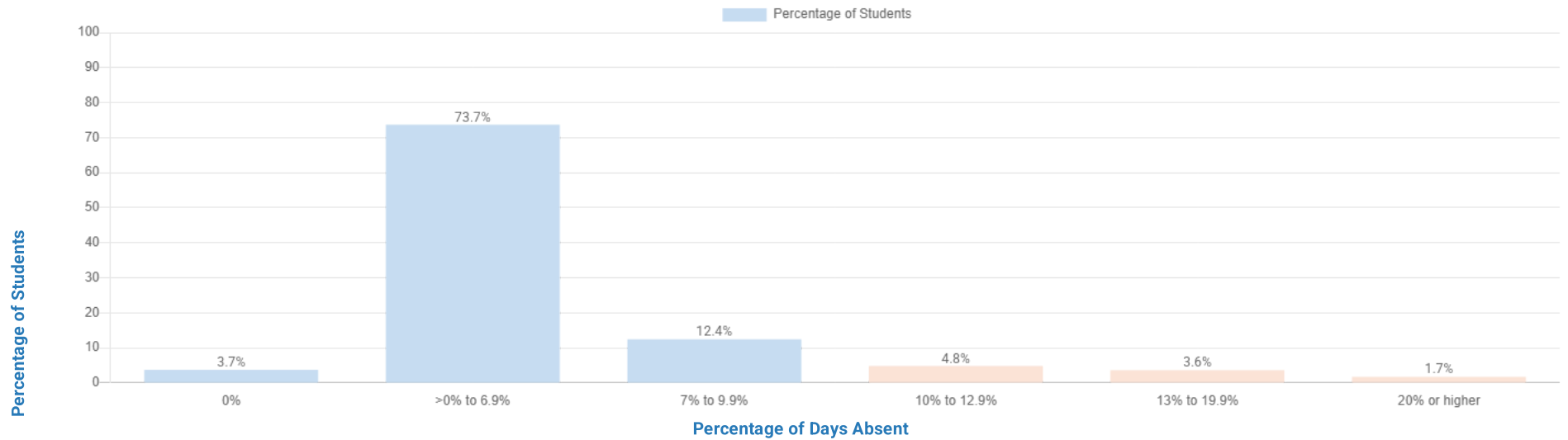

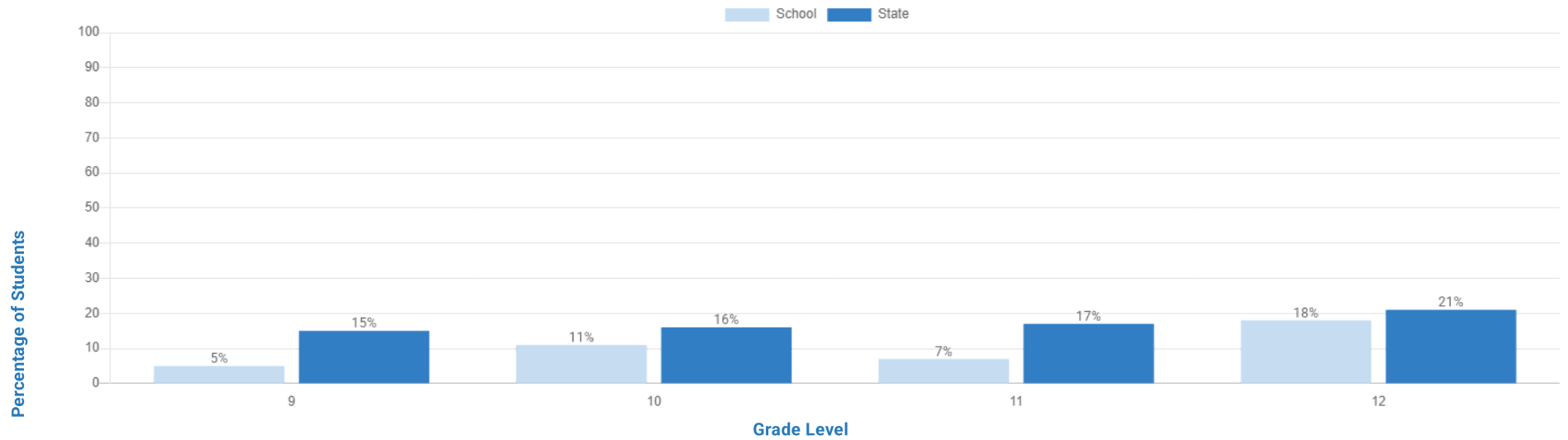

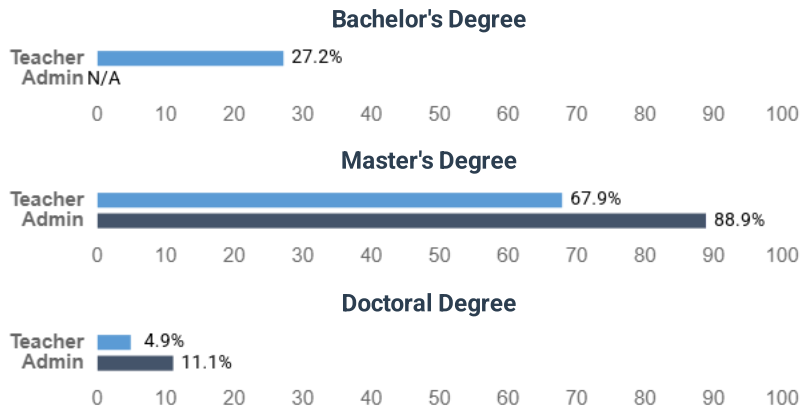

The International Baccalaureate's Approaches to Teaching and Learning guides instruction.

Students have been academically recognized as 4 Commended Scholars, and 35 AP Scholars, 23 with Honors, 17 with Distinction for a total of 75 Advanced Placement Scholars. WMC teachers have been awarded grants from companies such as BASF.

Courses, Curriculum, Instruction:

West Morris Central HS offers a comprehensive four-year program in all college preparatory subjects and a wide range of fine and performing arts, STEM, and academic elective courses. Instructional levels include: Advanced Placement and International Baccalaureate, Honors, Advanced, and Academic. Each year over 50 AP, IB, and dual enrollment courses are offered to students. Along with our sister school, WMC was the first high school in New Jersey authorized to offer both the IB Diploma Programme (DP) and the IB Career Programme (CP). It has the longest running public IB DP and CP Programmes and the highest number of IB program graduates in New Jersey. 120 credits of coursework are required for graduation.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Coed), Cross Country (Boys & Girls), Fencing (Boys & Girls), Field Hockey (Girls), Football (Coed), Golf (Boys & Girls), Ice Hockey (Coed), Lacrosse (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Boys & Girls), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls), Track and Field - Winter (Boys & Girls), Volleyball (Girls), Wrestling (Coed)

The WMC Wolfpack enjoys a proud tradition of achievement in scholastic athletics across 27 female and male programs, routinely competing for conference, county and state titles. Over a dozen students from a graduating class typically participate in NCAA-sanctioned athletic competition after competing at WMC. Most recently, a women's golf team has been established with a dedicated coach where, historically, a single coach was assigned to the coed team. A thriving Unified Sports program, partnering with the Special Olympics of NJ, offers all students the opportunity to compete in soccer, basketball, and track & field in an inclusive and supportive environment. The Unified Soccer program and coaches have recently received national attention by being named the official Unified Soccer team of the NY Red Bulls professional soccer organization. WMC is a member of the NJAC governed by the NJSIAA. A certified trainer is on staff to further support athletes and coaches both on & off the field.



Clubs and Activities:

WMC provides supervision and advice to over 80 student groups, clubs and organizations. The Highlanders for Humanity club coordinates most student-driven community service while our annual Relay for Life event is a joint project organized and executed in collaboration with our sister school. Last year, WMR Relay for Life students and advisors participated in the Relay for Life National Convention in Las Vegas, NV, while their fundraising efforts placed them in the top 10 nationally. Most recently, the WMR District Robotics Teams have prospered by competing in the national championships in Dallas, TX. The Diversity Council, first launched in 2016 to increase sensitivity and empathy, has transformed into a growing Diversity Club. Student publications showcase robust membership as our Technology Club continues to expand its competitive accomplishments into new areas.

Before and After School Programs:

The West Morris Regional High School District operates summer workshops for incoming freshmen to assist with the transition to high school as well as for rising seniors wanting to get a jump-start on the college essay writing and application process. Most recently, targeted math instruction during the summer months has provided additional support for students in need. An extended school year program is available annually to students who qualify.



Staff and Professional Learning:

The WMRHSD assigns ample resources to professional learning. District in-service is modeled after Ed-camp style, staff-directed learning where educators choose from a menu of workshops offered by colleagues. Topics include the integration of technology, formative assessment, and other pedagogical matters. Teacher Trainers provide hands-on and accessible technology support to staff in need. Staff are trained annually on best practices for integrating Chromebooks into teaching and learning. All staff have been trained on IB Approaches to Teaching and Learning and incorporate the instructional methodology into their daily practice. WMC hosts annual roundtable discussions with regional IB World Schools and sends numerous staff members to national IB-sponsored workshops. State training requirements are met via video instruction for teachers, coaches, and support staff.



Postsecondary Information:

77% of graduates from the Class of 2024 attend 4-year college/university and 15% attend 2-year colleges, and 8% entered the workforce or enrolled in a vocational institution. College placement is supported by six school counselors and a district director. Four college fairs are held annually showcasing over 150 postsecondary options for students. The school counseling department at WMC, a nationally Recognized ASCA Model Program, hosts annual grade-level presentations for all students on the post-secondary process. The Naviance software suite assists students with their research, planning and application process and also provides a number of test prep tools. WMRHSD fully subsidizes the administration of the PSAT to juniors. An annual awards ceremony in June honors students for both their scholarship and achievement.

Student Supports and Services:

WMC, a nationally recognized ASCA Model Program (RAMP) school, provides a variety of support services to students by delivering a data-informed school counseling program in an exemplary educational environment. English language learners benefit from targeted ESL instruction. The CST is composed of two social workers, two school psychologists, and an LDTC. The I&RS Team functions as a complement to our 504 Committee. A full-time Student Assistance Counselor and shared-time District Wellness Counselor provide additional support and programming to both students and staff. WMC offers behavioral support and a work-based structured learning experience program for students with IEPs. An Academic Center provides students who are faced with academic challenges with a focused setting for remediation. The Math Resource Center, a drop-in support space for students, is staffed by a building-based math teacher throughout the school day.



Student Health and Wellness:

An ongoing district wellness initiative has resulted in coordinated homework-free weekends, strategically placed delayed openings for students, an earlier start to the school year in order to frontload instruction prior to standardized testing, and in the design of a Zen Zone where students engage in yoga and mindfulness. A full-time Student Assistance Counselor along with Wellness Counselor, both housed on-site, are available for additional support. A Student Wellness and Suicide Prevention Committee provides all stakeholders an opportunity to develop action plans for concerns. The Diversity Council first launched in 2016 to increase sensitivity and empathy has transformed into a growing Diversity Club. Physical Education features a robust fitness and mindfulness component.



Parent and Community Involvement:

Valuing its relationships with parents and community, two WMC representatives sit on the community's Municipal Alliance to promote the wellness of our young people. Project Graduation exists to create a safe post-celebration event for graduates. The PTO provides meals of recognition for students and staff. They, with approximately 40 other community groups, present scholarships in an annual celebratory event. Athletic, music & IB programs enjoy the support of parent groups. Parents are active members of school-based committees including the selection panel for teacher recognition. Visits by local professionals fuels career exploration.

Facilities:

WMC is a wireless facility featuring an 800 seat state-of-the art auditorium and three dedicated music rooms, a 700 seat gymnasium and secondary auxiliary gym, a field house with locker rooms, trainer's room, wrestling room, and well-equipped science, technology, fine and practical arts labs. A recently-updated weight room in the fieldhouse provides year-round access to enhanced fitness equipment for staff and students. An all-purpose synthetic turf field with an updated LED lighting system allows for year-round access by all athletic teams, clubs and activities. A challenge course with a variety of climbing elements is integral to Physical Education classes.



School Safety:

Keeping students safe is the top priority at WMC. A full-time school resource officer and safety and security monitor assist the administration in organizing drills, improving protocols, and coordinating procedures in collaboration with our sister school. After-hours security provides twelve hours of daily on-campus coverage. The WMC School Safety Team is charged with developing, fostering, and maintaining a positive school climate. An expanding network of surveillance cameras gives school personnel and local police the ability to monitor student activity in common areas across campus both indoors and outdoors. Dynamic software monitors online student activity on all district-issued devices. An updated intercom system provides enhanced audio as well as visual components for improved communication purposes. Staff and students at WMC are trained regularly to ensure the school community is unified in our approach to school safety.



Technology and STEM:

The personalized learning initiative at WMC via Chromebooks has been phased in for all students with teachers actively sharing teaching and learning resources utilizing the PowerSchool Learning platform. Canvas serves as the learning management system for staff and students. G-Suite (formerly Google Apps) for Education provides staff and students the capability to communicate and collaborate effectively in a digital space. Teachers utilize various online teaching and learning resources in every classroom setting. Increased bandwidth and access point upgrades enable wireless coverage across campus and projectors in all classrooms provide for video-conferencing capabilities. All classrooms are outfitted with large-screen 55" monitors. WMC offers several STEM clubs/activities including the Technology Student Association, Science League, Science Olympiad, and participated in the Panasonic Design Challenge and the Hour of Code.

Regular attendance at school is an indicator of responsible student behavior. Prolonged or repeated absences from school or from class deprive the student of the classroom activities deemed essential to learning and may result in failure to meet academic requirements and loss of credit toward the high school diploma. Building administrators collaborate with school counselors to monitor and manage student attendance captured on PowerSchool, the district-based SIS, as reported by staff each period of the school day. As individual attendance concerns arise, intervention strategies are implemented consistently across grade levels. These strategies are believed to positively impact regular student attendance and include the convening of the building-based Attendance Review Committee. This team of educators investigates student attendance profiles and collaborates with the CST, school nurses, and school physicians as individual cases warrant to develop realistic action plans for students.

Other Information:

West Morris Central operates the modified rotating block schedule. While students maintain 8-class course loads, just six meet each day for alternating 55- and 65-minute blocks. Science labs are embedded within the 65-minute instructional blocks and allow all students and staff to experience the unit lunch. Teachers maintain Canvas pages to leverage interactive digital learning. Families are able to monitor student performance through the PowerSchool gradebook portal. Most forms, informational, procedural, and curricular resources are available through the school website. Thrillshare is utilized to instantly disseminate information to students and their families through email, text, and phone. West Morris Central continues to implement a personalized learning initiative, allowing all students to be equipped with a touch-screen Chromebook to further enhance their educational experience.
