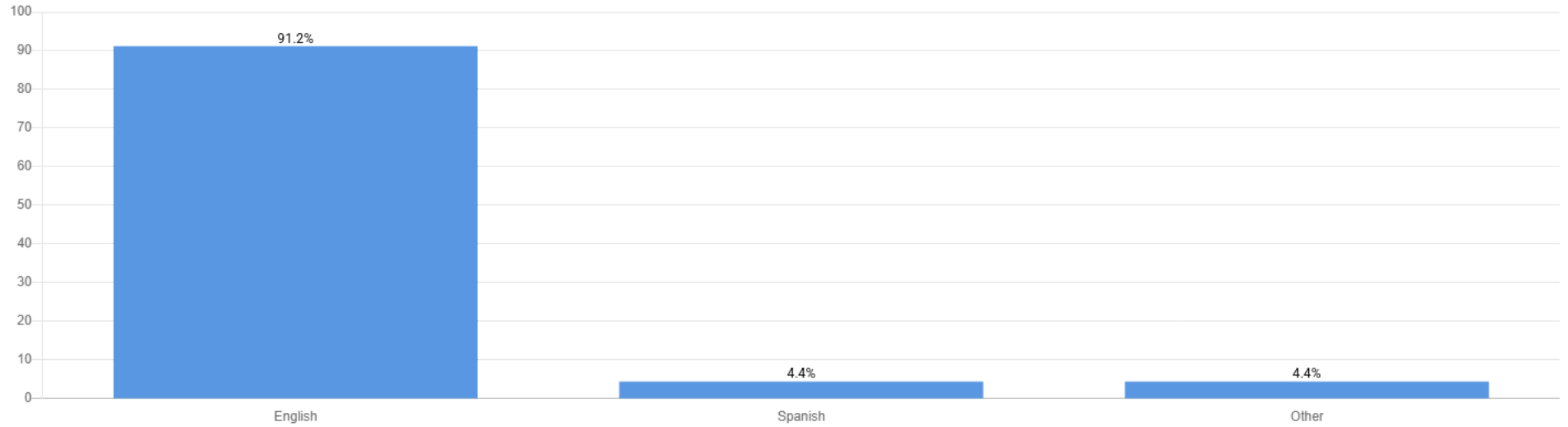

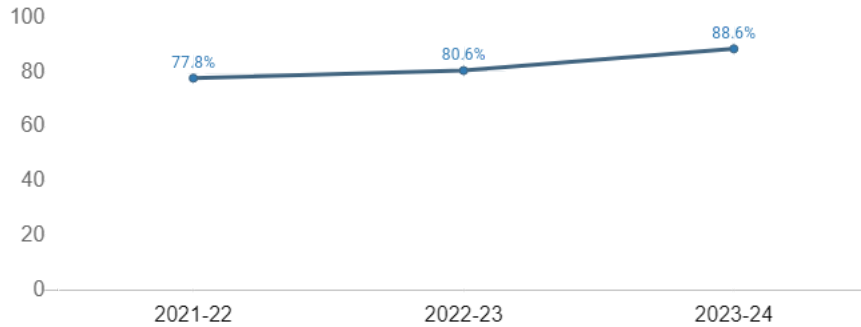

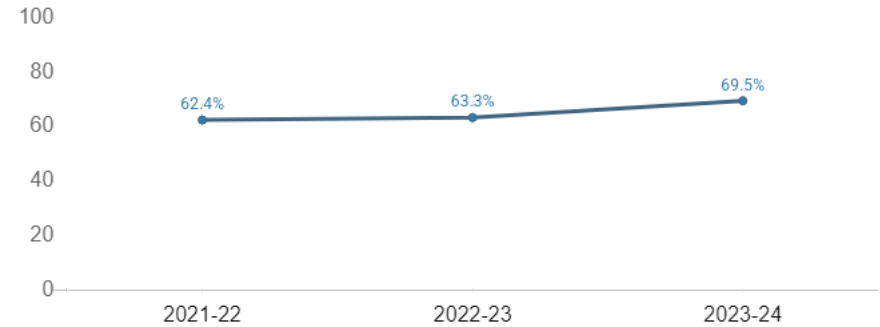
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 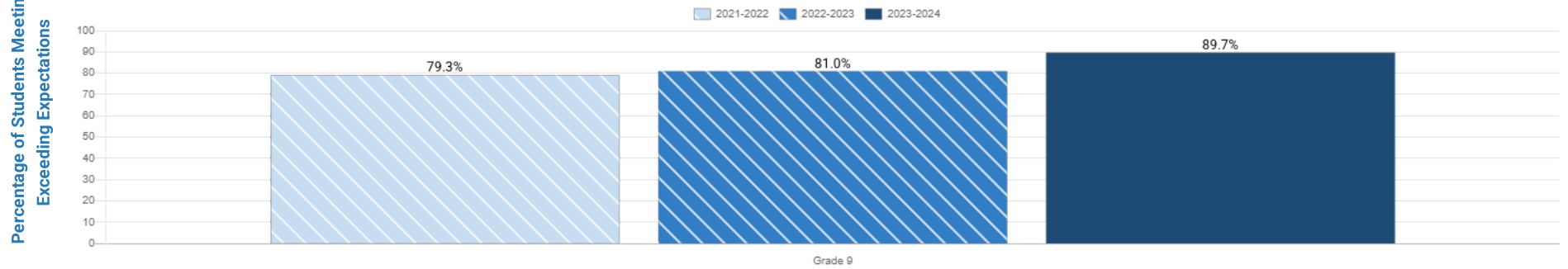

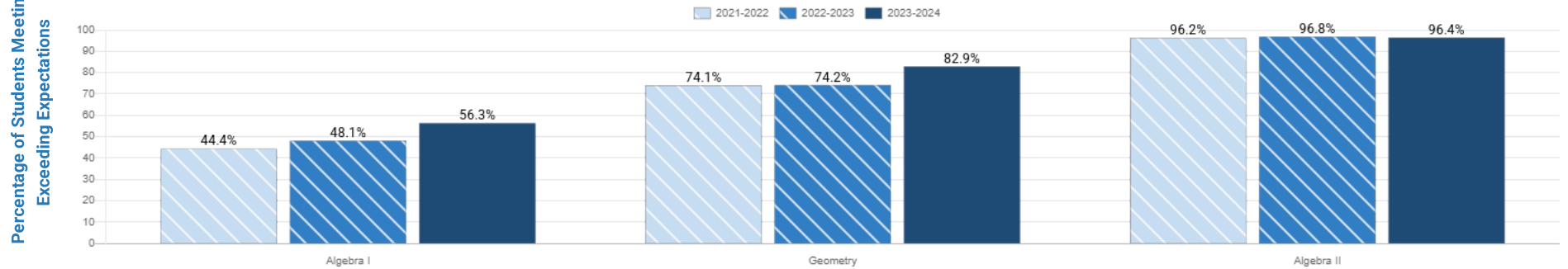

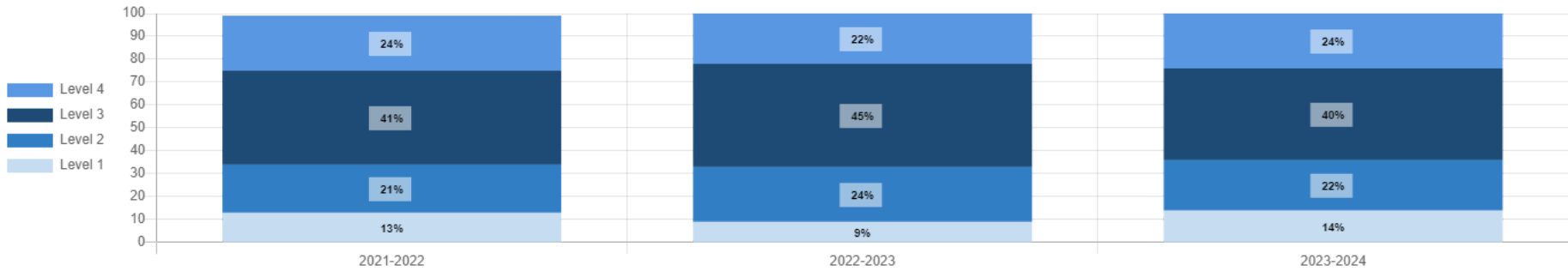

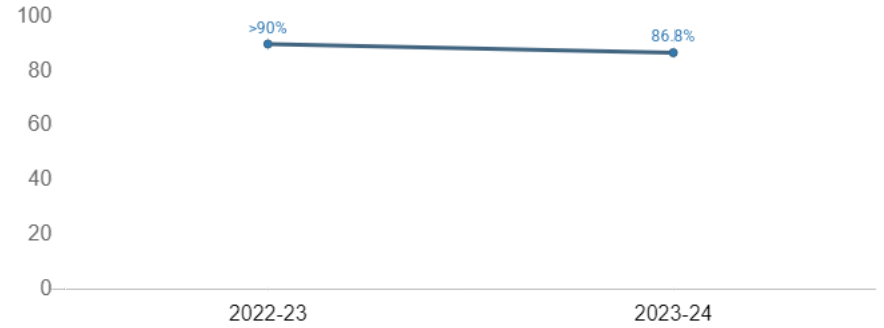

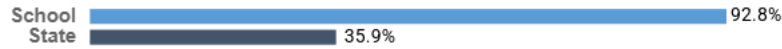

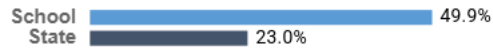
Students enrolled in one or more AP or IB course



Students taking one or more AP or IB exam

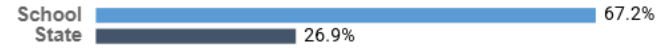


Students with one or more exams with a score of at least 3 on AP exams or 4 on IB exam

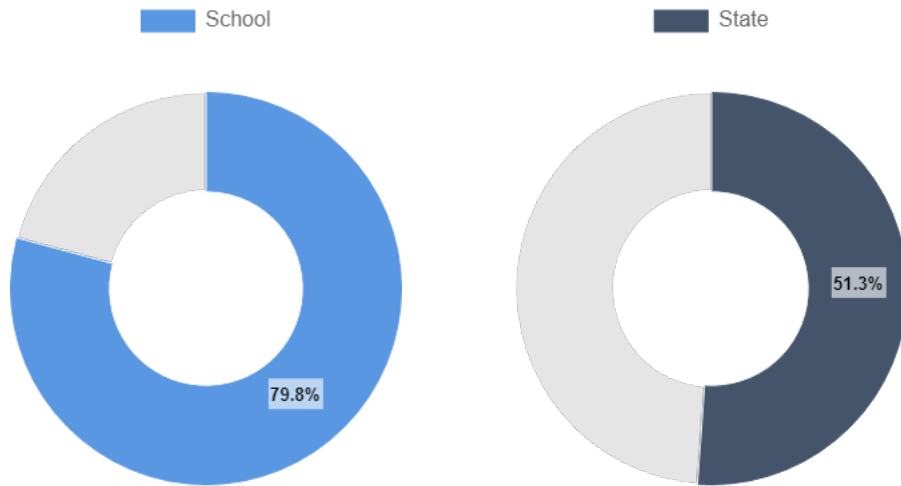

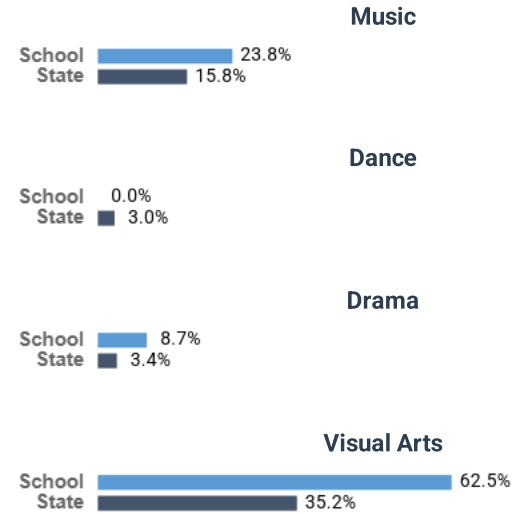

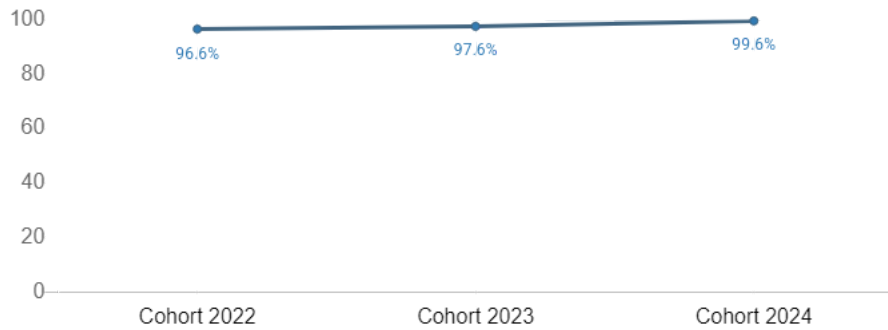

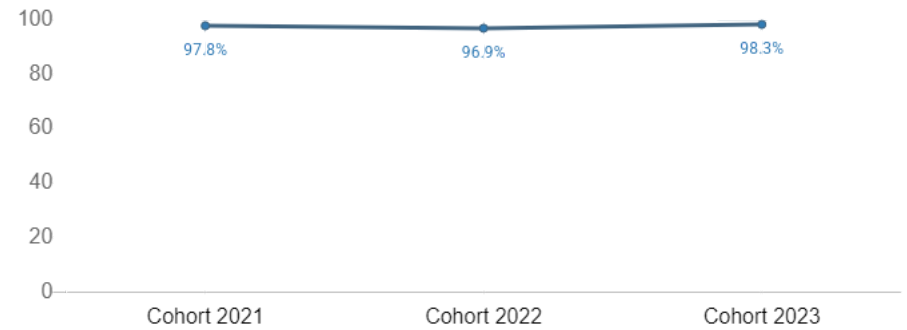

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

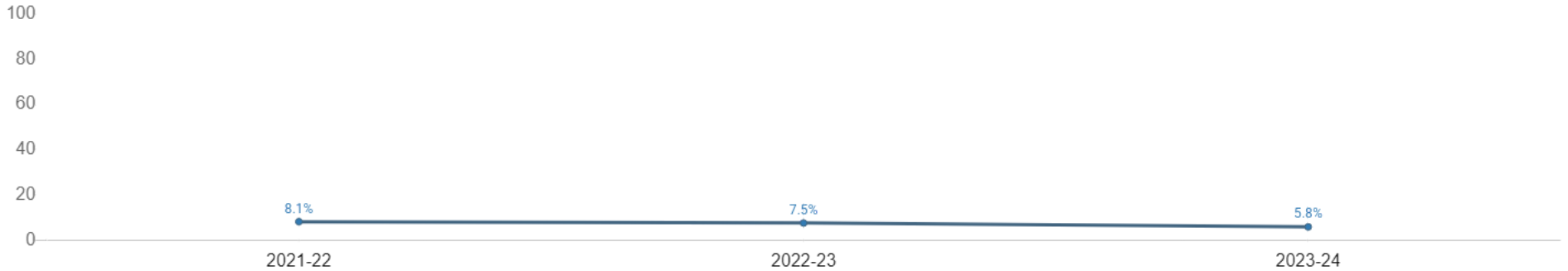

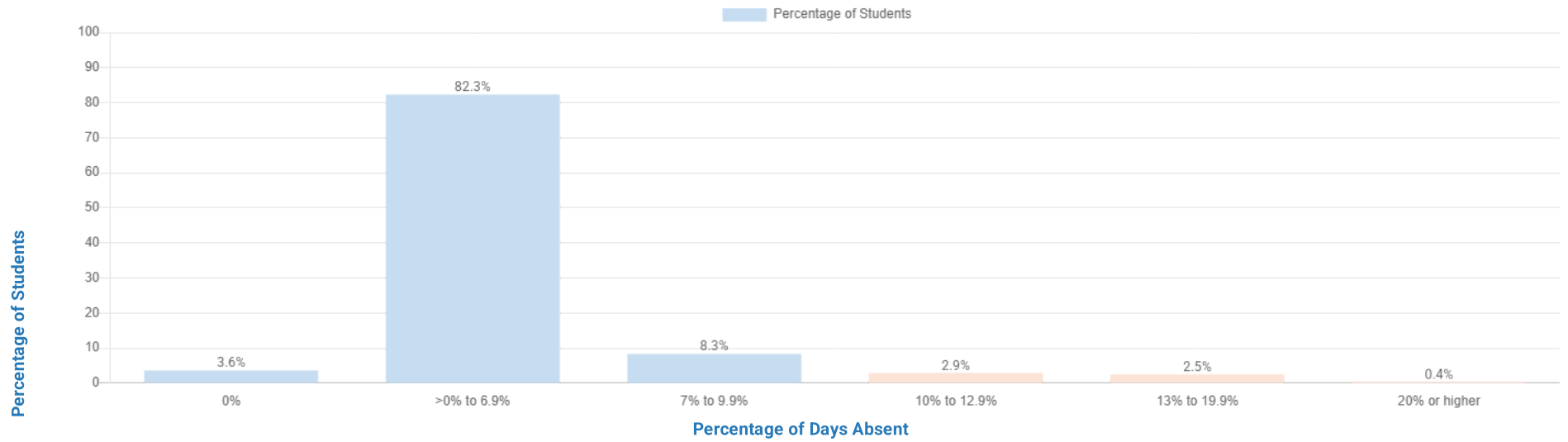

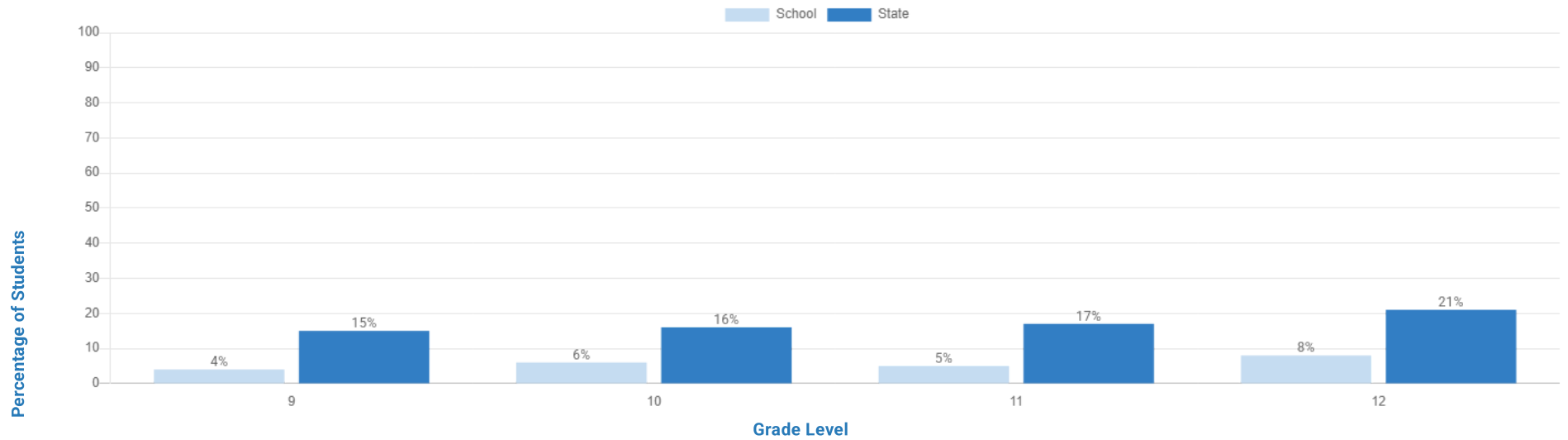

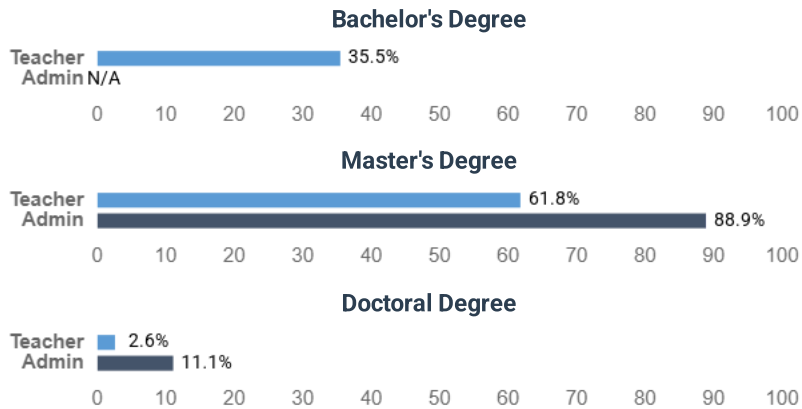

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Mission, Vision, Theme:

The mission of the WMRHSD is to advance student growth and learning by ensuring that our students and staff are highly engaged, balanced, and reflective at all levels and in all environments. We aim to recruit, develop, and retain the most dynamic/passionate educators and develop, evaluate, and continuously assess the depth and relevance of our curricula and programs. The International Baccalaureate Approaches to Teaching and Learning provides the pedagogical model for instruction.



Awards, Recognition, Accomplishments:

WMMHS and sister school WMC were the first high schools in New Jersey authorized to administer the IB Career-related Programme. They offer both the longest-running public IB Diploma Programme and the longest-running IB Career-related Programme in the state. The Washington Post ranks WMMHS among the most competitive in the State/Nation. Achievements include: NJ DOE Model World Language Program designation, 2 National Merit Finalists, 18 Commended Scholars, and 61 AP Scholars.

Courses, Curriculum, Instruction:

WMMHS offers a comprehensive four-year program in all college preparatory subjects and a wide range of fine and performing arts, STEM, and elective courses. Instructional levels include: Advanced Placement and International Baccalaureate, Honors, Advanced, Academic, and Studies. Over 50 AP, IB, and Dual Enrollment courses are offered each year. With our sister school, WMMHS has the largest number of IB programme graduates in New Jersey. 120 credits of coursework are required for graduation. As an International Baccalaureate World School we subscribe to IB's Approaches to Teaching and Learning and seek to cultivate learner attributes and dispositions intended to fully prepare students for effective participation in a global society.



Sports and Athletics:

WMMHS enjoys a proud tradition of achievement in scholastic athletics across 26 female, male and coeducational programs routinely competing for conference, county and state titles. WMMHS is a member of the Northwest Jersey Athletic Conference governed by the NJSIAA. WMMHS teams were recognized for the following Championships: Field Hockey-Conference Girls Cross Country-Conference Race, Morris County, Boys Cross Country-Conference Batch and Race, Morris County, Sectional and Group, Girls Winter Track-Sectional, Girls Basketball-Conference, Boys Golf-Sectional, Girls Golf-Conference Tournament, Boys Tennis-Sectional.



Clubs and Activities:

The Activities program supports over 40 clubs. Relay for Life and the WMMHS Service Club are among the most heavily subscribed. In the former, partnering with our sister school, students assemble teams to fundraise for the American Cancer Society and strive to reach an annual goal of \$100K. Also noteworthy: the Progressive Perspective Club, International Club, Future Business Leaders of America, Peer Leadership, Mendham Players, a cappella groups and numerous Academic teams, and a Gender-Sexuality Alliance. The Mock Trial team consistently earns County and State Championship honors. Newer additions include Music Analytical, Girl Up, and Women in STEM clubs as we strive to offer a breadth of activities that may serve or spark an interest among every one of our students.

Before and After School Programs:

WMMHS Unified Sports program facilitates the participation of special needs students in our interscholastic athletics offerings competing side-by-side with schoolmates. A wide variety of musical performance groups and a sports intramural program complement our scholastic athletic programs and myriad school clubs and activities including the Mendham Players.



Staff and Professional Learning:

The WMRHSD dedicates ample resources to professional learning. District in-service is modeled after Ed-camp style, staff-directed learning where educators choose from a menu of workshops offered by colleagues. Topics include the Approaches to Teaching and Learning, integration of technology, formative assessment, and other pedagogical matters. WMMHS teachers participate in perennial roundtable discussions with regional IB World Schools while annually sending several staff to national IB-approved workshops. State training requirements are met via video instruction. Two members of the faculty hold doctorate degrees, and 72% of the faculty has earned a master's degree. Faculty members both attend and present at discipline-specific conferences.



Postsecondary Information:

91% of graduates from WMMHS' Class of 2024 attend 4-year college/universities with 6% attending 2-year colleges. 3% commenced other undertakings in military/employment/gap-year options. The Class of 2024 achieved an average SAT score of 1275 and an average ACT score of 27. College placement is supported by 6 counselors and the Director of School Counseling Services. The Naviance software suite assists students with their research, planning, and application process and also provides a number of career exploration tools. WMRHSD subsidizes the administration of the PSAT for juniors while all sophomores may elect to participate in the PreACT.

Student Supports and Services:

WMMHS provides a variety of support services to students. The Child Study Team is comprised of two social workers, a learning consultant, and a school psychologist. The I&RS Team functions as a complement to our 504 Committee. WMMHS offers a behavioral support and a work-based structured learning experience program for students with IEPs. A Math Resource Center runs throughout the school day and peer tutoring is also available. Multilingual learners benefit from targeted ESL instruction. WMMHS provides high-quality, specialized, and inclusive academic, life skills, vocational, and extracurricular programs for students with disabilities. The Child Study Team and teaching staff proactively prepare students for transition to post-secondary life as college students, students in trade schools, public and military service, or for entry into the workforce.



Student Health and Wellness:

WMMHS employs a Wellness Counselor to support and promote student mental health and well-being. WMMHS' Zen Zone serves as a place for students to practice mindfulness. Our Safety/Climate Team meets throughout the year, focusing on various means of promoting student wellness. Our health curriculum covers drug and alcohol abuse in freshman, junior, and senior years; the anti-bullying curriculum in the freshman and junior years. Nutrition is discussed in freshman, junior, and senior years. Awareness campaigns and assembly topics include Suicide Prevention, Substance Abuse Prevention, Anti-Bullying, Self-Esteem, Study Skills, Dating Violence, and Social Media. Students participate in Physical Education yearly. WMMHS has a Mental Health & Wellness Committee, which established coordinated homework-free periods, distribution of teacher surveys to students, the strategic insertion of delayed openings, and starting the year earlier to frontload instruction prior to standardized testing.



Parent and Community Involvement:

WMMHS values its relationships with parents and the larger community. An active PTO provides programming for students and parents. Parent groups such as the PTO, IB Boosters, the Minuteman Sports Club, Music Boosters, and Project Graduation lend generous support to these branches of school life. Students in the IB Programmes complete service learning projects in the community. Since the introduction of the IBCP, Junior IBCP candidates have raised over \$59,500 for charitable causes through their Service Learning Philanthropy Projects.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students. WMMHS' climate committee continues to help foster a positive school climate and culture. Our committee consists of parents, teachers, counselors, and a member of our administrative team. We meet 4-5 times per year to gather feedback from students to determine how we can better the school climate. Positive takeaways from our climate committee last year included most students feeling safe in the building, widespread participation in clubs/activities, and a broad indication of students making new friends, while most students agreed they have a trusted adult in the building. Programming was developed and is ongoing in the 2023-2024 school year. We plan to send out a new climate survey mid-year to gather more data from our students.



Facilities:

WMMHS is a fully wireless facility featuring a 525-seat auditorium, 3 music rooms, an 800-seat gymnasium, an auxiliary gym, a field house with locker rooms, an athletic training treatment room, a recently renovated wellness & performance center, a dedicated wrestling room, and well-equipped science, technology, and fine & practical arts labs. The Library was redesigned in 2018. A climbing challenge course consisting of various structural elements is a cornerstone of the Physical Education curriculum. The school also offers dedicated video/audio production and editing labs and a versatile 50-seat STEM lab. A 2024 referendum will fund classroom air conditioning, culinary arts/tech-ed renovations, and a remodel of the cafeteria kitchen and dining area. Exterior athletics facilities include a lighted stadium with track and 1 of 2 multi-purpose artificial grass fields, 2 softball fields, 2 baseball fields, and 3 grass fields plus 6 tennis courts.



School Safety:

School safety and security are supported by the full-time presence of a school resource officer and a part-time Class II Officer for afternoons and evenings at WMMHS. The campus is monitored with an extensive video-camera surveillance system. (2) Emergency Drills are conducted Monthly (Fire Drill & Emergency Drill). Administrators remain visible during passing time and lunches.

Technology and STEM:

WMMHS has assembled a host of technologically advanced machines for student use, including multiple 3D printers, to support learning in our technology education, science and math departments. Introduction to Coding and Computer Science, Computer Programming and Game Design, Robotics, and Design Technology/Engineering constitute several of the STE- focused classes available for students. WWMHS features a flex-space "STEM Lab" with state of the art didactic tools and participates in the national "Day of Coding" project. WMRHSD Robotics VEX Team has participated in and hosted numerous tournaments and scrimmages; their Team is currently ranked #1 in NJ and in the top 100 for the world.



Attendance:

WMMHS maintains an attendance rate above 90% through a variety of effective strategies. The Attendance Review Committee, comprising administrators, counselors, and teachers, reviews data, identifies at-risk students, and intervenes early. Weekly attendance letters warn families nearing chronic absenteeism and potential credit loss. Family engagement is prioritized via phone, virtual, and in-person conferences to address barriers. Collaboration with the Child Study Team, Guidance Department, and faculty ensures holistic support for academic, social-emotional, and external challenges. A make-up seat time initiative helps students recover missed instruction. These efforts foster accountability and sustain high attendance rates.

Other Information:

WMMHS runs a modified rotating block schedule. While students maintain 8-class course loads, six meet each day for 55 or 65-minute periods. This schedule mimics a collegiate atmosphere, providing variety in the student's schedule and helping to develop time management skills. The unit lunch allows students to interact with peers while increasing access to faculty, clubs and other resources. All students are given a school-issued email address, a Chromebook, and access to a Learning Management System and numerous digital tools to promote 21st century skills within the curriculum. Families can monitor student performance through the PowerSchool portal. Most forms, informational, procedural and curricular resources are available through the school website where events and announcements are also publicized. Informational updates and urgent notifications are disseminated to students and families through text, email and phone through digital broadcast management tools.
