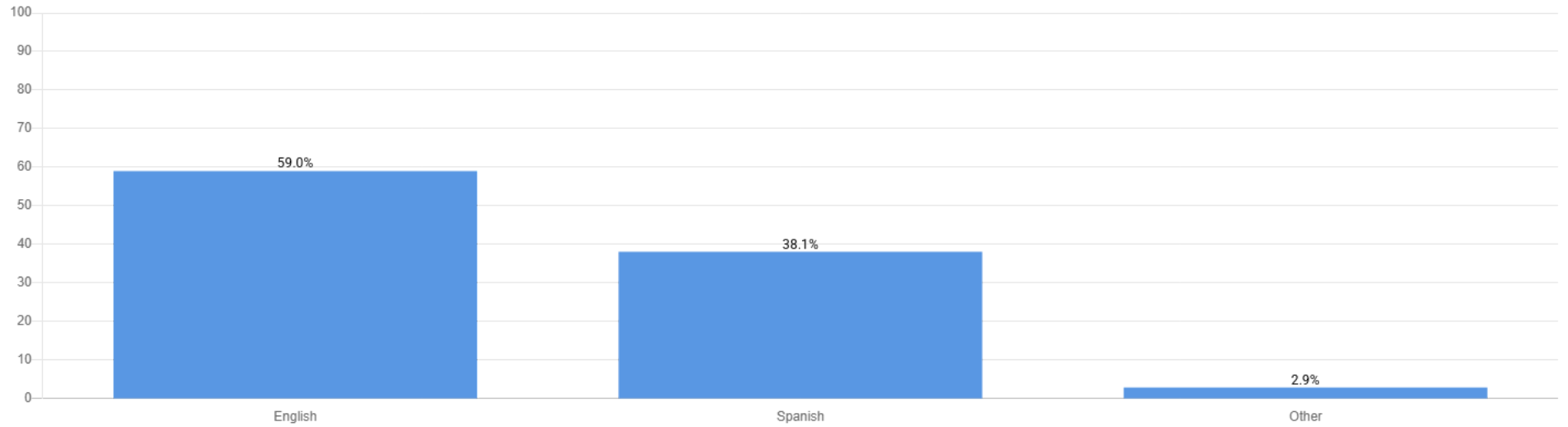

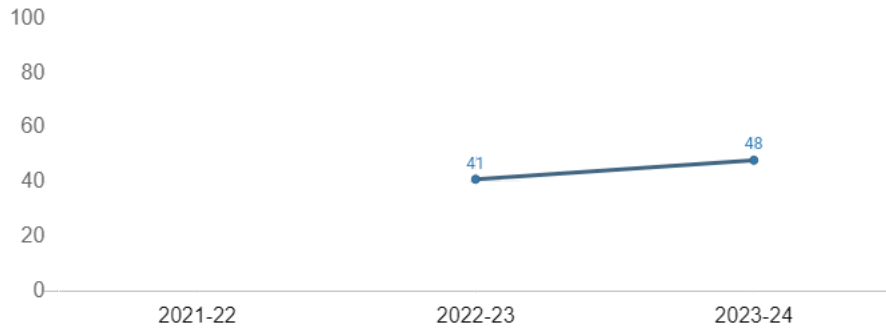

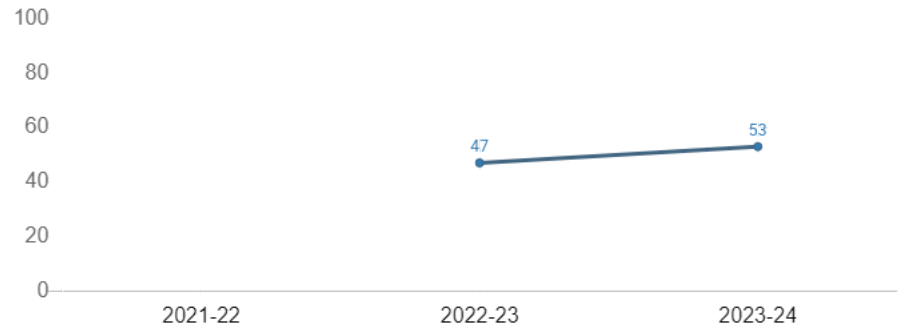

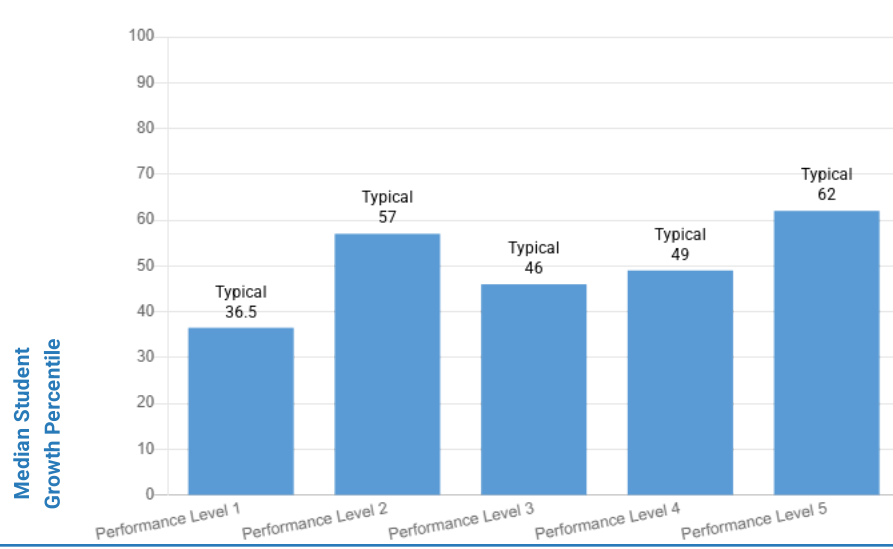

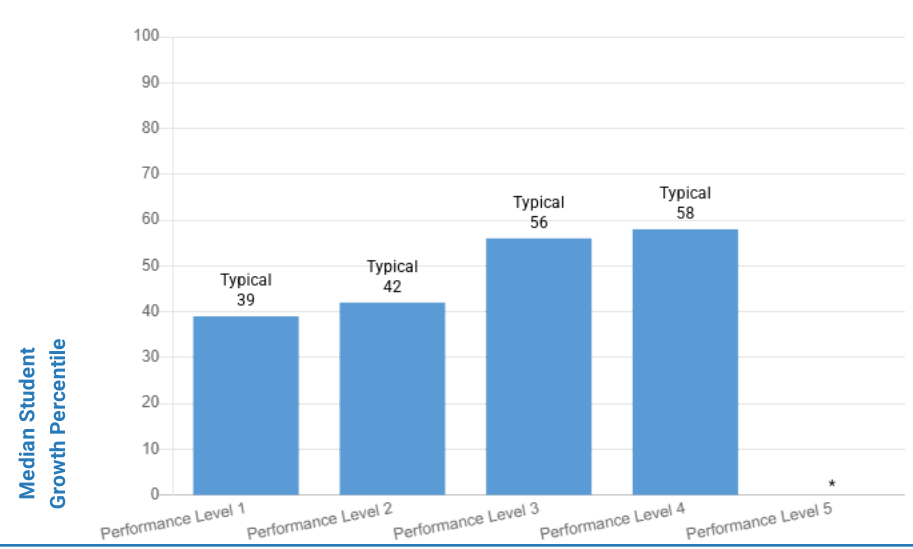

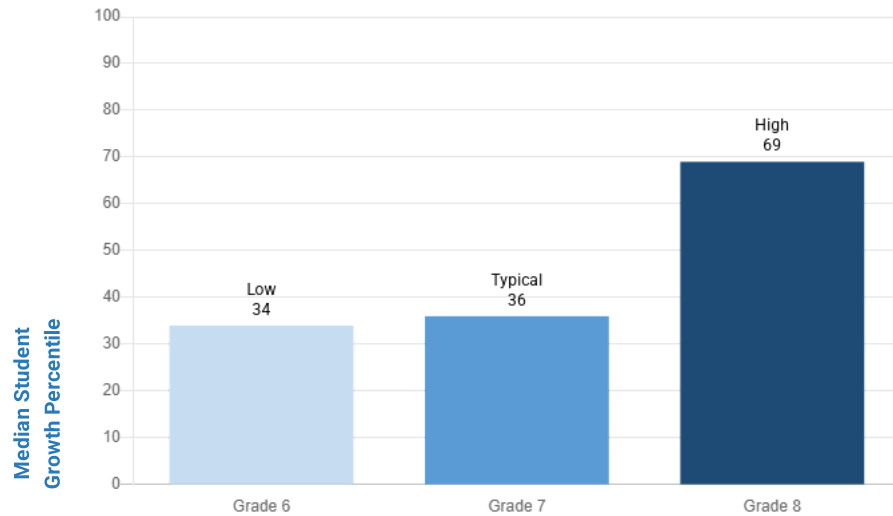

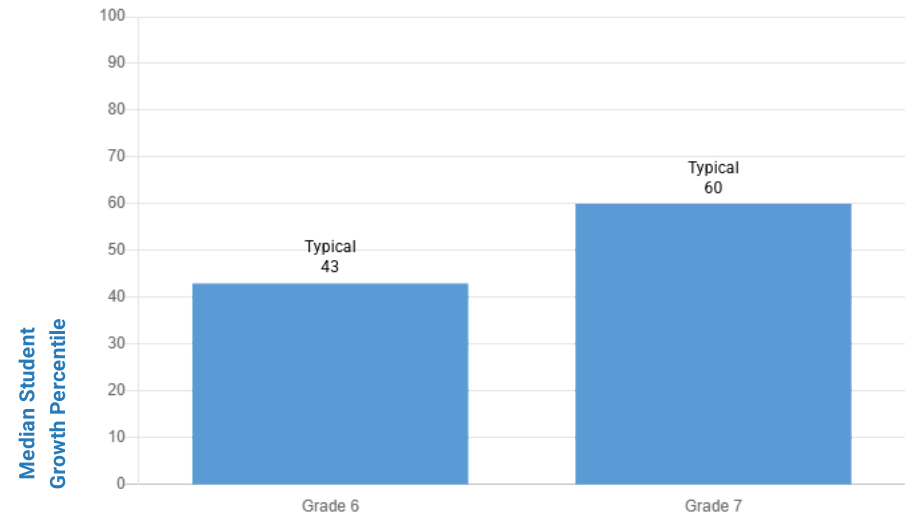

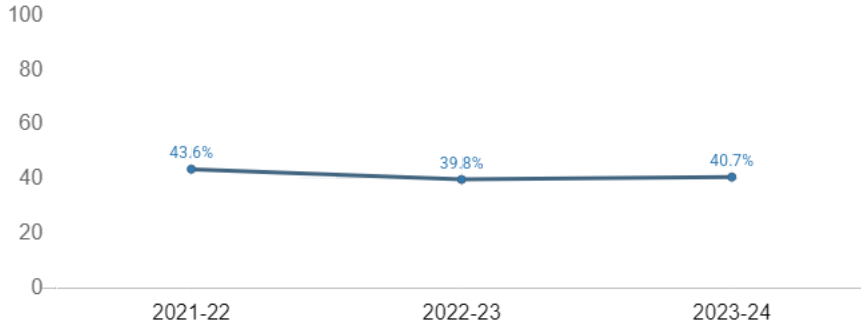

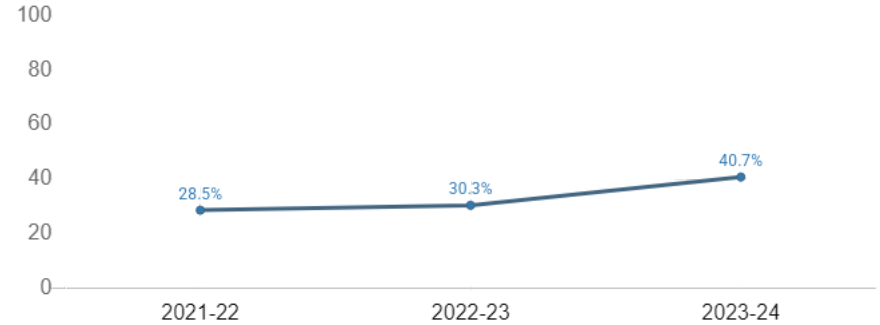
English Language Arts and Mathematics Performance Trends

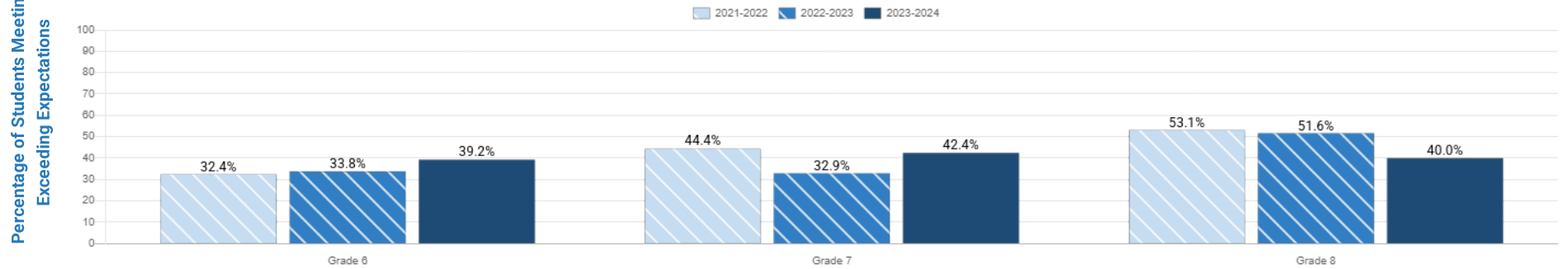

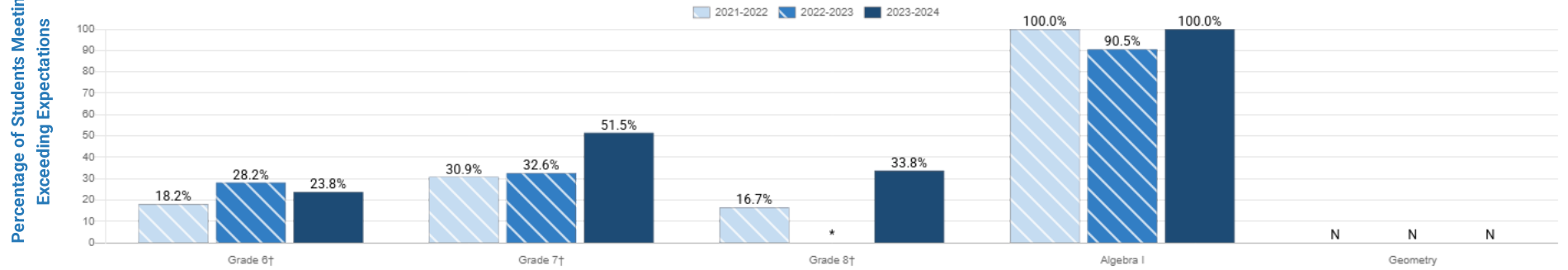

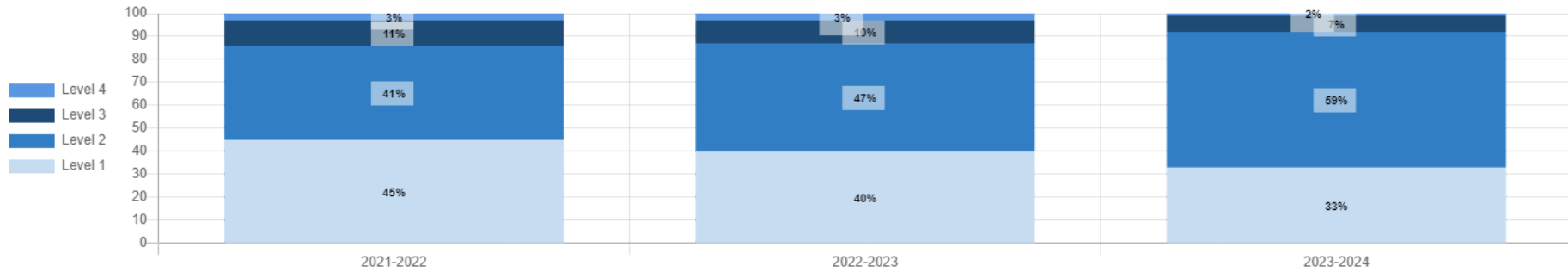

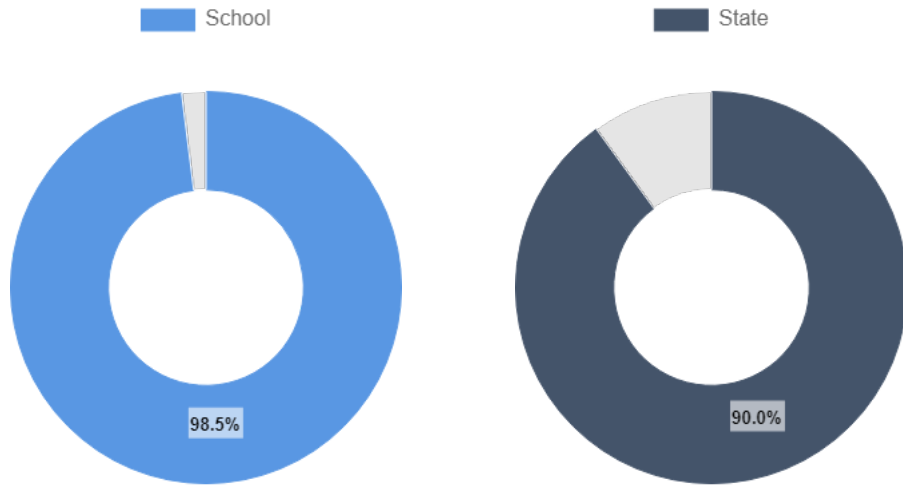

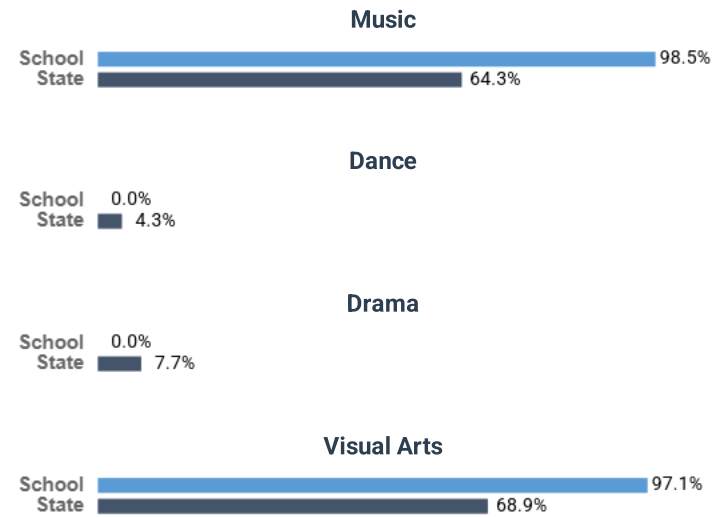

Students enrolled in one or more classes by discipline:



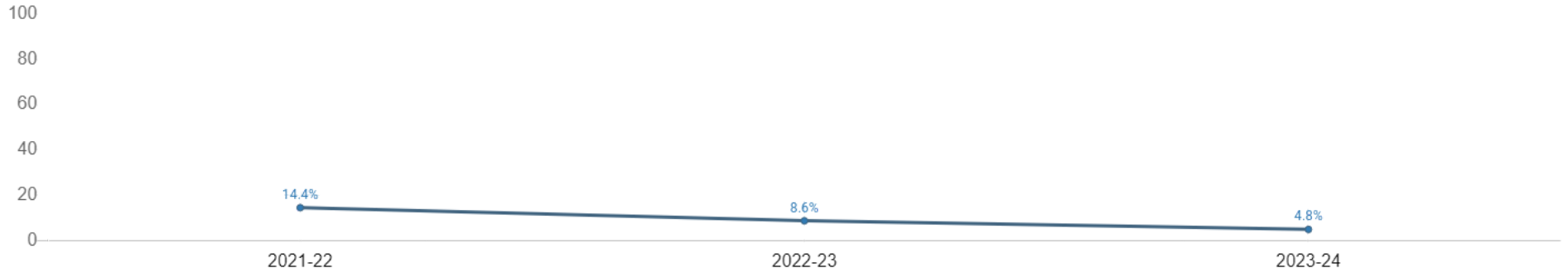

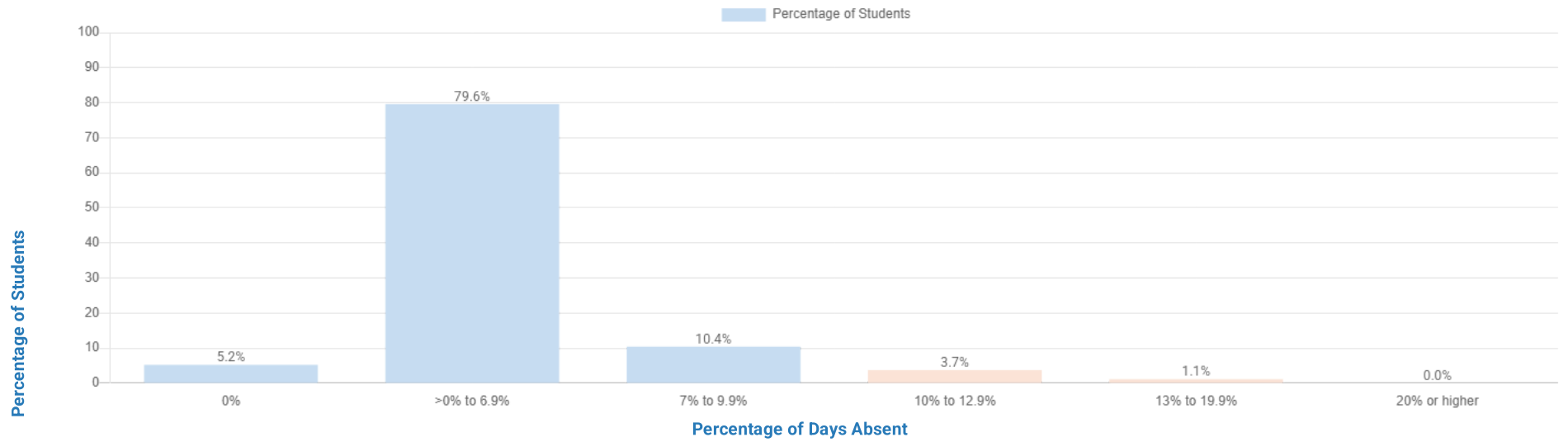

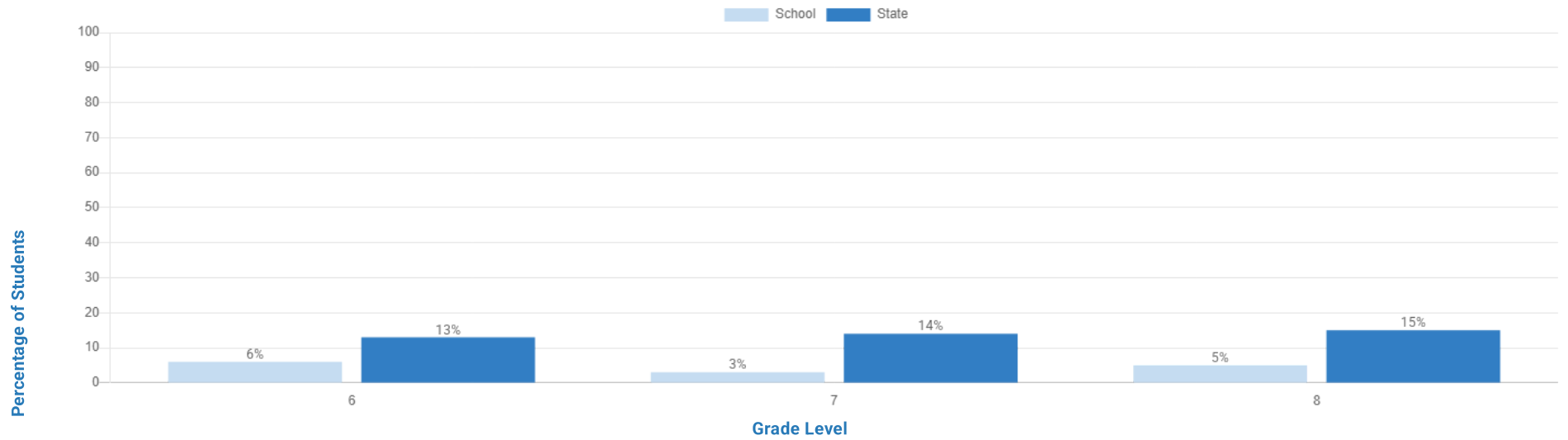

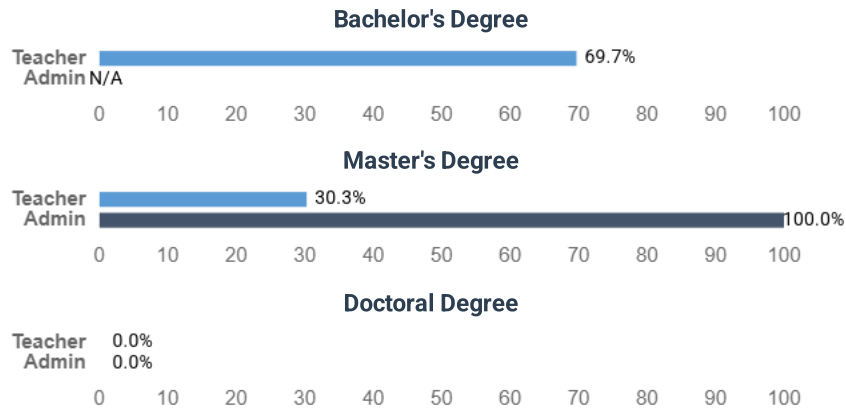

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Before and After School Programs:

MacKinnon Middle School offers several before school programs and multiple after school programs. We have various clubs and activities that meet either before or after school. We have a strong music program as well as performing arts program that meets both before school and after school. The Middle School has an Athletic program that competes against other schools in the county. Sports include boys and girls cross country, boys soccer, girls soccer, boys basketball, girls basketball, boys wrestling, girls wrestling, basketball and softball. Each team has anywhere from 8-20 competitive events per season. Regarding Academics, MacKinnon Middle School offers enrichment programs after school with tutoring opportunities as well as a Homework club for students that may be struggling academically, or just need a quiet place to get their work done. We also offer STEM, Coding, and College and Career Readying Program.



Staff and Professional Learning:

Through the use of the shared drive within the district, staff members are able to access a "Hub" that was created that has a wide array of topics that staff can peruse through when need to enhance professionally in certain areas. Videos, websites, etc. are included in this hub that can easily be reviewed. The district has a contract with a Literacy coach that meets with staff individually or in small groups and offers development opportunities. The literacy coach has also provided seminars to staff including but not limited to providing additional supports working with ELL students. As a state requirement, staff participate in Professional Learning Communities (PLC's) and meet frequently as a subject area or specialization area and discuss best practice and will conduct research as a group. We are also actively participating in the New Jersey Inclusive Practices Grant to include more special needs students into the general education setting. .

Student Supports and Services:

MacKinnon Middle School offers services that are available to all students as well as services for our 504 and/or students with an Individualized Education Plan. We have Counseling Services, Speech, OT/PT, behaviorist services available, and in-house clinicians offering therapeutic mental health services. Students are assessed frequently to determine if additional supports may be needed. The Middle School uses RTI to provide multi-tiered systems of support.



Student Health and Wellness:

MacKinnon Middle School Schedule includes health class as well as physical education. In these classes health and wellness is promoted. During the school year, students will meet periodically with the kitchen staff to discuss food options and ensure students are being served items with strong nutritional value. Embedded within certain curriculum, students learn about positive health choices. School Wellness Week is held during the school year with various activities that promote leading a healthy and productive lifestyle and dependent upon choices. All students are afforded the opportunity to participate in recess daily. If weather permits students get to go outside and enjoy the weather as well as the ability to be physically active.

The Municipal Alliance, Wharton Kids First Foundation, as well as the District PTA have great involvement with the schools. Through not just these groups but through even individuals expressing interest, numerous community members join together to support the students and staff in Wharton. Through Social Media platforms, and our student database system (Realtime) our district provides the community with information on how they can become more involved in the schools as well as shares the ways in which the community members are currently involved. There are many opportunities throughout the school year for the community to get involved.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Mental Health concerns became more evident around the time of the pandemic. It was imperative that students and staff feel supported and know where they can go for support for their social and emotional well-being. Currently we have two licensed clinicians on staff, as well as a School Counselor. Also, easily accessible are members of the Child Study team to assist with any concerns. Through creation of additional programs, an enhanced use of our P.A. building wide announcements system, more frequent push in to classrooms to promote a healthier climate, as well as infusing building wide fun activities, a positive impact is bolstered throughout the building. A climate/environment is being created where students feel comfortable, supported, and anyone, regardless of their ability, can find success. All students are encouraged to challenge themselves to be the best they can be so they can see personal growth. The district has also added an additional support position for families.



Facilities:

MacKinnon Middle School was built in 1999. Our population is currently approximately 275 students. Upon entering the building you will see school logos and inspirational messages. Our school promotes a positive climate. Hallways and classrooms are clean. Our classrooms are geared toward the specific subject area. We encourage strong work ethic in the classroom and our facilities support that. Each student is provided with a locker and each classroom is equipped with flexible seating options. The Middle School is attached to the Elementary School and we share the hallways and particular classrooms at times, such as the gymnasium, where Middle School may use it for a period and then the Elementary School then uses the gym another period. Students have access to a Media Center(Library) Music Room, Art Room, Technology lab, Cafeteria/All Purpose Room with a stage, and Physical Therapy and Occupational Therapy Room.



School Safety:

The school has a Class III officer within the building for added security measures. Our main entrances all have security vestibules to enhance security and classrooms have enhanced locks to deter intruders. The MacKinnon School has access to enhanced security cameras that capture all areas of the building. If needed with additional features such as facial recognition. Each month the school holds their required fire drill and security drill to practice and ensure the safety of all those in the building. Any visitors into the building sign in and if entering the building must provide ID that is scanned and run through the system to identify any concerns documented with the state, if any. Staff are trained and updated throughout the year on any improvements in security measures.

Technology and STEM:

Each student is supplied with a Chromebook which connects to the district Wi-Fi. Each classroom is equipped with a Promethean Board that. The teacher utilizes this Promethean Board in the classroom. As an exploratory class, students participate in technology classes that incorporate STEM-like activities. Students can participate in a STEM and Robotics program which runs 1-2 times per week and different times throughout the year. All students are afforded the opportunity to participate in a Family Technology Night where students and their family members embark in technology based activities together.
