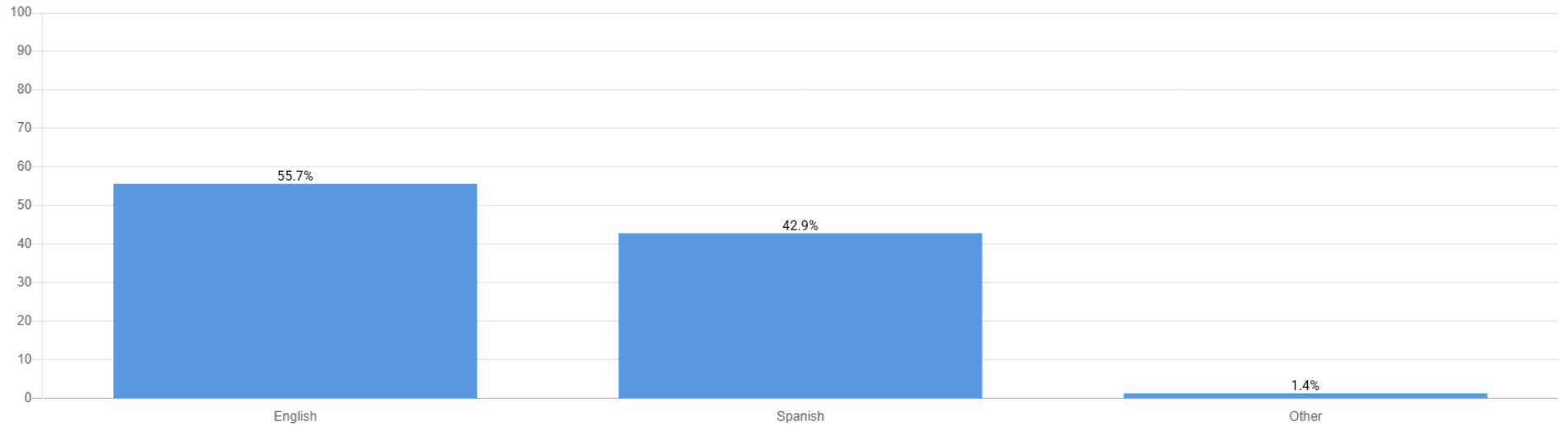

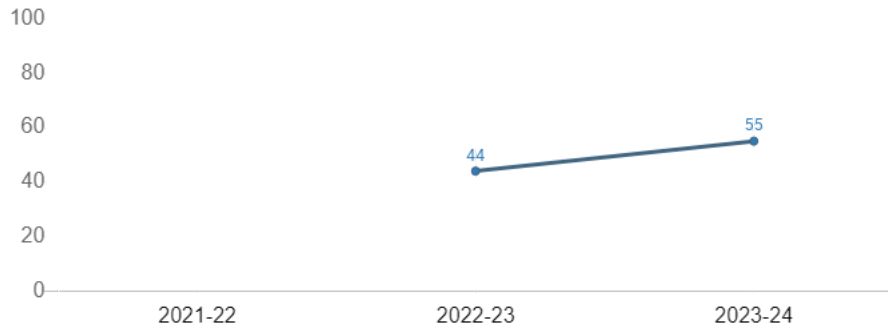

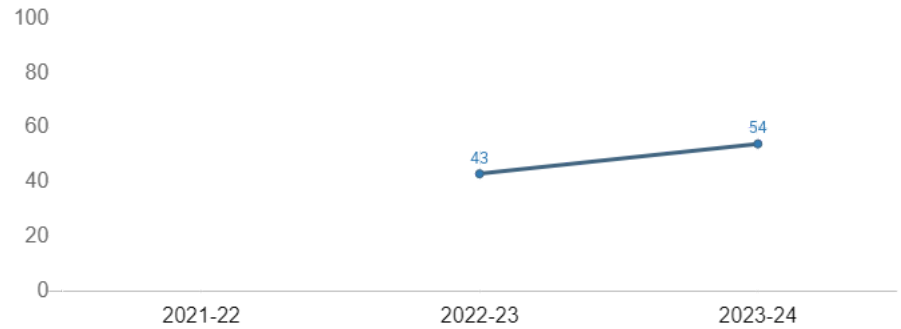

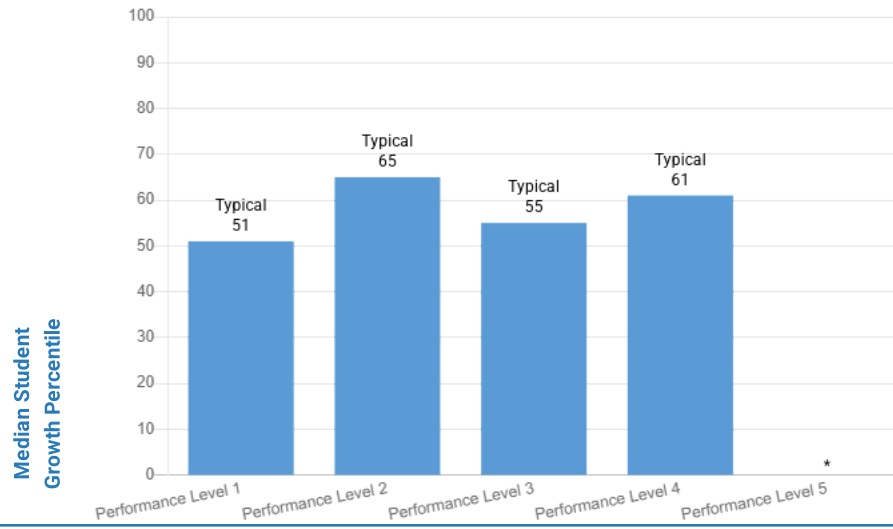

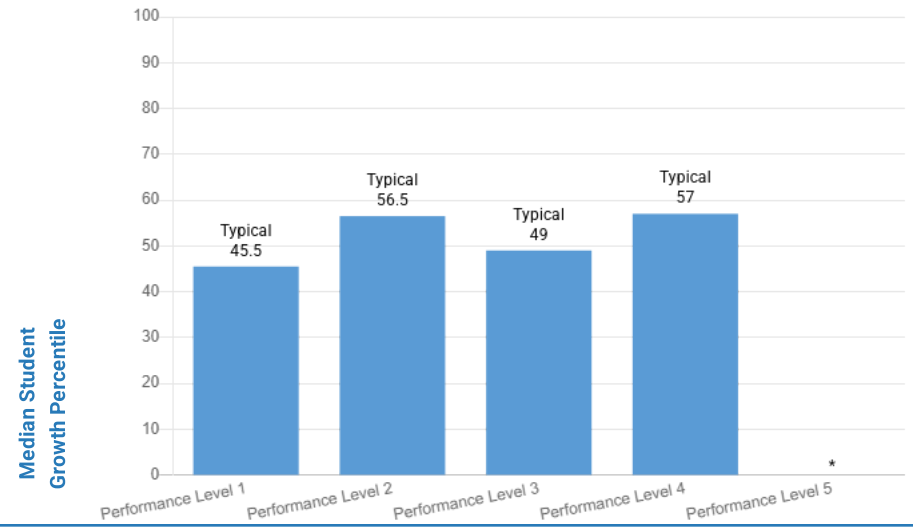

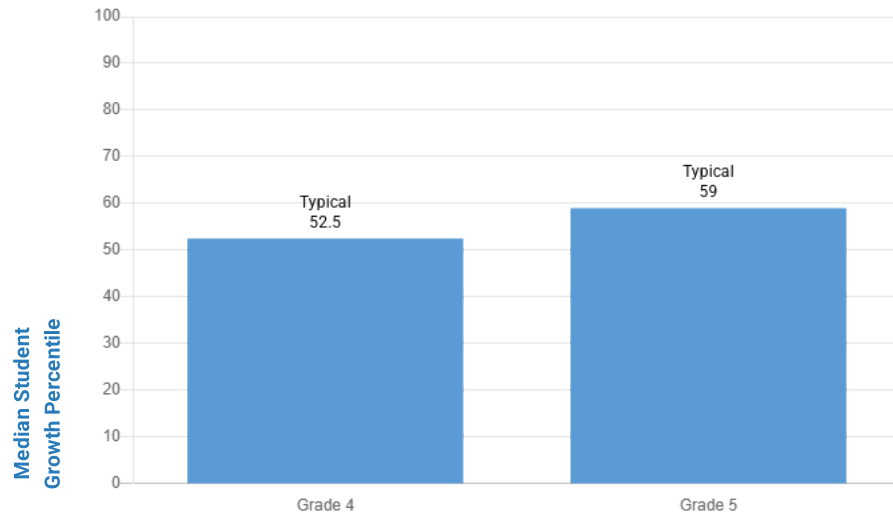

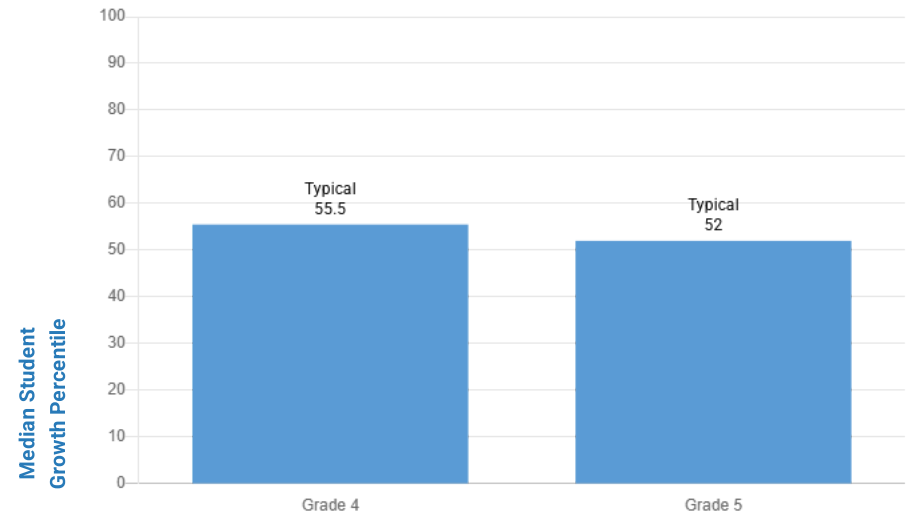

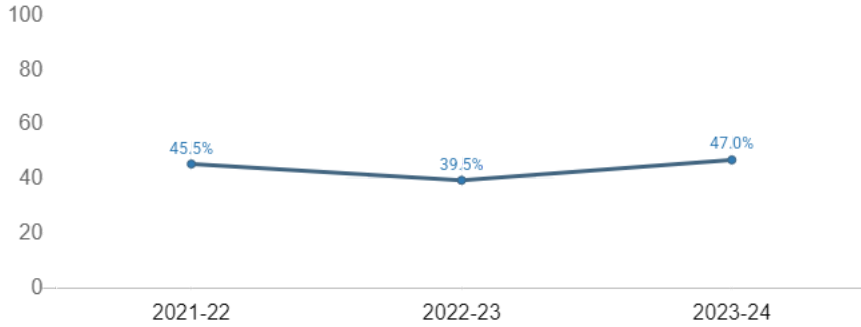

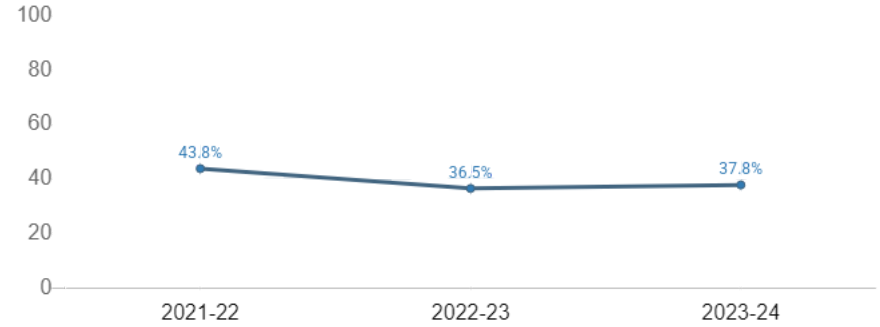
### English Language Arts and Mathematics Performance Trends

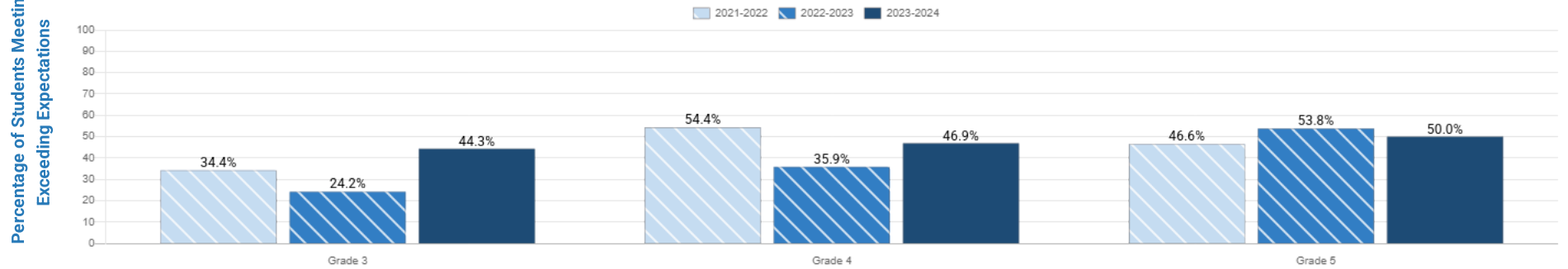

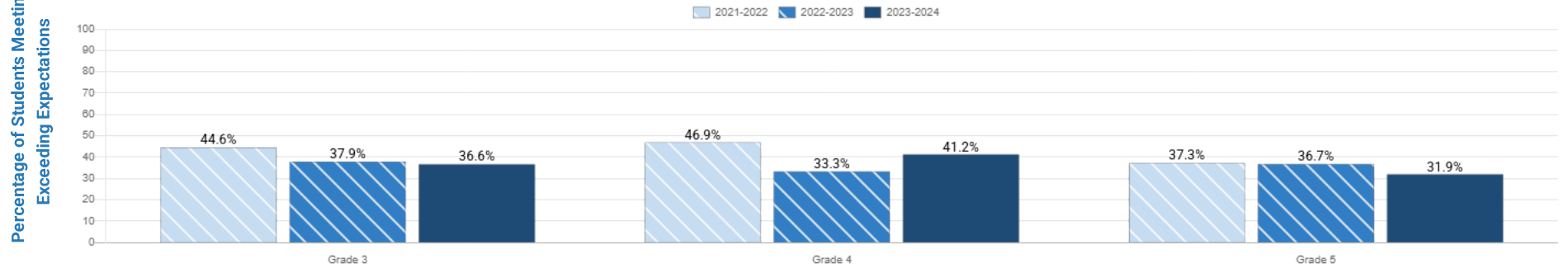

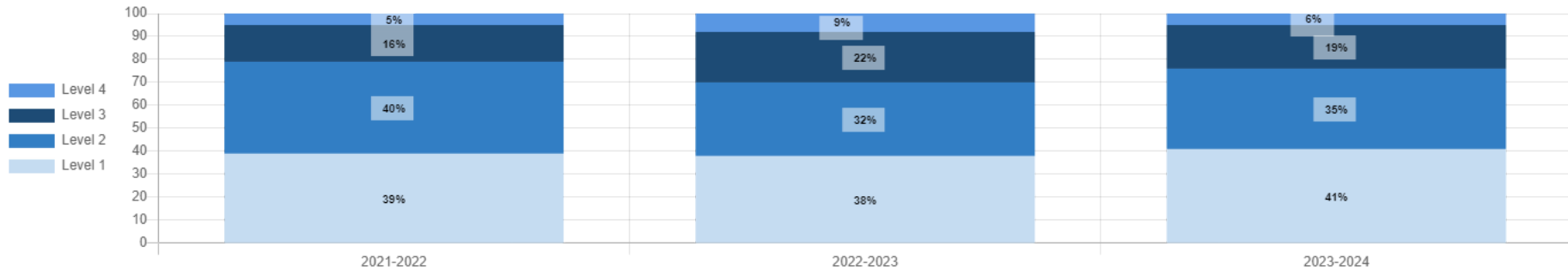

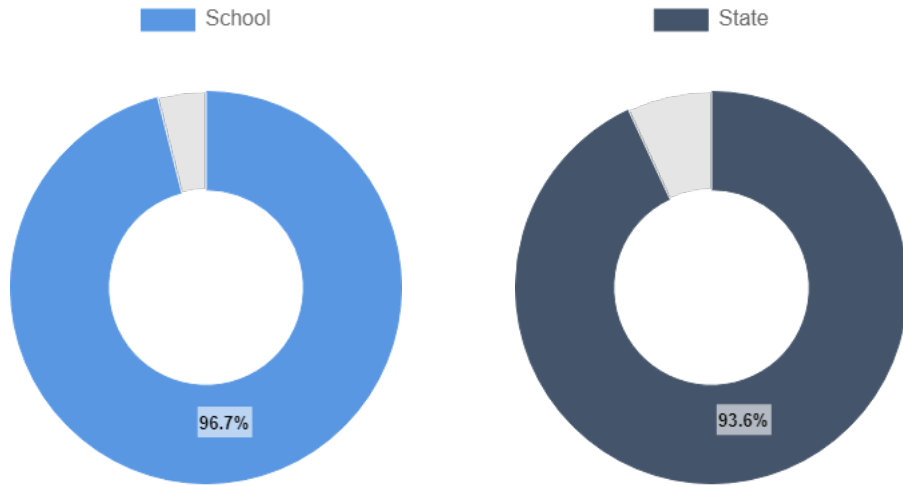

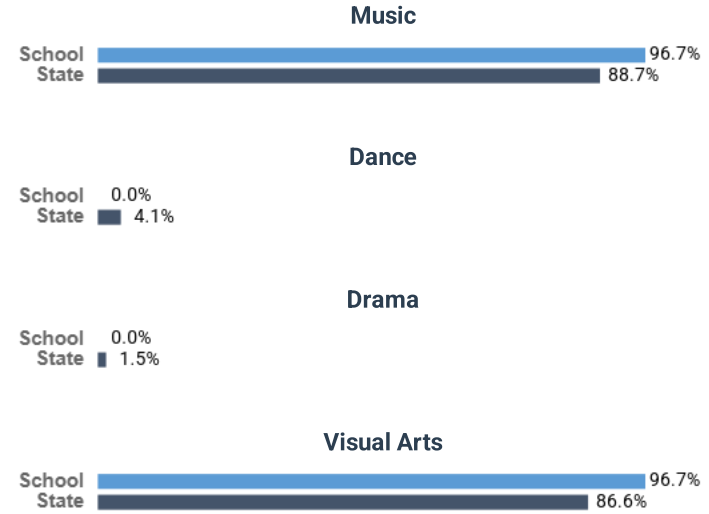

**Students enrolled in one or more classes by discipline:**



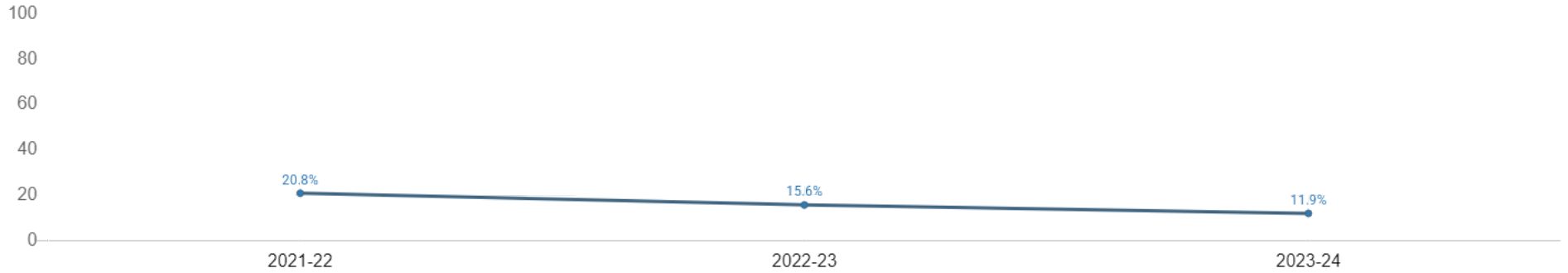

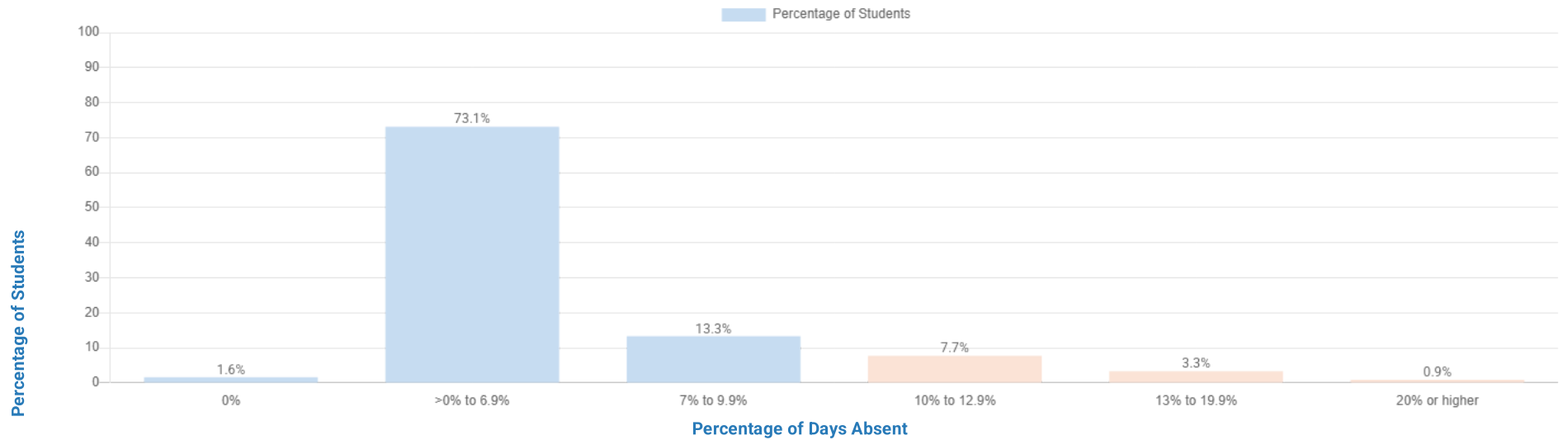

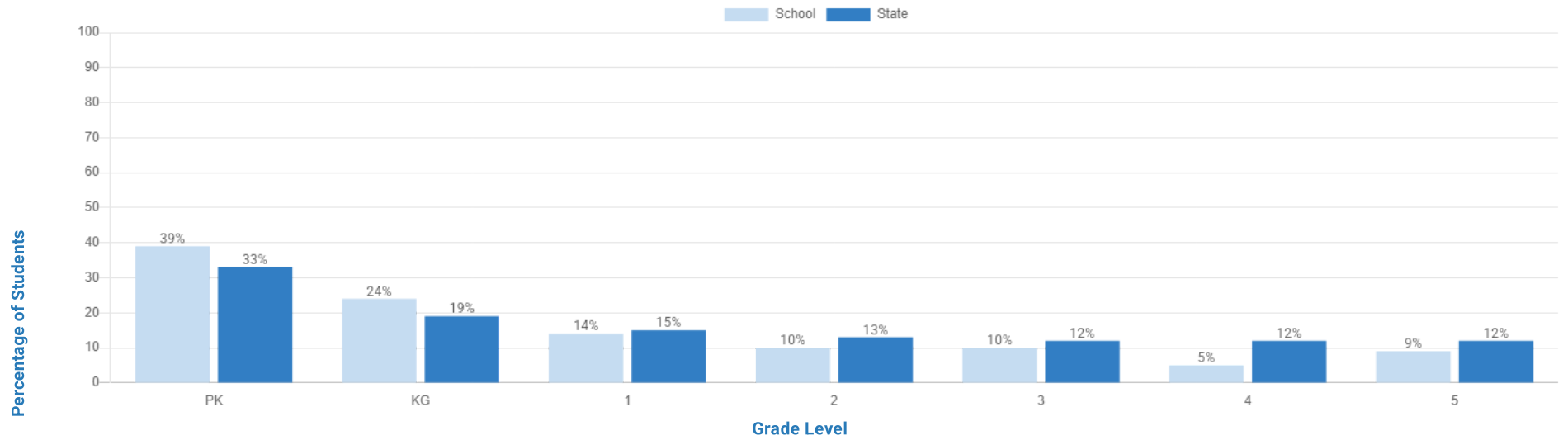

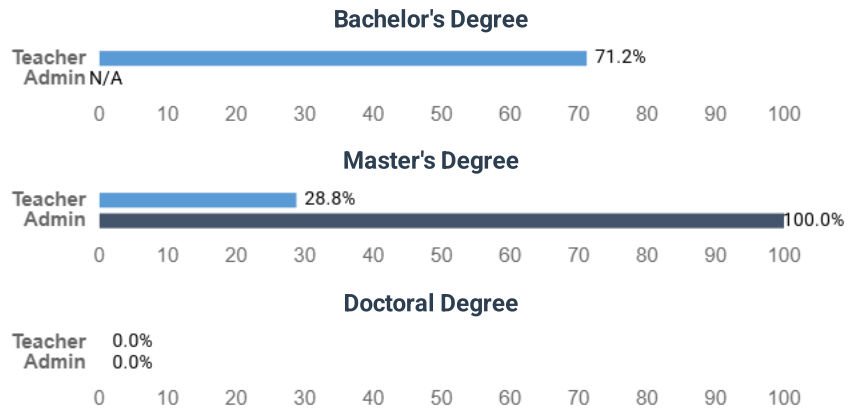

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ## Narrative

### Before and After School Programs:

Marie V. Duffy Elementary School offers before and after school programs. Band and performing arts are available both before school and after school. Duffy Drop In provides students with an opportunity to start the day with teacher support to ease into the school day in a supportive environment. A full breakfast program is offered to all students in the district. SOS Club (Students Obtaining Success) provides after-school teacher support for students completing their homework. In addition, there are varying opportunities across the year which have included Family Book Clubs and Art Nights, STEM Club, Garden Club, Game Clubs and TREPs, for example.



### Staff and Professional Learning:

Staff members have multiple opportunities for professional development including workshops, in-class coaching sessions, participating in virtual learning, access to a district professional development "Hub" that includes videos, webinars, websites, etc. The district contracts with a literacy coach who meets with staff, provides feedback and modeling. Staff participate in Professional Learning Communities (PLC's) and meet frequently to hone their practice focused on research-based instructional practices and standard-based assessment. In addition, staff are supported in pursuing advanced degrees.



### Student Supports and Services:

Assessments used to identify students needing support services include the Access (ML), universal benchmarks, data collection and work samples (Rtl), as well as the C-TOP and the Connors. Benchmark Assessments in key content areas occur three times a year to track the progress of all students toward the mastery of Student Learning Standards. Additional assessments are used on an individual basis as needed. Students with health difficulties documented by medical diagnoses may require a 504 or IEP. The district provides push-in and/or pull-out services for identified MLs, and students struggling to meet the universal benchmarks. Behavioral supports include restorative justice, class conversation circles, and meeting with the guidance counselor, Thrive clinicians, and/or behavioral coaches (teachers with time scheduled daily to help collect data and address patterns by providing relevant support to students and staff). Behaviorists work with students identified through Rtl.

### Student Health and Wellness:

The District promotes the health and wellness of students through the school lunch program by offering promotional days during the school year where at least one new nutritional alternative menu item is featured. The Principal encourages food products that meet the nutrition standards of the Healthy, Hunger Free Kids Act of 2010. Periodically the students have input on menu planning that includes taste-testing of new nutritional food, satisfaction surveys, and other activities that promote nutrition awareness. All students receive health and physical education and are afforded the opportunity to participate in recess daily, outside as weather permits. Age-appropriate equipment and supplies are available during recess time. The Art Department incorporates healthy nutrition through art projects. The district encourages fundraisers that promote physical activity. In addition, School Wellness Week is held during the school year with various activities.



### Parent and Community Involvement:

The Wharton Public School District prides itself on the bond it holds with the greater school community. Parents learn about opportunities for involvement through the parent portal (using Realtime) and social media as well as information sent directly home. Parents and the community are invited to participate in Advisory Councils focused on curriculum, special education, early childhood education and strategic planning. There are many other opportunities throughout the school year. Marie V. Duffy hosts a plethora of academic celebrations, both during and after school, for example a "We Are Readers!" Kindergarten parade, reading and writing celebrations, Colonial Day, Habitat and Hispanic Heritage celebrations. Additionally, classes host special events for veterans, invite community members in for Career Day and family members are invited to be mystery readers. Parents have access to student achievement and announcements via our parent portal.



### Climate Surveys:

With all the challenges resulting from the global pandemic, the school district has focused tremendous efforts to support school climate and focus on student social emotional and mental health. The district has a guidance counselor, two full-time mental health clinicians and continues to employ behaviorists to support not only individual student needs, but to target family needs as well. Multiple "Behavior Coach" positions provide positive supports and assistance to academically and/or social emotionally struggling student. The elementary school continues "Duffy Force", a group of students and teachers volunteering their time toward improving the school's culture and climate. Members of the Child Study team are also able to assist with concerns as needed.

### Facilities:

The Marie V. Duffy Elementary School was constructed in 1964 and adjoined to the middle school built in 1999, at one location. The district has a Library Media Center, Technology Lab, two Science Labs, Gymnasium, Art Room, full-service Kitchen, Cafeteria/All Purpose Room with Stage, Music Room, and Physical and Occupational Therapy Room. Recent capital projects include renovating bathrooms, technology media center upgrade, security vestibule and camera upgrade.



### School Safety:

The District recognizes the importance of providing and maintaining a safe environment for the students. The District also maintains a school district security program that includes: maintenance of facilities that are secure against unwelcome intrusion; protection against fire hazards and faulty equipment; and compliance with safe practices in the use of electrical, plumbing, heating, and other school building equipment. The district has a Class III officer within the building for added security. The Duffy main entrance has a security vestibule. The district provides access to enhanced security cameras that capture key areas of the building. Regular security/fire drills provide practice to help ensure the safety of all those in the building. Visitors are required to sign in and, if entering the building, must provide ID that is scanned and run through the system that can identify state-documented concerns.



### Technology and STEM:

Every student is issued a Chromebook with school provided internet connectivity, and each classroom is equipped with a Promethean Board. Additionally, both schools have access to a full technology lab in our Technology Learning Center. Some students with special needs are provided individual tablets. Multiple assessment software and online programs are incorporated into our curriculum and Google Apps for Education is used daily. Elementary and middle level students are offered technology classes during the school. After school STEM and Robotics programs are sponsored by our support organizations for both elementary and middle school students. Each student is supplied with a Chromebook which connects to the district Wi-Fi. Each classroom is equipped with a Promethean Board that acts as a big computer. All students are afforded the opportunity to participate in a Family Technology Night as well.

### Early Childhood Education:

Wharton provides a choice of high-quality preschool programs that address children's social, emotional and academic needs in an inclusive setting. Preschool classes are limited to 15 students. The district contracts with Head Start of Morris County as well as other local private providers. The students in these programs are mainly funded through Preschool Expansion Aid. We also have an in-district preschool disabled class. The district maintains a waiting list. Programs have highly trained teachers and assistants, use a state-recommended curriculum and a performance-based assessment system. Preschool providers are enrolled in Grow NJ Kids.
