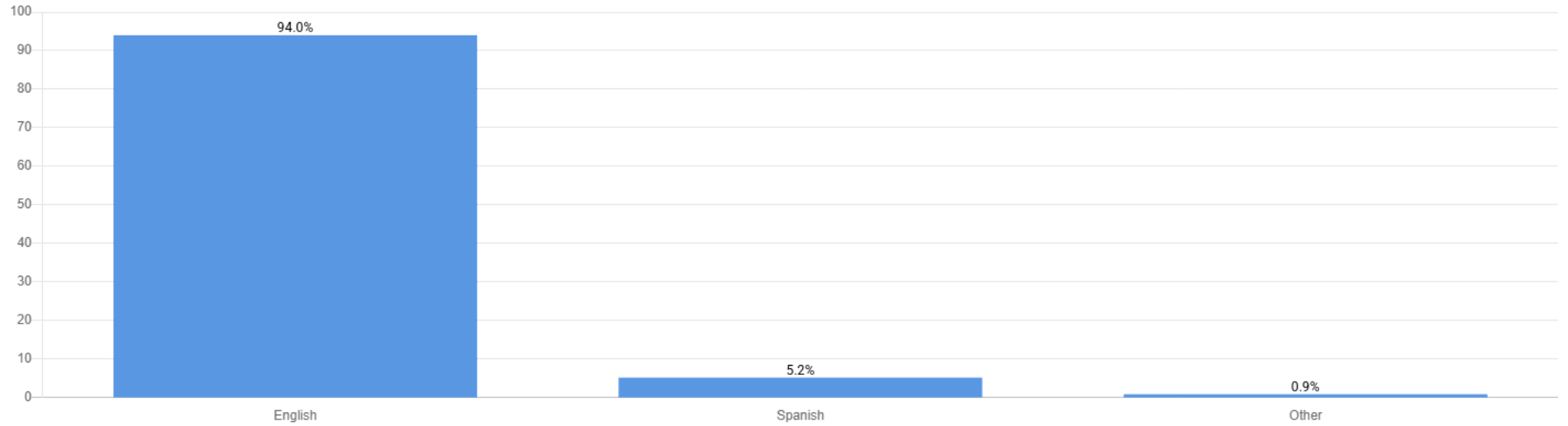

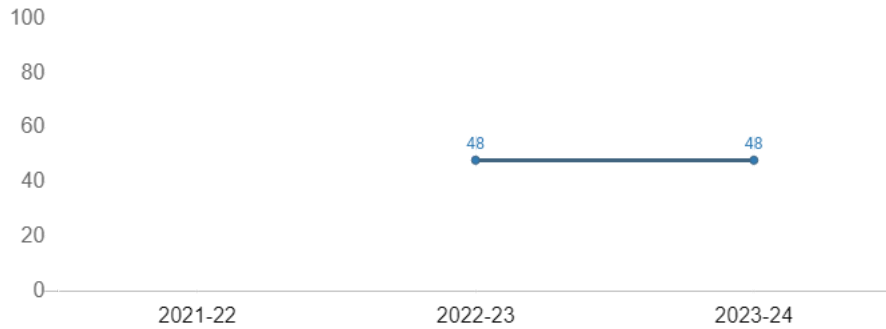

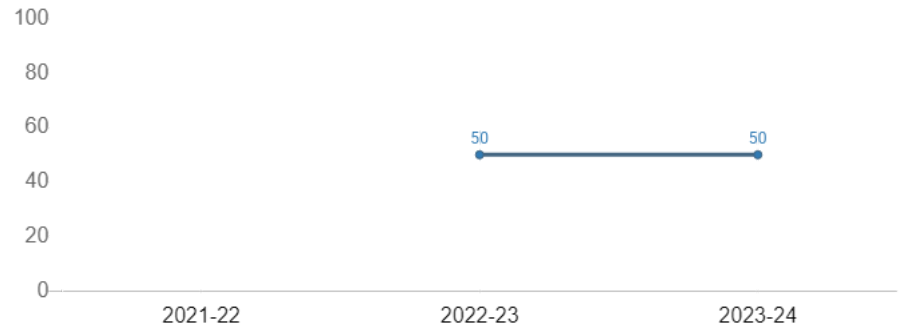

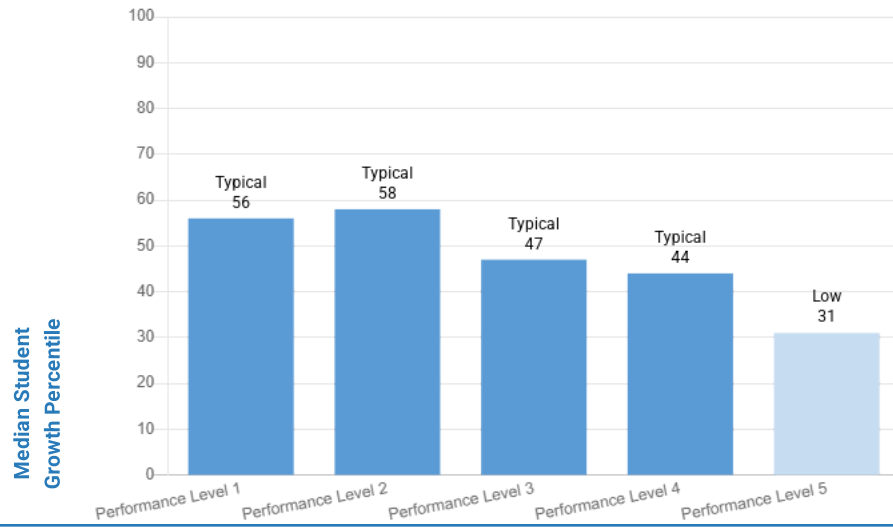

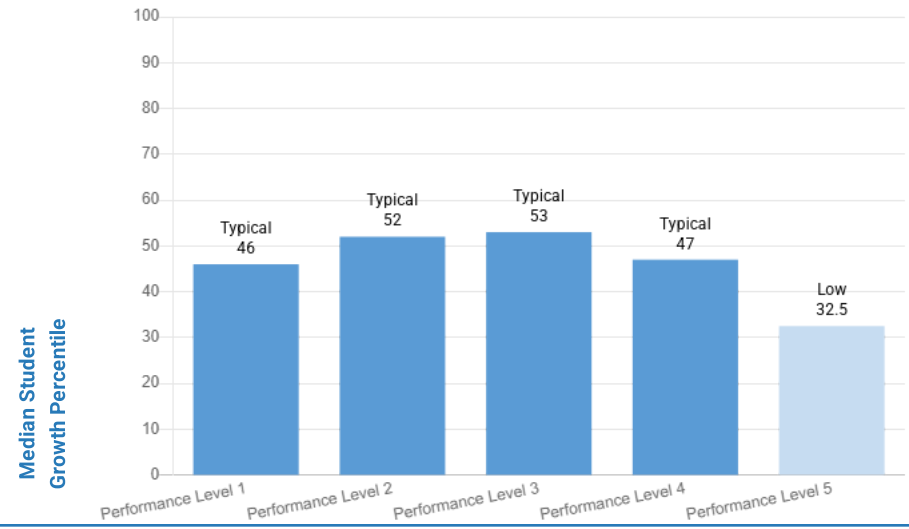

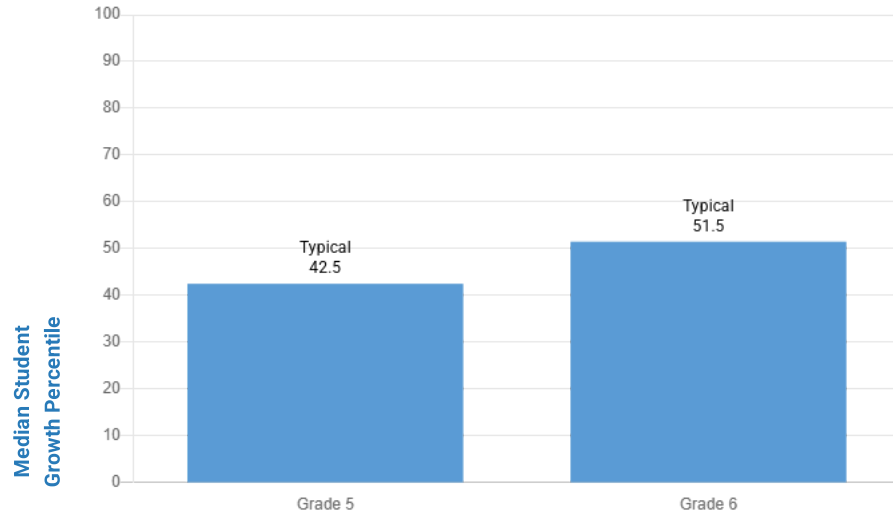

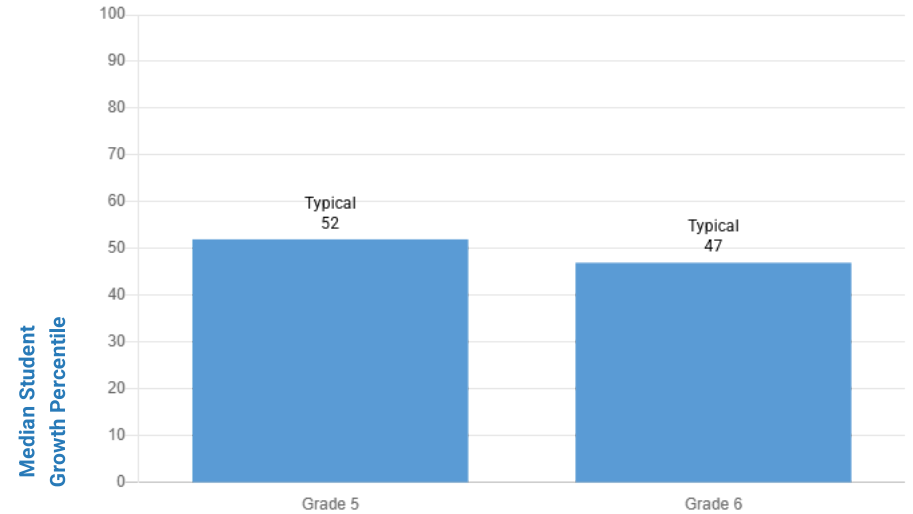

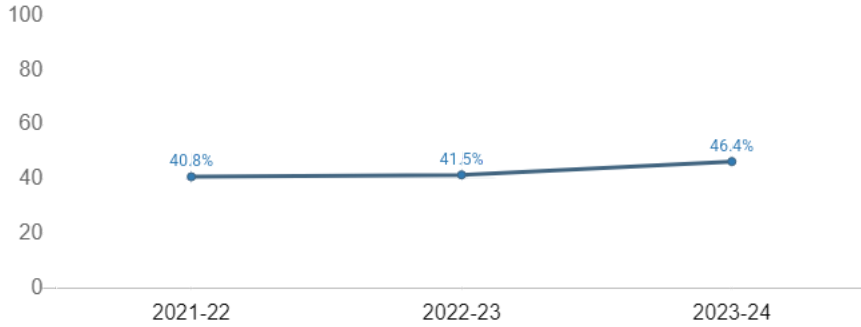

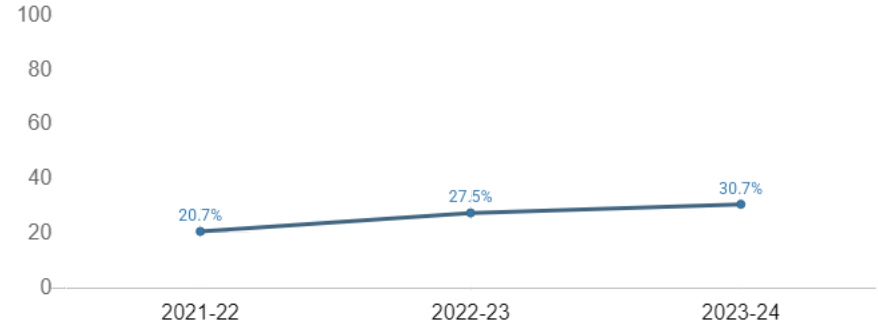
English Language Arts and Mathematics Performance Trends

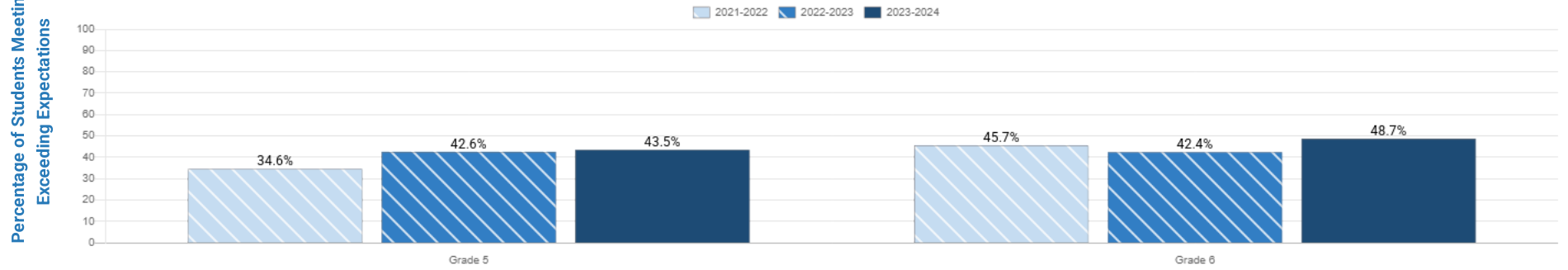

Mathematics Assessment - Participation and Performance

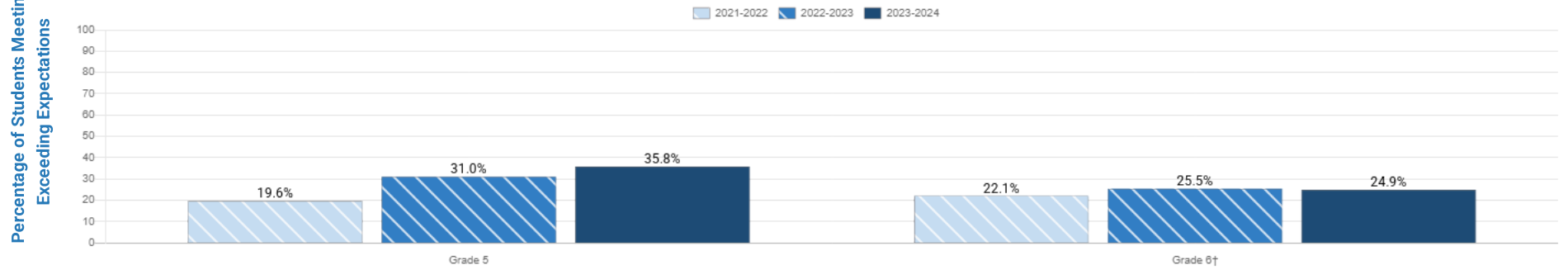

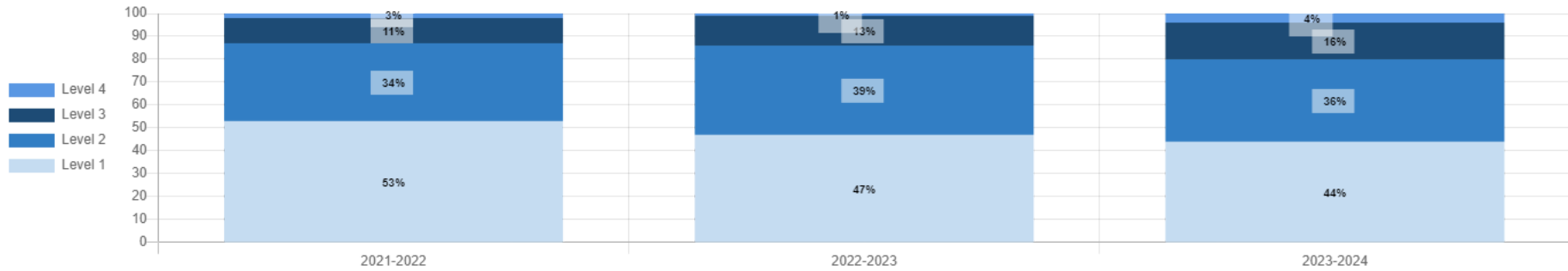

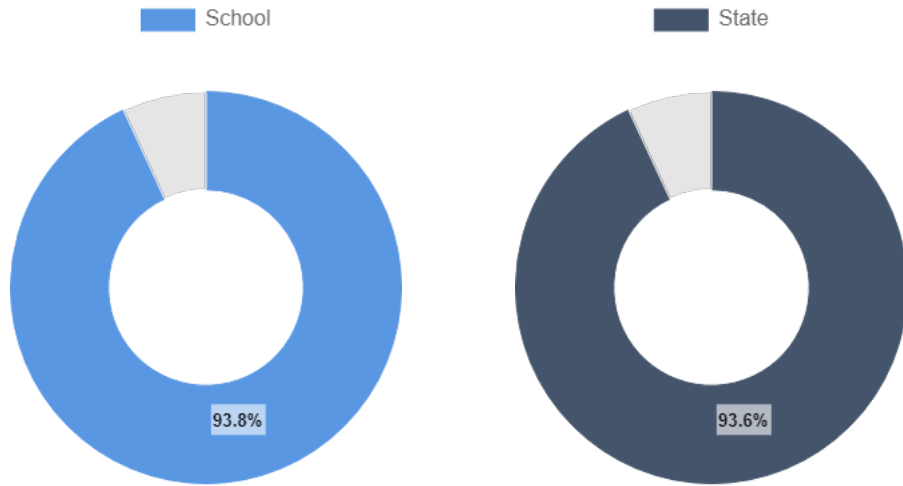

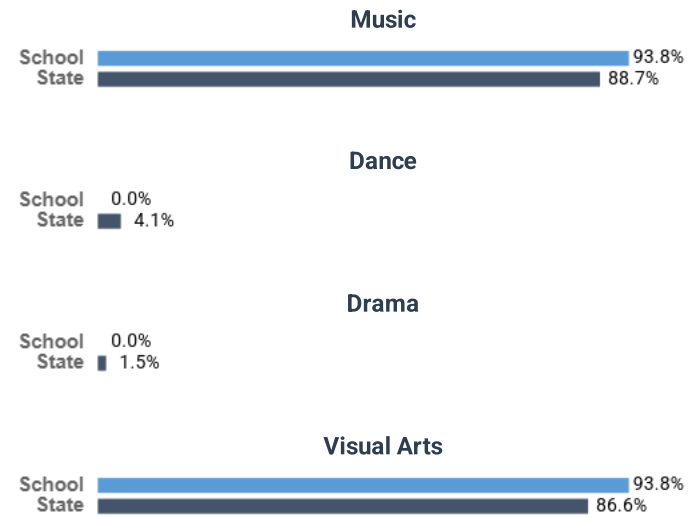

Students enrolled in one or more classes by discipline:



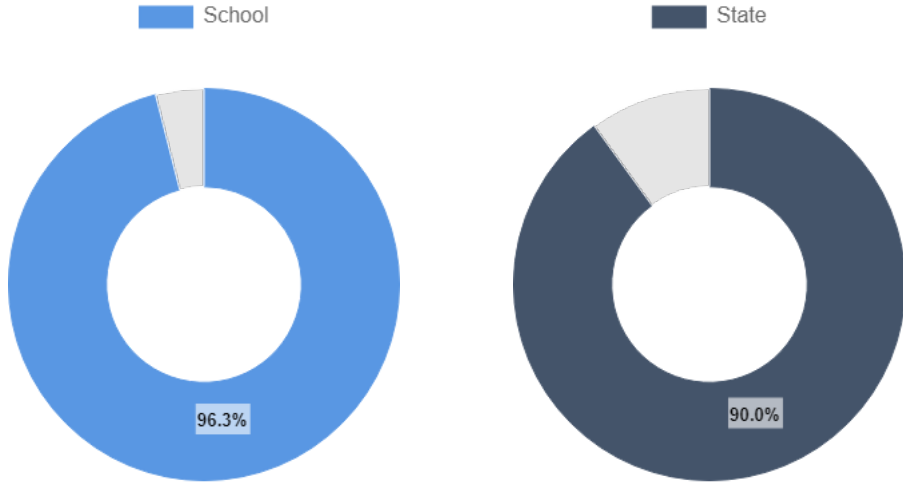

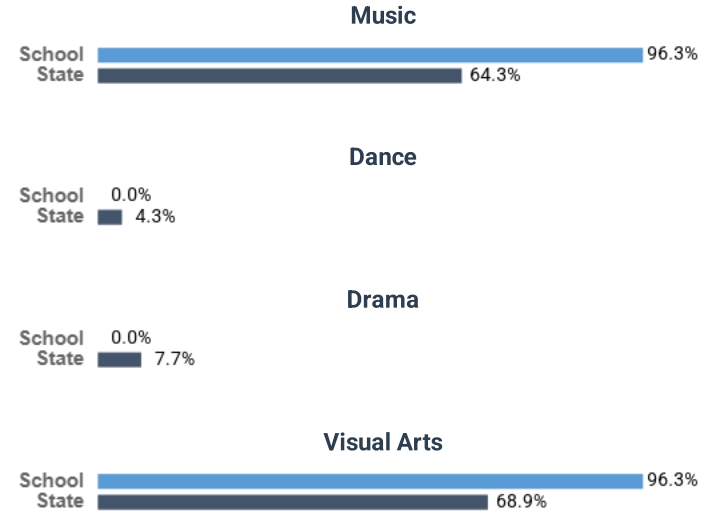

Students enrolled in one or more classes by discipline:



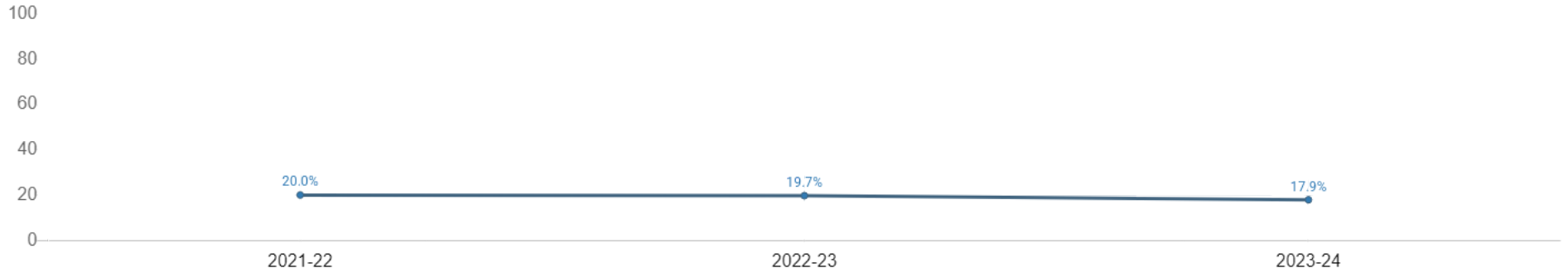

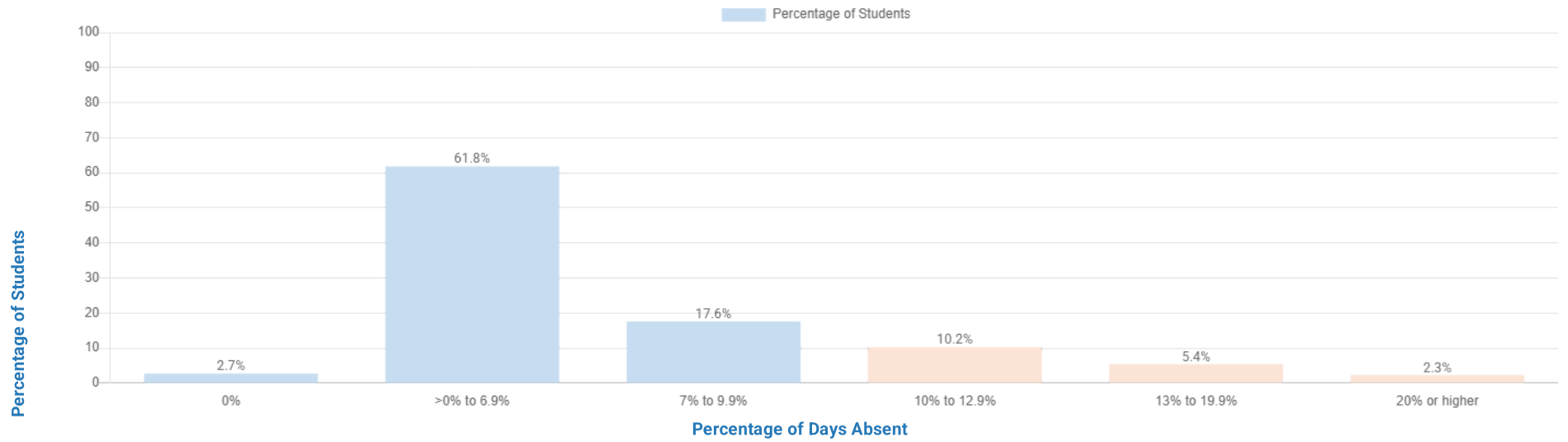

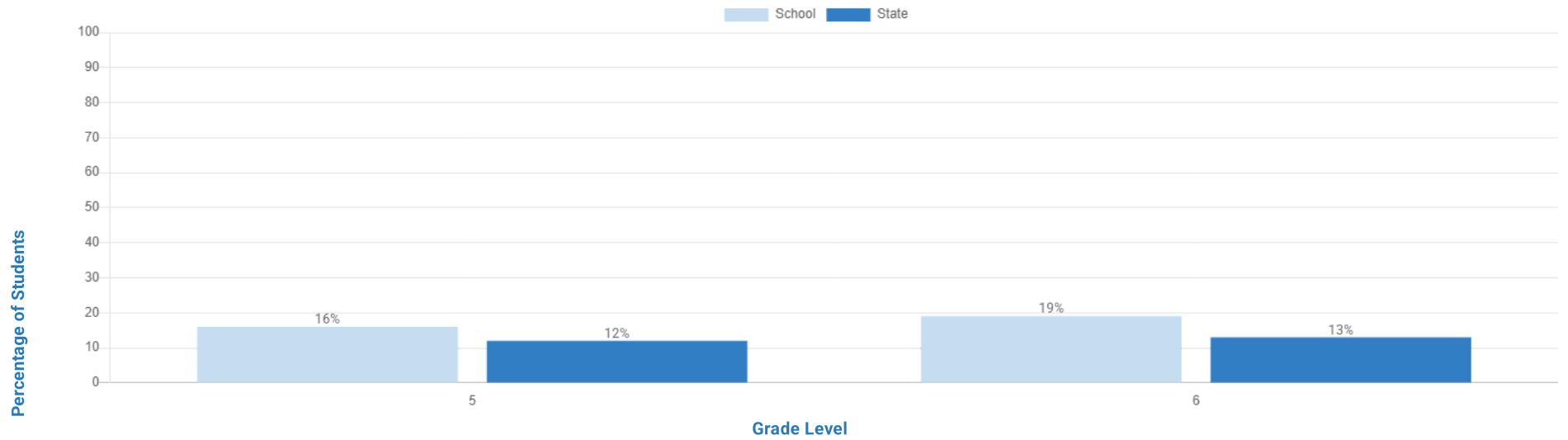

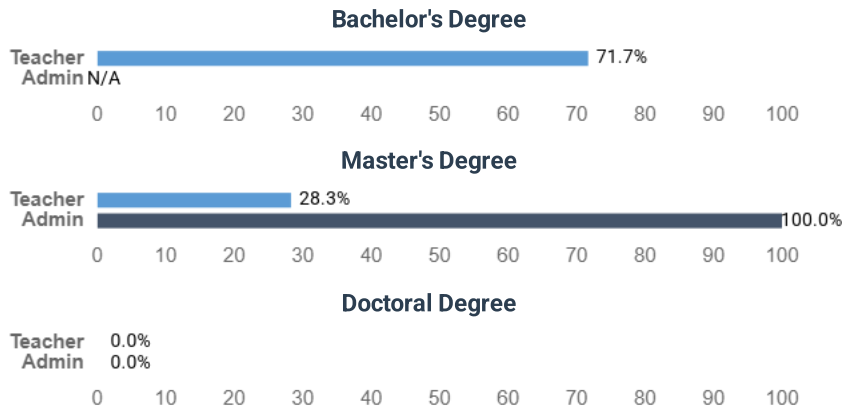

Staff

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers by Subject Area

This table shows the counts of teachers by subject area with gender breakdown, experience, and level of education. The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Courses, Curriculum, Instruction:

Our curriculum is aligned to the New Jersey Student Learning Standards. In preschool we use Creative Curriculum. We provide reading instruction in kindergarten through grade 5 with i-Ready and in grade 6 we use My Perspectives. In Mathematics we use Envision. Our Science lessons are aligned to the NGSS and we use the FOSS program. We offer Enrichment in grades K-2 and Gifted and Talented in grades 3-6.



Before and After School Programs:

The Starfish Program, an extended day program, targets displaced students and other students in need. Operation Schoolhouse is a homework help program that is provided three times weekly for all students after school. All programs are run by district staff after school.



Staff and Professional Learning:

Administrators participate in a variety of professional development opportunities such as the Educational Foundations Academy for new/non-tenured teachers and SCIP meetings to review policies and evaluation tools. All teachers are given the opportunity for professional development off campus as well. The district participates in the Regional Professional Development Academy and SRI-ETTC partnership for PD. We frequently update our curriculum and have trainers and professional development on Google Classroom and aligning to the NJSLS.
