









The LTHS Intervention and Referral Services Team is composed of teachers, counselors, administrators, and other pertinent staff members to address academy, behavioral, and health-related issues for referred students.

Student Supports and Services:



Our full-time school nurse provides a variety of health-related services to our students. Physical education is scheduled every day, while health classes covering a variety of age-appropriate topics are offered one marking a period of the year. The LTHS Community Closet receives donations from citizens and area businesses to provide necessary toiletries and other health-related items to students in need.



Parent and Community Involvement:

The Lacey High School has an active and supportive PTSA that provides many student opportunities and supports various academic programs. There are several events throughout the year that encourage staff, students, and parent involvement. Through monthly meetings of the PTSA, access to the parent portal and website, as well as a monthly newsletter, parents are kept up to date on school matters. The LTHS Boosters Association and their subsidiaries promote athletics, extra-curriculars, and co-curricular activities to broaden student experiences and opportunities.

The STEM Academy focuses on a collaboration among Science, Technology, Engineering, and Mathematics courses where the standard curriculum is enriched with hands-on projects, real-world problems, and career-based activities. The Academy includes opportunities for interaction with professional representatives and field trips that expose the students and staff to current trends, expectations, research, and career opportunities. The overall experience is a coordinated effort in part by the administration, teachers, guidance, counselors, and students to expose the cohort with enriching experiences to help Academy students in their postsecondary planning and decision making.



LTHS's Introduction to Education curriculum affords high school students, under direct supervision, the ability to work with pre-school students who attend pre-school at LTHS several times a week.
