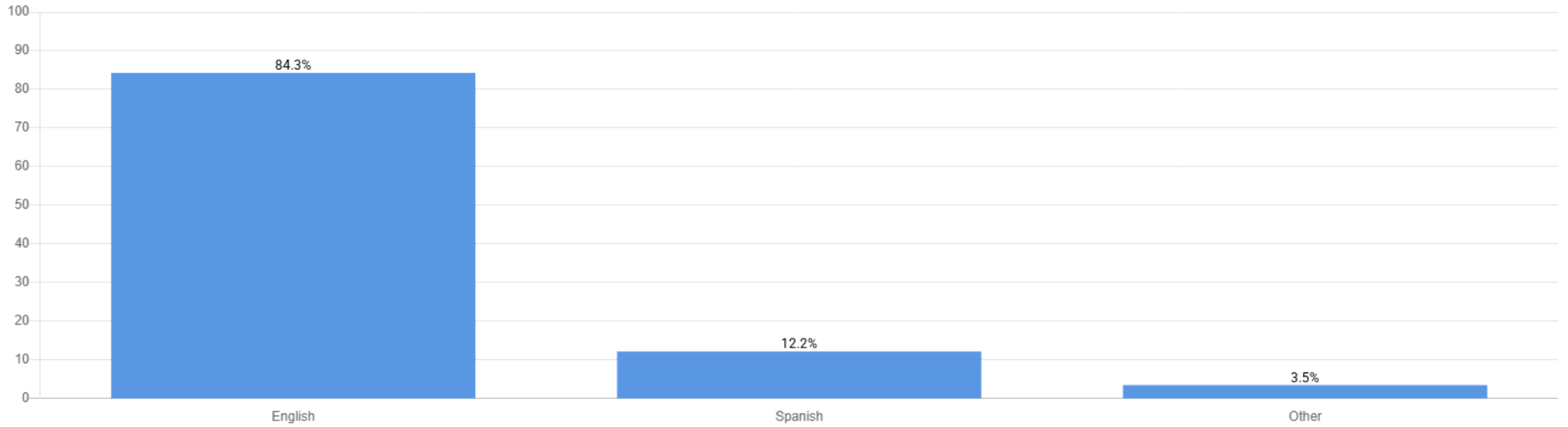

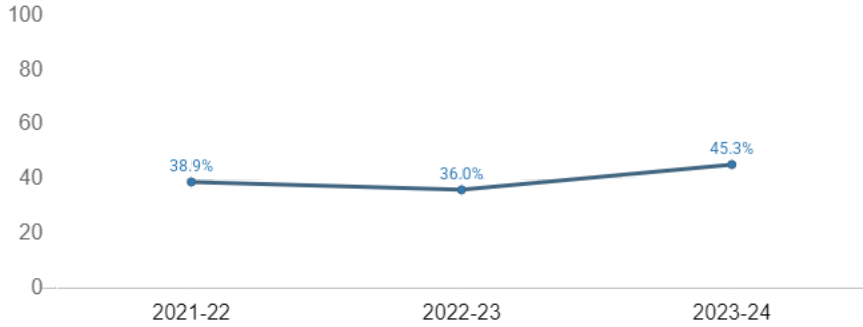

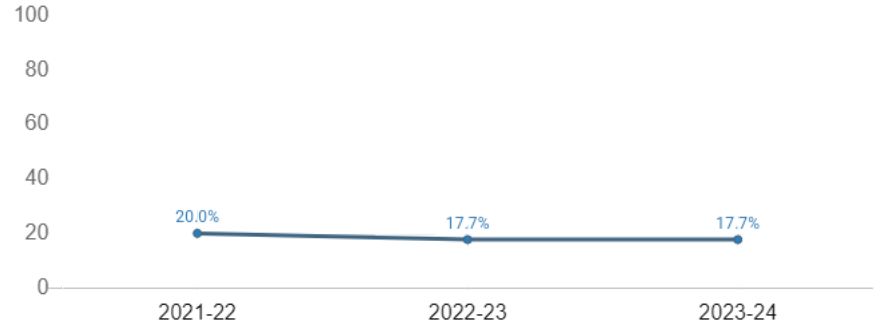
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 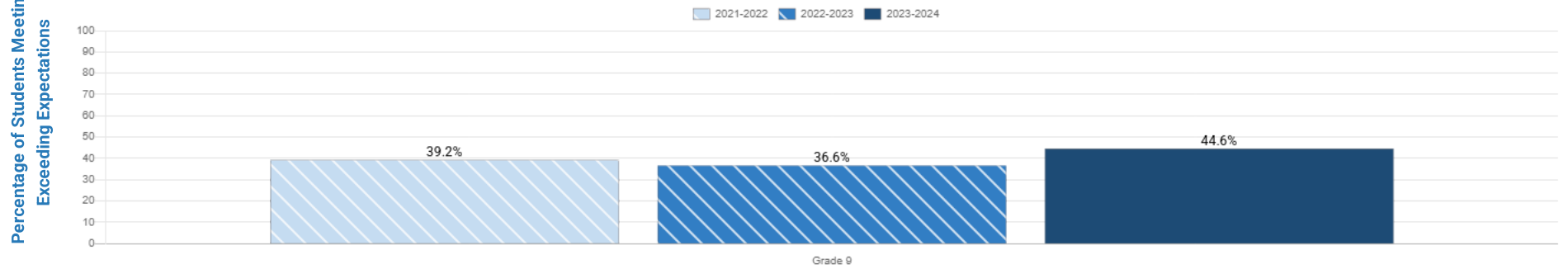

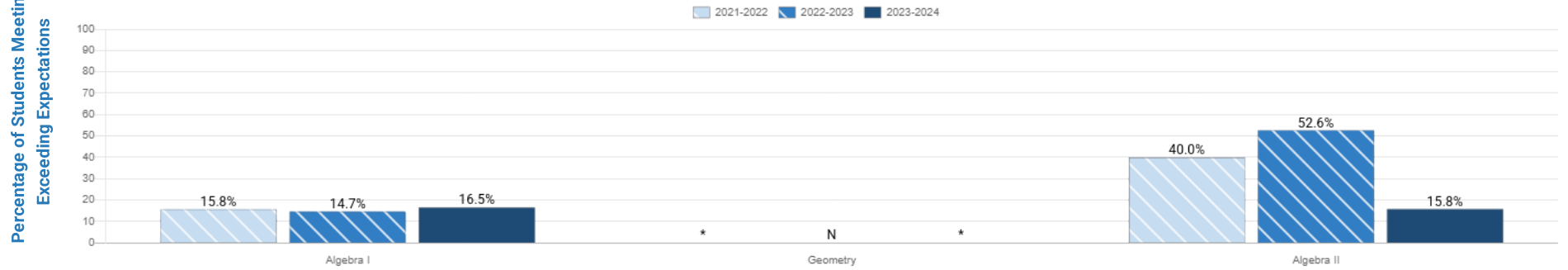

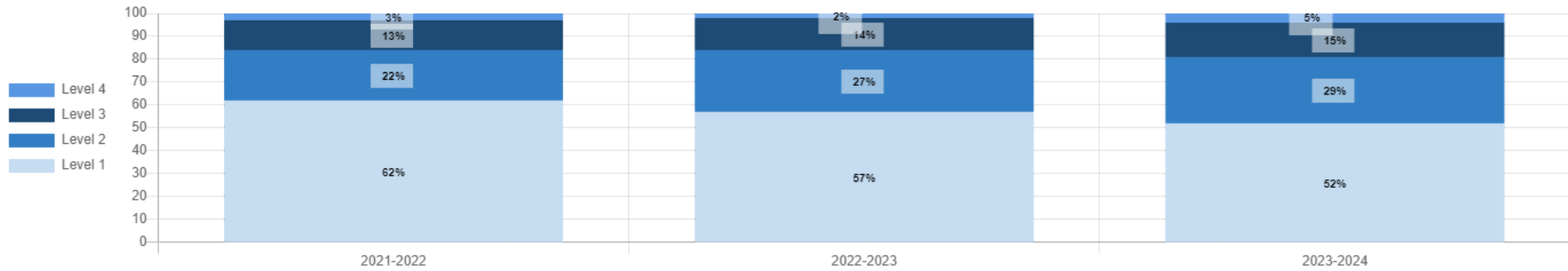

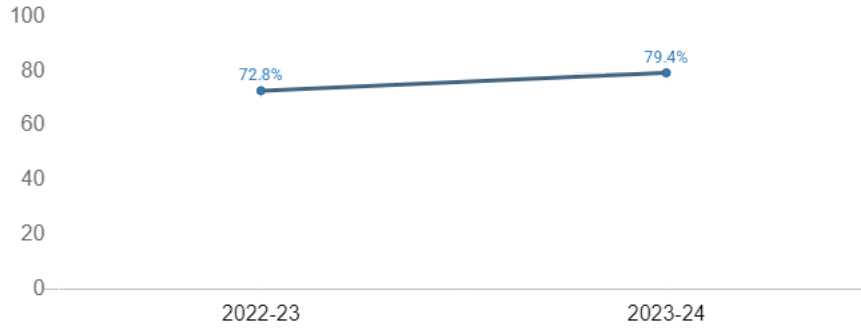

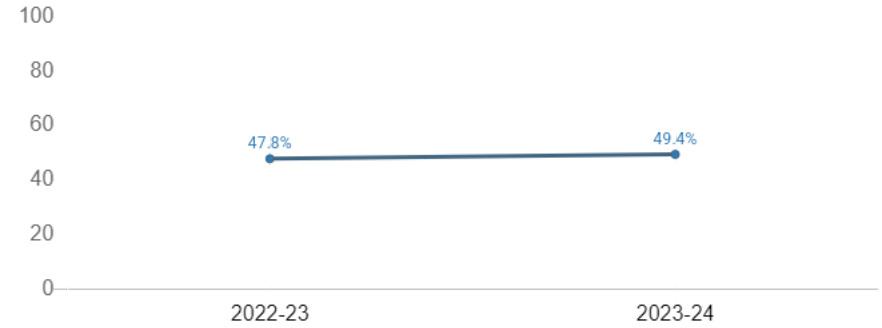

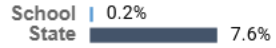

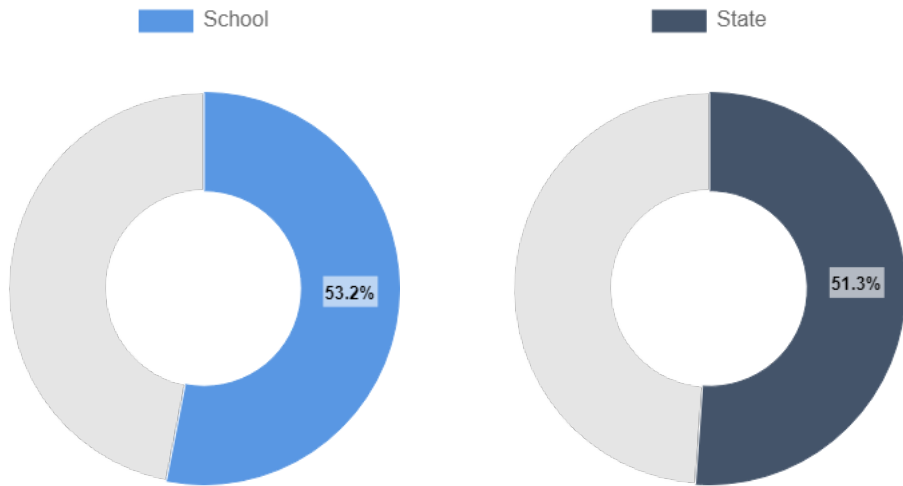

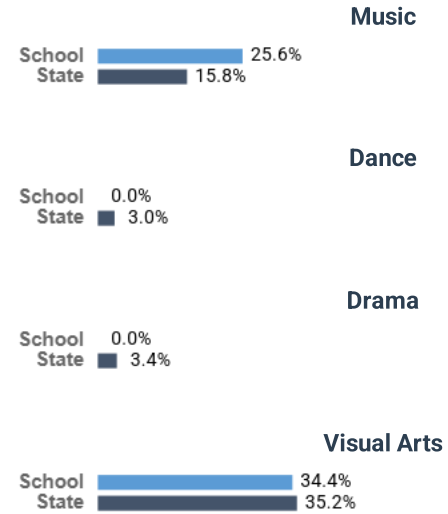

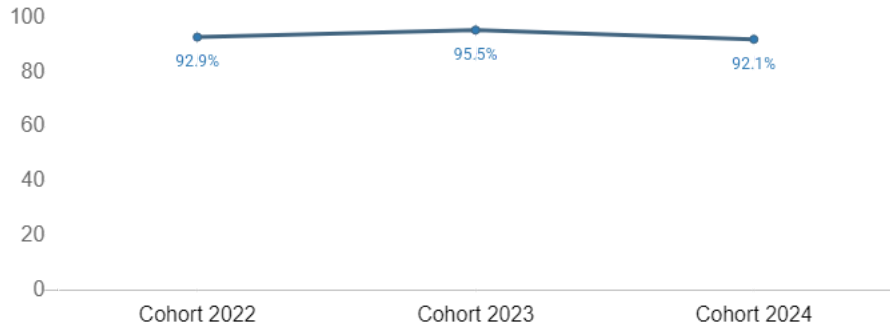

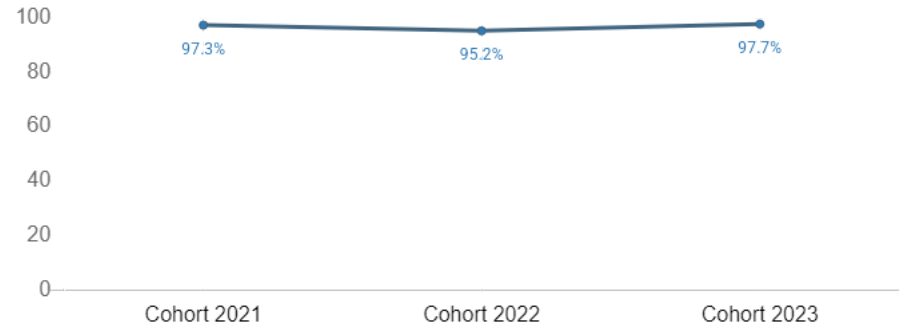

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

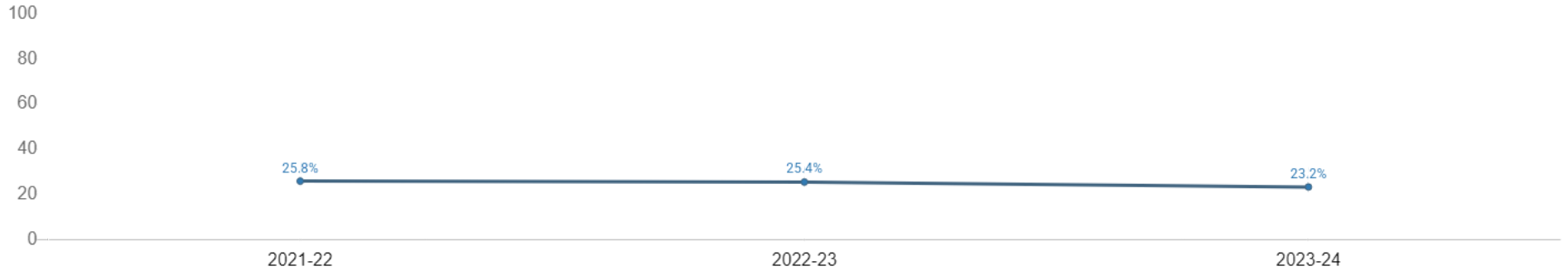

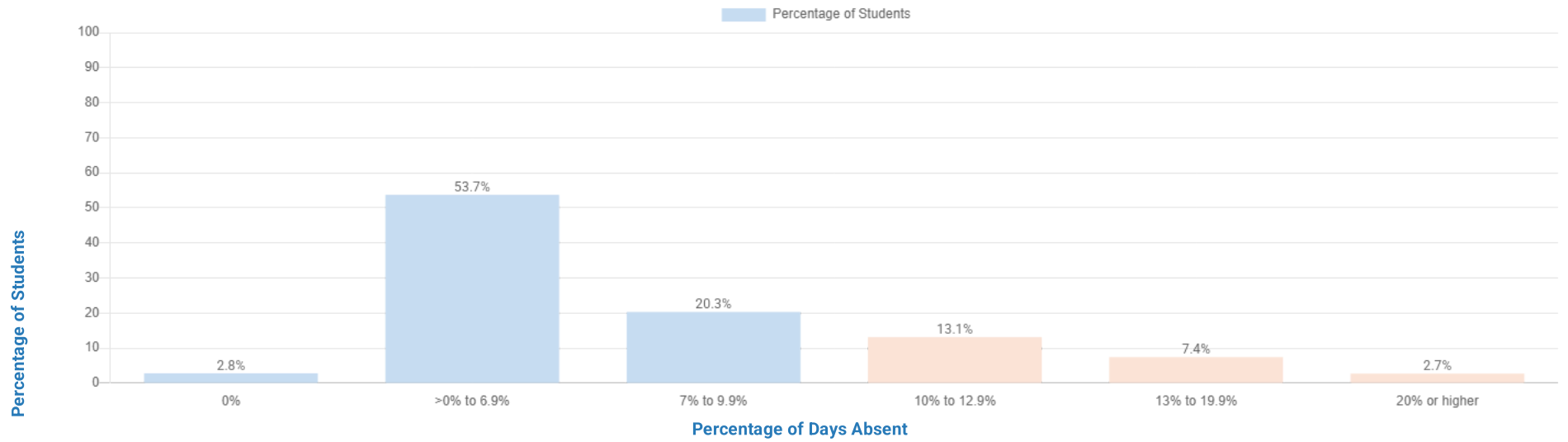

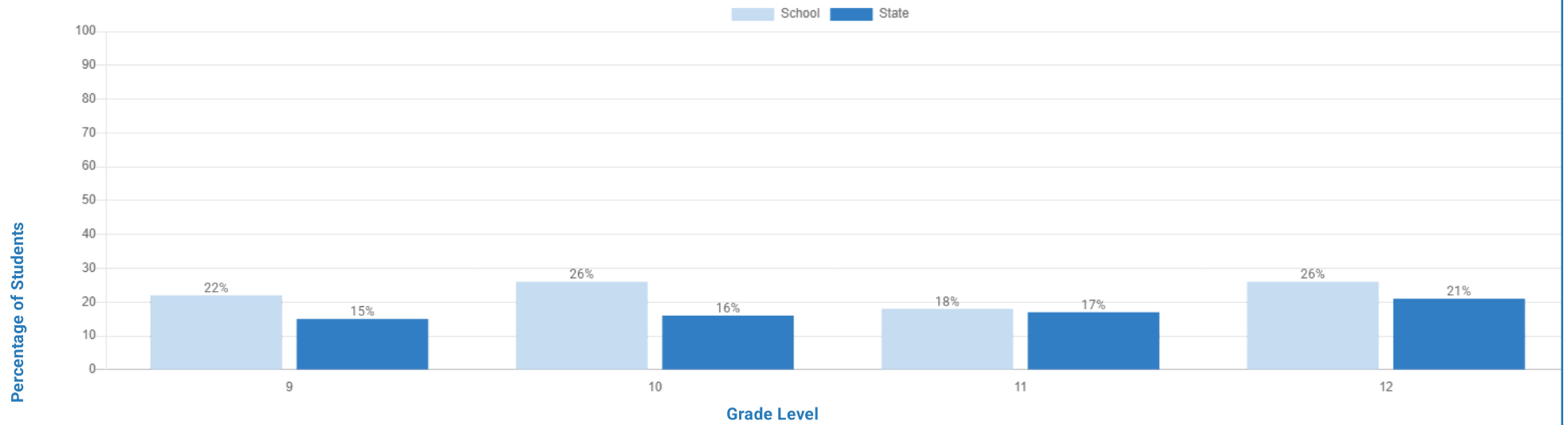

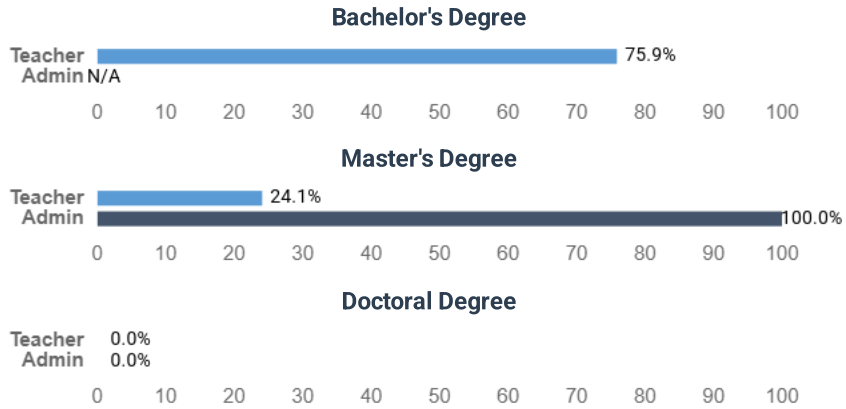

Accountability Summary by Student Group - 2023-24 School Year

The athletic opportunities at Manchester are varied. Boys have 14 and girls 13 programs exclusive to their gender with girls also being allowed to wrestle and play golf. In addition, we offer cheerleading, marching band, a drama club and winter guard. Each require the same level of time, as our NJSIAA recognized athletic programs and attract dedicated participants throughout their active seasons. The fall season favors female participation as the offerings are 6, while the boys have 3. Winter favors boys 6-4 as spring favors boys 5-3. Total participation through the year has consistently favored boys in most years. Practice facilities & uniform replacement are scheduled with equal access to all teams within each season/cycle. Though the NJSIAA permits student-athletes to participate in 2 non-strenuous athletics and activities during the same season, the large majority of students are generally restricted by time and schedules to participate in one activity.

New Teachers are supported with PD through monthly meetings and ongoing meetings with the SCiP



Postsecondary Information:

MTHS graduates of 2024 were placed in the following locations after graduation; 69% at a college, 10% at trade/technical colleges, 7% at the military, 11% in direct employment, and 3% other. Support programs for students applying for college: College Pathways (FAFSA workshops, college application process, scholarships, with presentation for parents and students). Support programs for students taking college entrance exams: SAT school day testing, Fee waivers, Manchester Community School SAT course, websites such as Khan Academy/Naviance. After graduation students go to direct employment, military or college, students apply and are accepted to over 60 different colleges and universities. Students taking AP tests had the potential to earn college credit. Dual enrollment is offered through OCC to earn college credit.

Title III ESL tutoring by World Language Department is available to all grades. Freshmen Seminar course continues to support 9th students transition to high school. AIM is a remedial summer program for incoming freshmen. Through a partnership with the Manchester Township Police Department, the #NotEvenOnce opioid program was infused in health classes. Students with disabilities can participate in a RISE transition program. There are speakers and assemblies for students. The SAC created and shared mental health website for students. SAC advises the Youth Prevention Coalition supports the well-being for all students. Students have access to outside counseling services to CompassNJ. Field trips, Genders and Sexualities Alliance, Intervention and Referral Services Committee, APEX-online learning system, home instruction.

Our Student Assistance Counselor works with administration to provide assemblies geared towards Mental Health and Wellness. SAC provided a Google classroom of resources for students and parents.

The Attendance Committee engages students and parents. Also, students can redeem credit and connect with the the community through community service with local businesses. Additionally, we implement Attendance Hours and Credit Denial for serious cases. Support services like the Zen Den help students manage challenges, fostering overall engagement and success.
