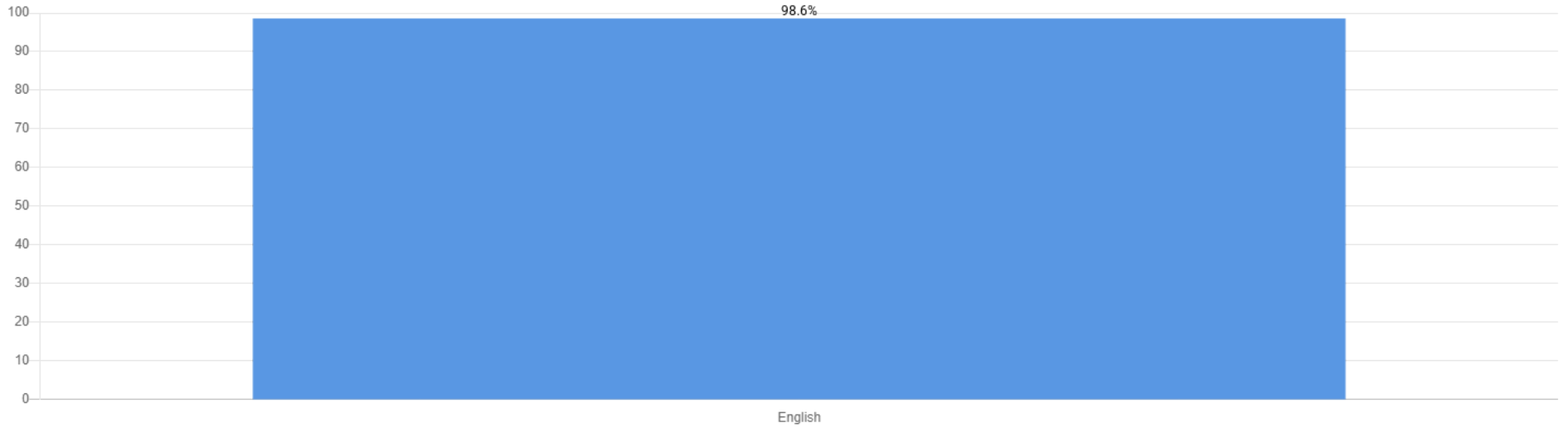

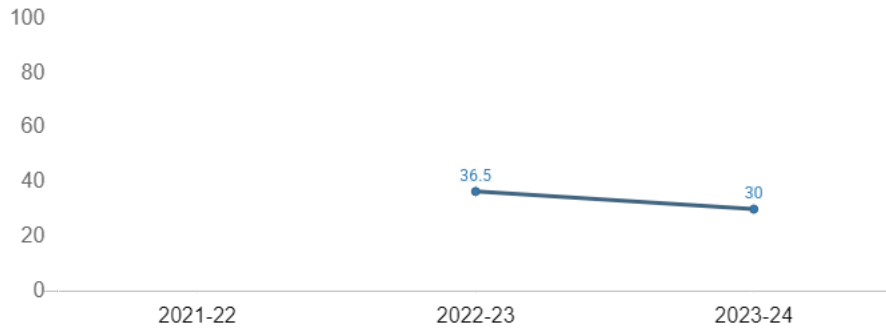

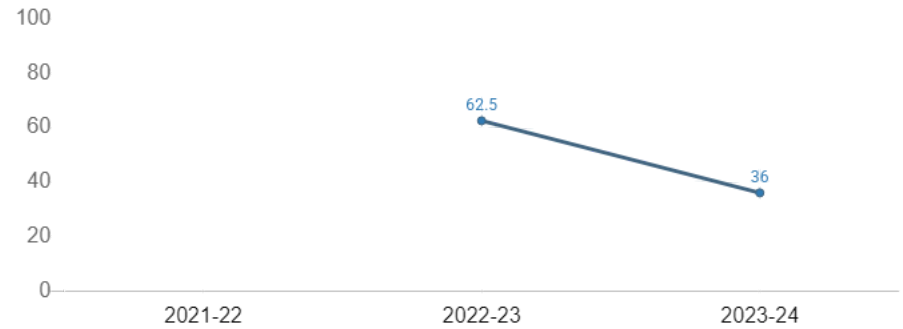

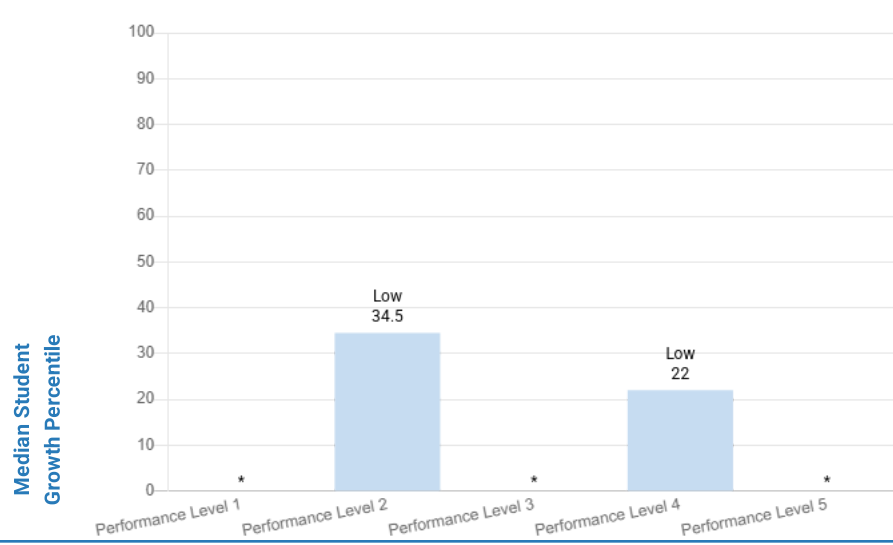

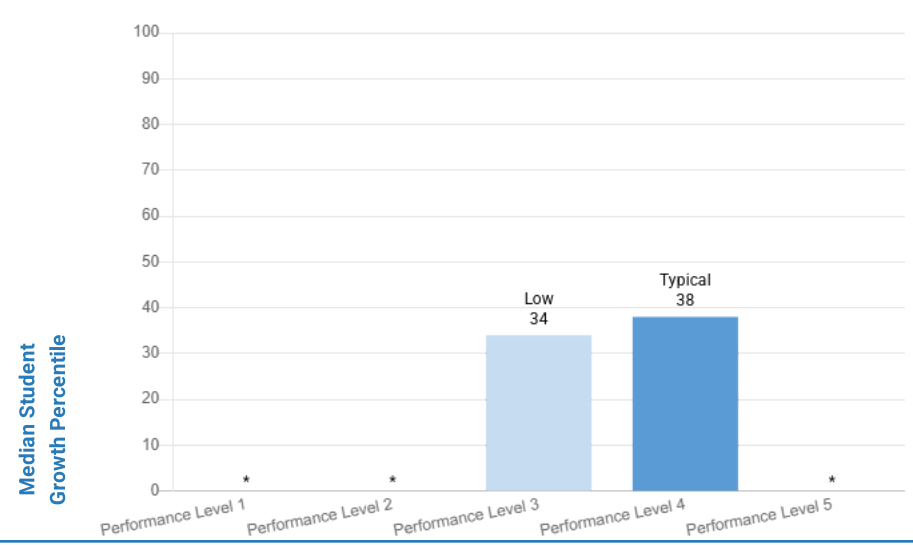

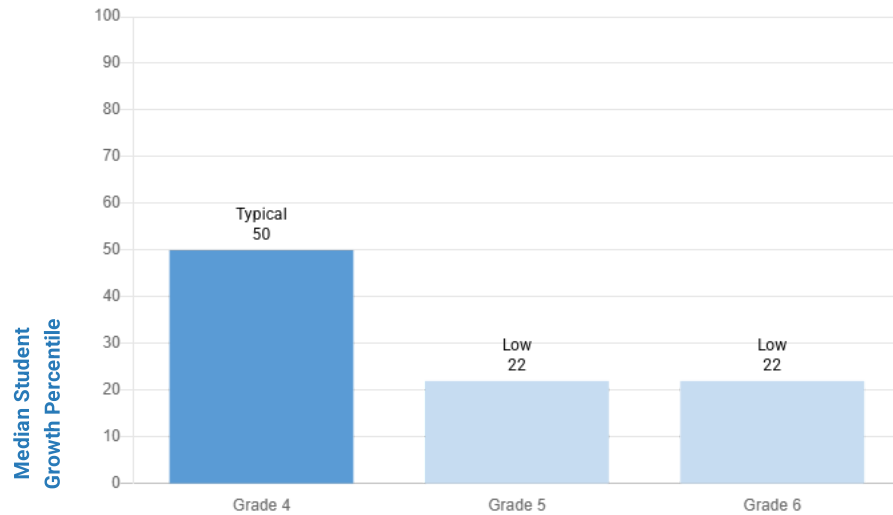

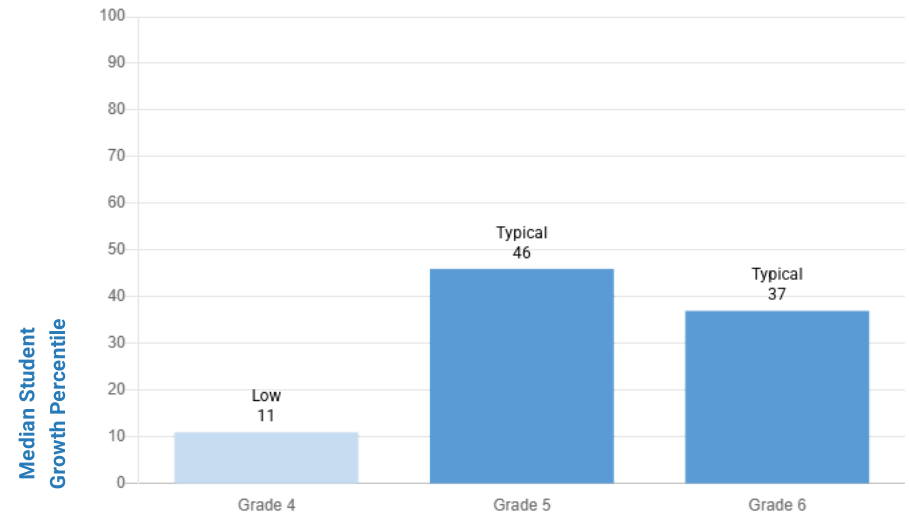

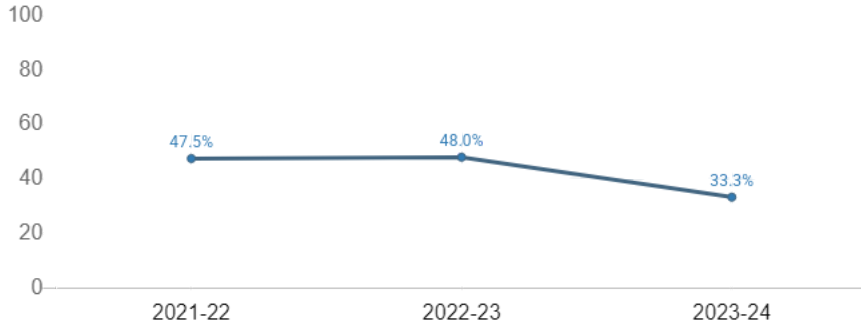

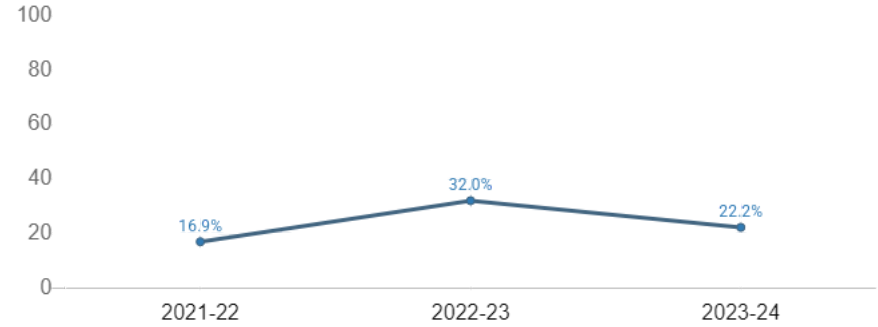
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 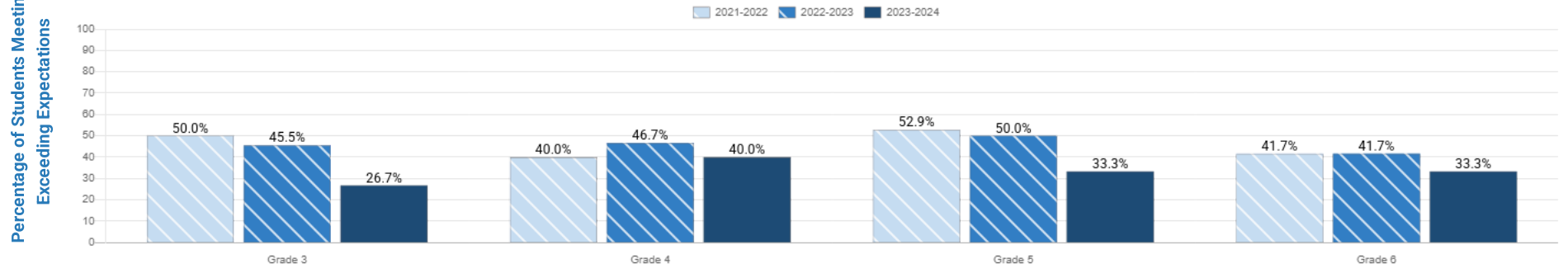

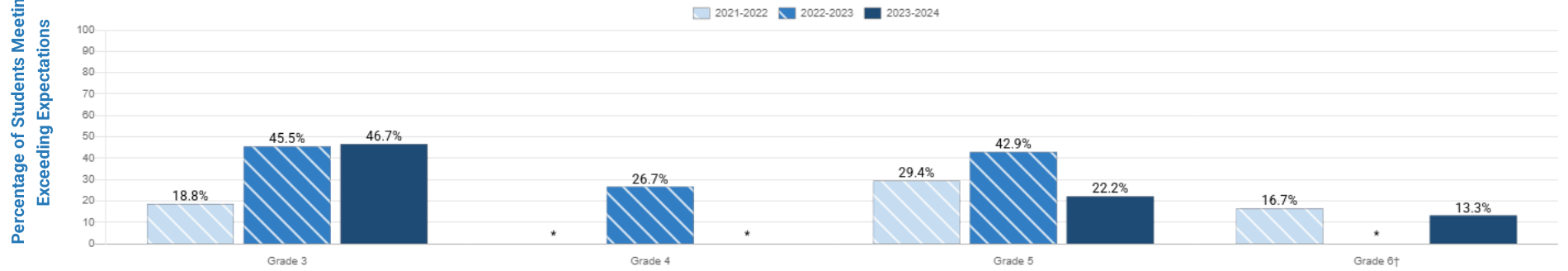

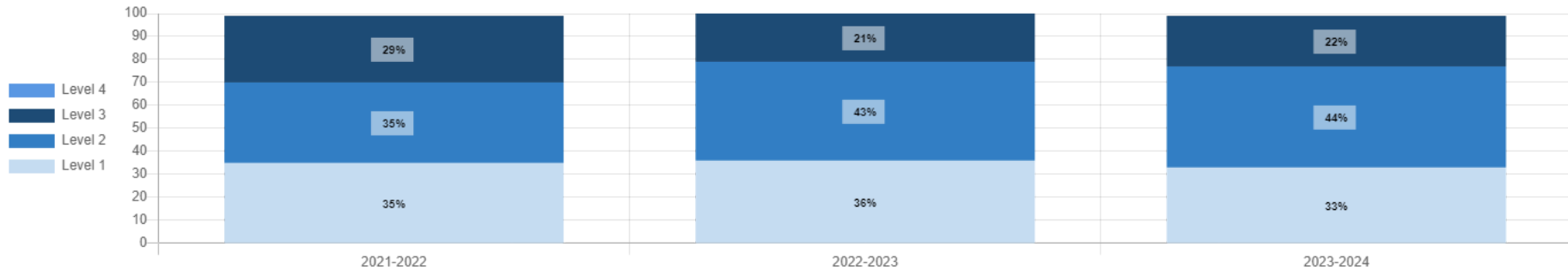

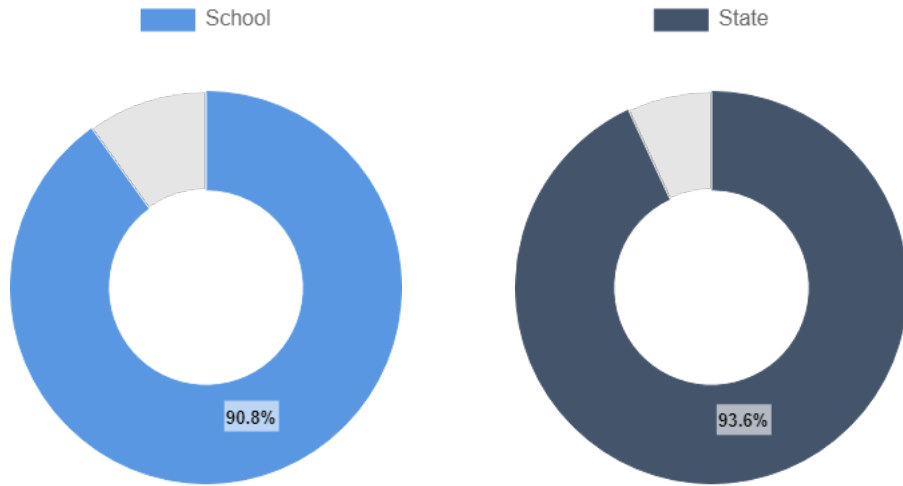

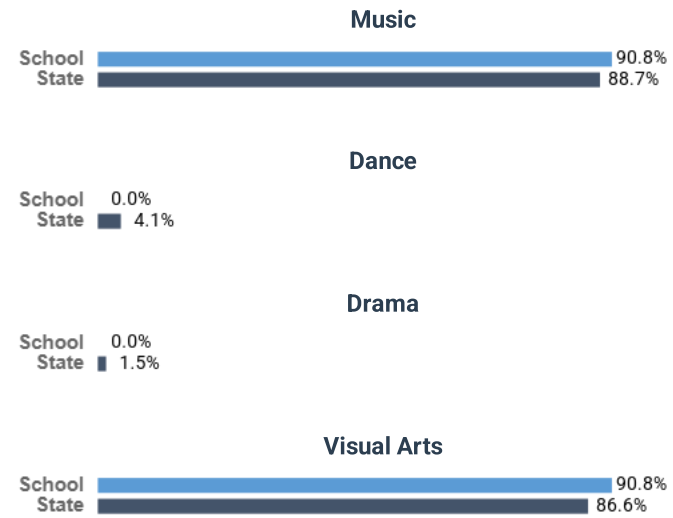

Students enrolled in one or more classes by discipline:



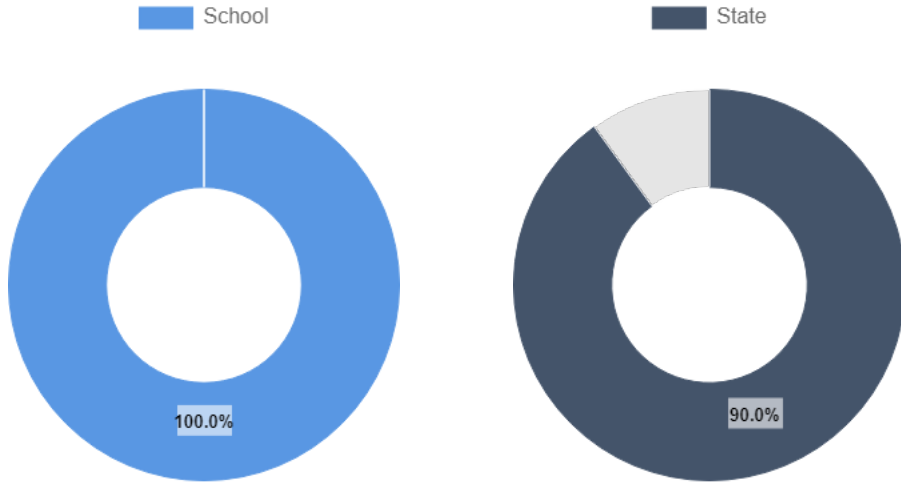

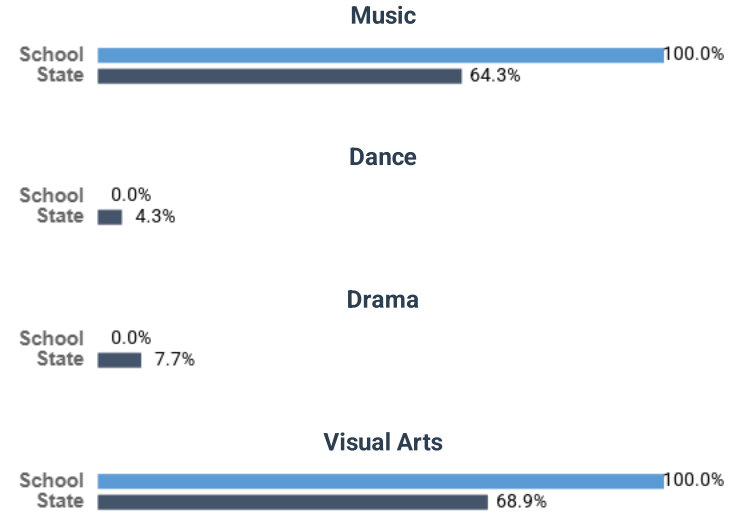

Students enrolled in one or more classes by discipline:



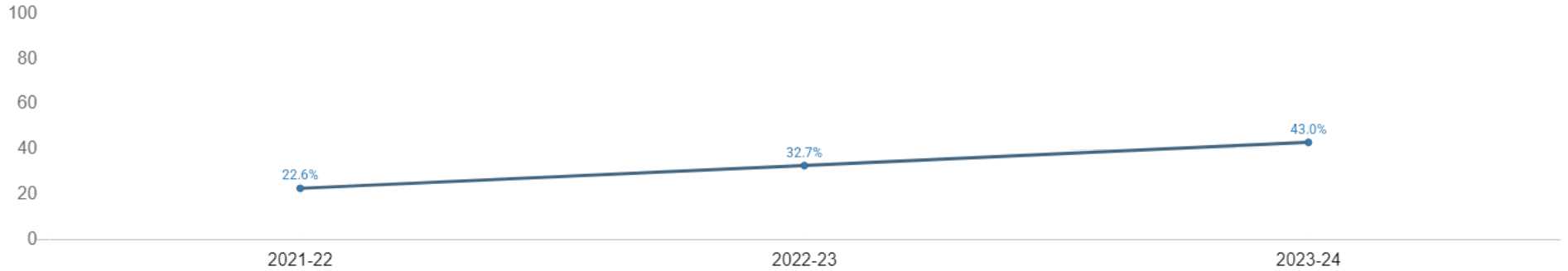

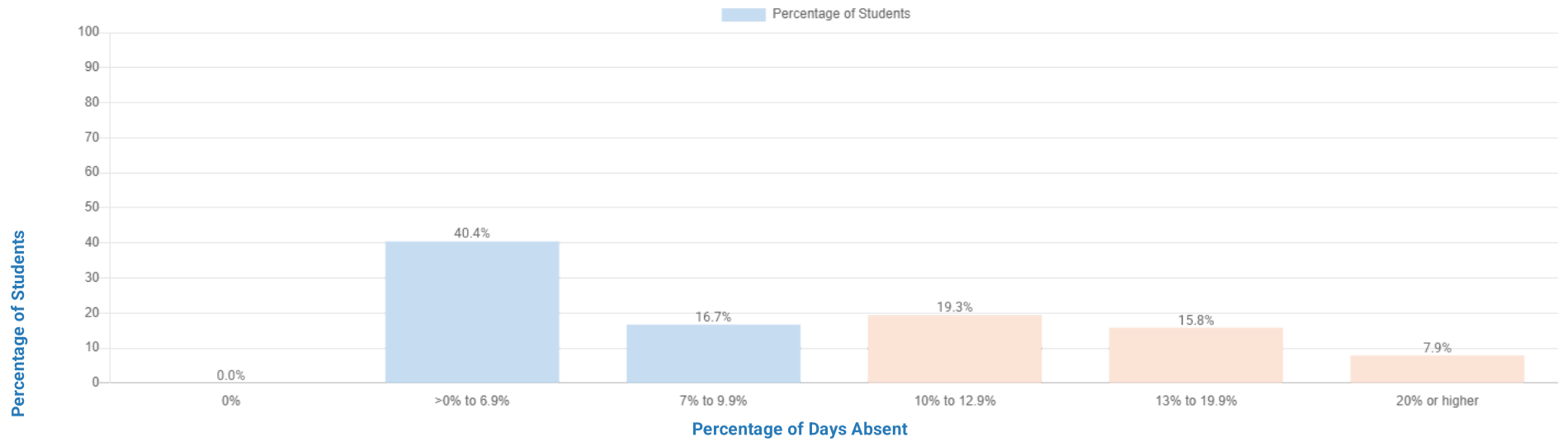

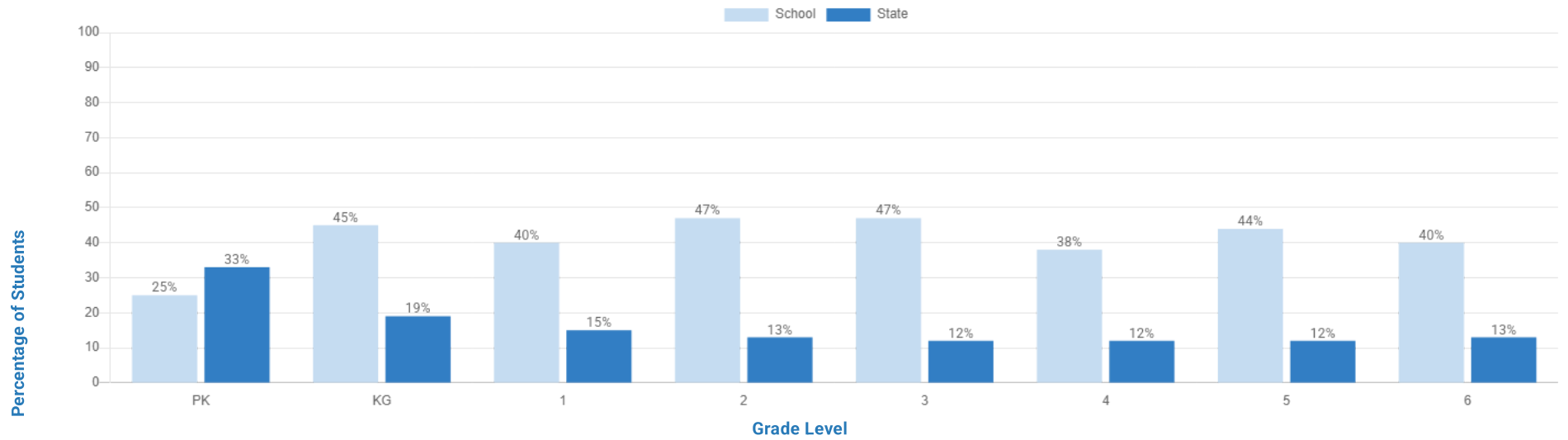

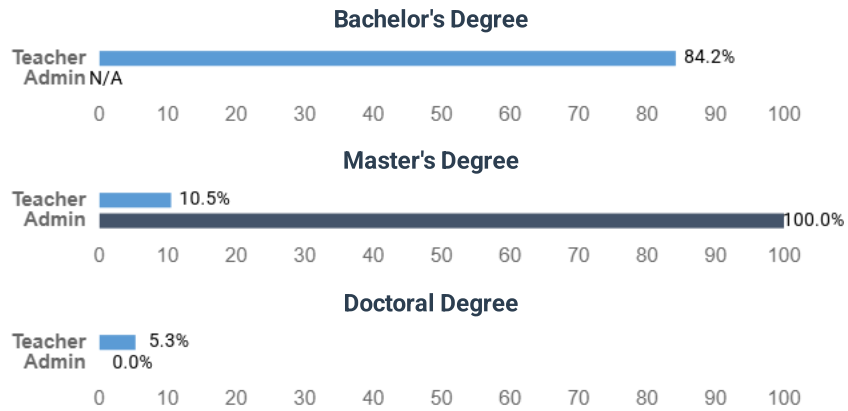

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. The borough encompasses .44 square miles and has a population of 2,023. In 1914 the original one room school on Arverne Avenue with an outhouse and a pot bellied wood stove was built. All eight grades were taught here. Today this building is occupied by our Kindergarten class. In 1940 a two room school was built on Barnegat Avenue. In 1956 Ocean Gate became a member of the Central Regional School District. Our students attend the Central Regional School District, in neighboring Berkeley Township, for grades seven through twelve. In 1968 the third building was built on Arverne Avenue. Again in 1994, Ocean Gate School expanded with an addition to the main building.
